The ornamental design of a tubular shaped container for cosmetics, of the present invention as shown and described.

### DESCRIPTION

FIG. 1 is a front view of the tubular shaped container for cosmetics of the present invention;

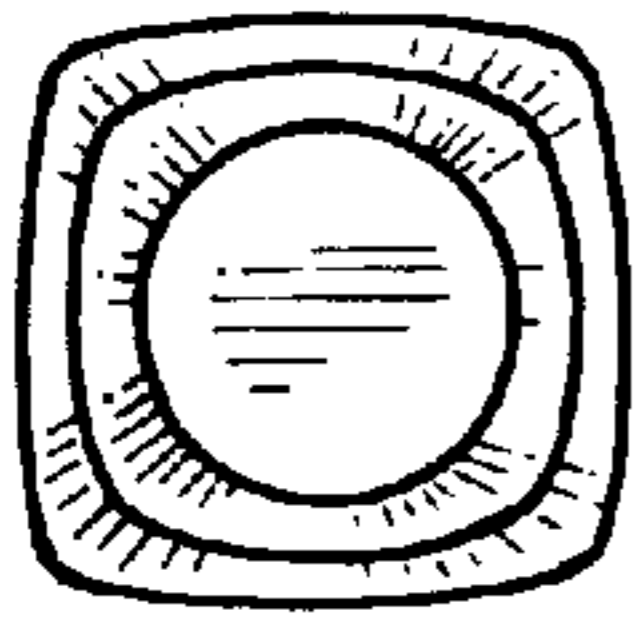

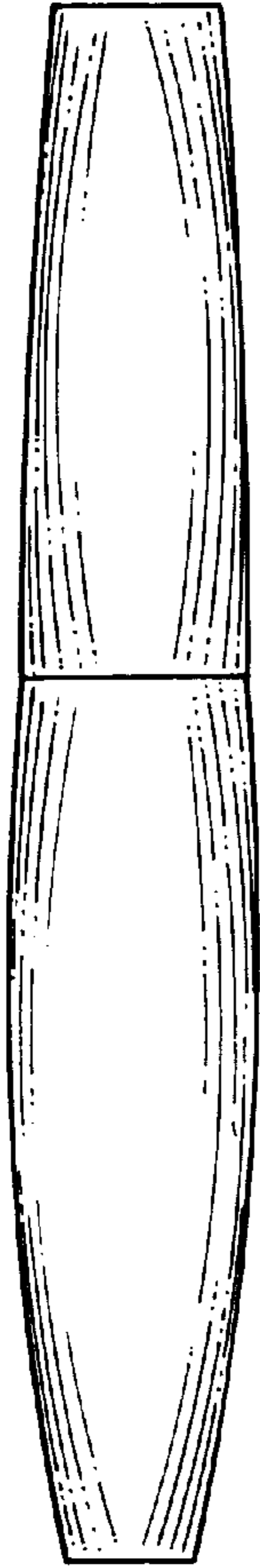

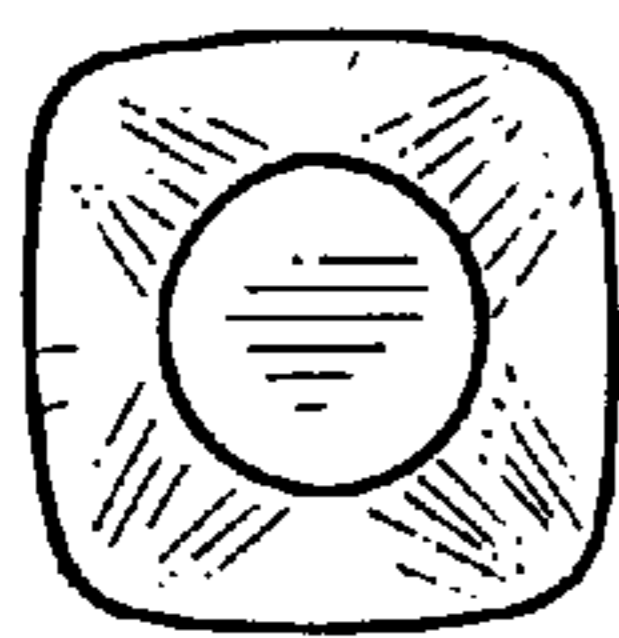

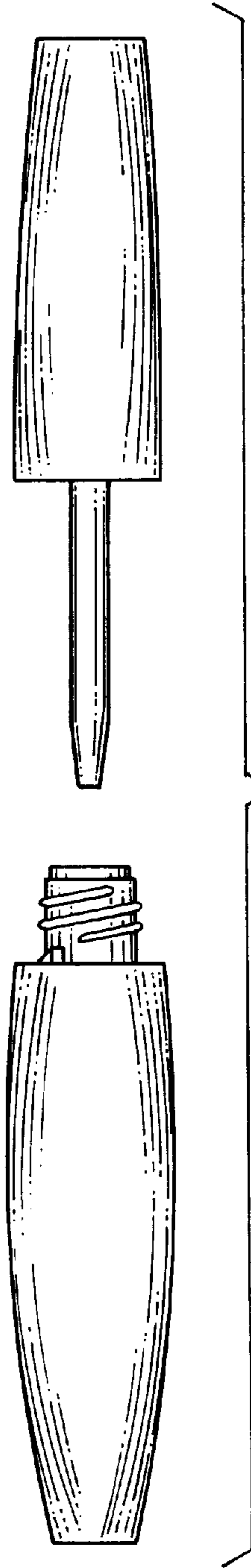

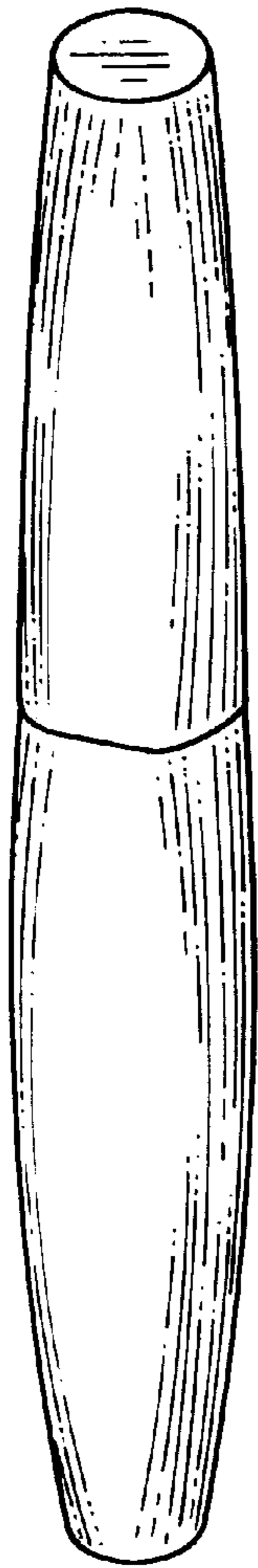

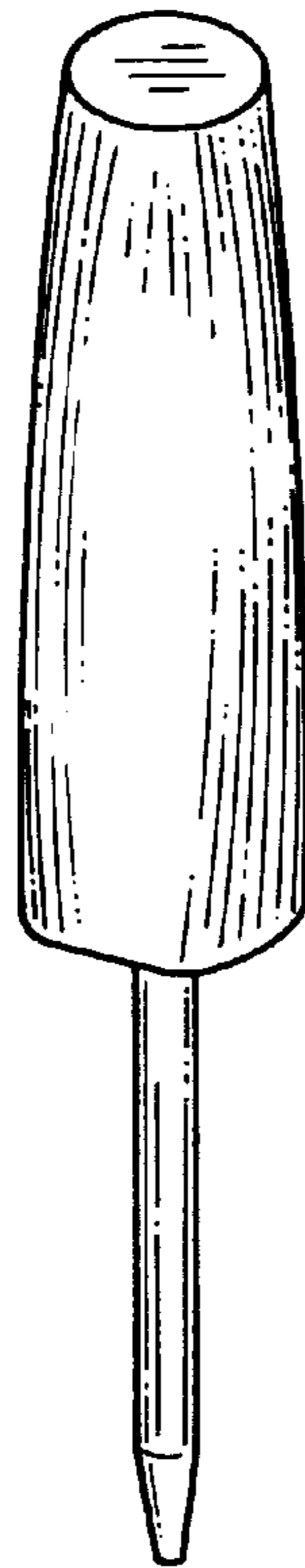
