The ornamental design for a hair adornment, as shown and described.

### DESCRIPTION

FIG. 1 is a front perspective view of the hair adornment of the invention;  
FIG. 2 is an enlarged partial rear perspective view thereof;  
FIG. 3 is an enlarged partial top and front perspective view thereof;  
FIG. 4 is an enlarged partial bottom and end perspective view thereof; and,  
FIG. 5 is an enlarged partial perspective view thereof from the opposite end.

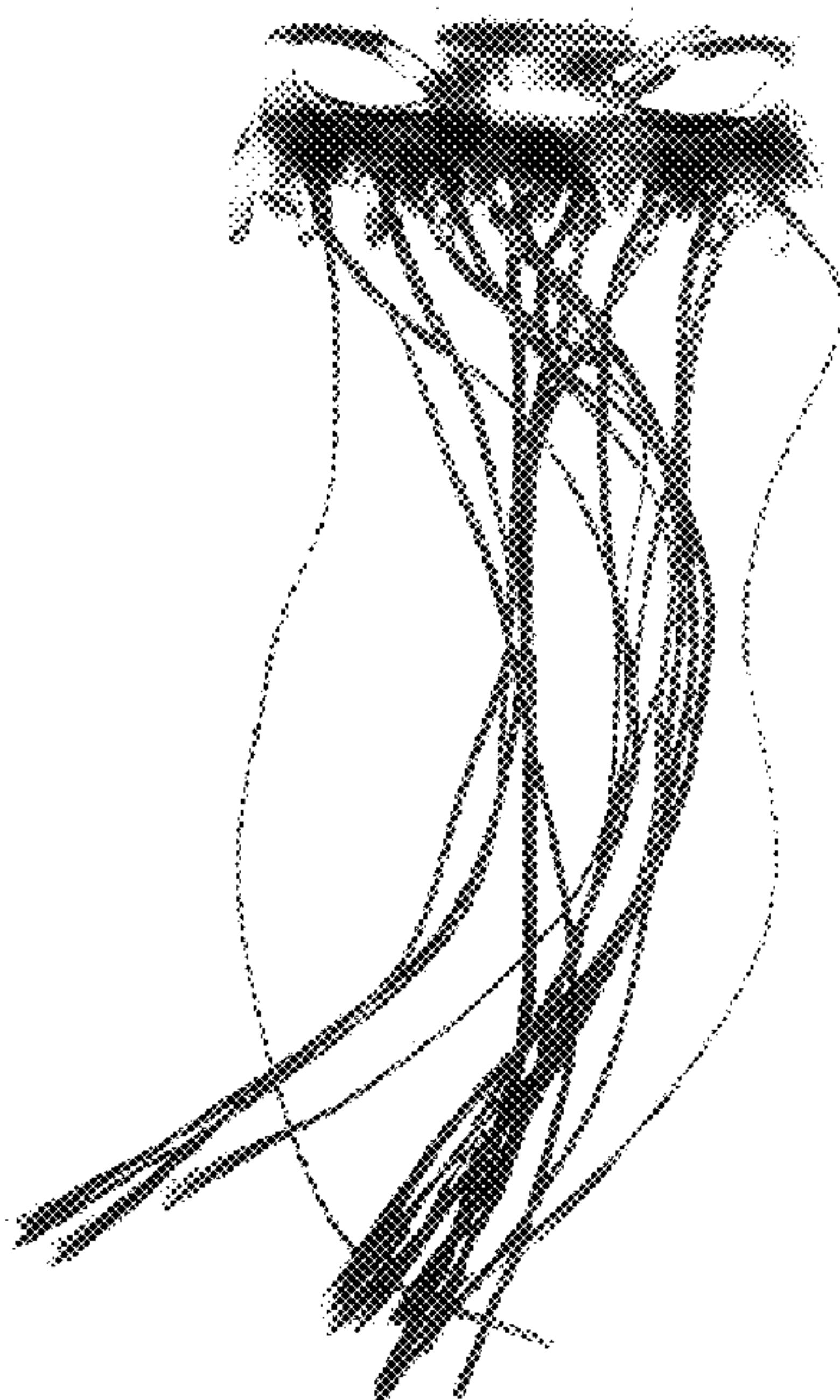

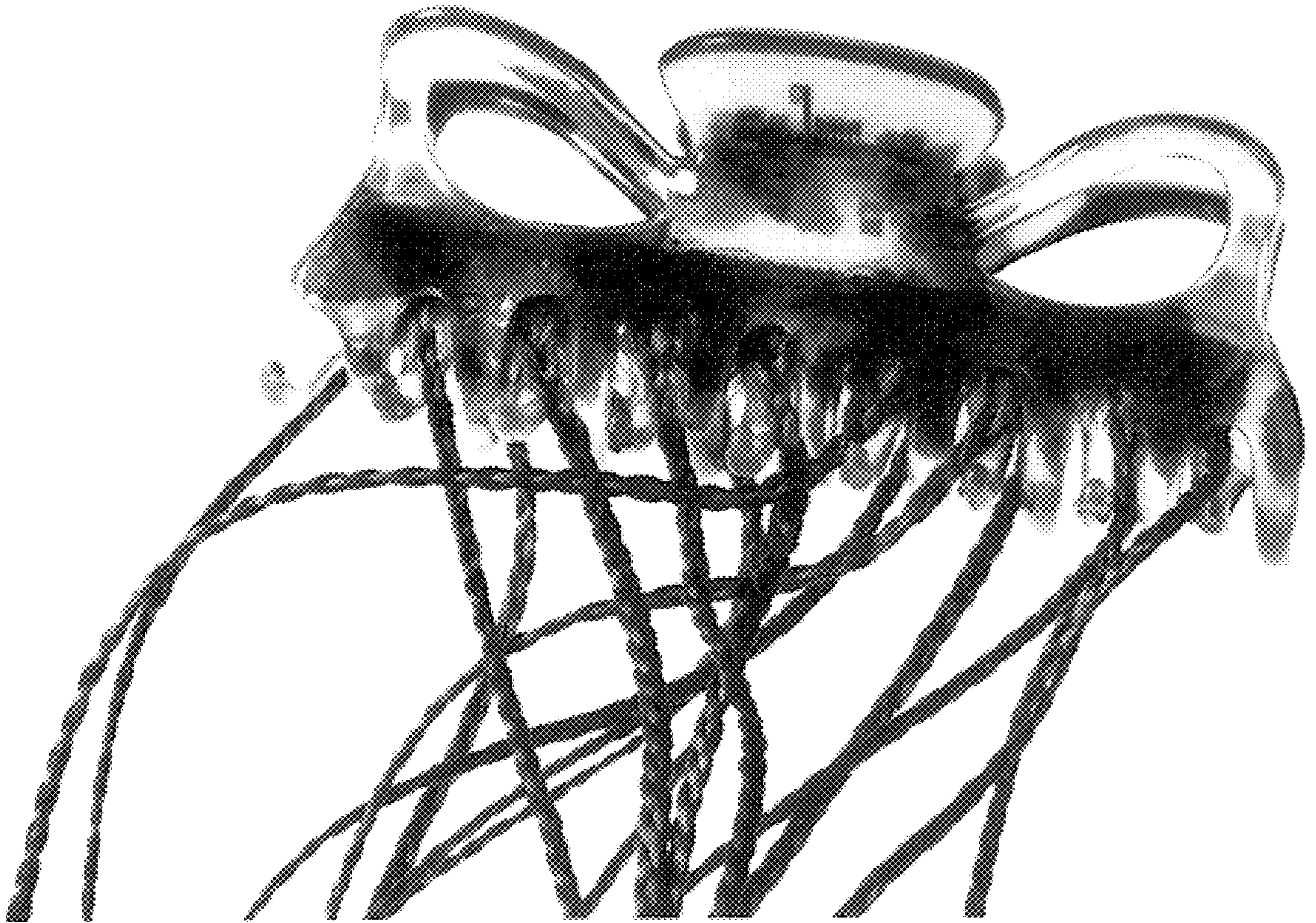

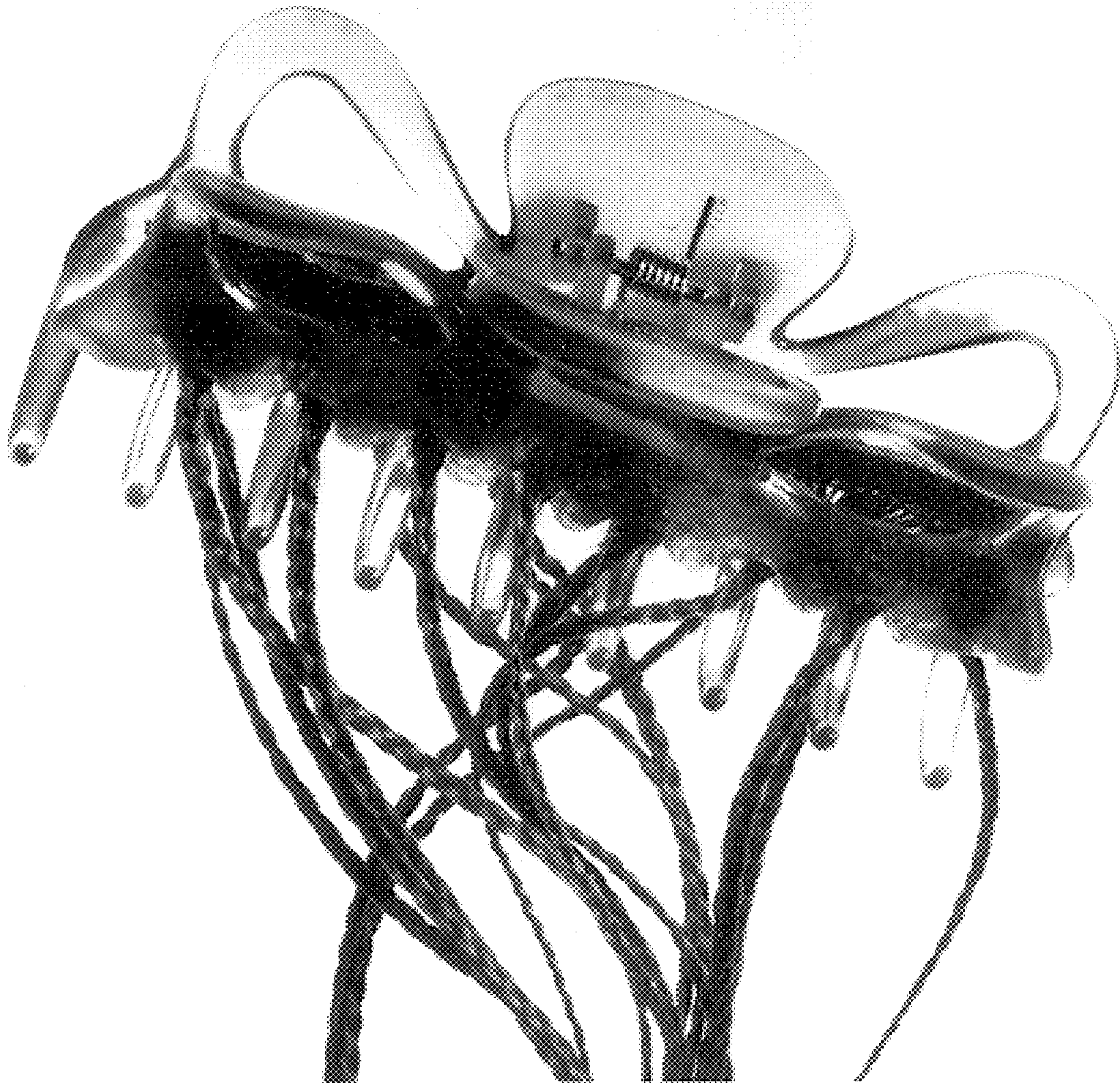

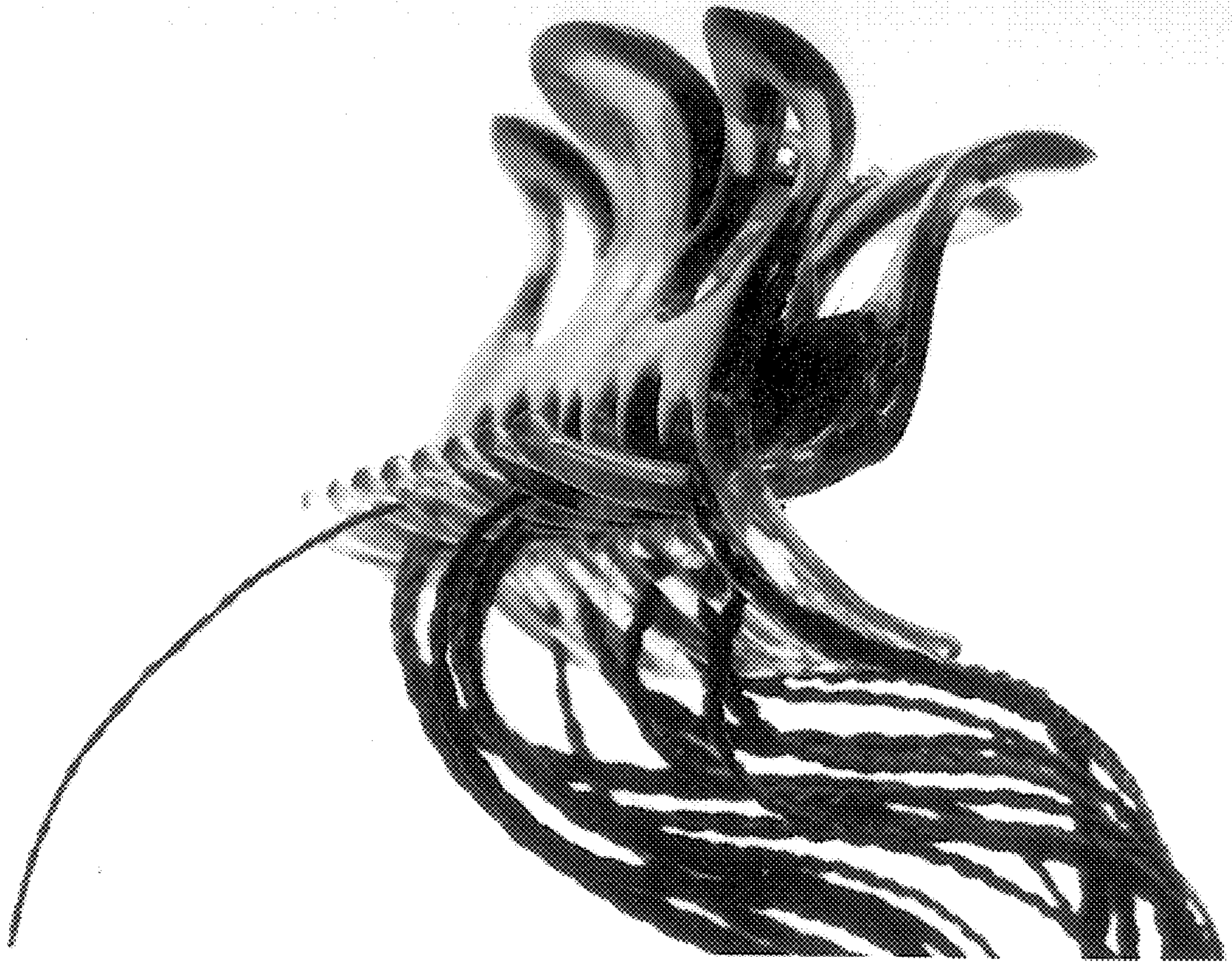
