The ornamental design for a basket, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a basket showing our new design;

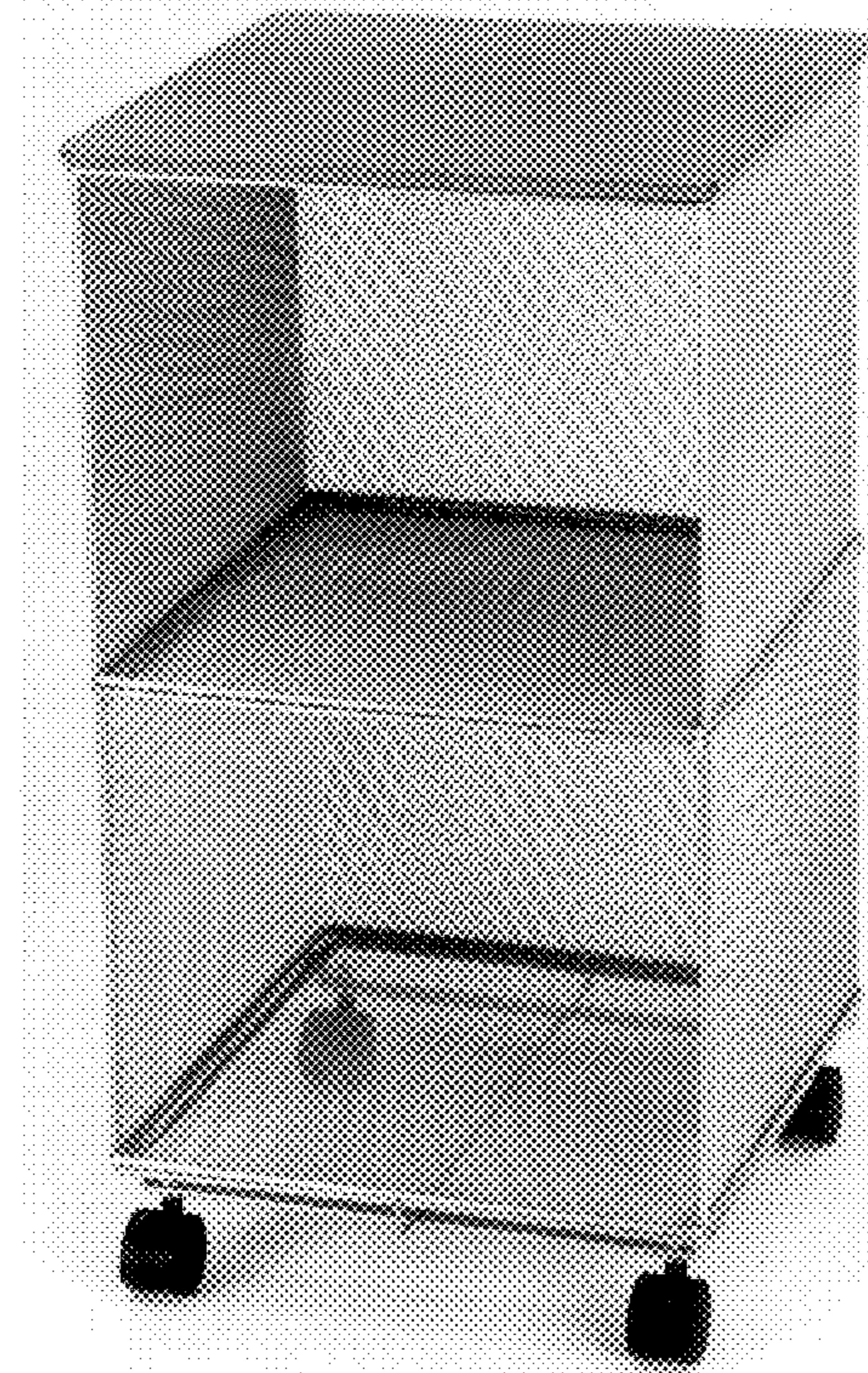

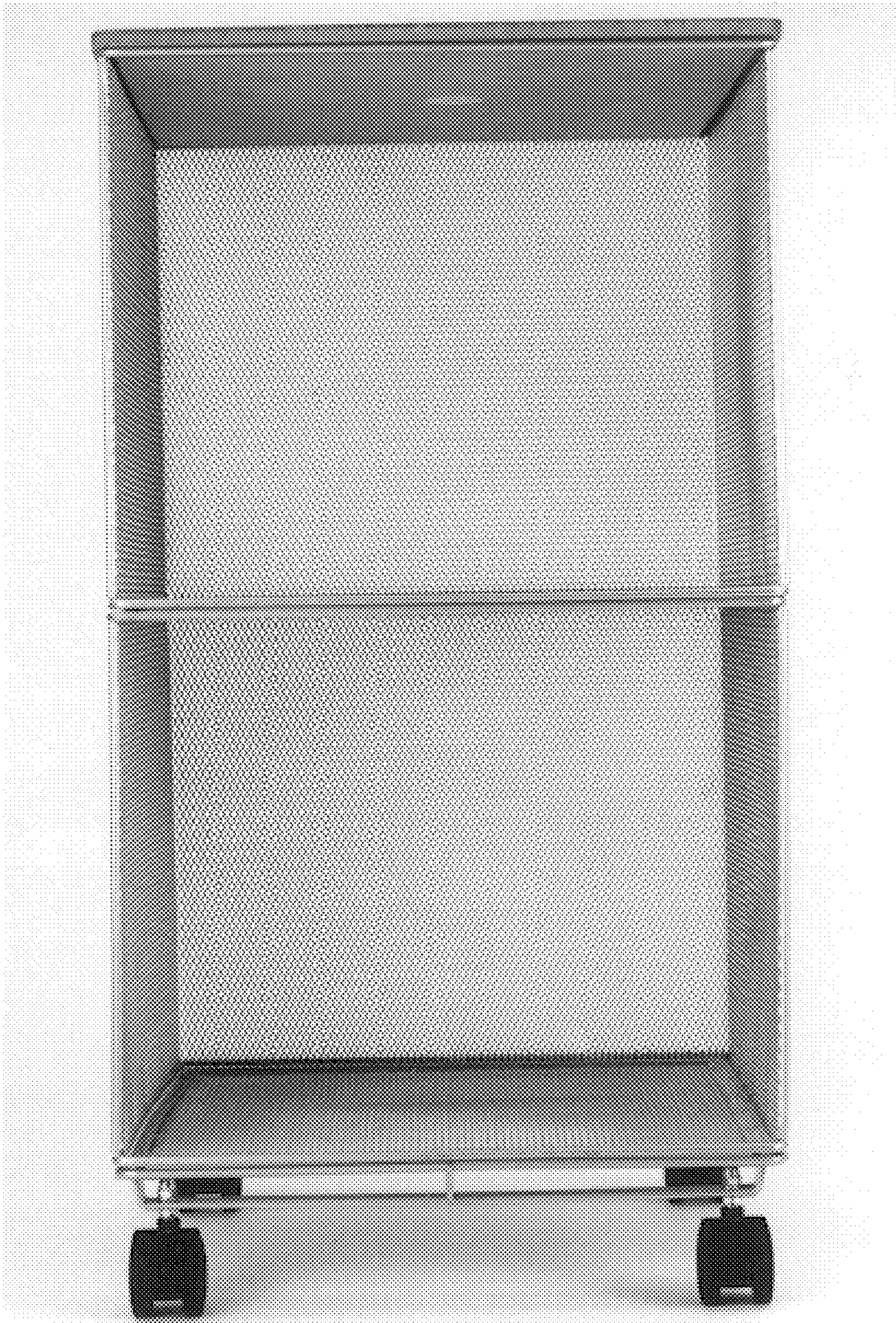

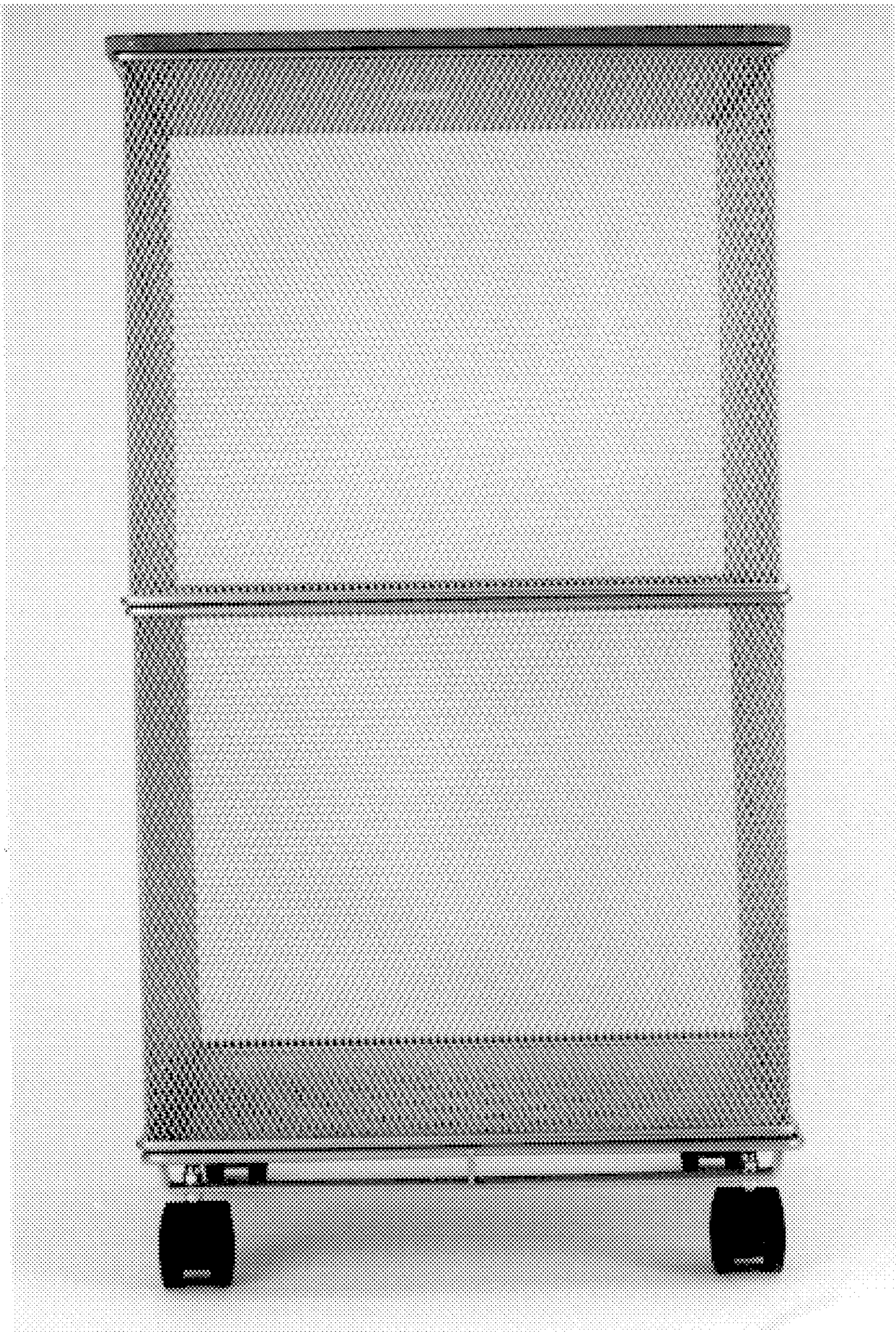

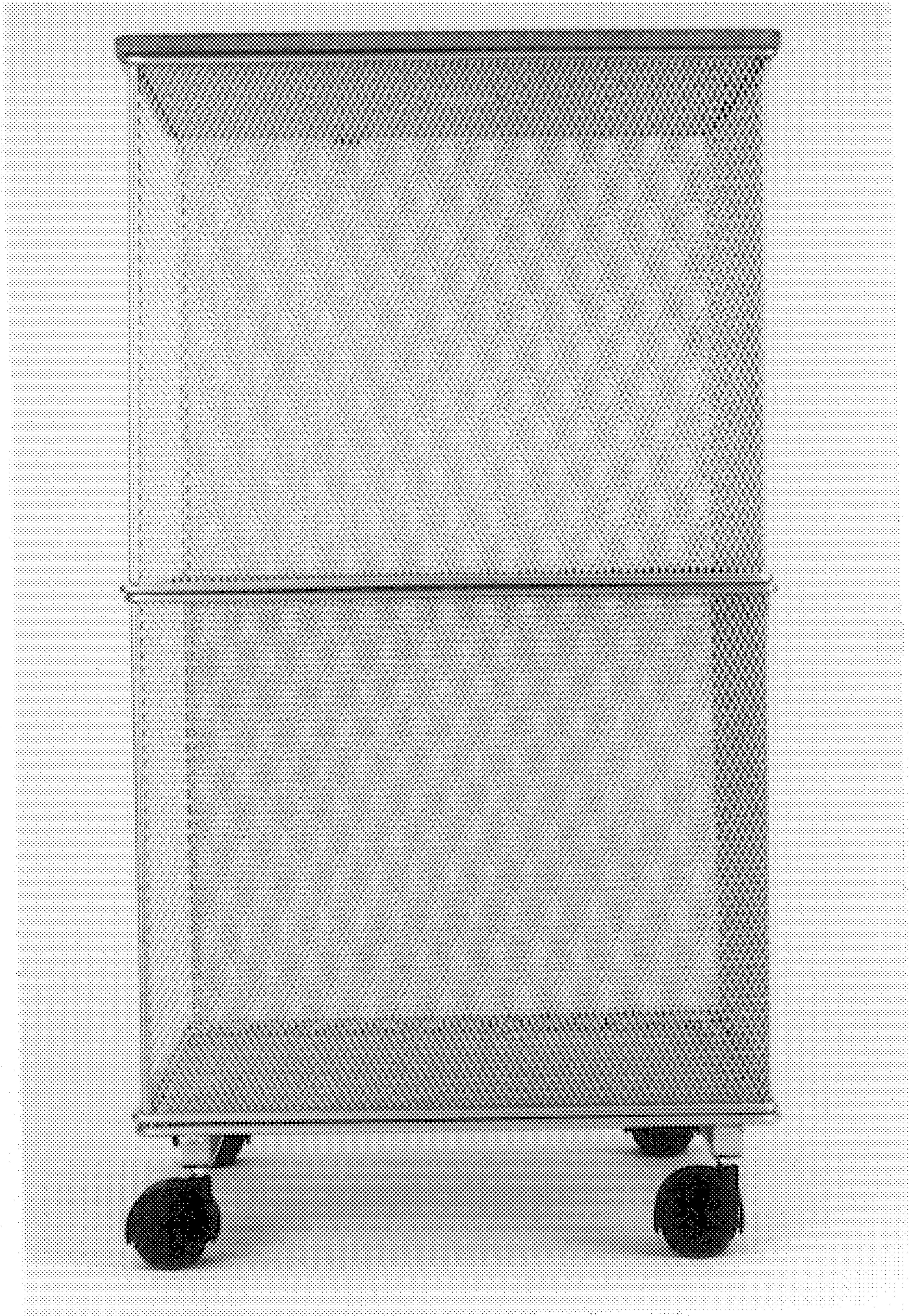
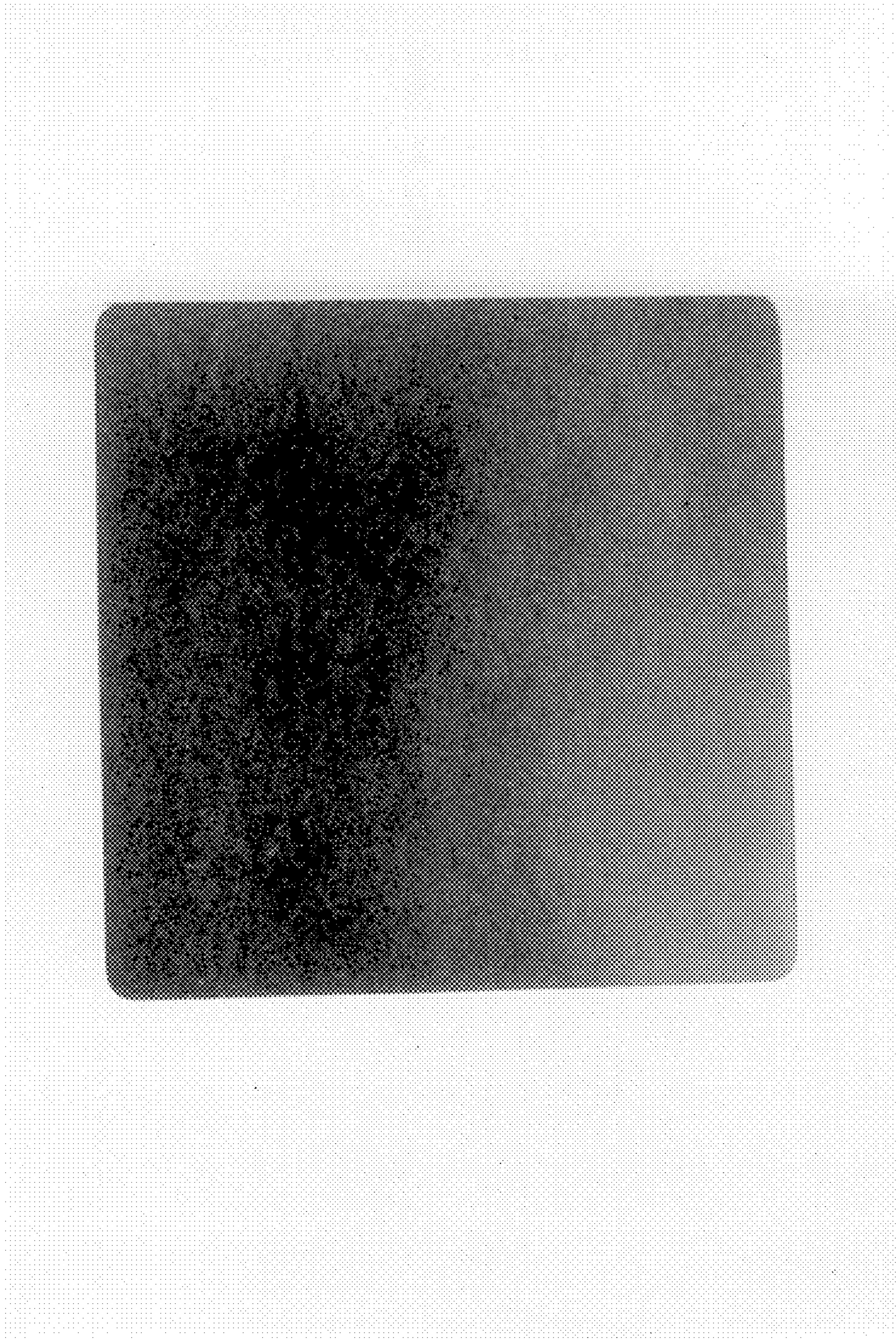

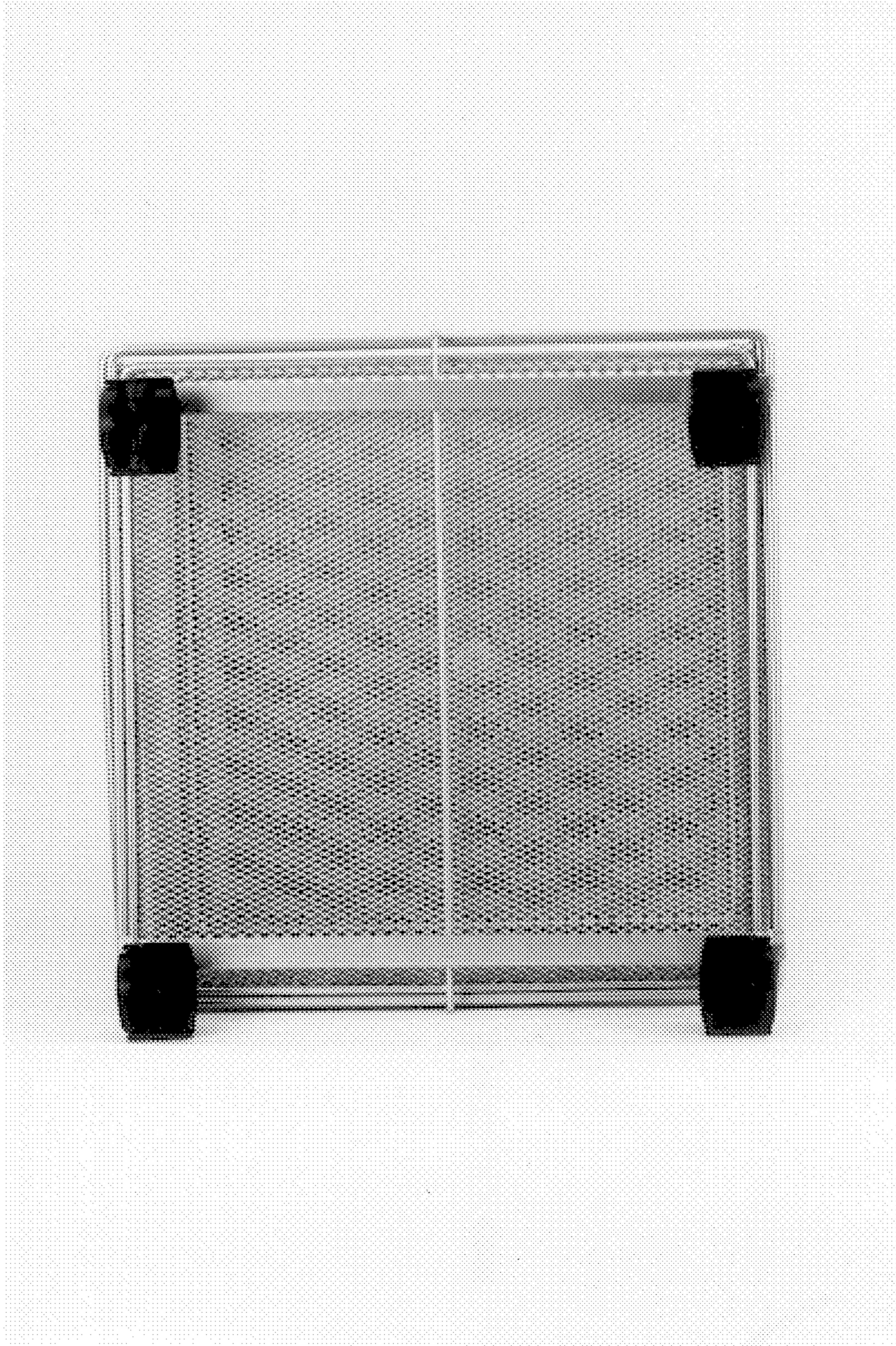

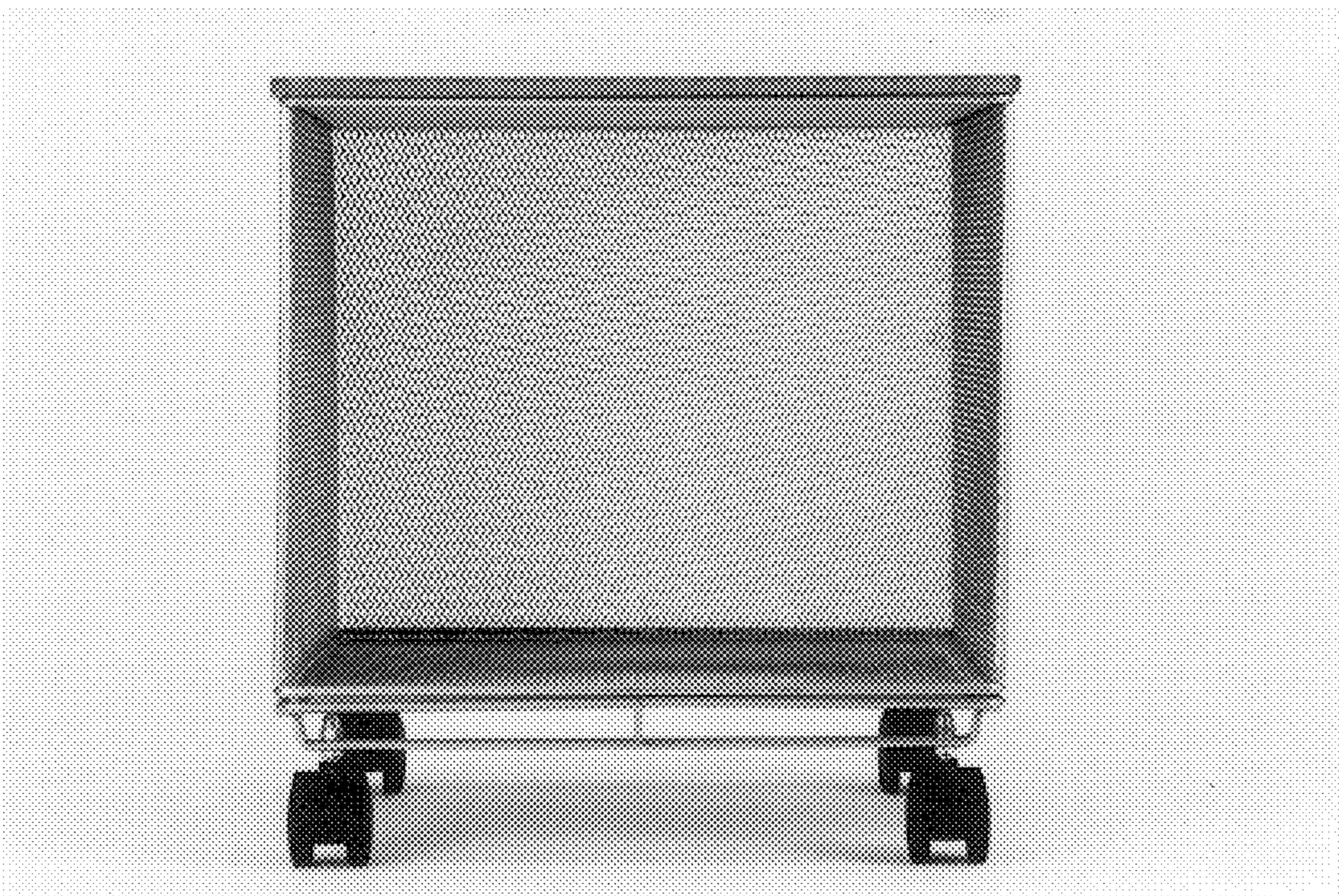

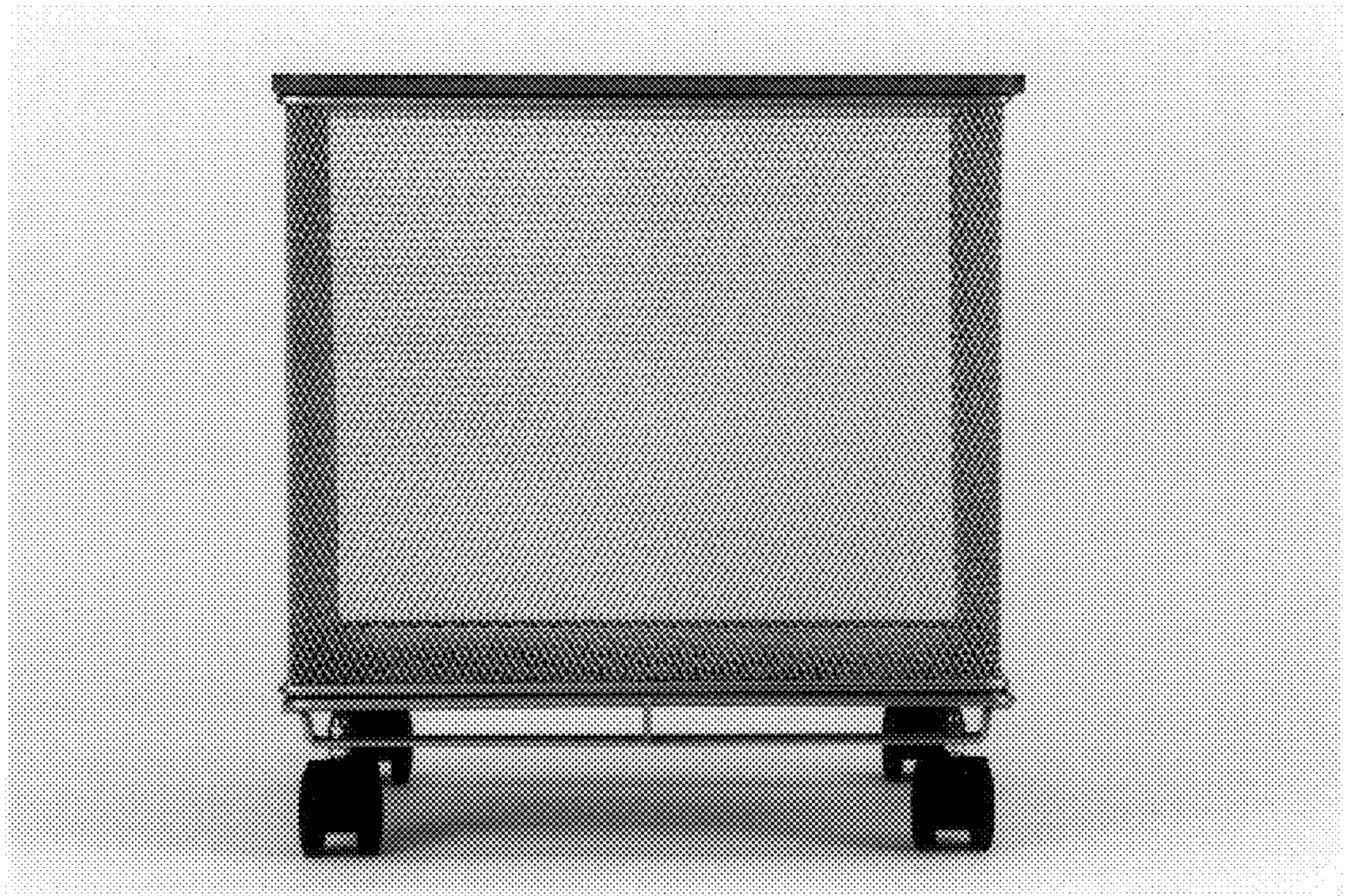

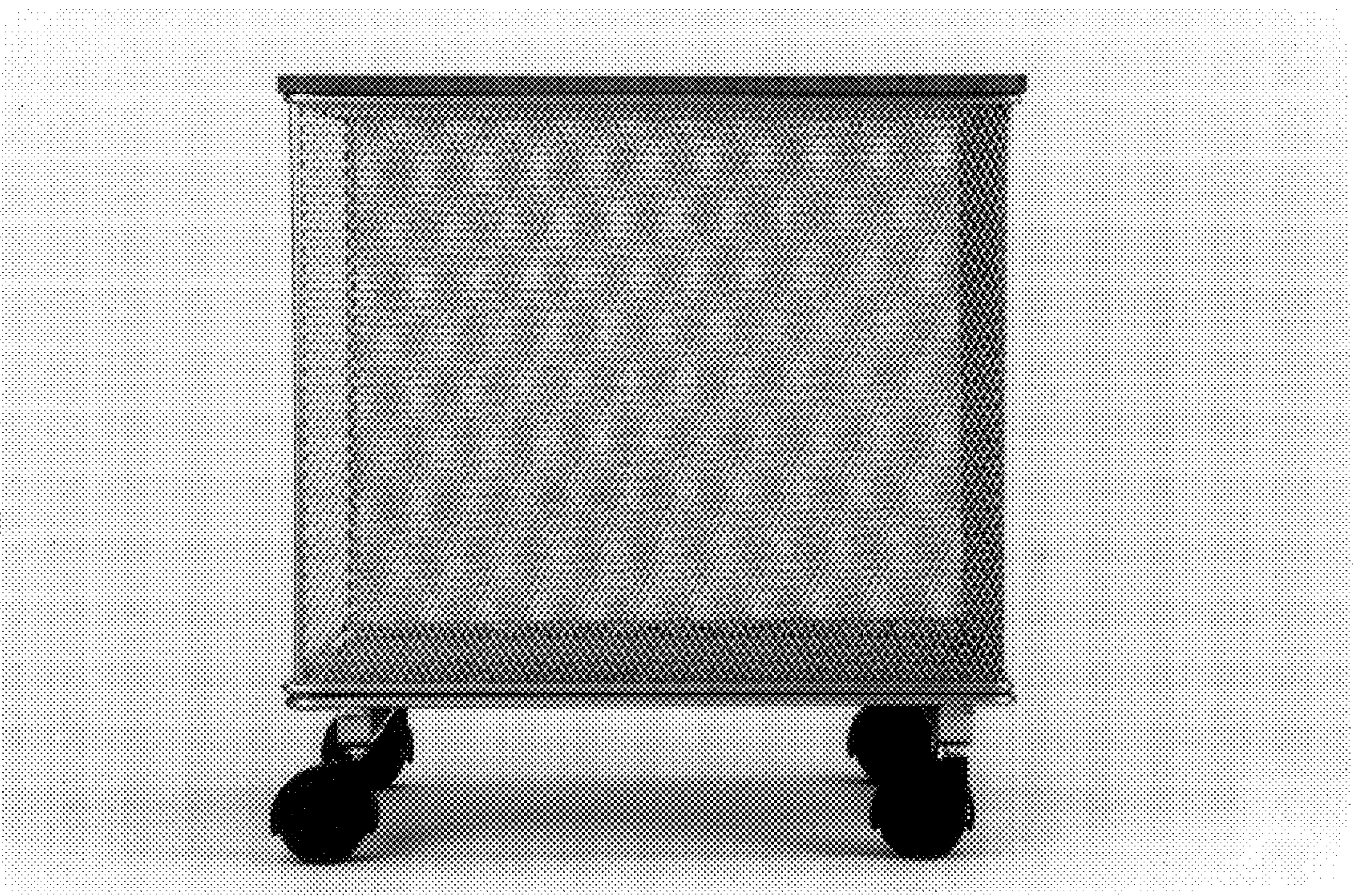

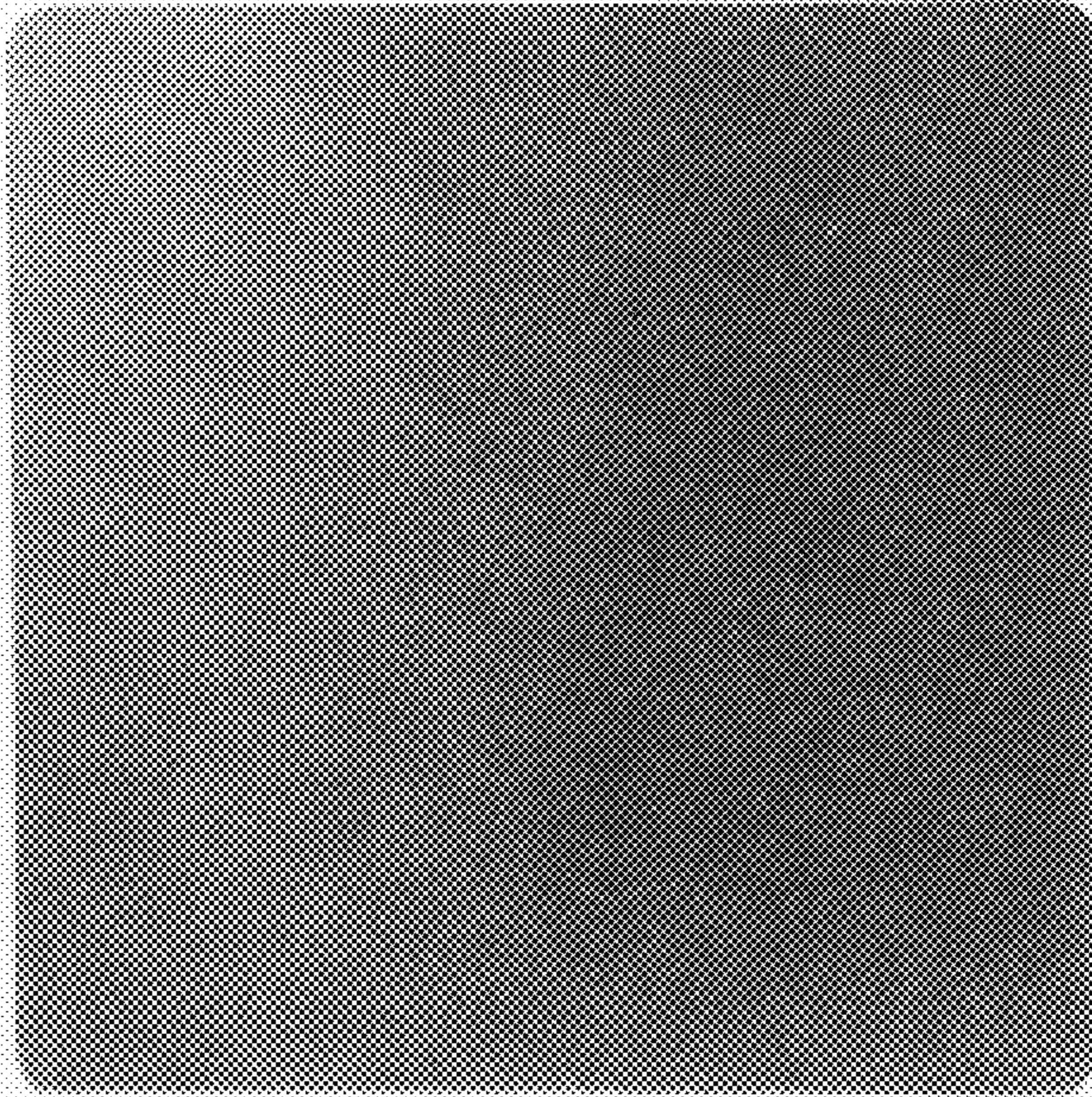

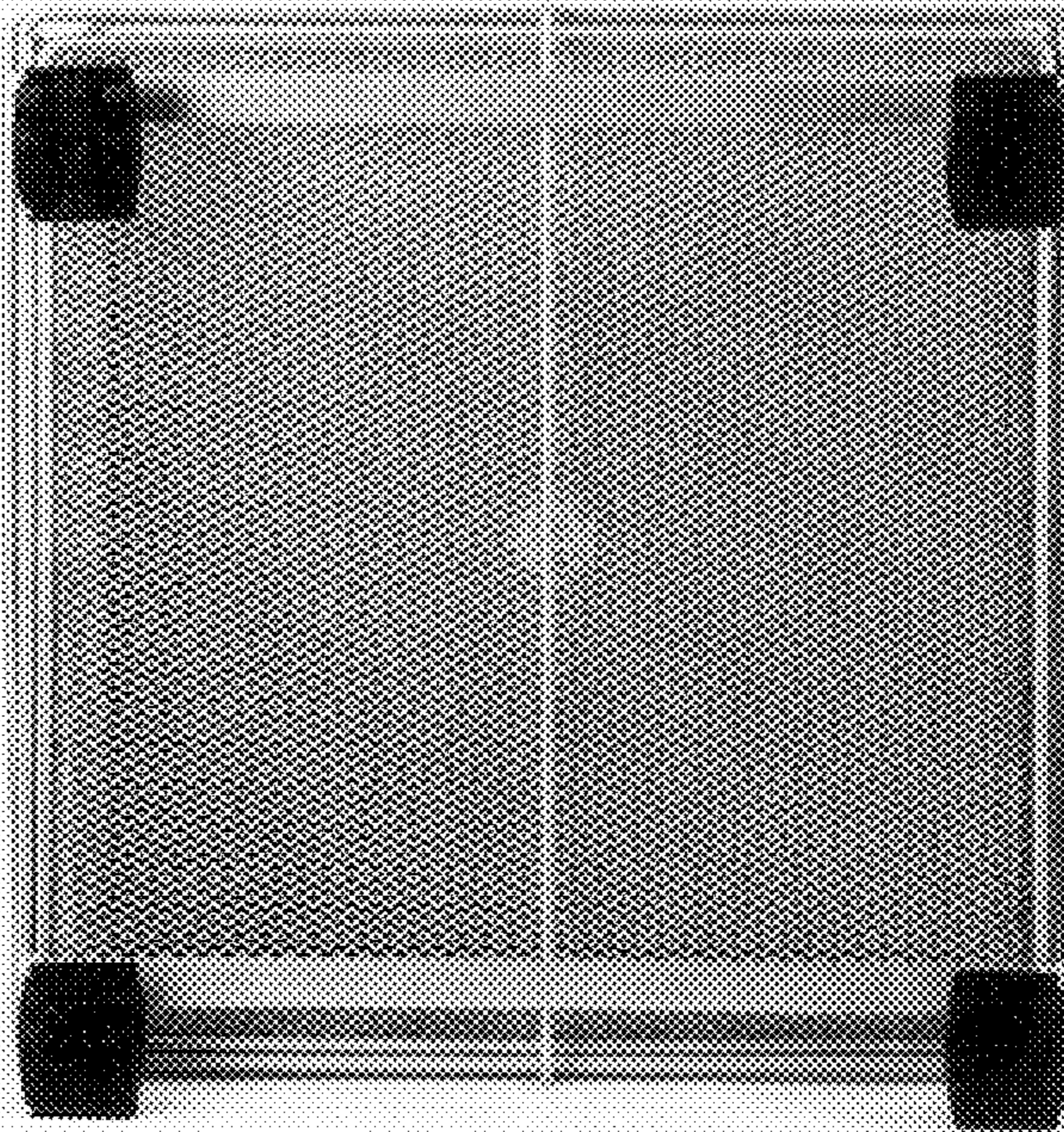
