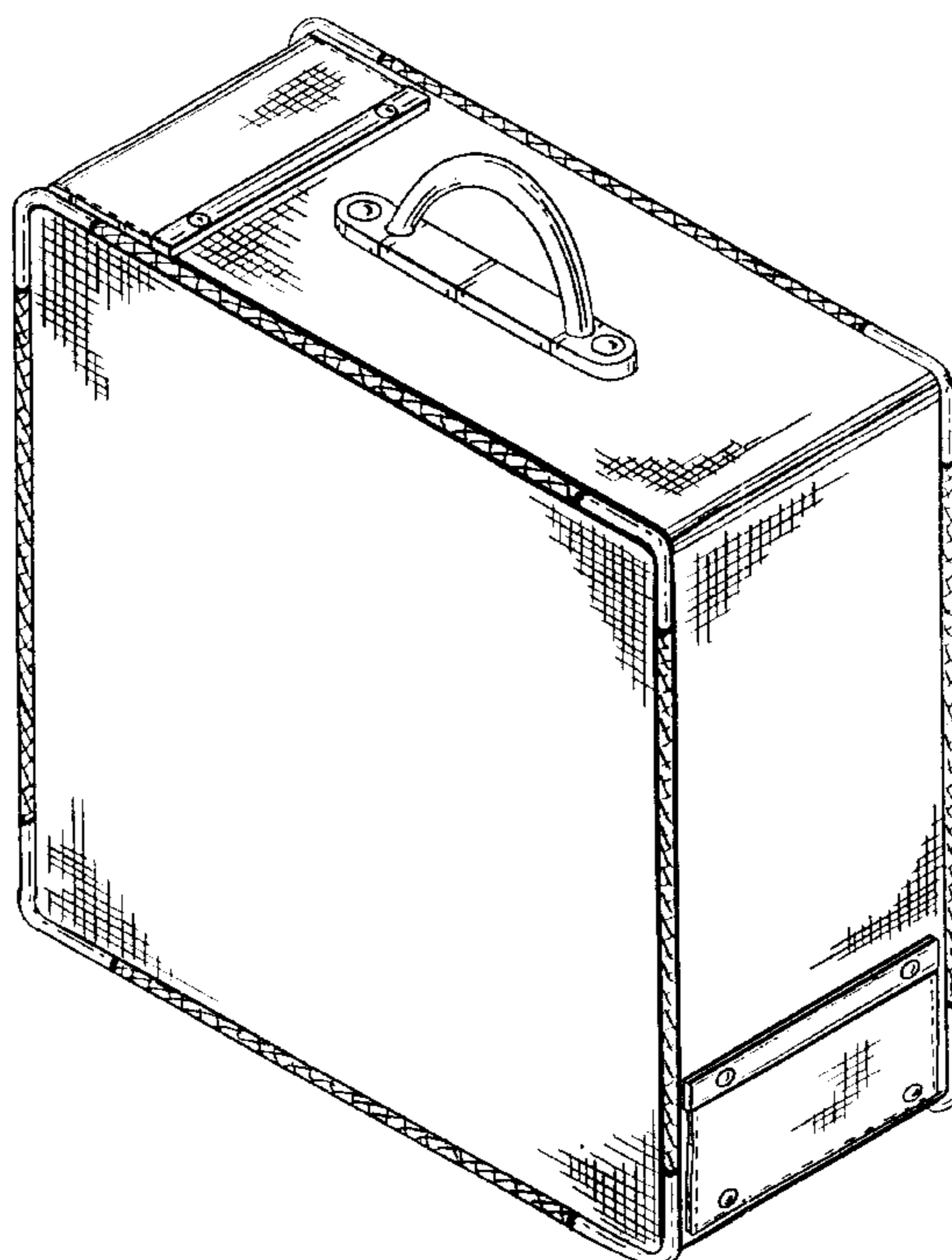
[57] **CLAIM**

The ornamental design for a portable beverage container holder and dispenser, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the portable beverage container holder and dispenser of my new design;
 FIG. 2 is a reduced scale side elevational view thereof, the opposite side being a mirror image thereof;
 FIG. 3 is an end elevational view of the left end of FIG. 2;
 FIG. 4 is an end elevational view of the right end of FIG. 2;
 FIG. 5 is a top plan view of FIG. 2;
 FIG. 6 is a bottom plan view of FIG. 2;
 FIG. 7 is a perspective view of a first modified embodiment of the portable beverage container holder and dispenser of FIG. 1;
 FIG. 8 is a reduced scale side elevational view of FIG. 7, the opposite side being a mirror image thereof;
 FIG. 9 is an end elevational view of the left end of FIG. 8;
 FIG. 10 is an end elevational view of the right end of FIG. 8;
 FIG. 11 is a top plan view of FIG. 8;
 FIG. 12 is a bottom plan view of FIG. 8;
 FIG. 13 is a perspective view of a second modified embodiment of the portable beverage container holder and dispenser of FIG. 1;
 FIG. 14 is a reduced scale side elevational view of FIG. 13, the opposite side being a mirror image thereof;
 FIG. 15 is an elevational view of the left end of FIG. 14;
 FIG. 16 is an end elevational view of the right end of FIG. 14;
 FIG. 17 is a top plan view of FIG. 14; and,
 FIG. 18 is a bottom plan view of FIG. 14.

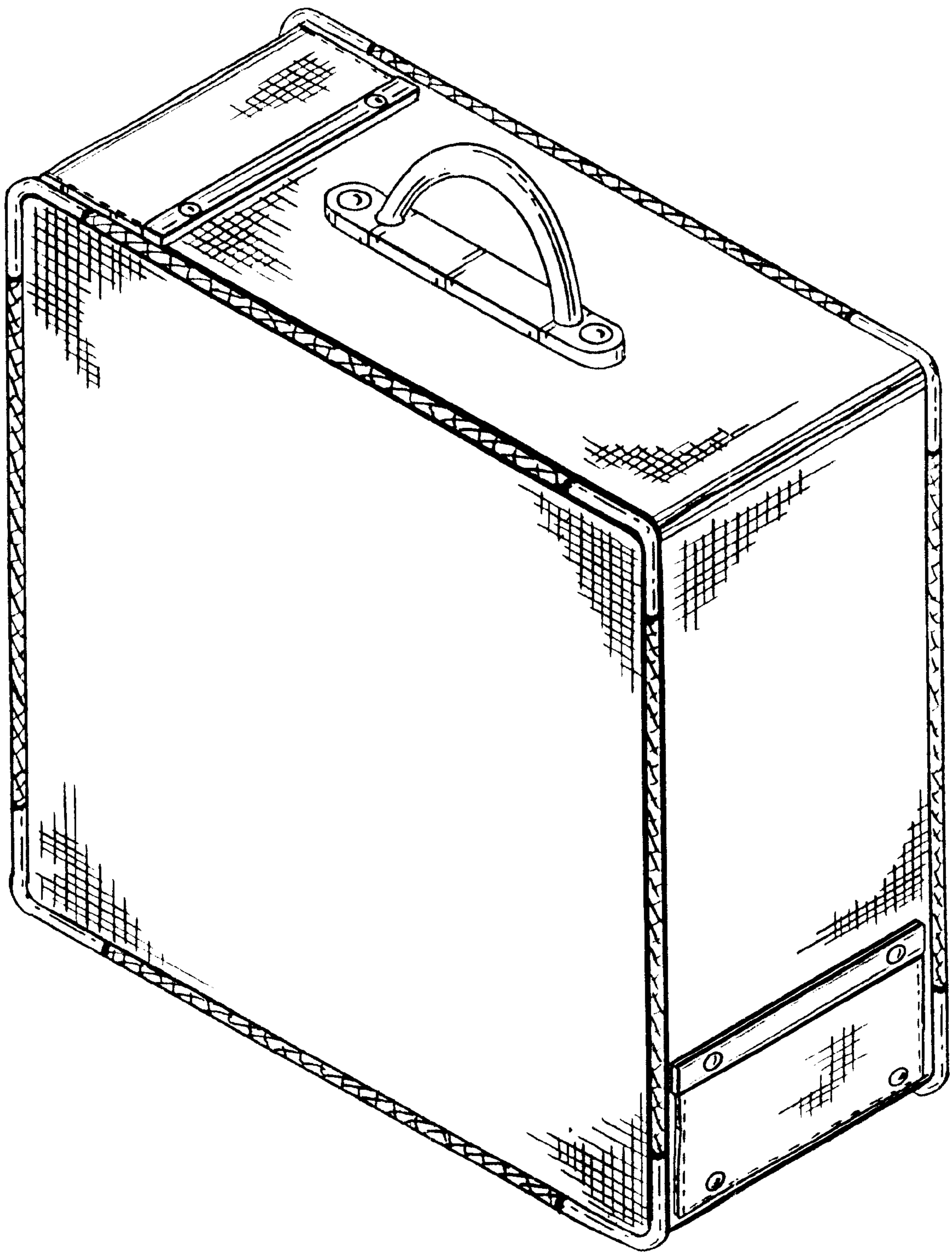

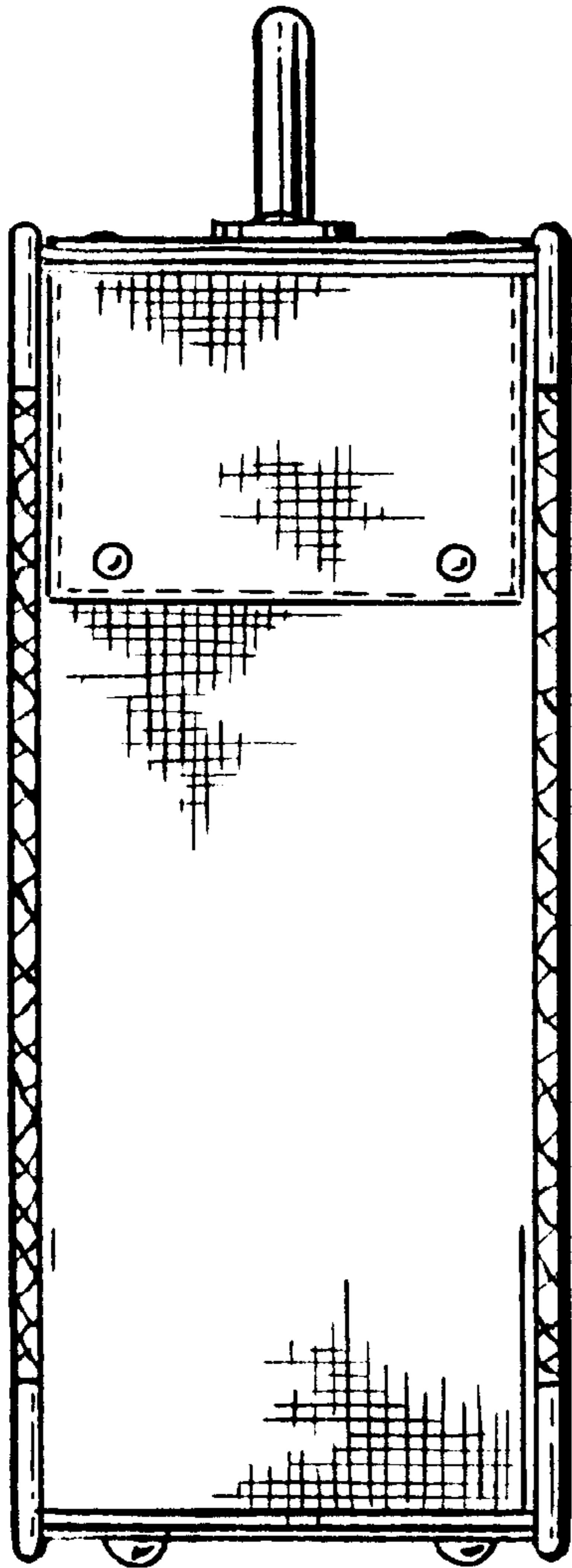

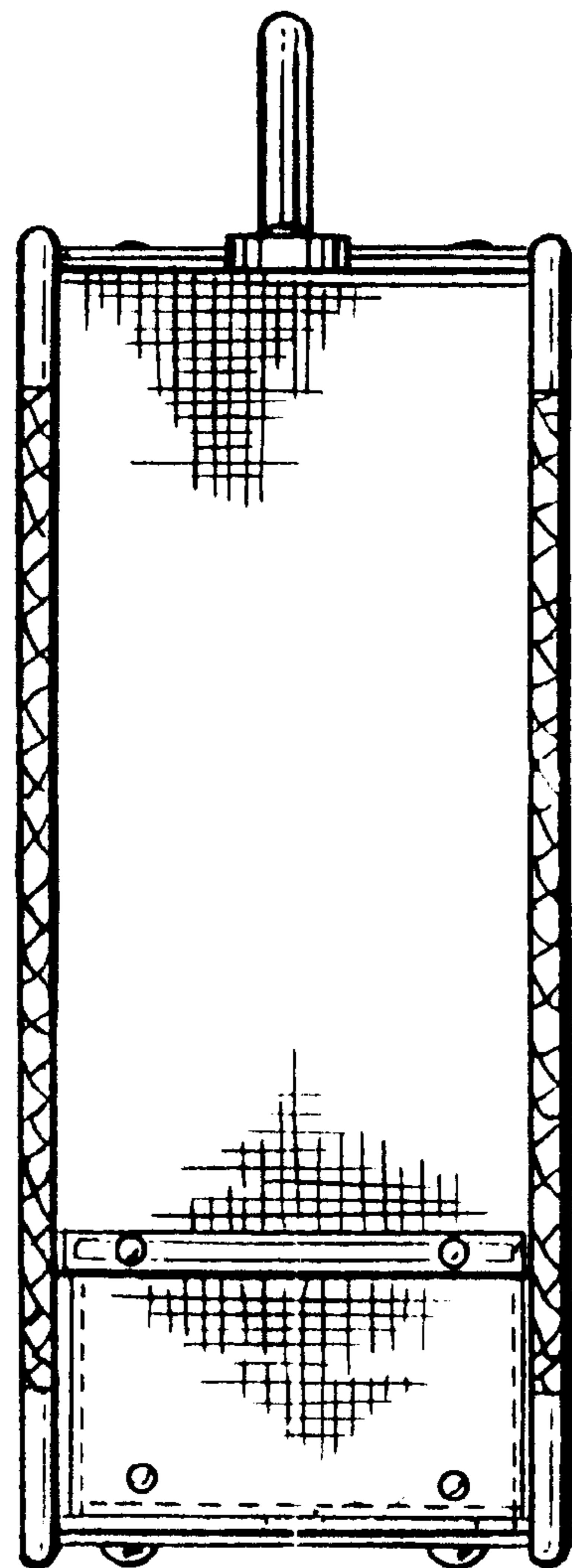

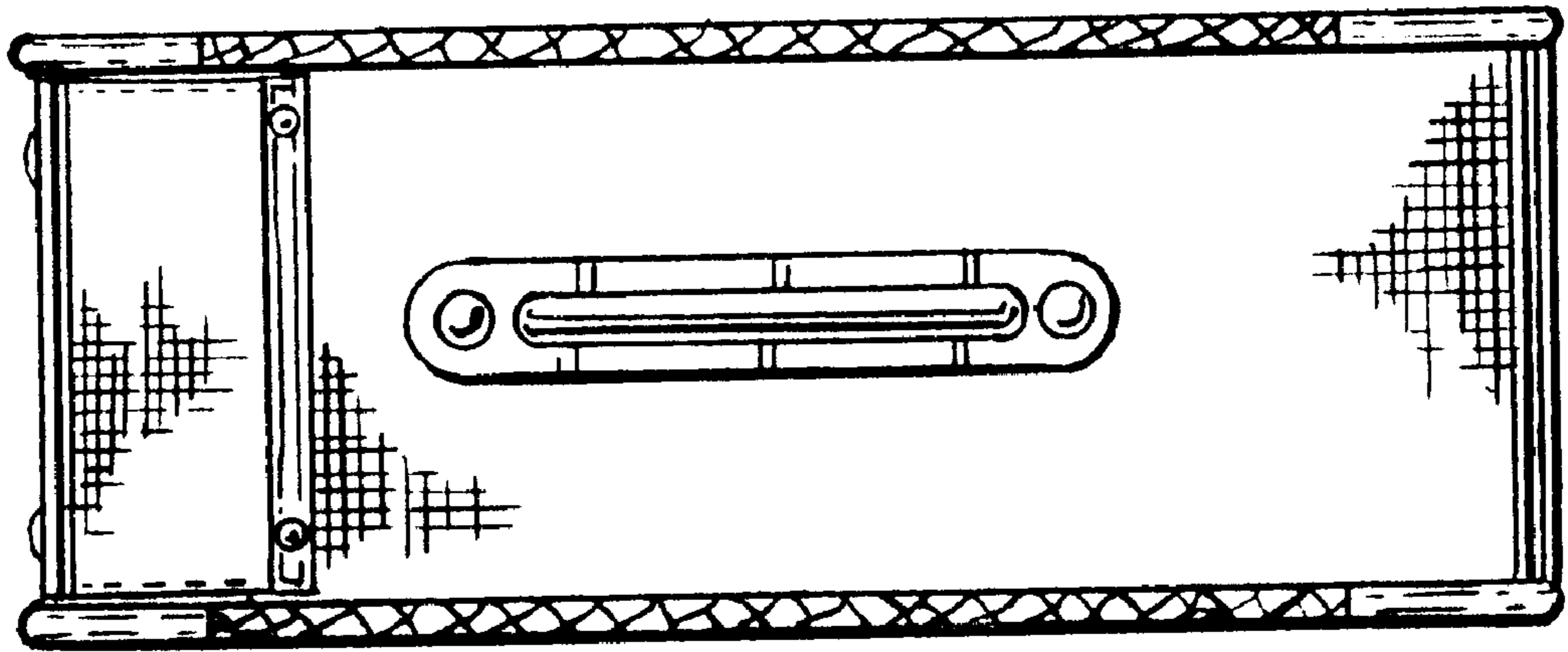

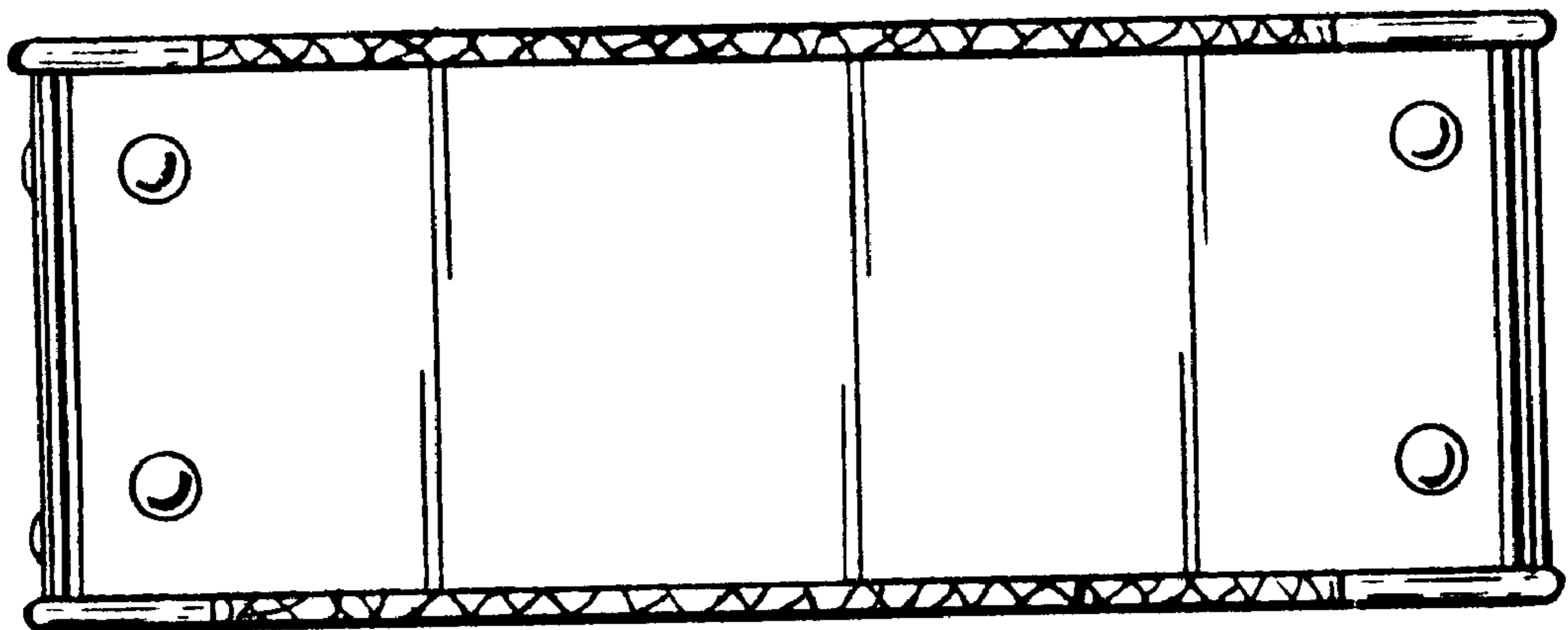

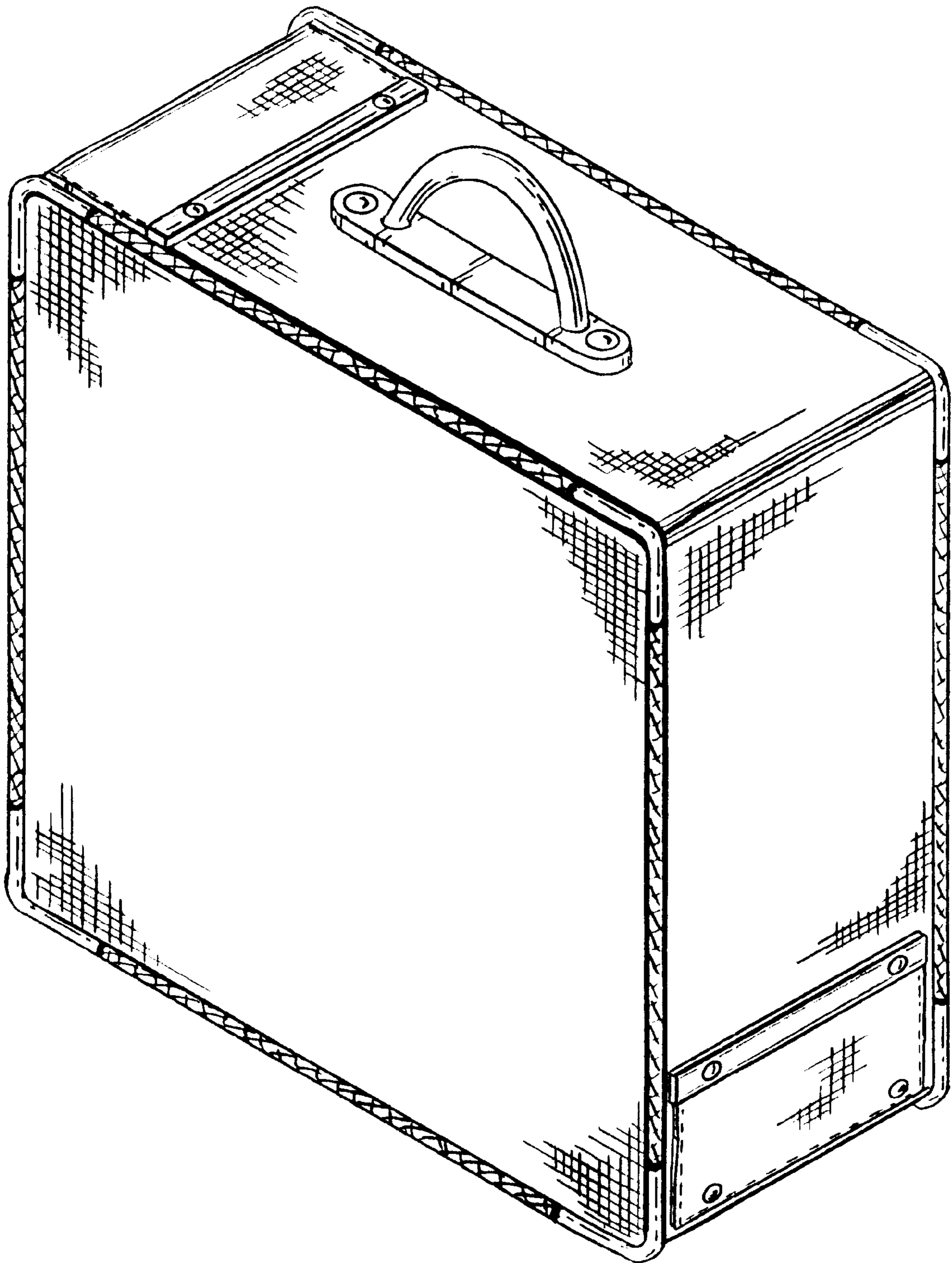

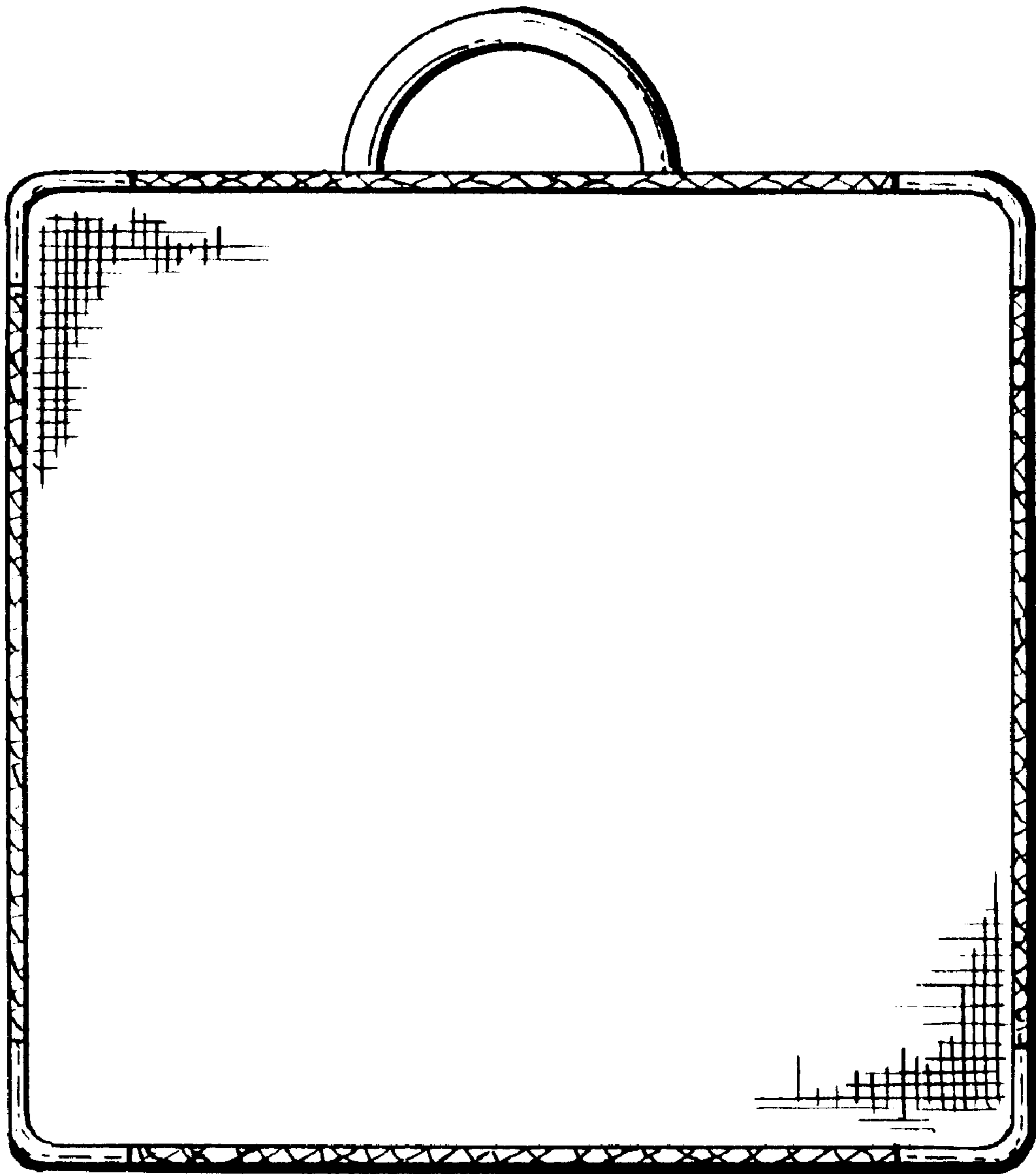

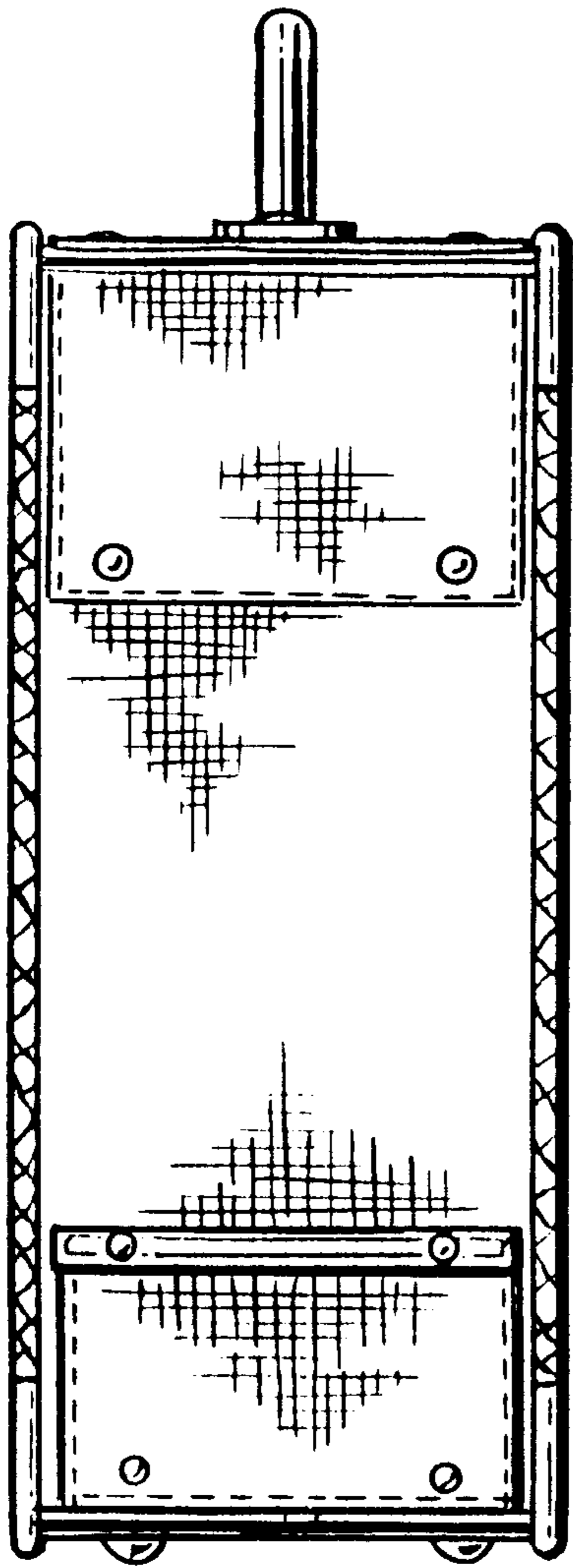

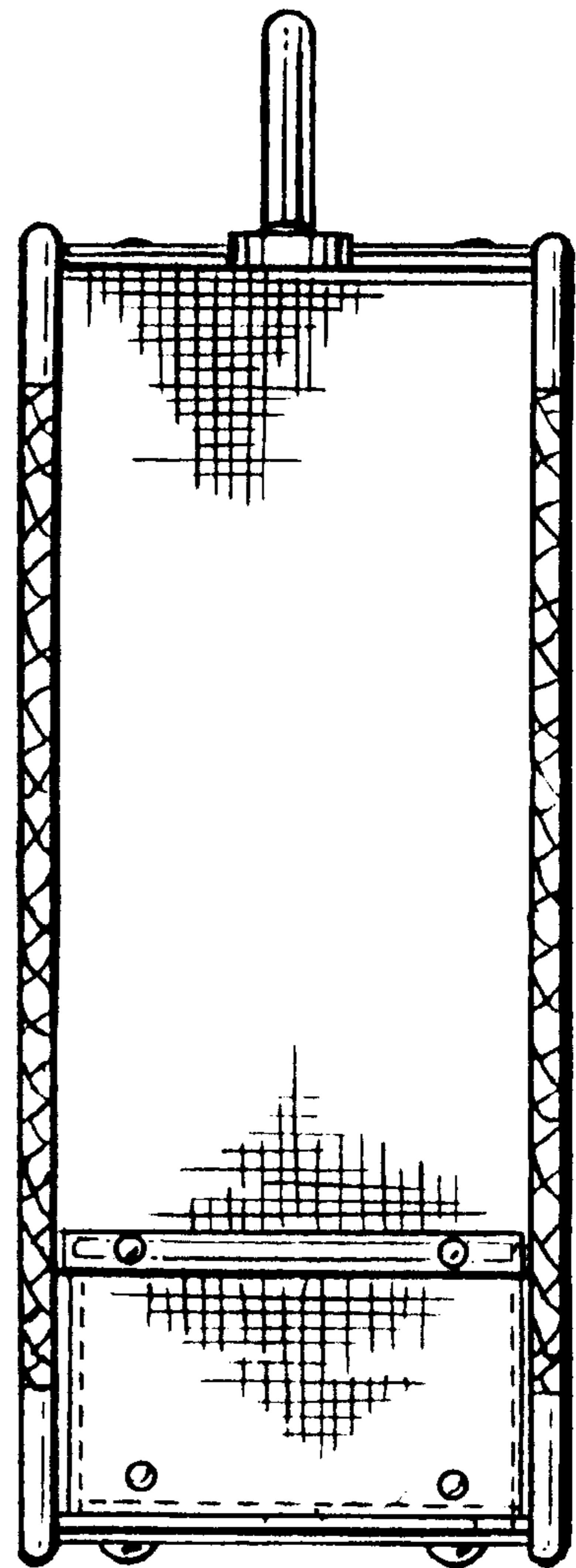

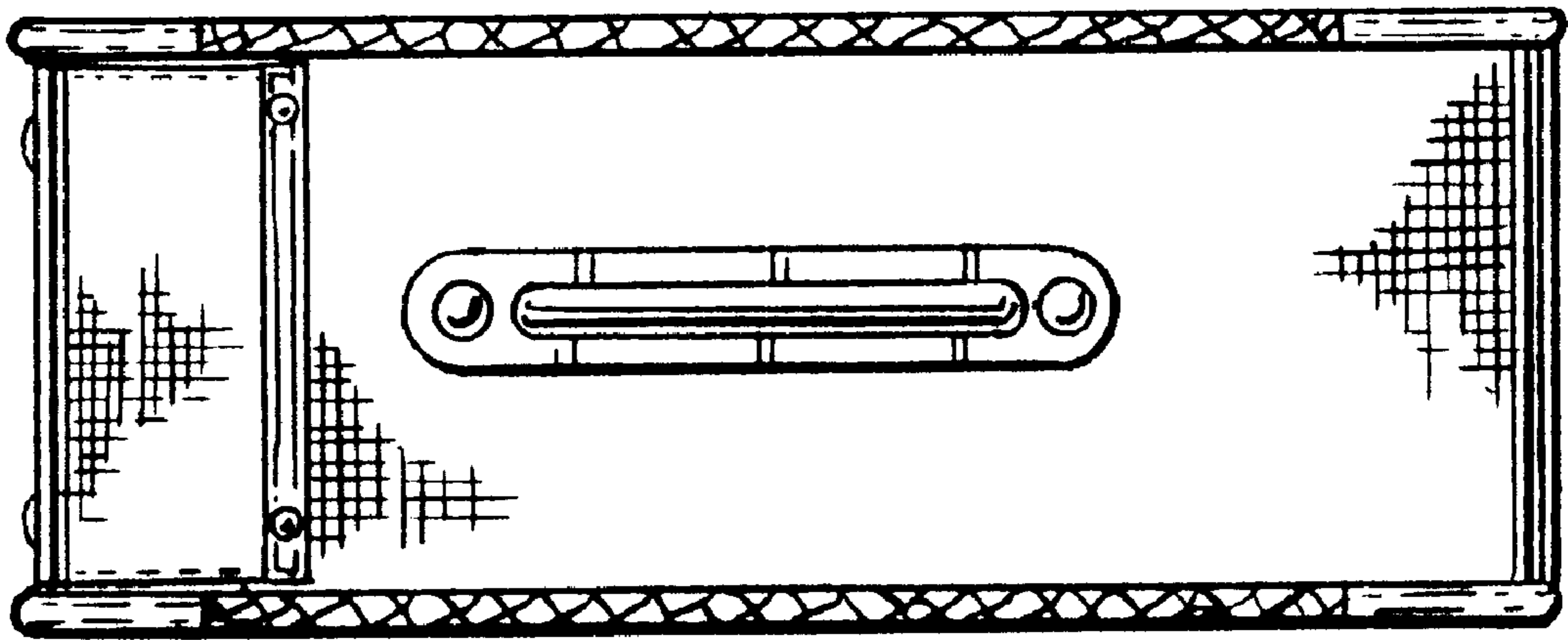

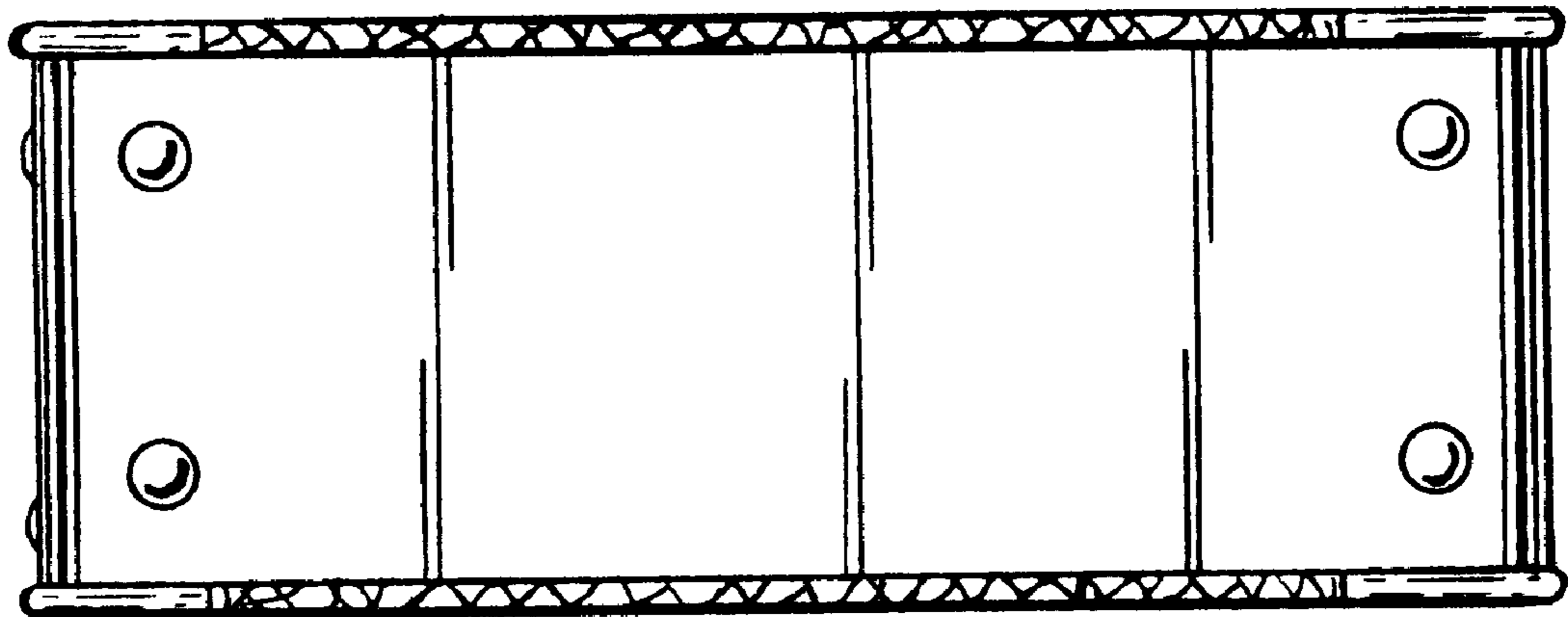

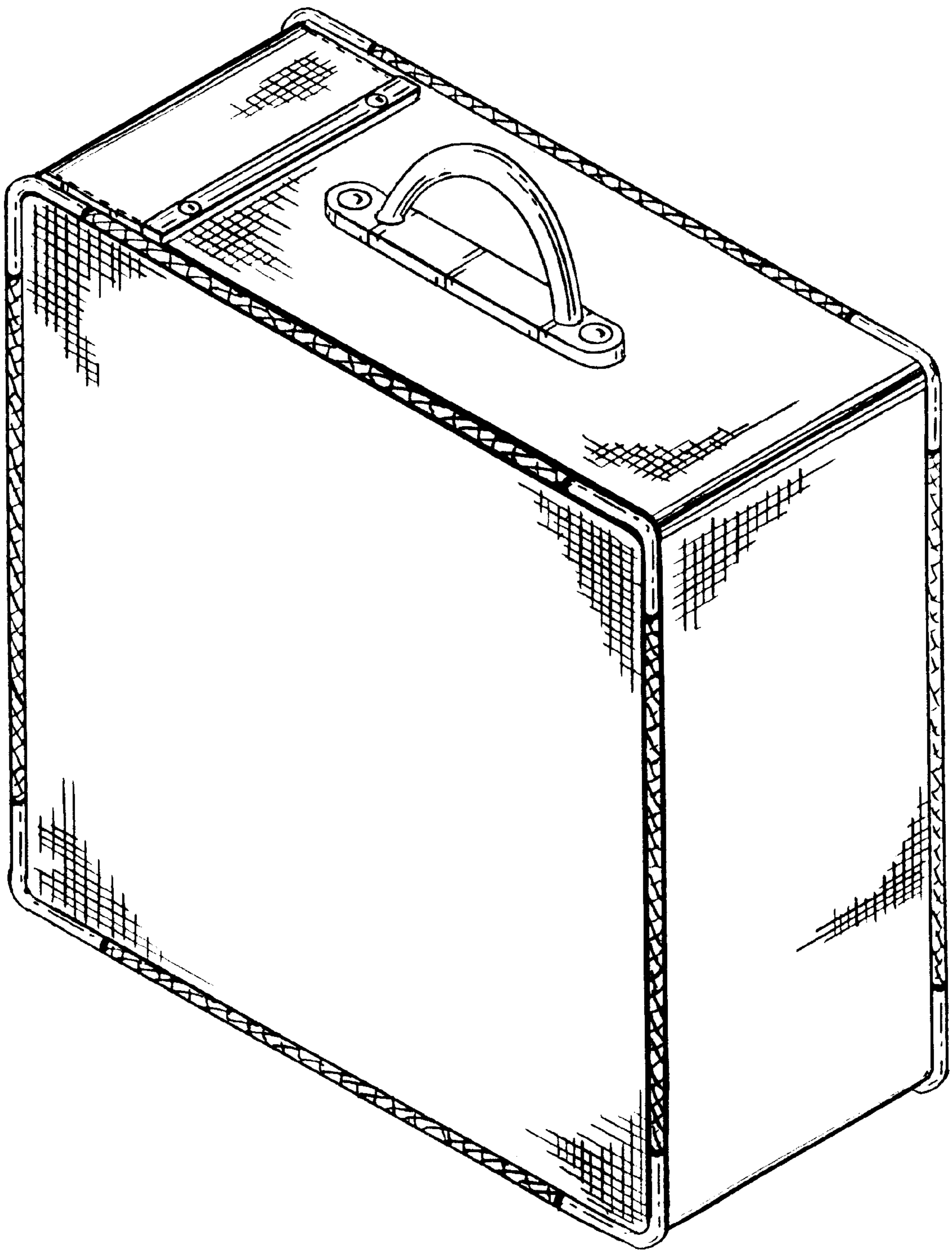

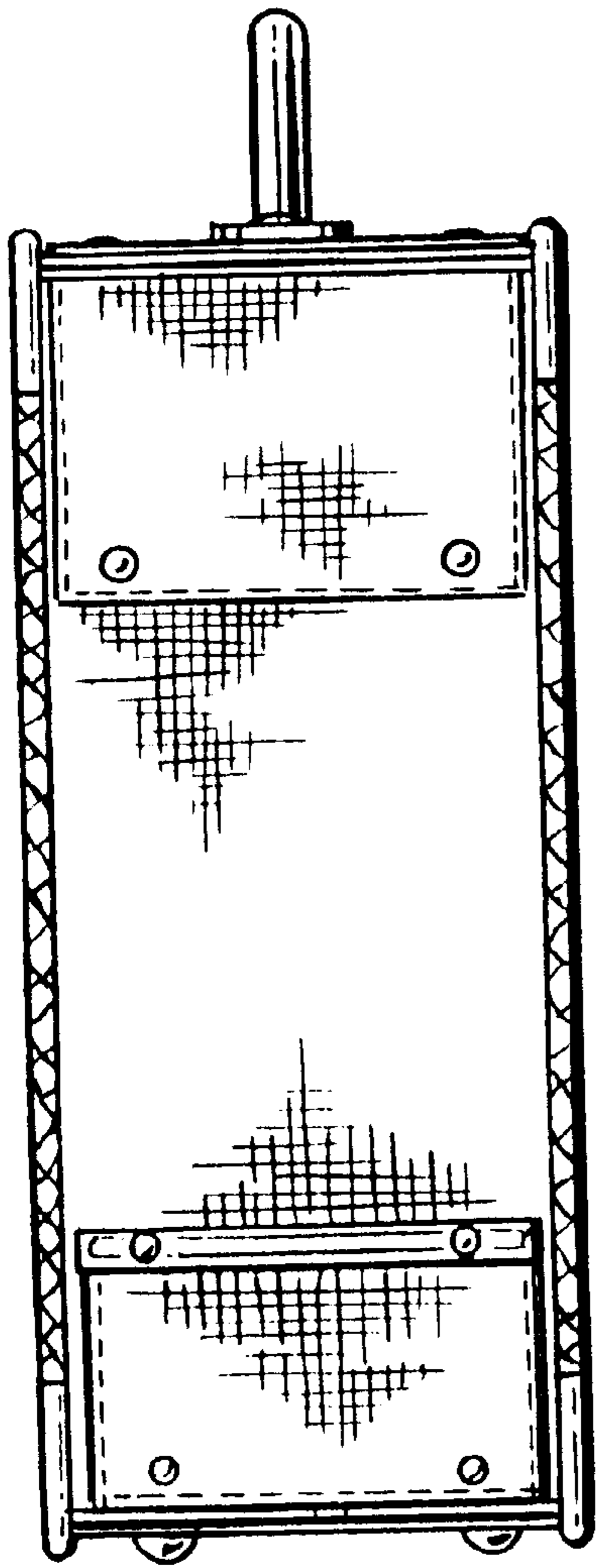

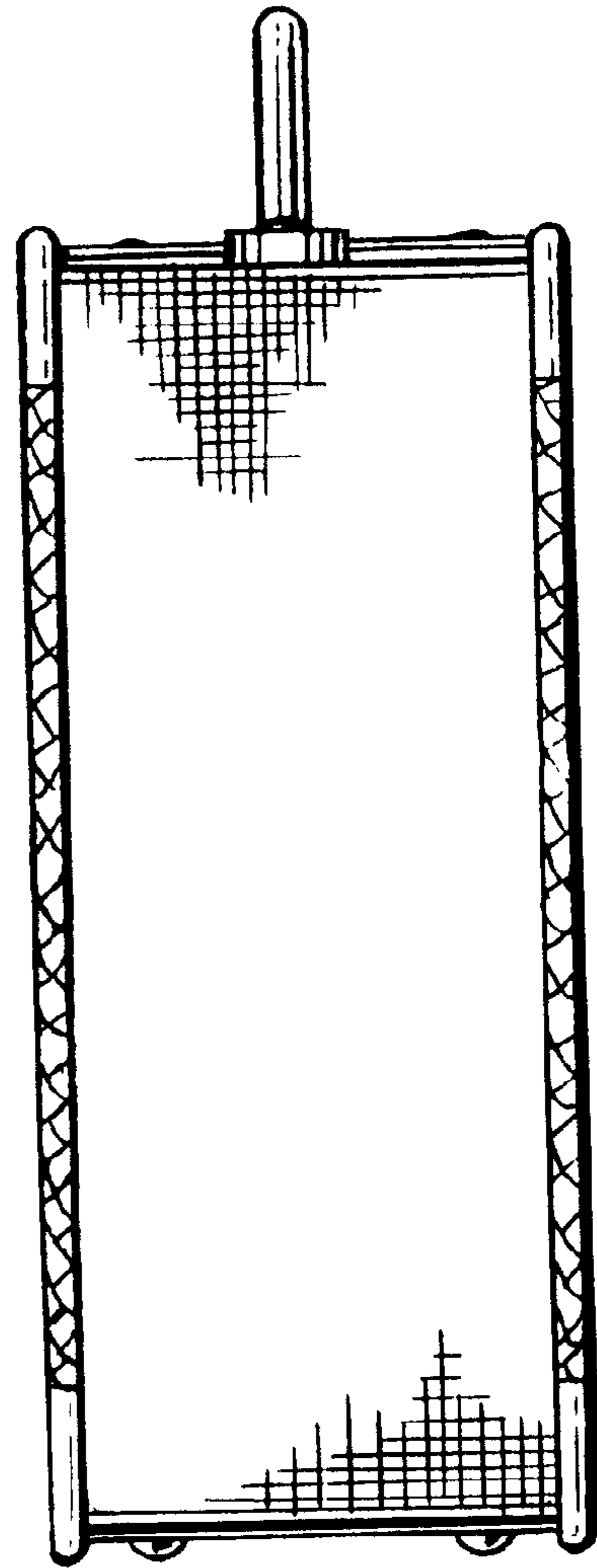

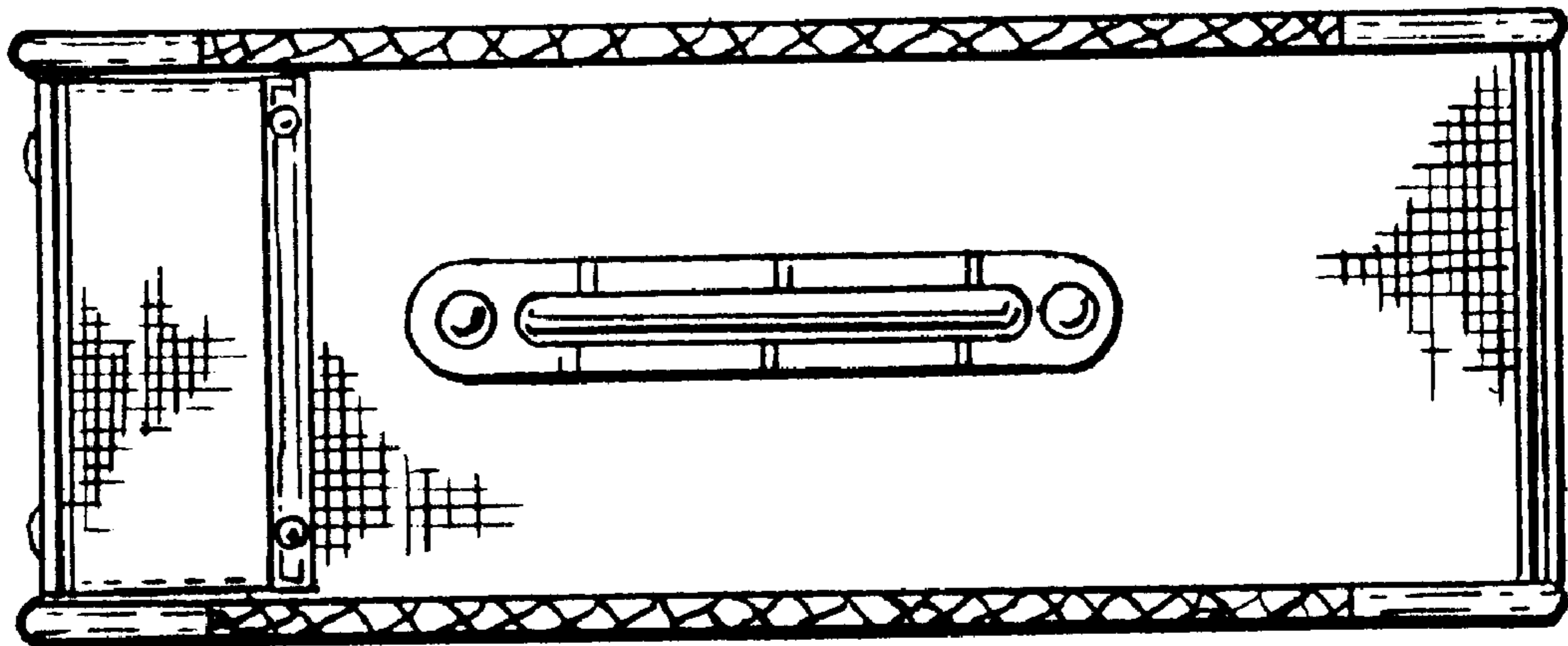

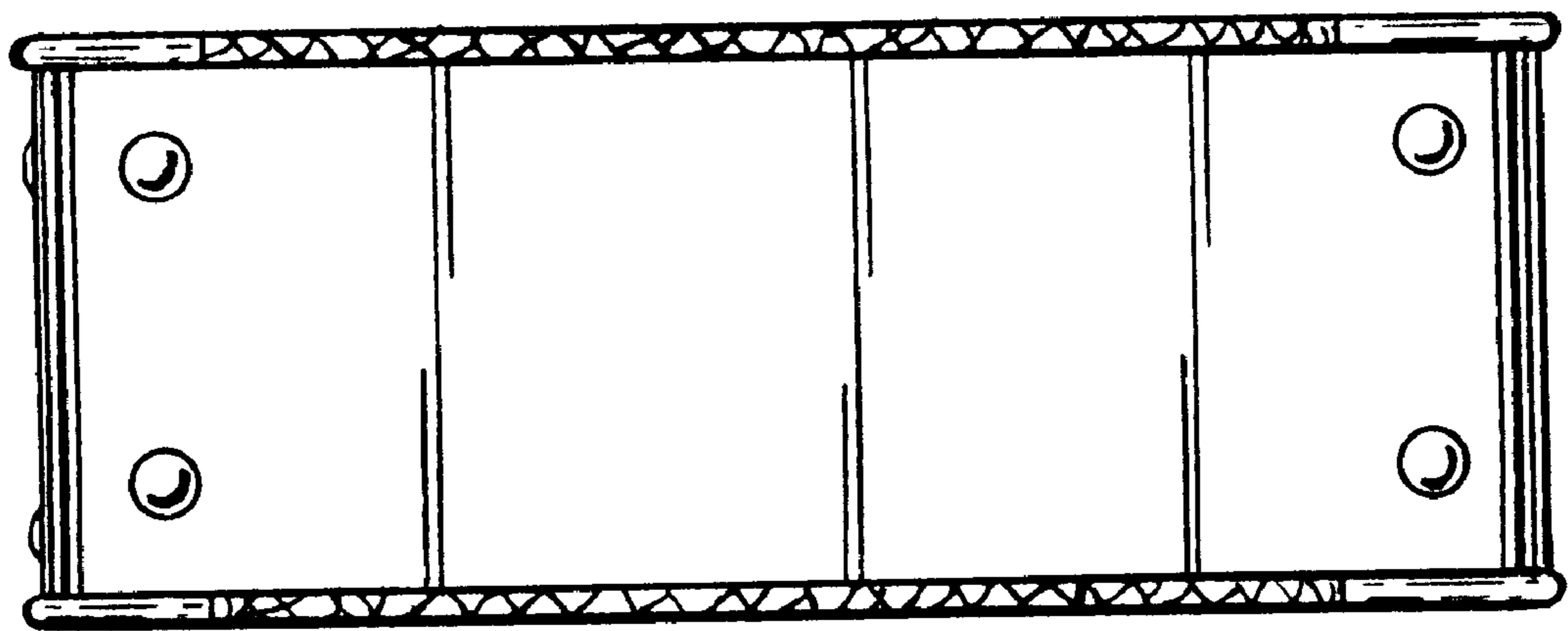
