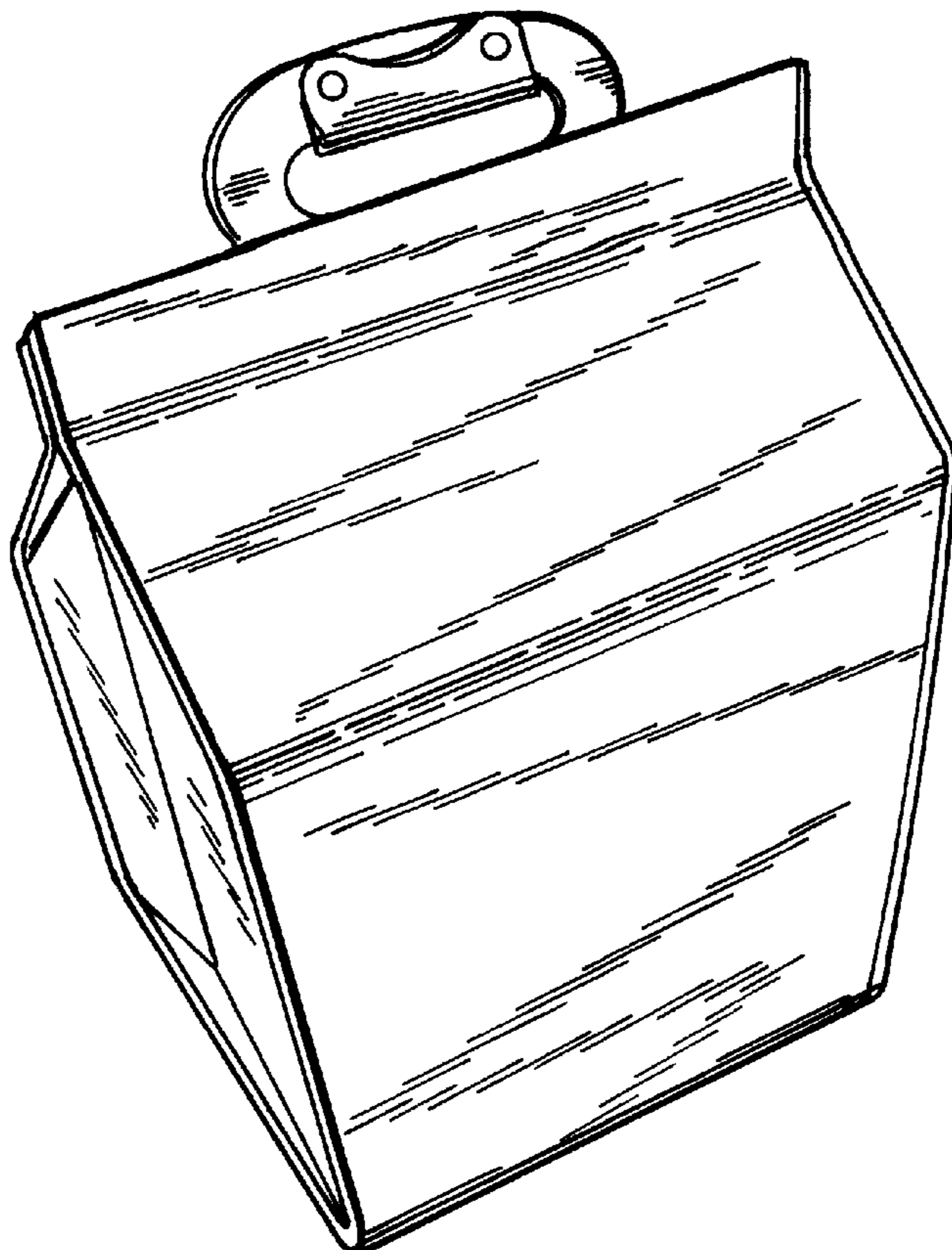
[57] **CLAIM**

The ornamental design for a market bag, as shown.

**DESCRIPTION**

FIG. 1 is a front perspective view of a market bag showing our new design, unfolded and with the resealable flap in the closed position;  
 FIG. 2 is a front perspective view thereof, with the resealable flap in the open position;  
 FIG. 3 is a front perspective view thereof, with the market bag in the folded condition;  
 FIG. 4 is a front elevational view thereof; with the resealable flap in the open position;  
 FIG. 5 is a right side view of the market bag shown in FIG. 4;  
 FIG. 6 is a top plan view of the market bag shown in FIG. 4; and,  
 FIG. 7 is a bottom plan view of the market bag shown in FIG. 4.

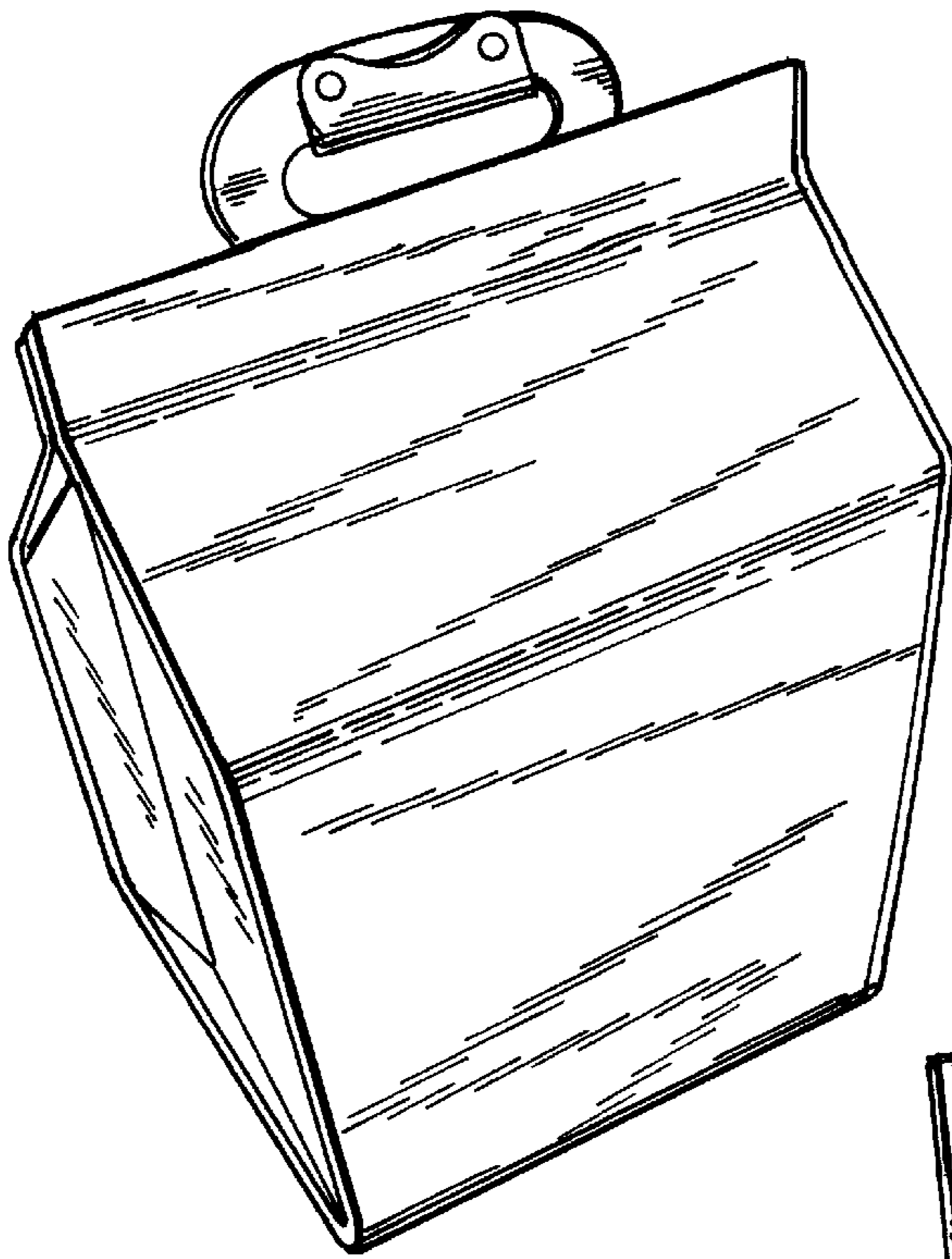

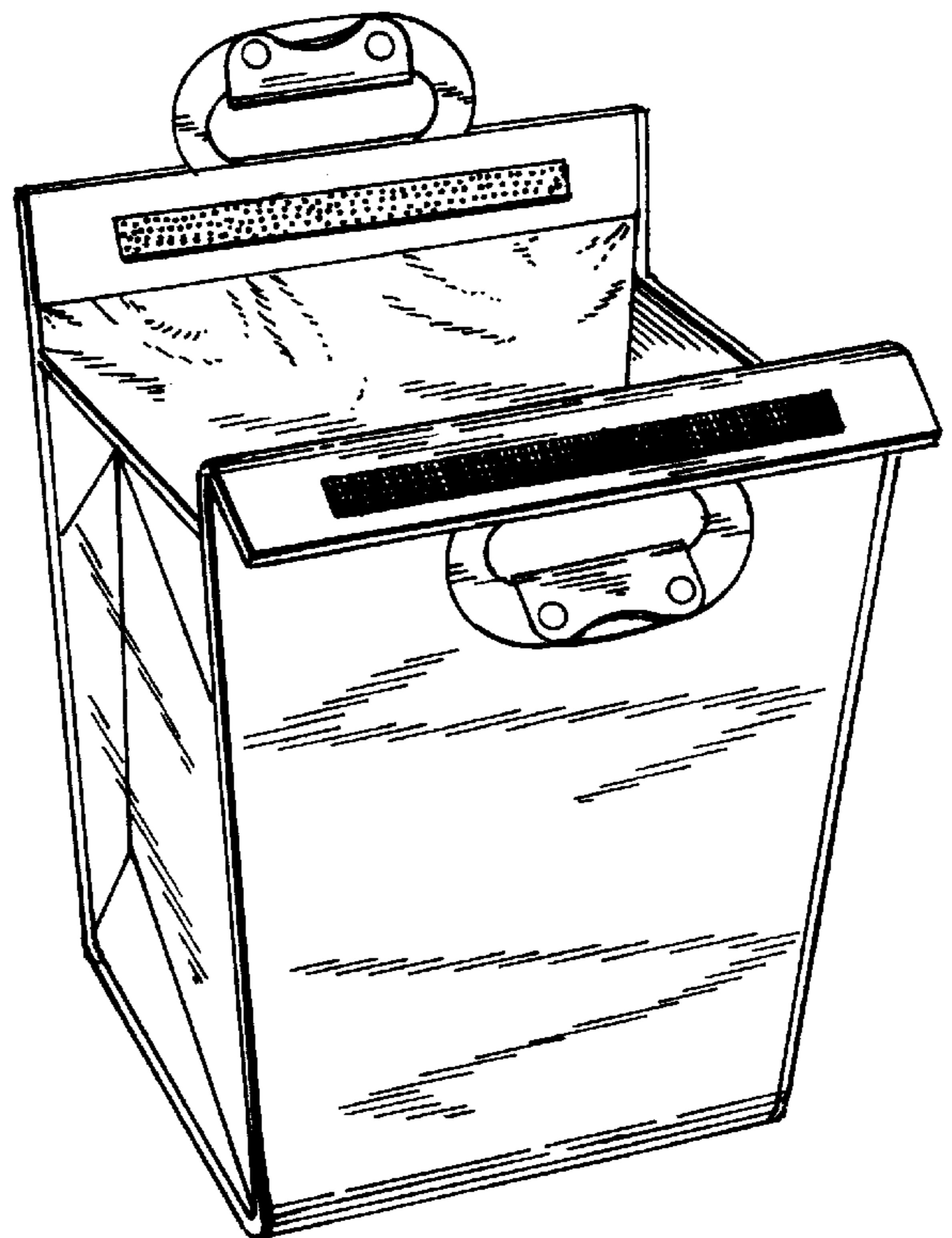

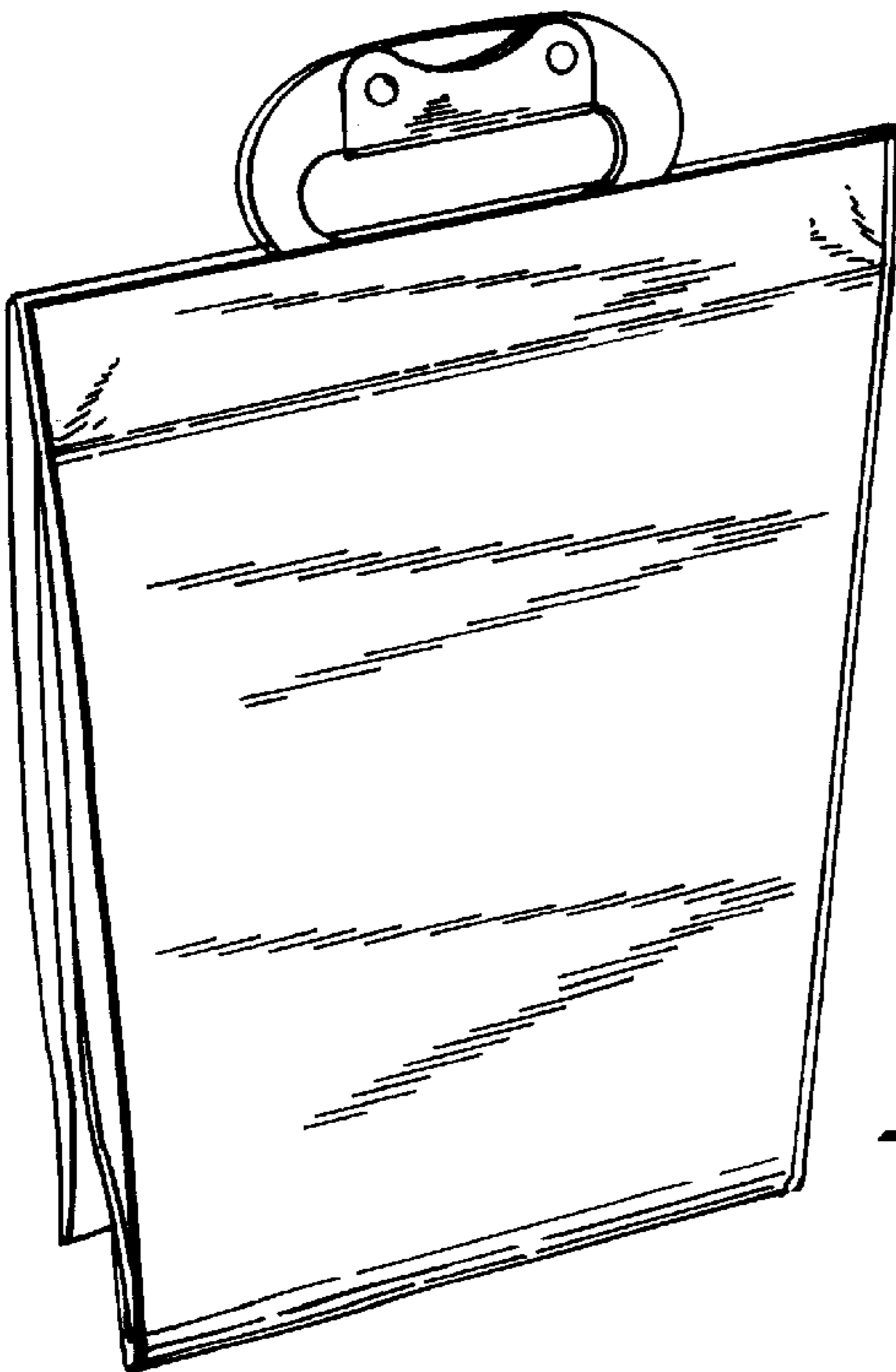
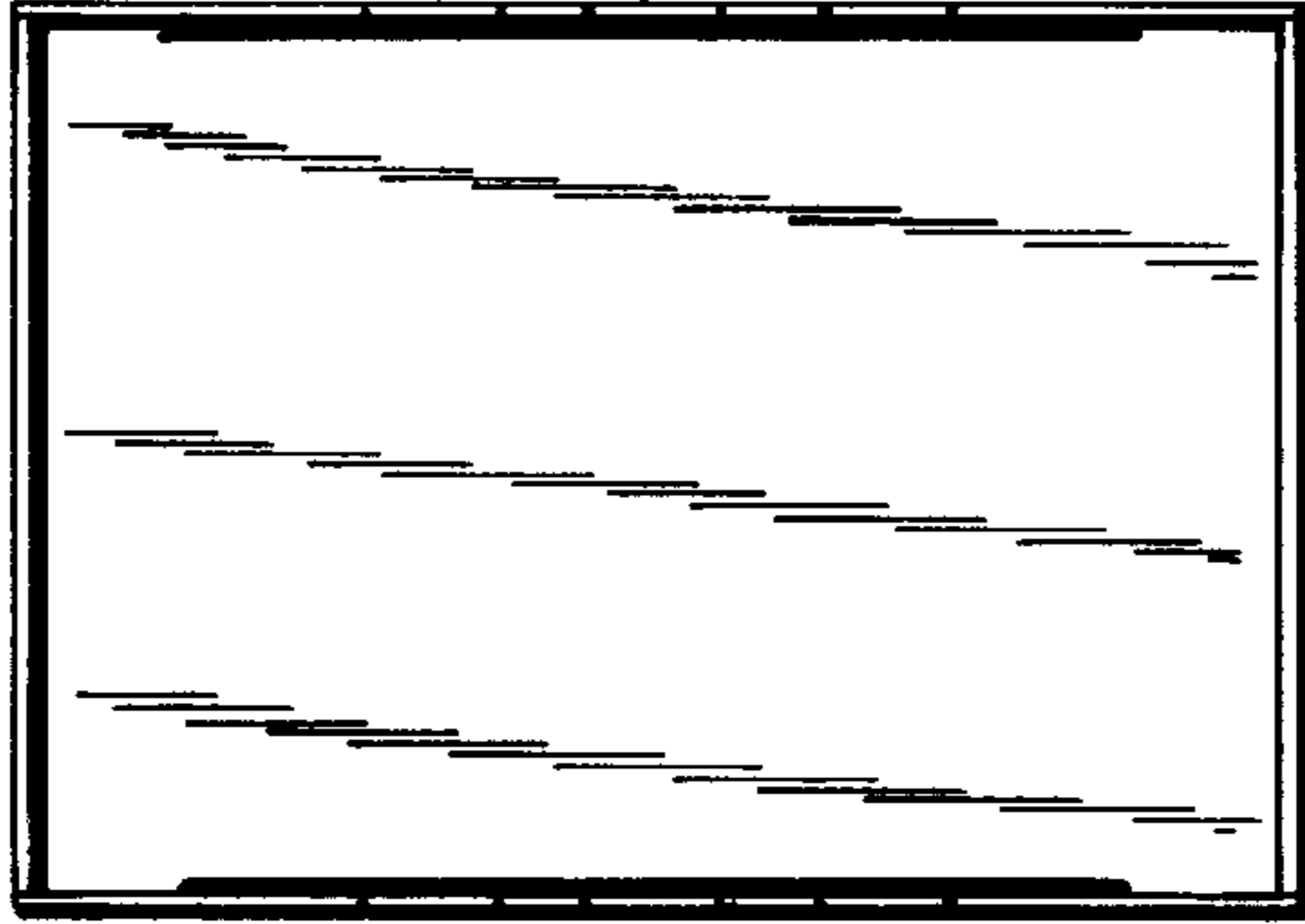
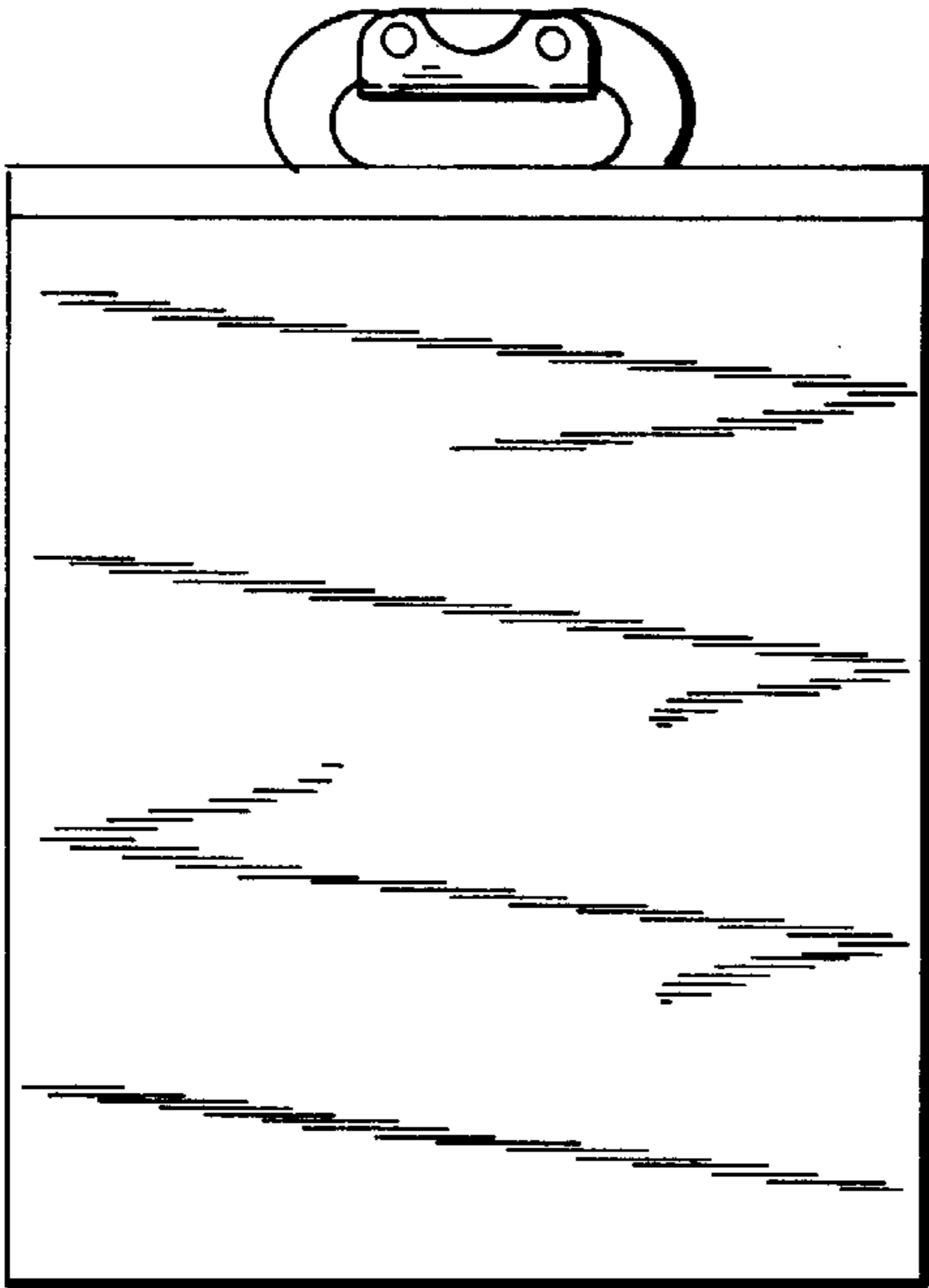


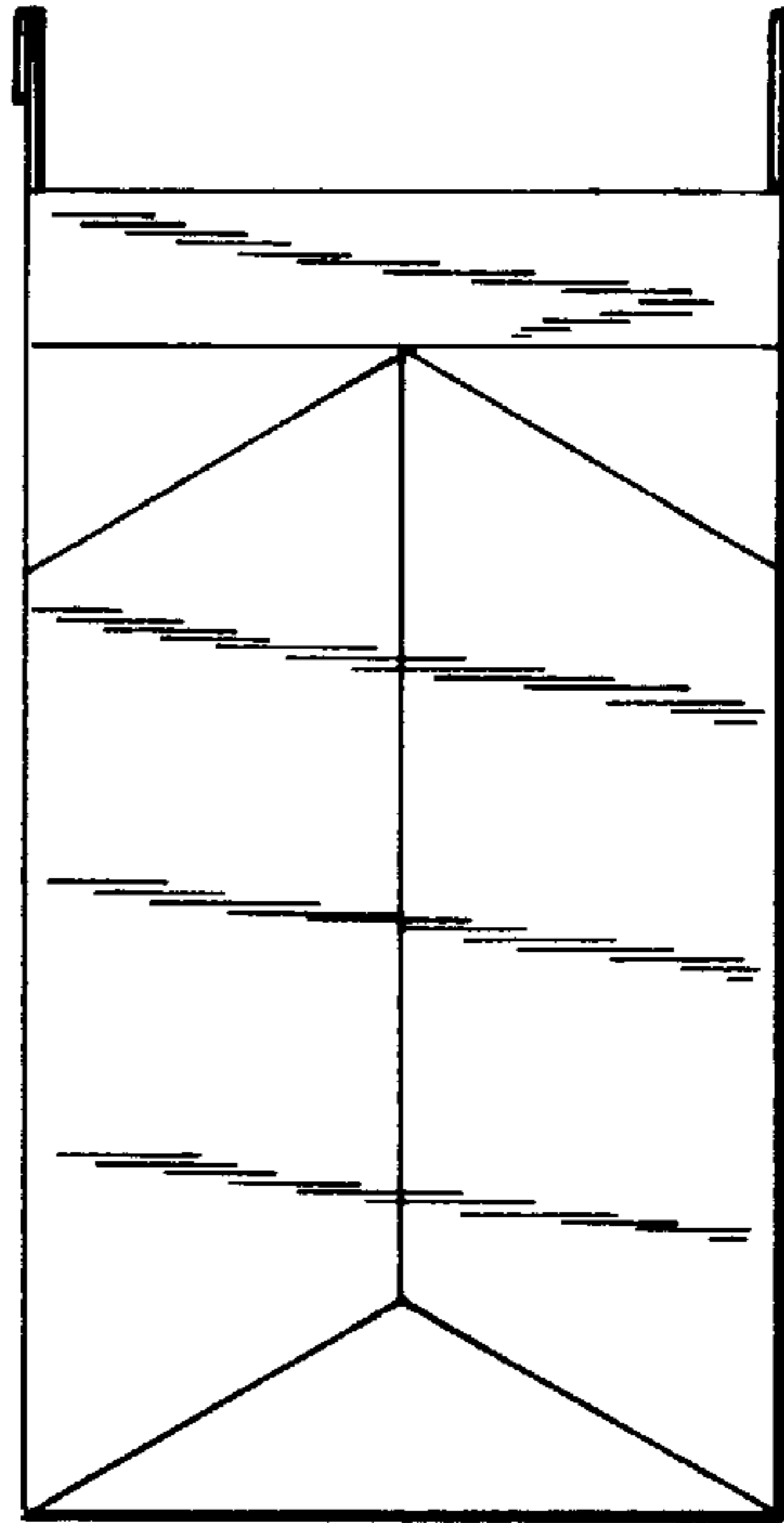

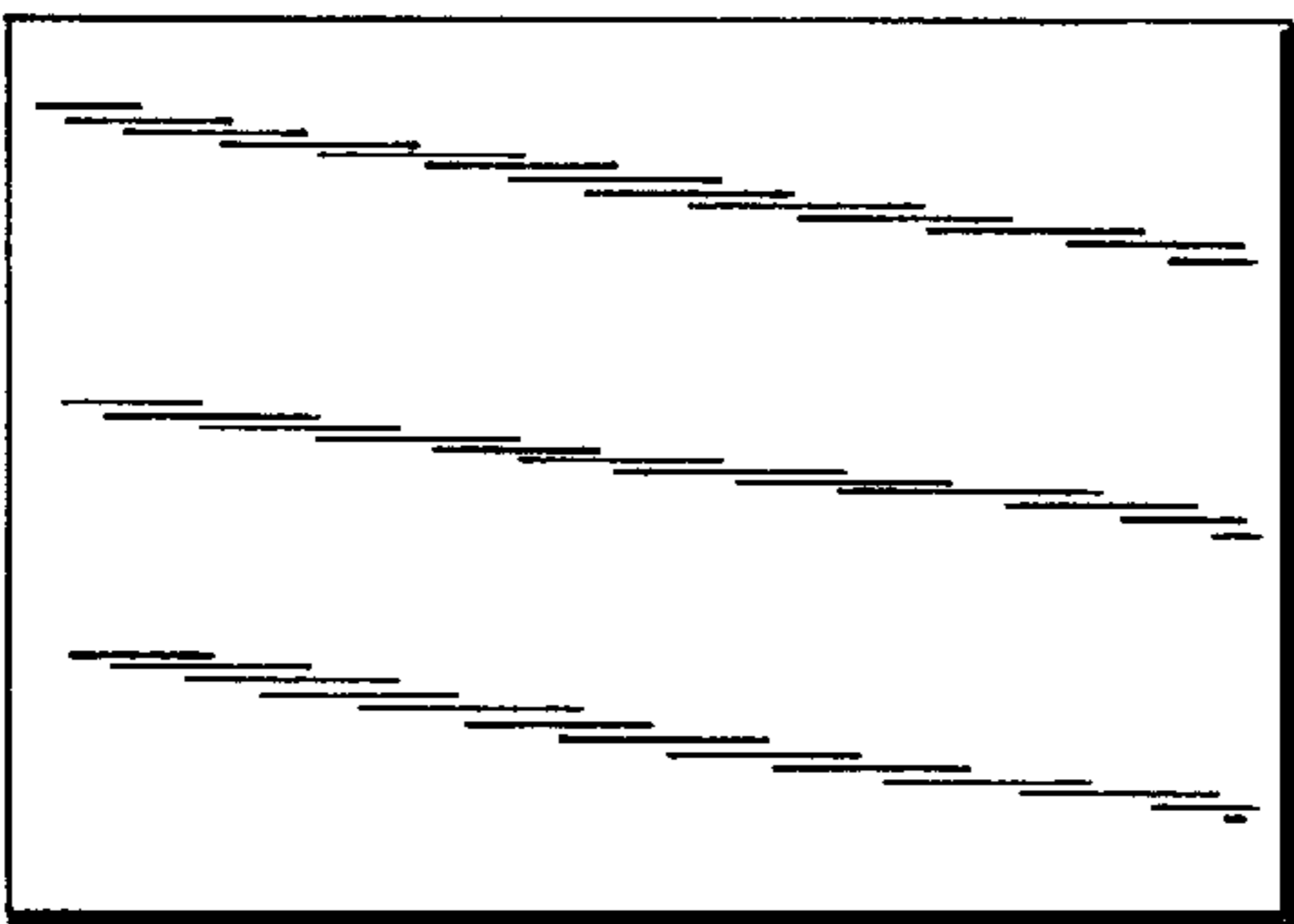
