The ornamental design for a seat and back support for collapsible chair, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view showing my new design.

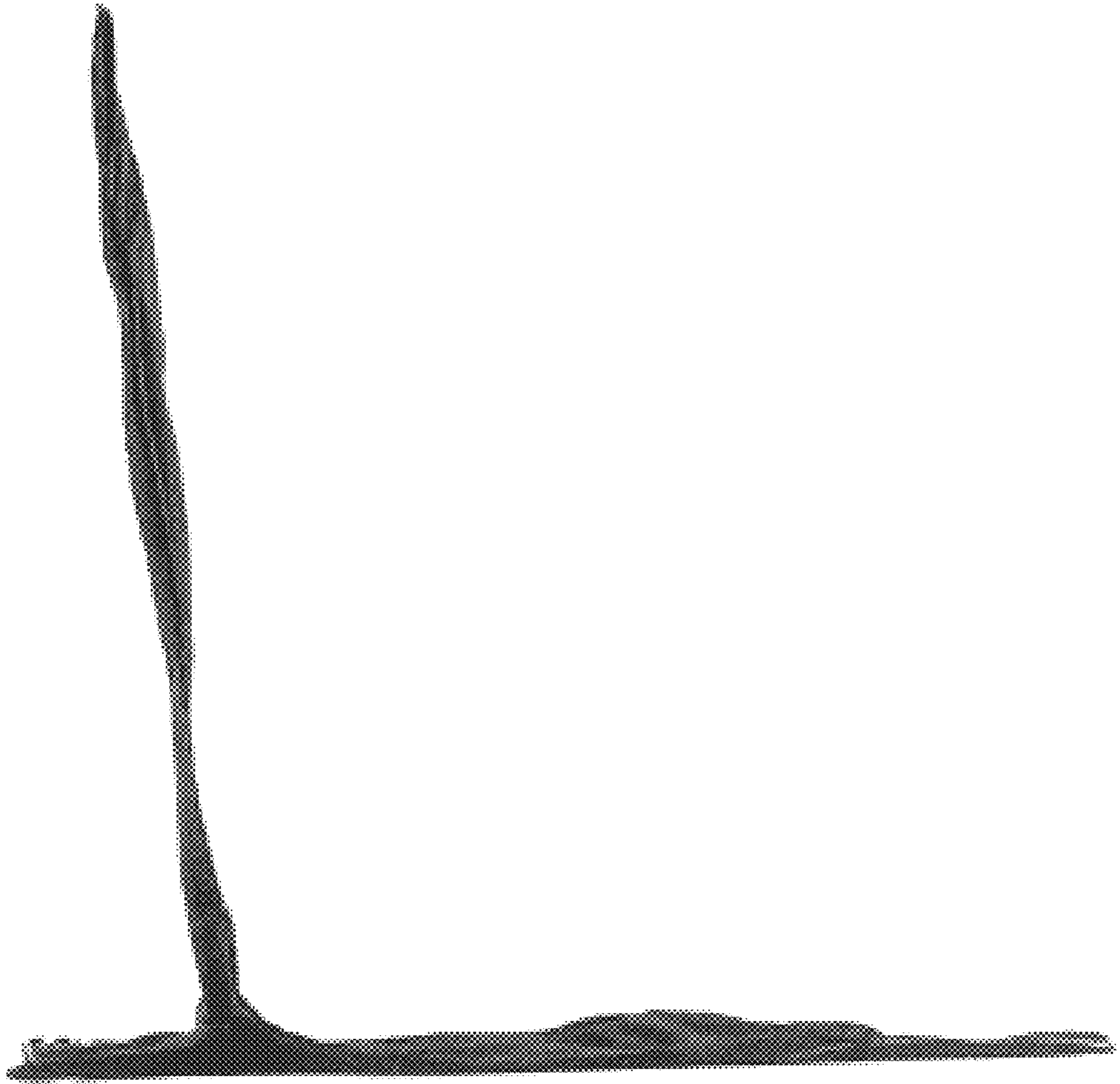

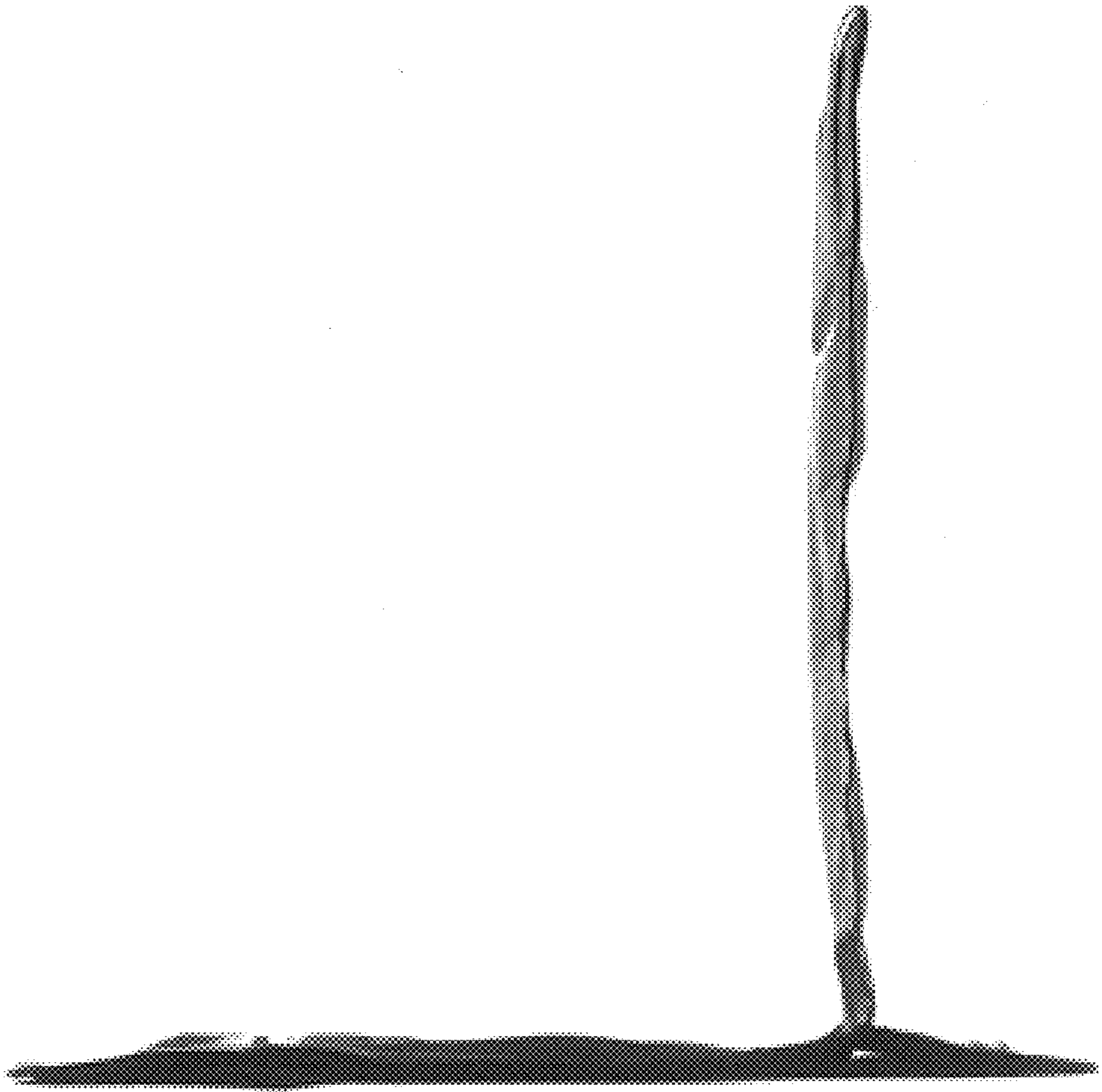
