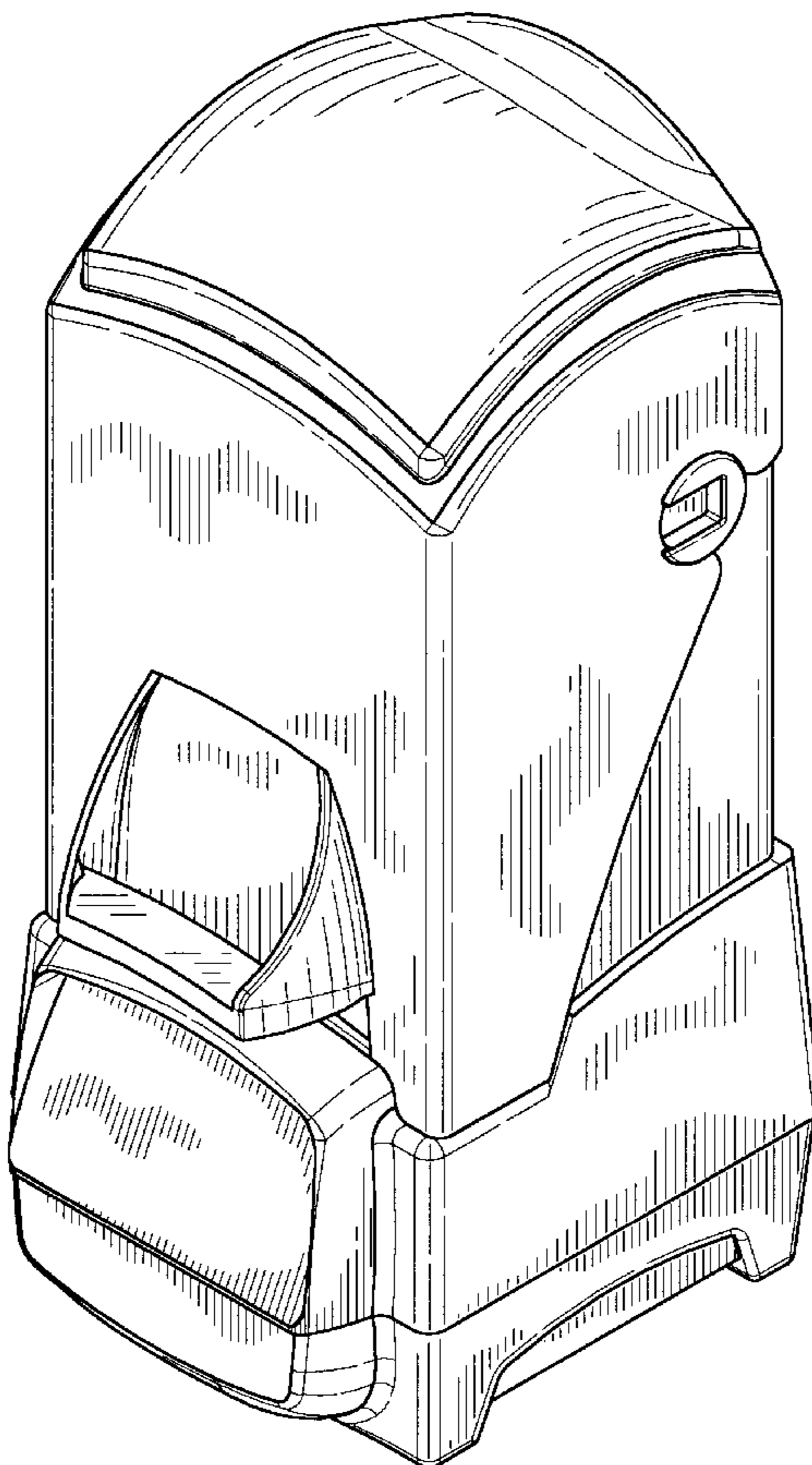
### [57] **CLAIM**

The ornamental design for an enclosure for a food processor, as shown and described.

### DESCRIPTION

FIG. 1 is a top, front, right side perspective view of an enclosure for a food processor showing our new design; FIG. 2 is a top plan view thereof; FIG. 3 is a left side elevational view thereof; FIG. 4 is a front elevational view thereof; FIG. 5 is a right side elevational view thereof; and, FIG. 6 is a rear elevational view thereof.

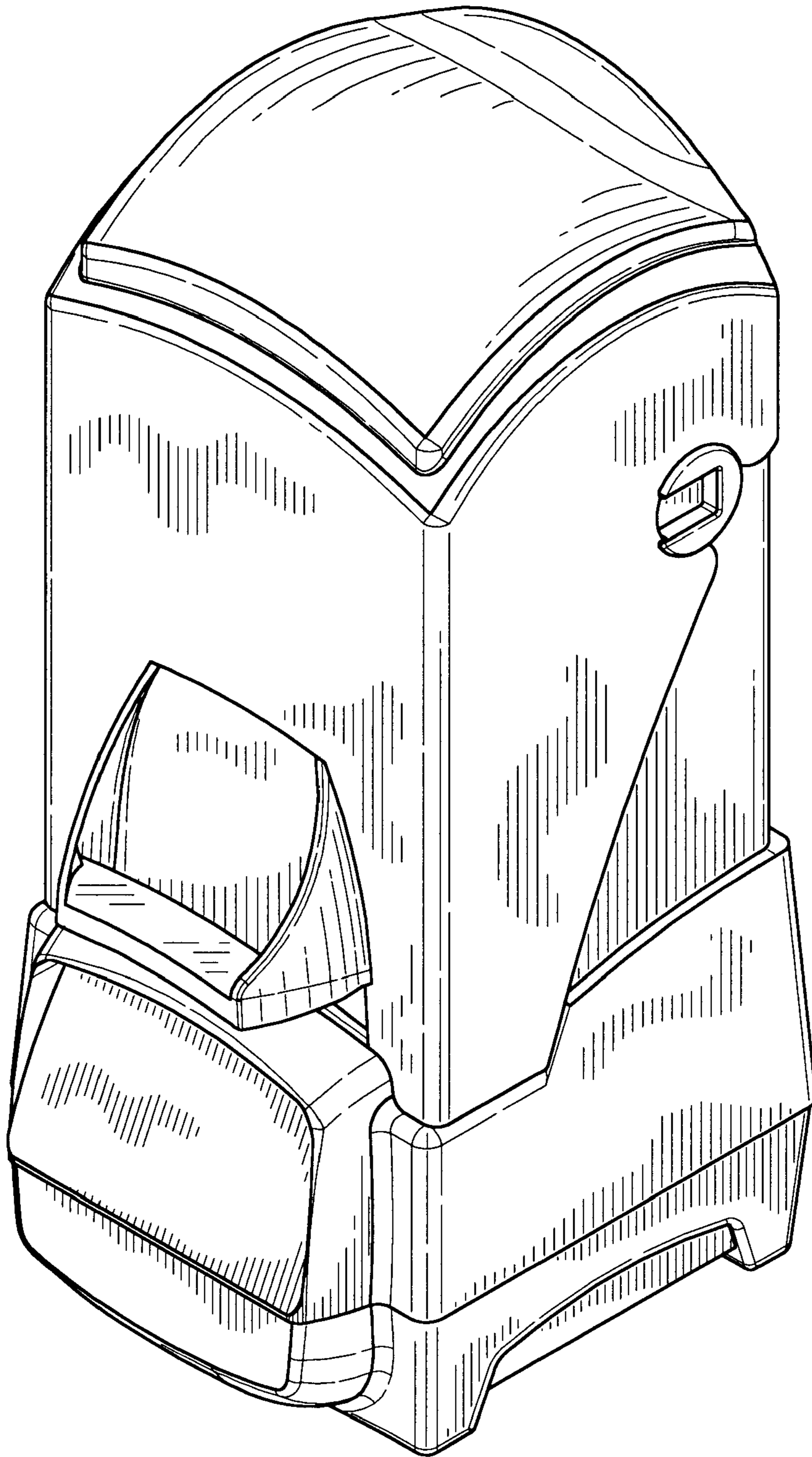

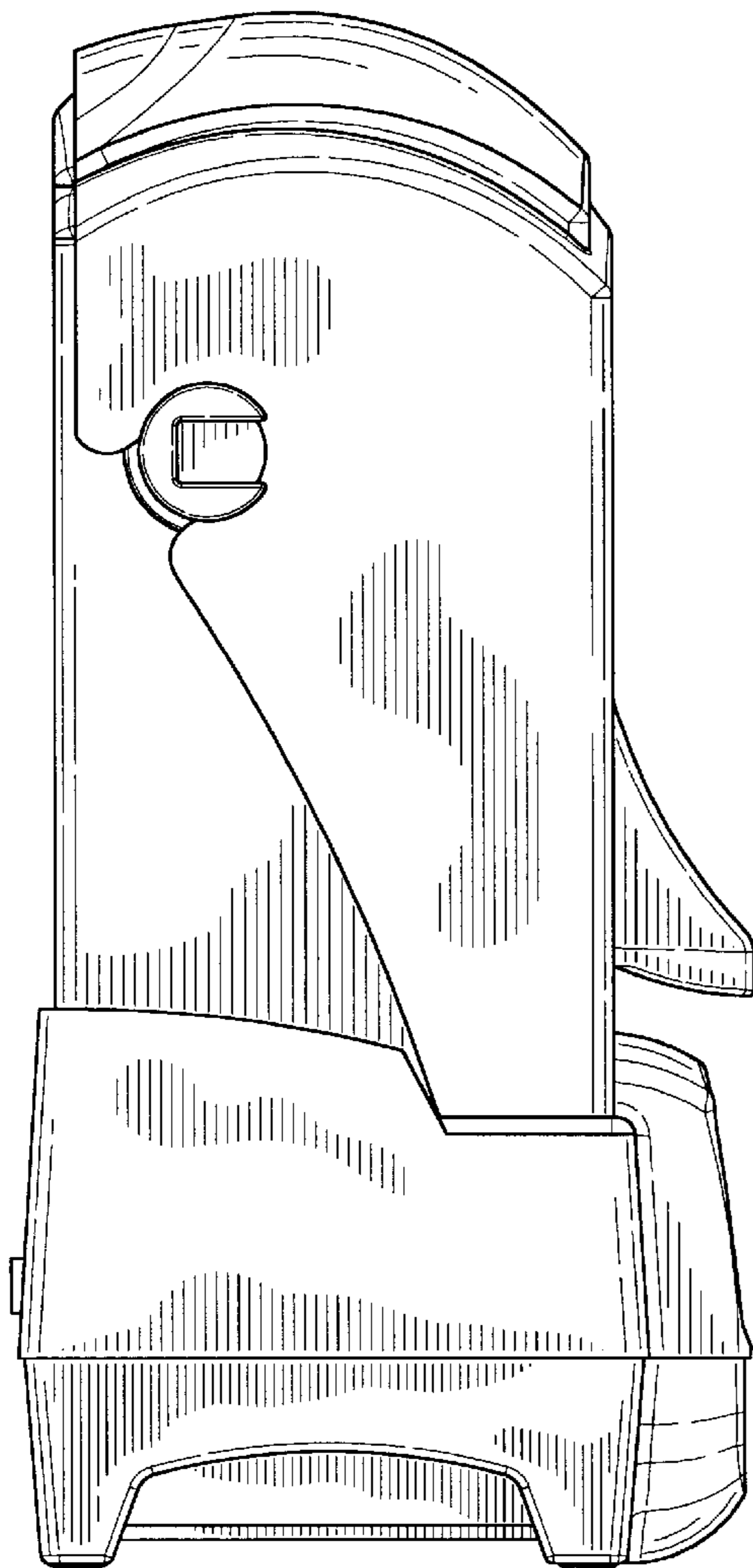
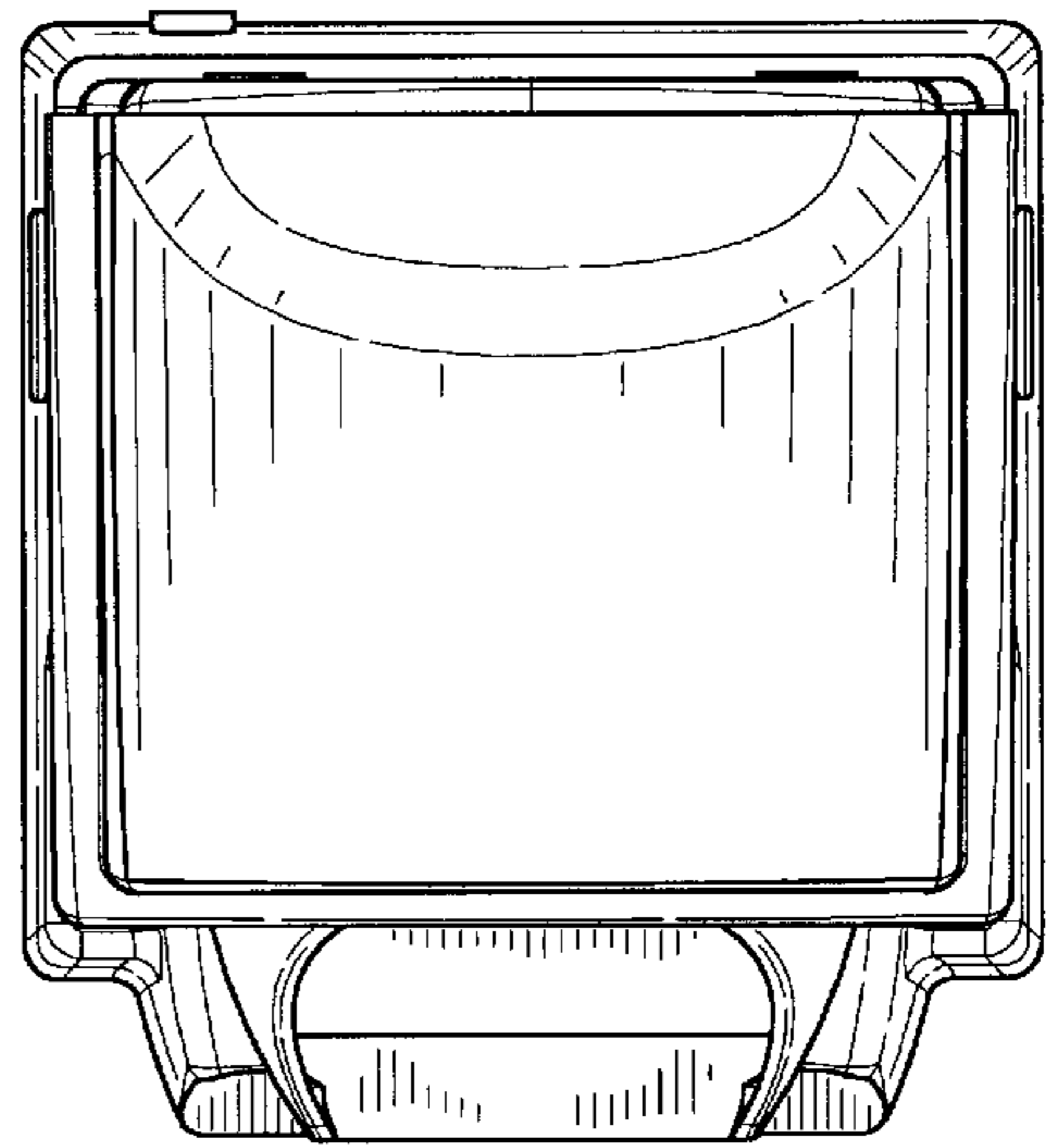

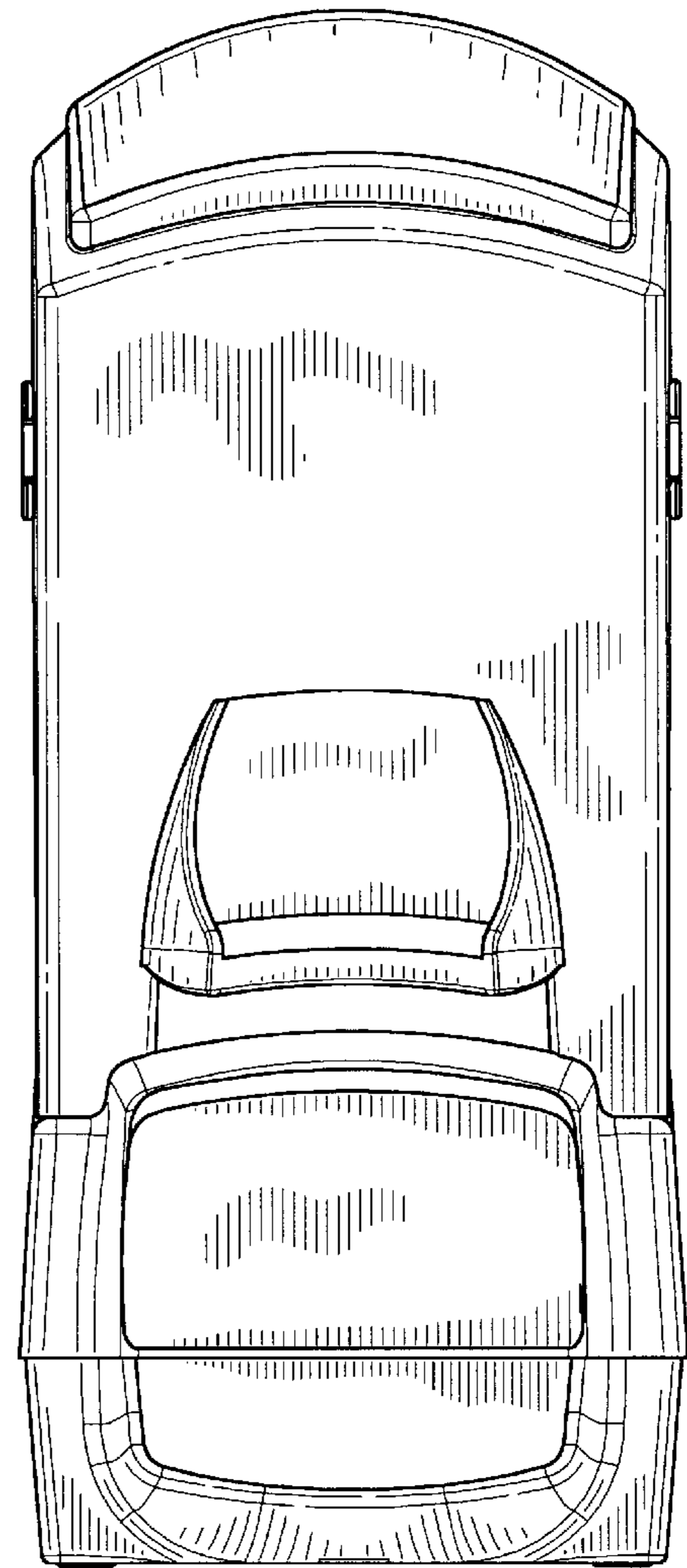

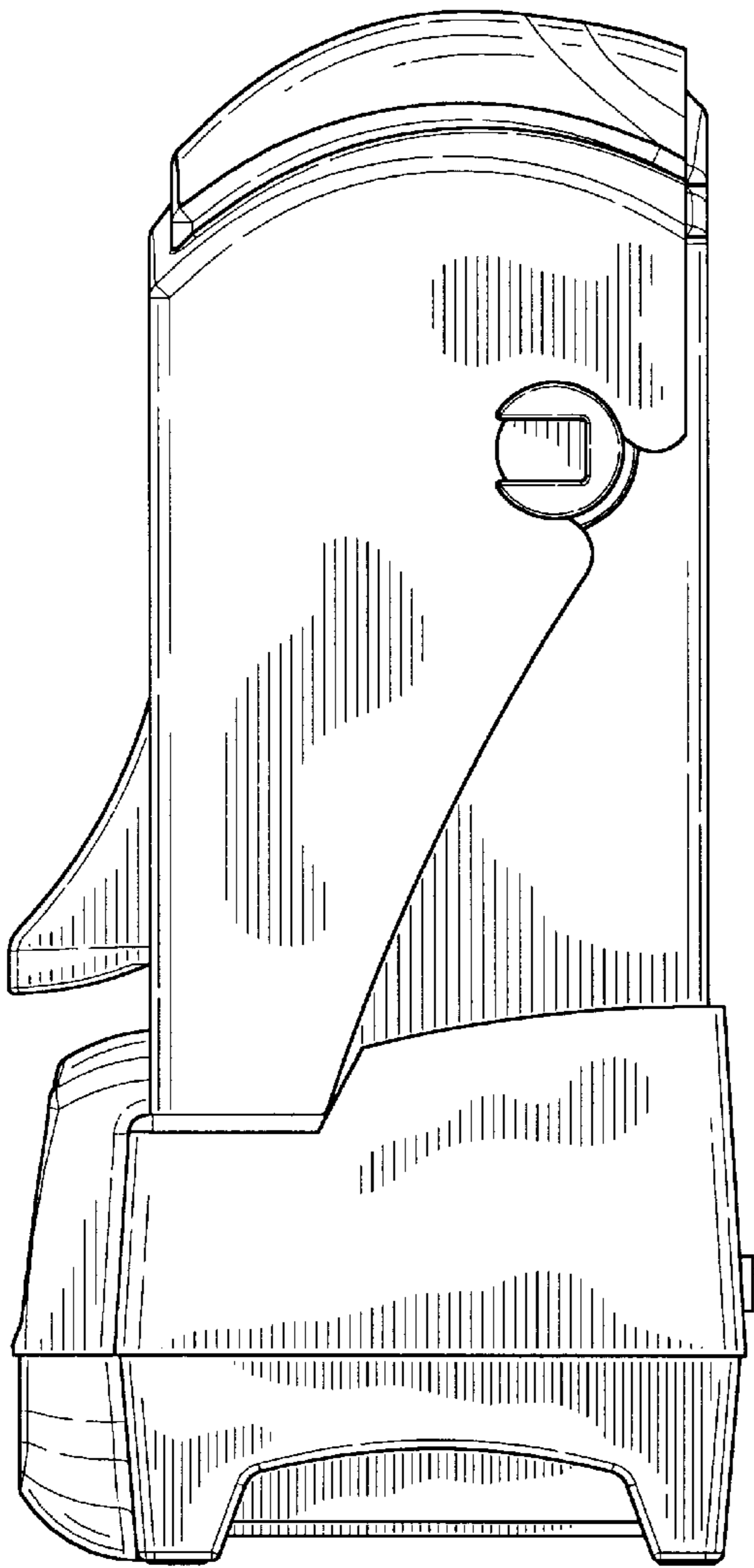

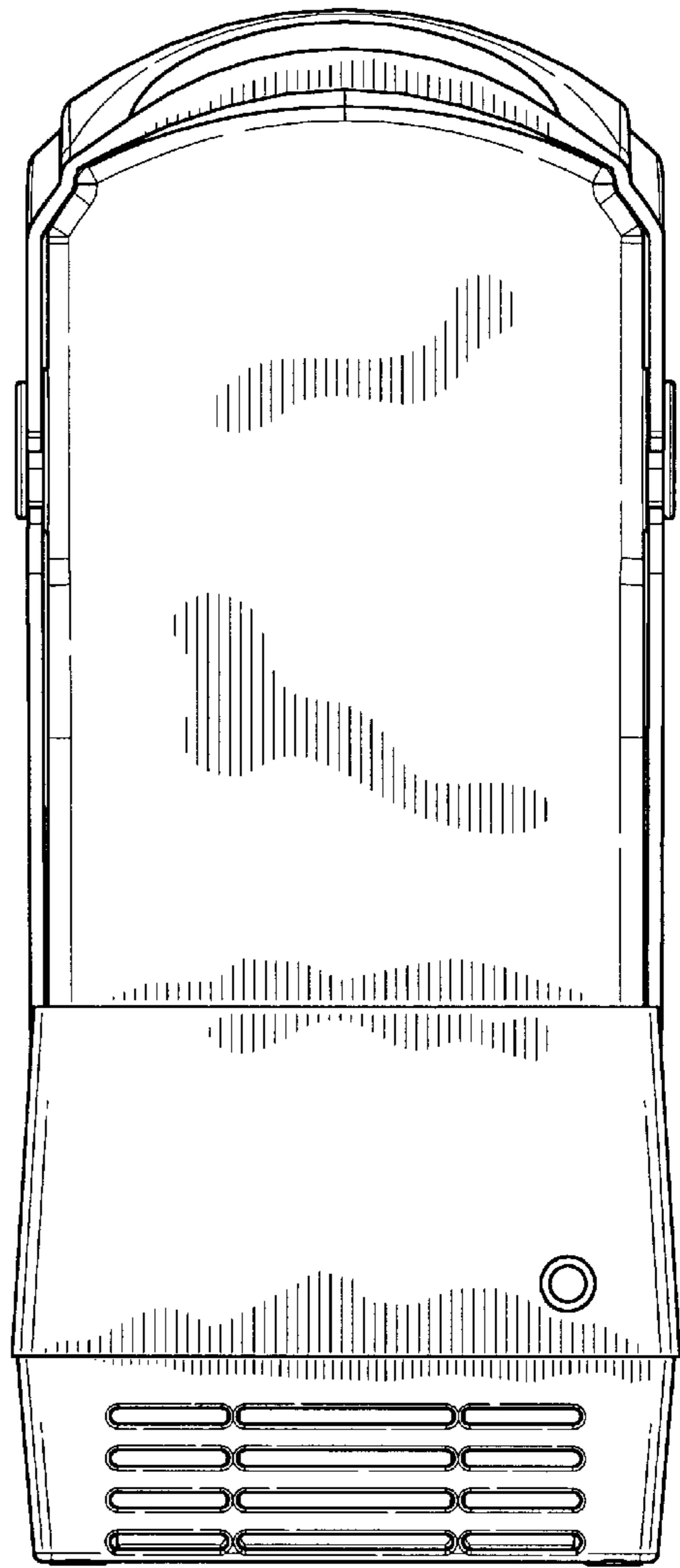
