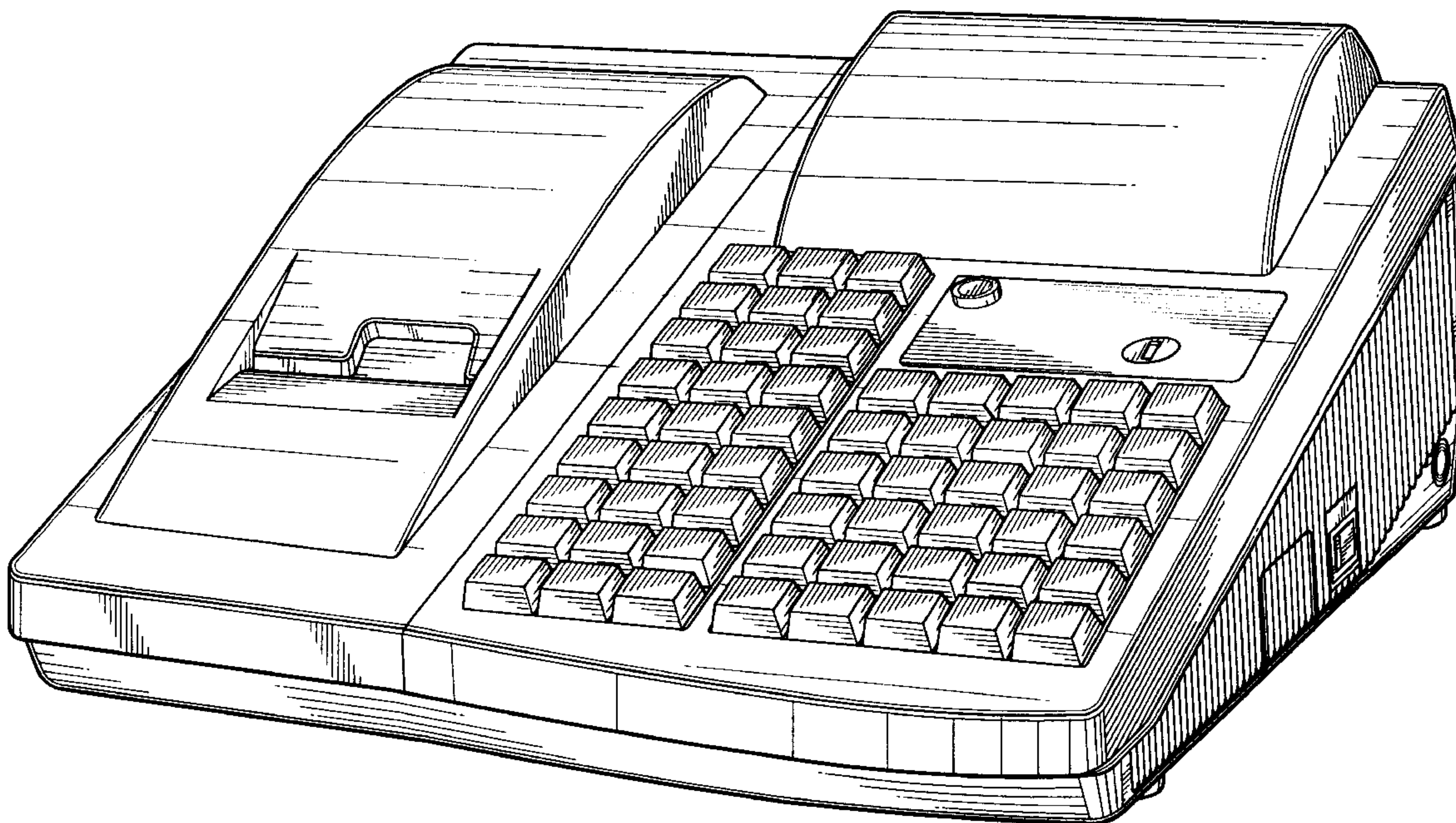
### [57] CLAIM

### DESCRIPTION

FIG. 1 is a top, front and right side perspective view of a cash register according to our design;  
FIG. 2 is a top plan view thereof;  
FIG. 3 is a front elevational view thereof;  
FIG. 4 is a rear elevational view thereof;  
FIG. 5 is a right side elevational view thereof;

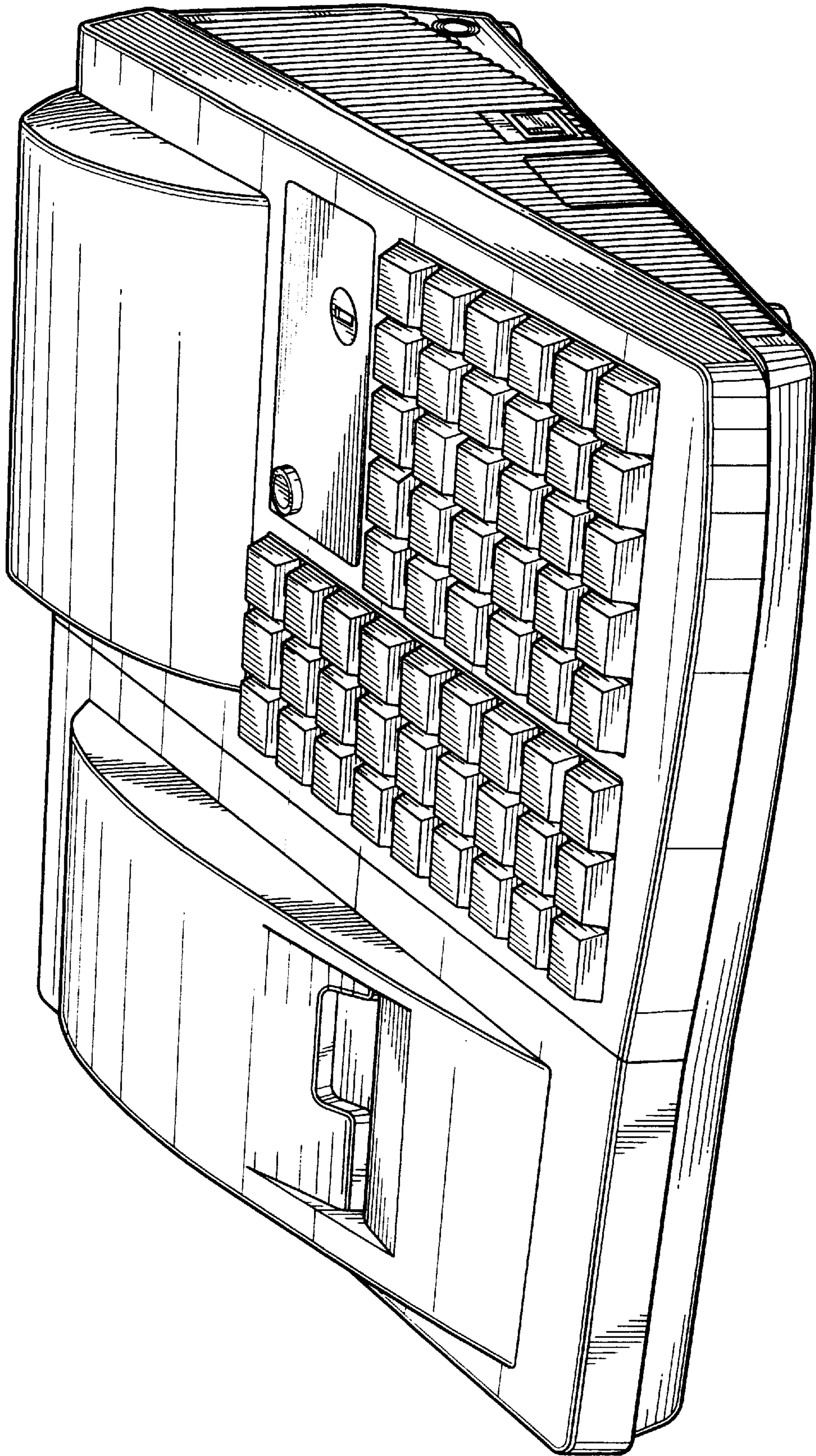
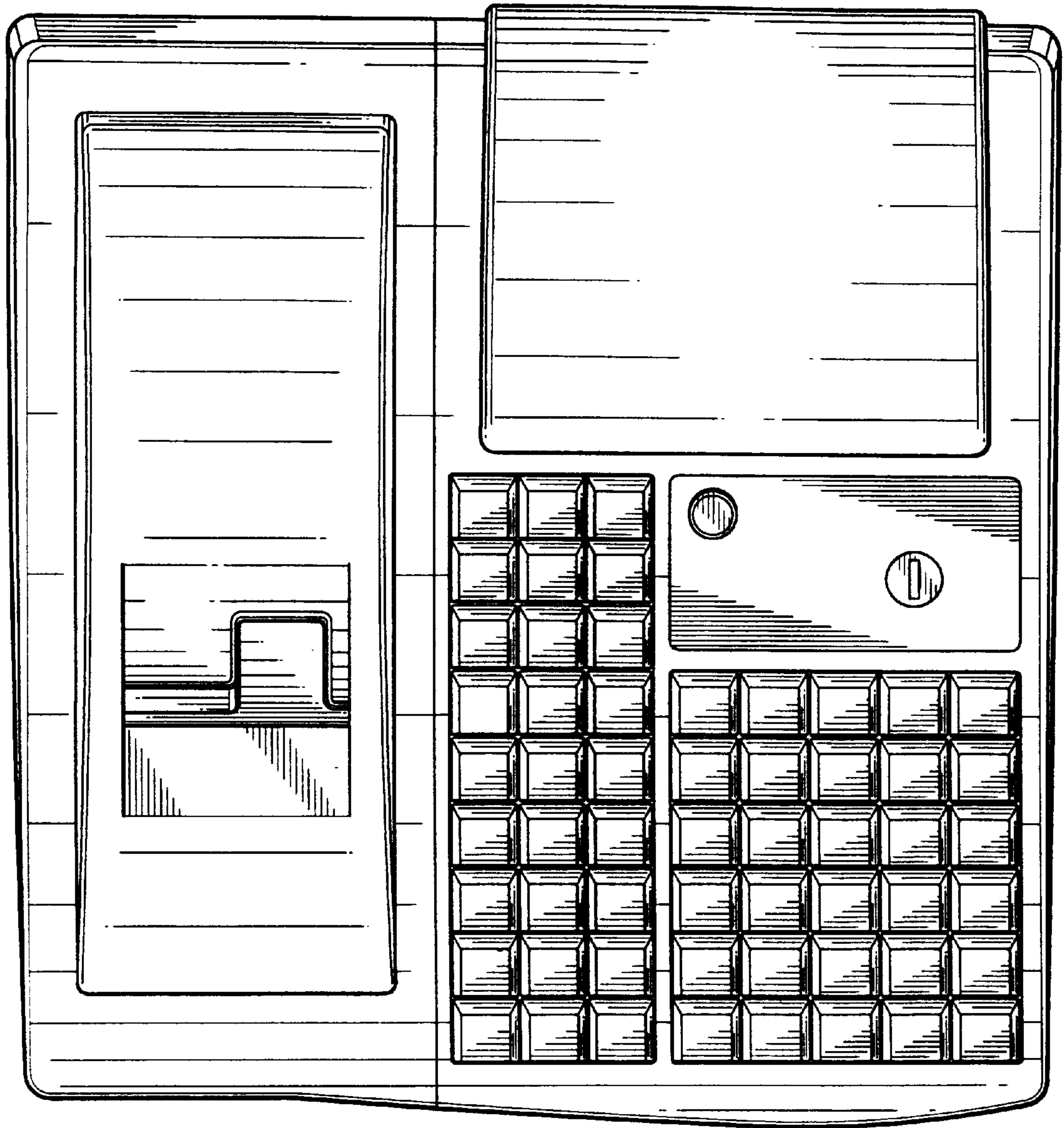
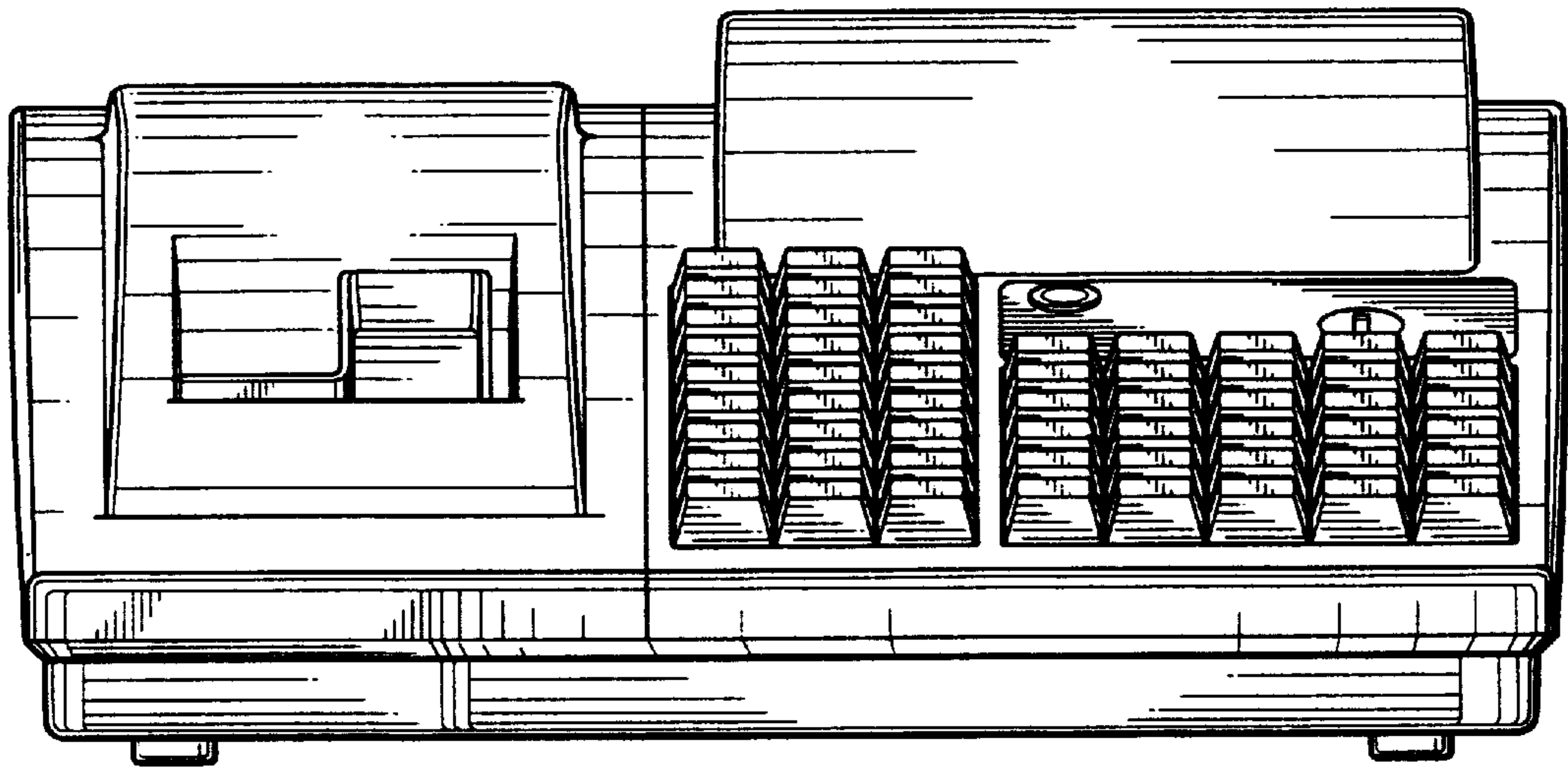

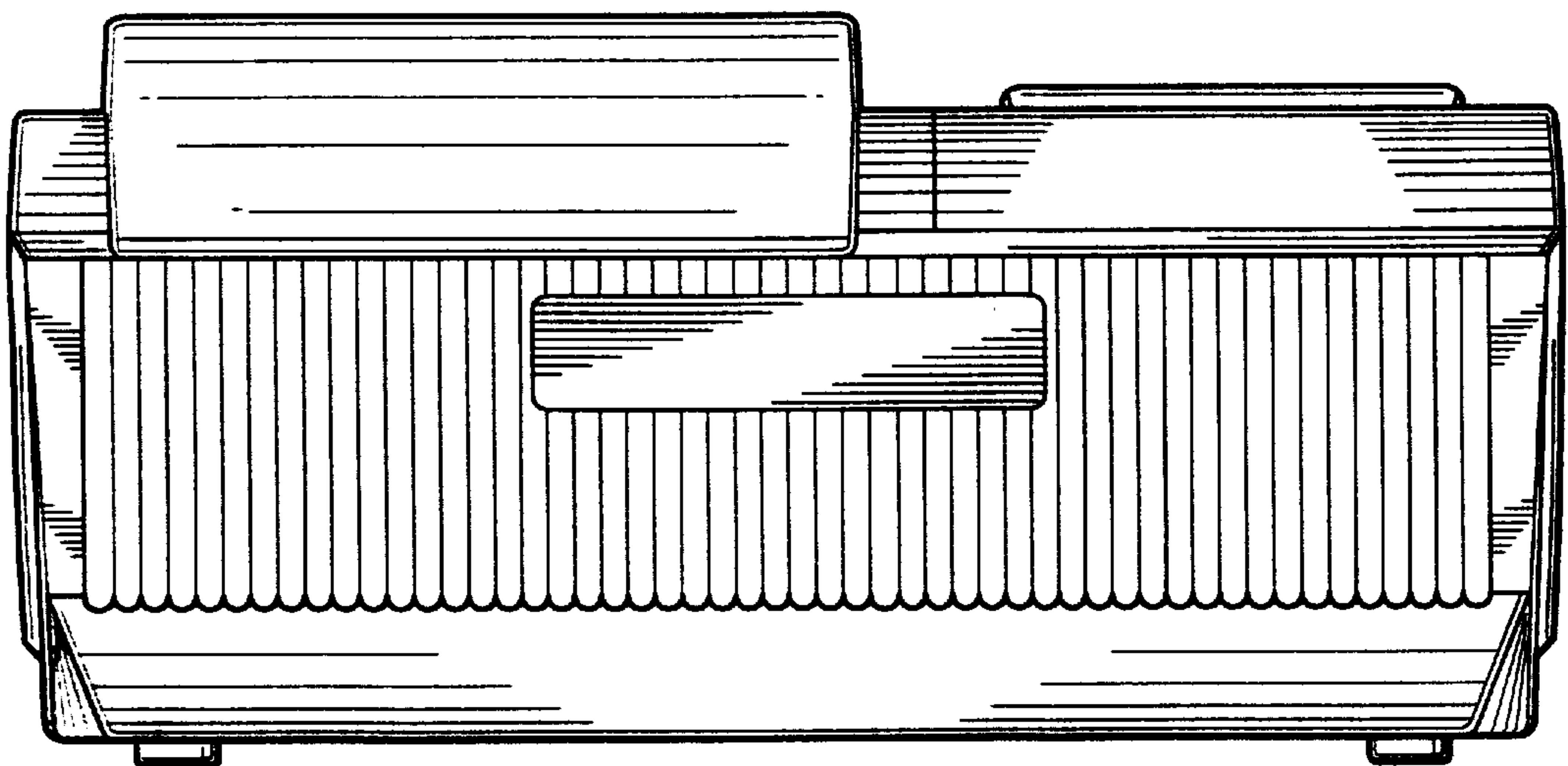




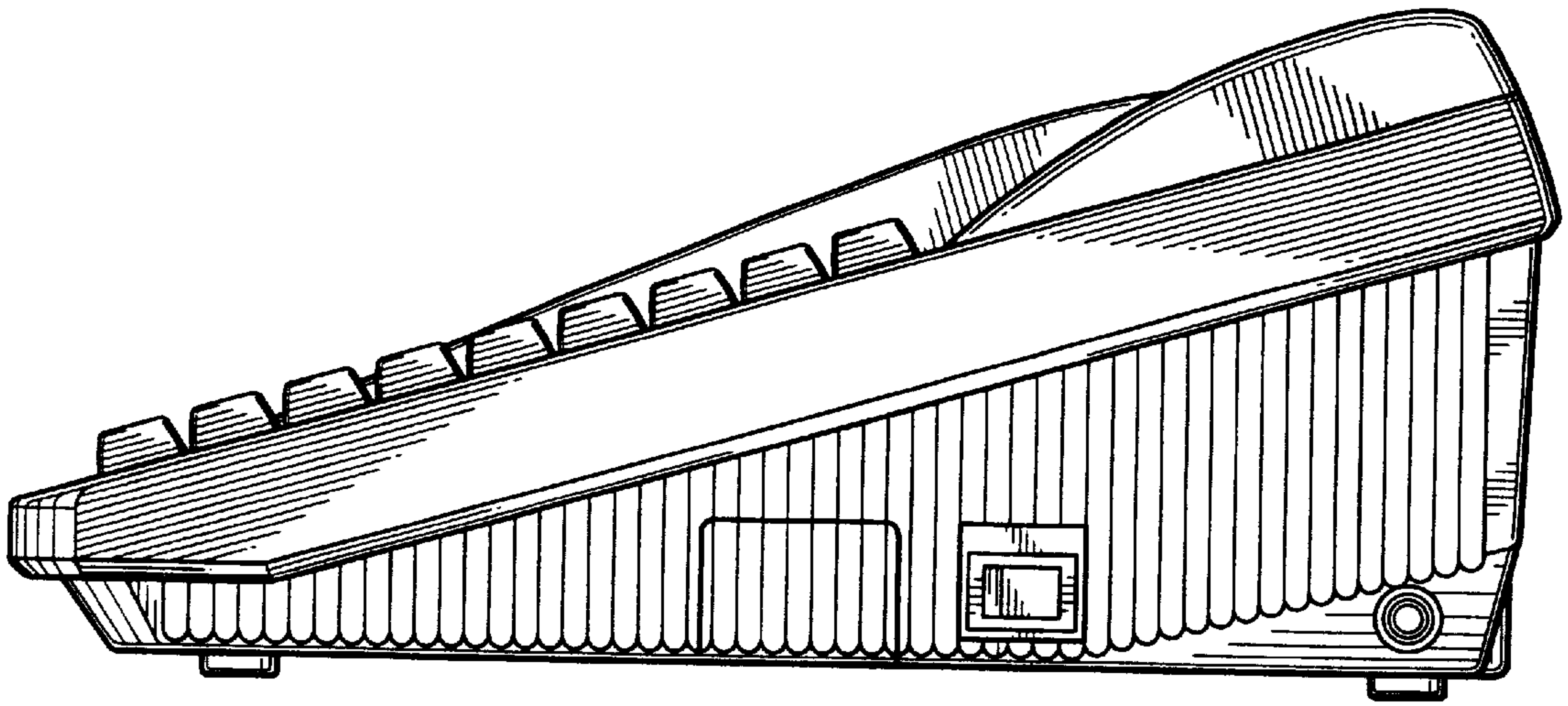

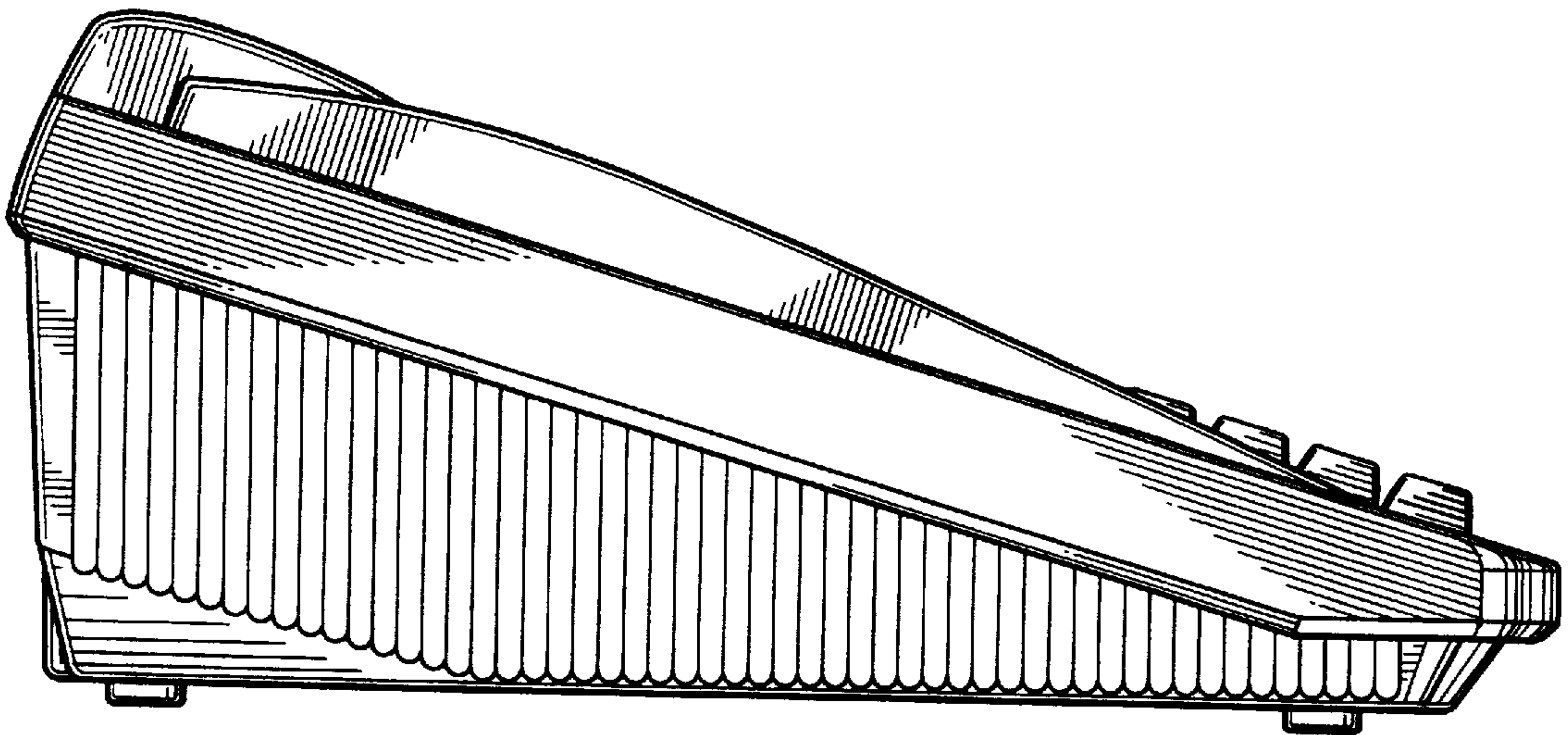

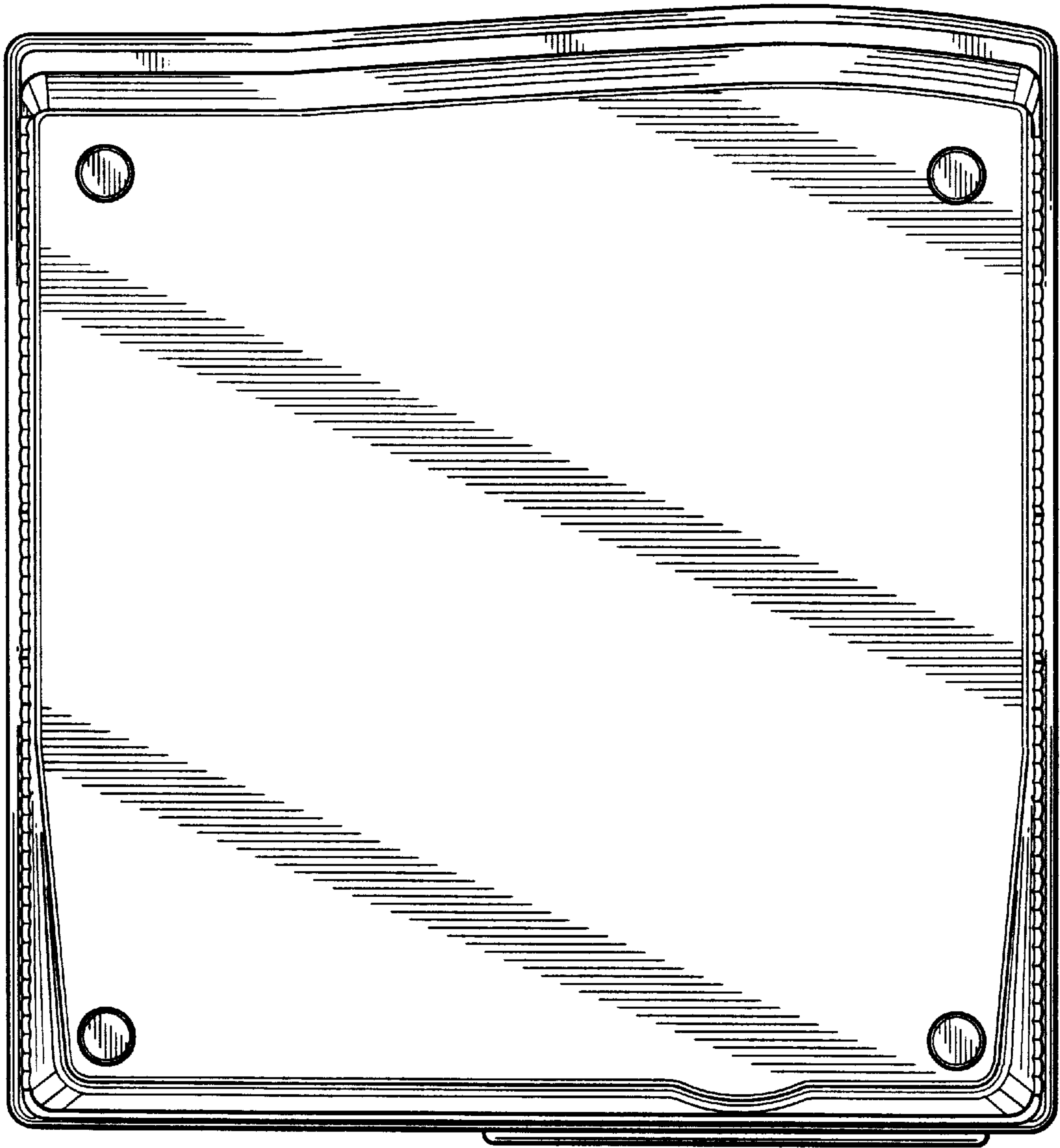
