[57] **CLAIM**

The ornamental design for a toy typewriter, substantially as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of the toy typewriter of the present invention.

FIG. 2 is a left side elevational view thereof.

FIG. 3 is a top view thereof.

FIG. 4 is a perspective view thereof.

FIG. 5 is a right side elevational view thereof.

FIG. 6 is a bottom view thereof. The portions illustrated in dashed lines are hereby disclaimed. Moreover, the bottom view of the toy typewriter, other than those portions also visible from the side views, are also hereby disclaimed.

FIG. 7 is a rear elevational view thereof.

FIG. 8 is a front elevational view of a modified embodiment of the design shown in FIGS. 1–7.

FIG. 9 is a left side elevational view thereof;

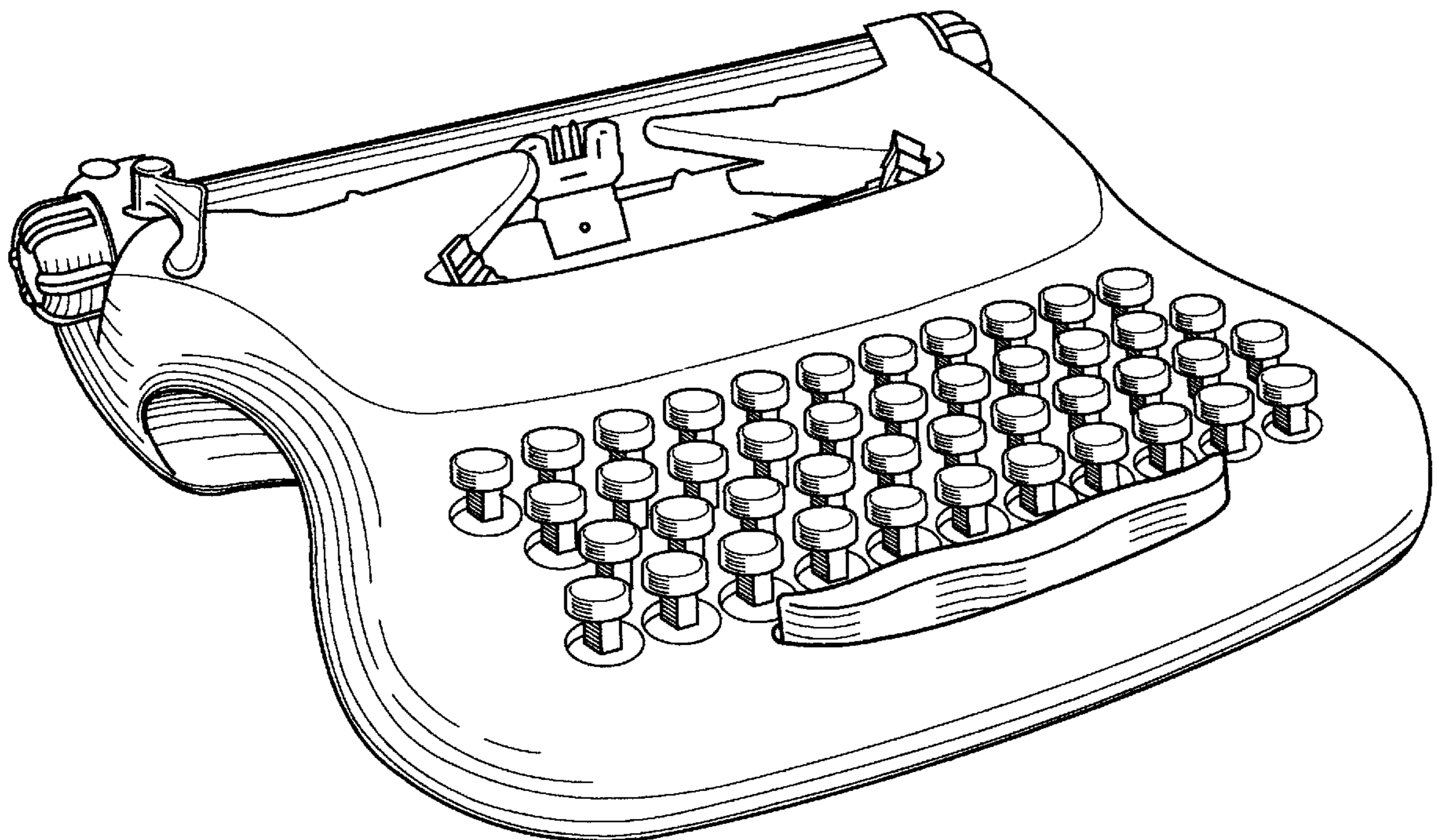
FIG. 10 is a top view thereof; and,

FIG. 11 is a perspective view thereof.

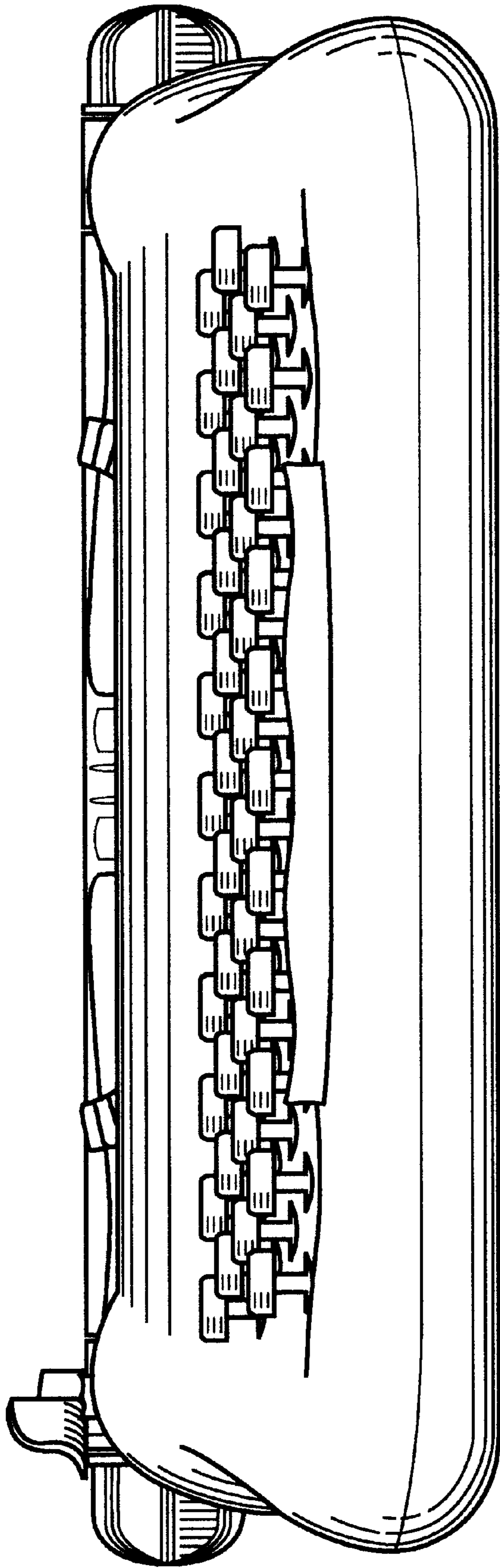

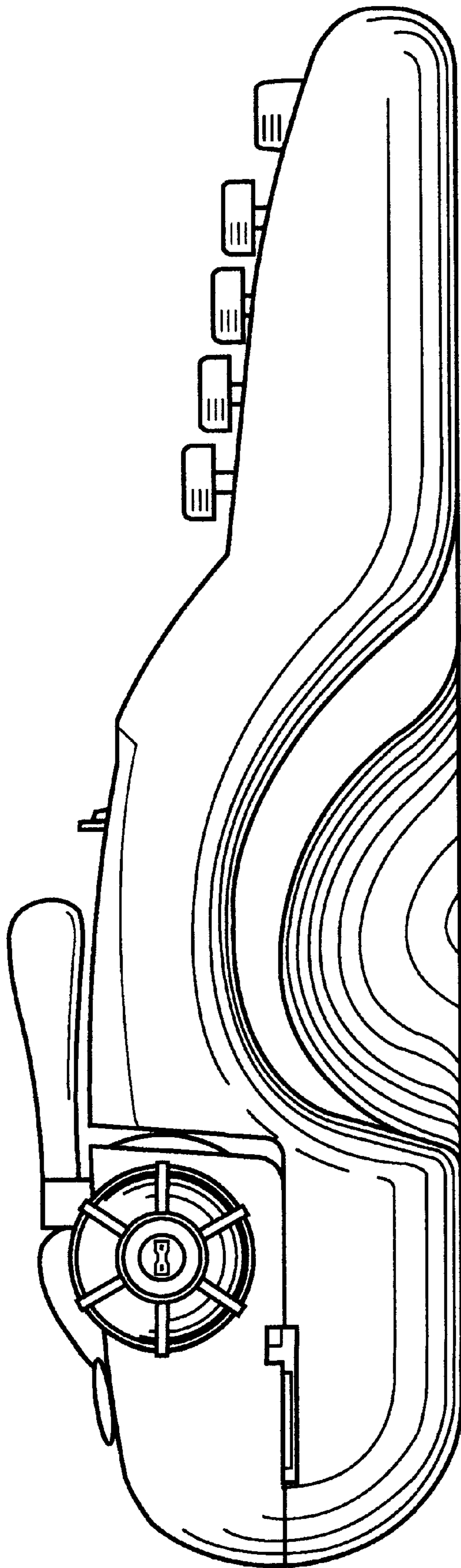

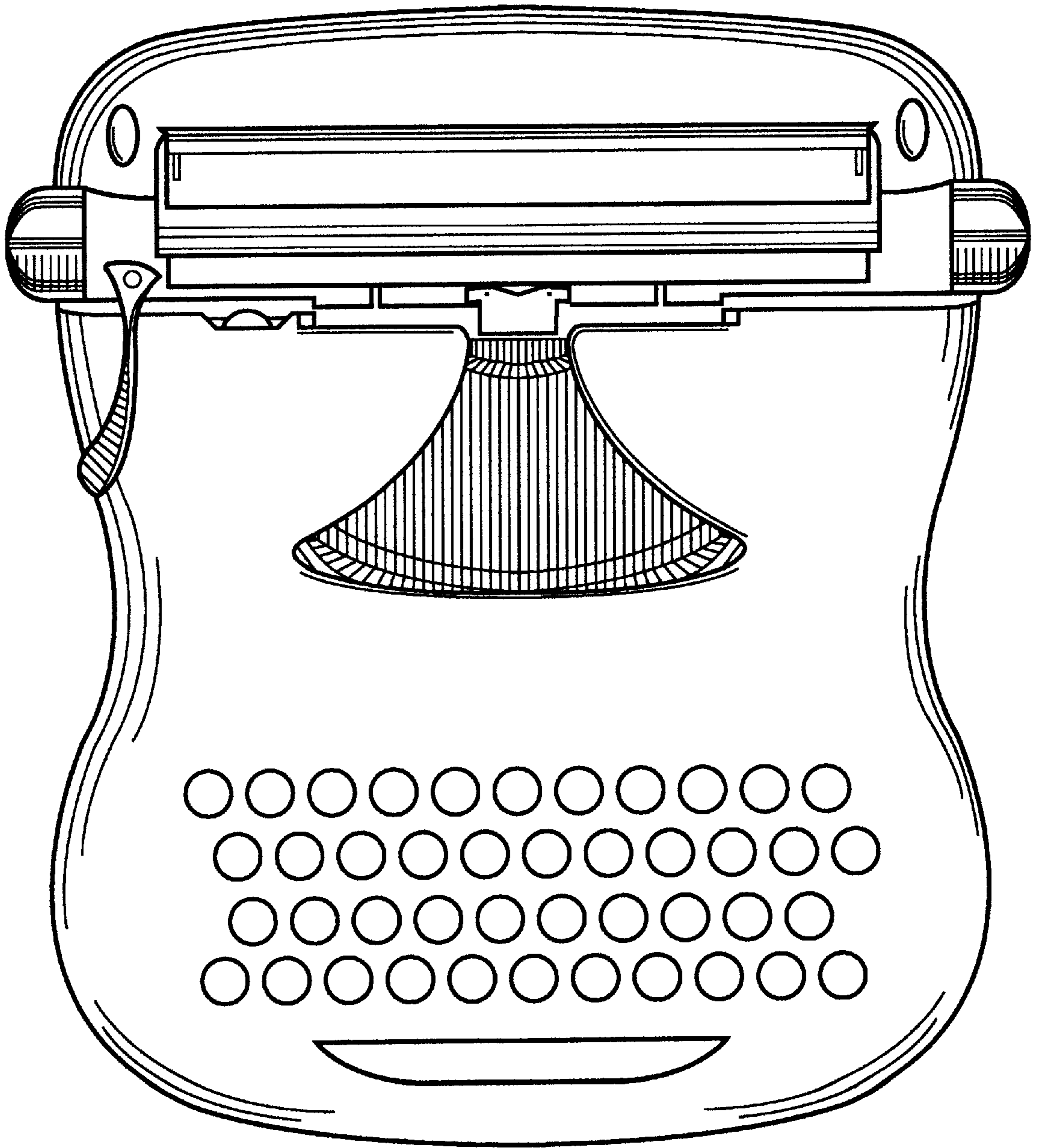

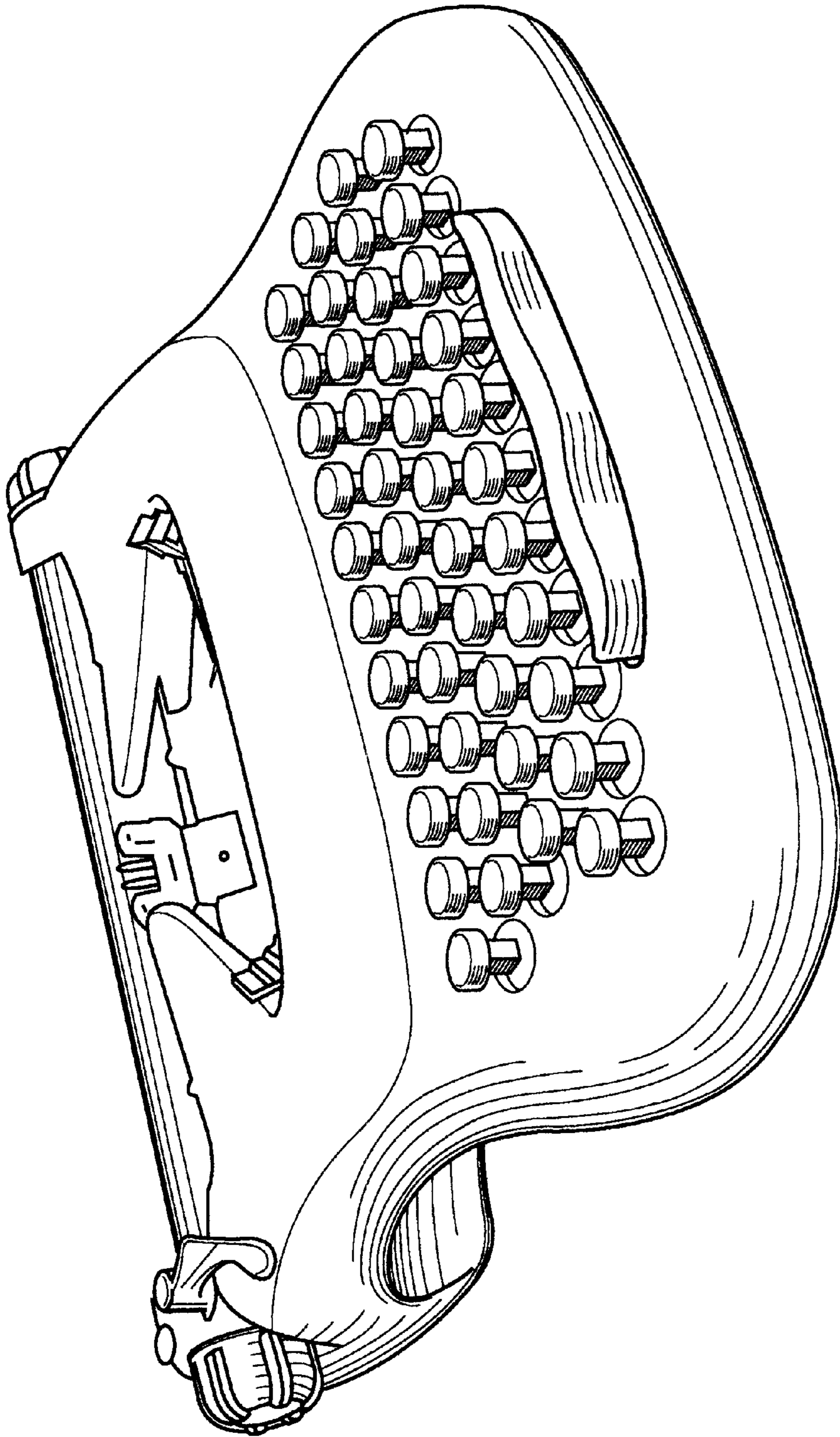

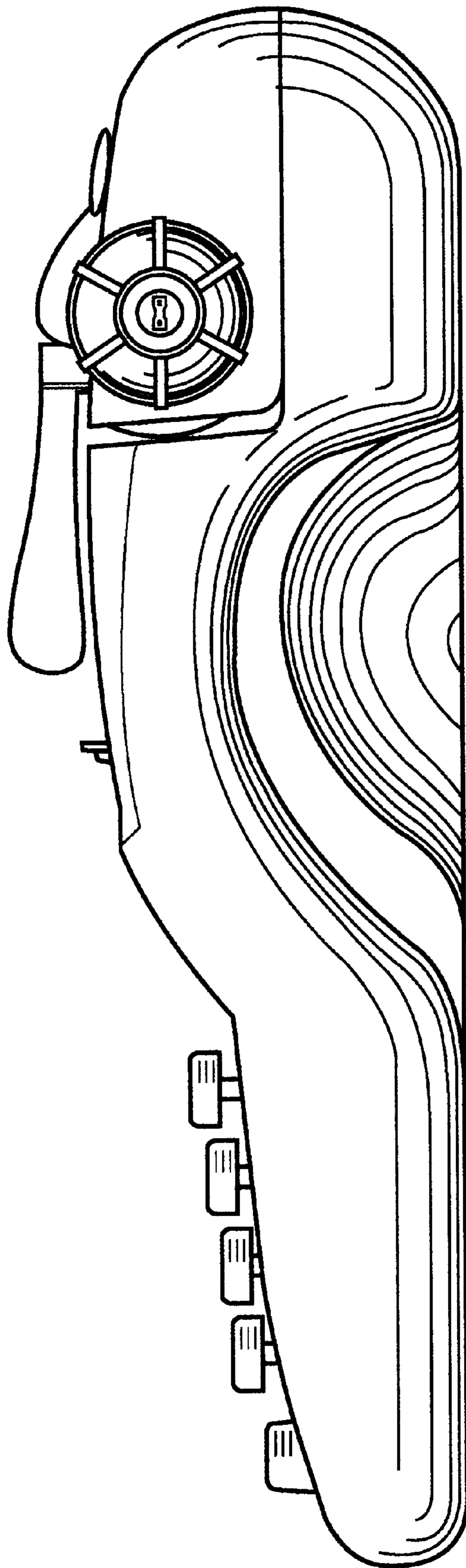

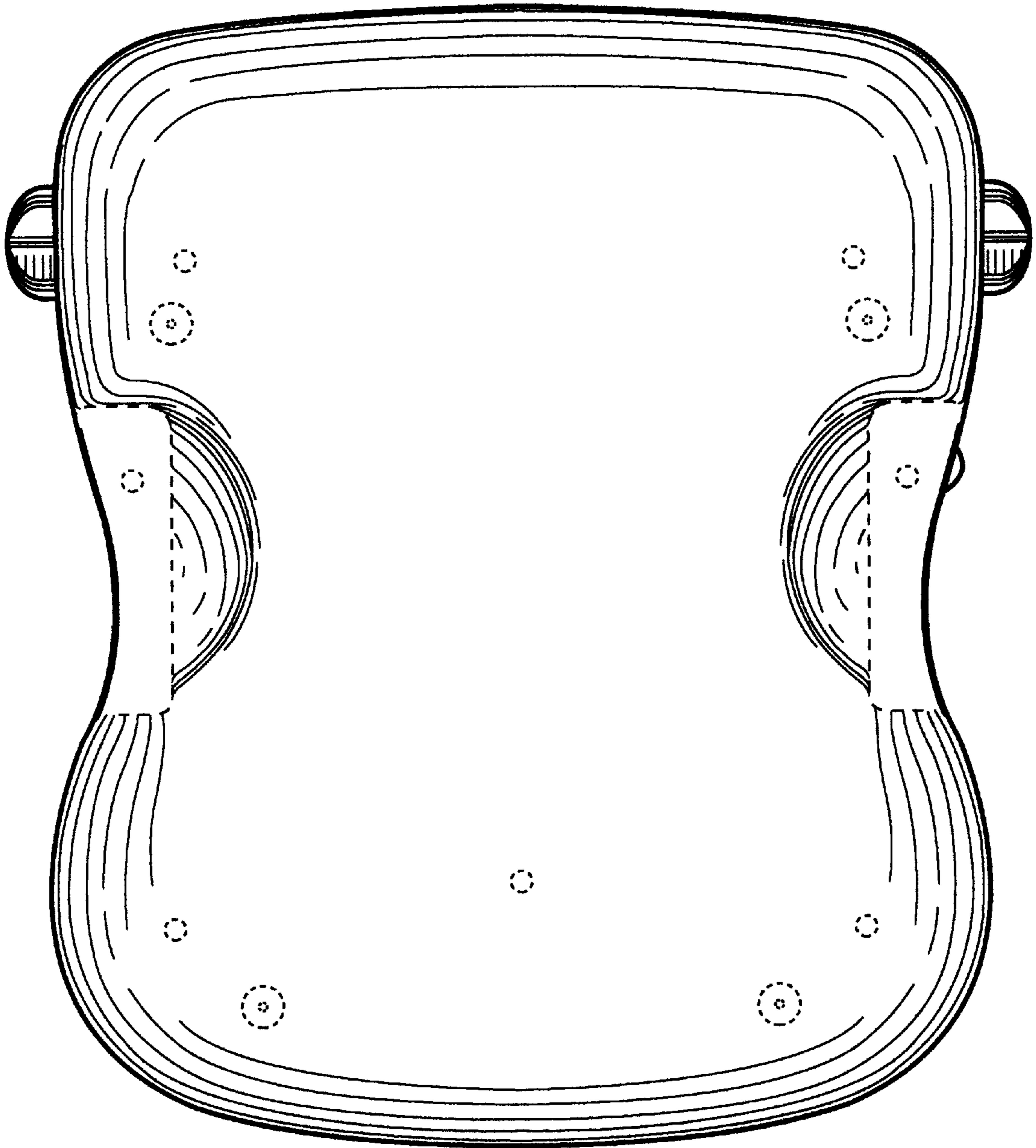

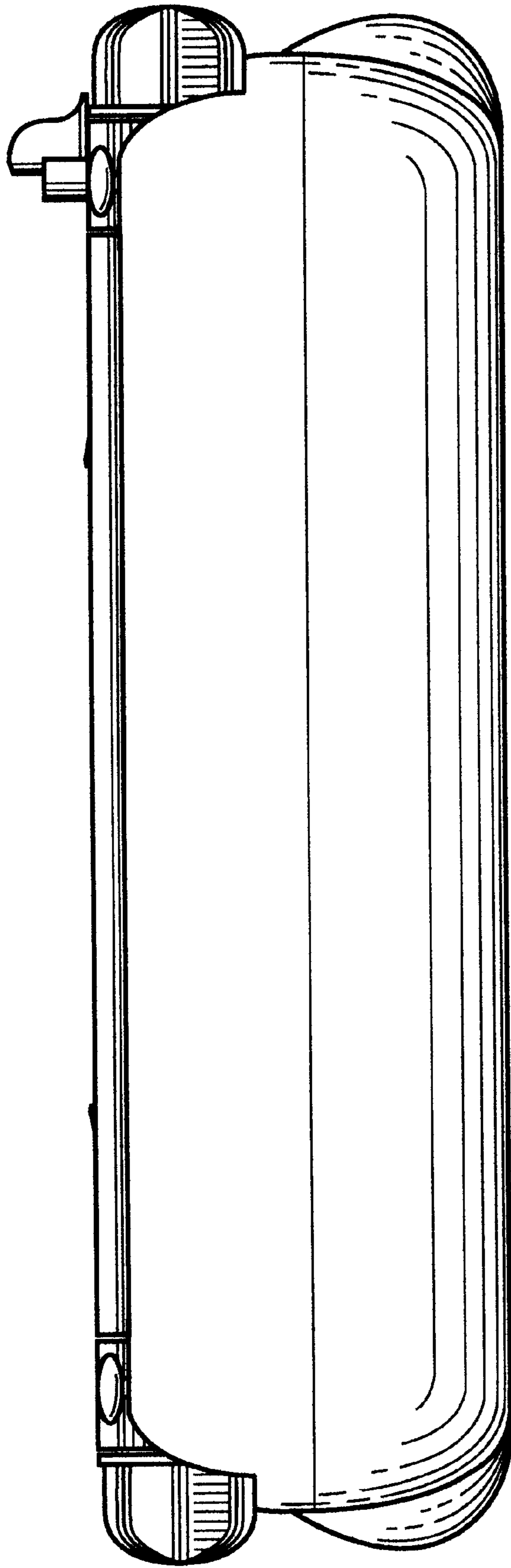

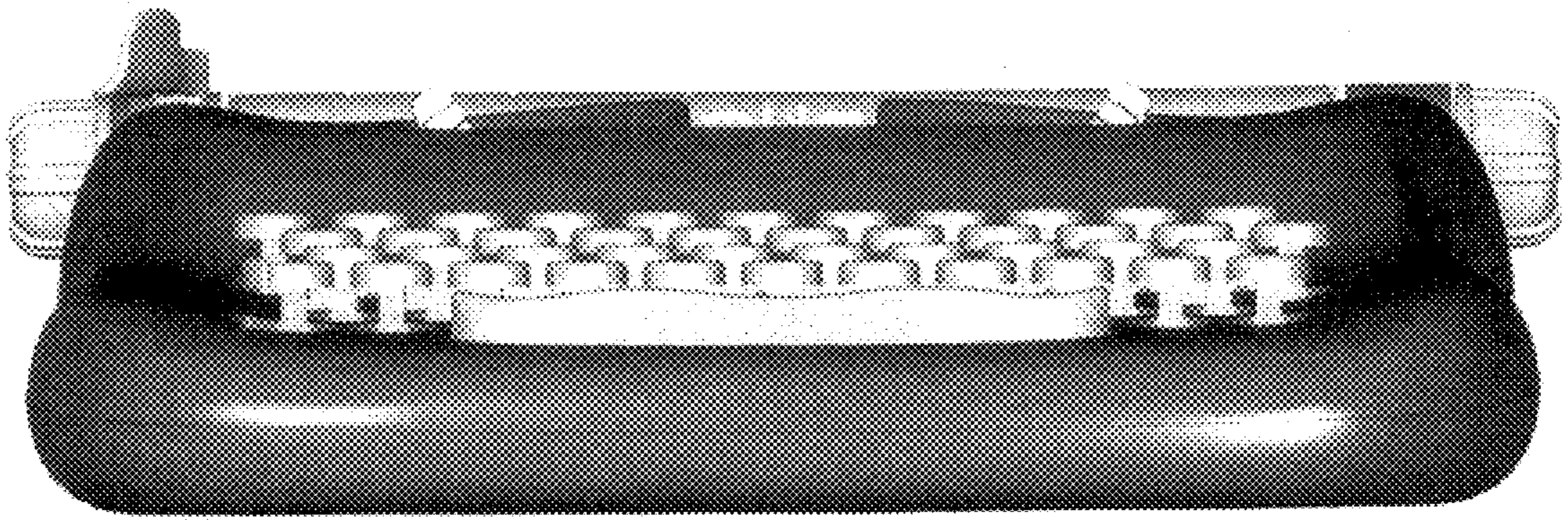

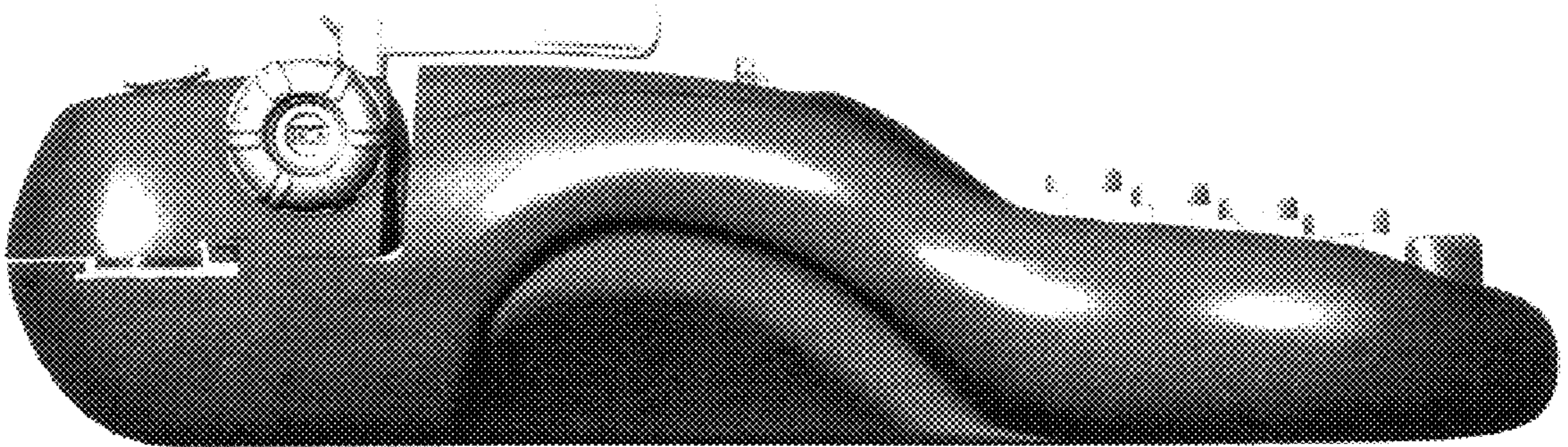
