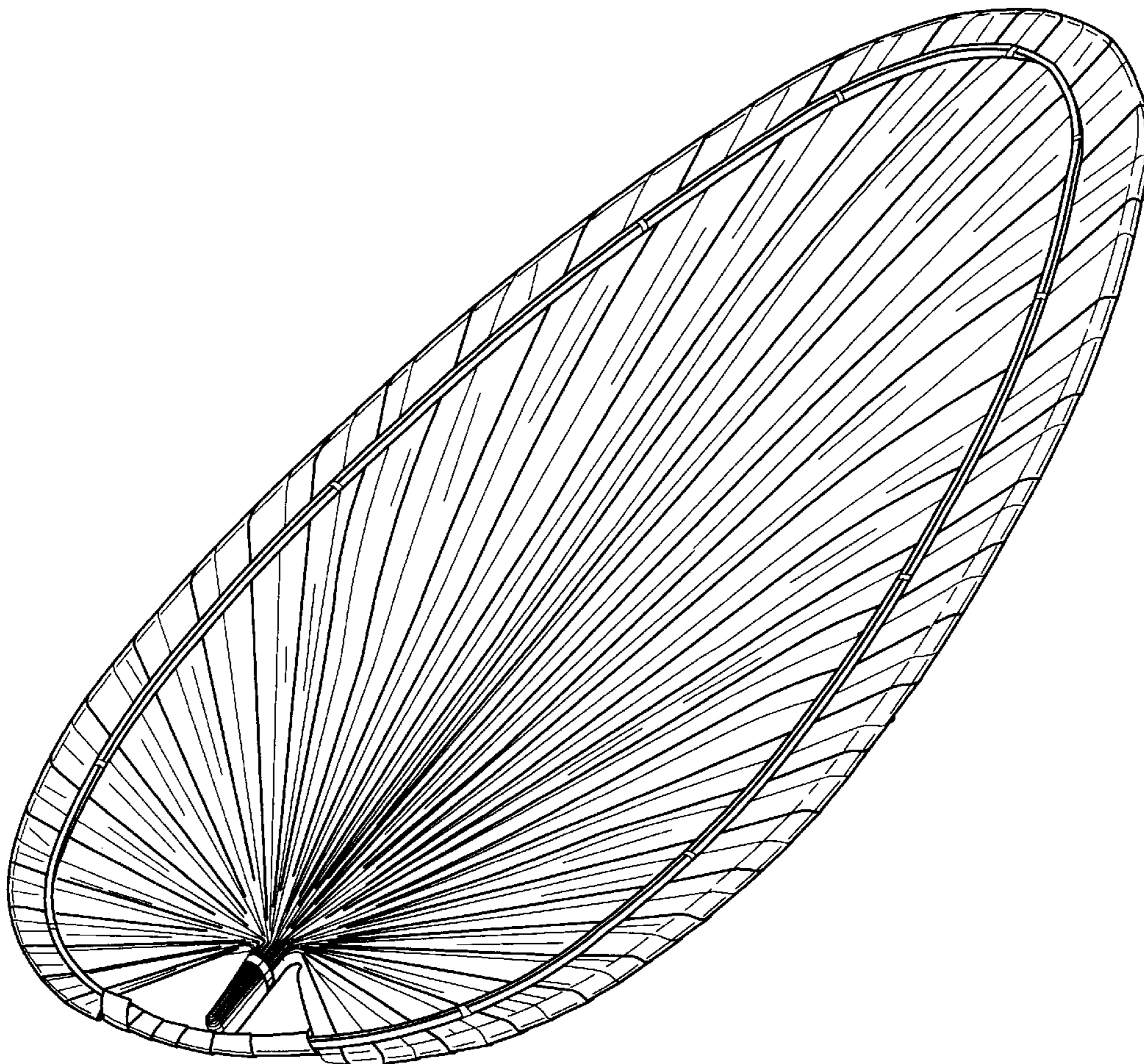
[57] CLAIM

The ornamental design for a fan blade, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a fan blade showing my novel design;
FIG. 2 is a bottom plan view of the design shown in FIG. 1;
FIG. 3 is an elevation view of the design shown in FIG. 1 viewed from the left of FIG. 1;
FIG. 4 is an elevation view of the design shown in FIG. 1 viewed from the right of FIG. 1;
FIG. 5 is an elevation view of the design shown in FIG. 1 viewed from the top of FIG. 1;
FIG. 6 is an elevation view of the design shown in FIG. 1 viewed from the bottom of FIG. 1; and,
FIG. 7 is a top perspective of the design shown in FIG. 1.

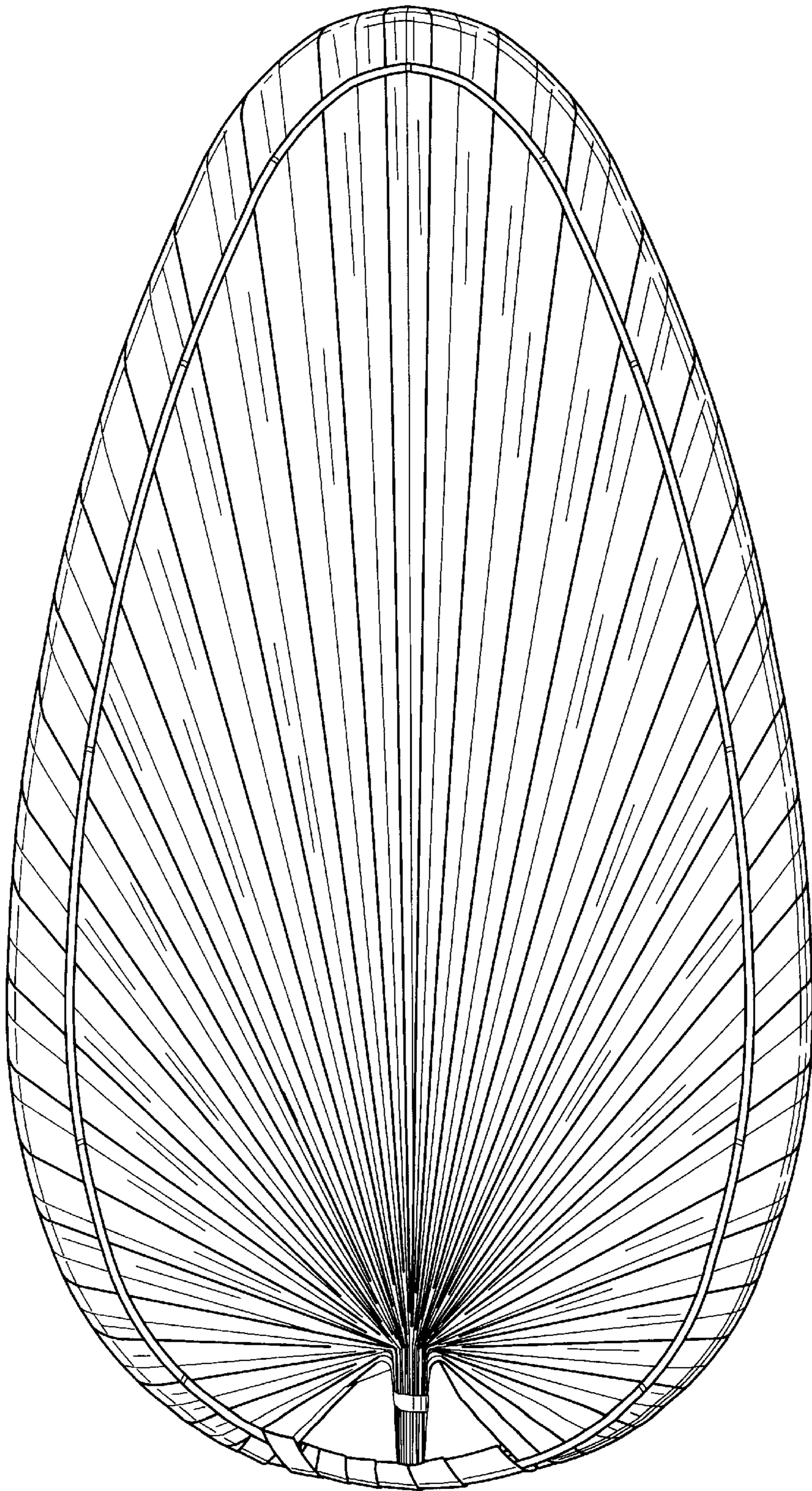

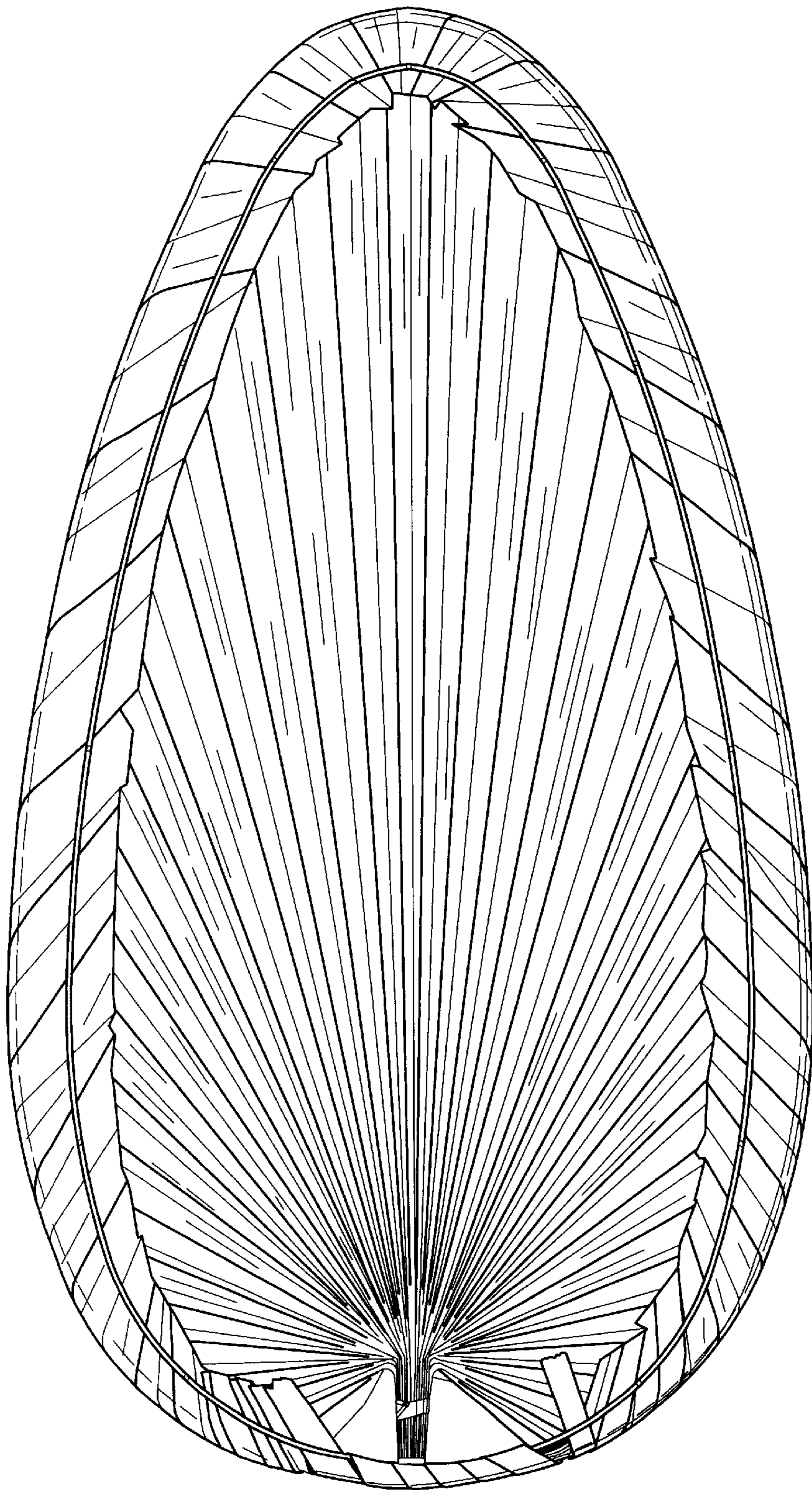

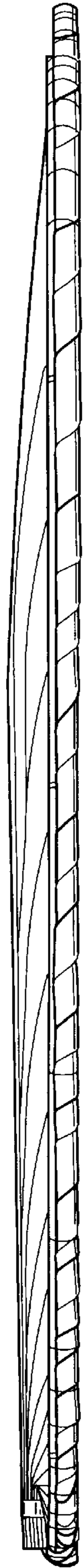

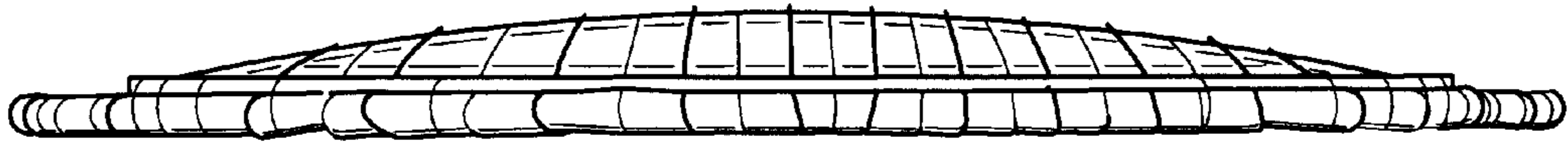

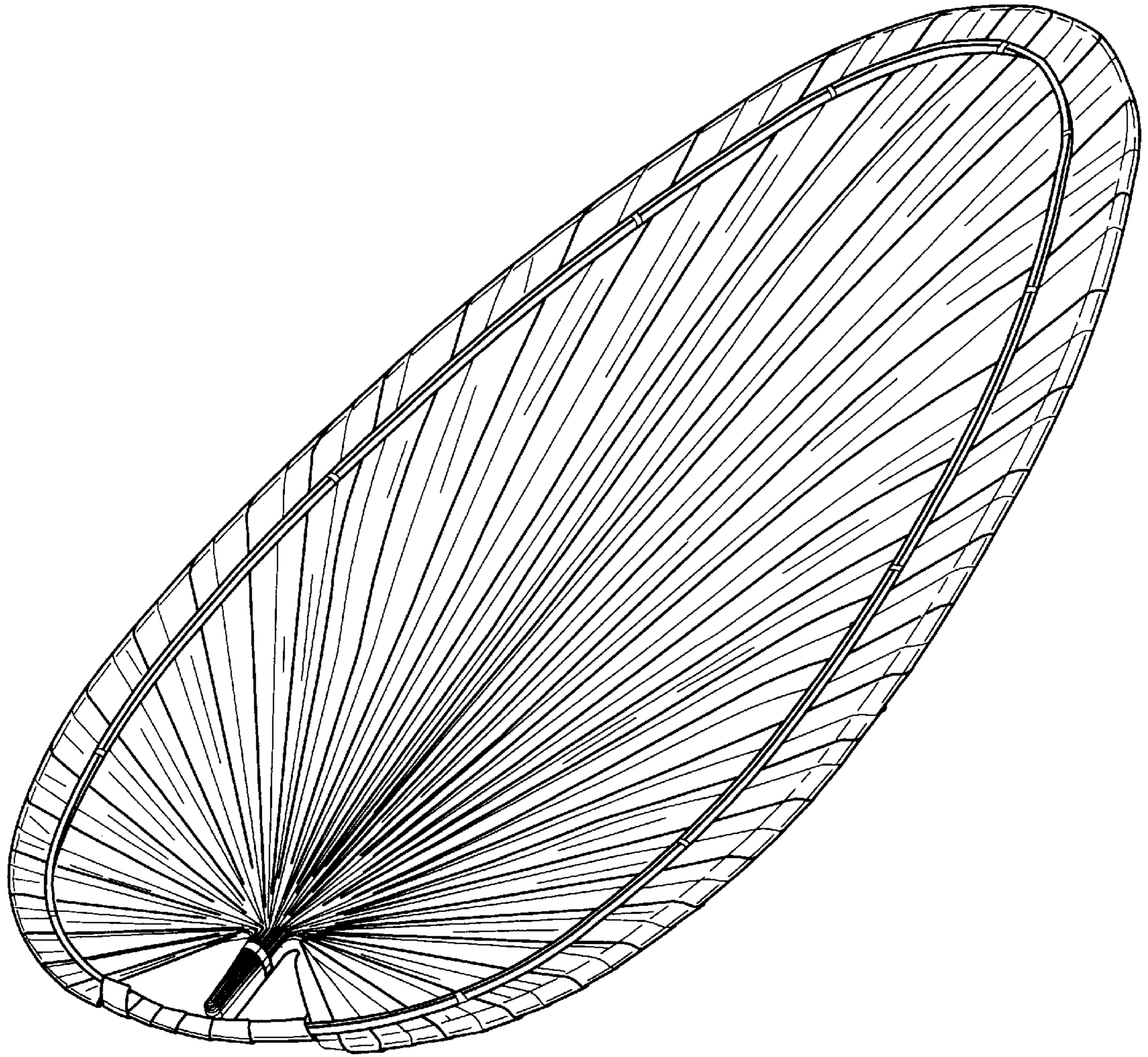
