[57] CLAIM

I claim the ornamental design for wine cork birdhouse, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a wine cork birdhouse showing my new design.

FIG. 2 is a rear elevational view thereof.

FIG. 3 is a right side elevational view thereof.

FIG. 4 is a left side elevational view thereof.

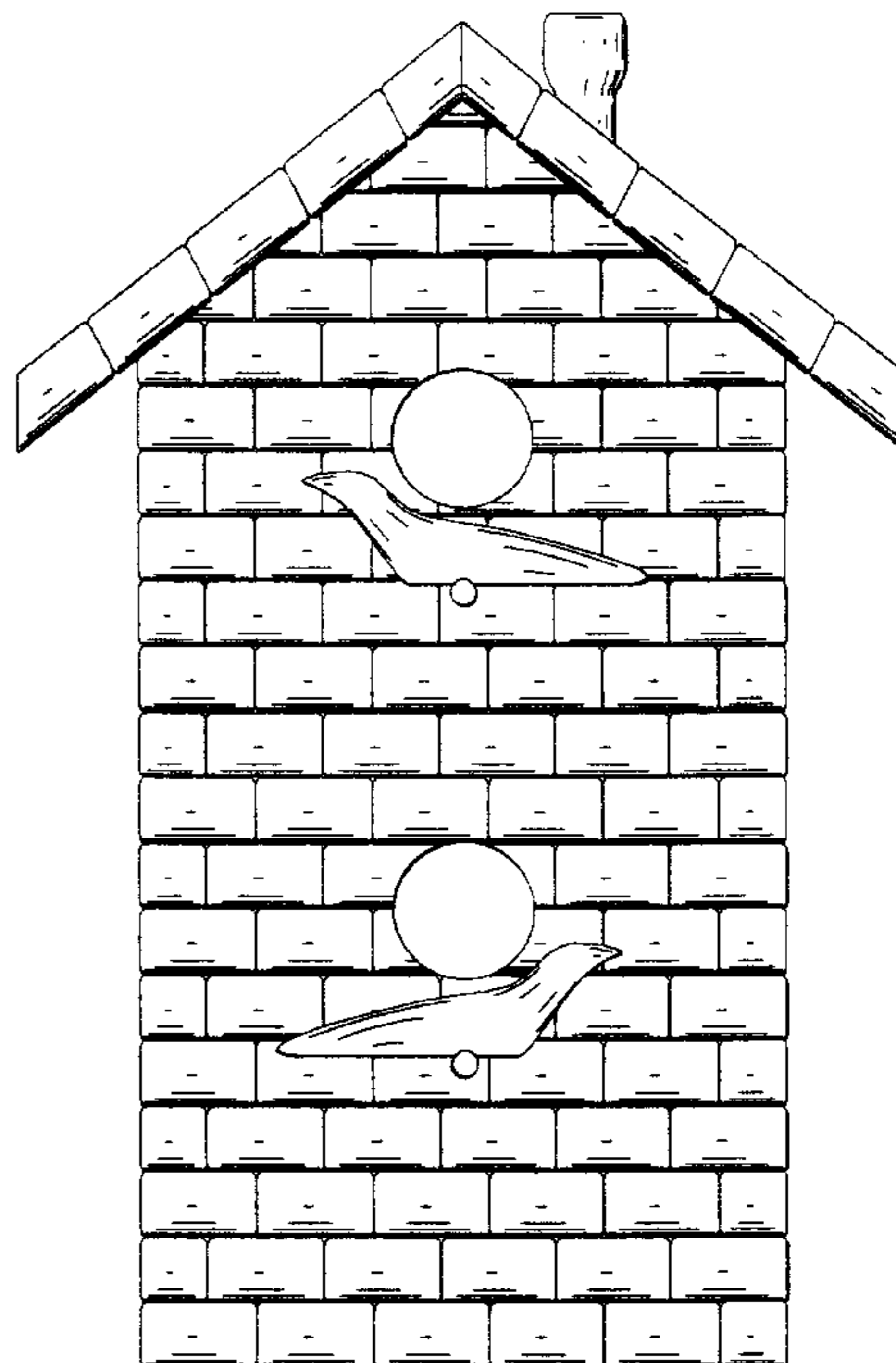
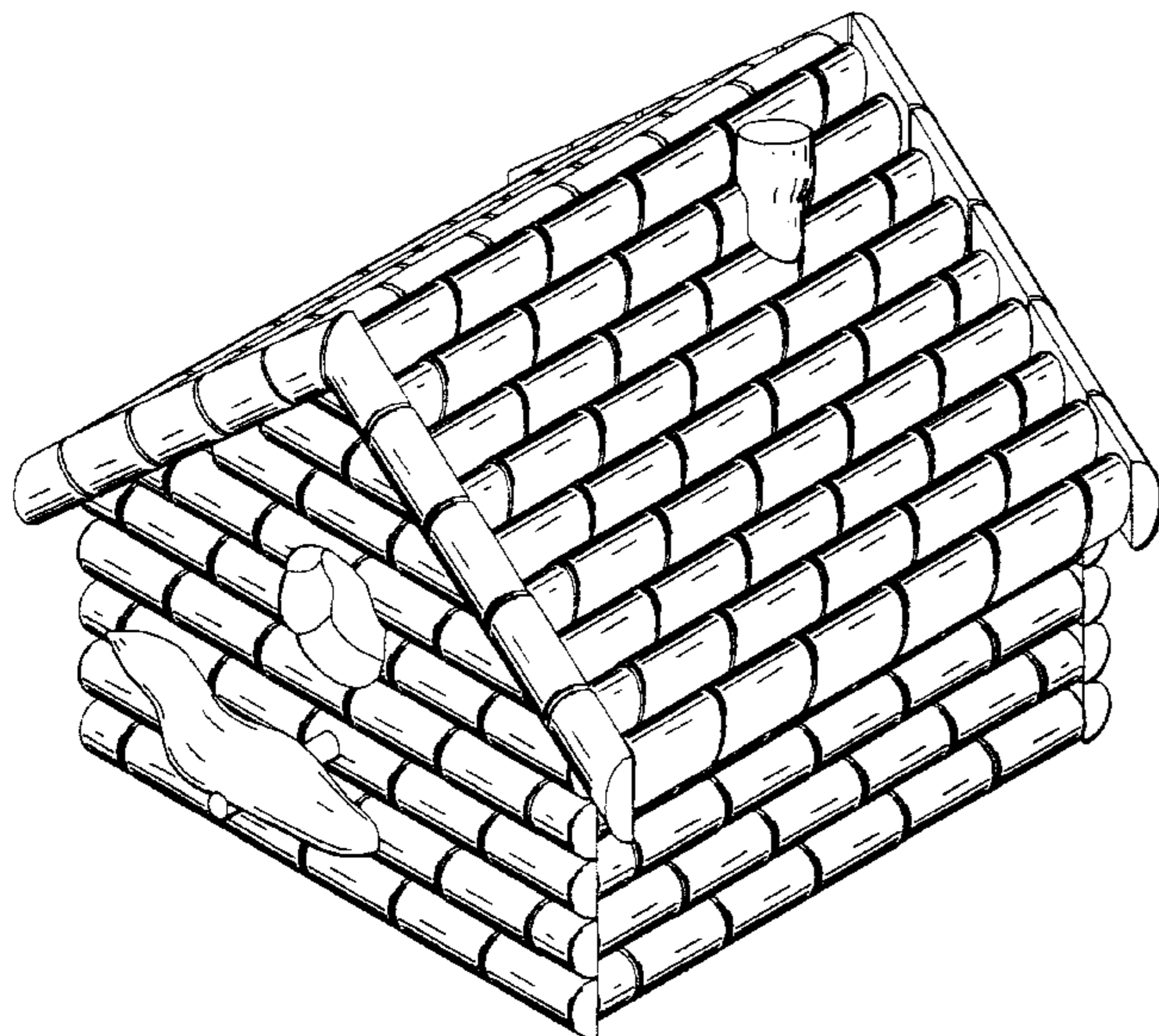
FIG. 5 is a top plan view thereof.

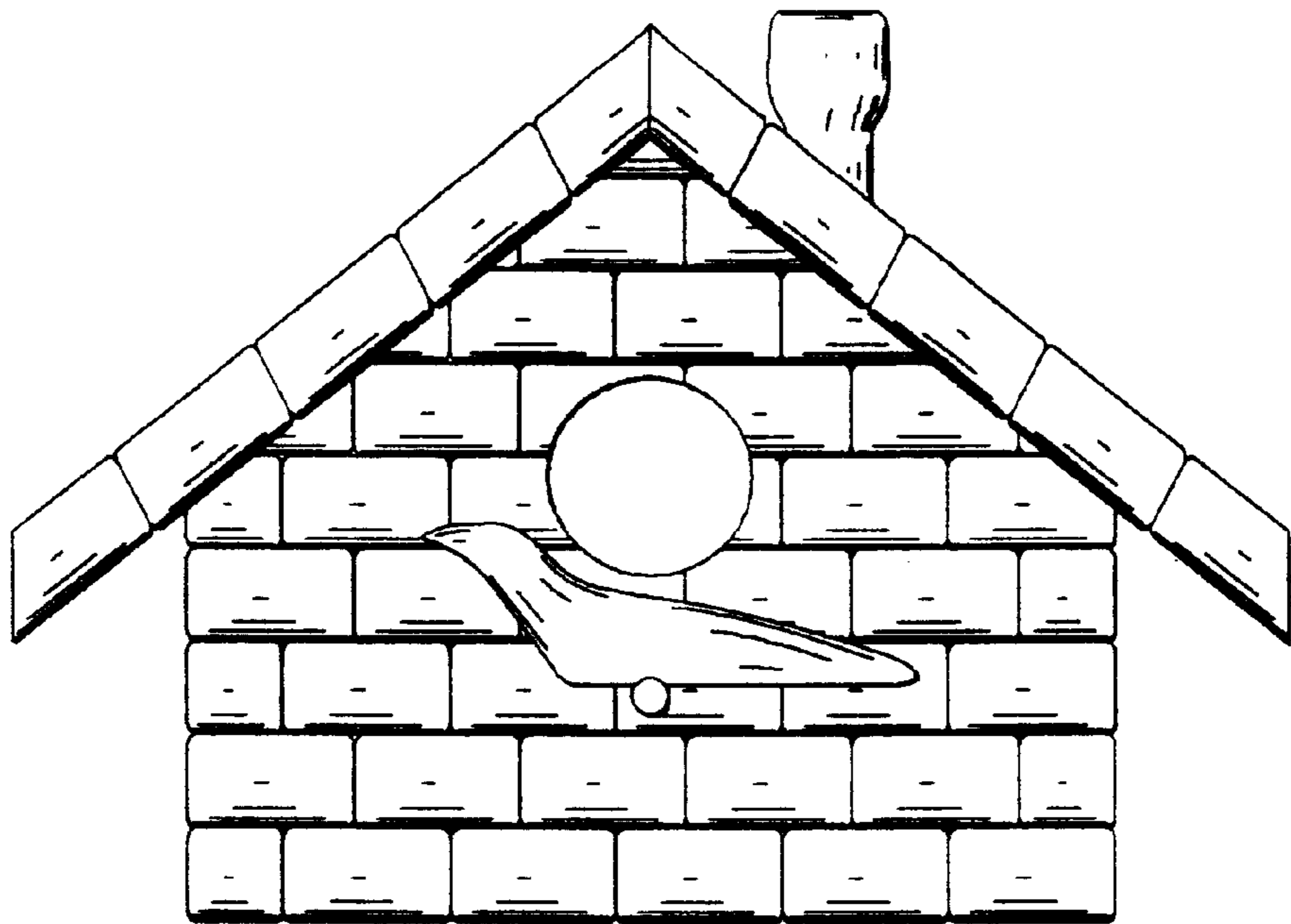

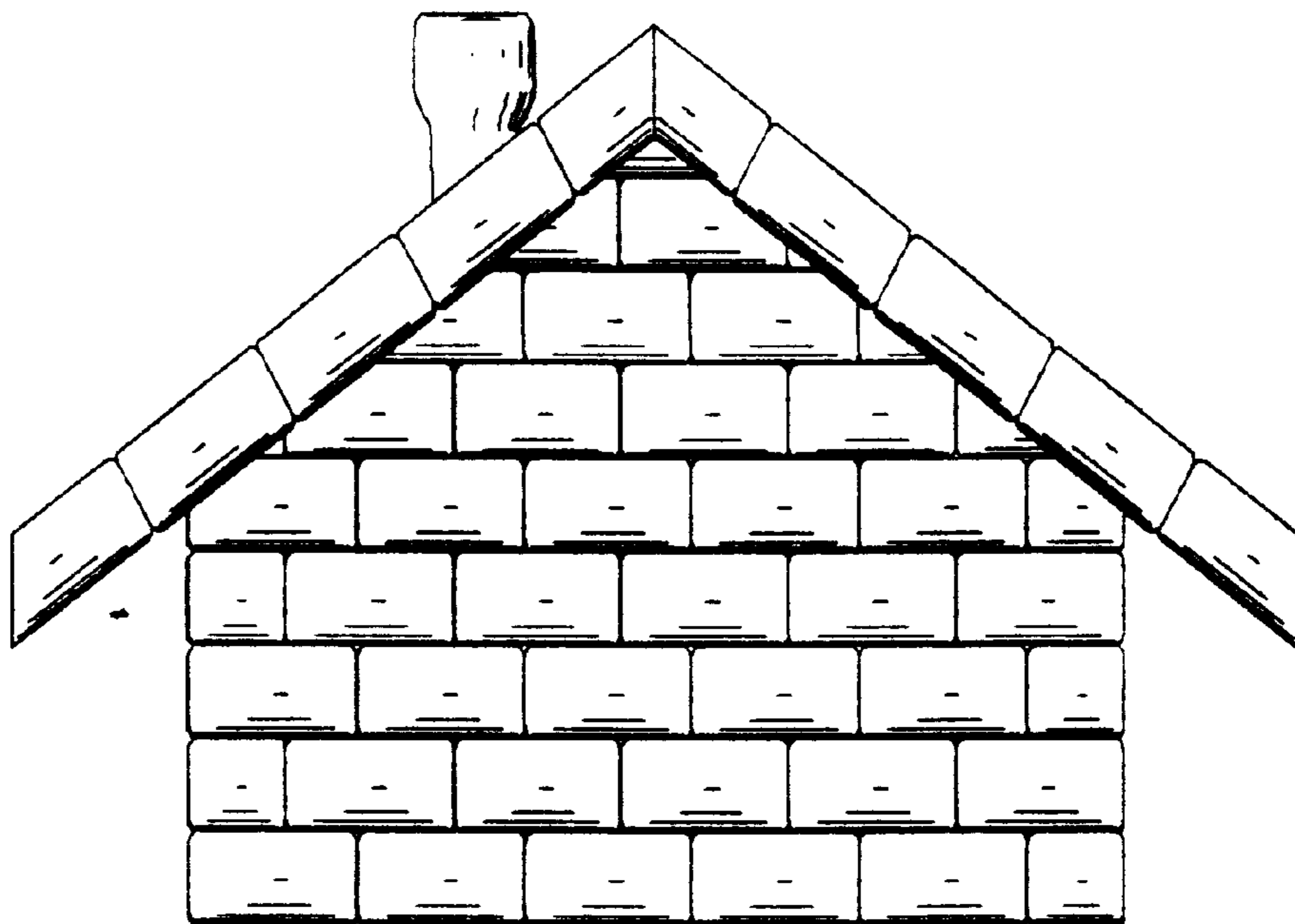

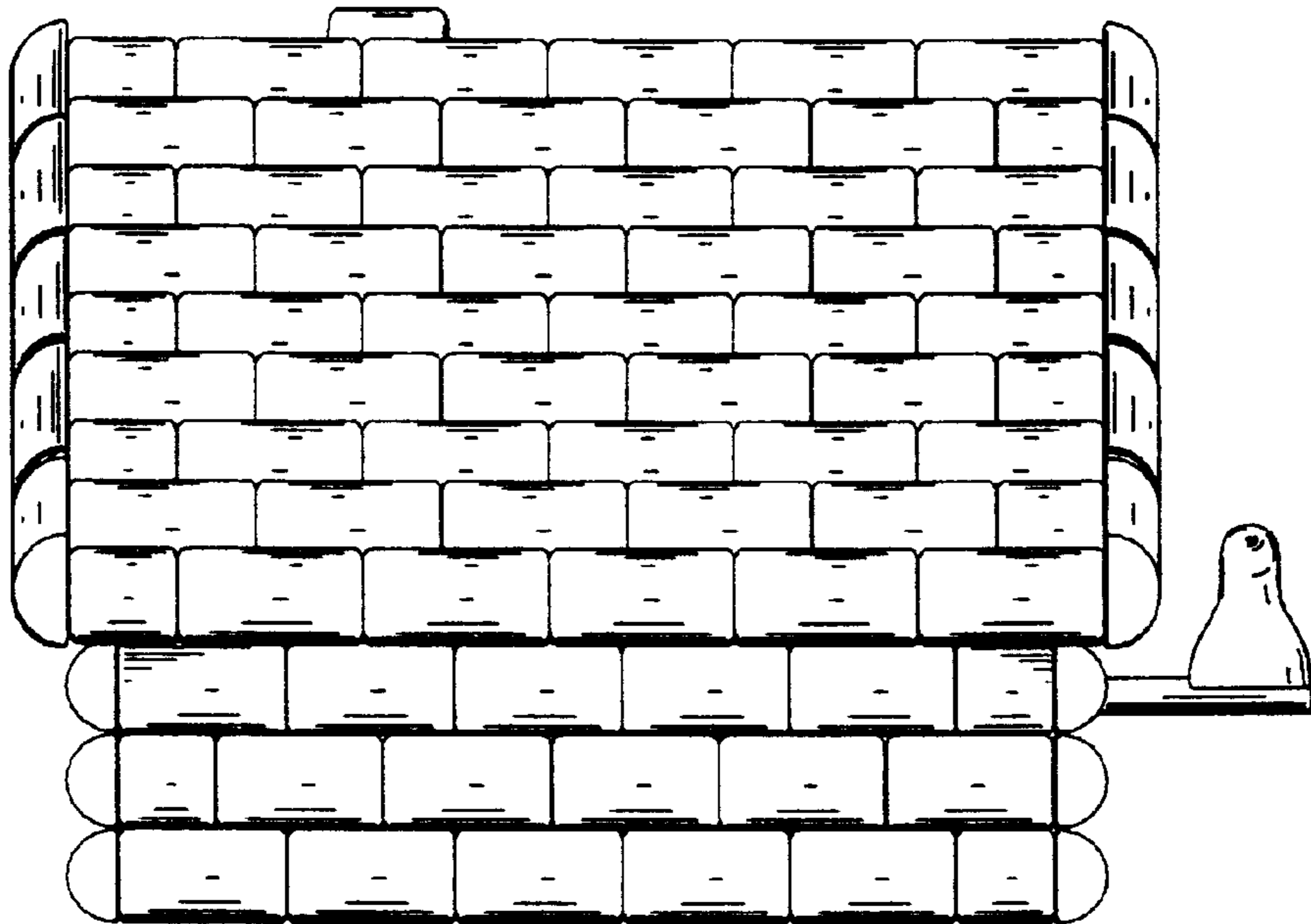

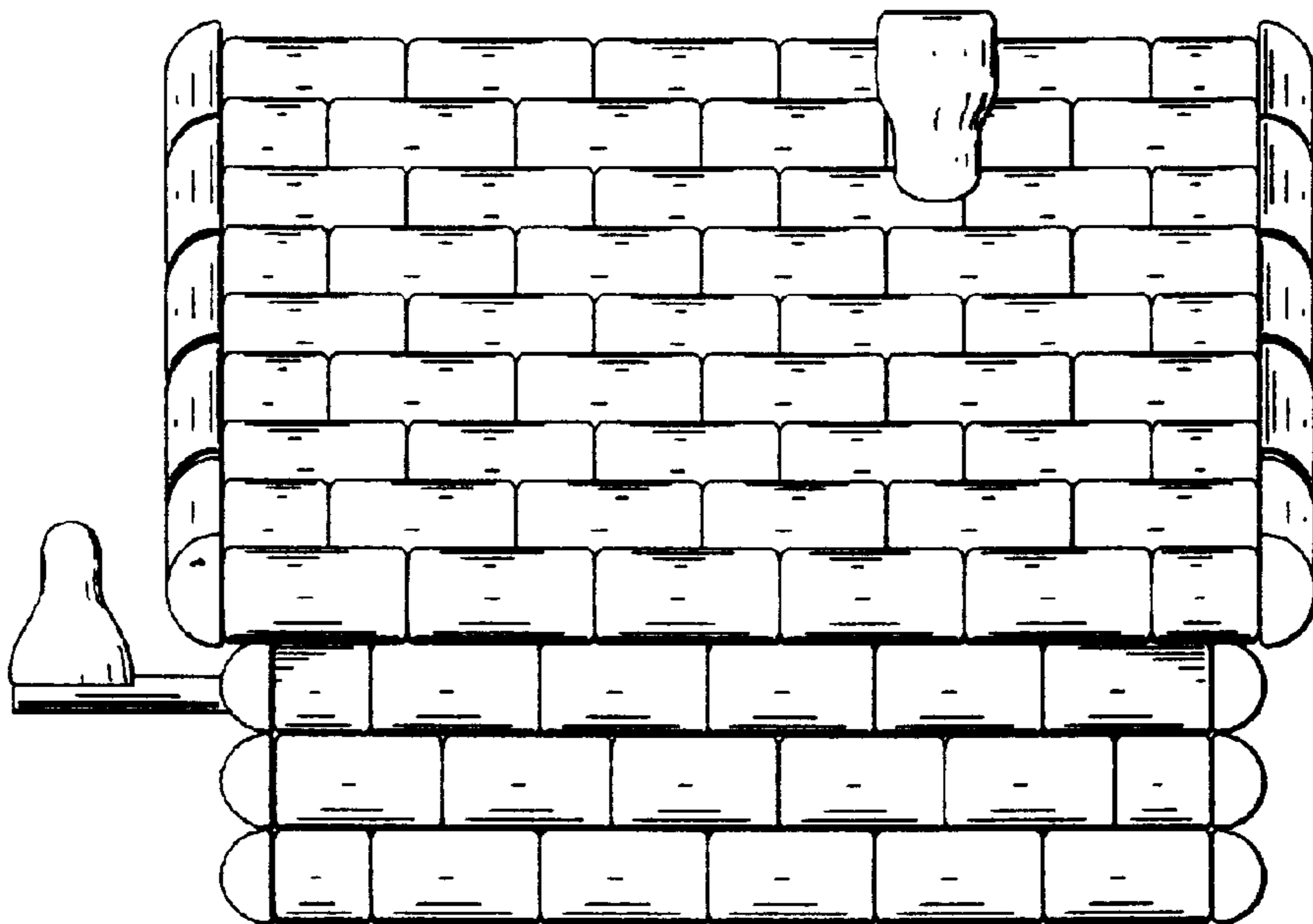

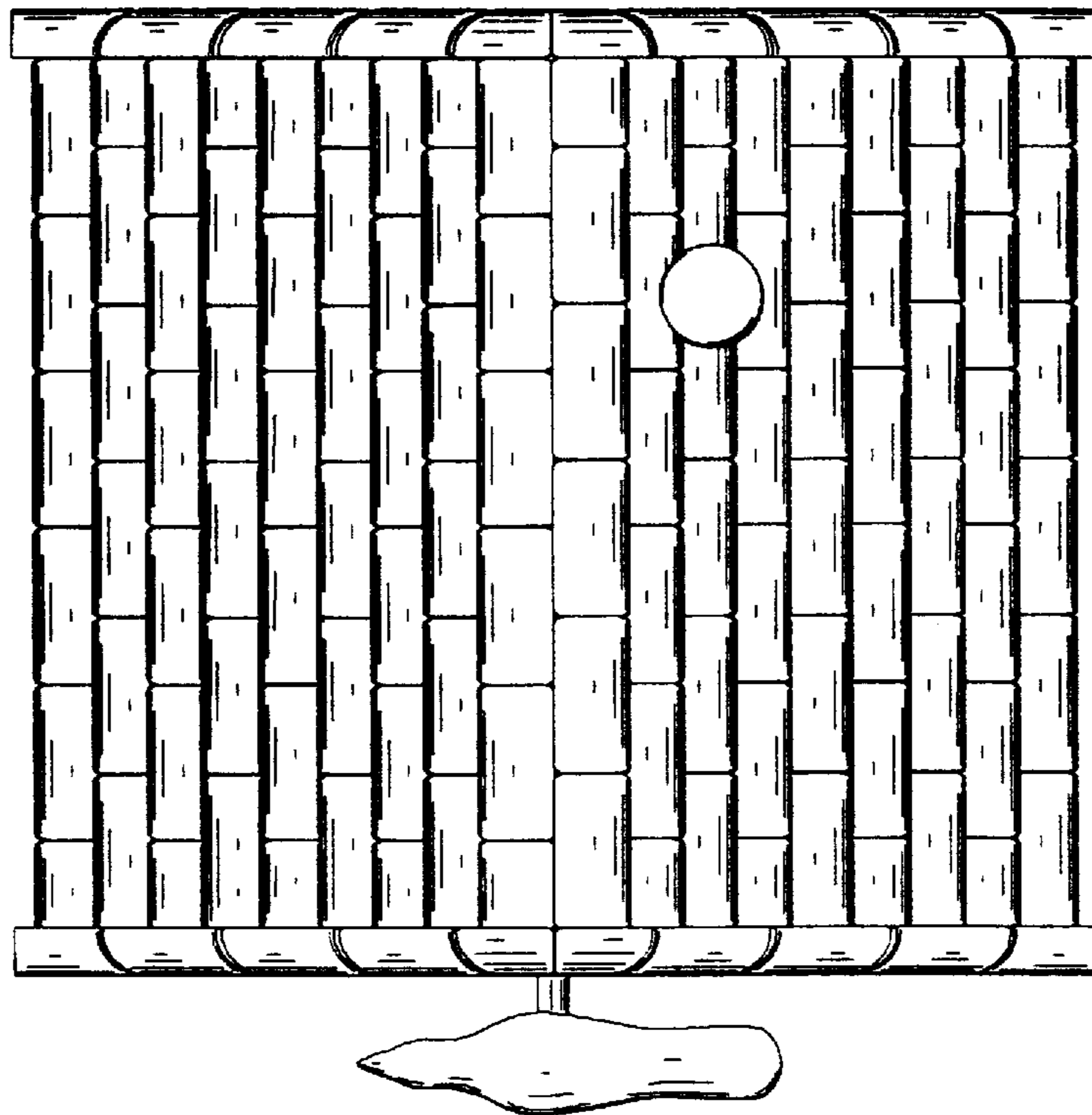
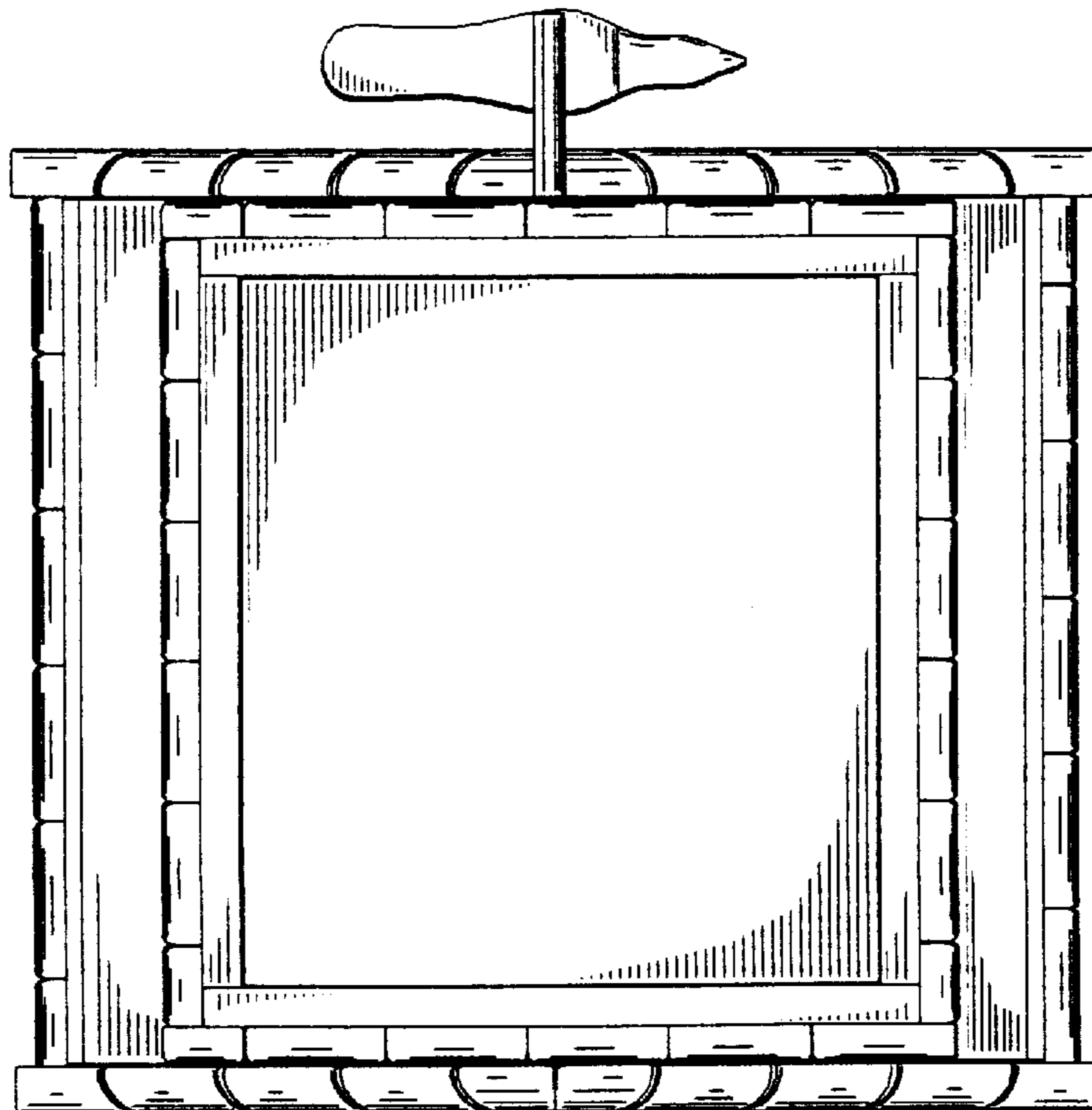

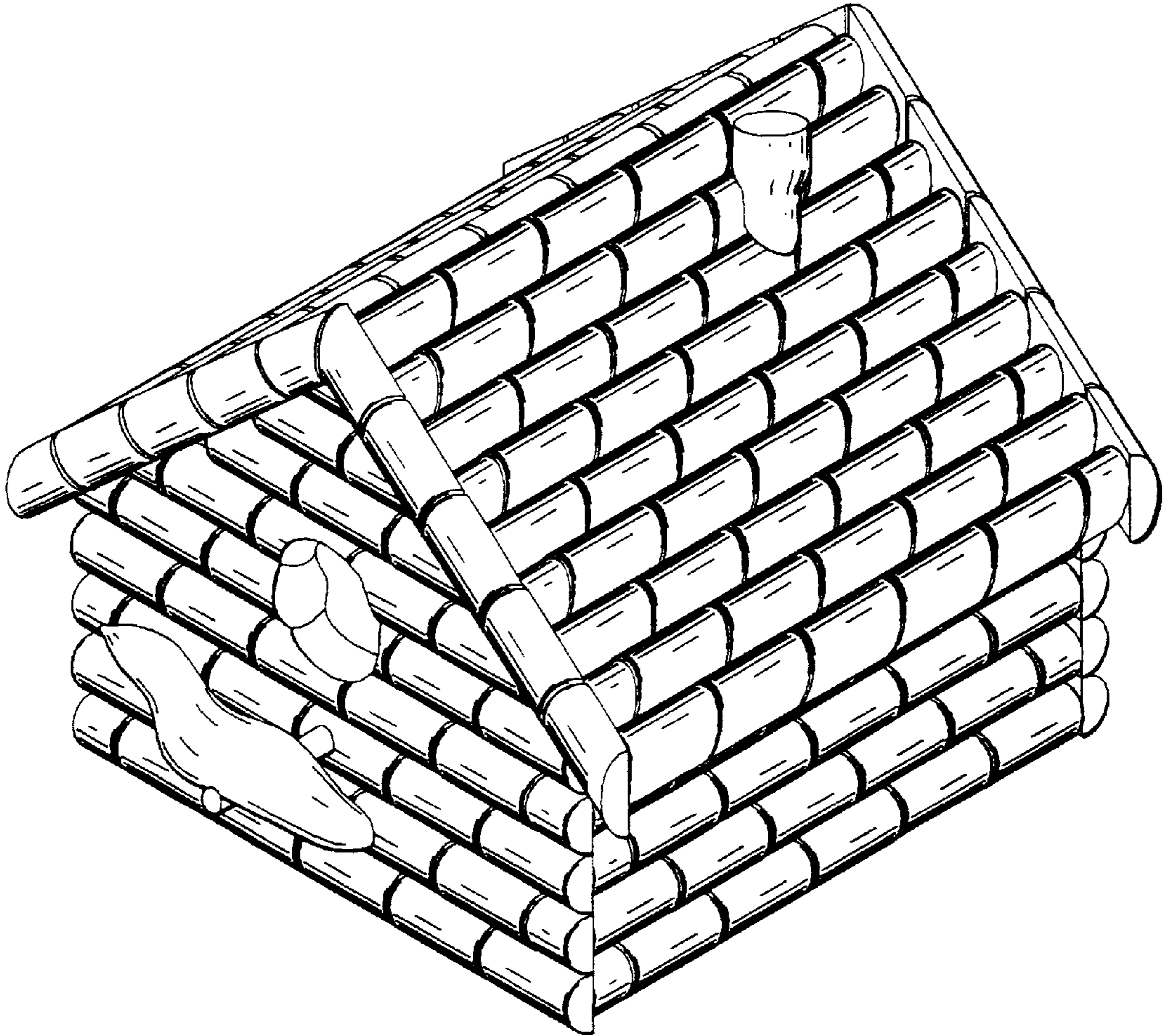

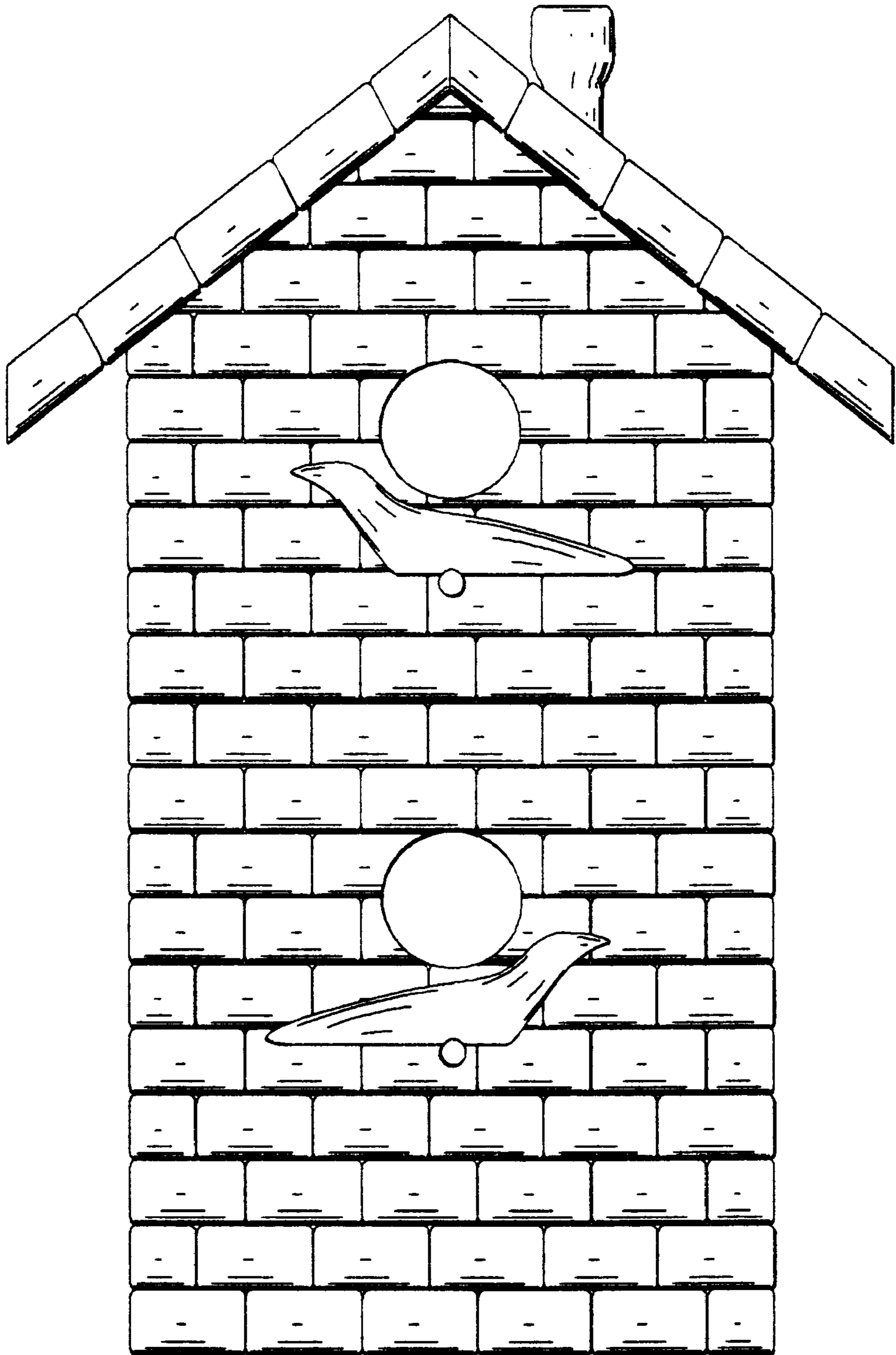
