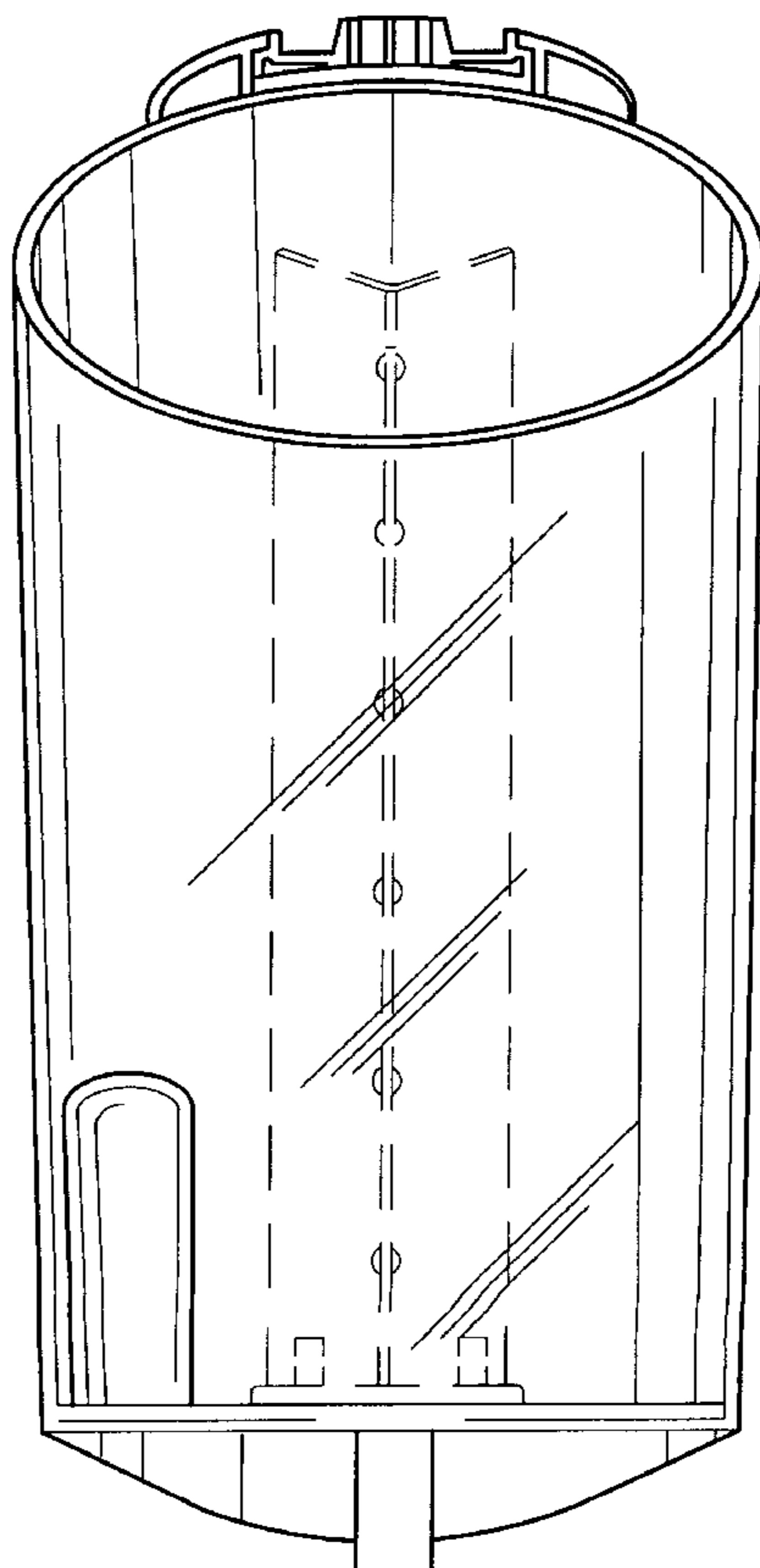
[57] CLAIM

The ornamental design for a vacuum cleaner dust cup, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a vacuum cleaner dust cup showing our new design; FIG. 2 is a rear elevational view thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a right side elevational view thereof; FIG. 5 is a left side elevational view thereof; and, FIG. 6 is a bottom plan view thereof. The parts shown in broken lines in FIGS. 1–6 are shown for illustrative purposes only and form no part of the claimed design.

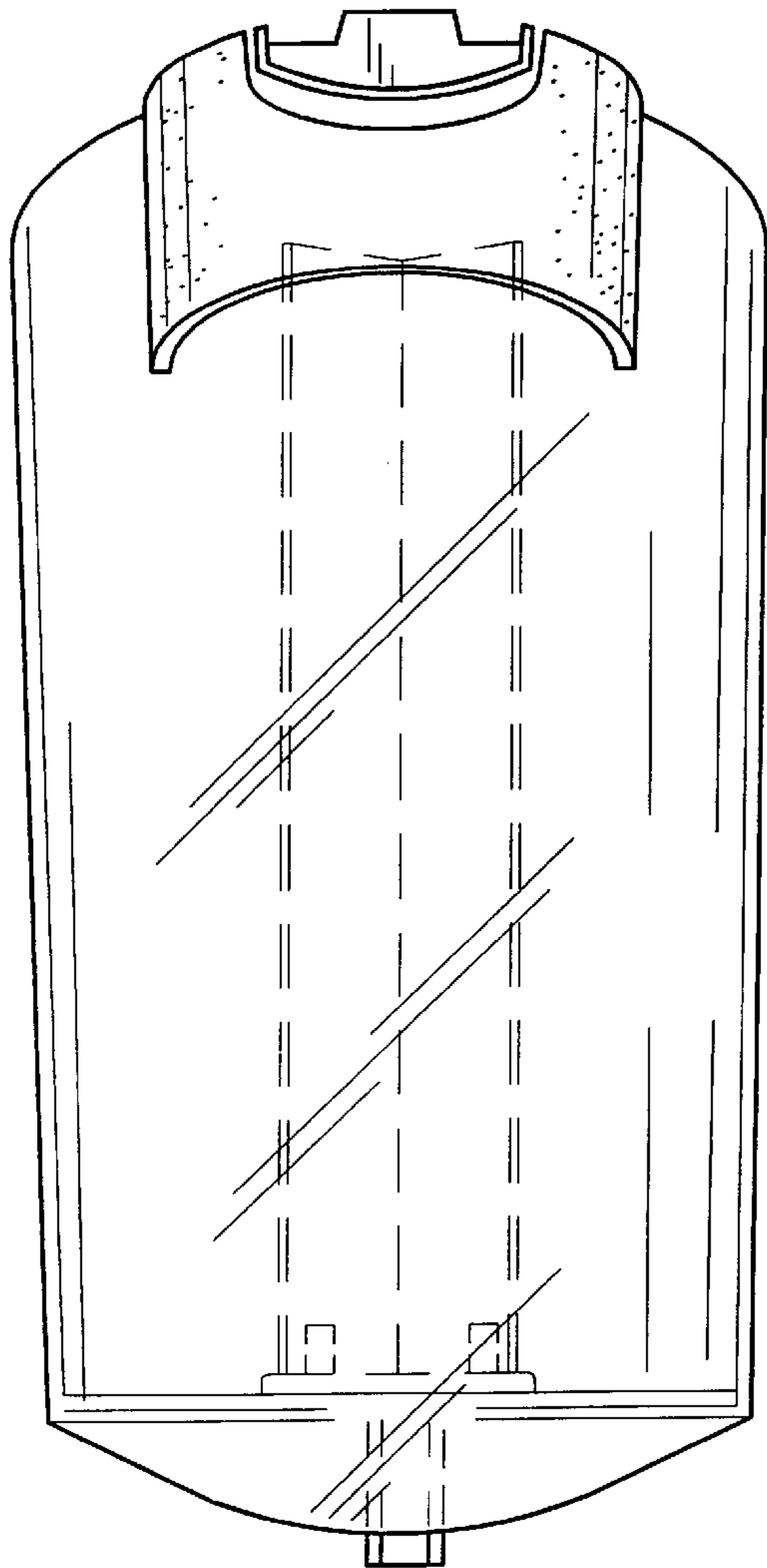

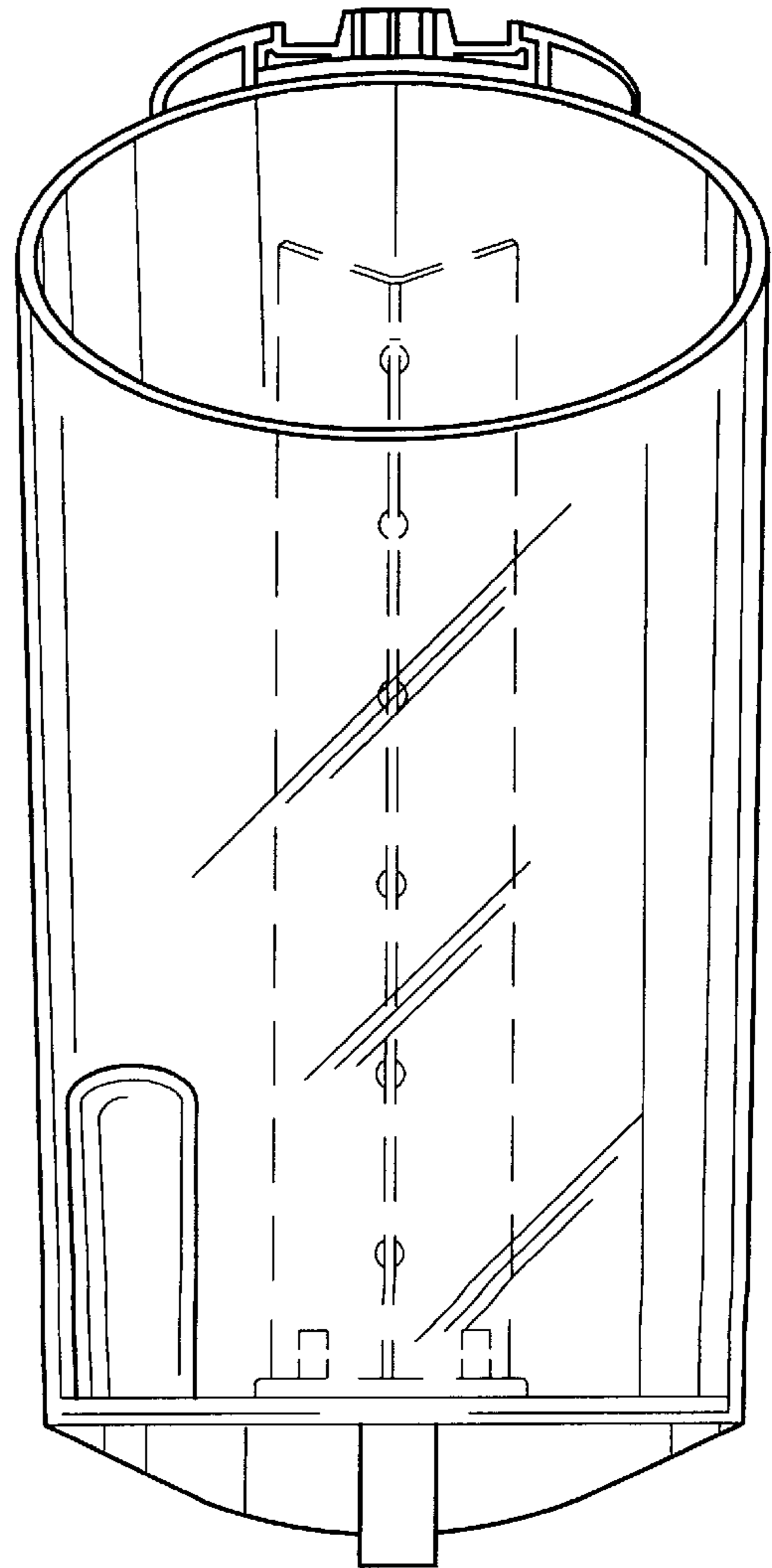

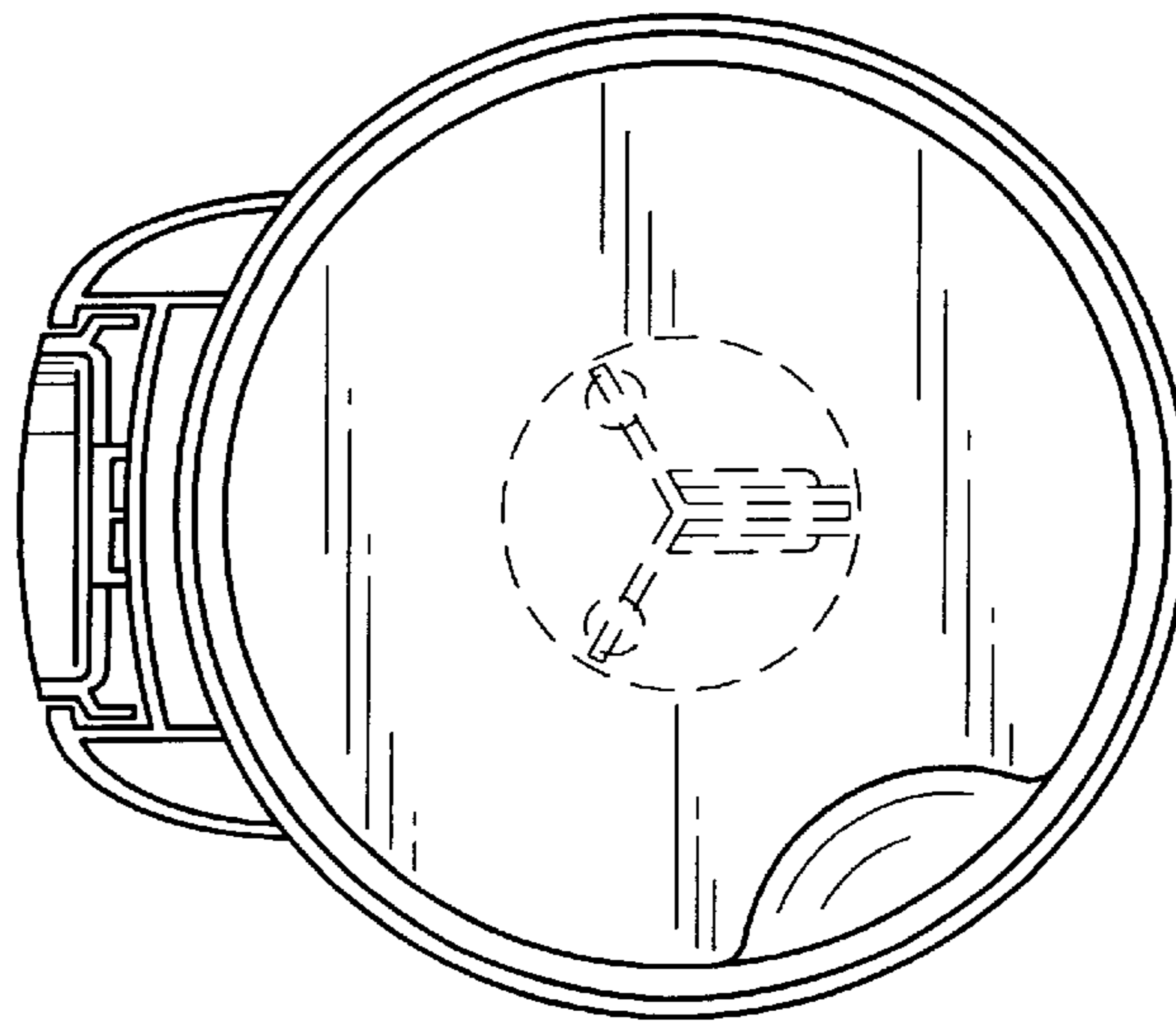

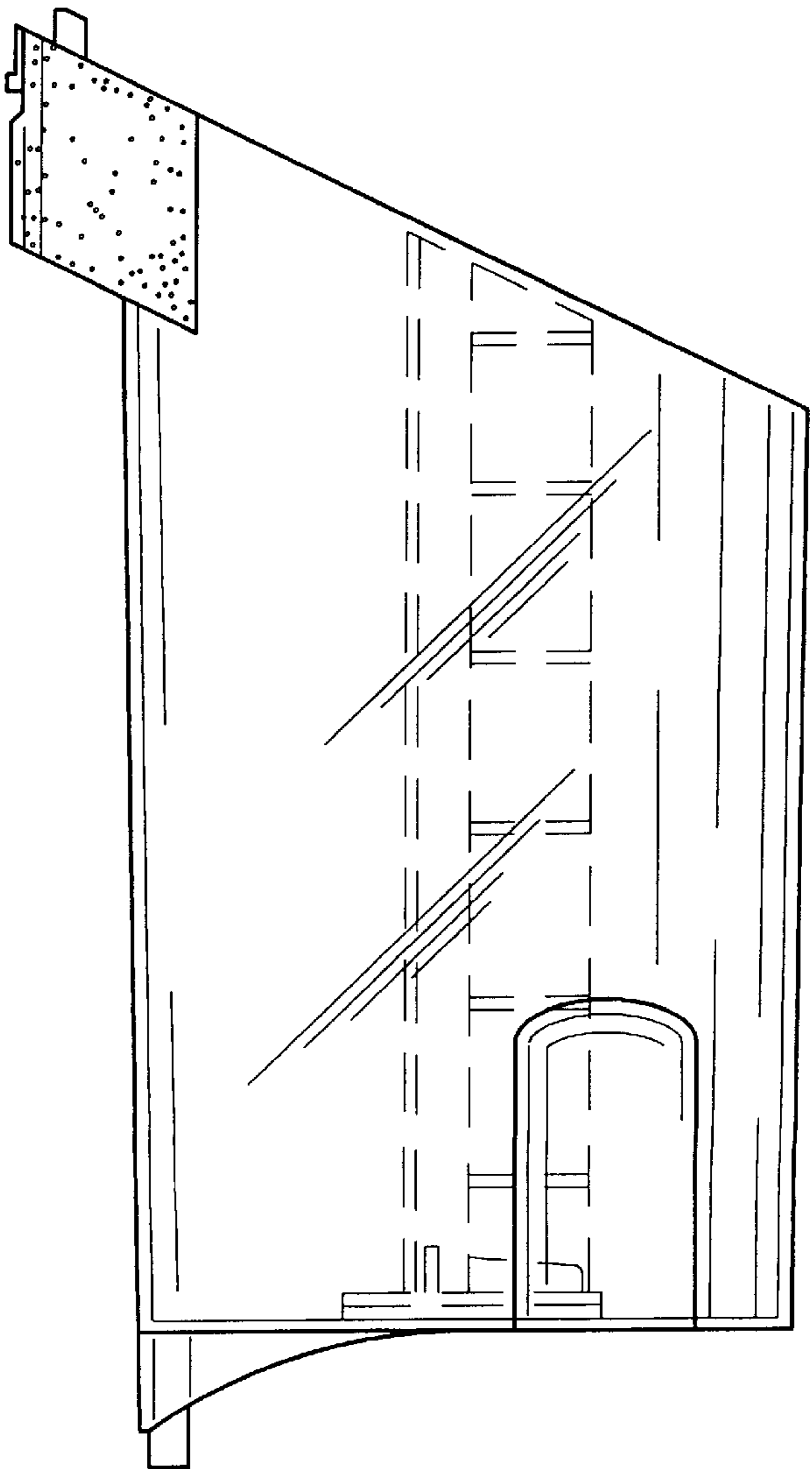

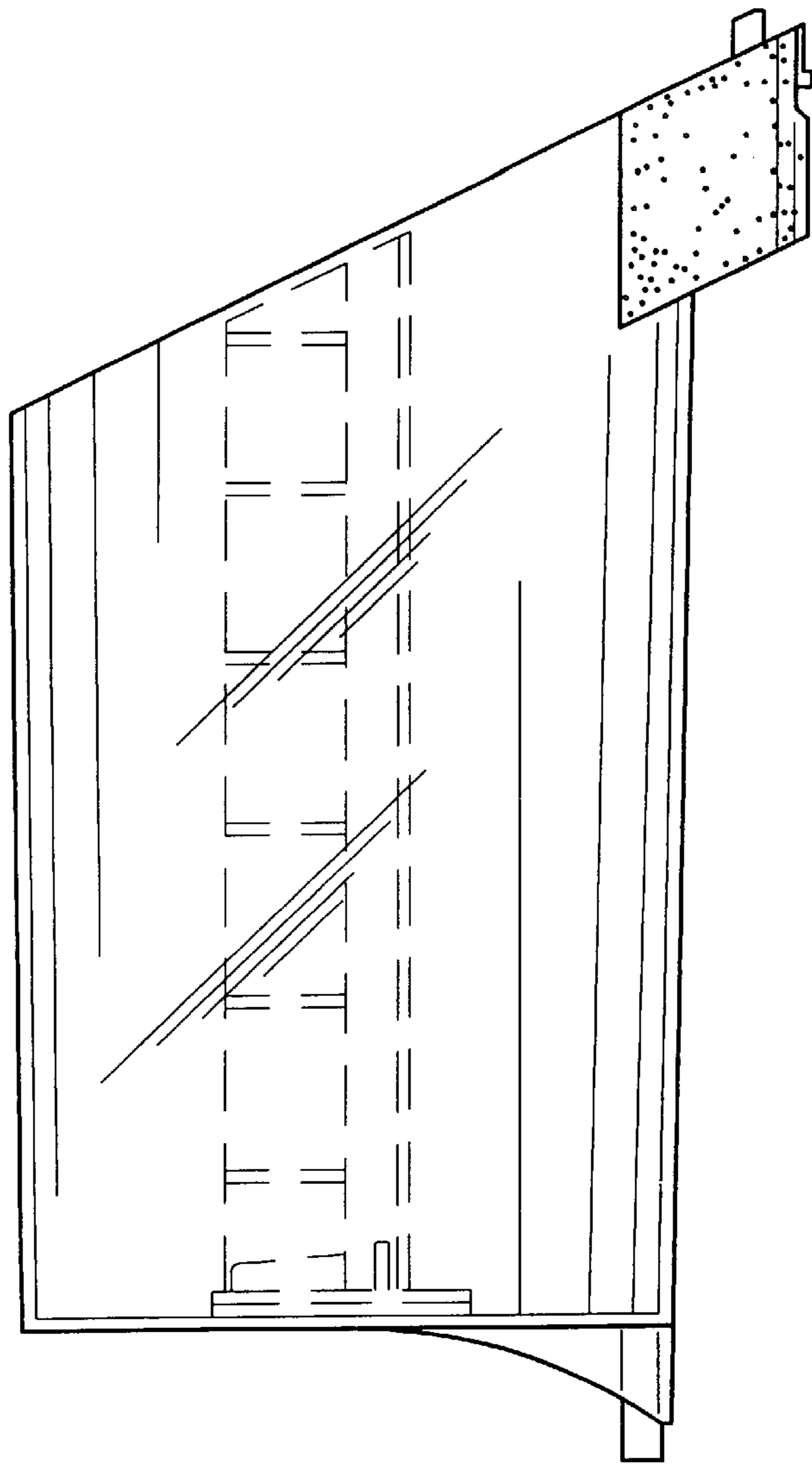
