DESCRIPTION

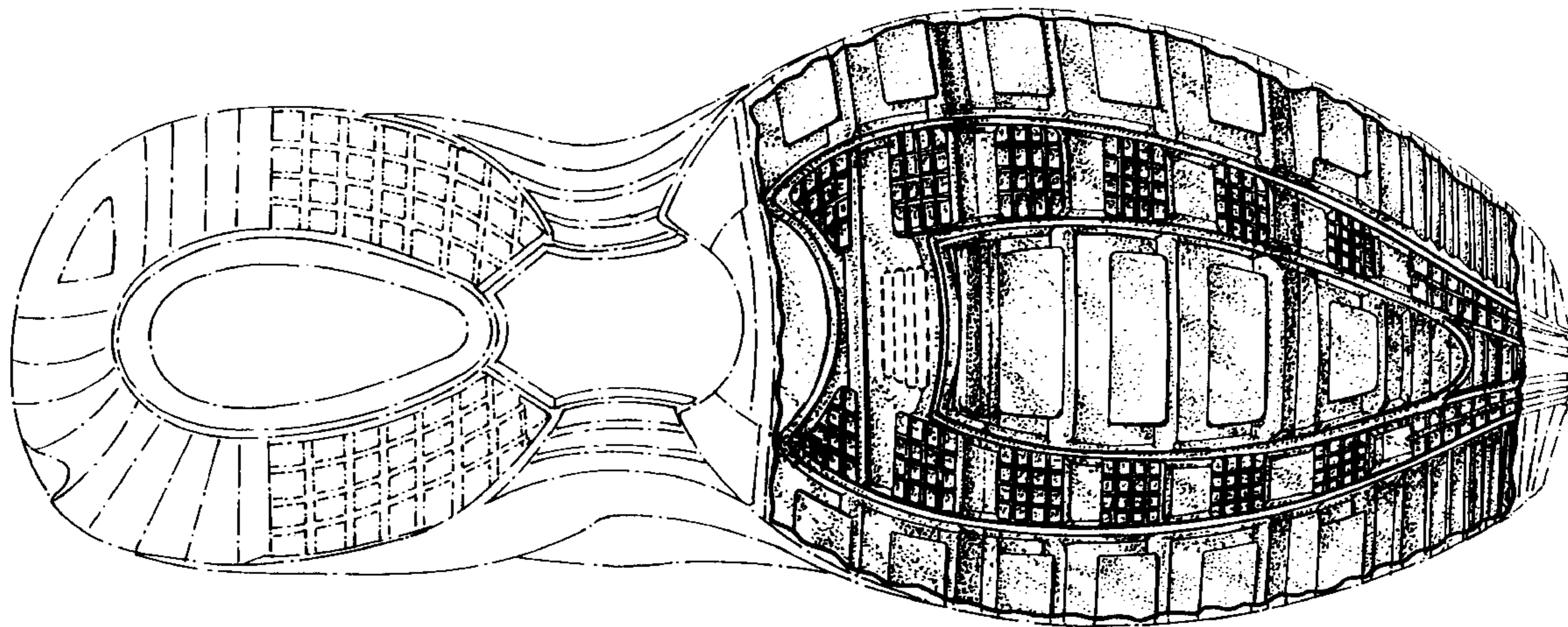
FIG. 1 is a plan view of a portion of a shoe outsole showing my new design;

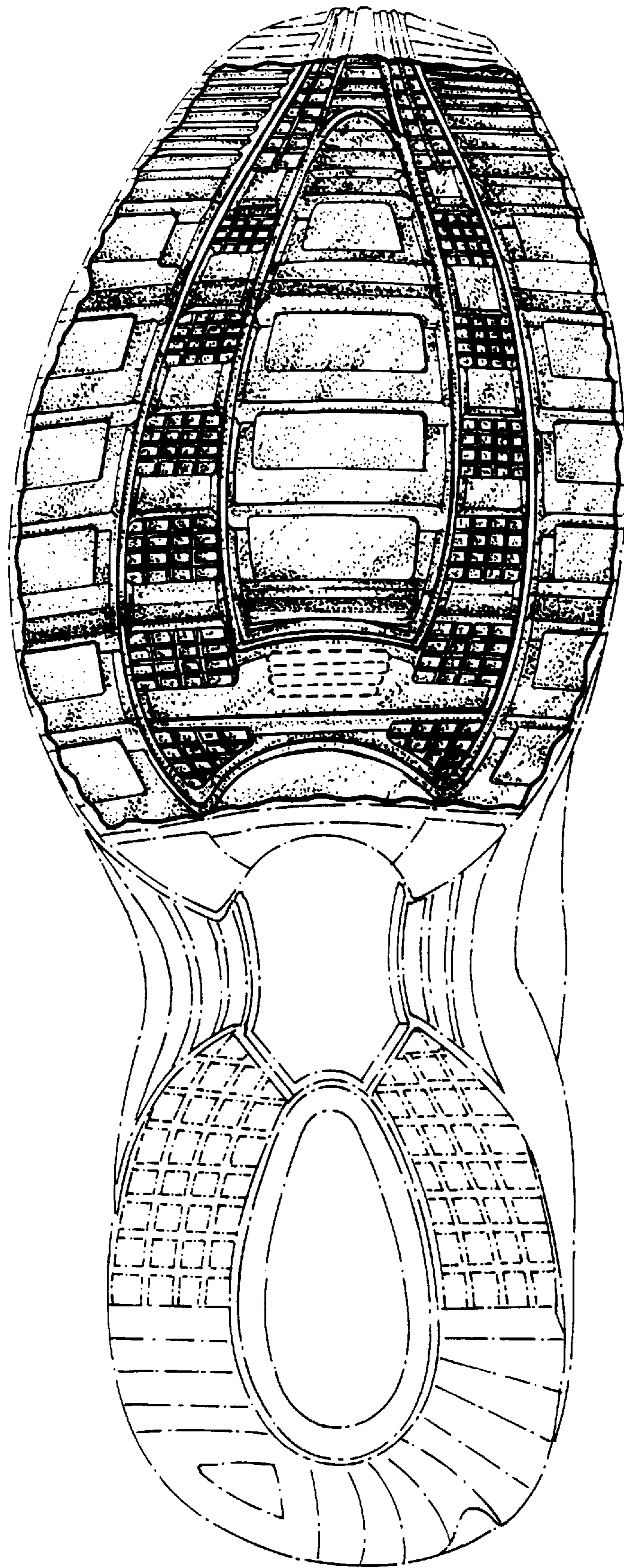

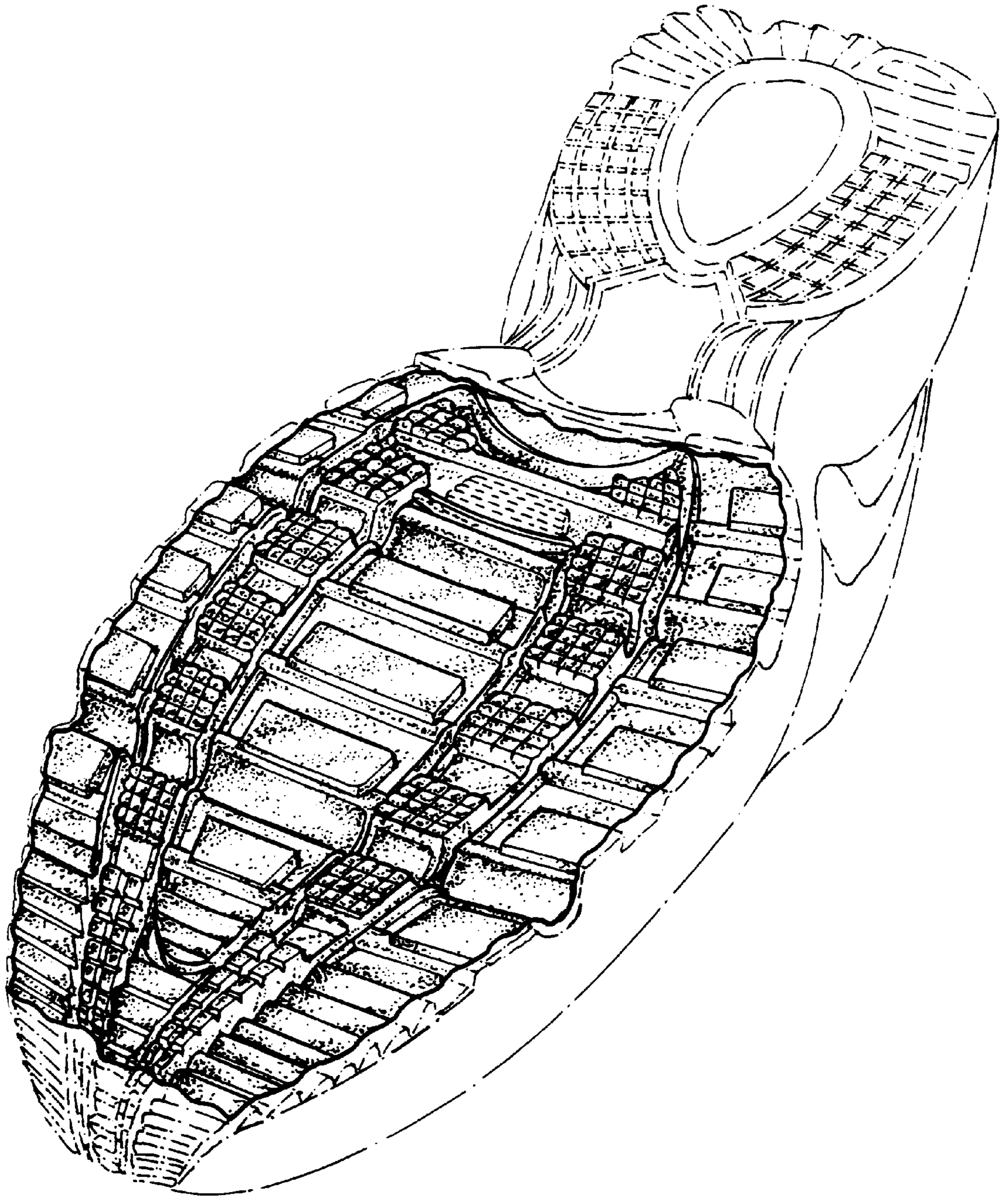

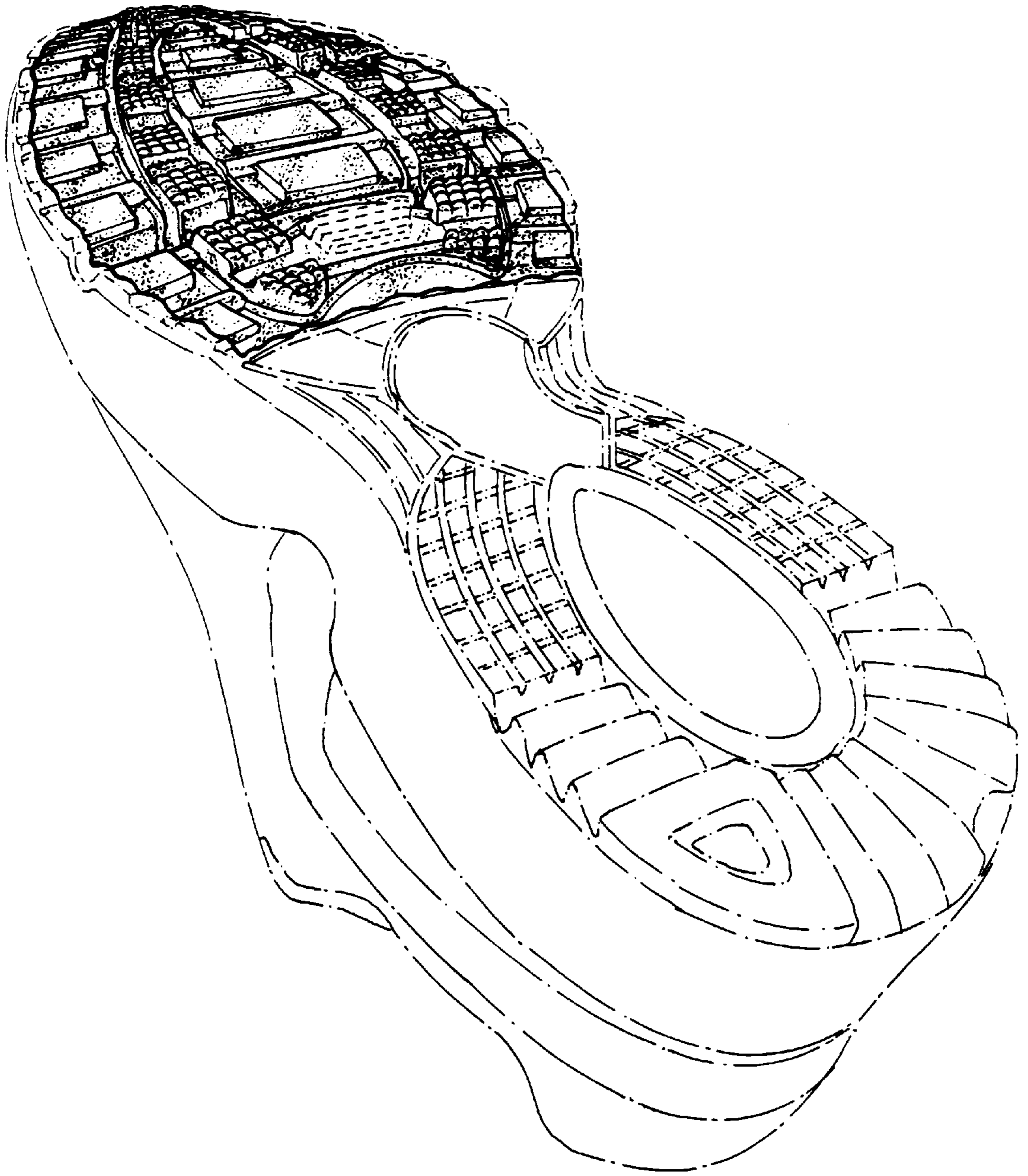

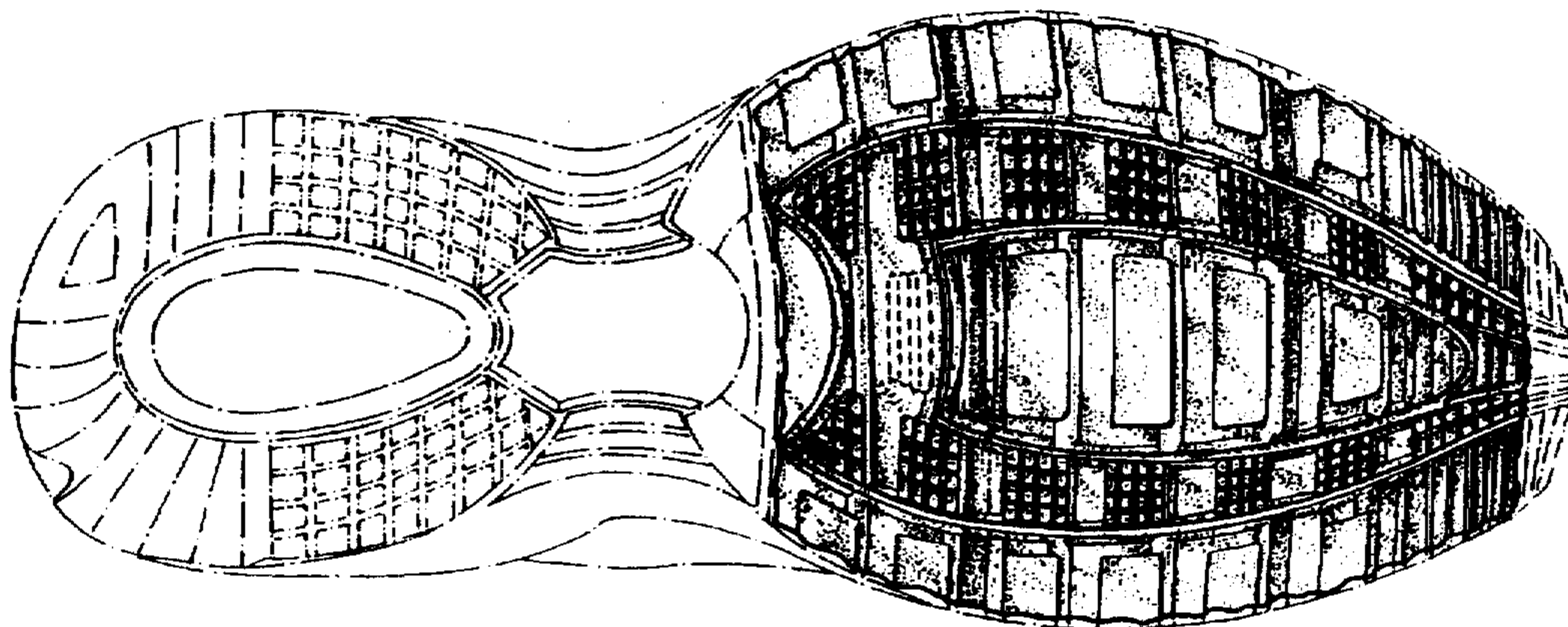

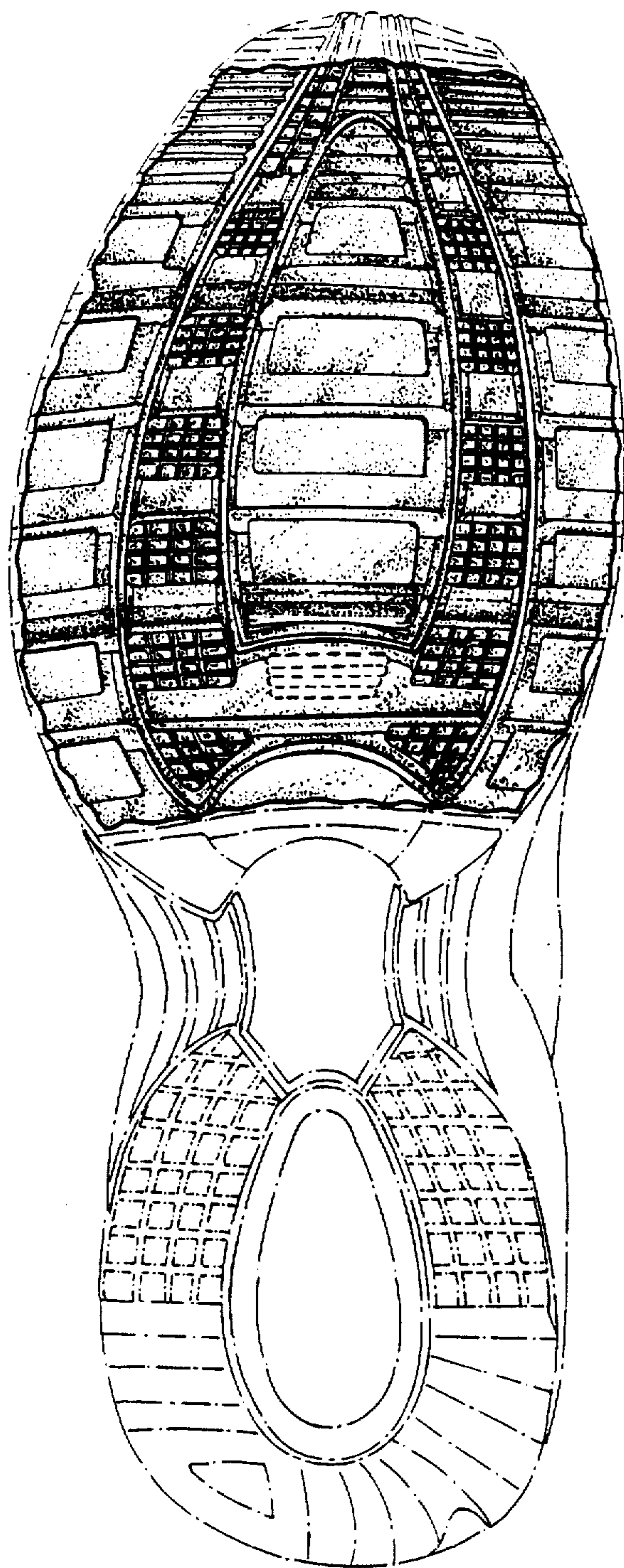

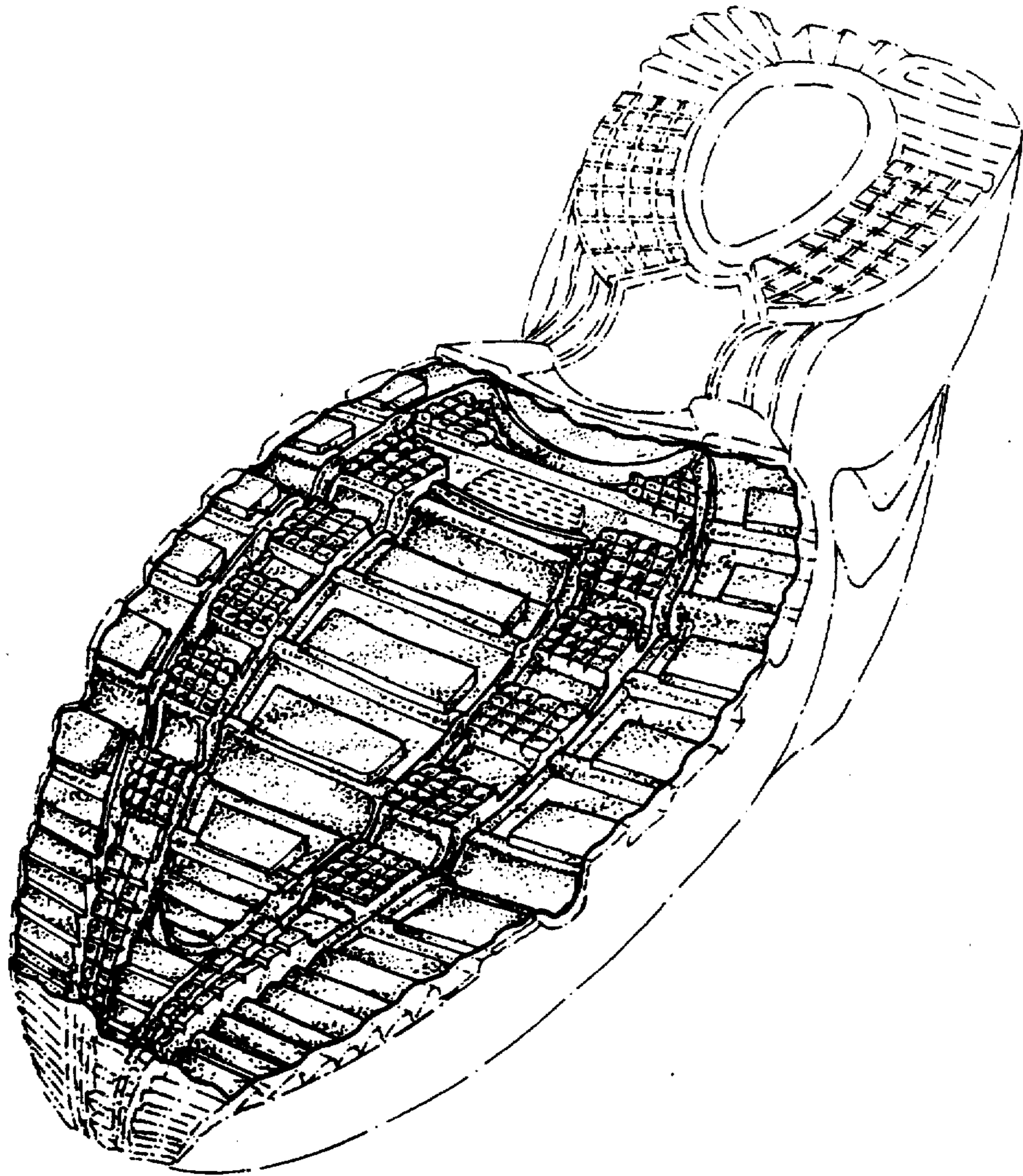
