The ornamental design for a CD cabinet, as shown and described.

### DESCRIPTION

FIG. 1 is a perspective front view of a CD cabinet showing the new design, in a closed position;  
FIG. 2 is a perspective rear view thereof;  
FIG. 3 is a perspective front view of the CD cabinet in an open position; and,  
FIG. 4 is a perspective rear view thereof.

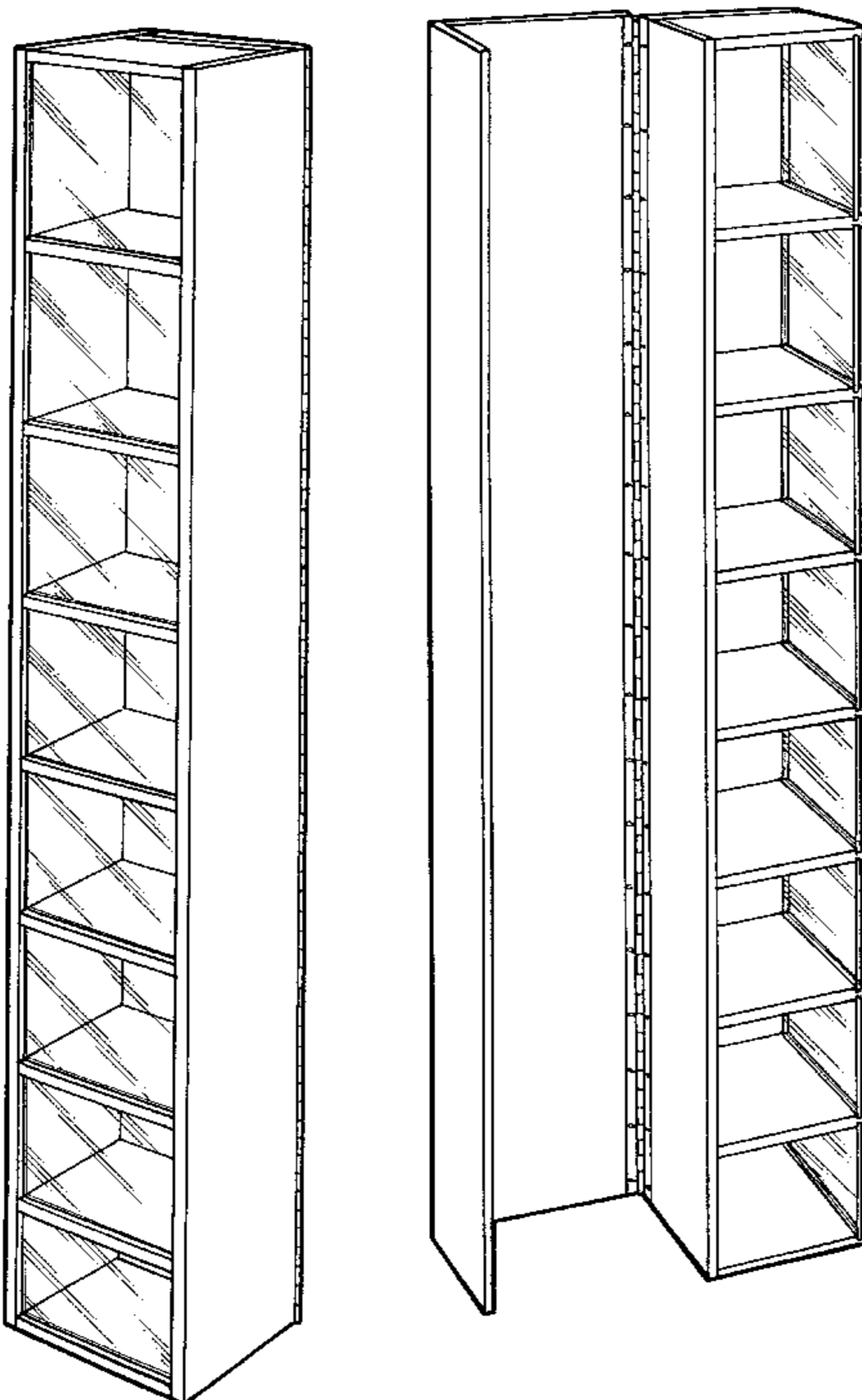

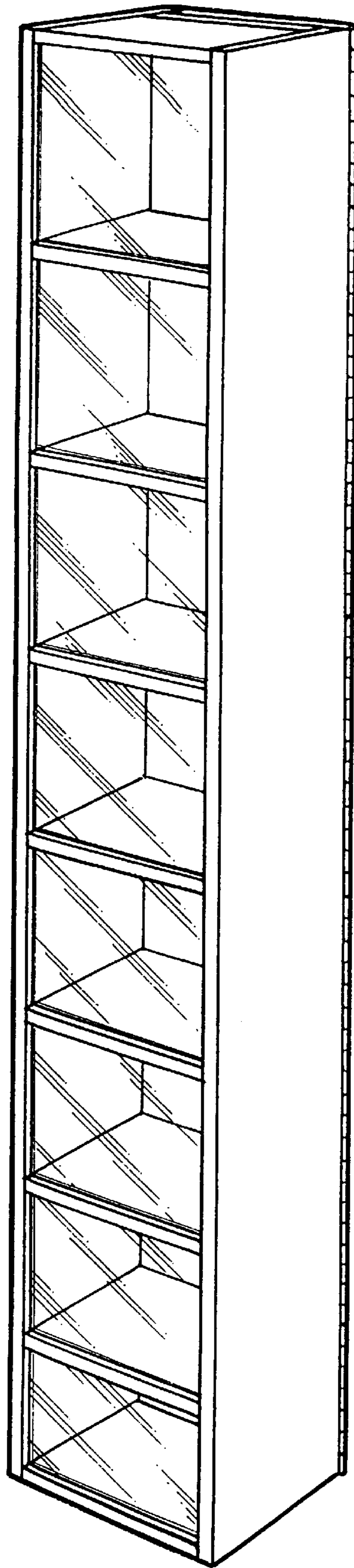

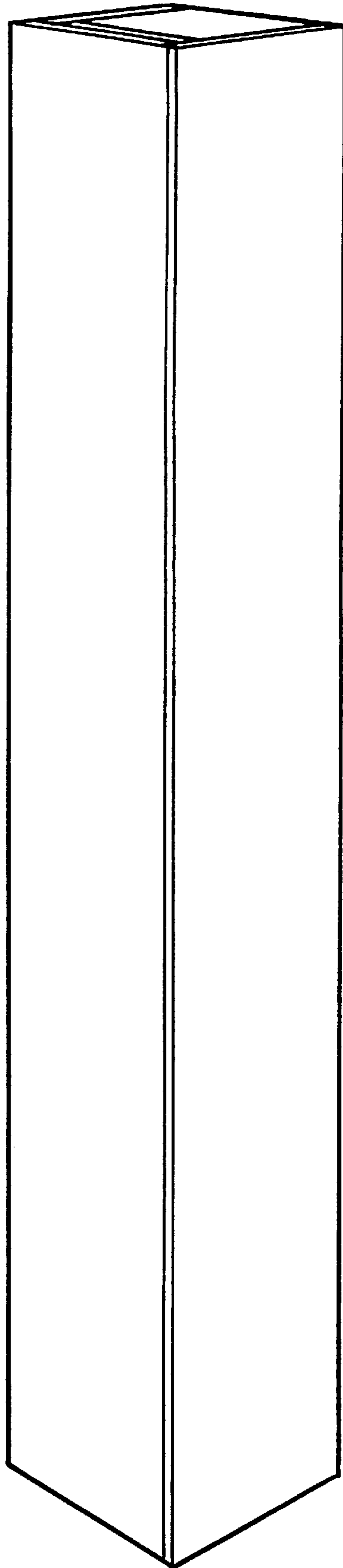

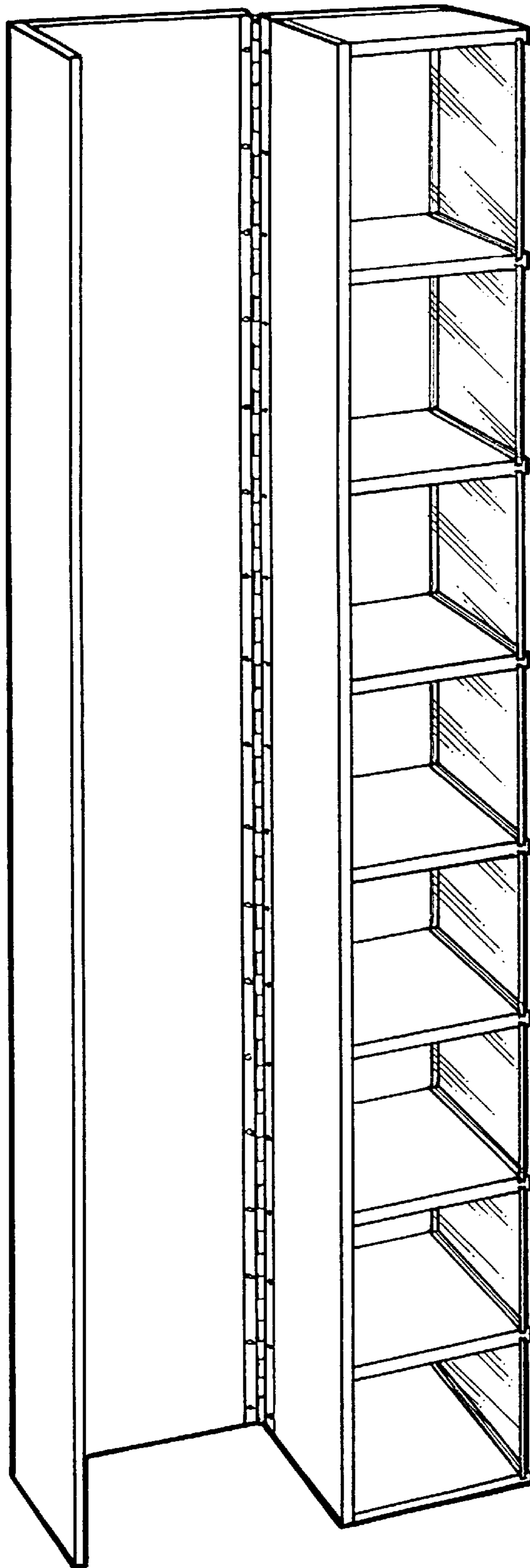
