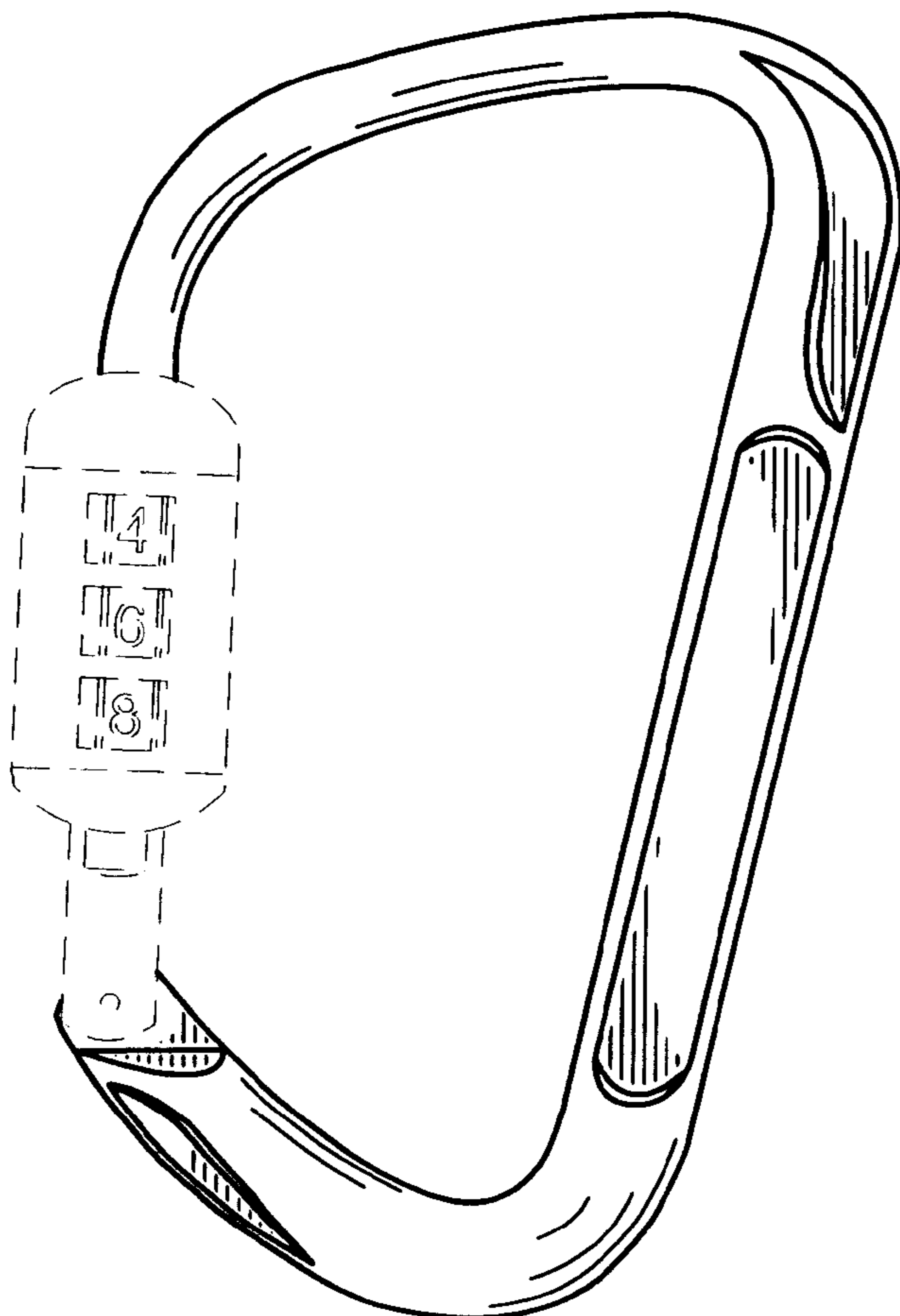
### [57] CLAIM

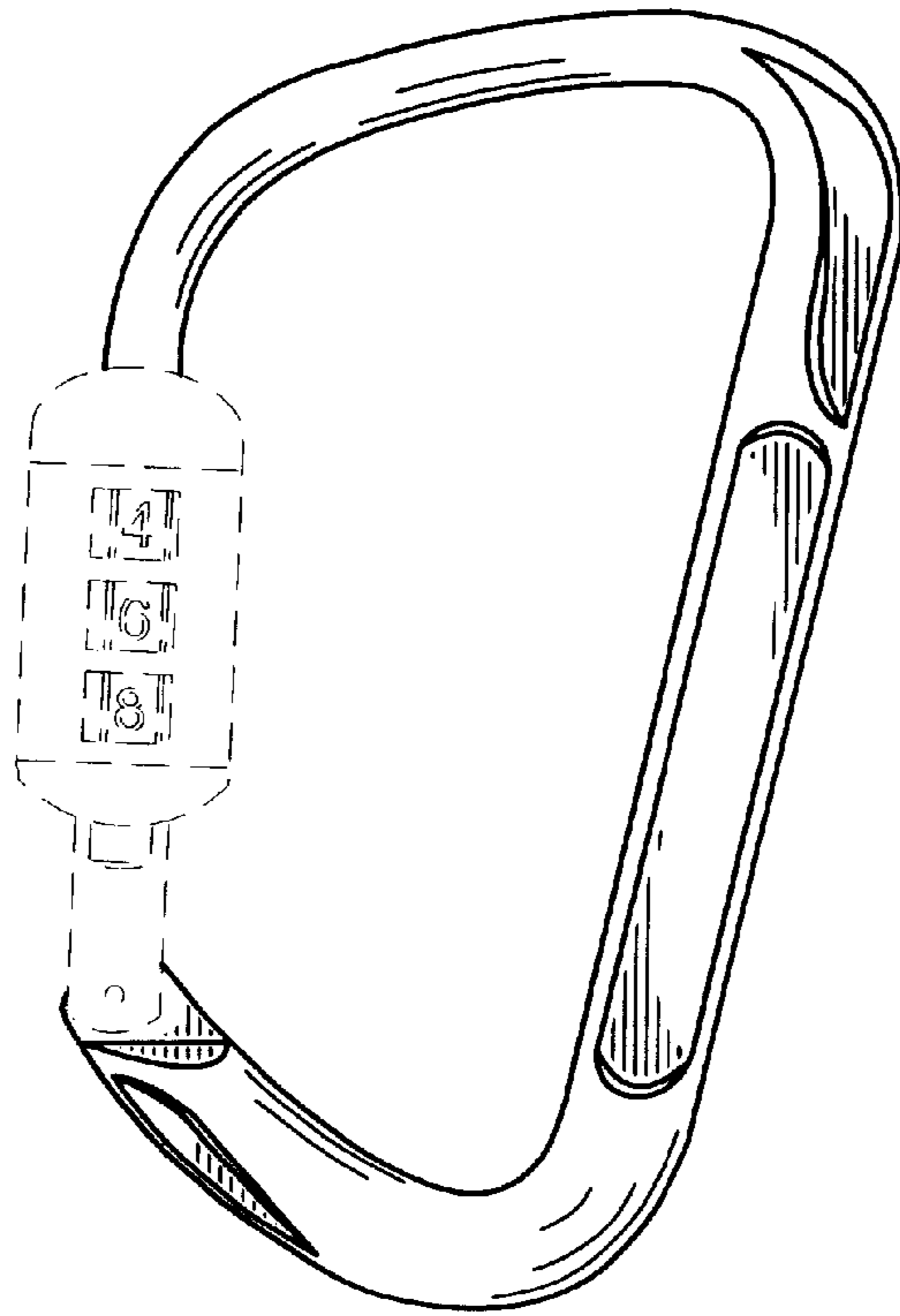
The ornamental design for a shackle for a padlock, as shown and described.

### DESCRIPTION

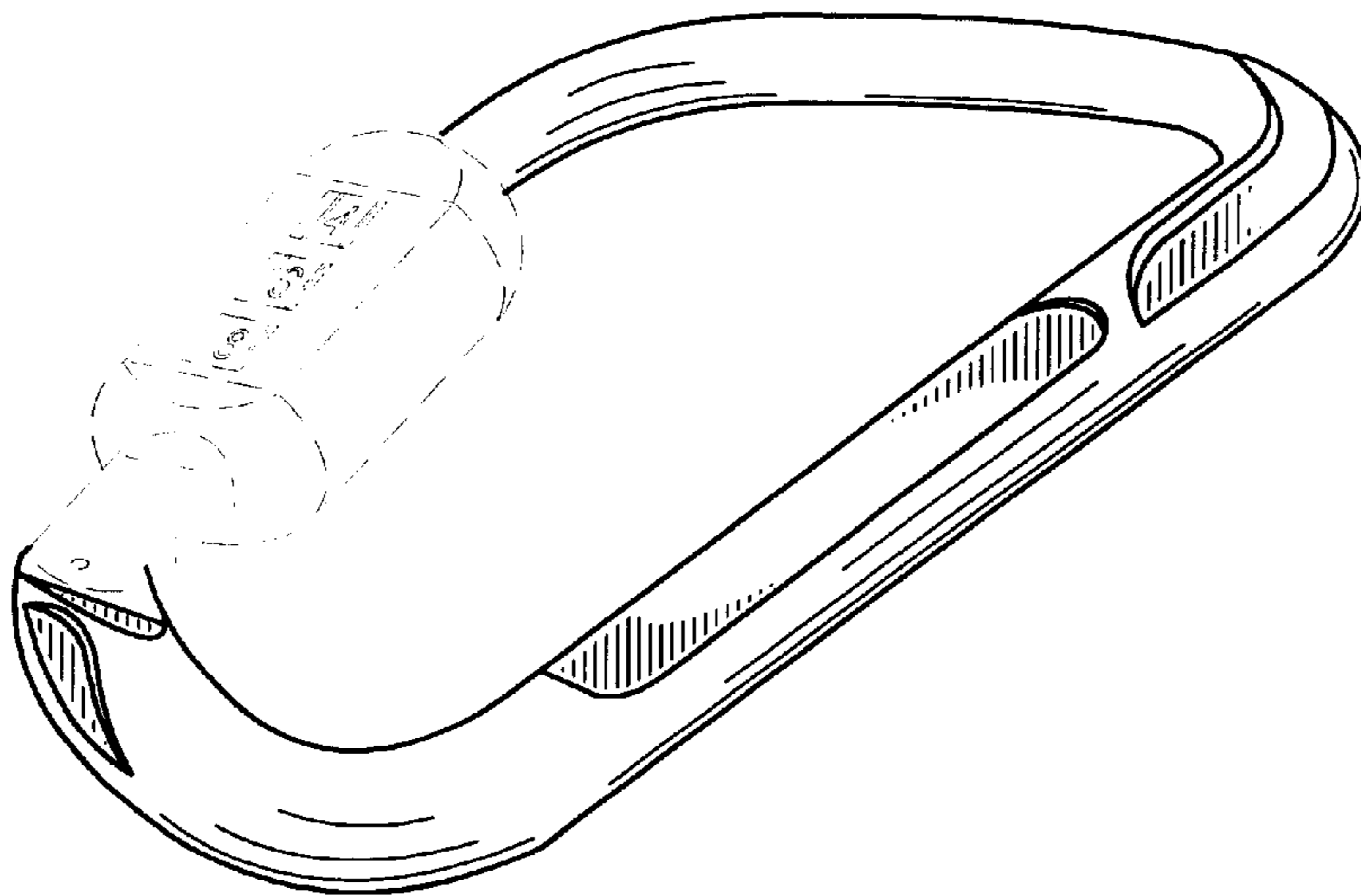
FIG. 1 is a top plan view of a shackle for a padlock; the bottom plan view being a mirror image thereof.  
 FIG. 2 is a front perspective view of the shackle of FIG. 1.

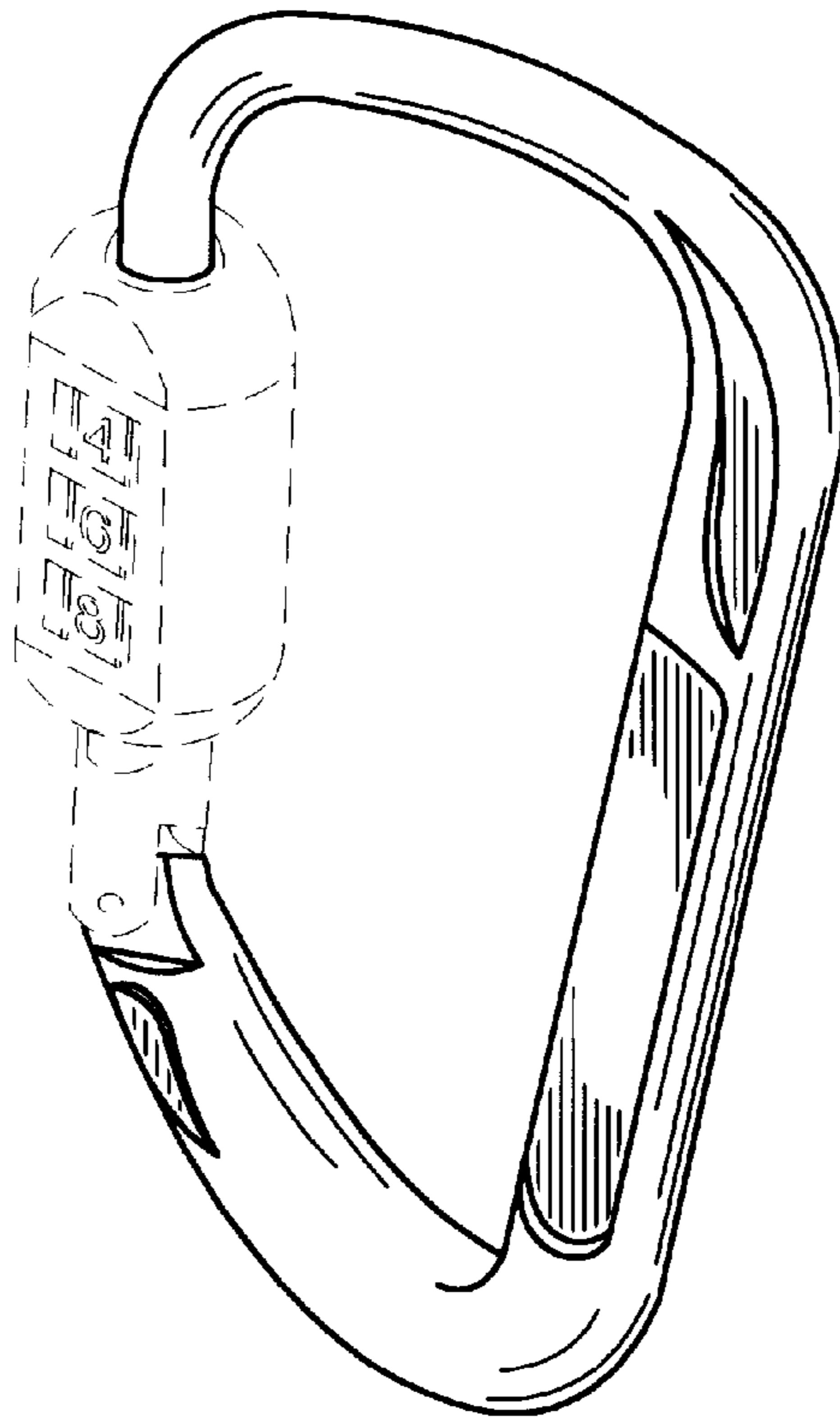




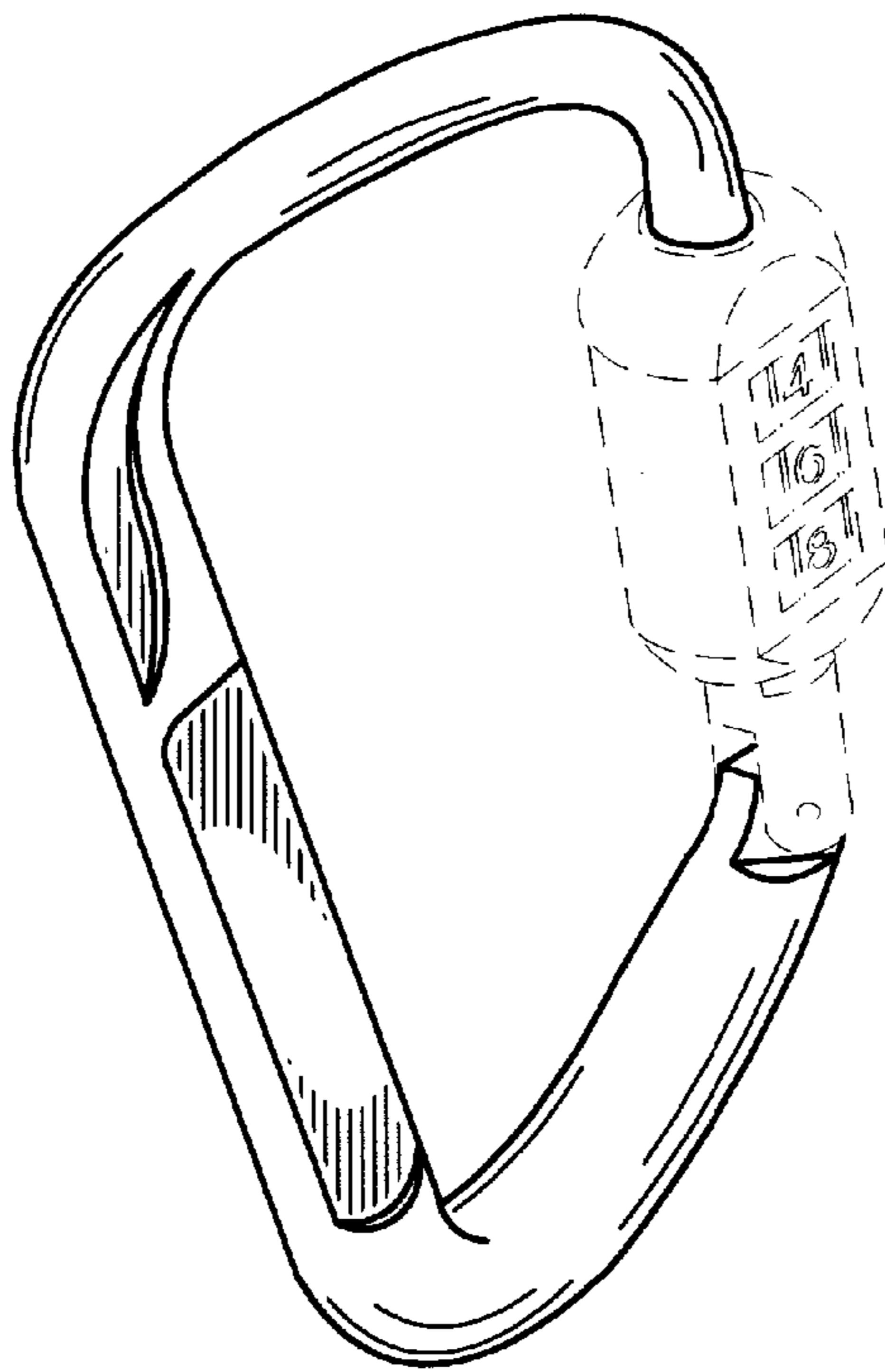
