DESCRIPTION

FIG. 1 is a front perspective view of a computer mouse showing our new design;

FIG. 2 is a front elevational view thereof;

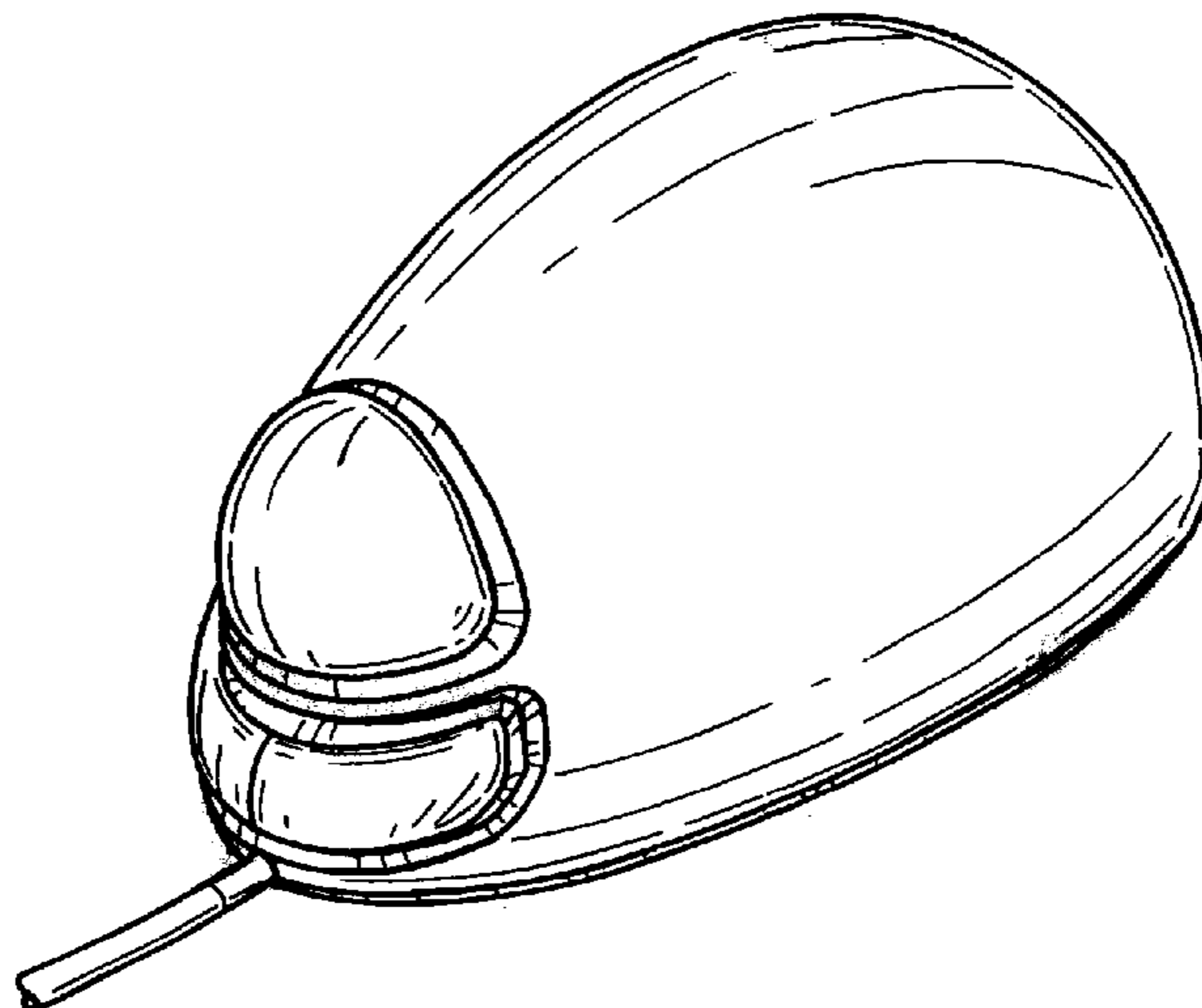
FIG. 3 is a rear elevational view thereof;

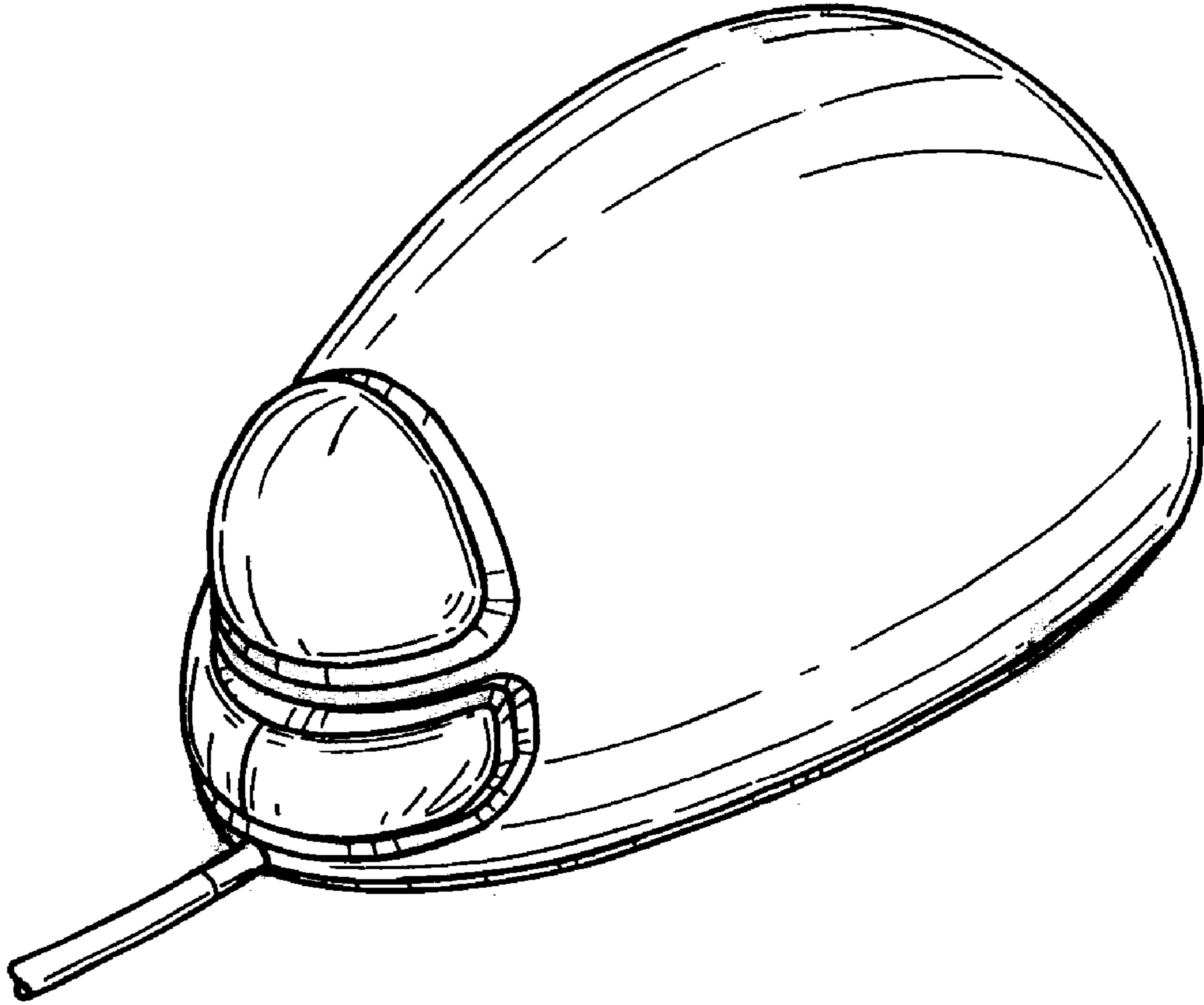

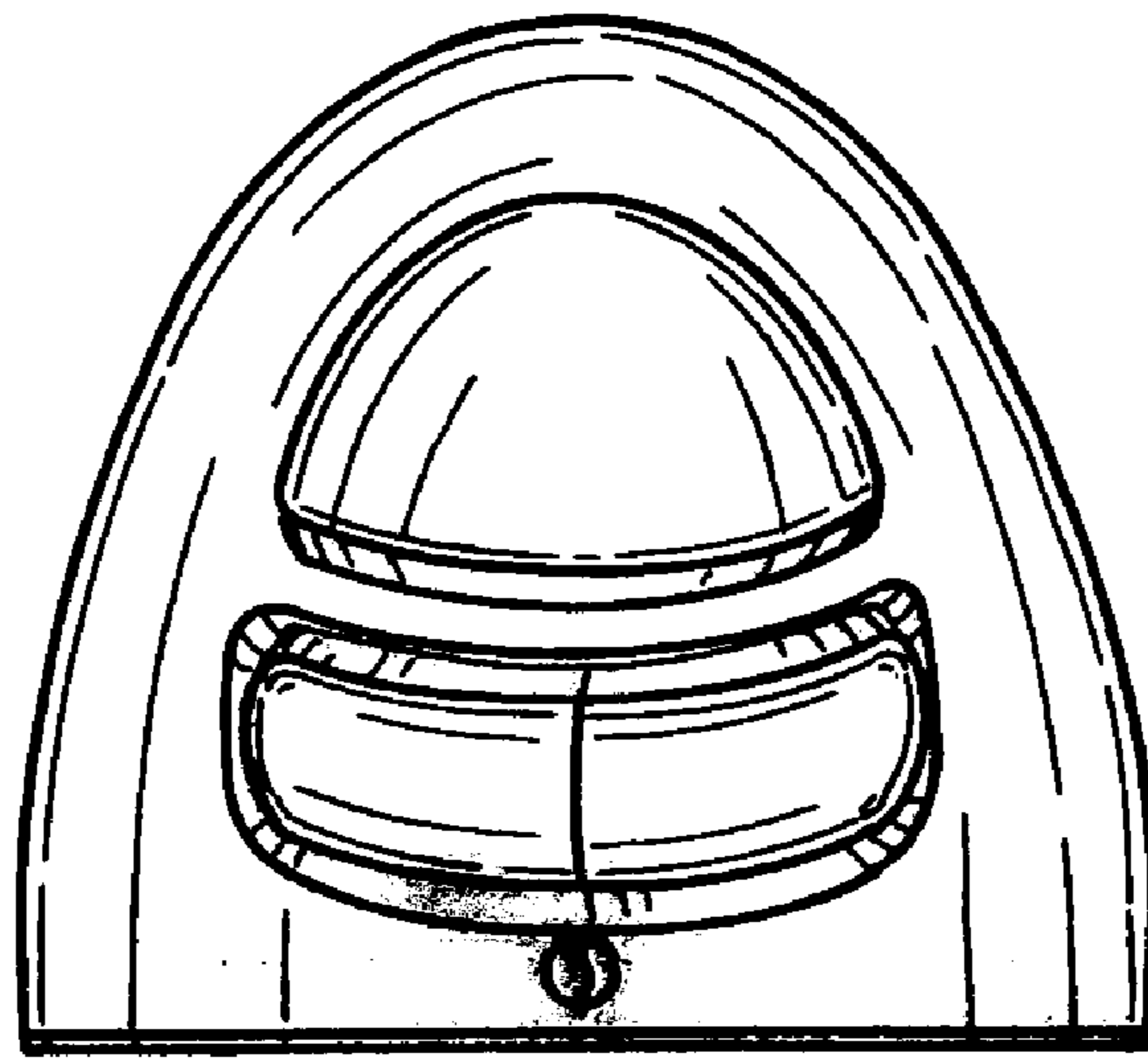

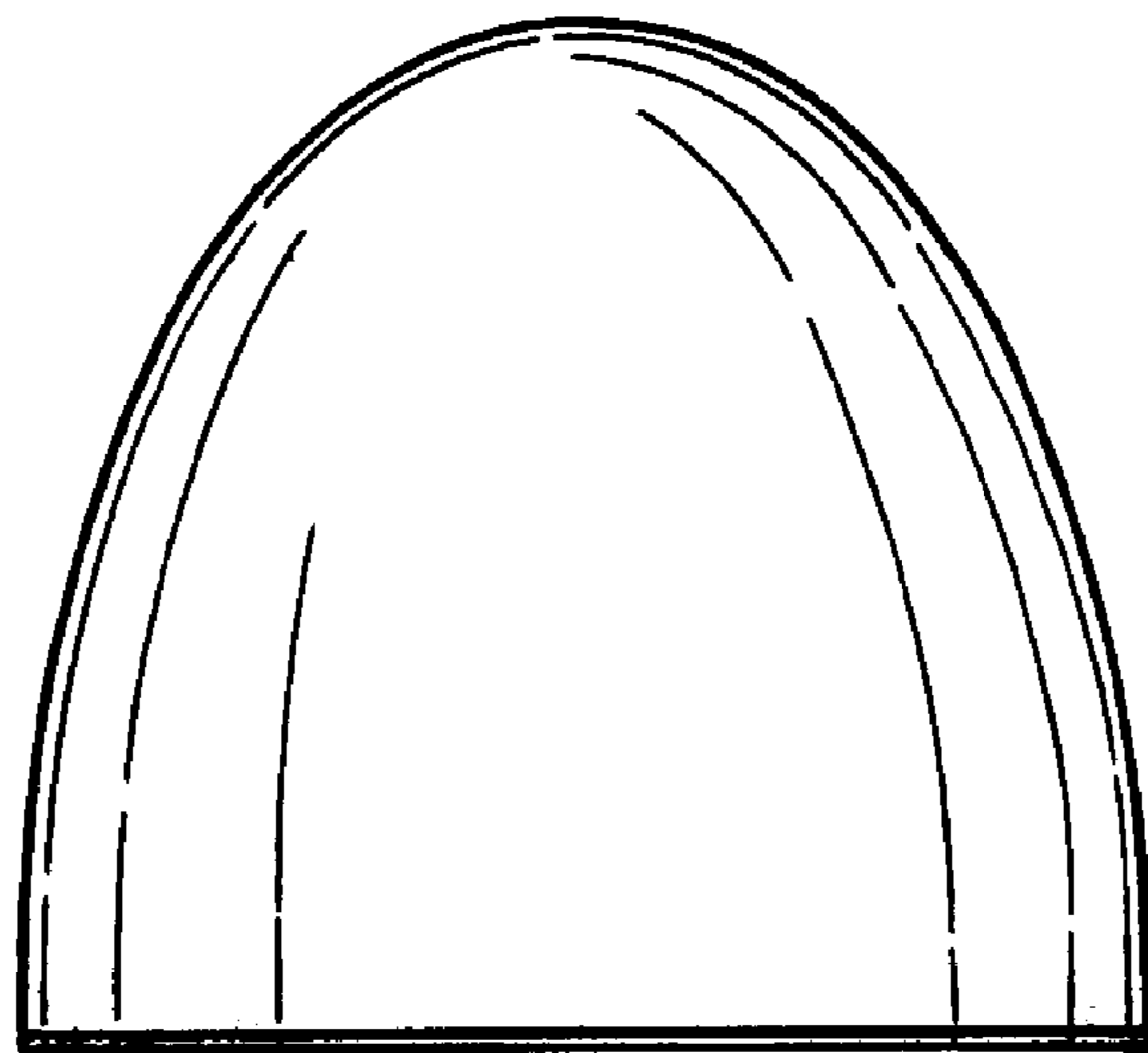

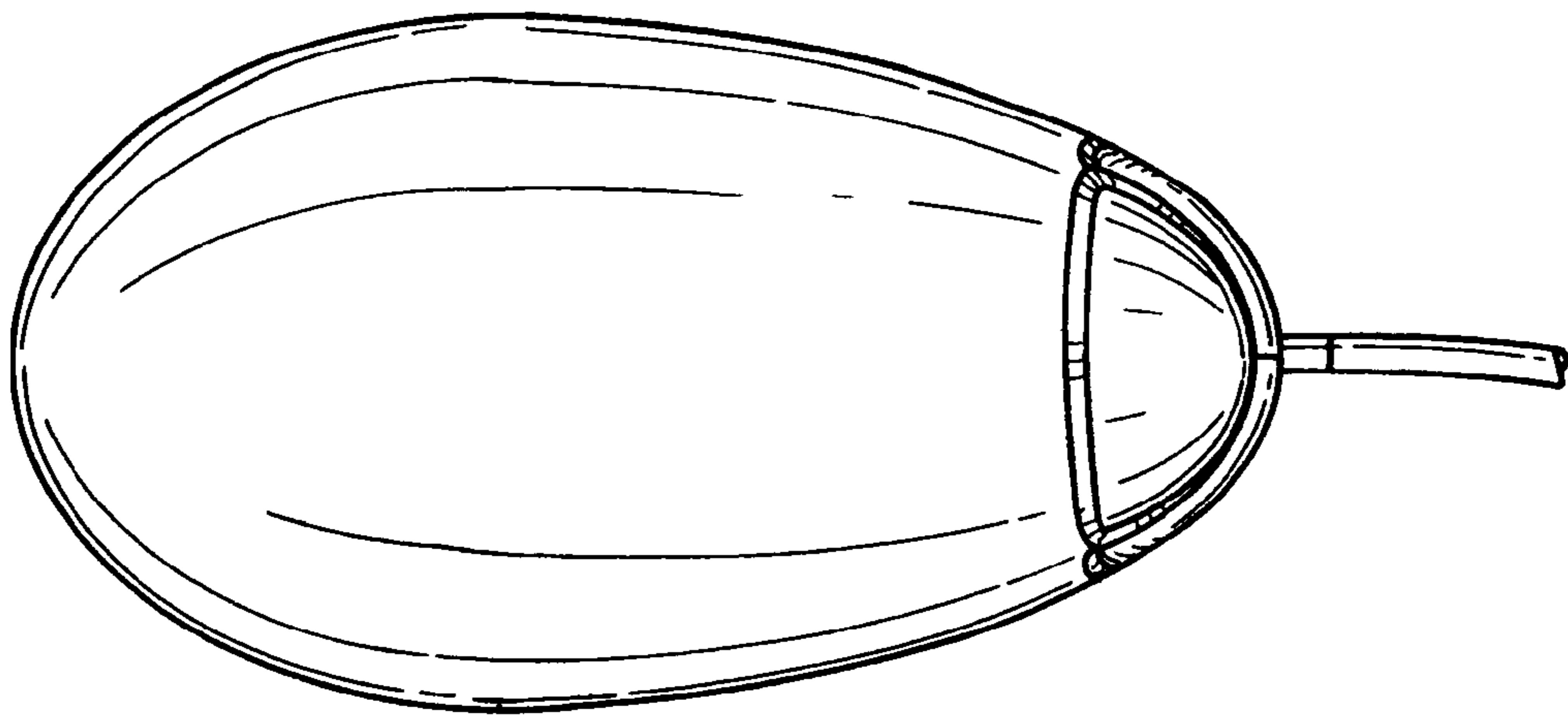

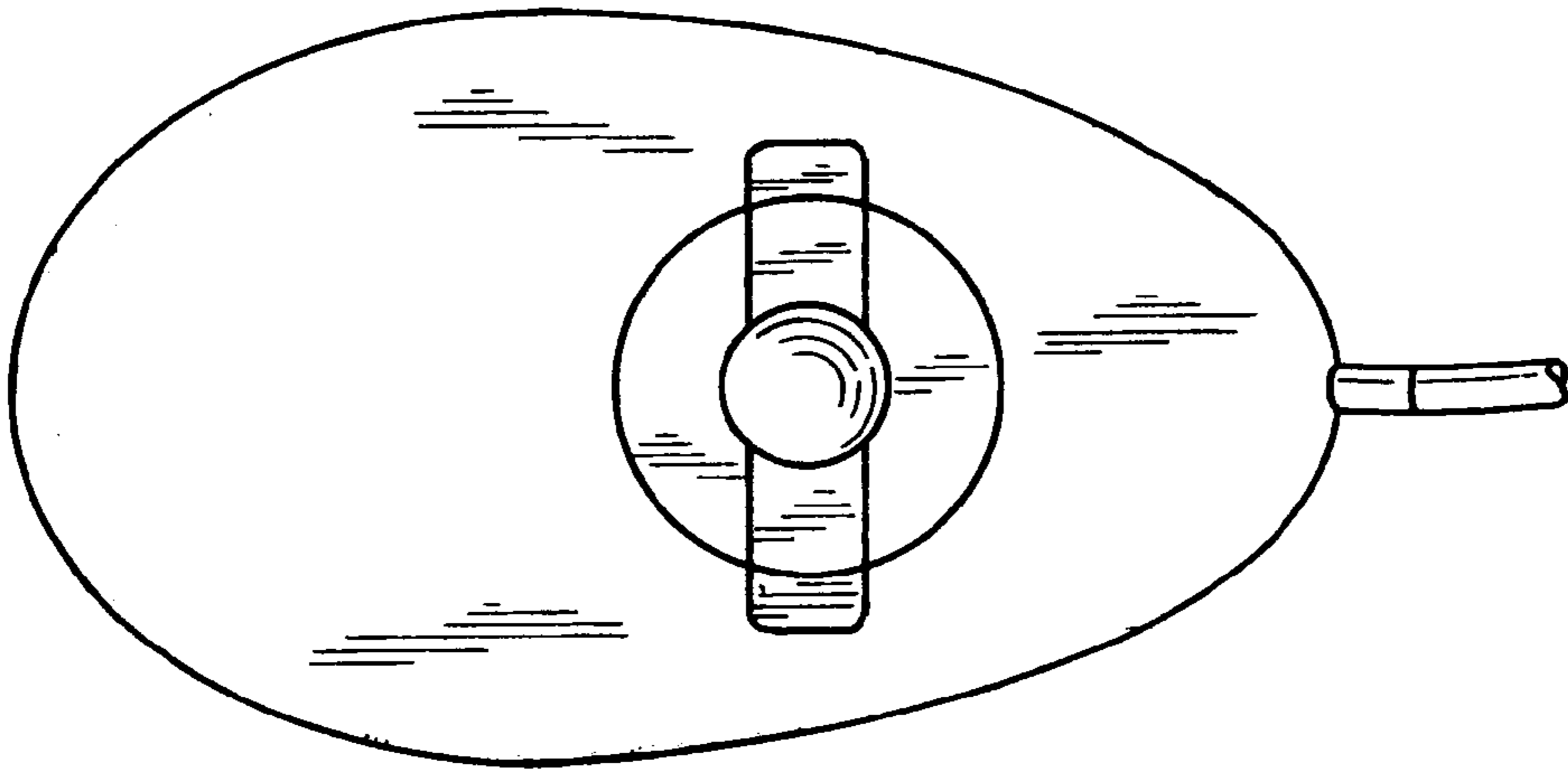

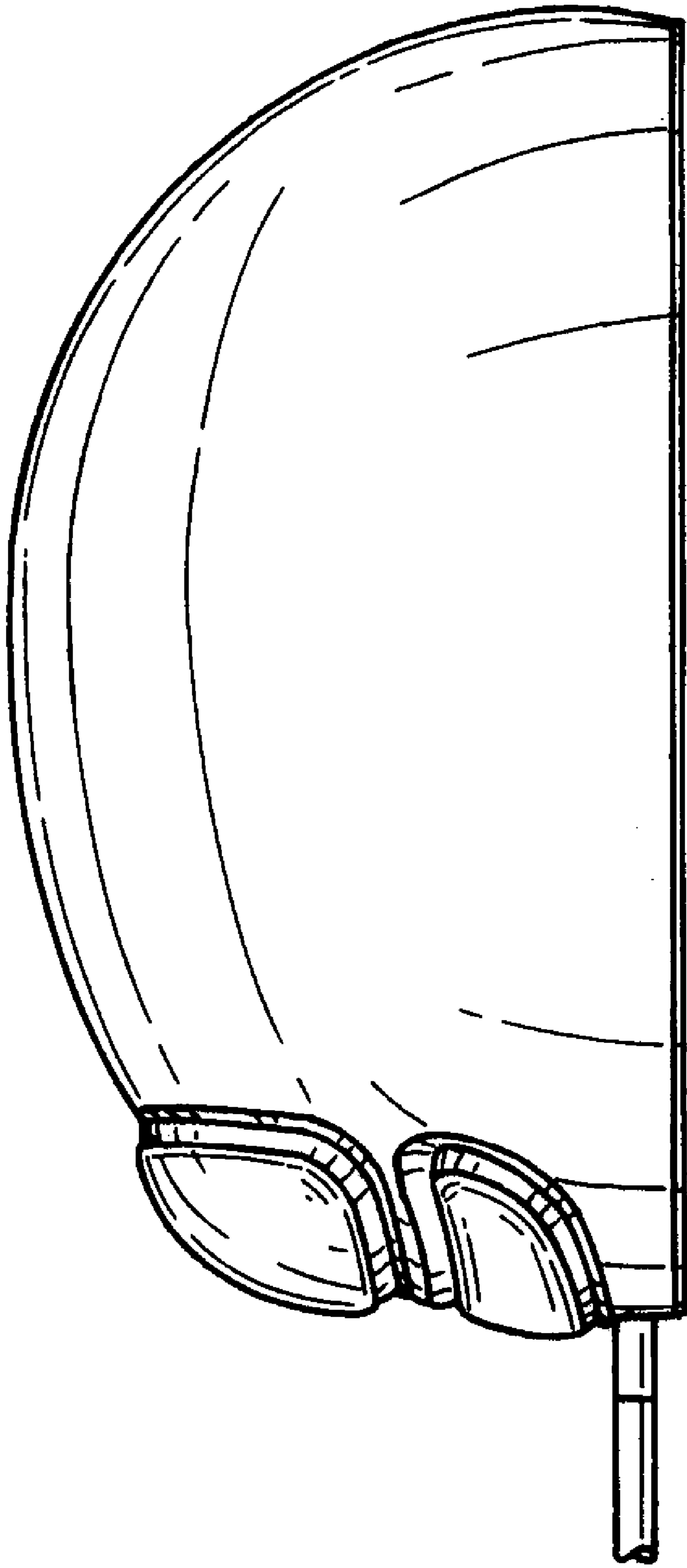
