[57] CLAIM

The ornamental design for a medical identification system device, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a medical identification system device, showing my new design. The broken lines around the perimeter of the claimed design of this embodiment are for illustrative purposes only and form no part of this embodiment.

FIG. 2 is a front view of the first embodiment.

FIG. 3 is a side view of the first embodiment, the side view having rotational symmetry.

FIG. 4 is rear view of the first embodiment.

FIG. 5 is a perspective view of a second embodiment showing my new design.

FIG. 6 is a front view corresponding to the second embodiment.


FIG. 7 is a rear view corresponding to the second embodiment.

FIG. 8 is a right side elevational view of the second embodiment, the left side elevational view being identical thereto; and,


FIG. 9 is a top view of the second embodiment, the bottom view being identical thereto.

The broken line showing in the center portion of FIGS. 1, 2, 5 and 6 is for illustrative purposes only and forms no part of my claimed design.








