[57] CLAIM

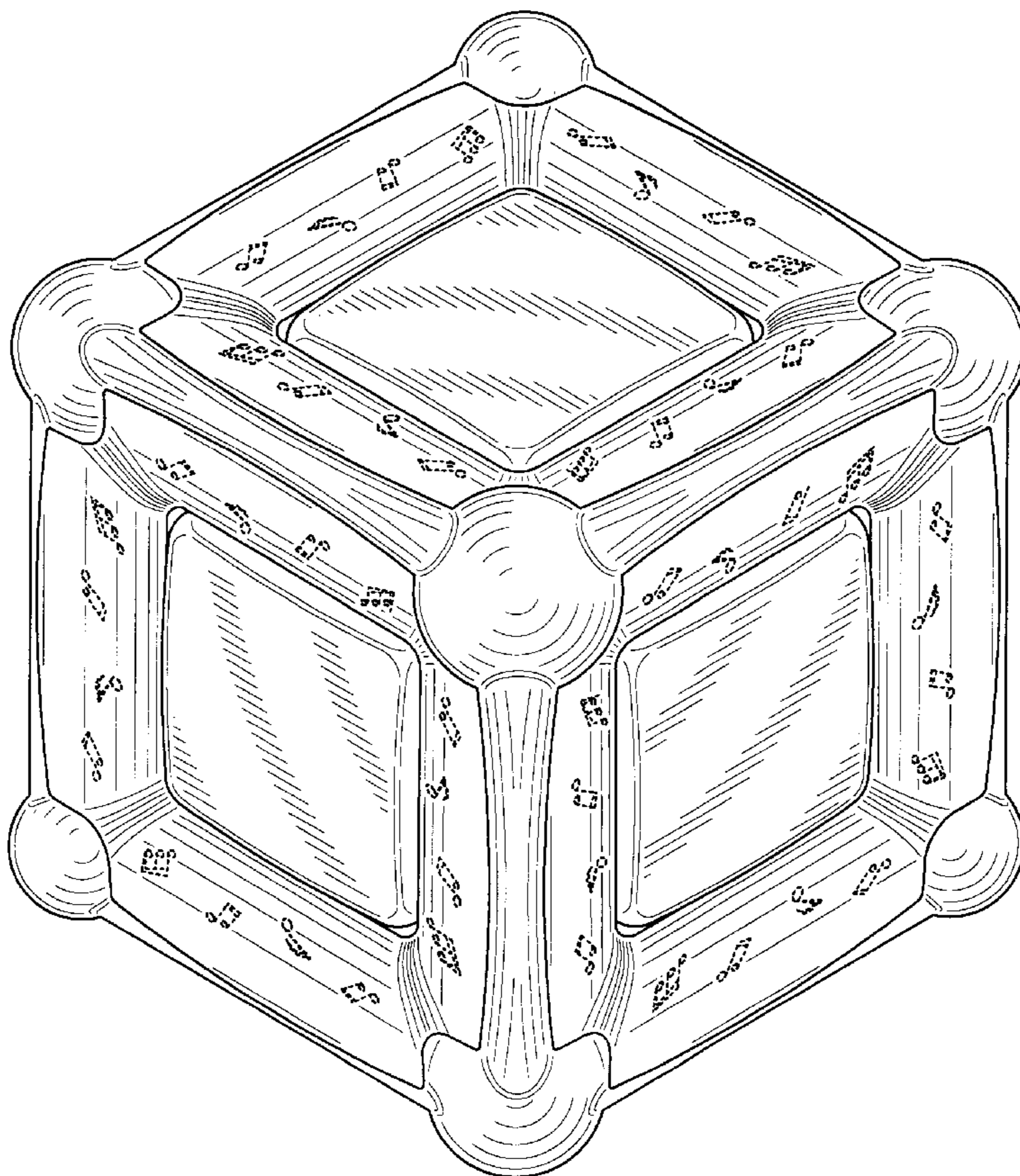
An ornamental design for a musical toy, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view showing our new design;
FIG. 2 is a top plan view;
FIG. 3 is a bottom plan view;

FIG. 6 is a front view; and,
FIG. 7 is a rear view.

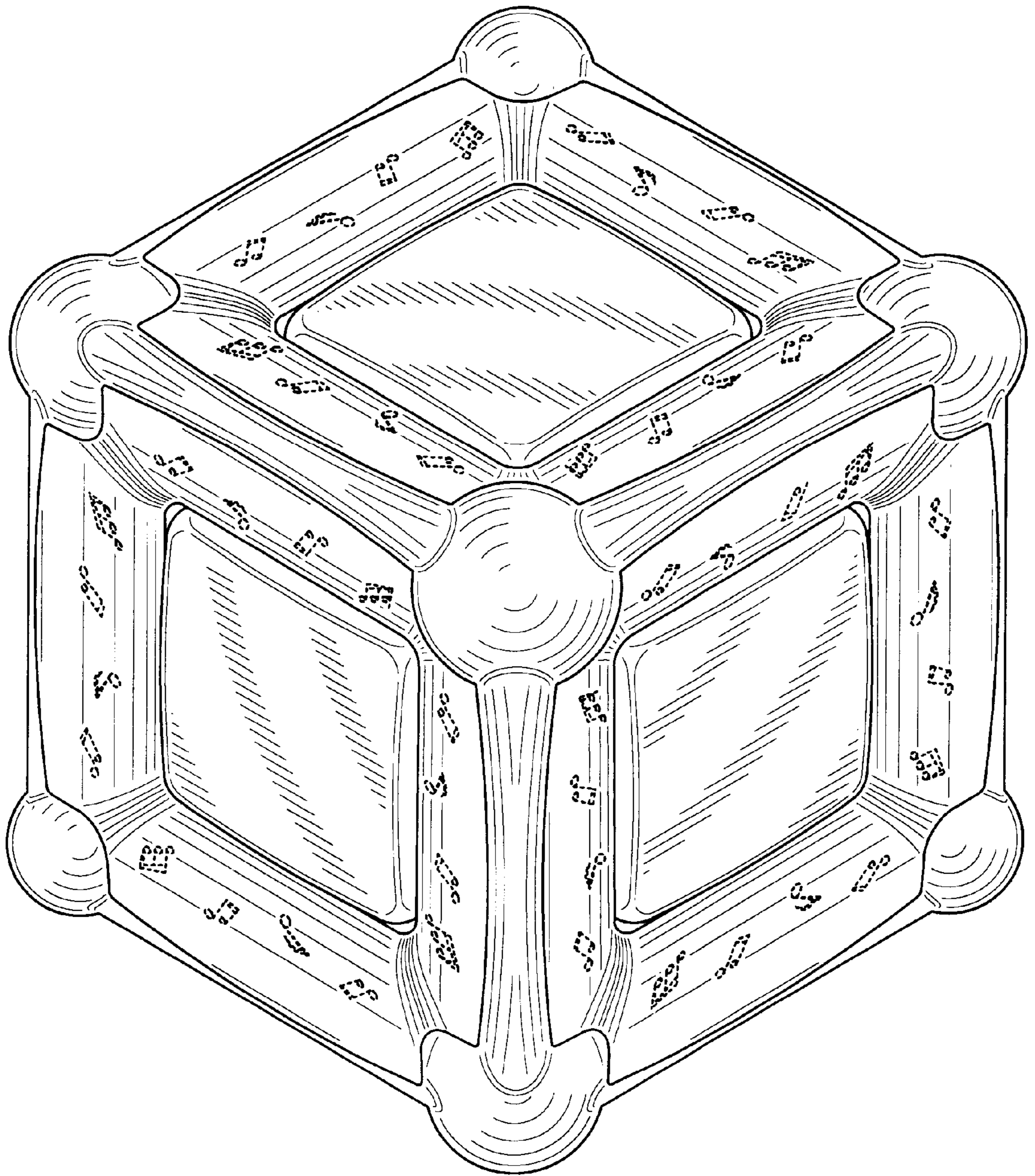

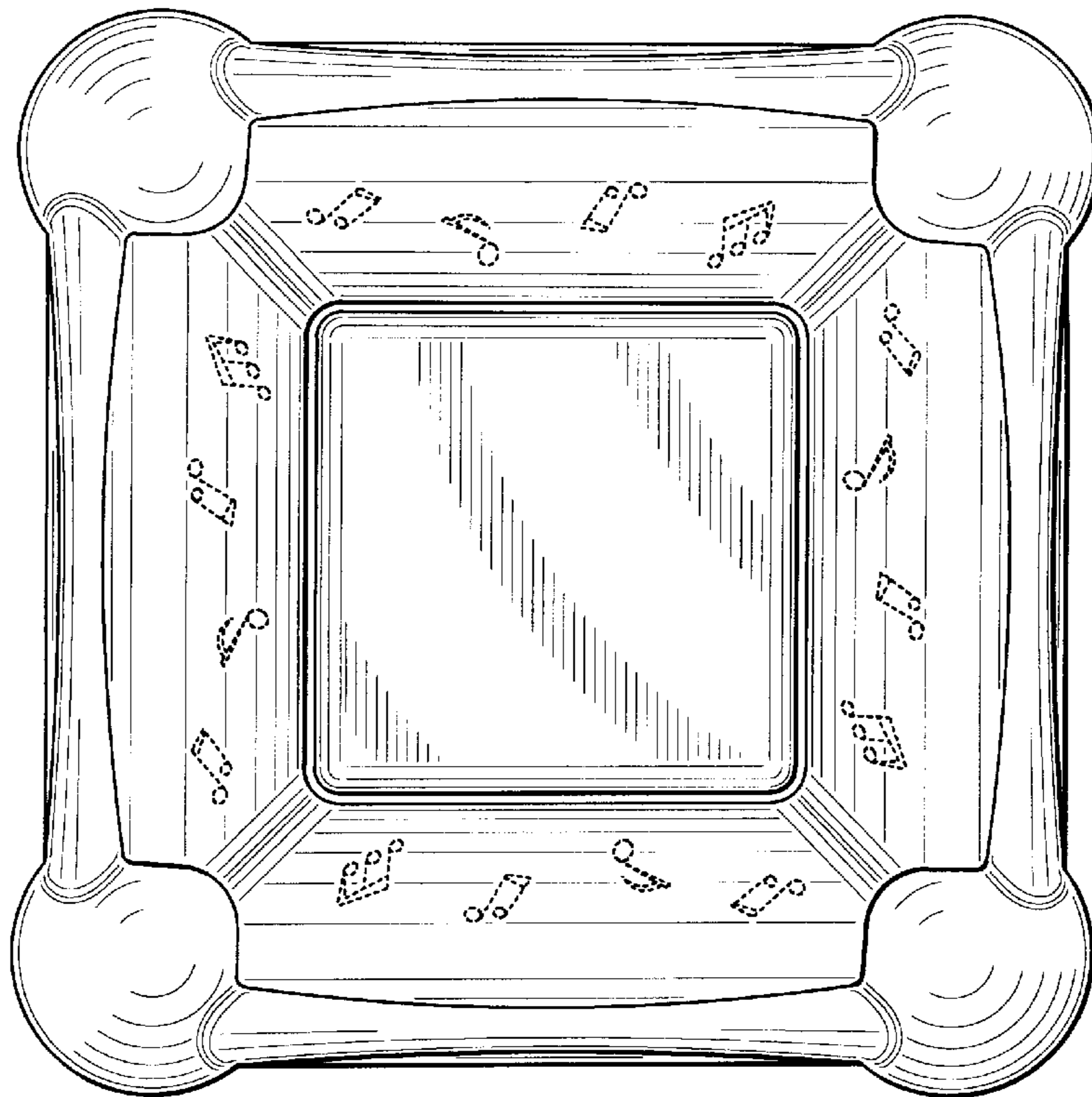

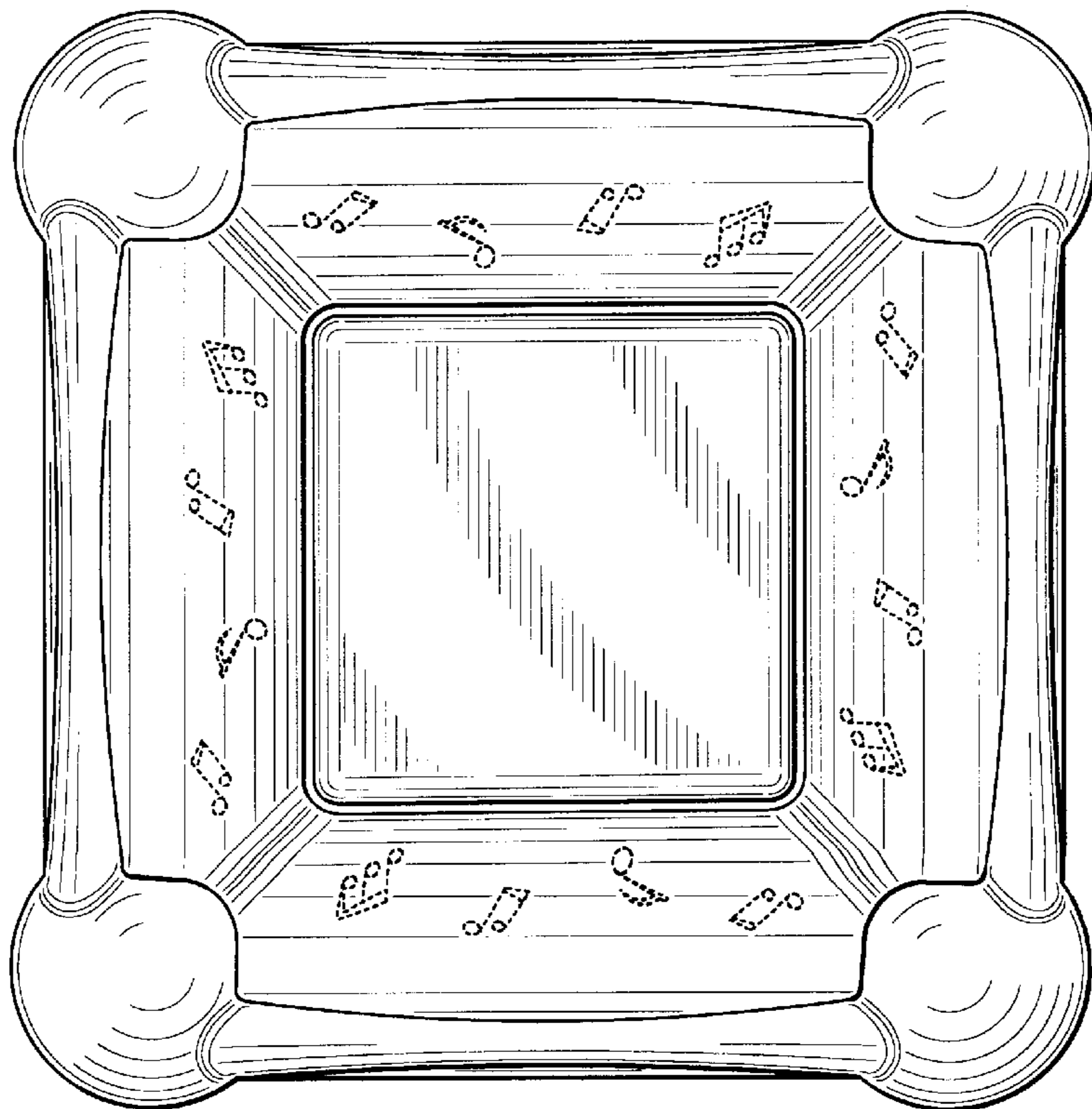

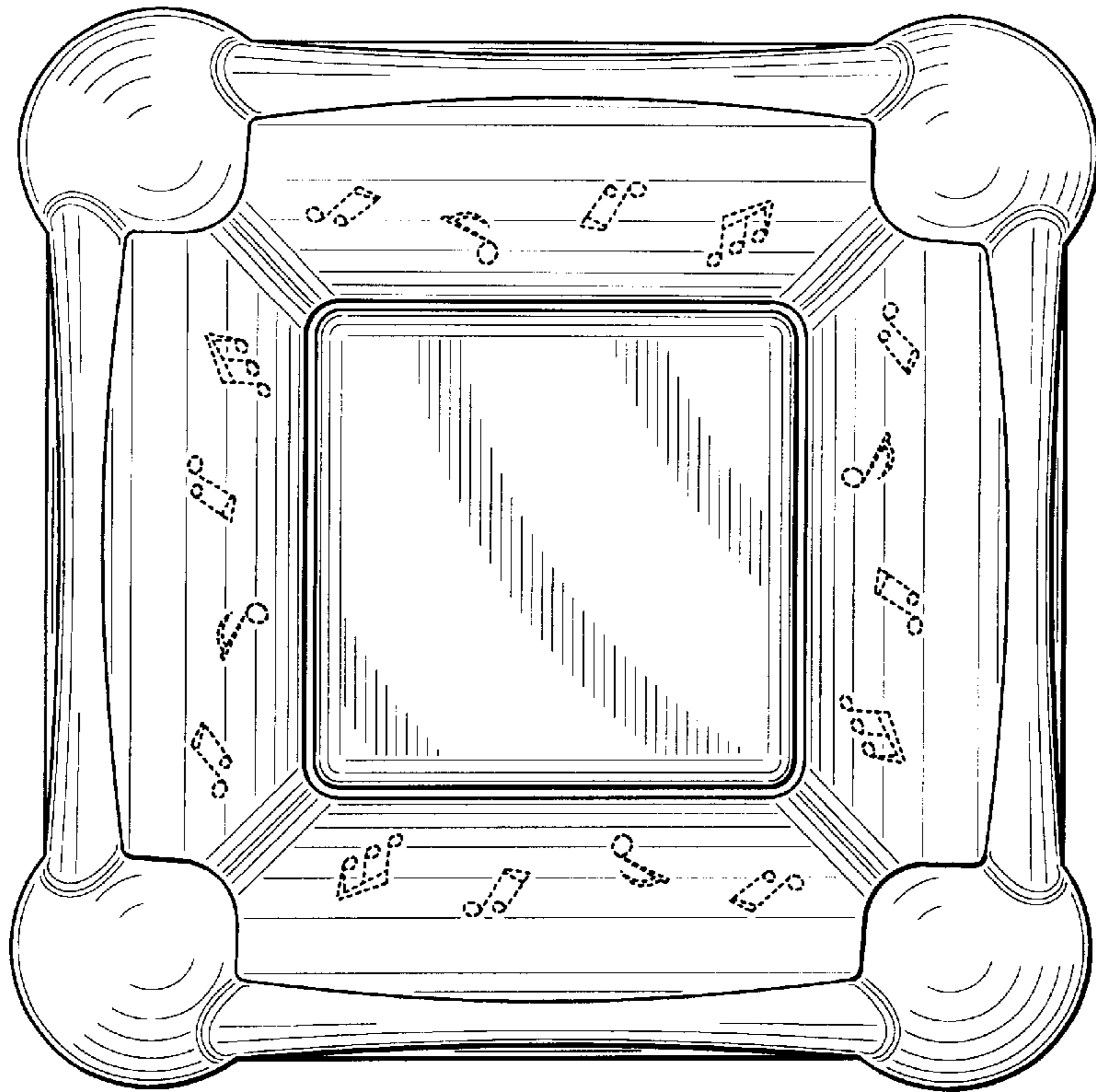

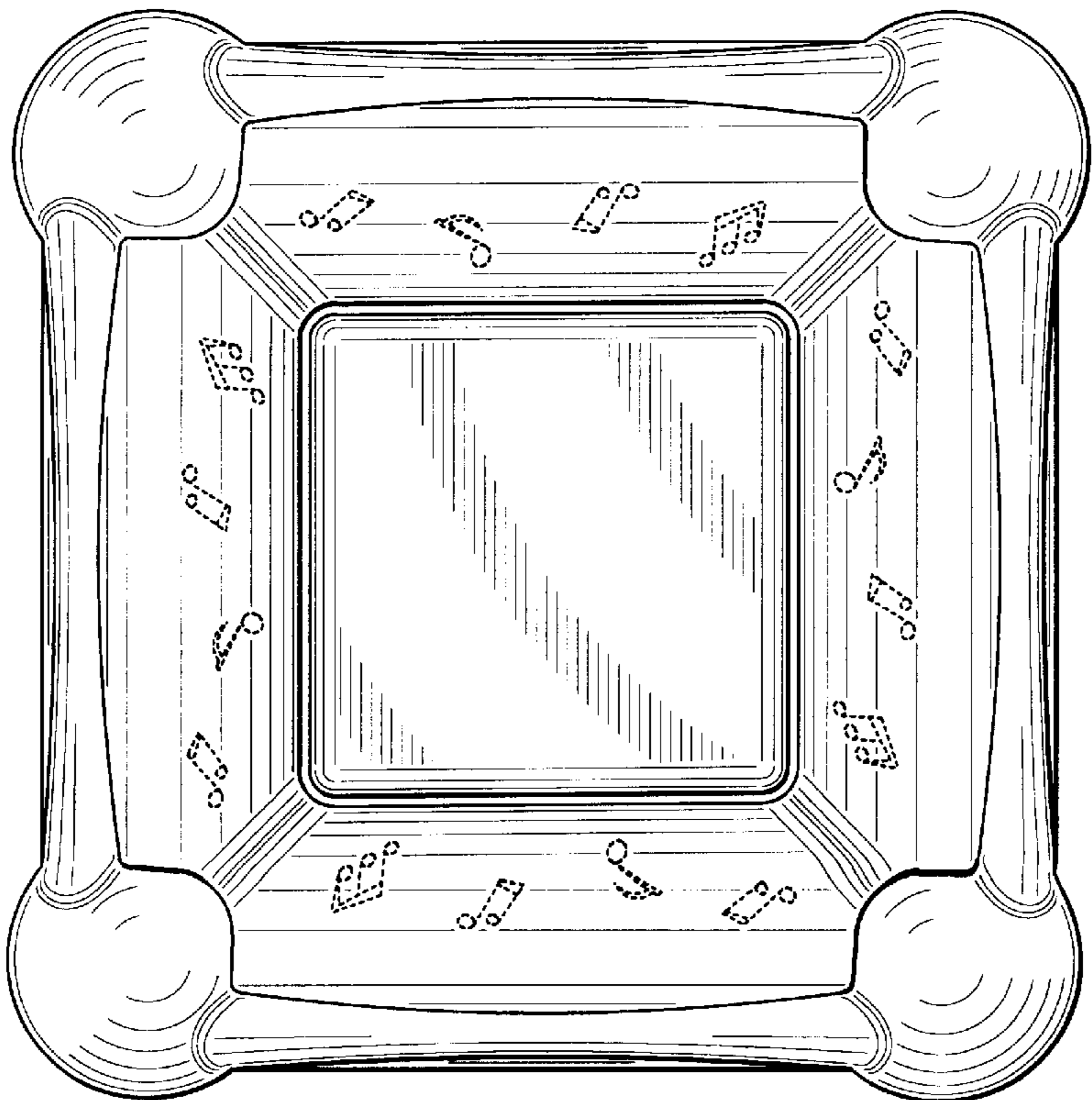

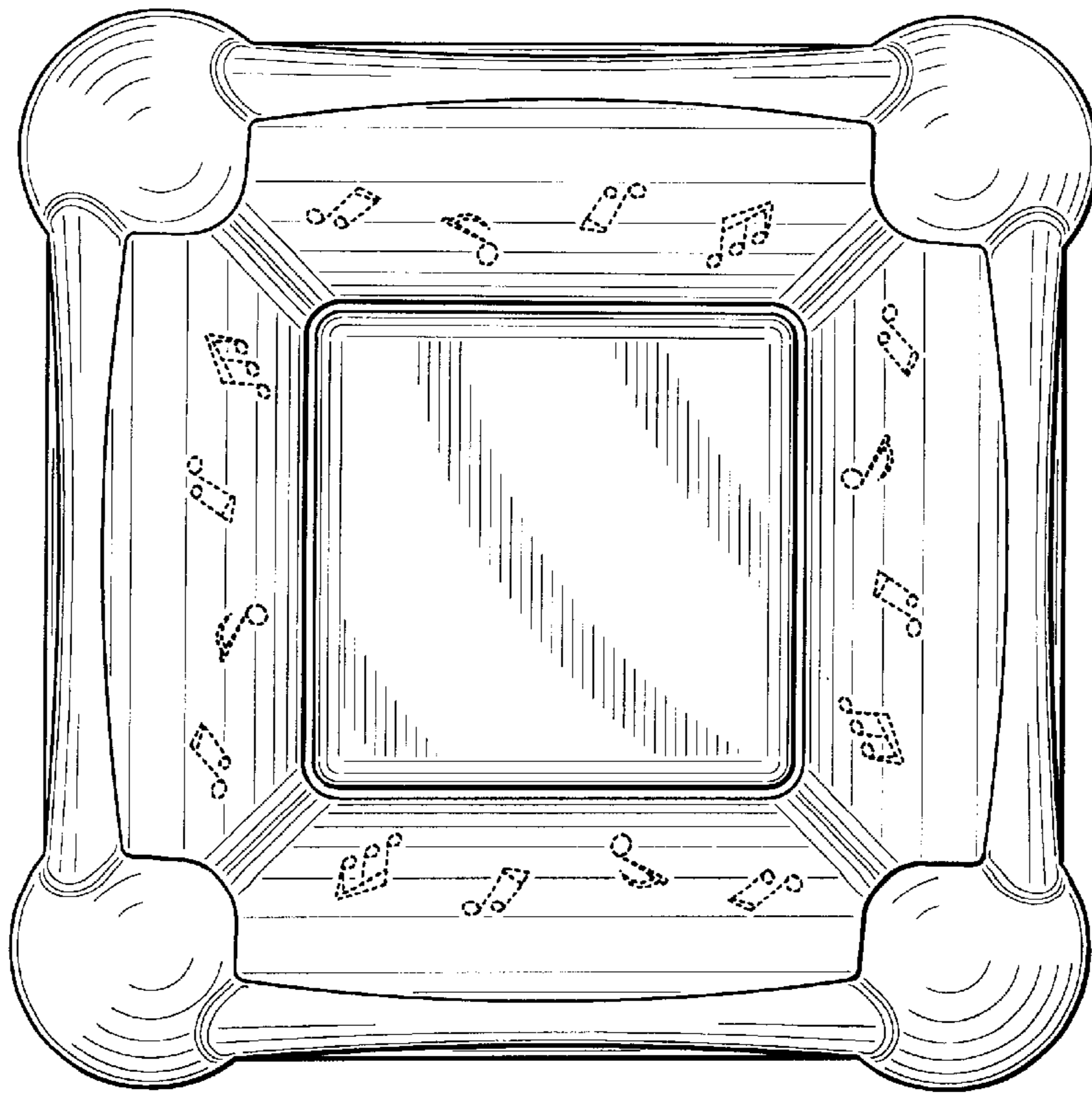

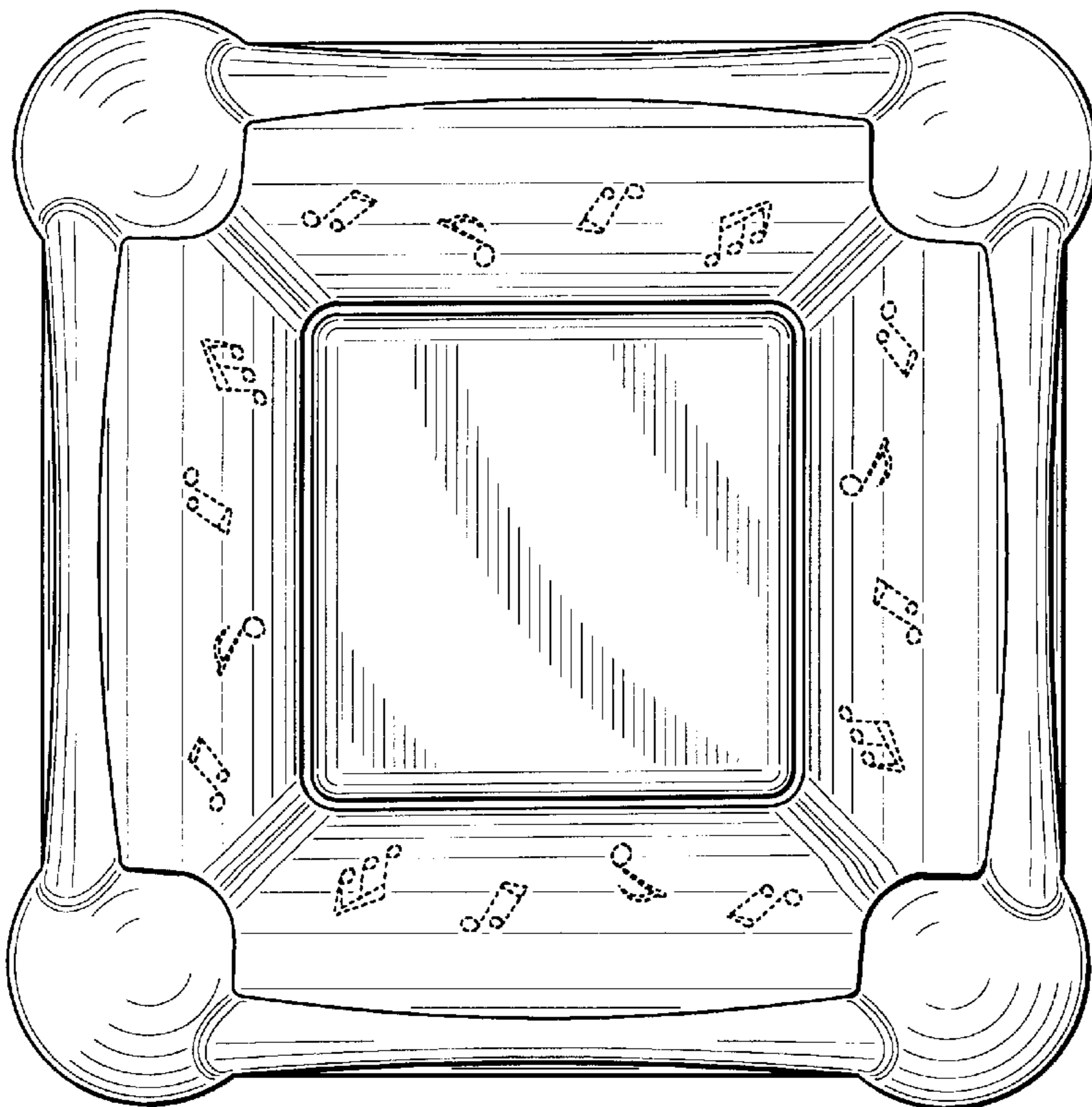
