The ornamental design for a shower control assembly escutcheon, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of our new design for a shower control assembly escutcheon;
FIG. 2 is a bottom view thereof;
FIG. 3 is a front view thereof;
FIG. 4 is a right side view thereof, the left side being the same as the right side;
FIG. 5 is a top view thereof; and,
FIG. 6 is a rear view thereof.

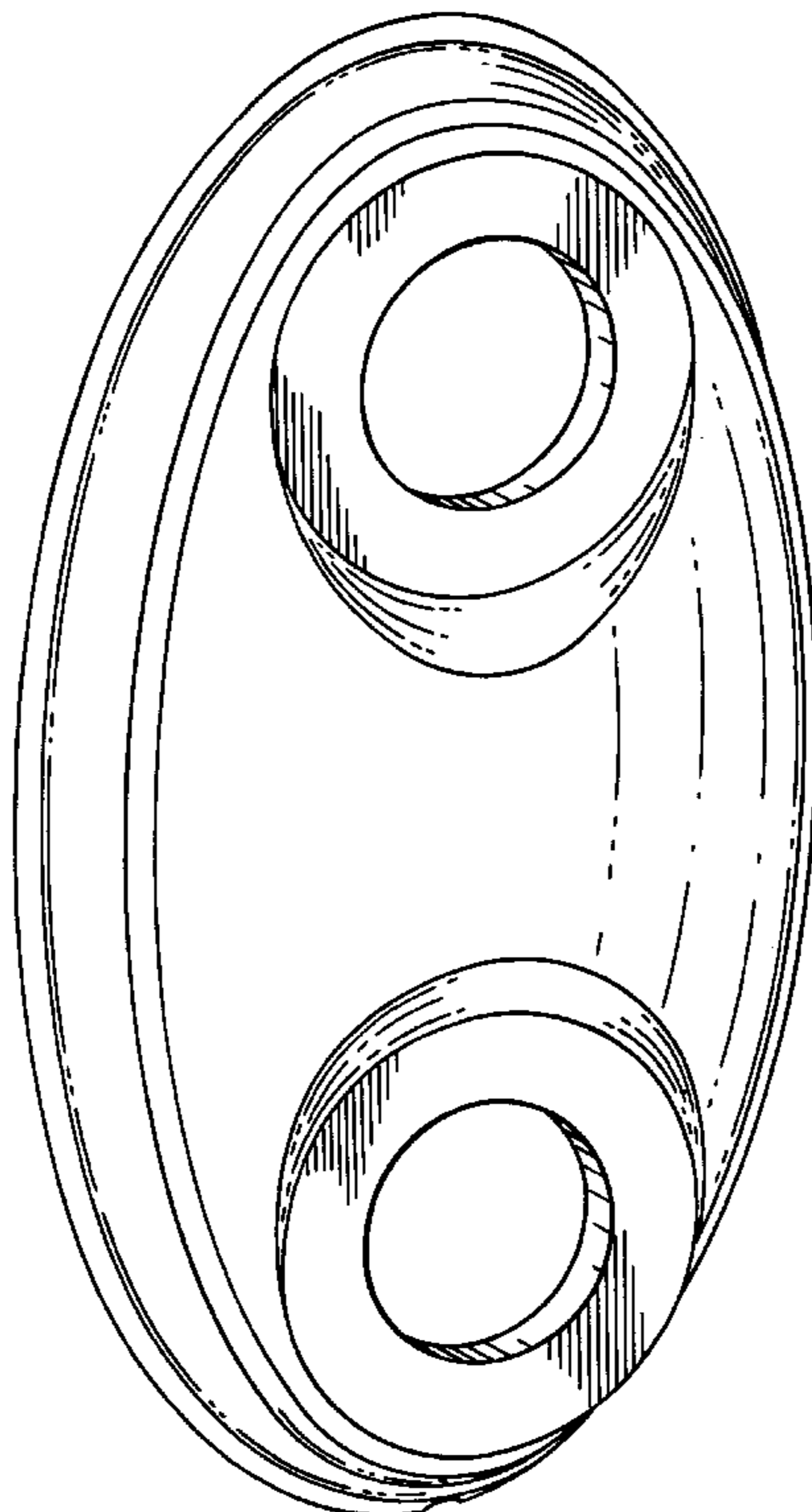

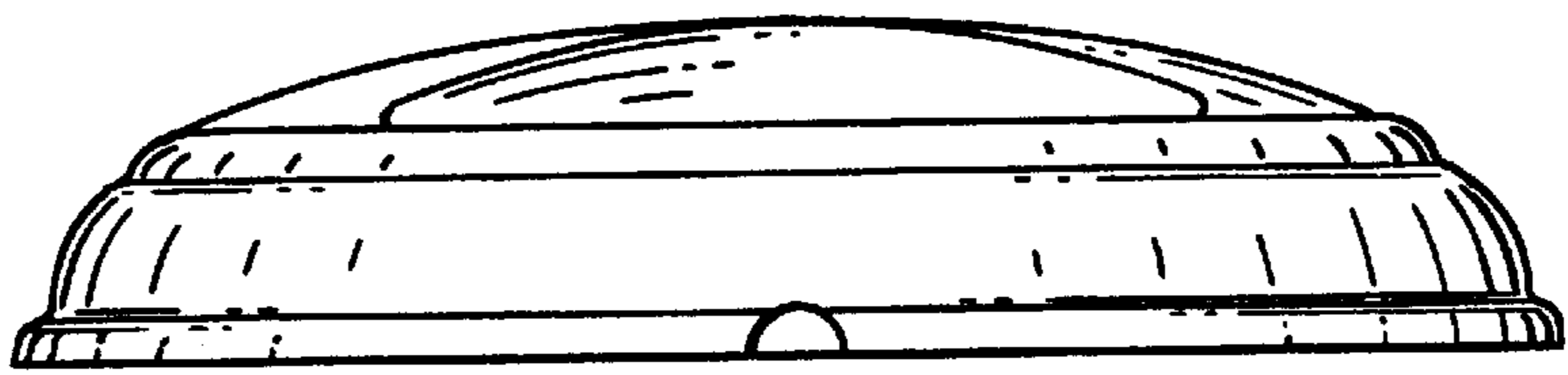
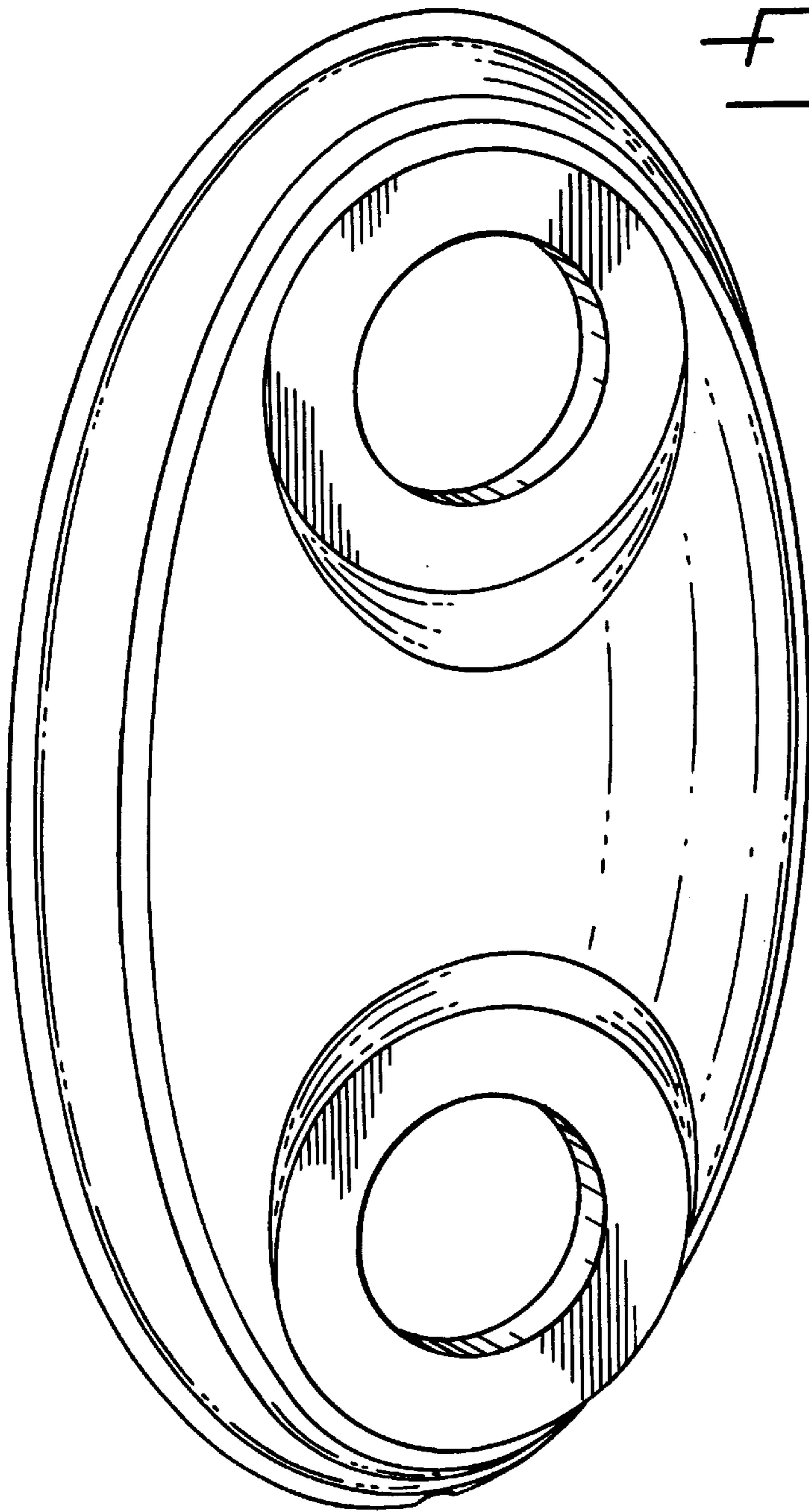

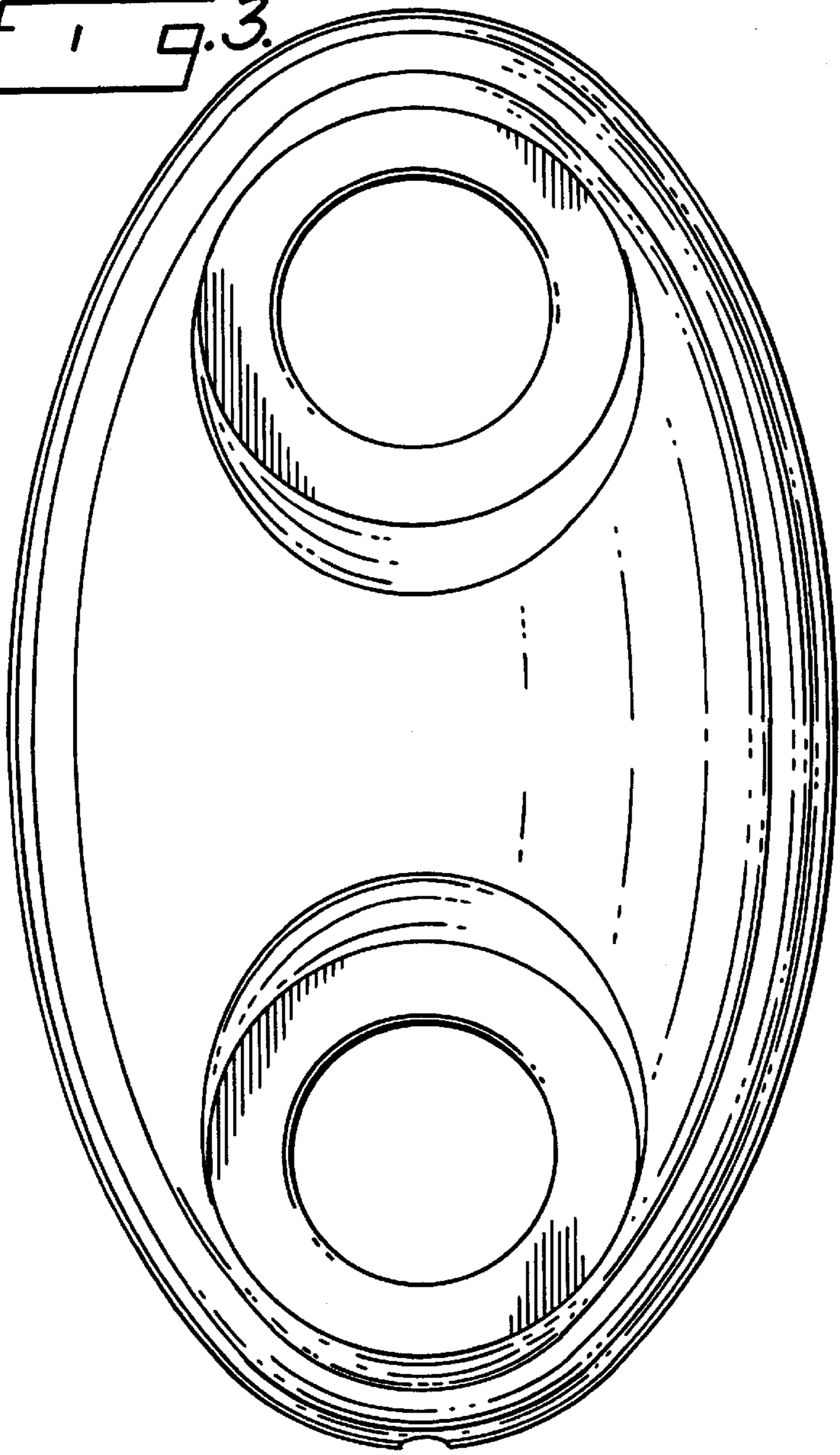

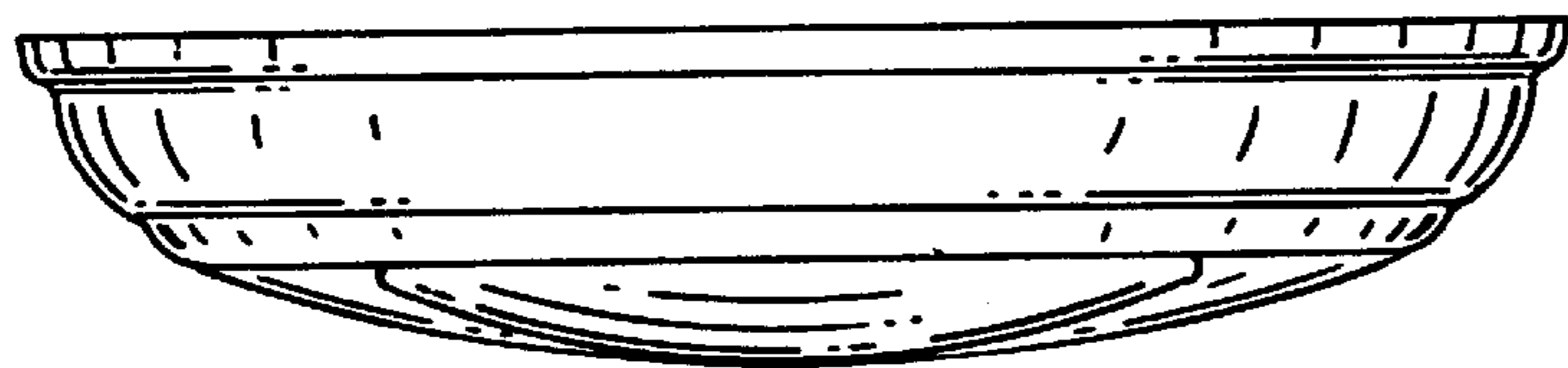

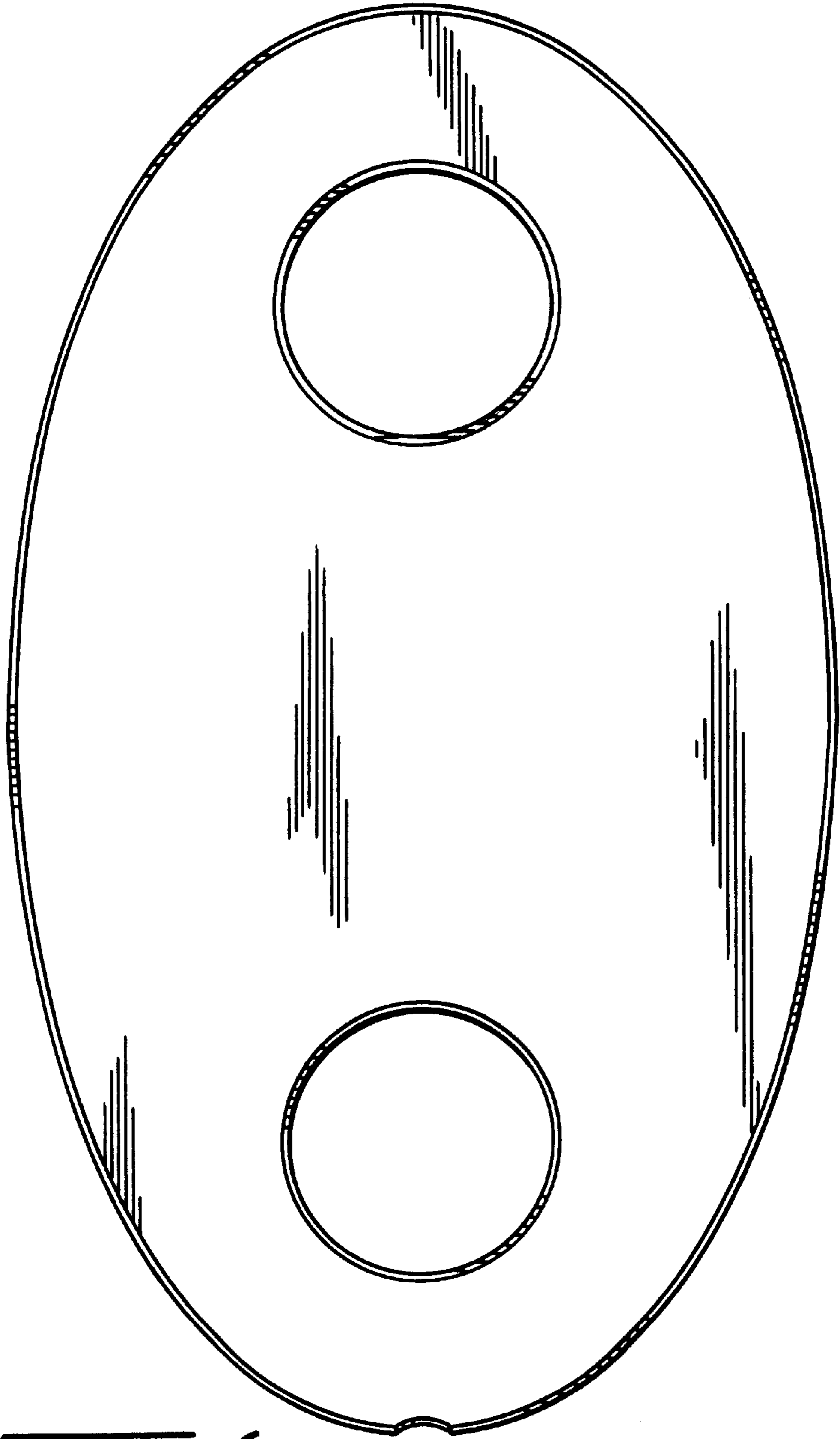
