FIG. 8 is a perspective view thereof, the interior drum being removed from the housing for purposes of disclosure;

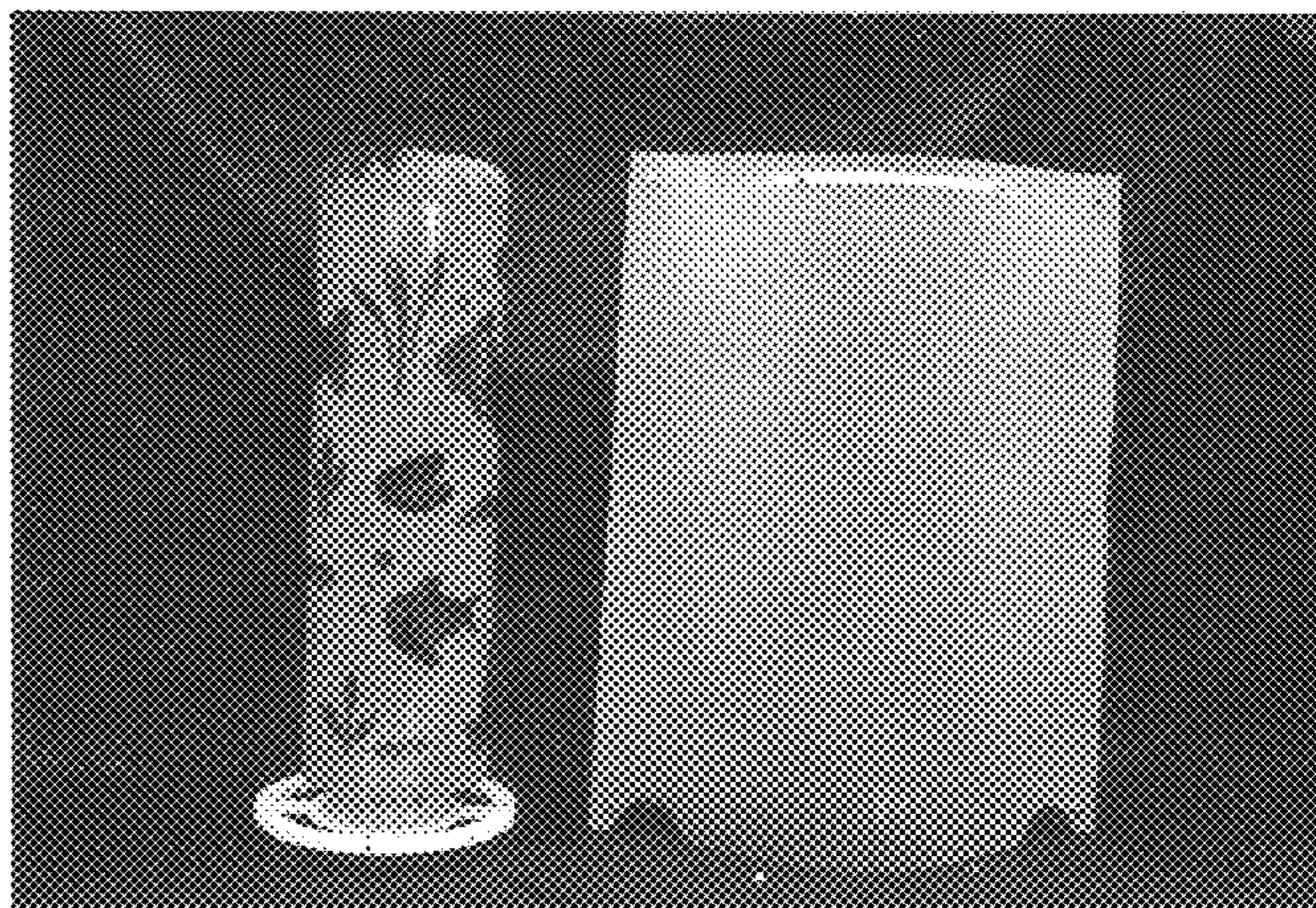
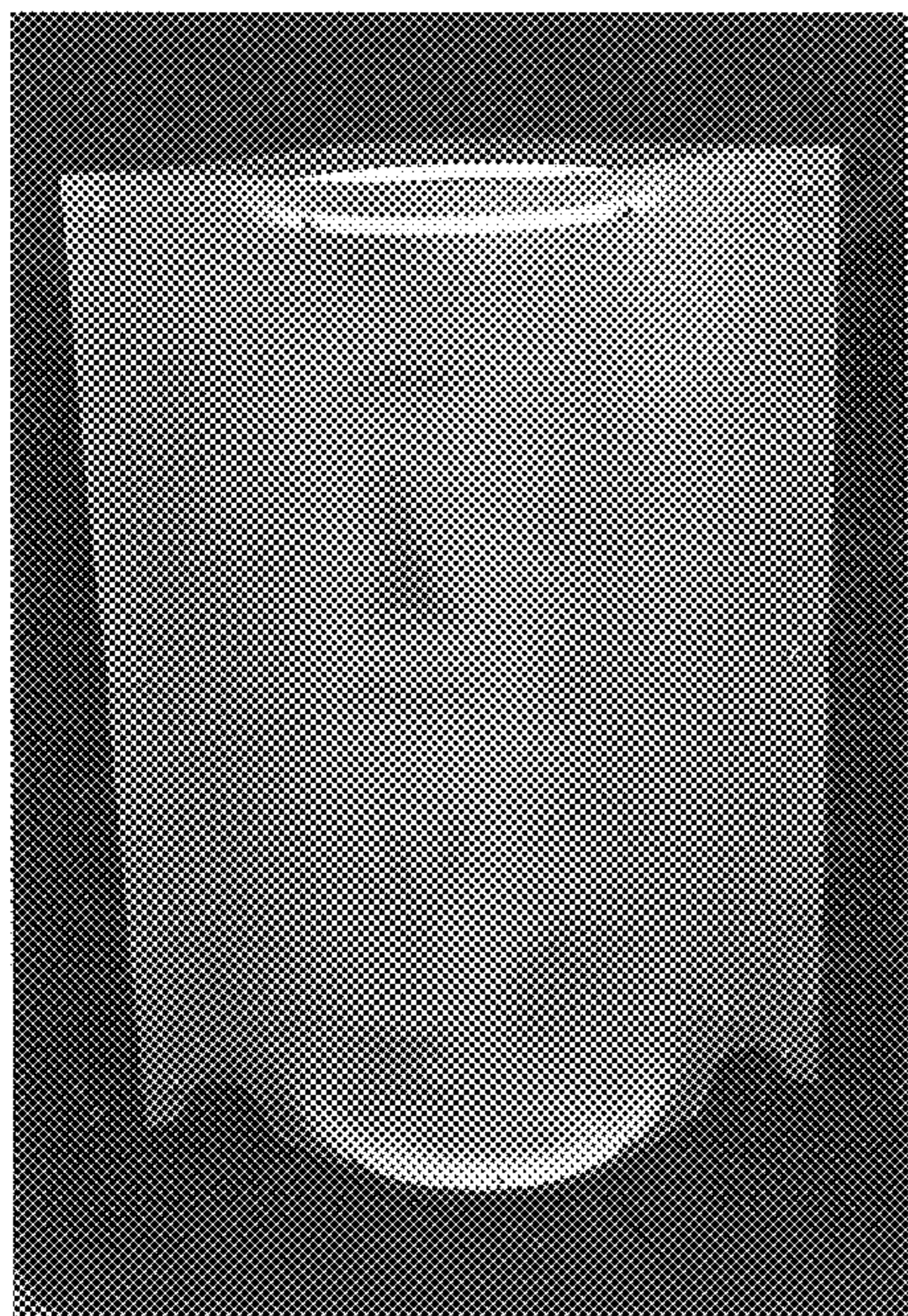
FIG. 9 is a top view thereof, the interior drum being removed from the housing for purposes of disclosure;

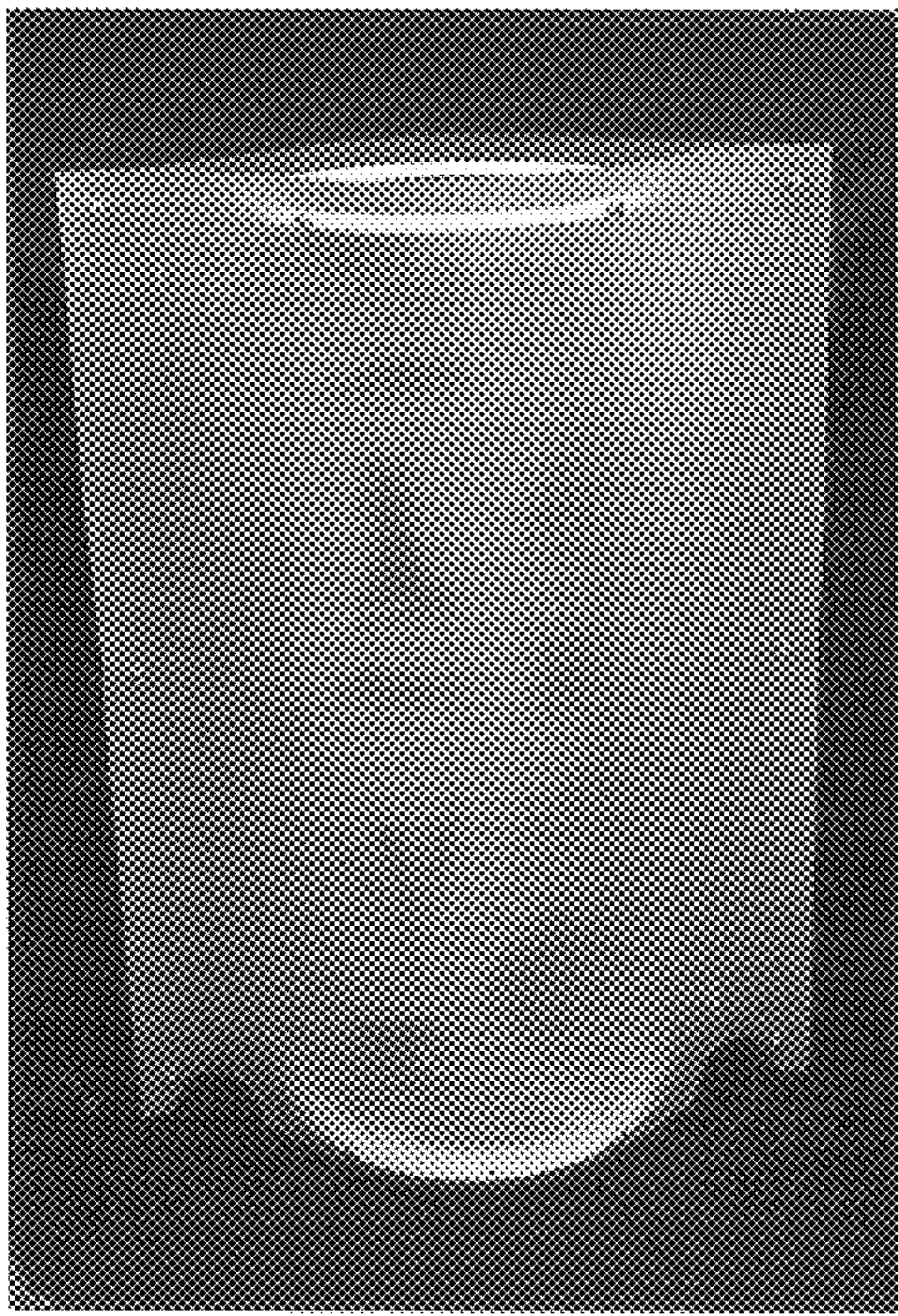

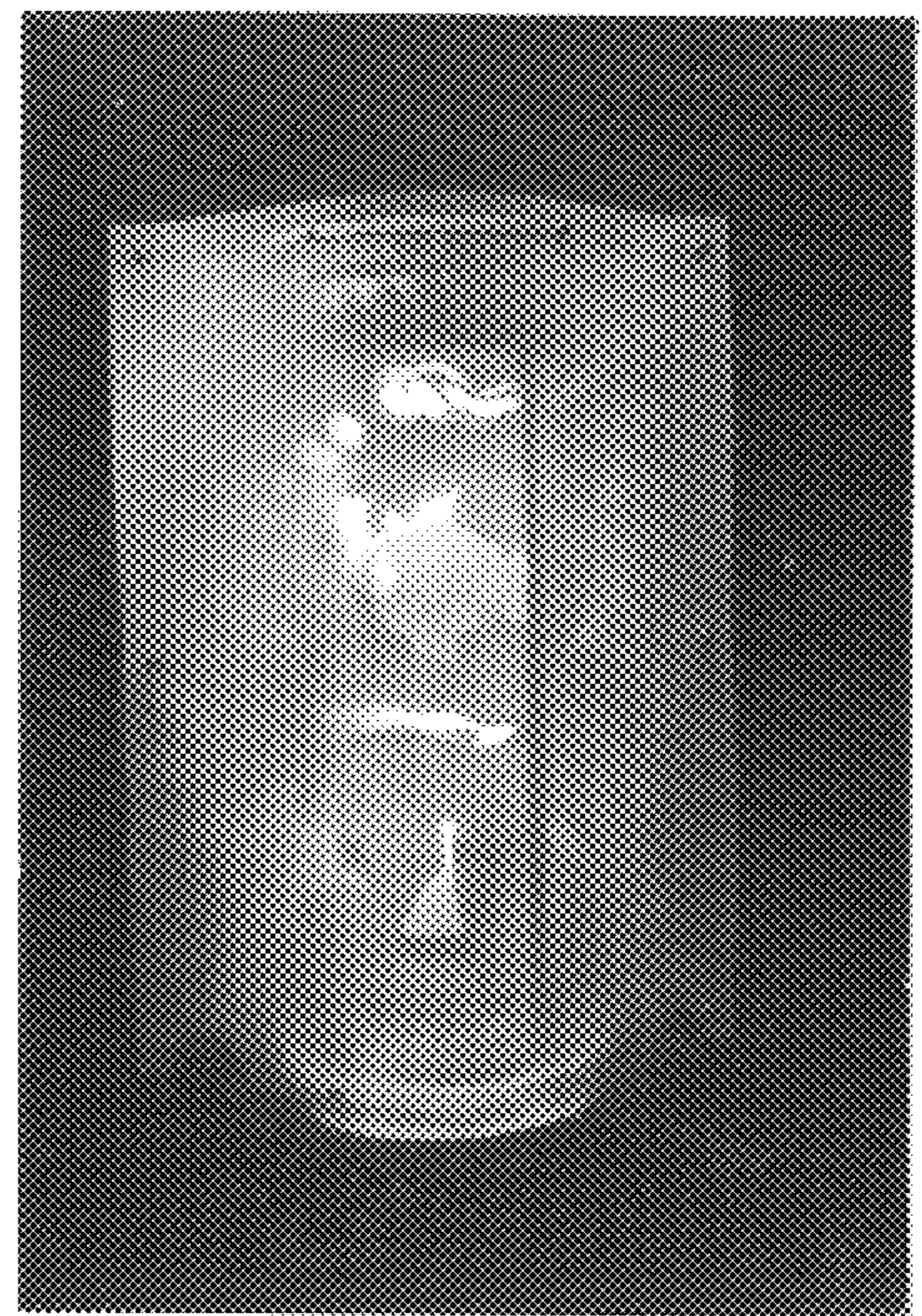

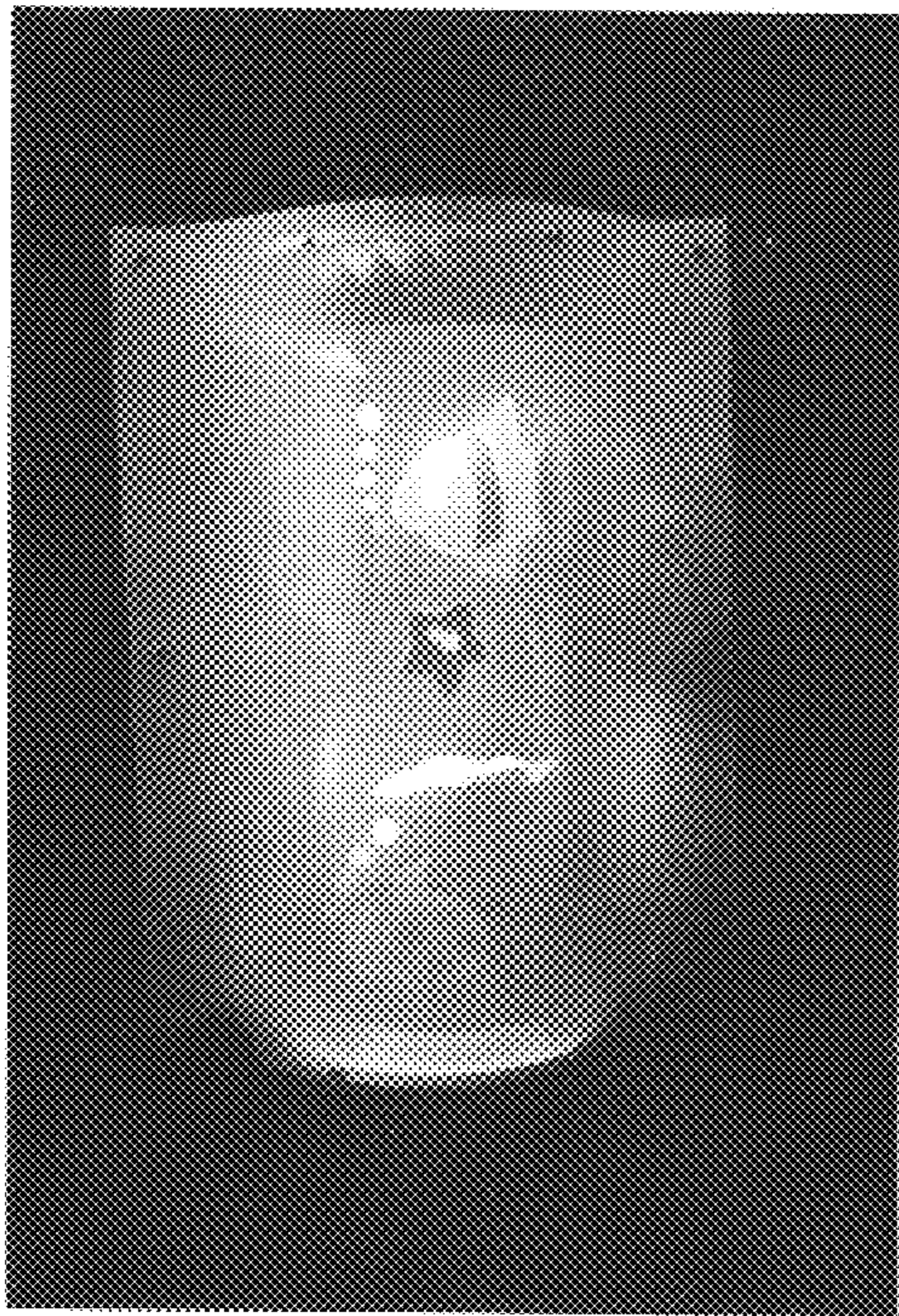

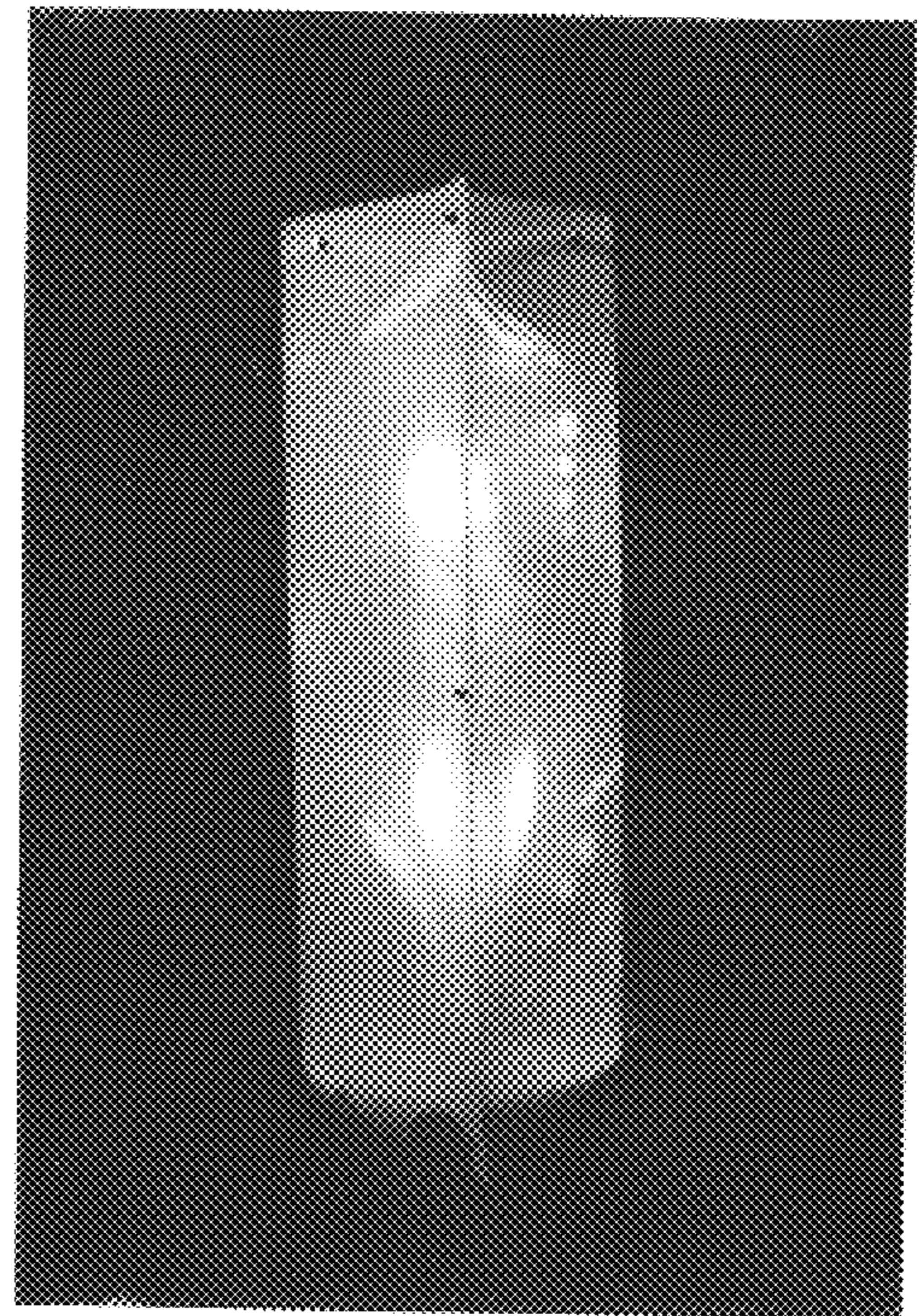

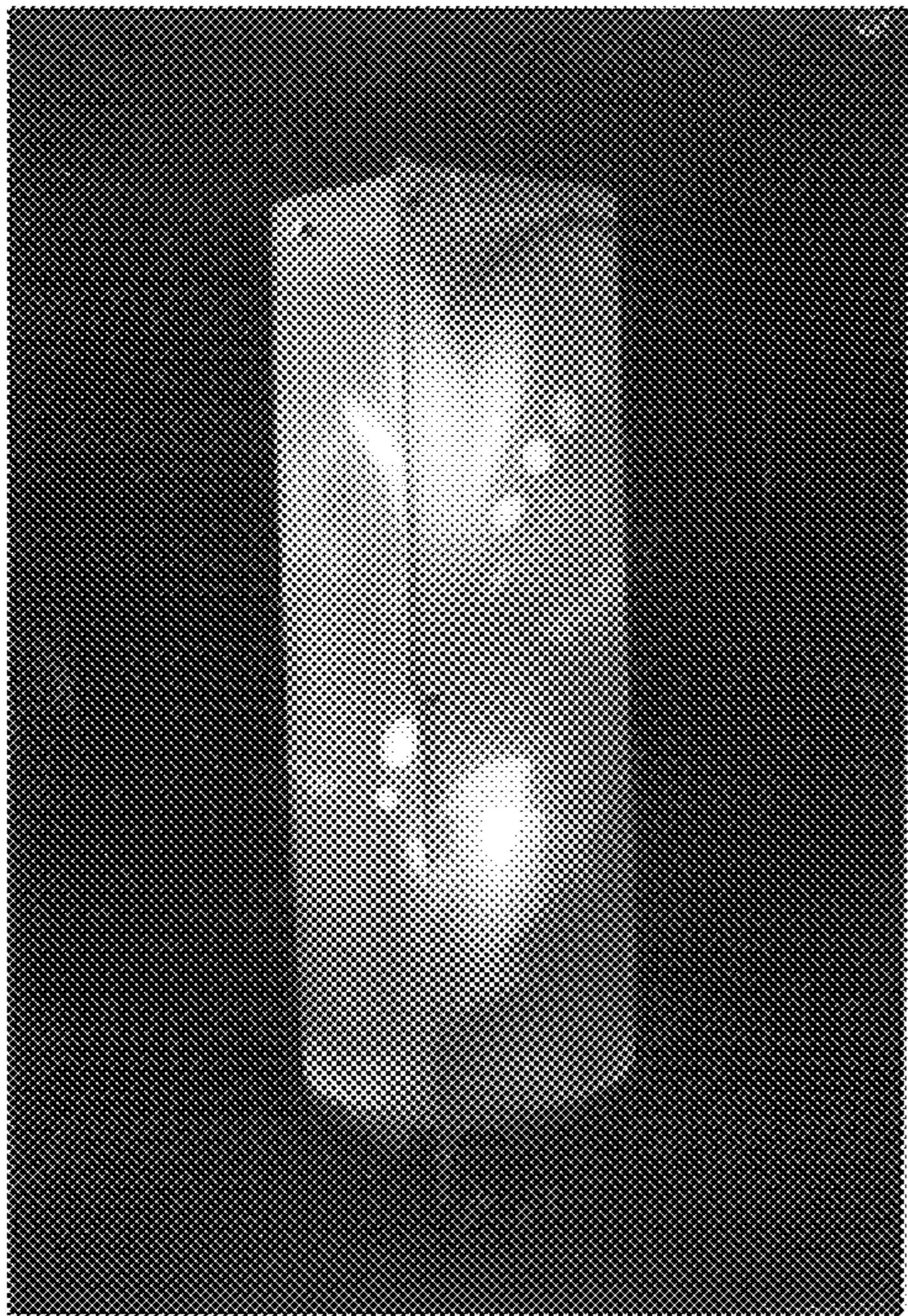

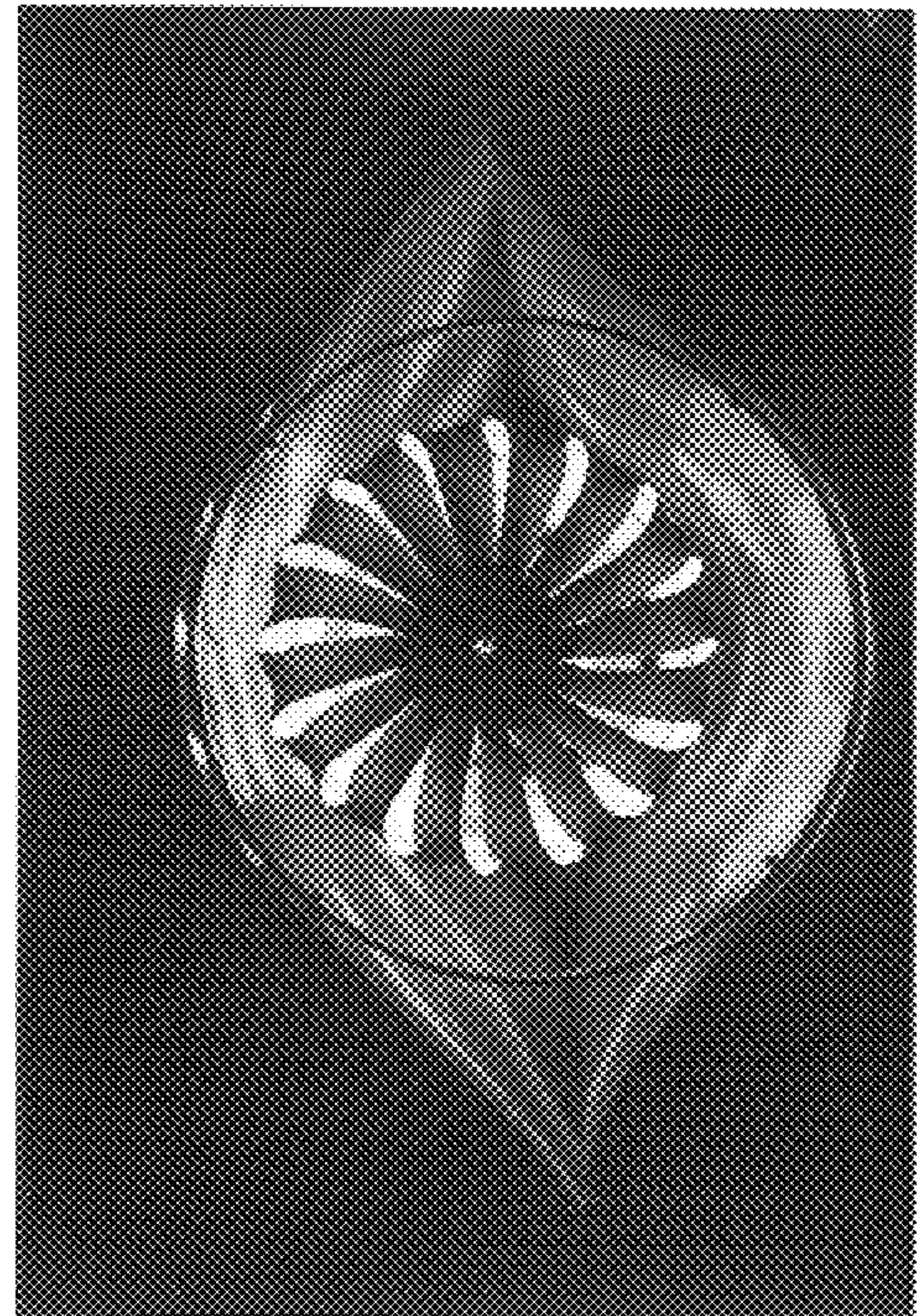

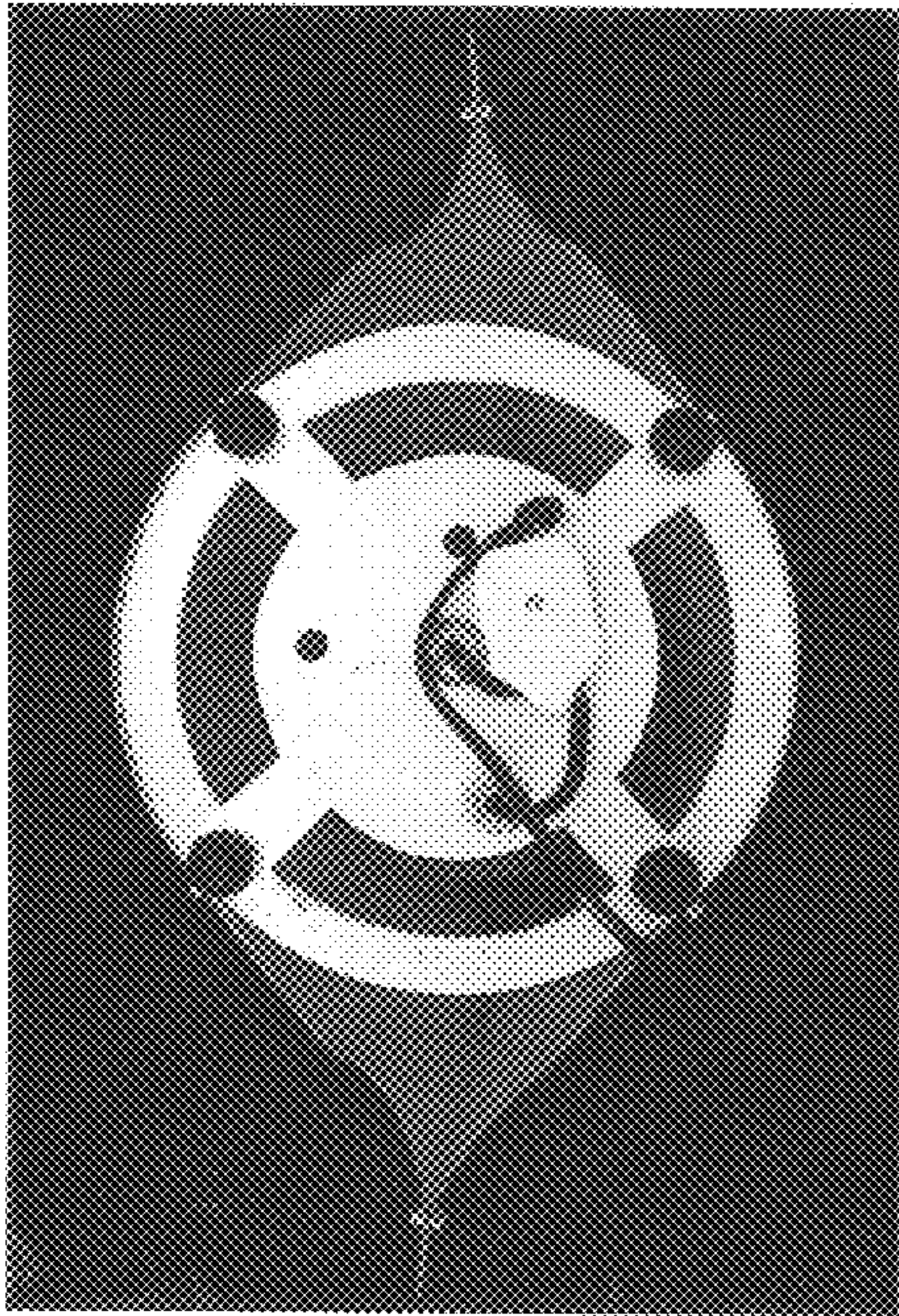

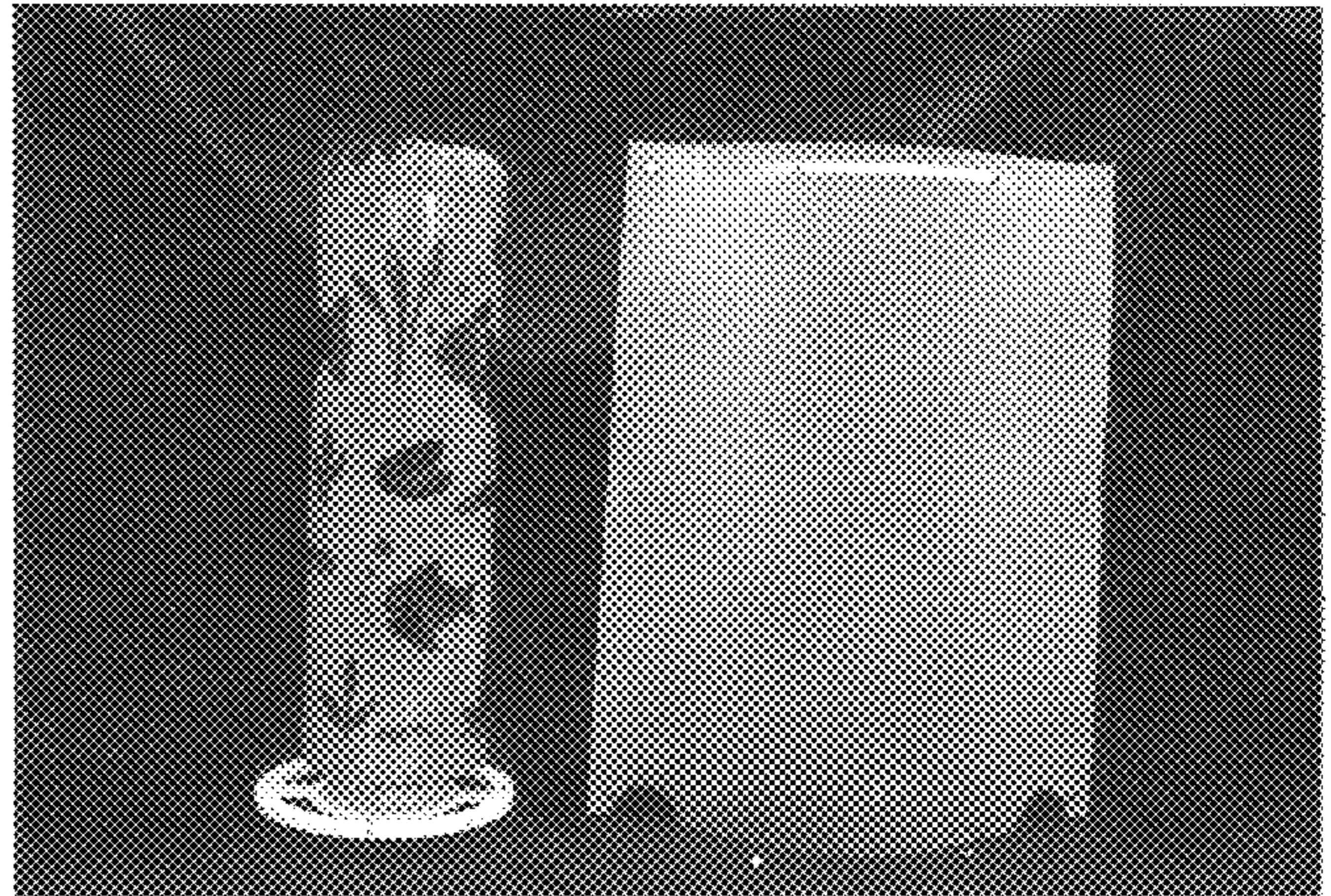

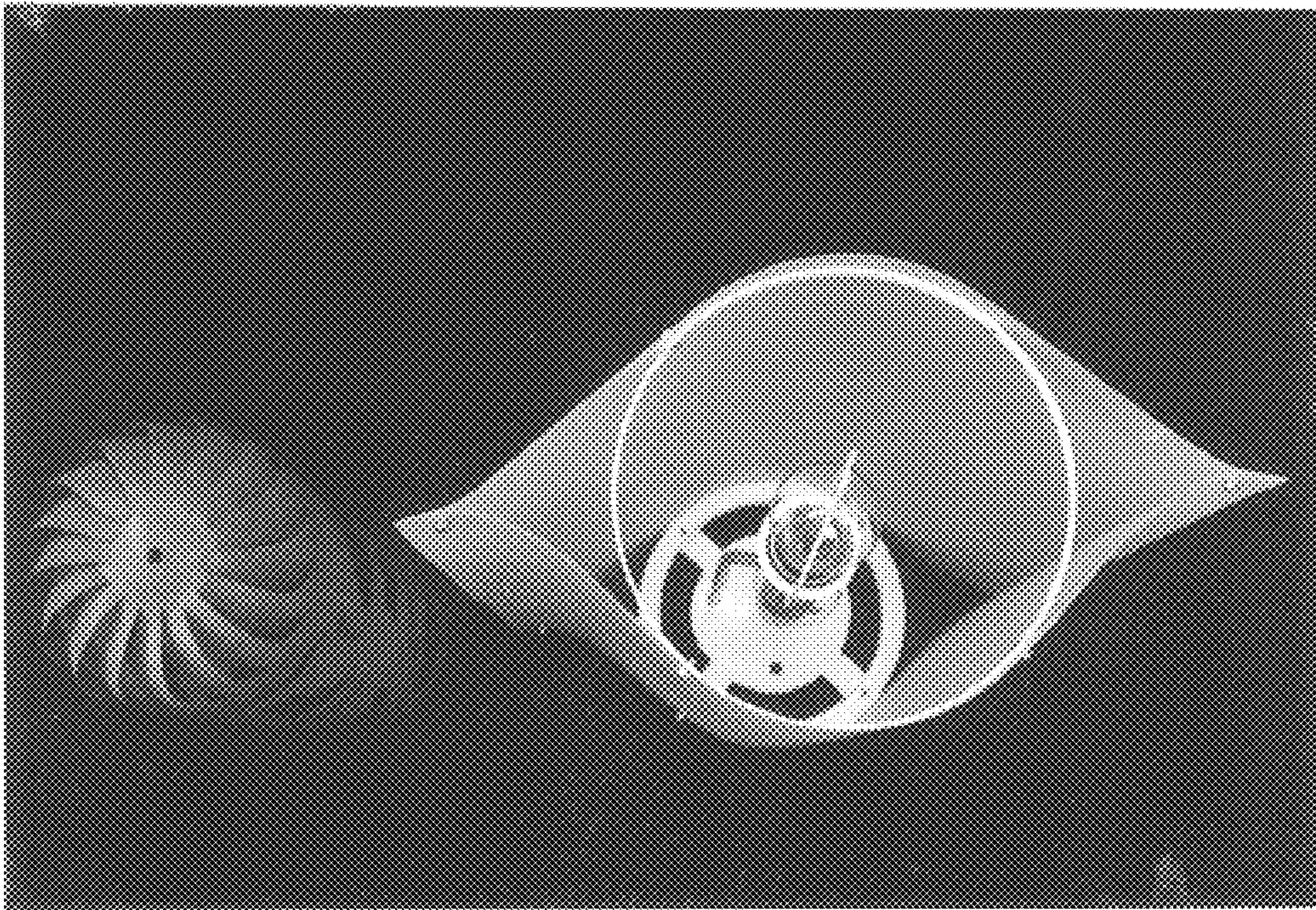

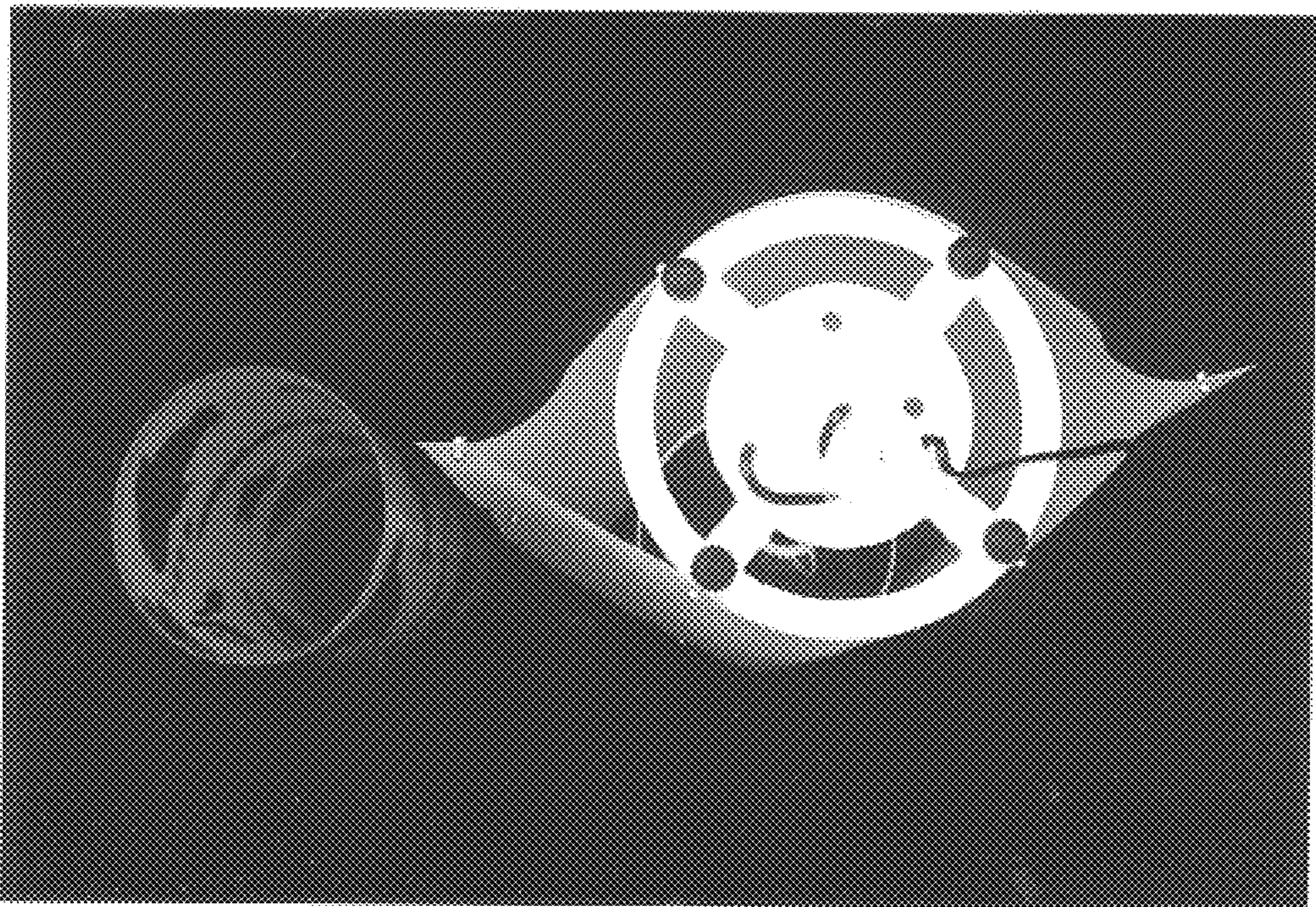
