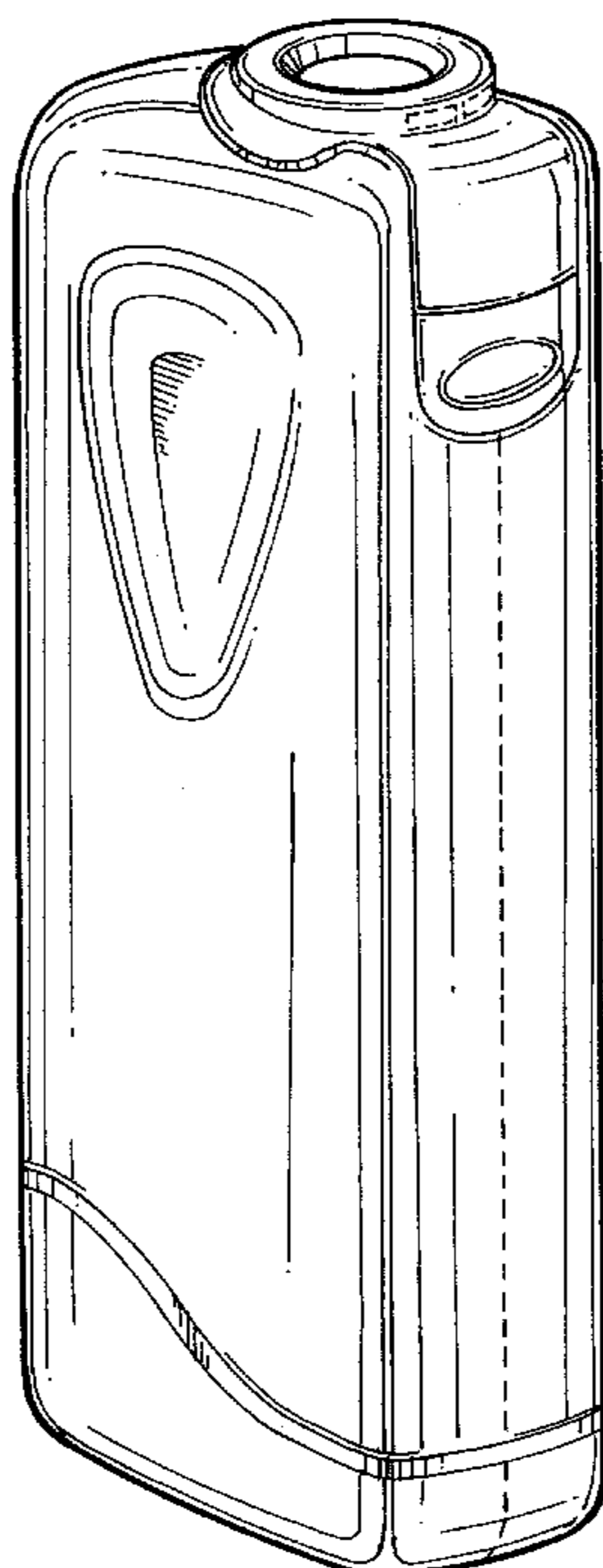
[57] **CLAIM**

We claim the ornamental design for a hand-held smoking unit, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of the hand-held smoking unit incorporating our new design;  
FIG. 2 is a rear elevational view thereof;  
FIG. 3 is a right side elevational view thereof;  
FIG. 4 is a left side elevational view thereof;  
FIG. 5 is a top plan view thereof;  
FIG. 6 is a bottom plan view thereof; and,

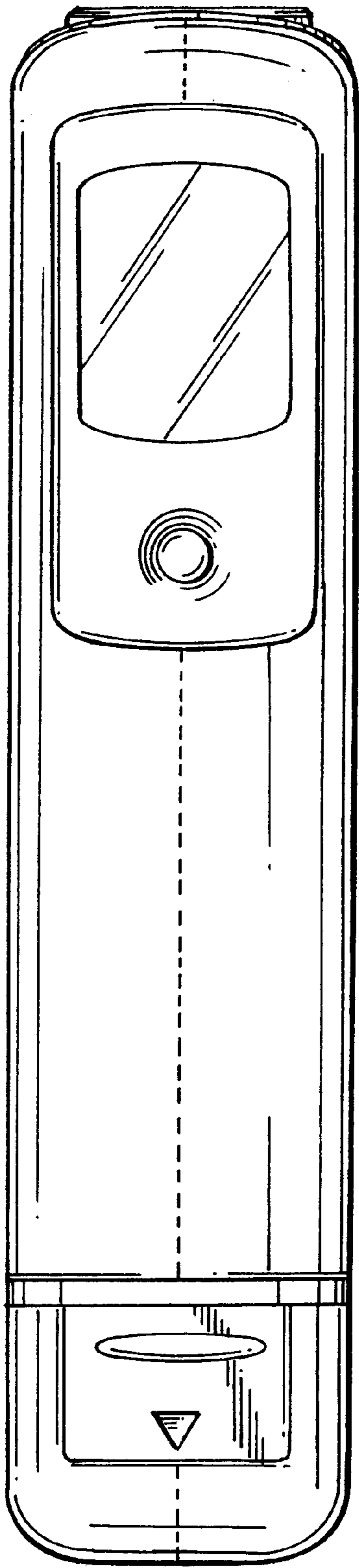

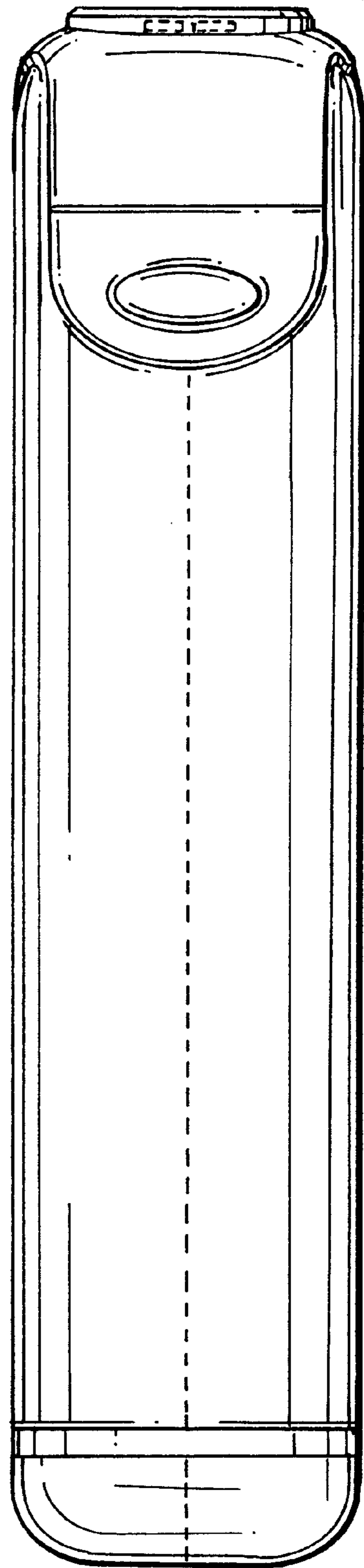

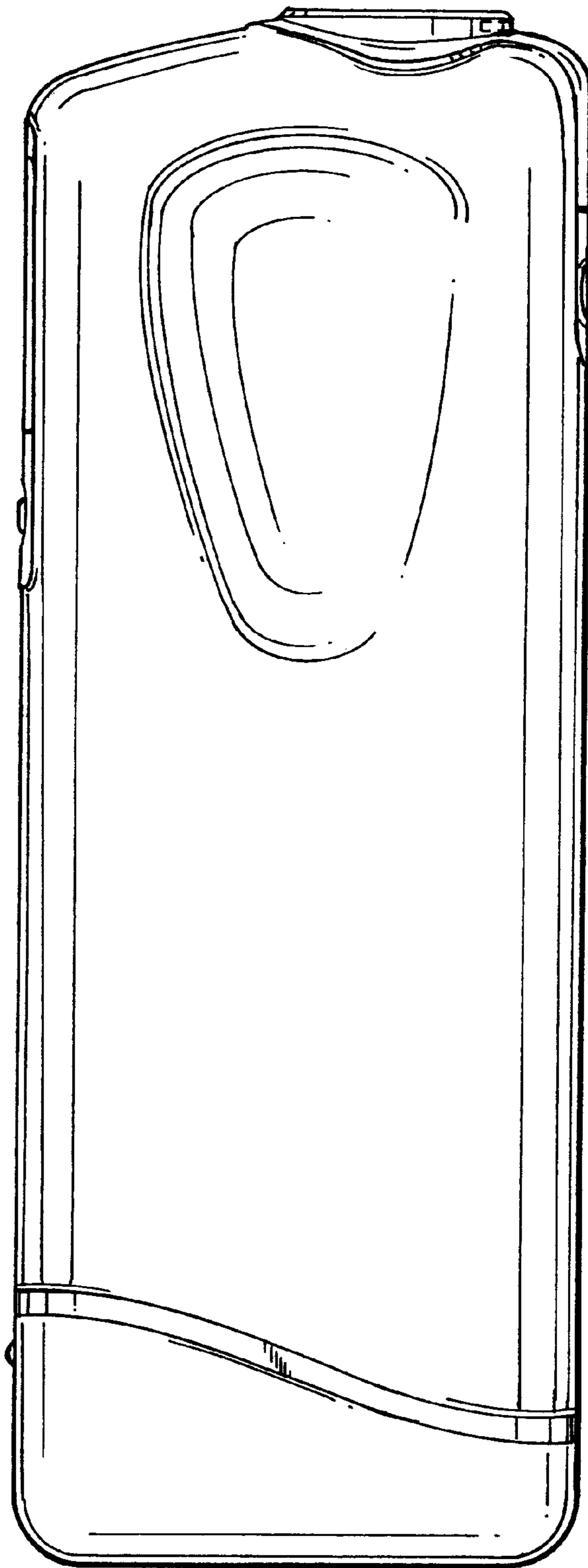

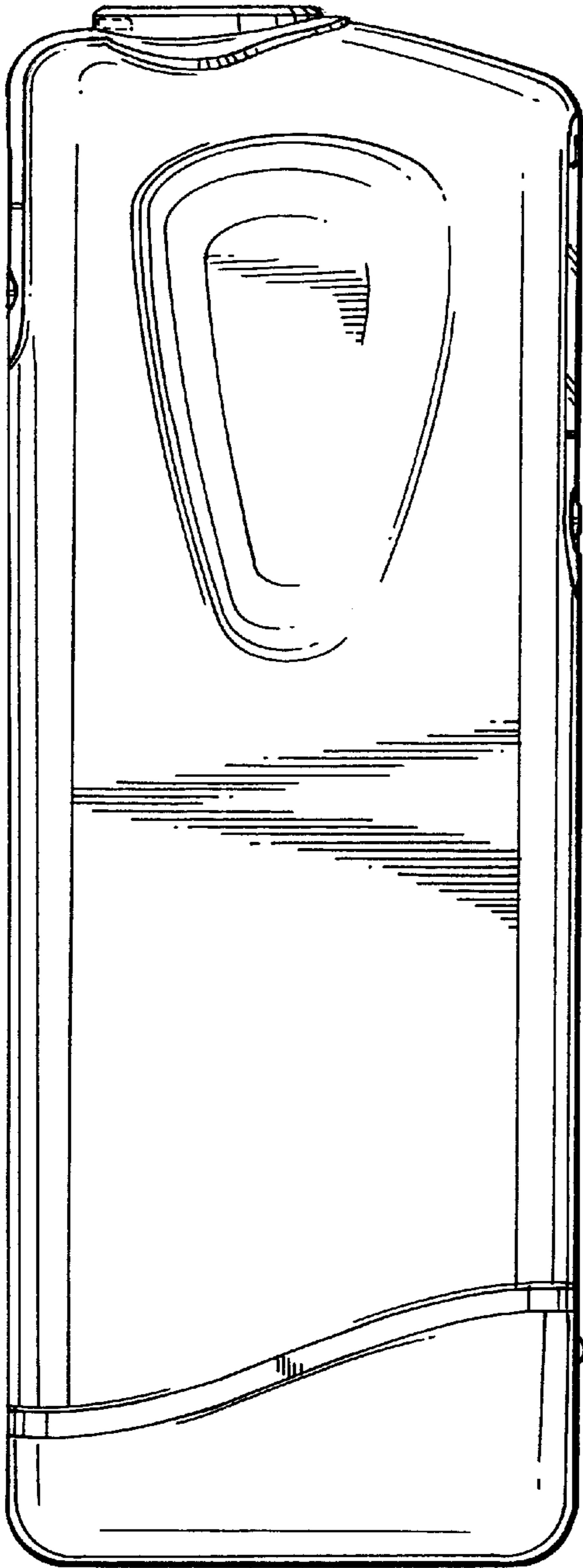

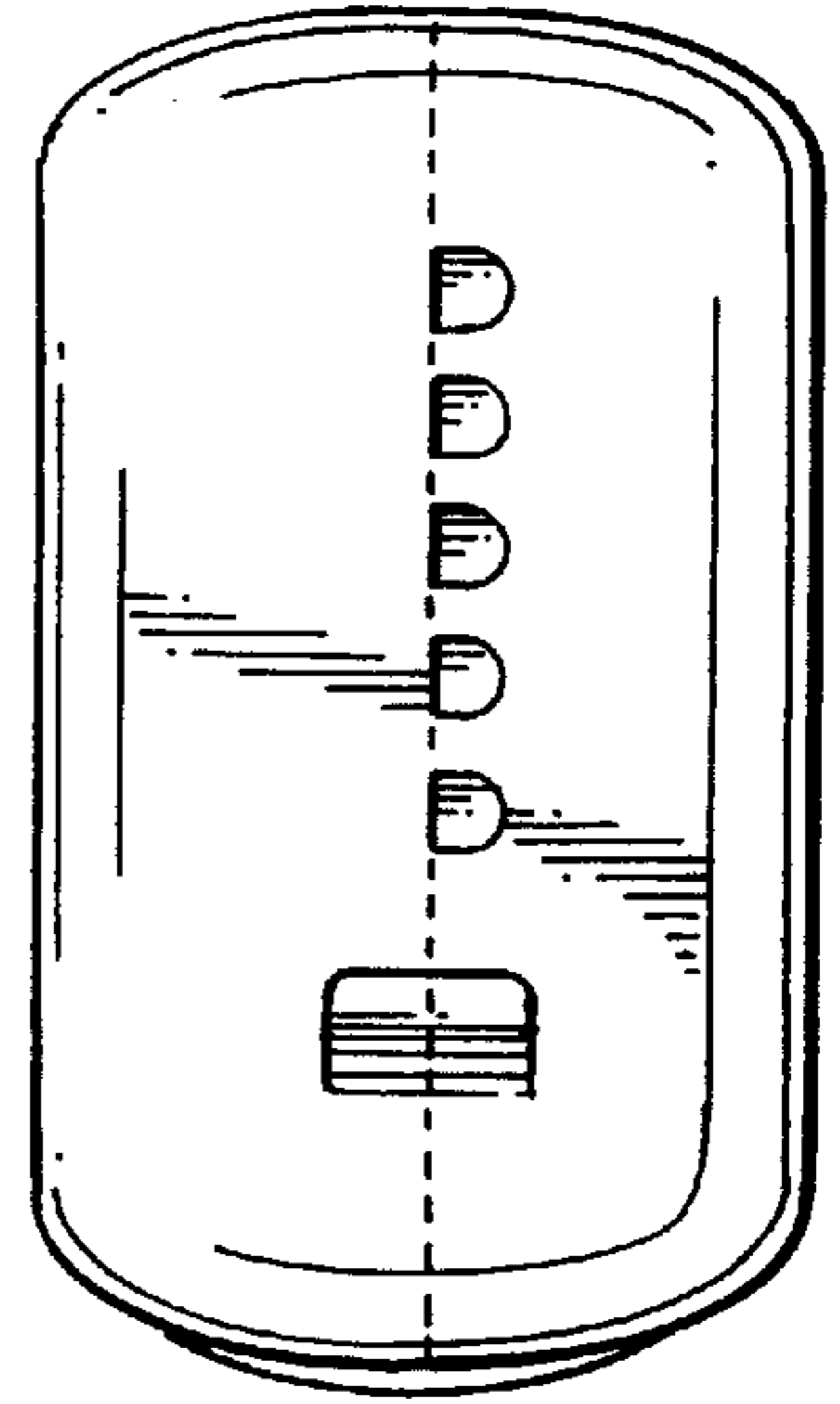

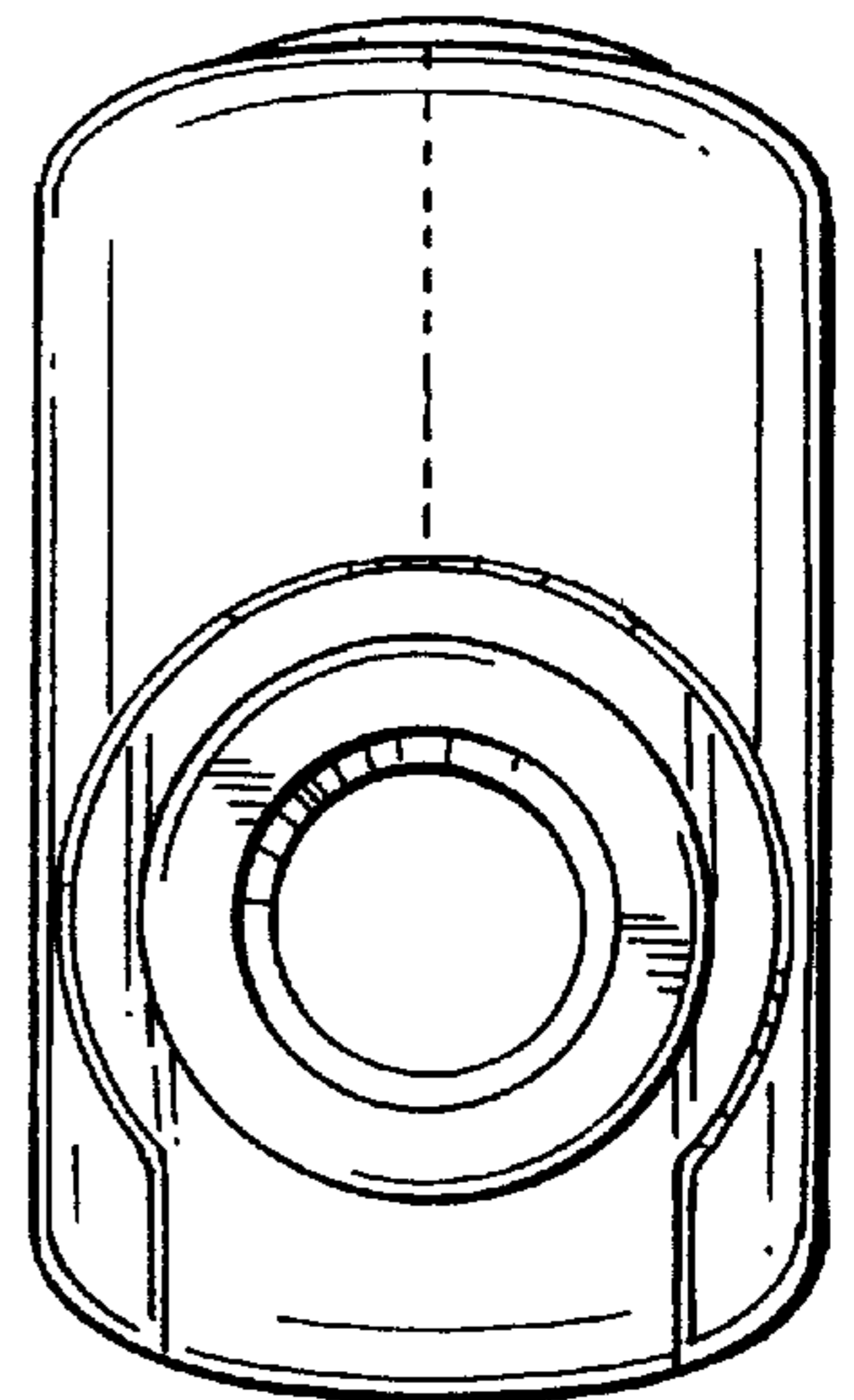

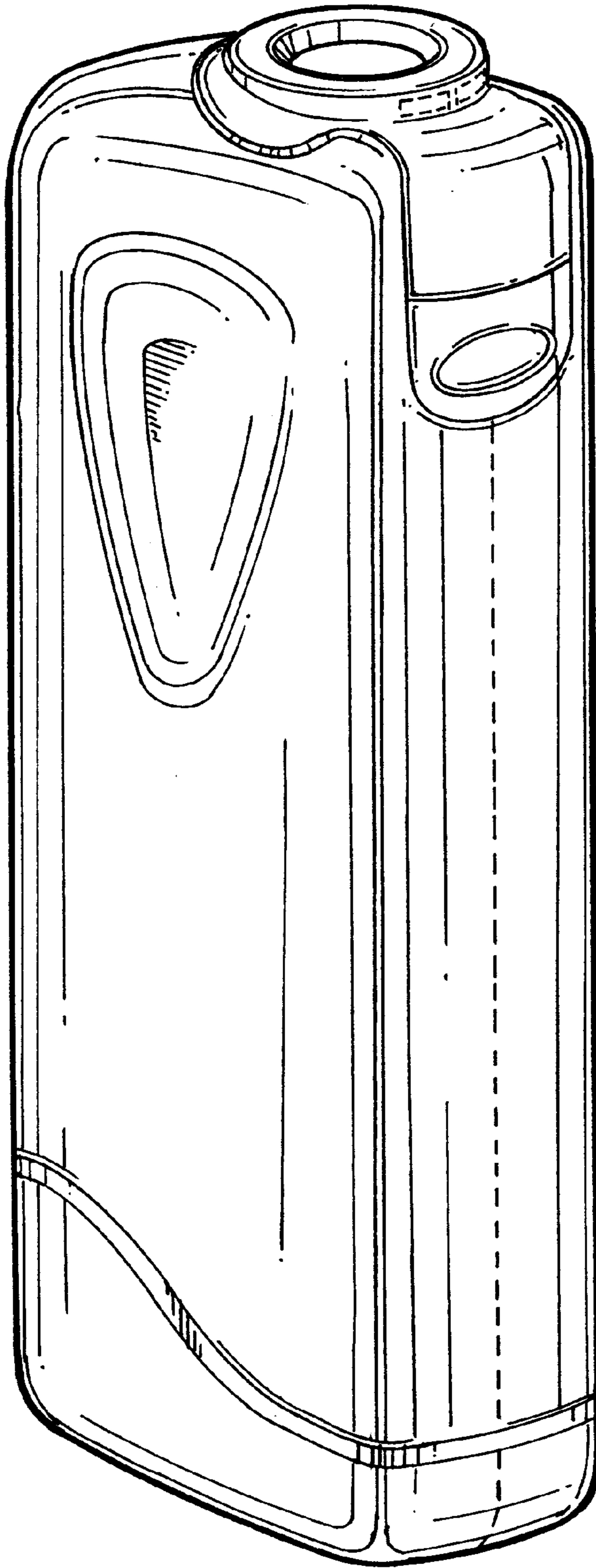
