We claim the ornamental design for a bottle, as shown.

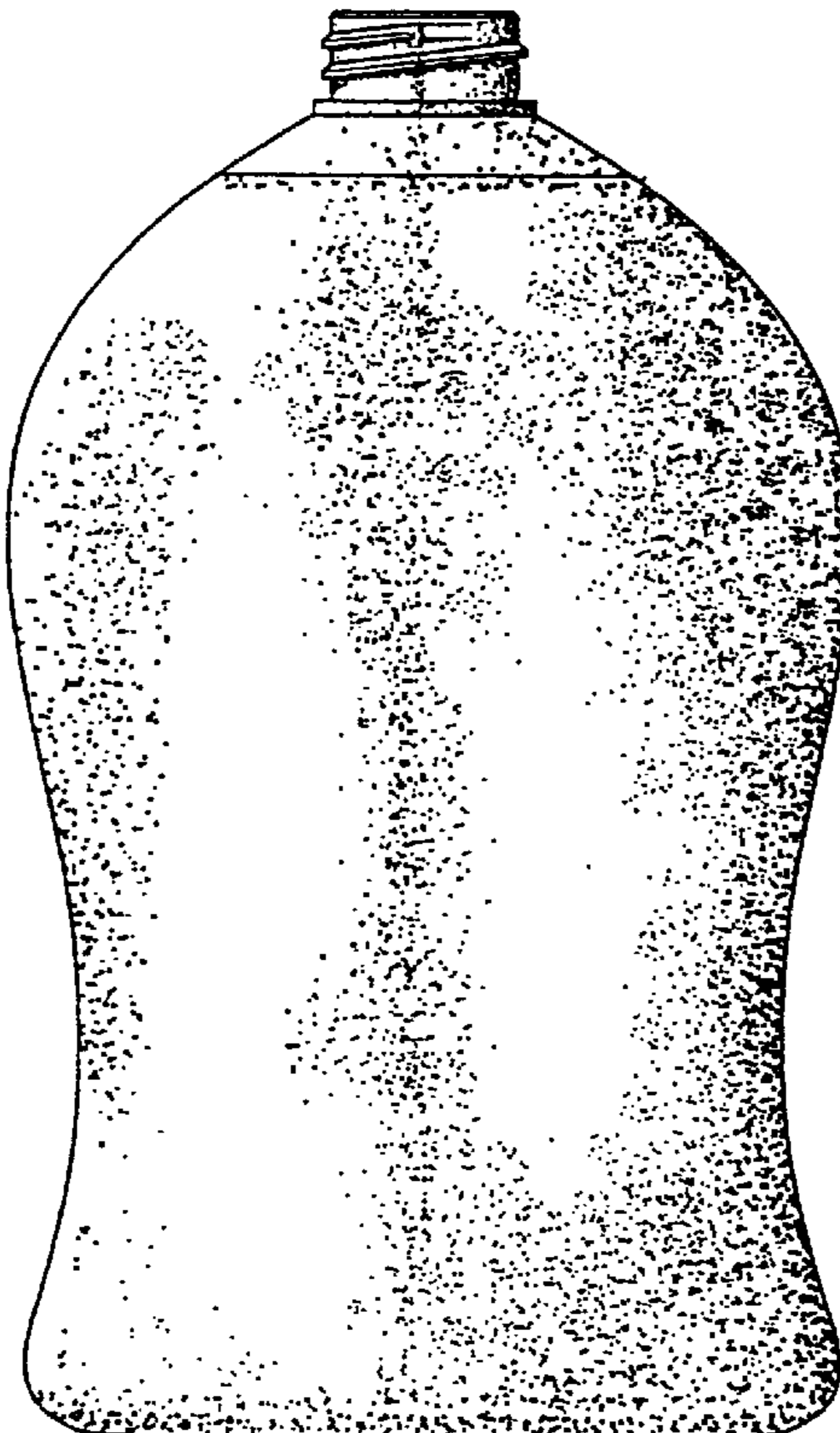

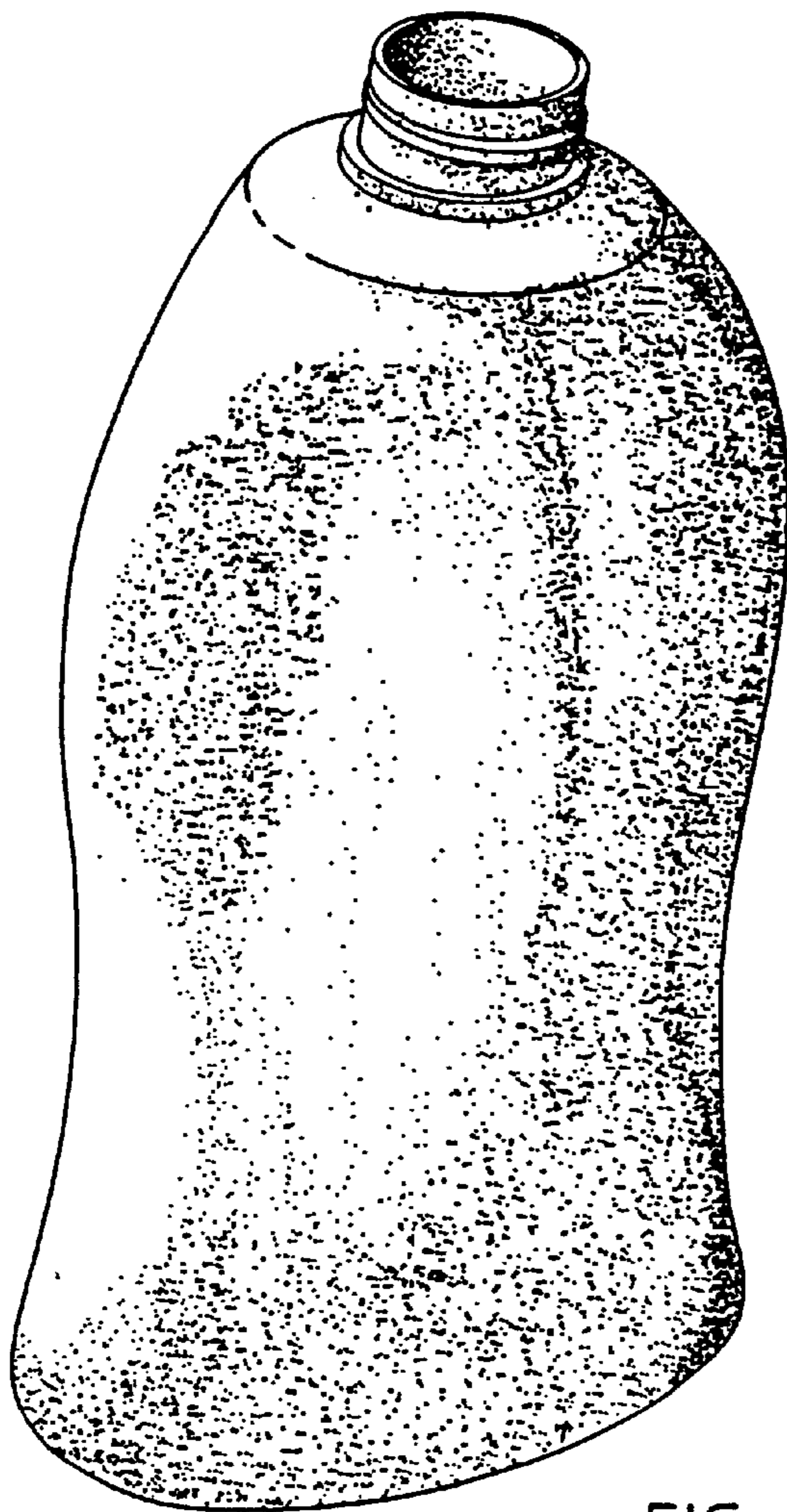

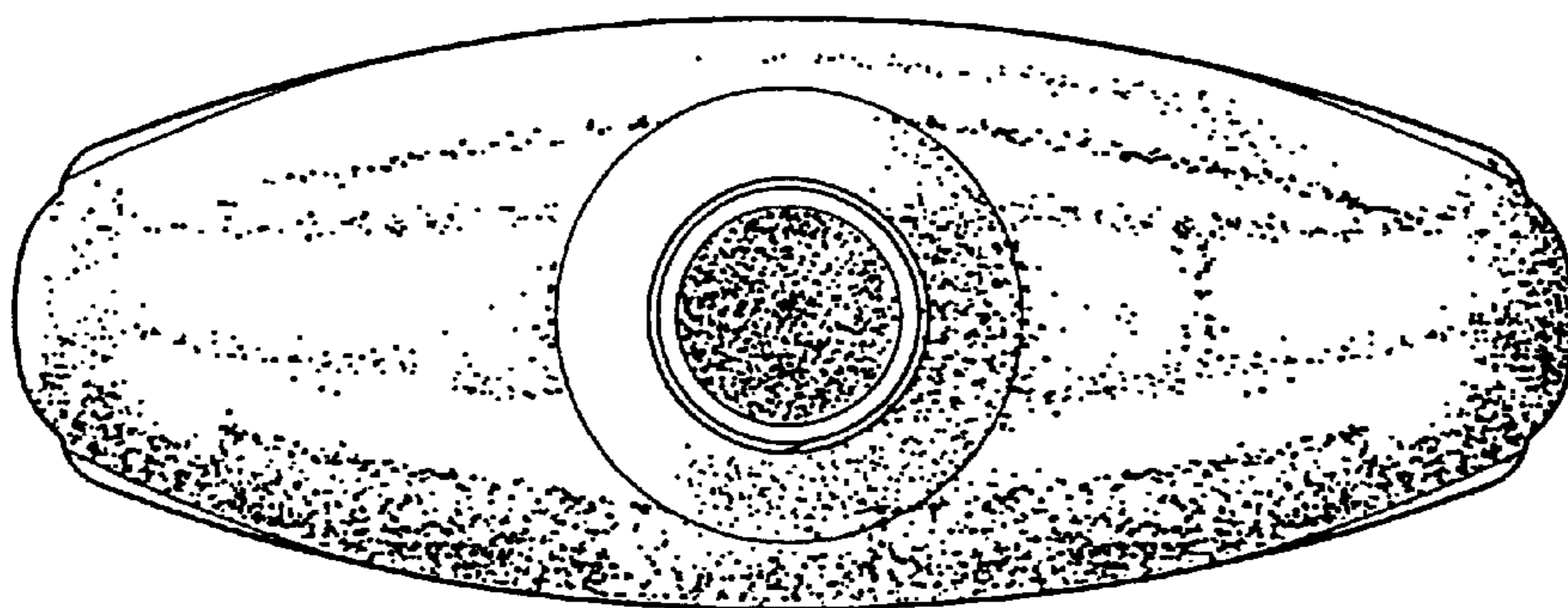

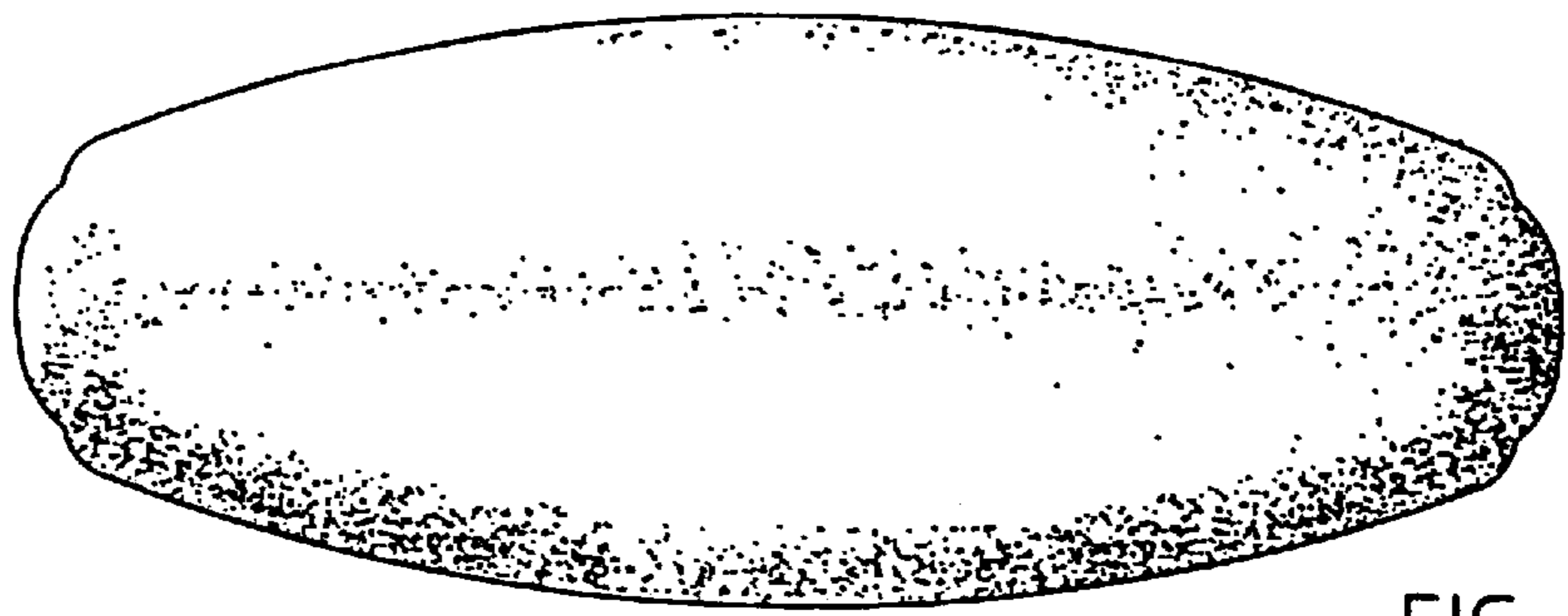

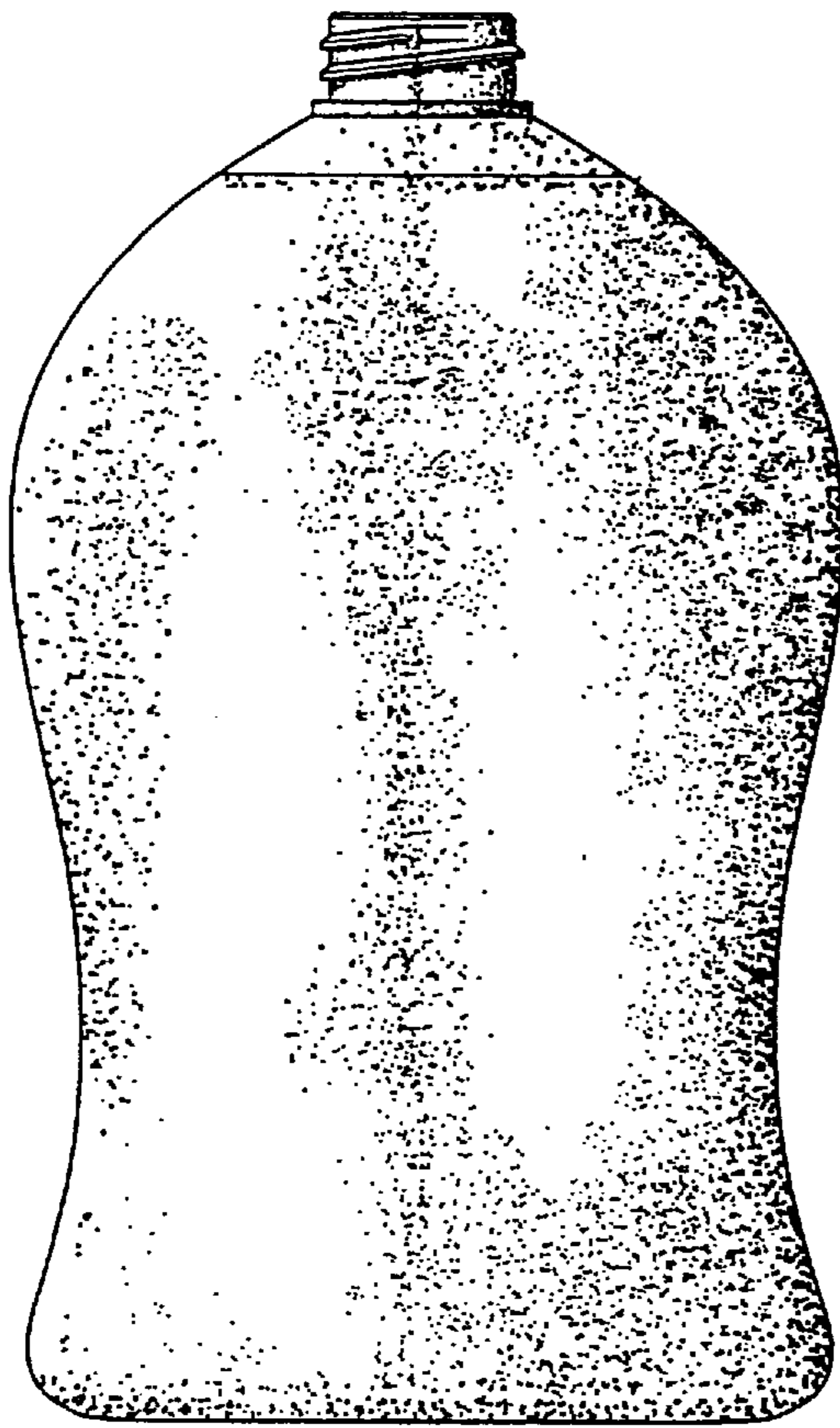

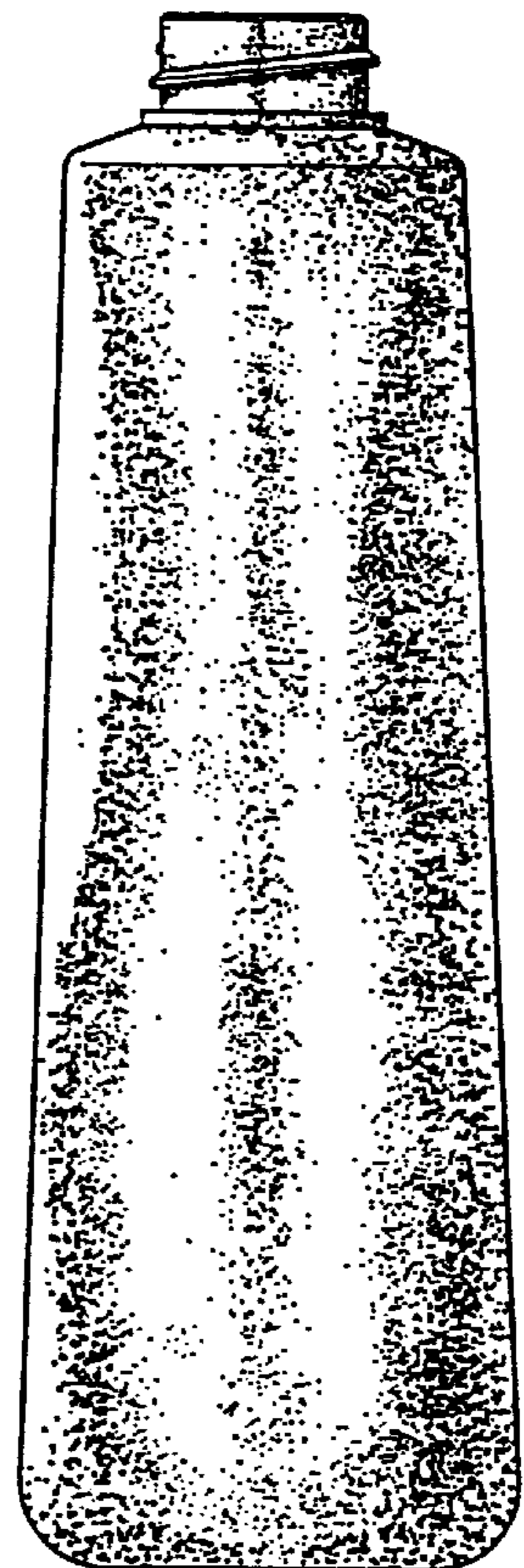
