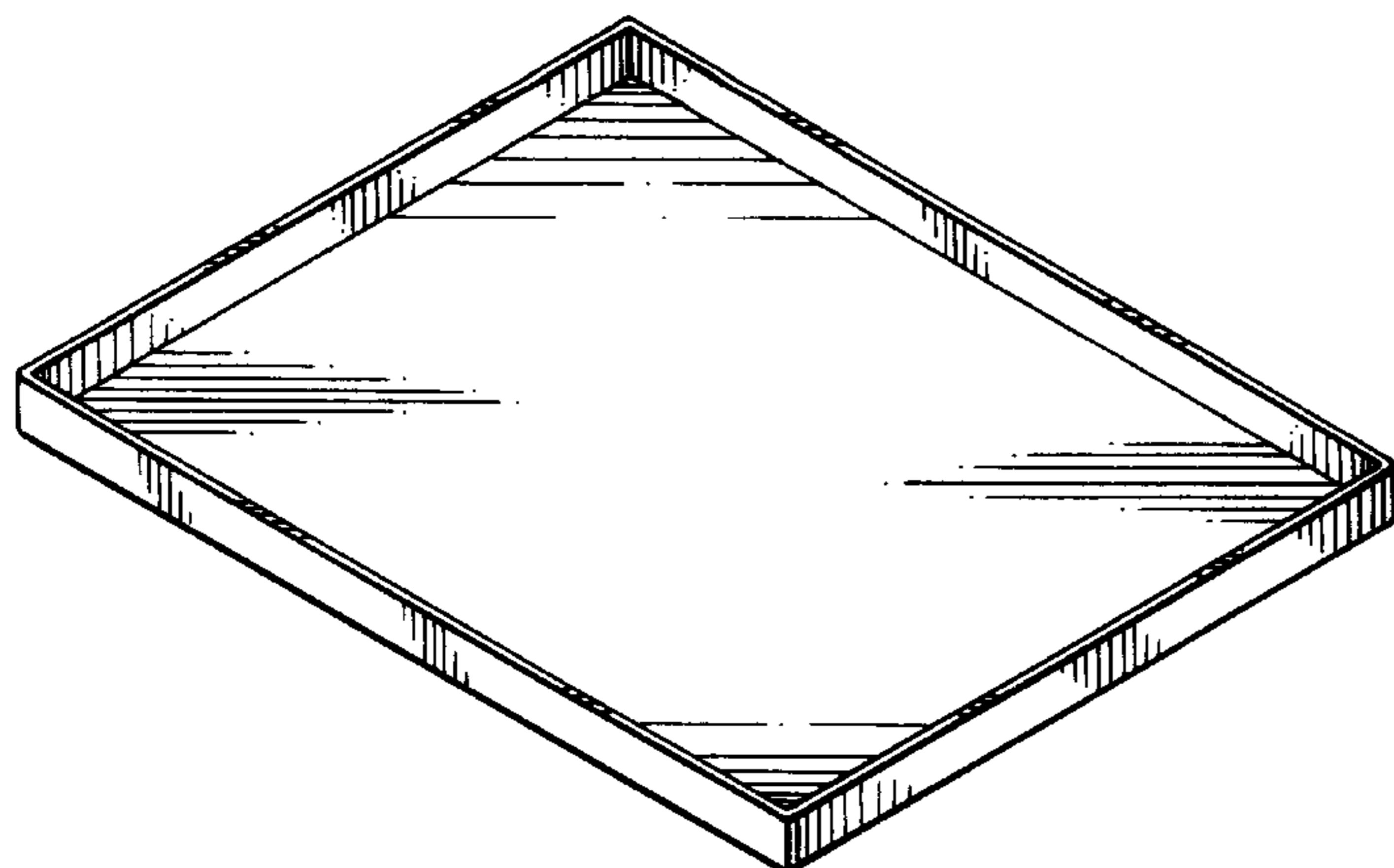
### [57] **CLAIM**

The ornamental design for a motorcycle tray, as shown.

### **DESCRIPTION**

FIG. 1 is an isometric view of a motorcycle tray incorporating our new design;  
FIG. 2 is a top view of the motorcycle tray shown in FIG. 1;  
FIG. 3 is a side view of the motorcycle tray shown in FIG. 1;  
FIG. 4 is a bottom view of the motorcycle tray shown in FIG. 1;  
FIG. 5 is a left side view of the motorcycle tray shown in FIG. 1;  
FIG. 6 is a front end view of the motorcycle tray shown in FIG. 1; and,

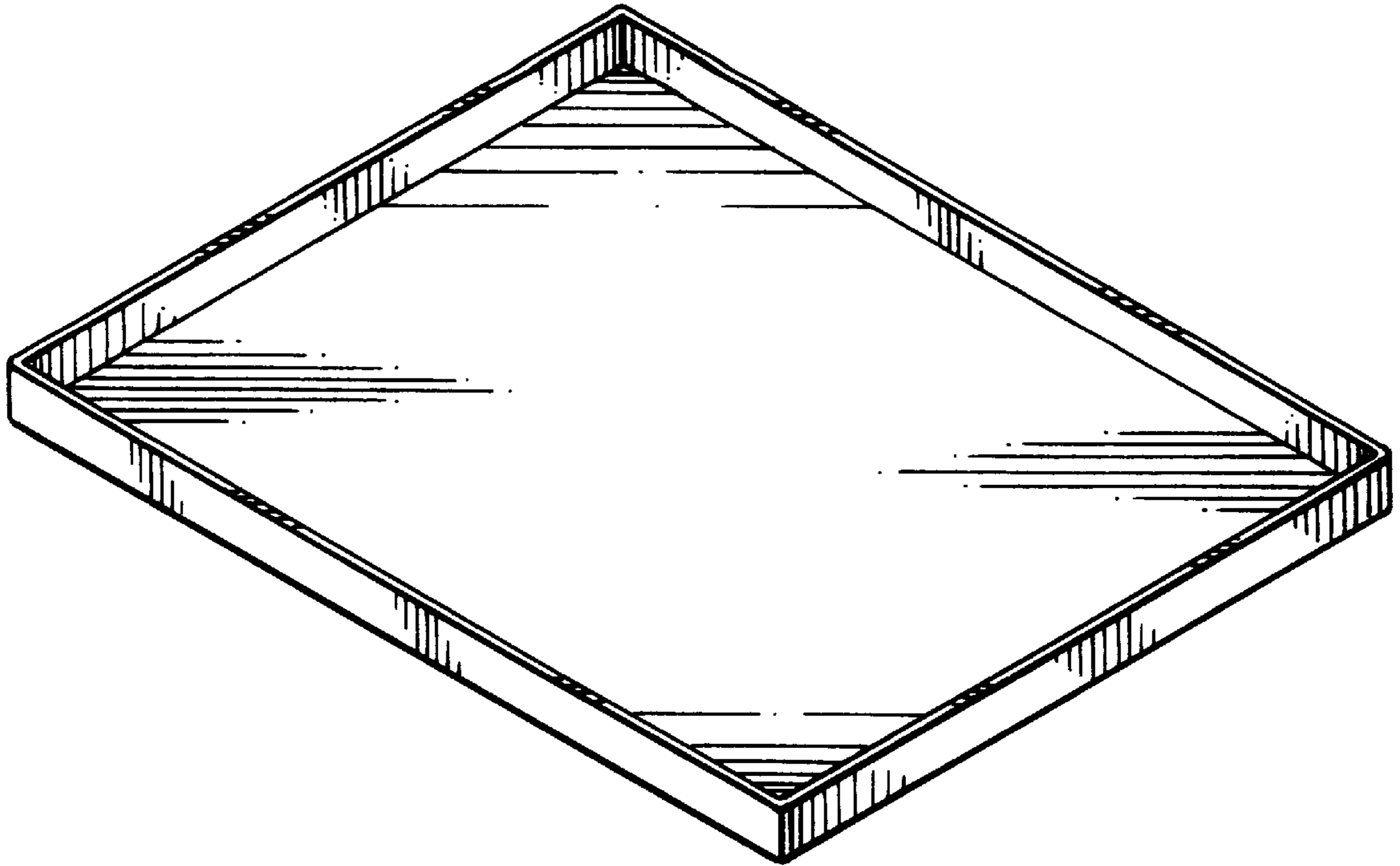

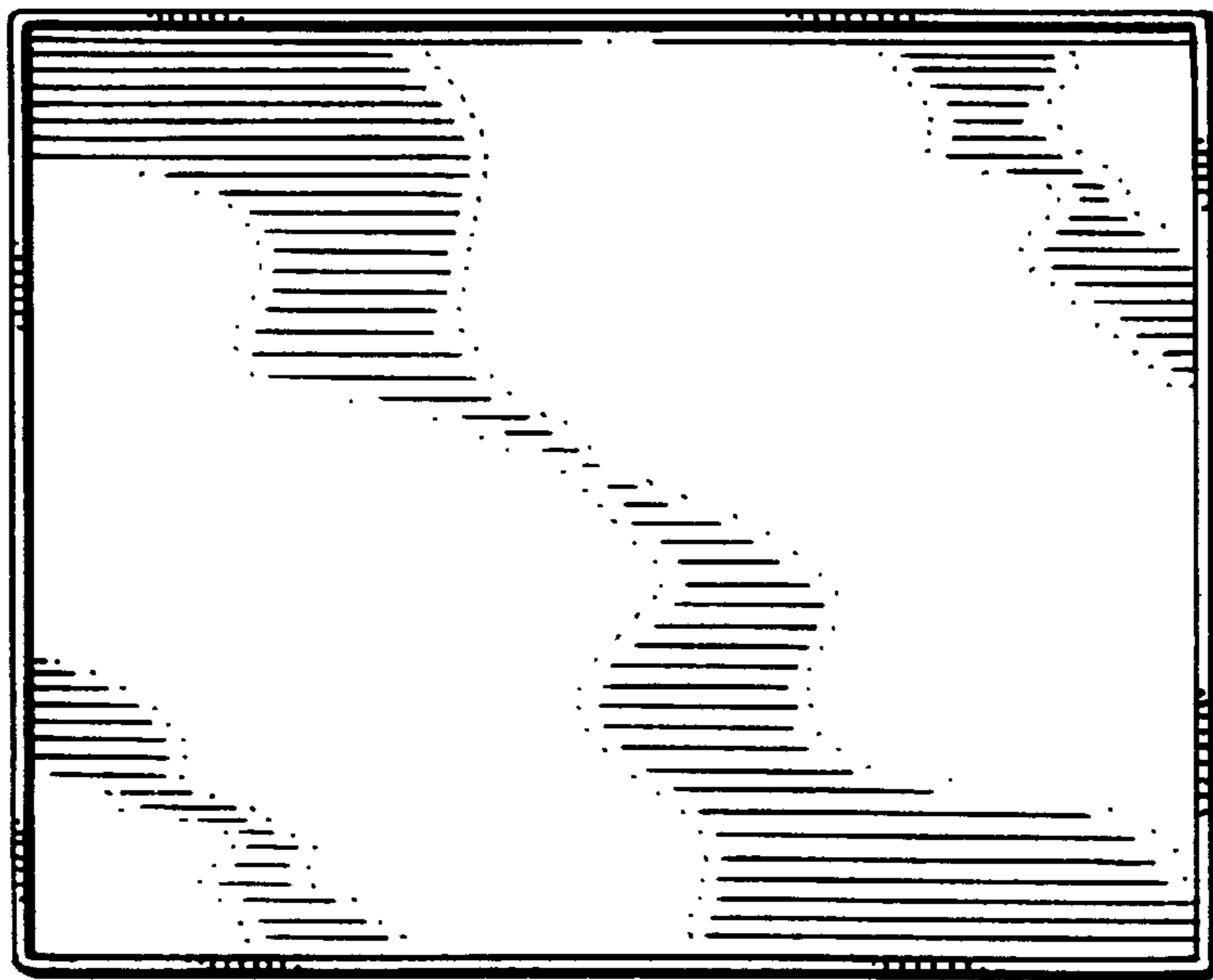

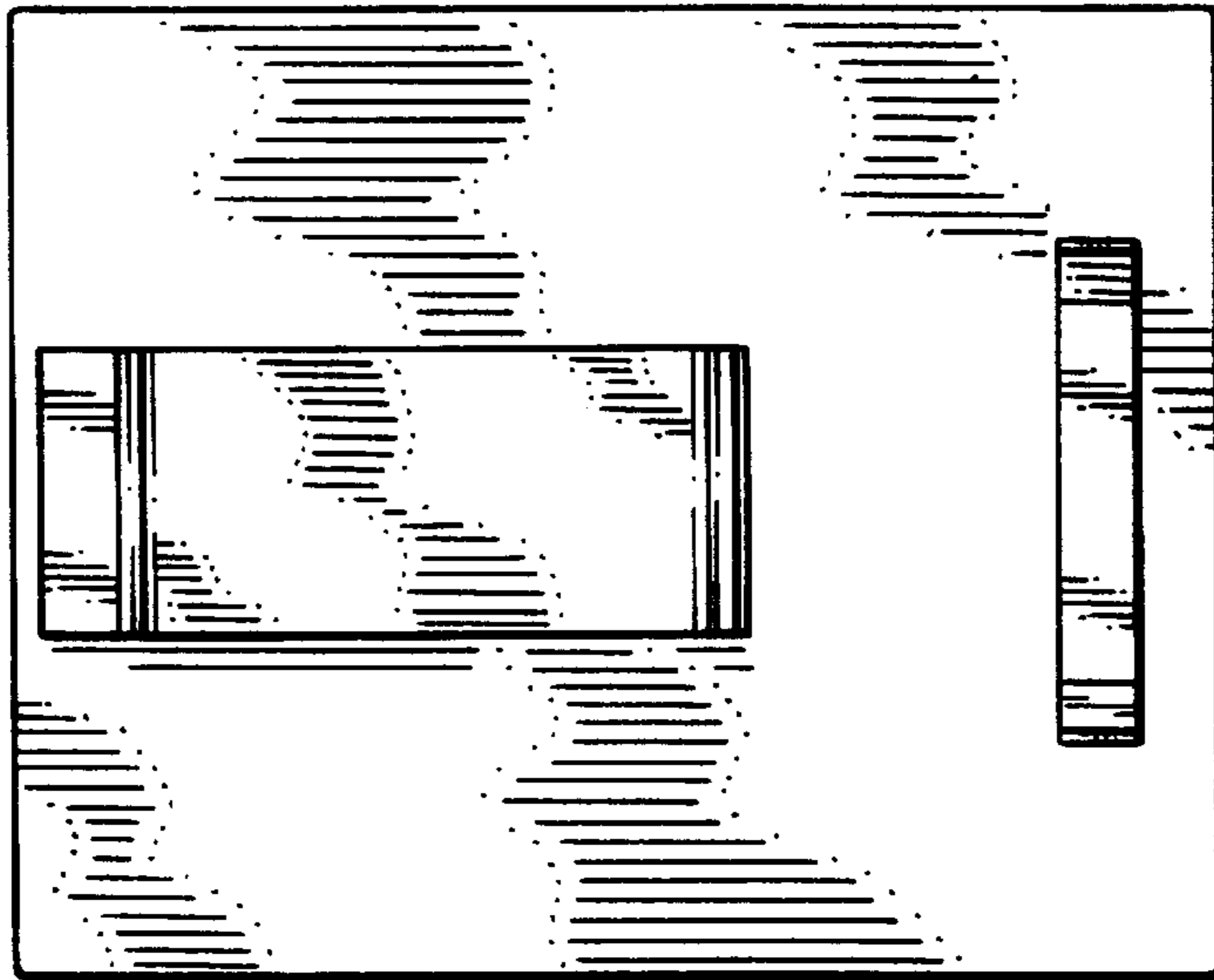
