### DESCRIPTION

FIG. 1 is a front view of a vial carrier according to the presently disclosed invention;  
FIG. 2 is a right-side view of the vial carrier of FIG. 1;  
FIG. 3 is a rear view of the vial carrier of FIG. 1;  
FIG. 4 is a left-side view of the vial carrier of FIG. 1;  
FIG. 5 is a top view of the vial carrier of FIG. 1;  
FIG. 6 is a bottom view of the vial carrier of FIG. 1; and,

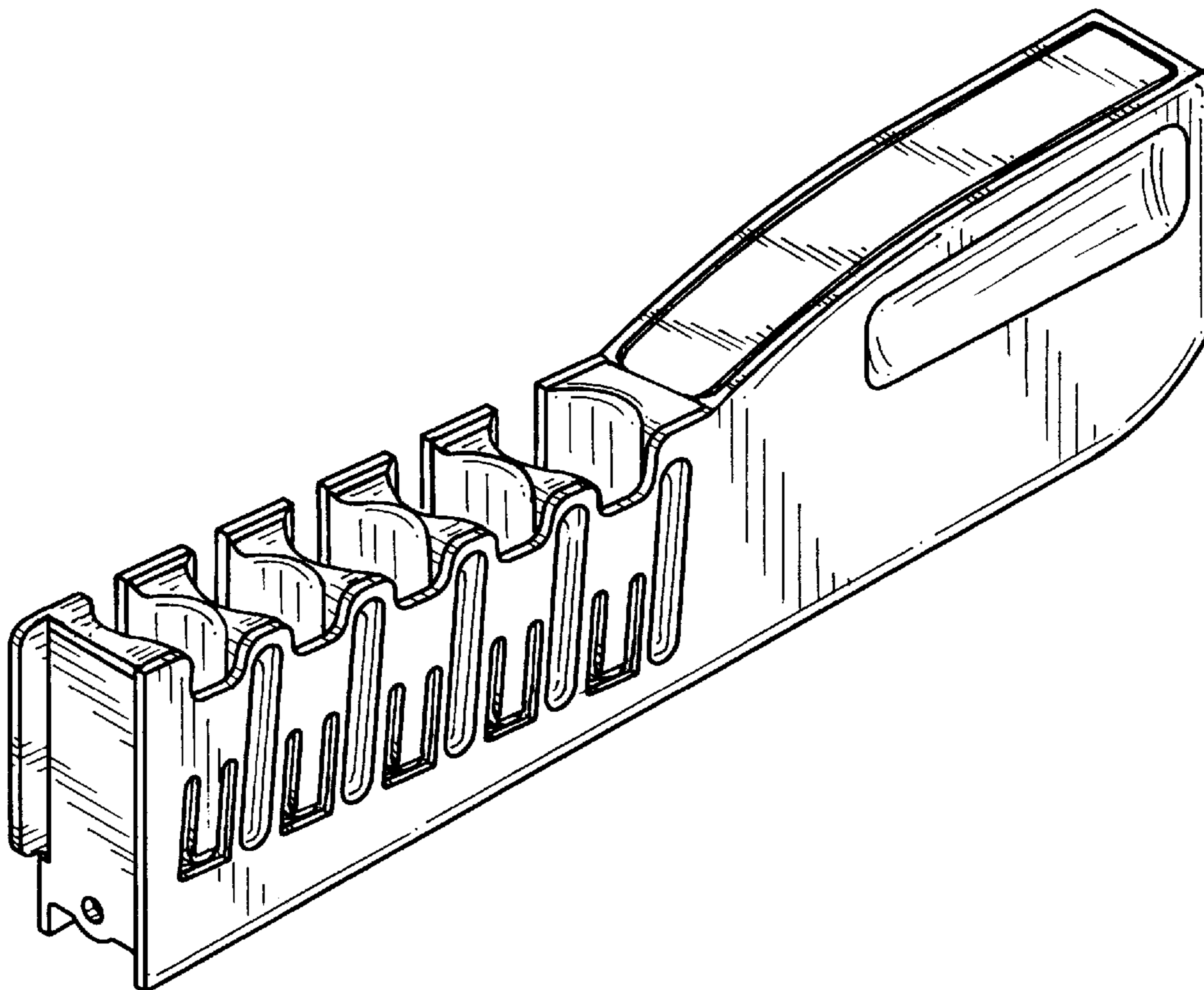

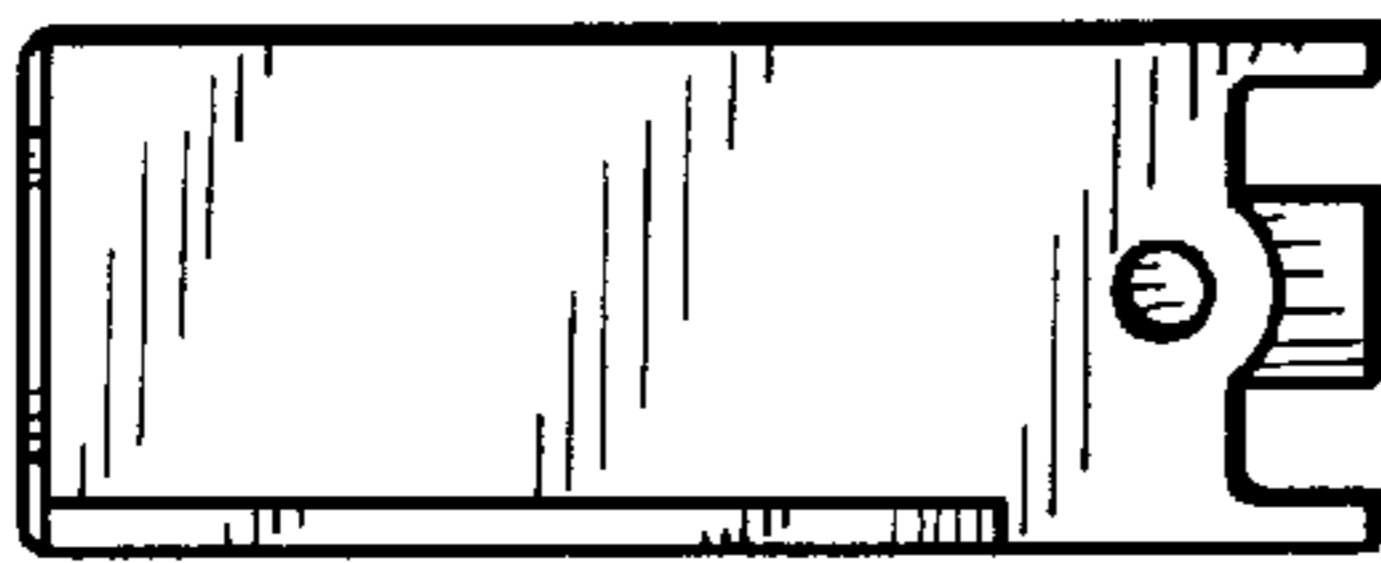

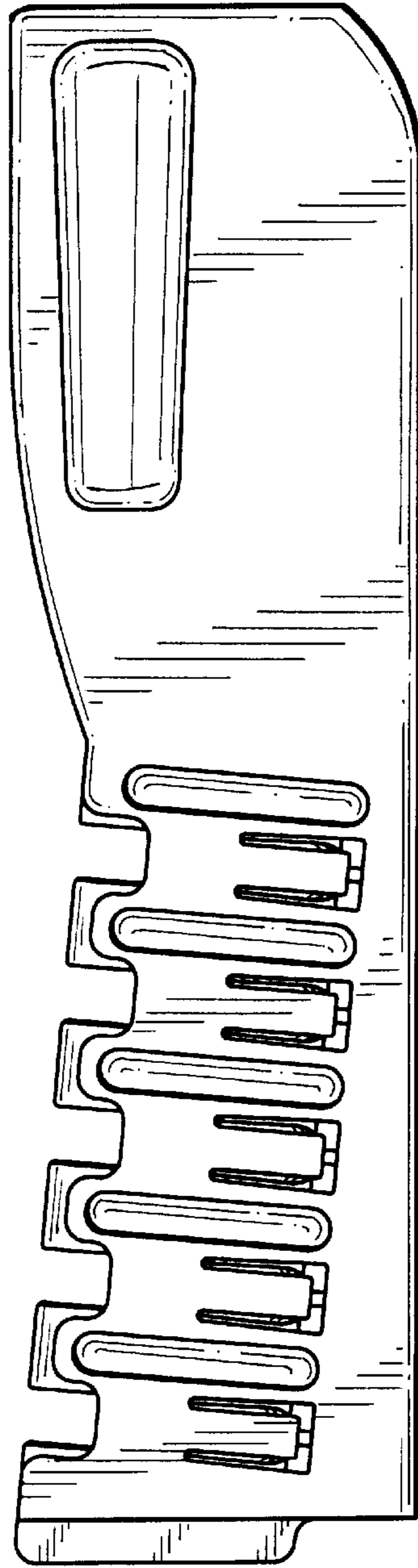

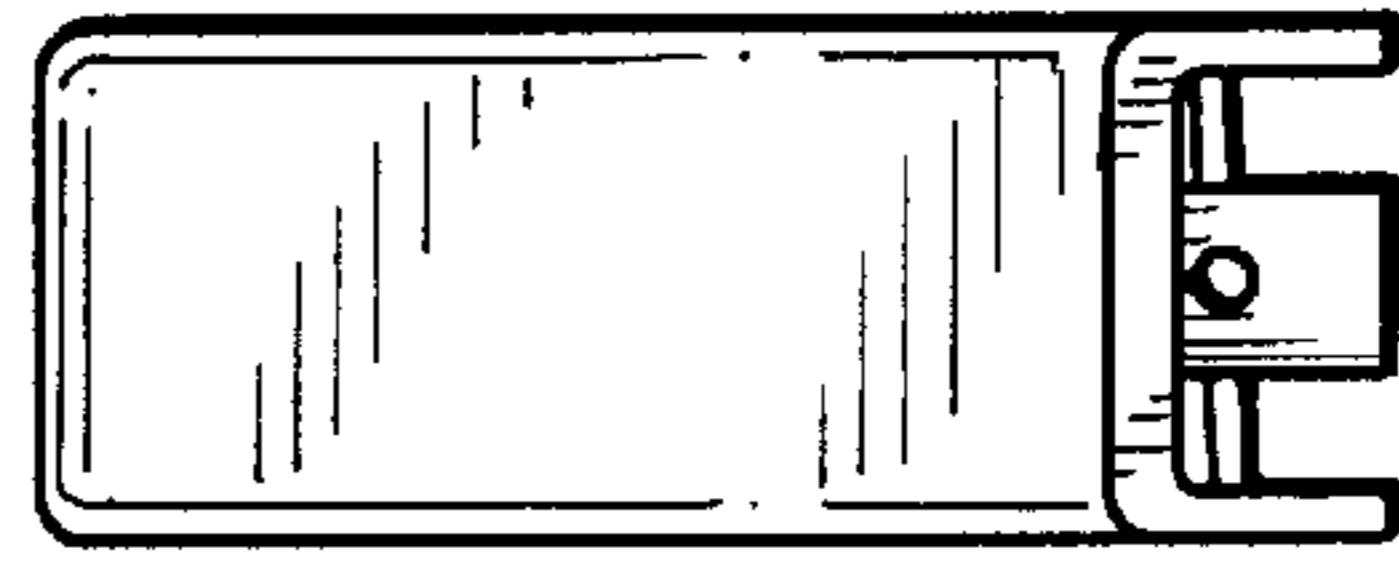

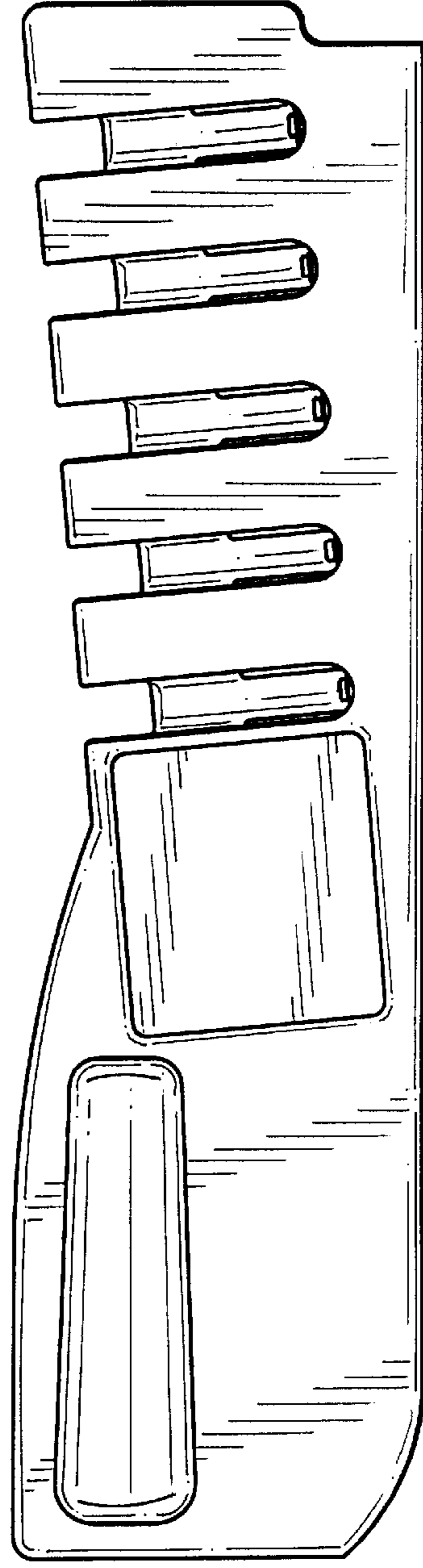

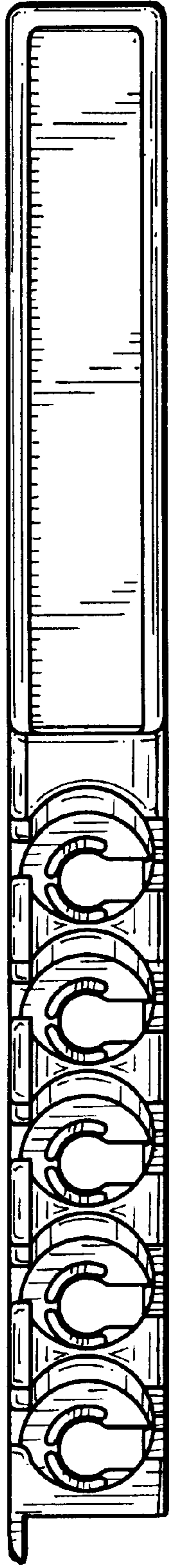
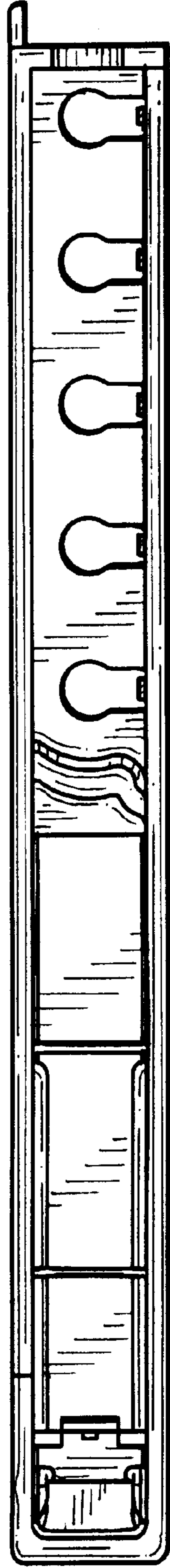

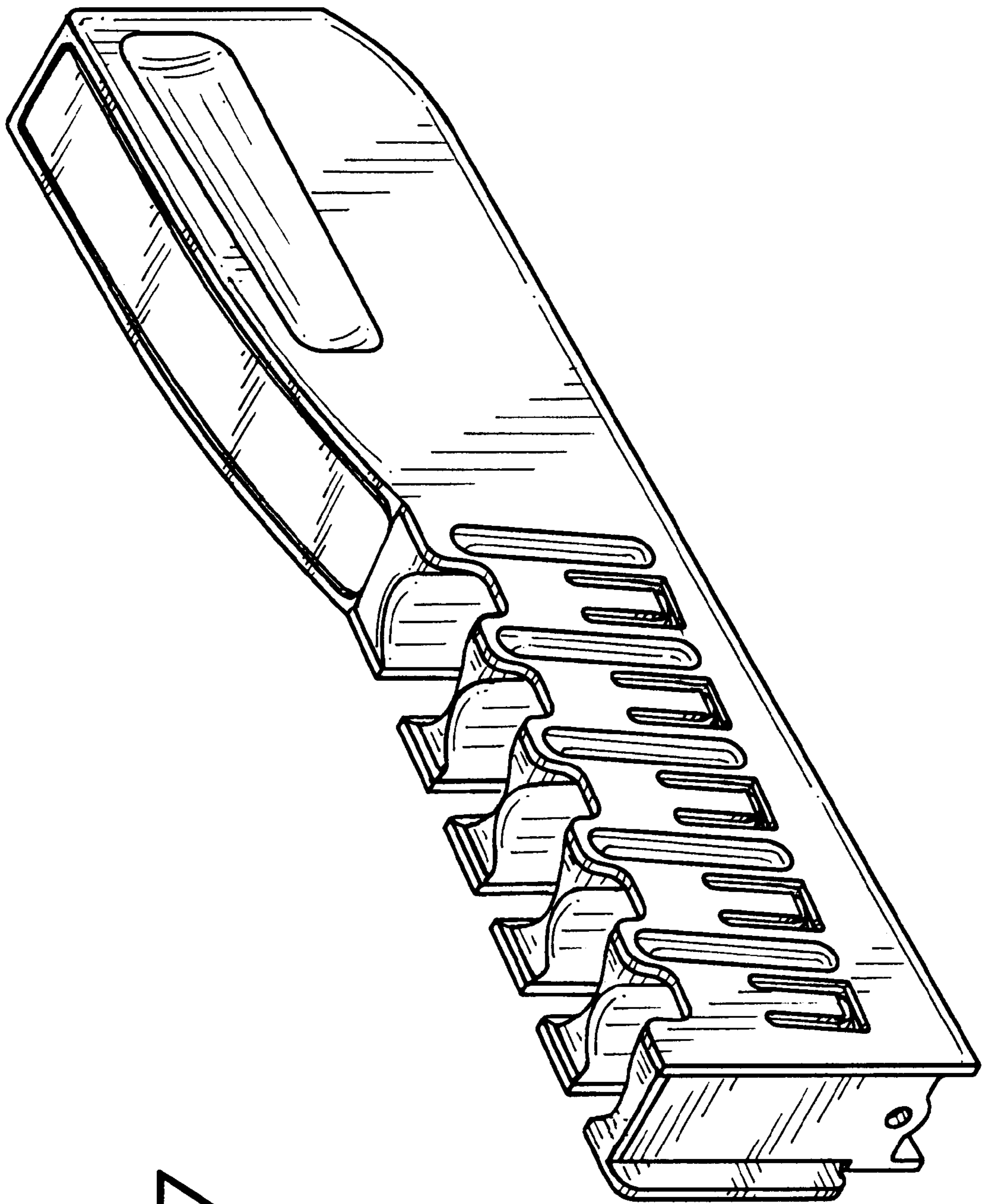
