[57] CLAIM

The ornamental design for a golf glove, as shown and described.

DESCRIPTION

FIG. 1 is a top view of the golf glove showing our new design;

FIG. 2 is a side elevational view thereof;

FIG. 3 is a front elevational view thereof; and,

FIG. 4 is a rear elevational view thereof.

The broken lines shown in the drawing are for illustrative purposes and form no part of the claimed design.

The fragmentary criss-cross pattern shown in the drawing is understood to represent fabric and is repeated uniformly throughout the areas shown.

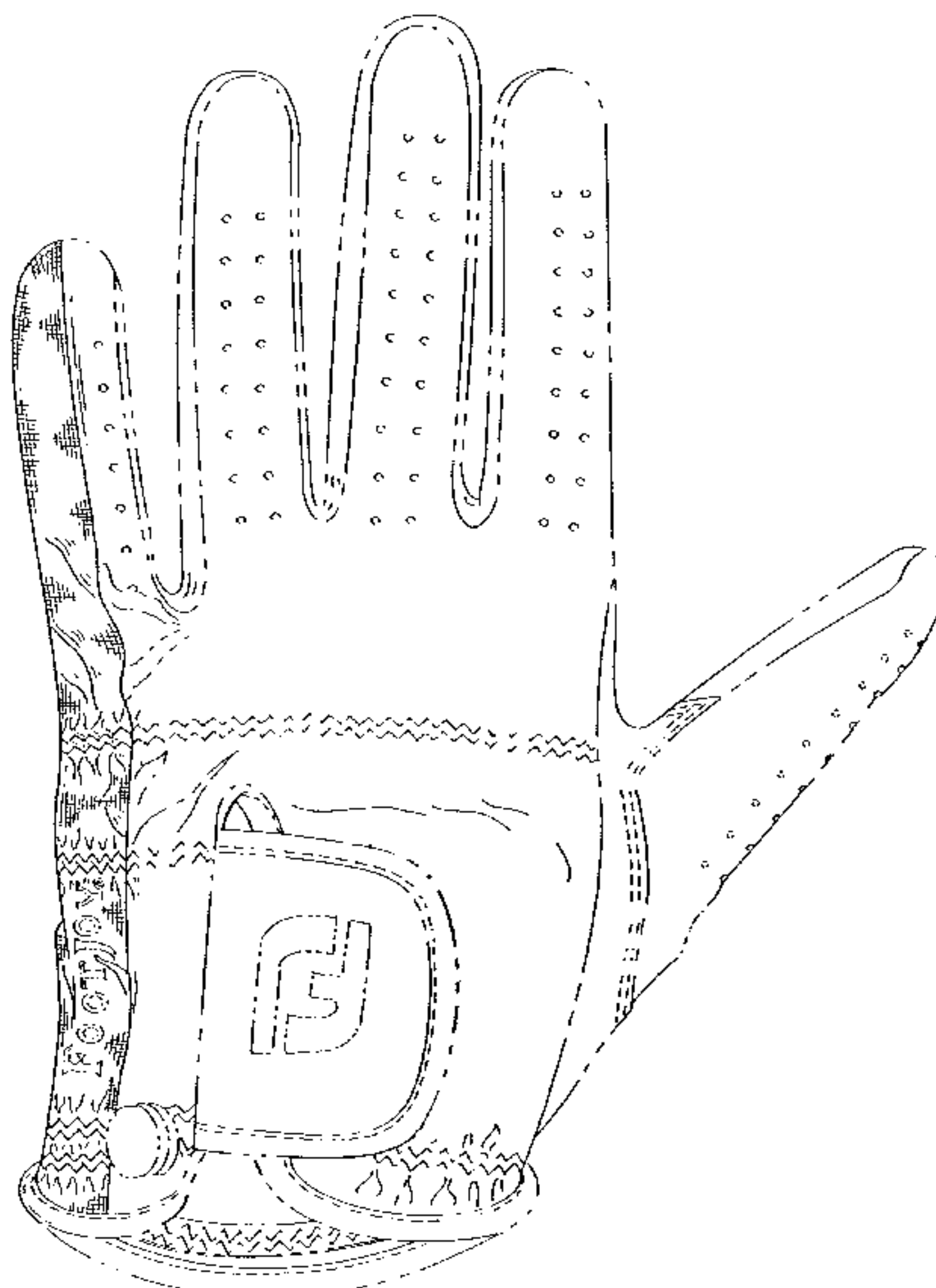

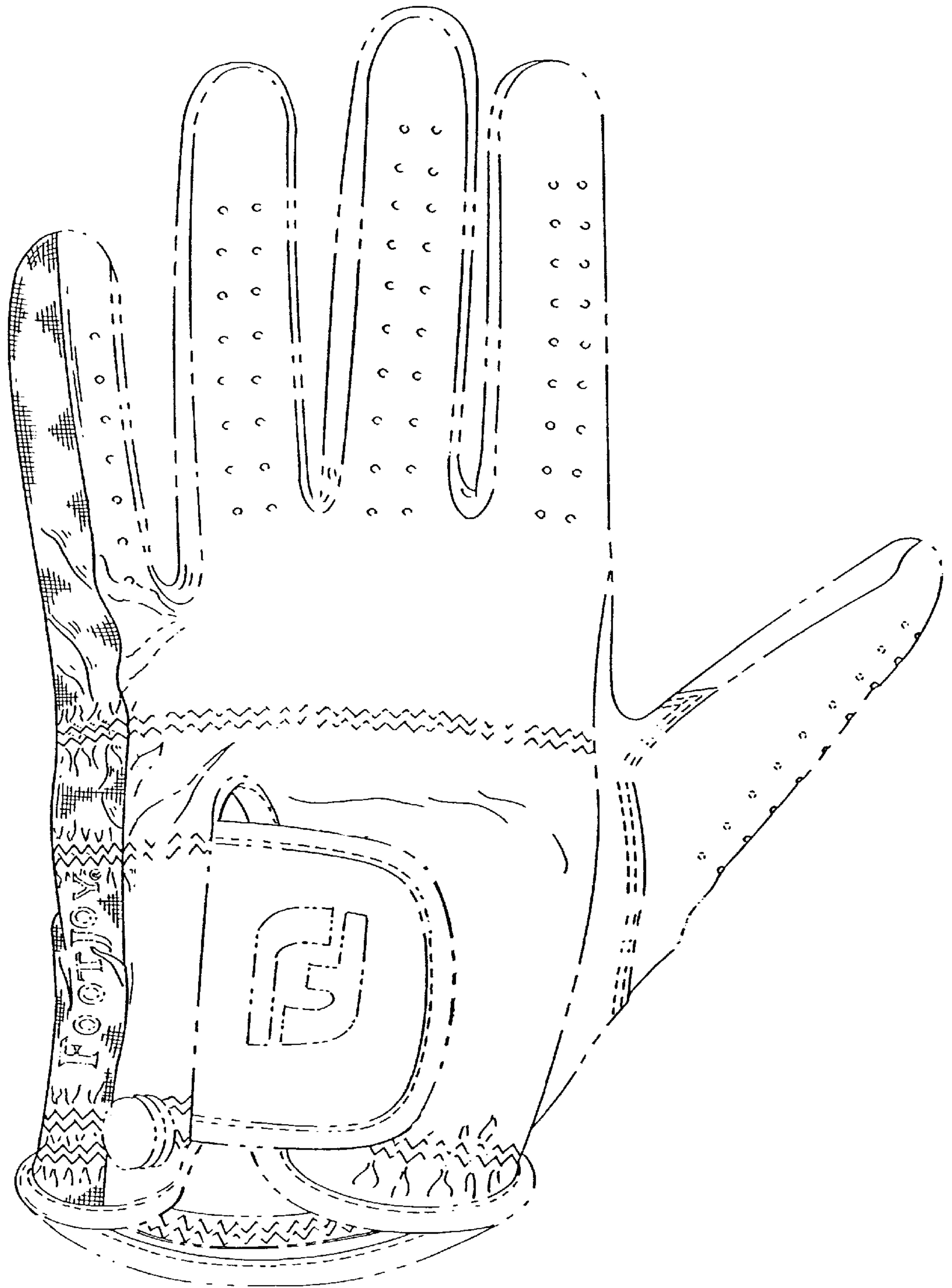
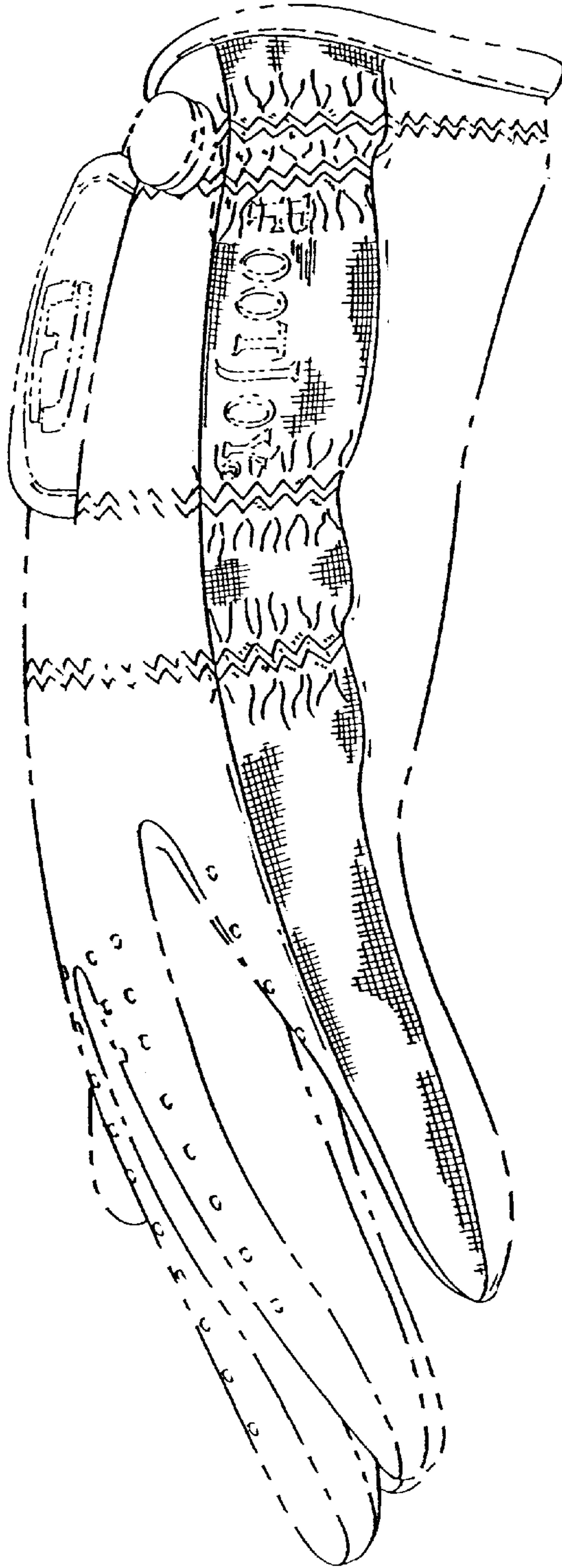

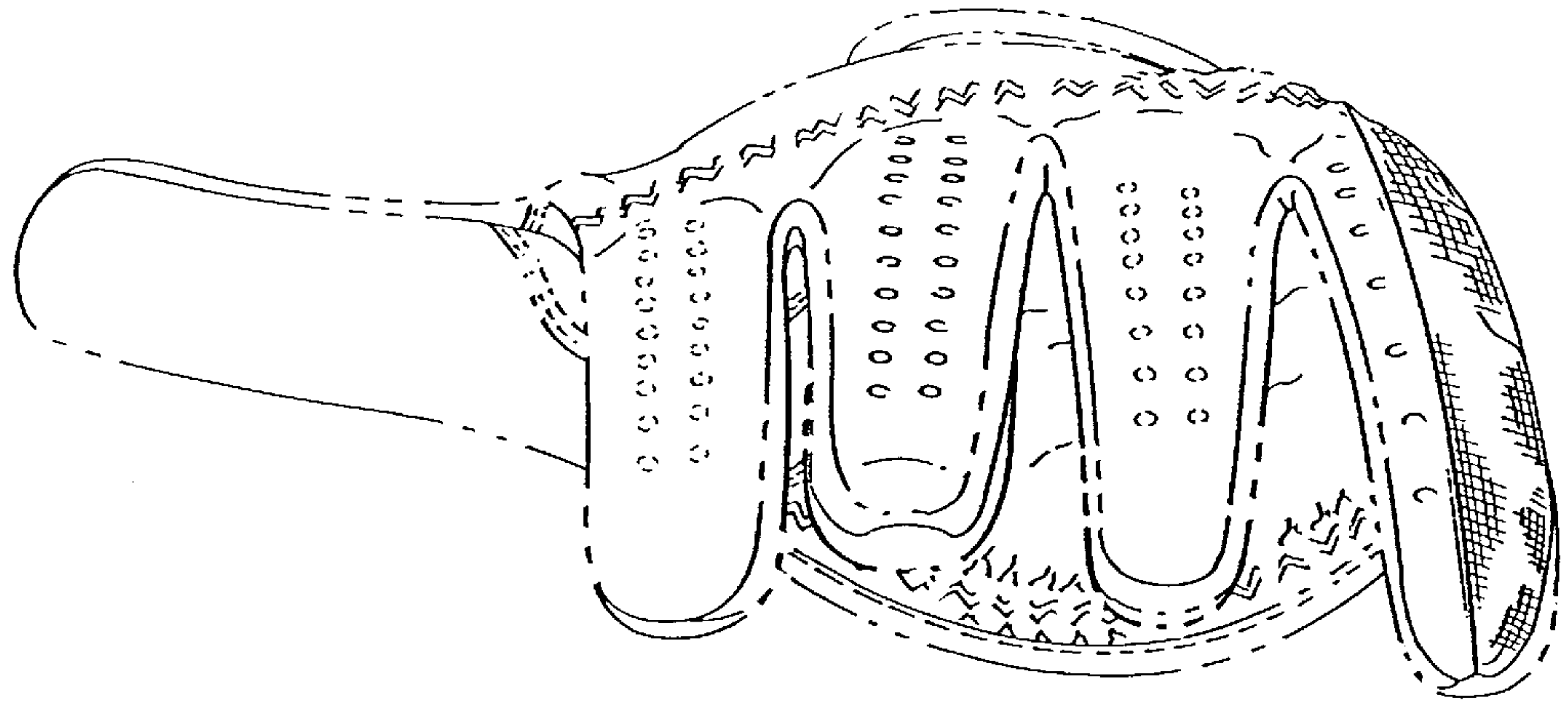

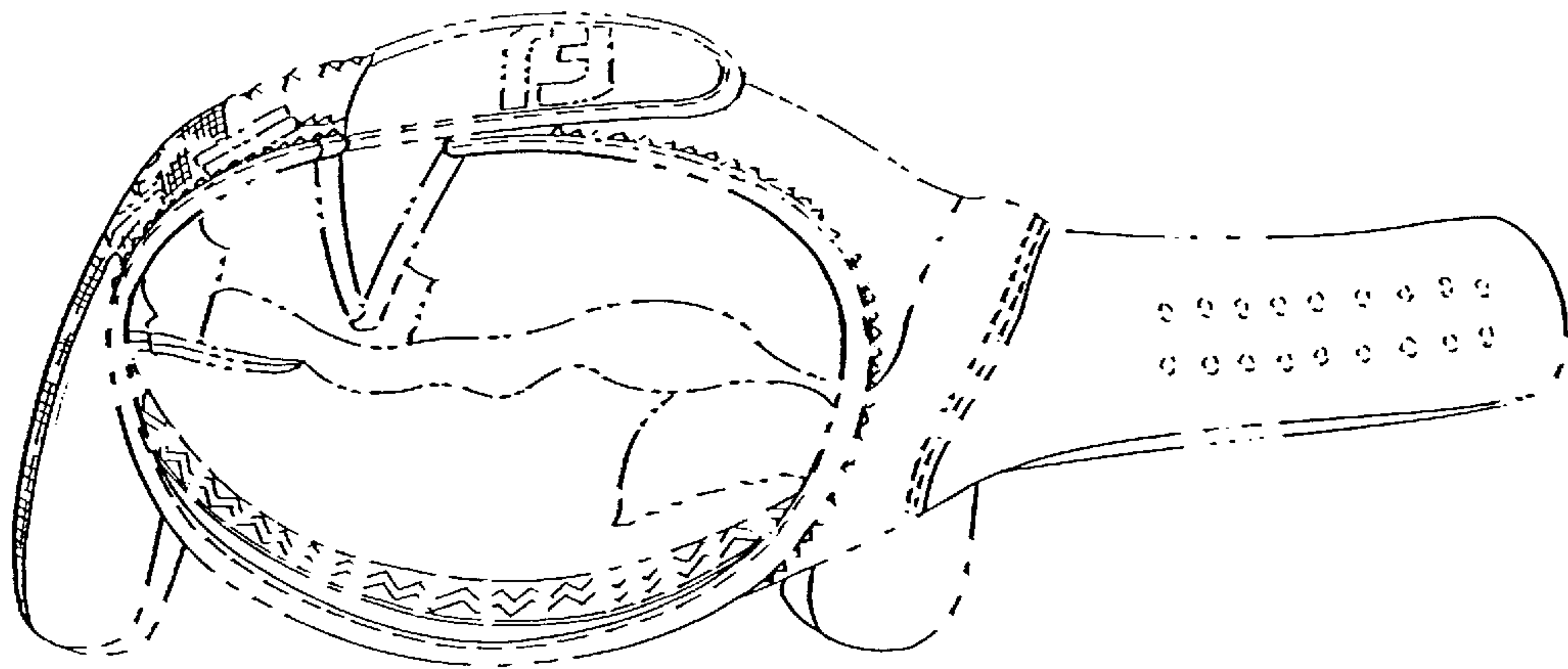
