### [57] CLAIM

The ornamental design for a slipper case with slippers, as shown and described.

### DESCRIPTION

FIG. 1 is a top plan view of a slipper case with slippers showing my new design, the bottom plan view being the mirror image thereof;

FIG. 2 is a right side elevation view thereof;

FIG. 3 is a left side elevation view thereof;

FIG. 4 is a rear elevation view thereof;

FIG. 5 is a front elevation view thereof;

FIG. 6 is a top plan view thereof with the case open showing the slippers inside;

FIG. 7 is a left side elevation view of FIG. 6, the right side elevation view being the mirror image thereof;

FIG. 8 is a front elevation view of FIG. 6;

FIG. 9 is a bottom plan view of FIG. 6;

FIG. 10 is a rear elevation view of FIG. 6;

FIG. 11 is a top plan view of a second embodiment with the case open showing open toed slippers inside;

FIG. 12 is a left side elevation view of FIG. 11, the right side elevation view being the mirror image thereof;

FIG. 13 is a front elevation view of FIG. 11;

FIG. 14 is a bottom plan view of FIG. 11;

FIG. 15 is a rear elevation view of FIG. 11;

FIG. 16 is a top plan view of the case open without any slippers inside;

FIG. 17 is a left side elevation view of FIG. 16, the right side elevation view being the mirror image thereof;

FIG. 18 is a front elevation view of FIG. 16;

FIG. 19 is a bottom plan view of FIG. 16; and

FIG. 20 is a rear elevation view of FIG. 16.

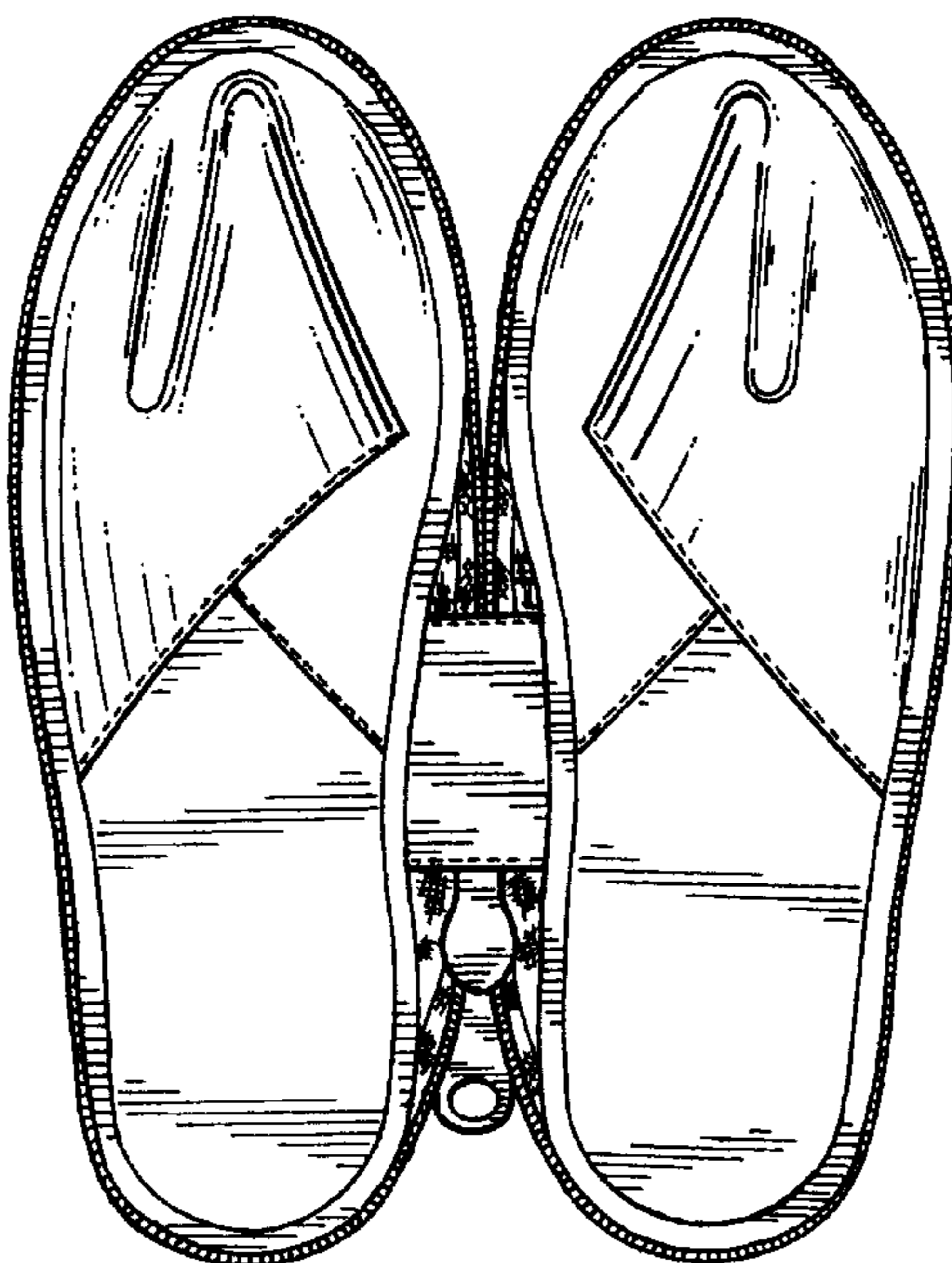

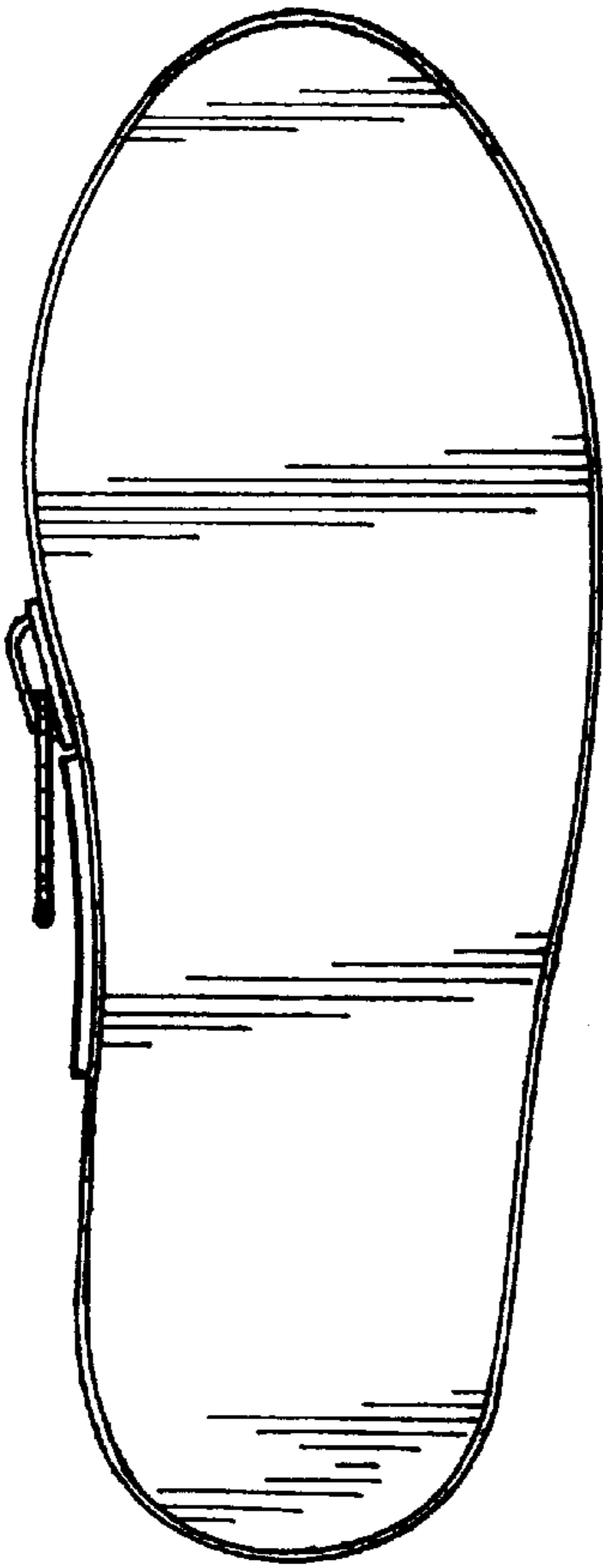

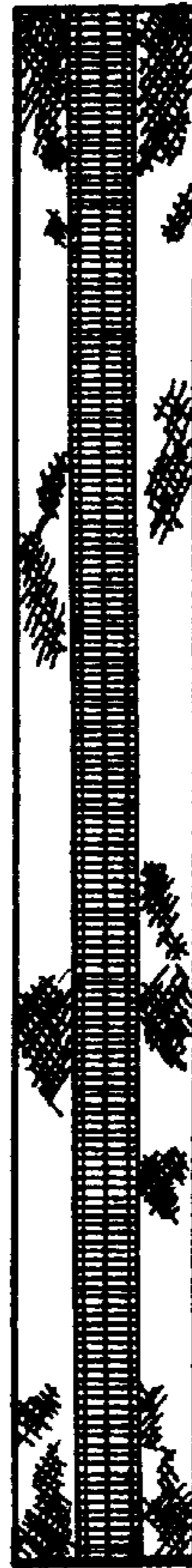

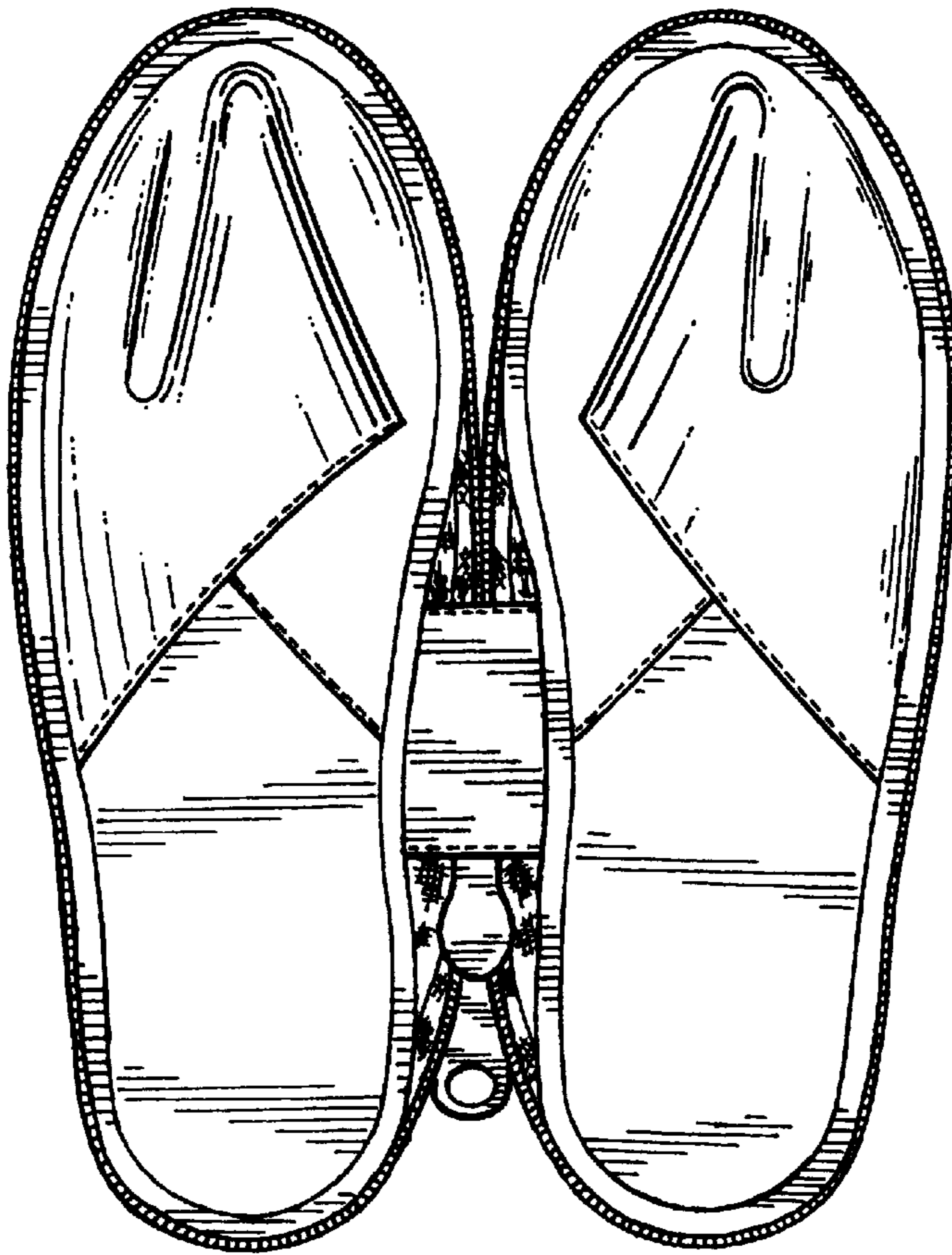

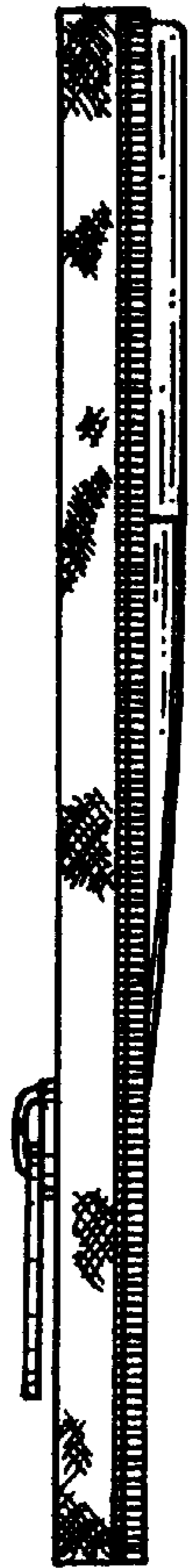

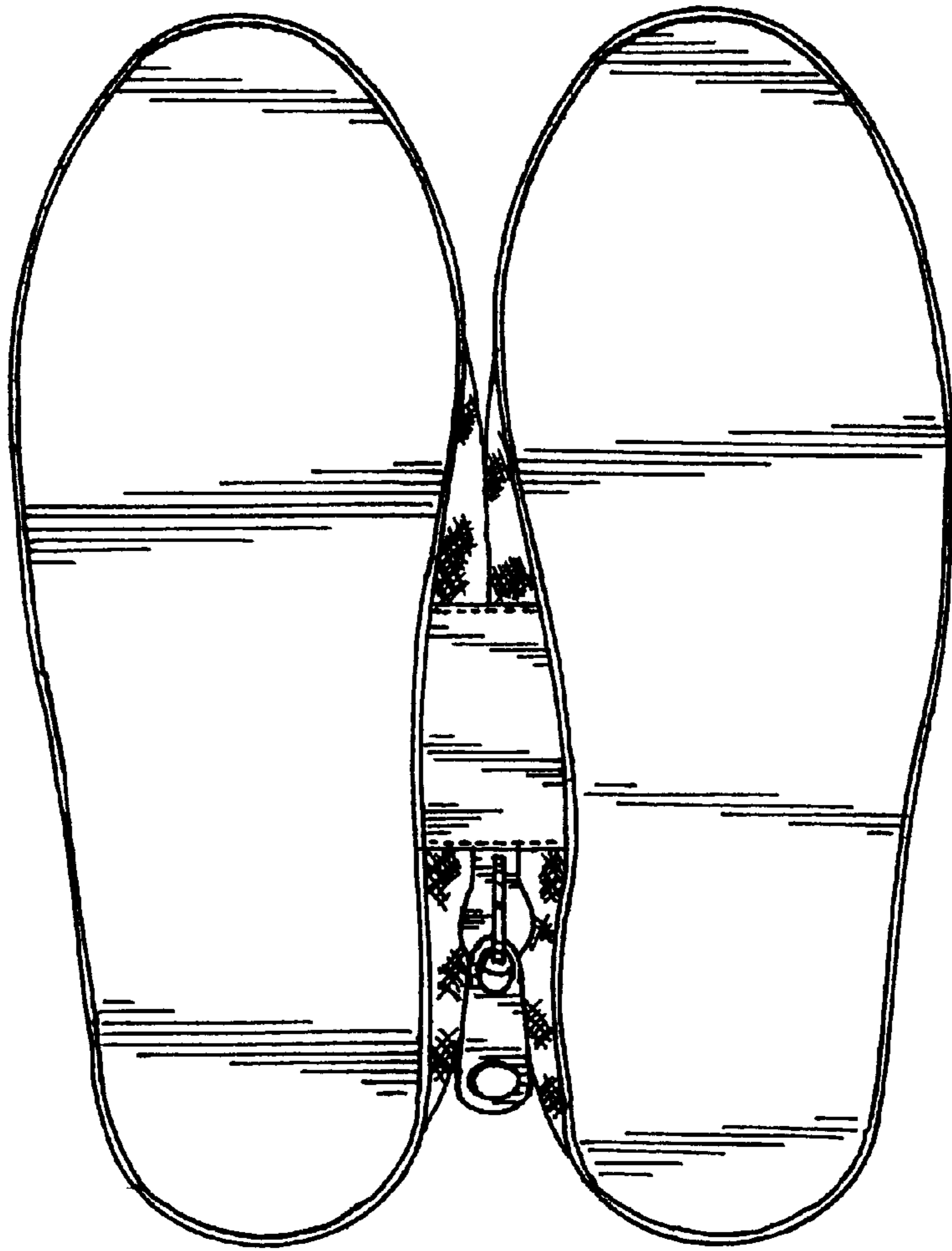

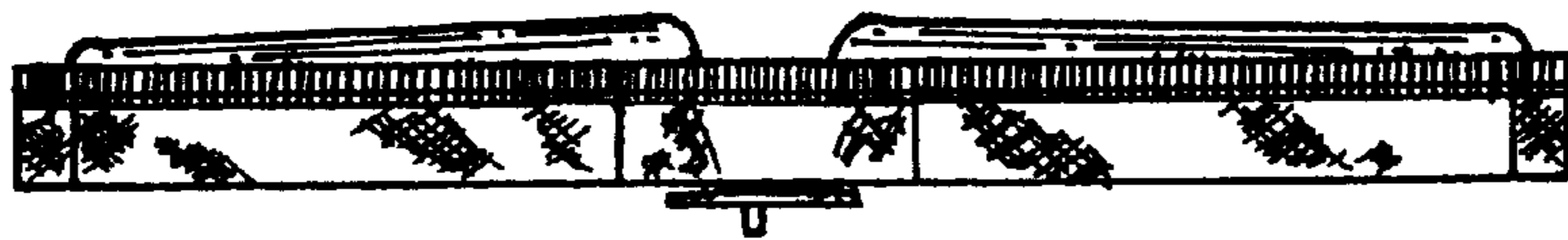

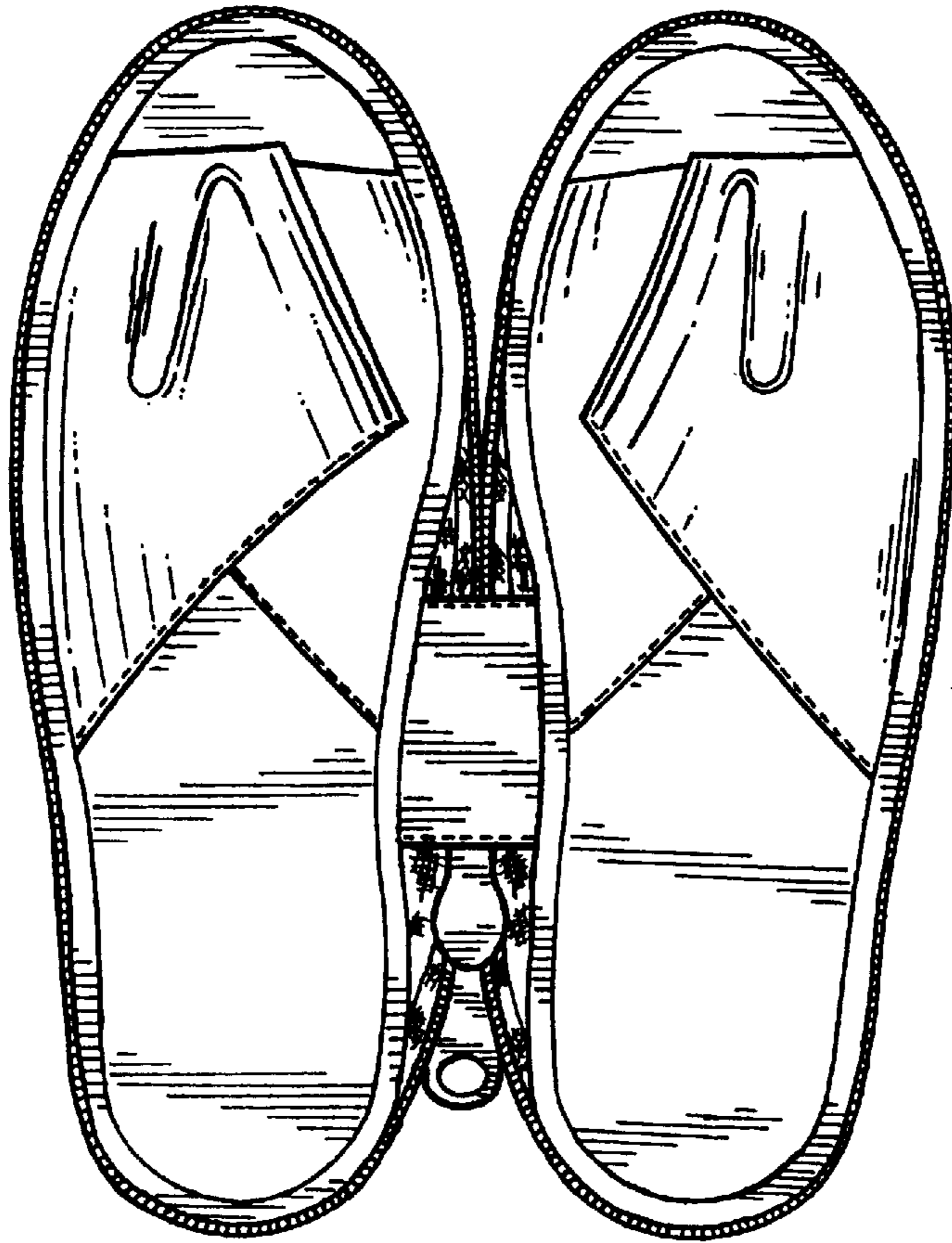

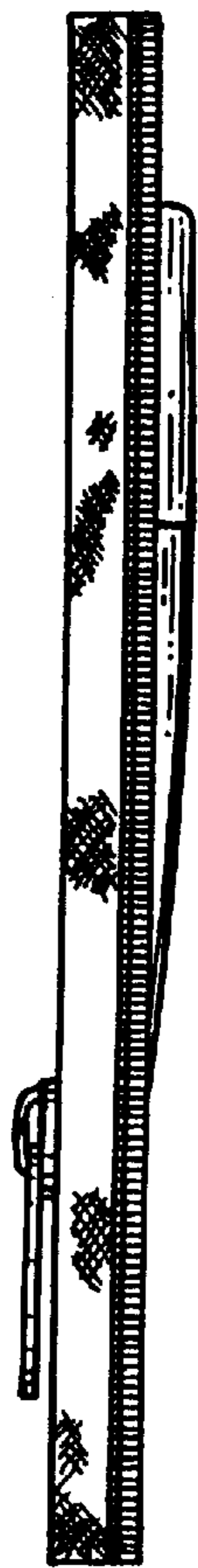

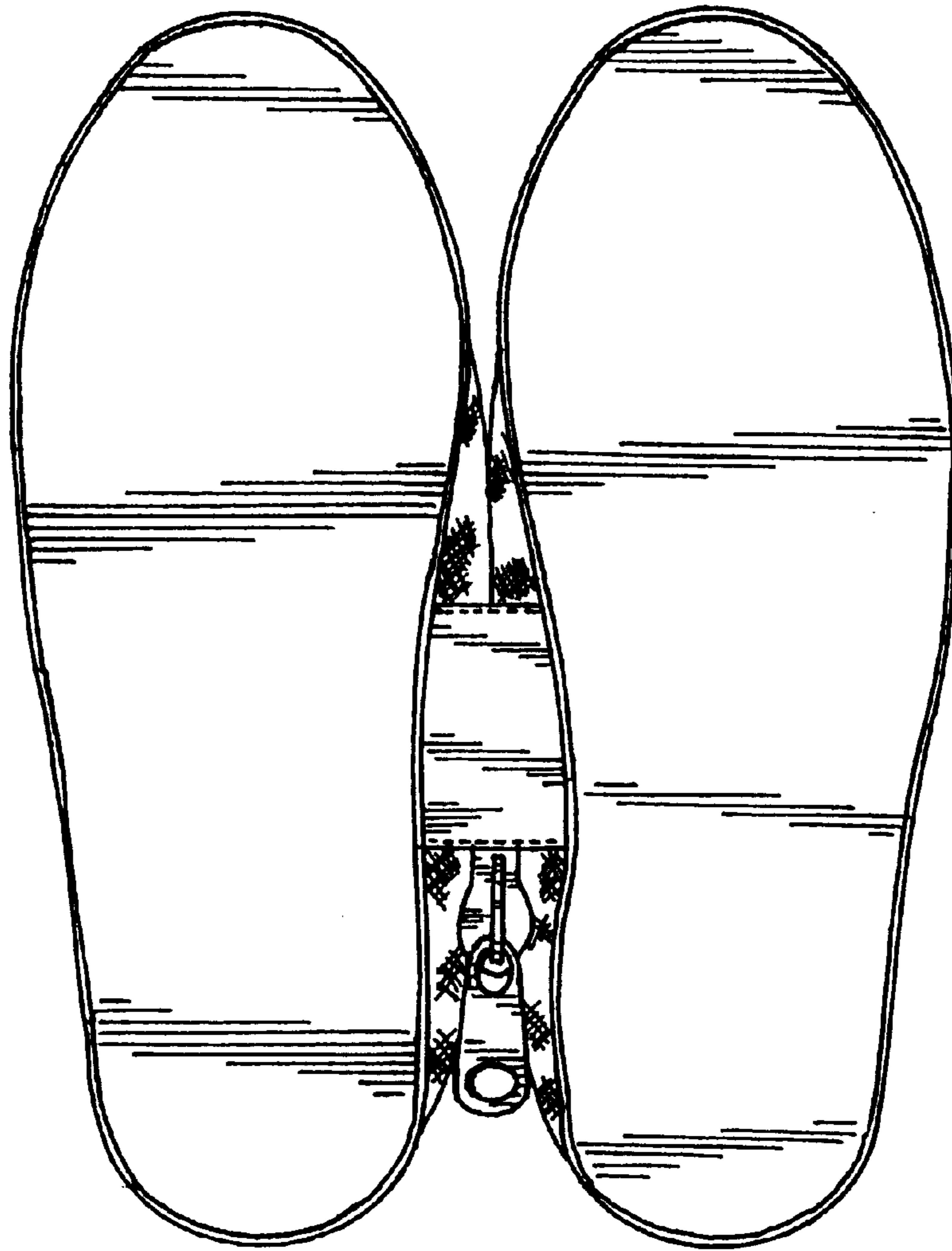

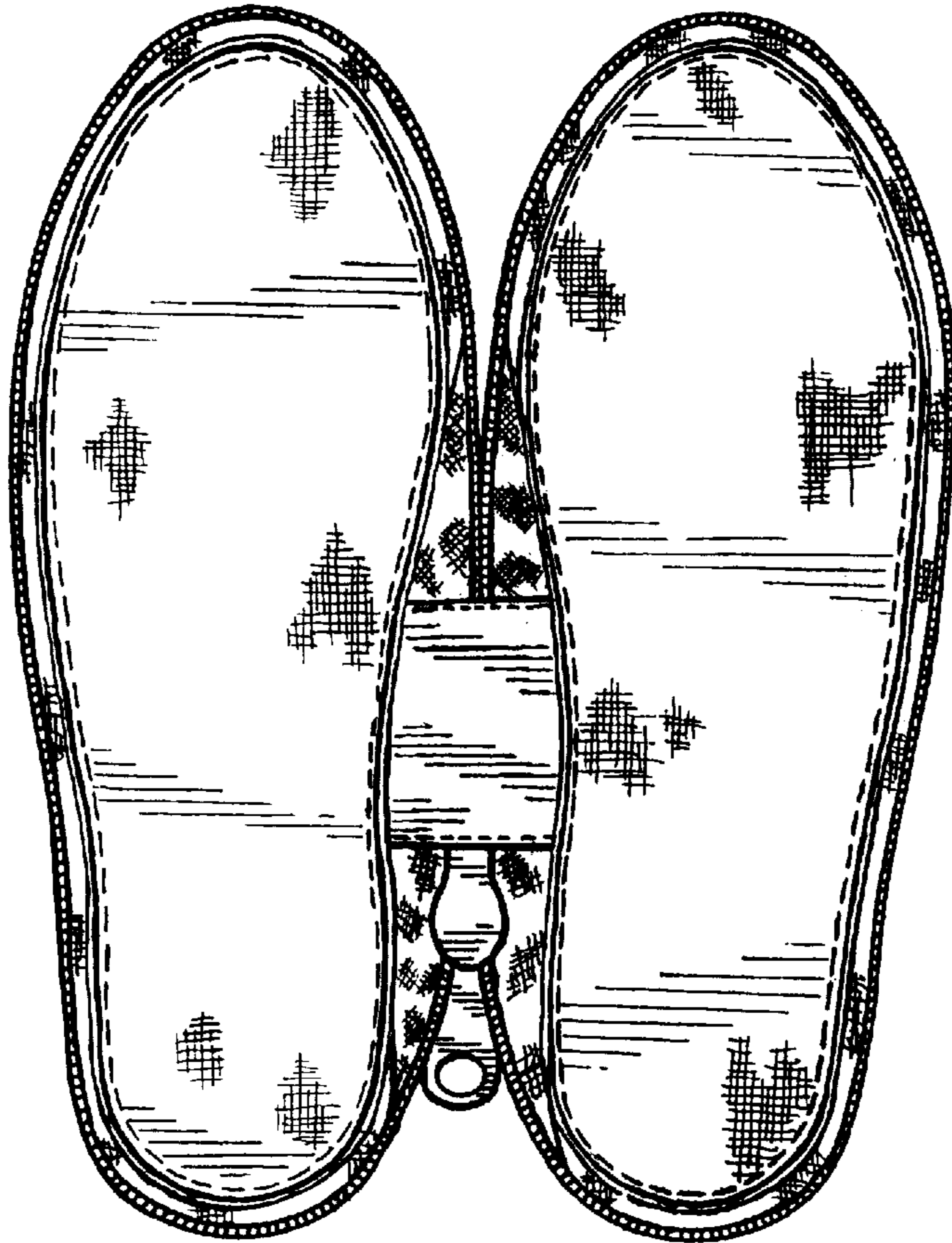

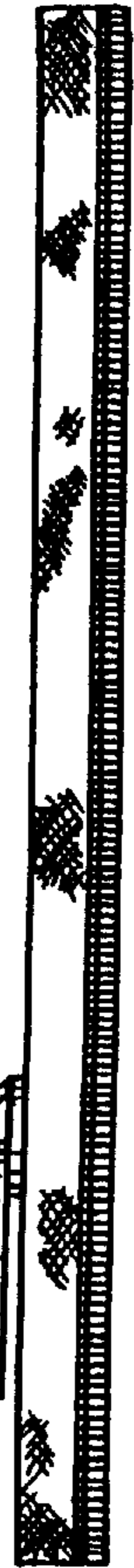

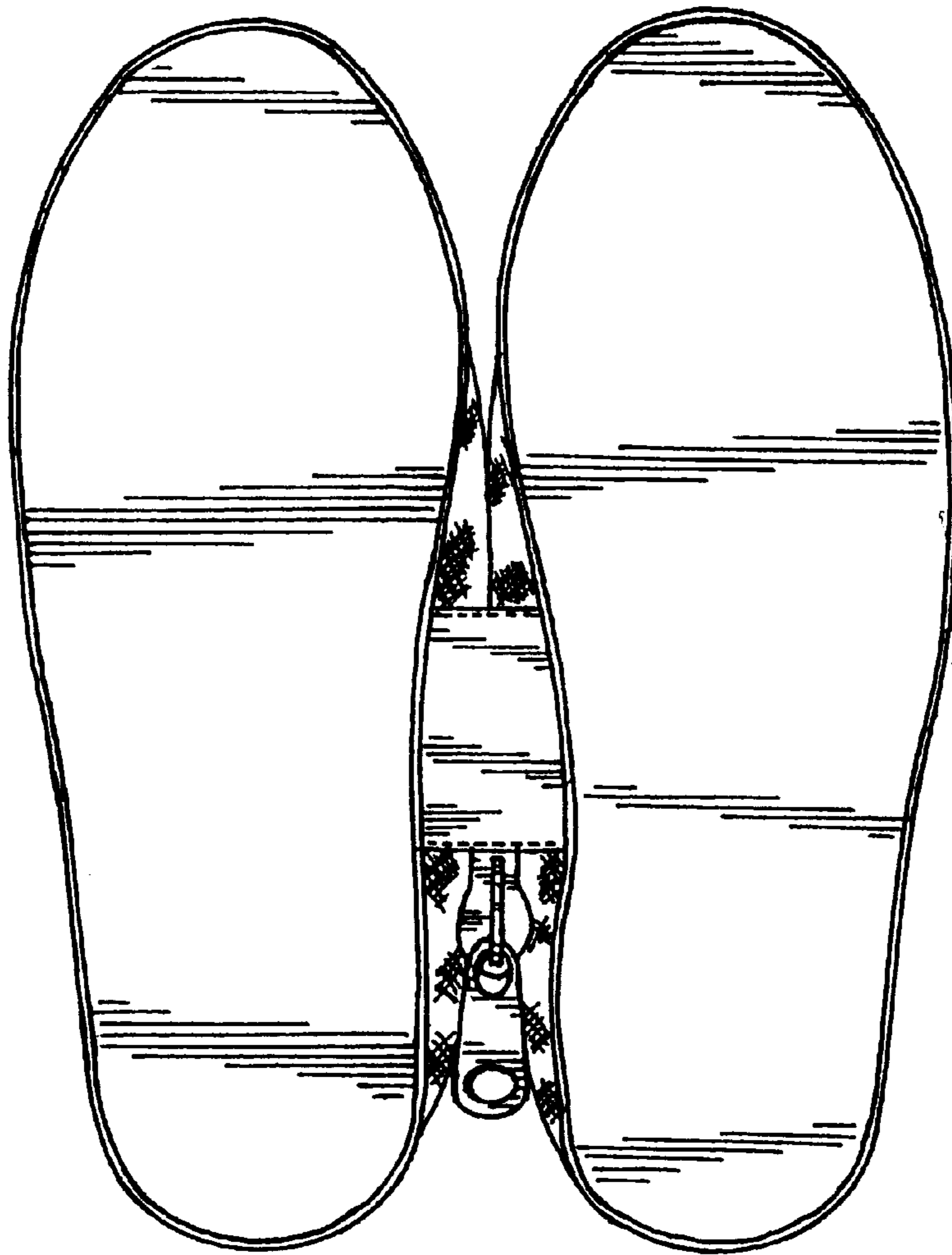
