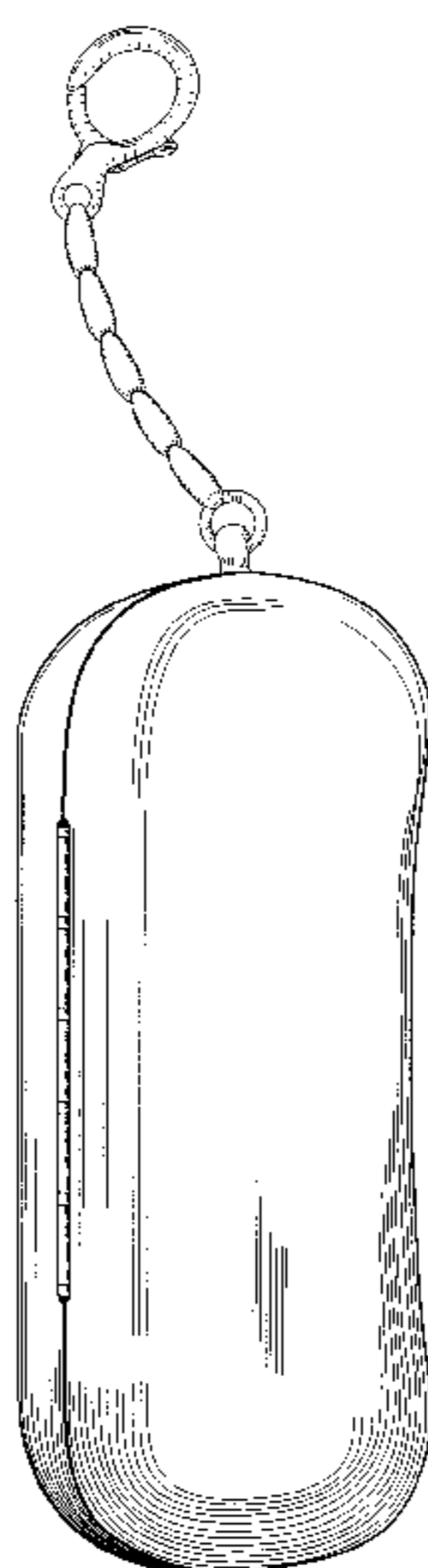
[57] **CLAIM**

The ornamental design for a waist attaching organizer for personal items, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the waist attaching organizer for personal items showing my new design in an open position;
 FIG. 2 is a front perspective view, with the environmental objects removed;
 FIG. 3 is a front and left side view;
 FIG. 4 is a rear and right side view;
 FIG. 5 is a top plan view; and,
 FIG. 6 is a bottom plan view.
 The broken line showing of environment in FIG. 1 is for illustrative purposes only and forms no part of the claimed design.

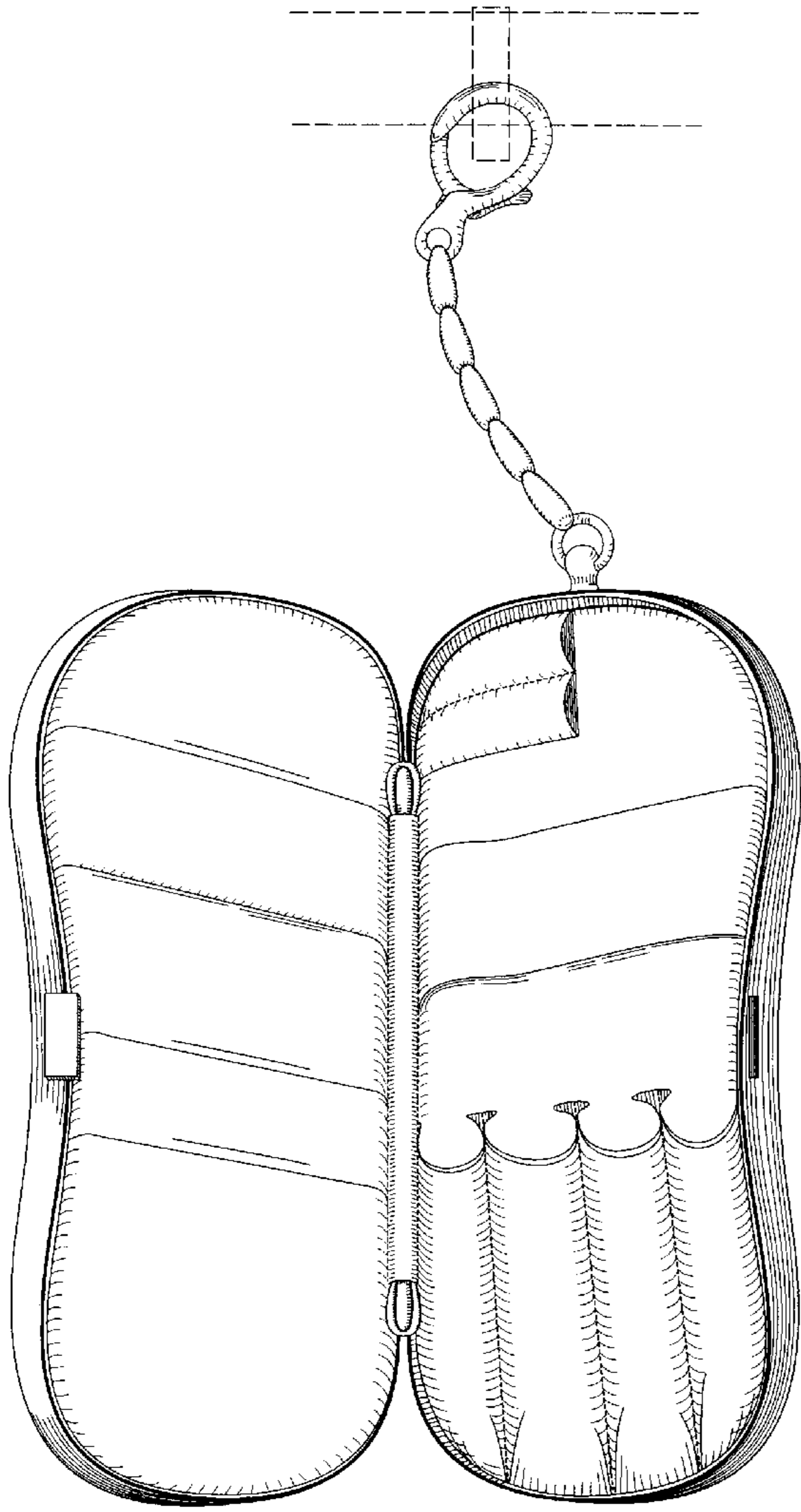

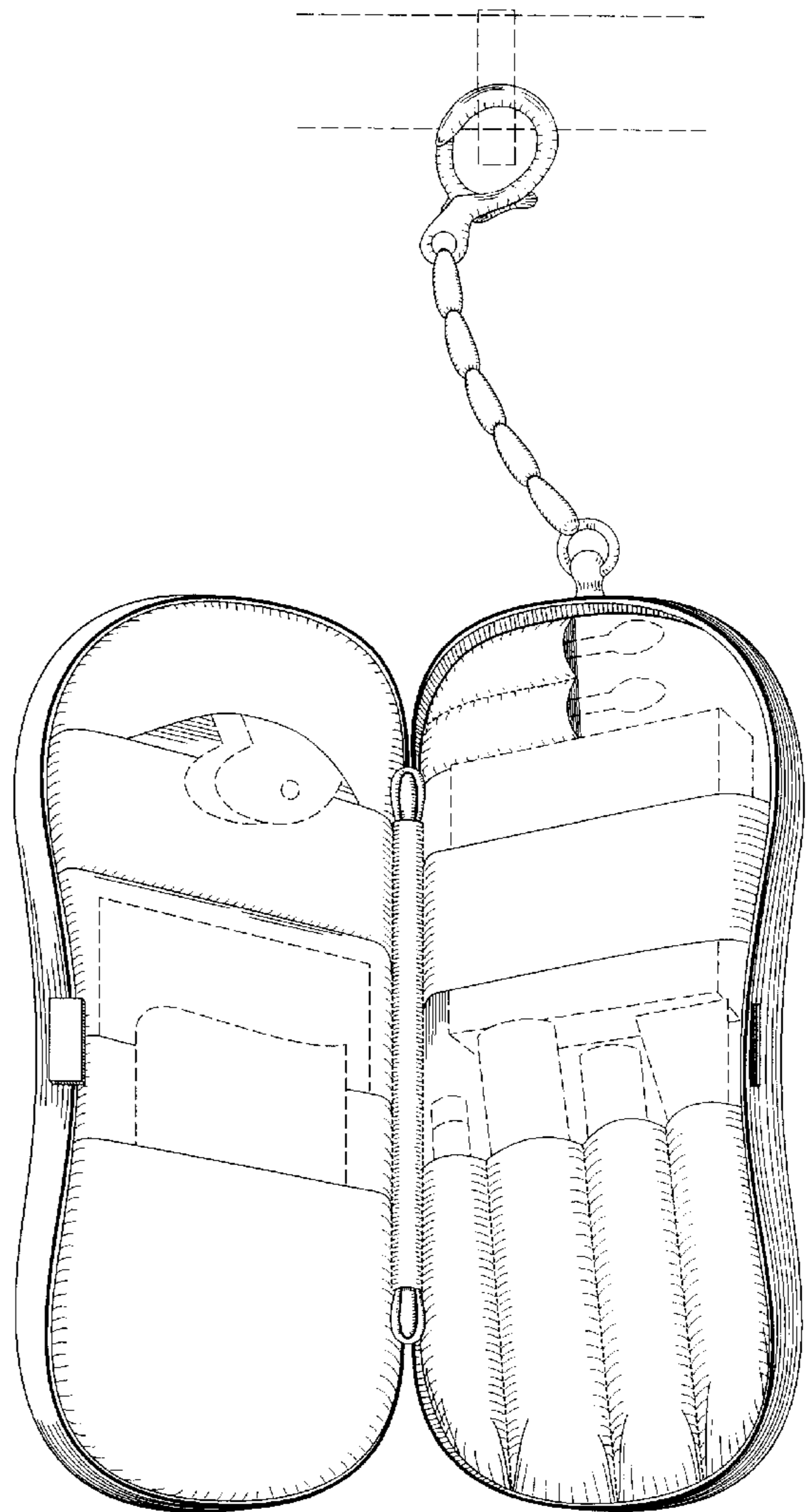

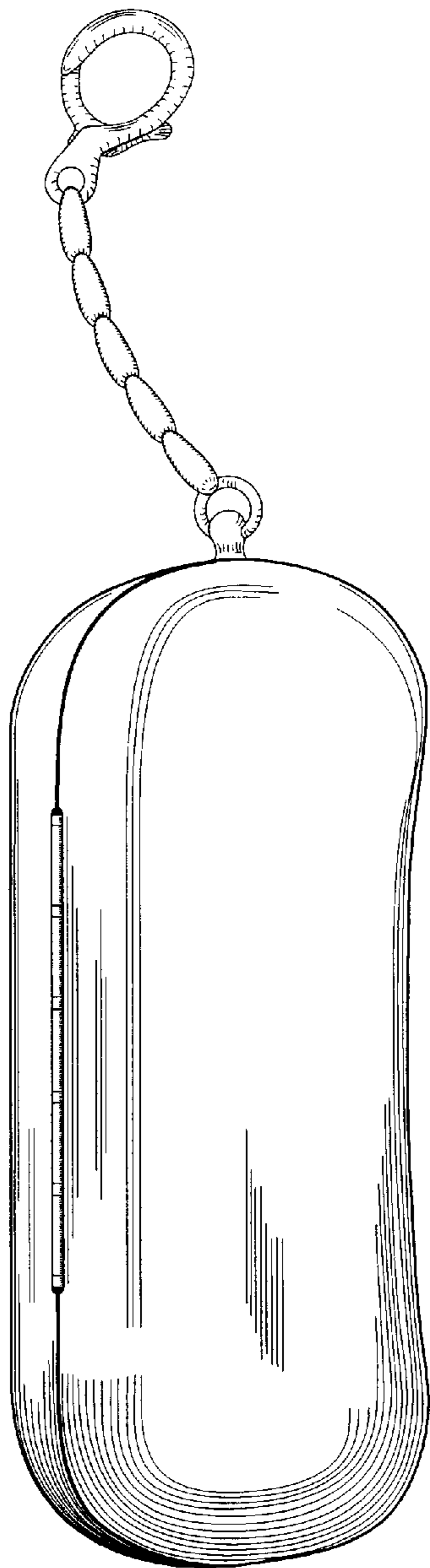

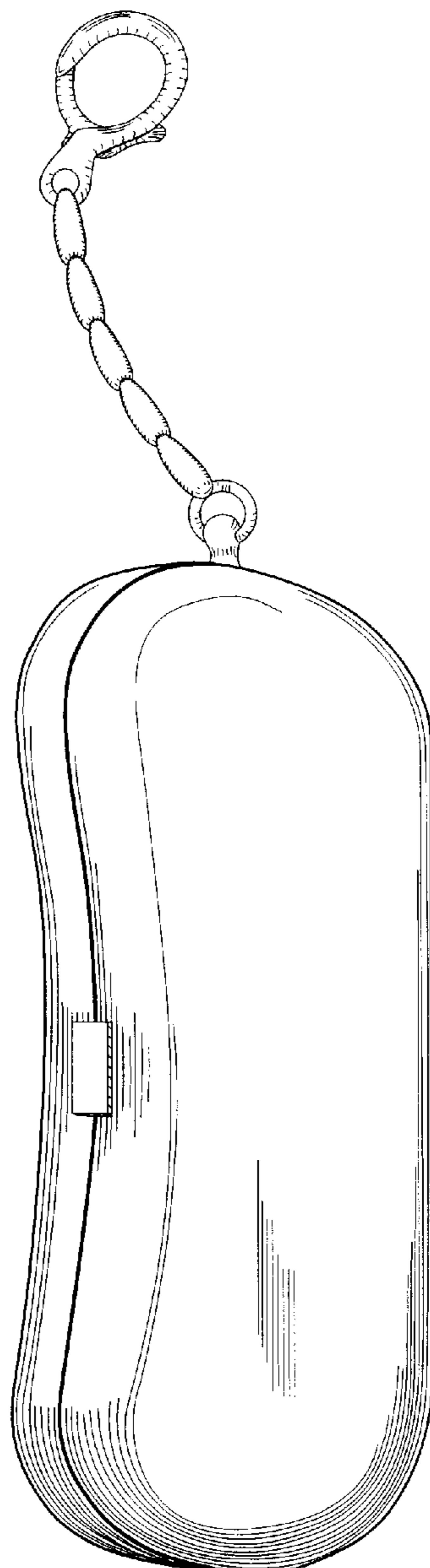

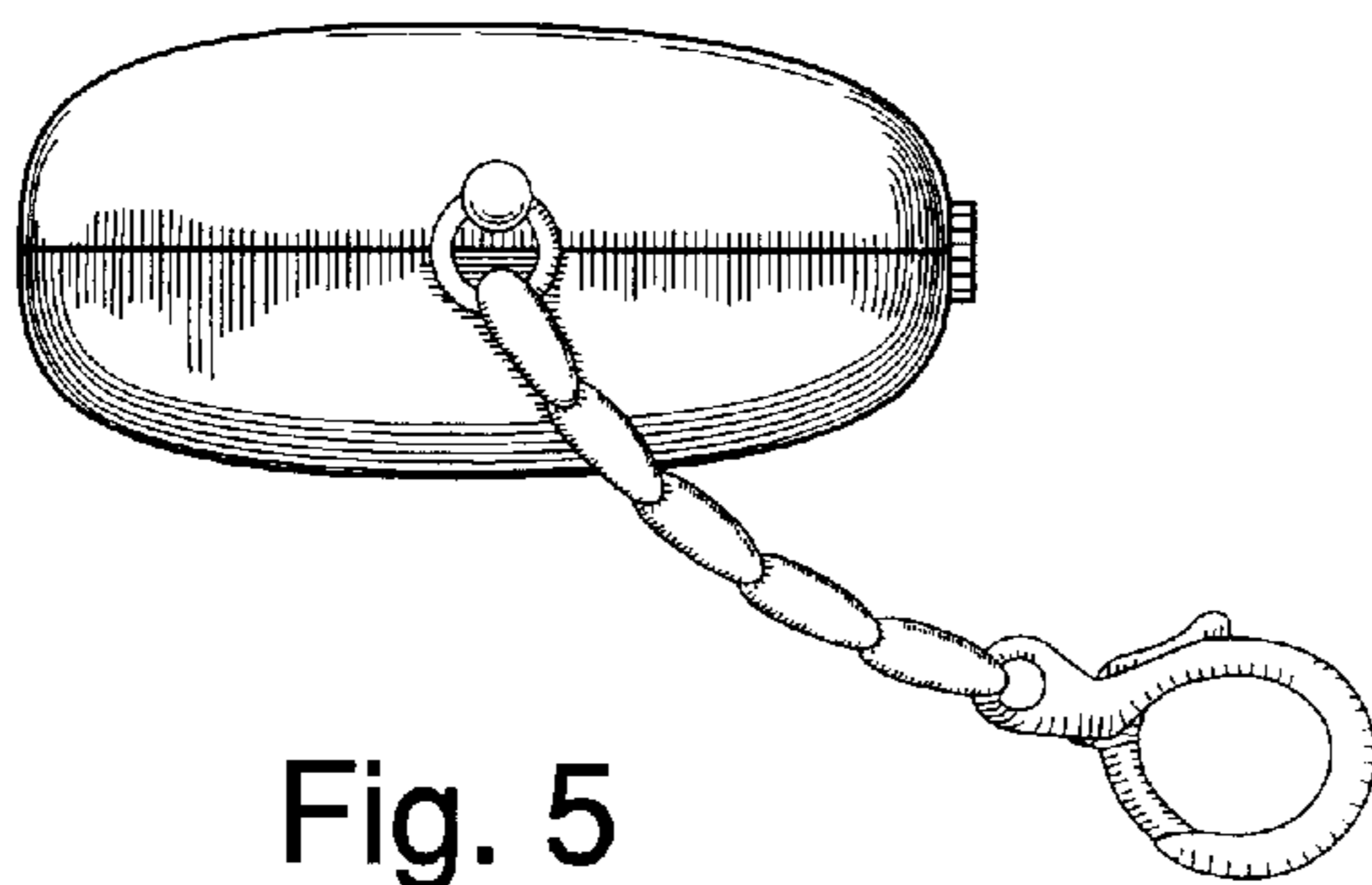

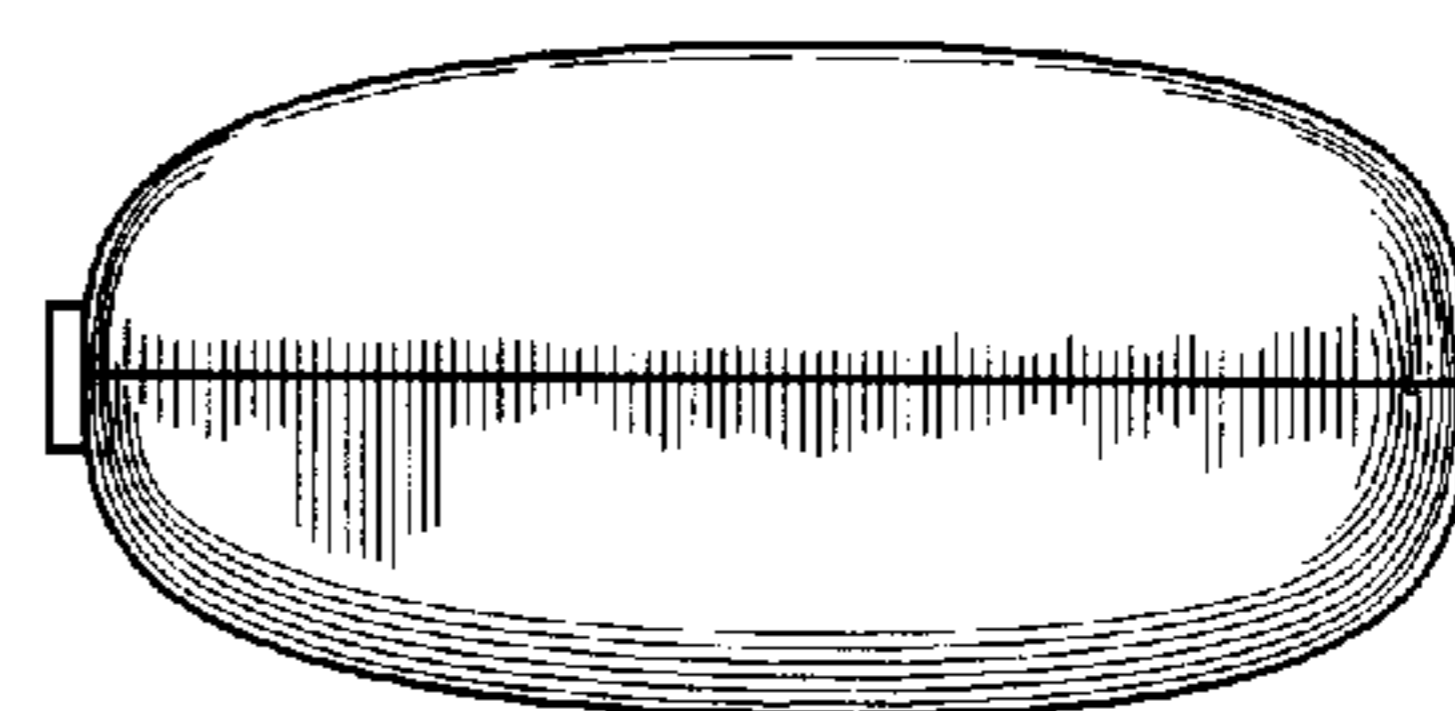
