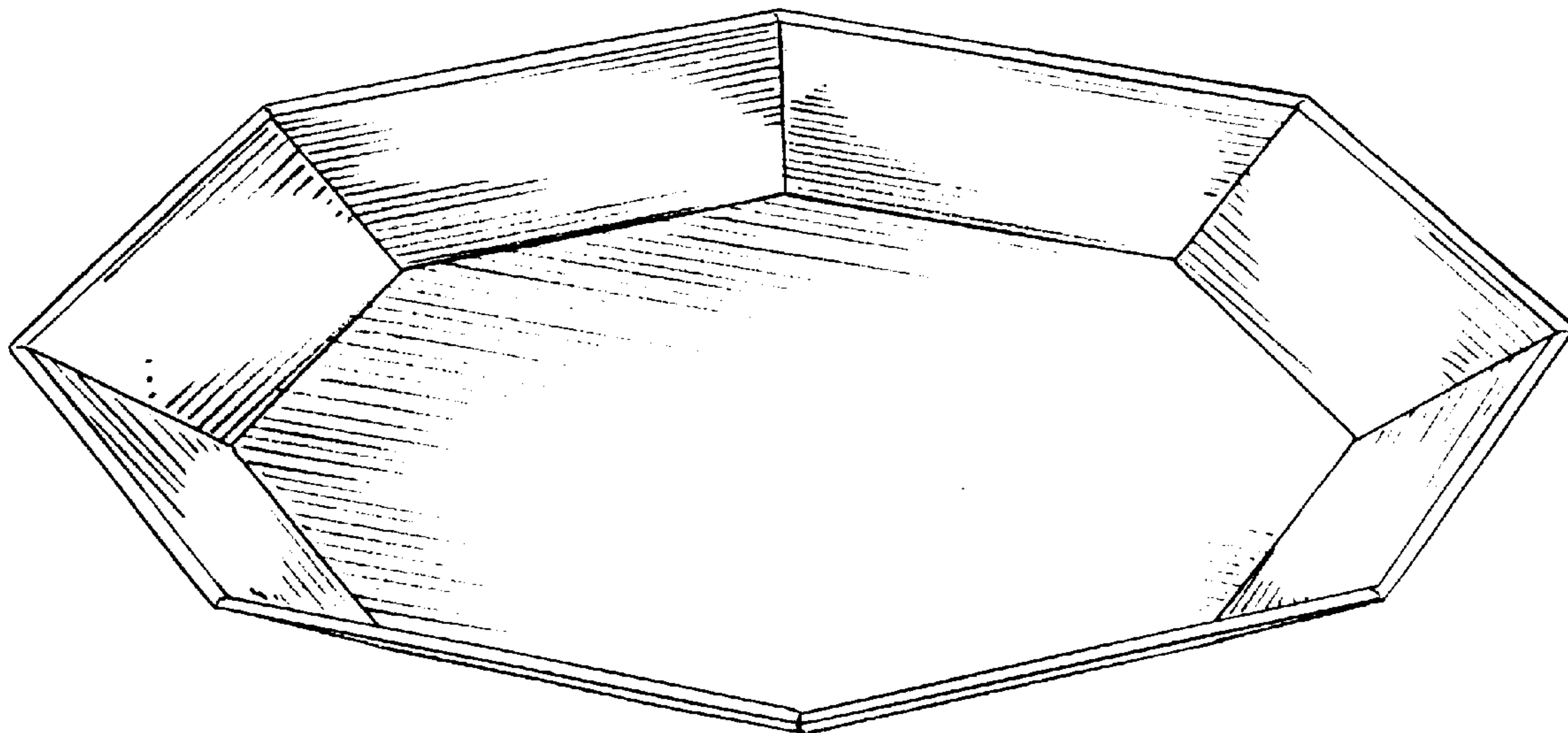
[57] **CLAIM**

DESCRIPTION

FIG. 1 illustrates a top perspective view of the serving plate; FIG. 2 illustrates a top plan view of the serving plate; FIG. 3 illustrates a side elevation view of the serving plate (each side being symmetrical); FIG. 4 illustrates a bottom plan view of the serving plate; and, FIG. 5 illustrates an enlarged sectional view taken on line 5—5 of FIG. 2.

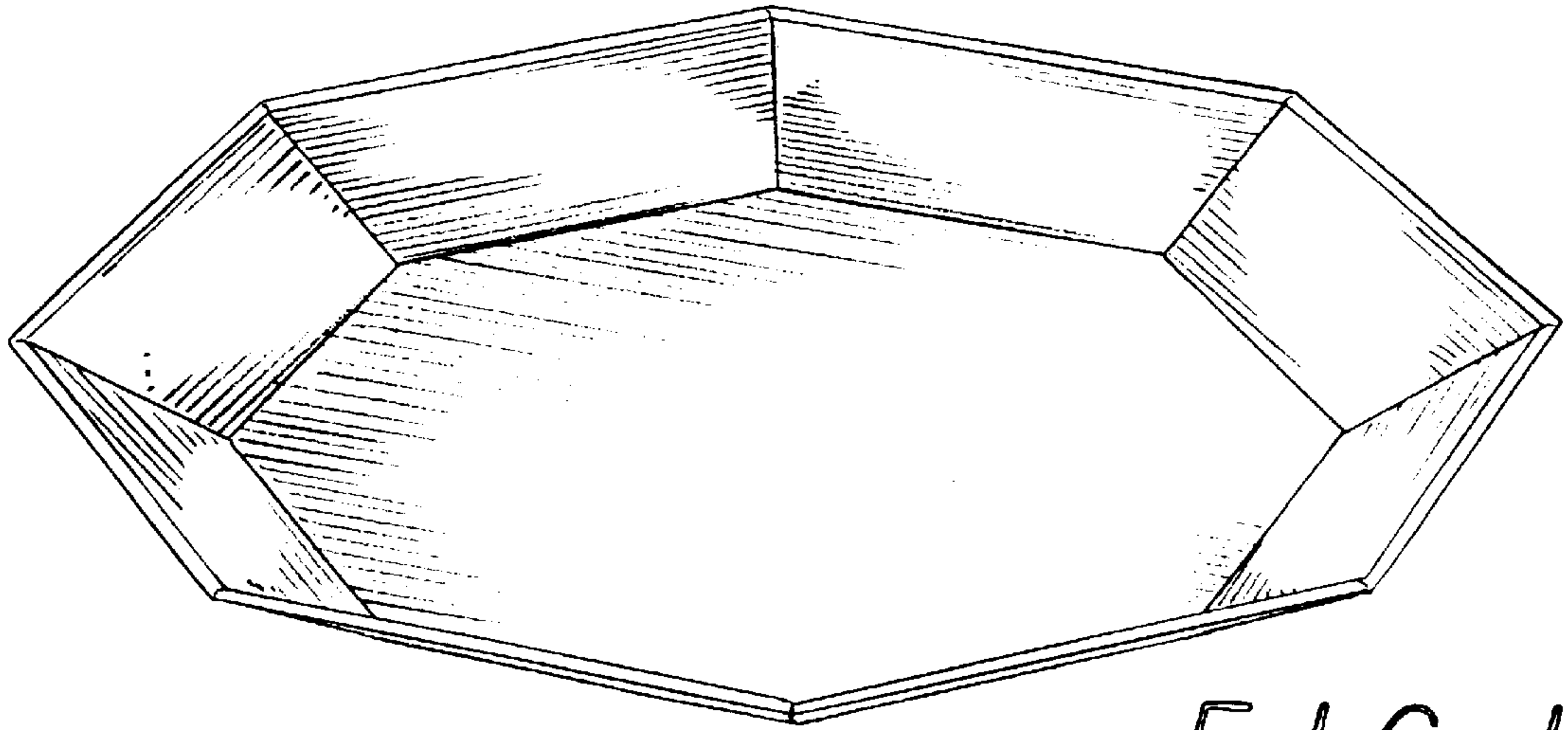

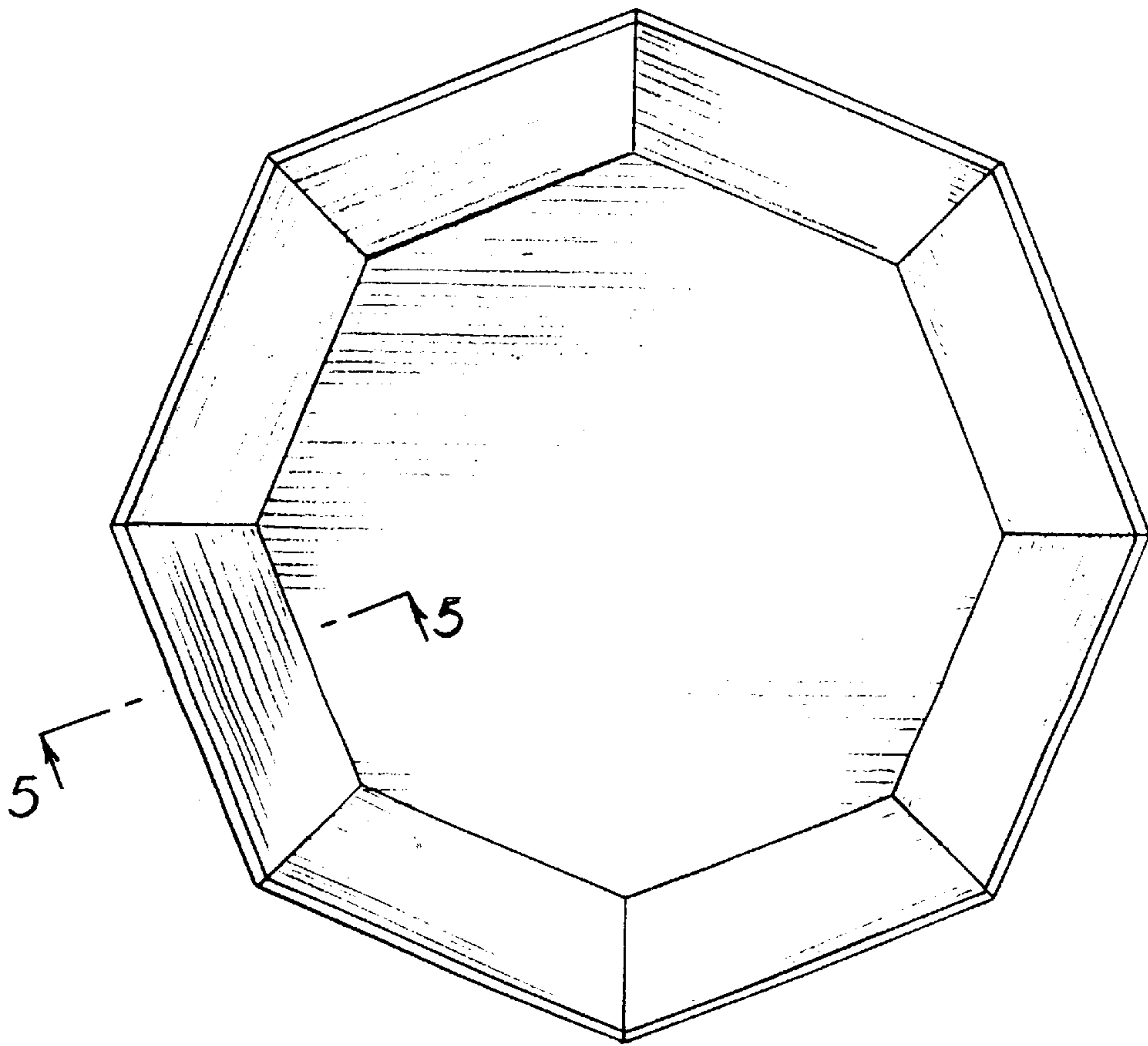

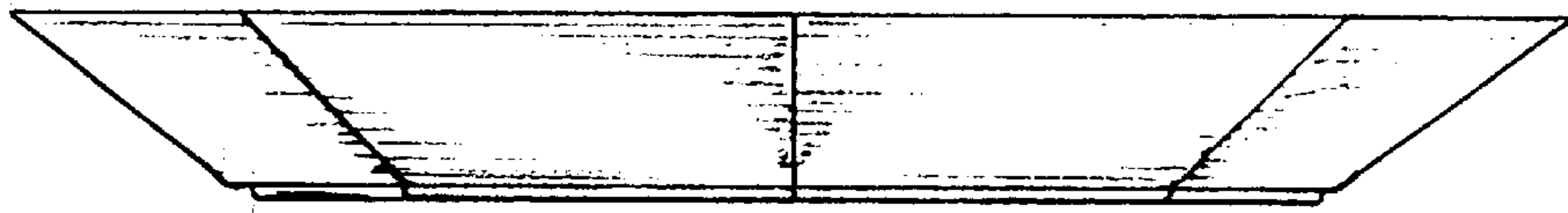

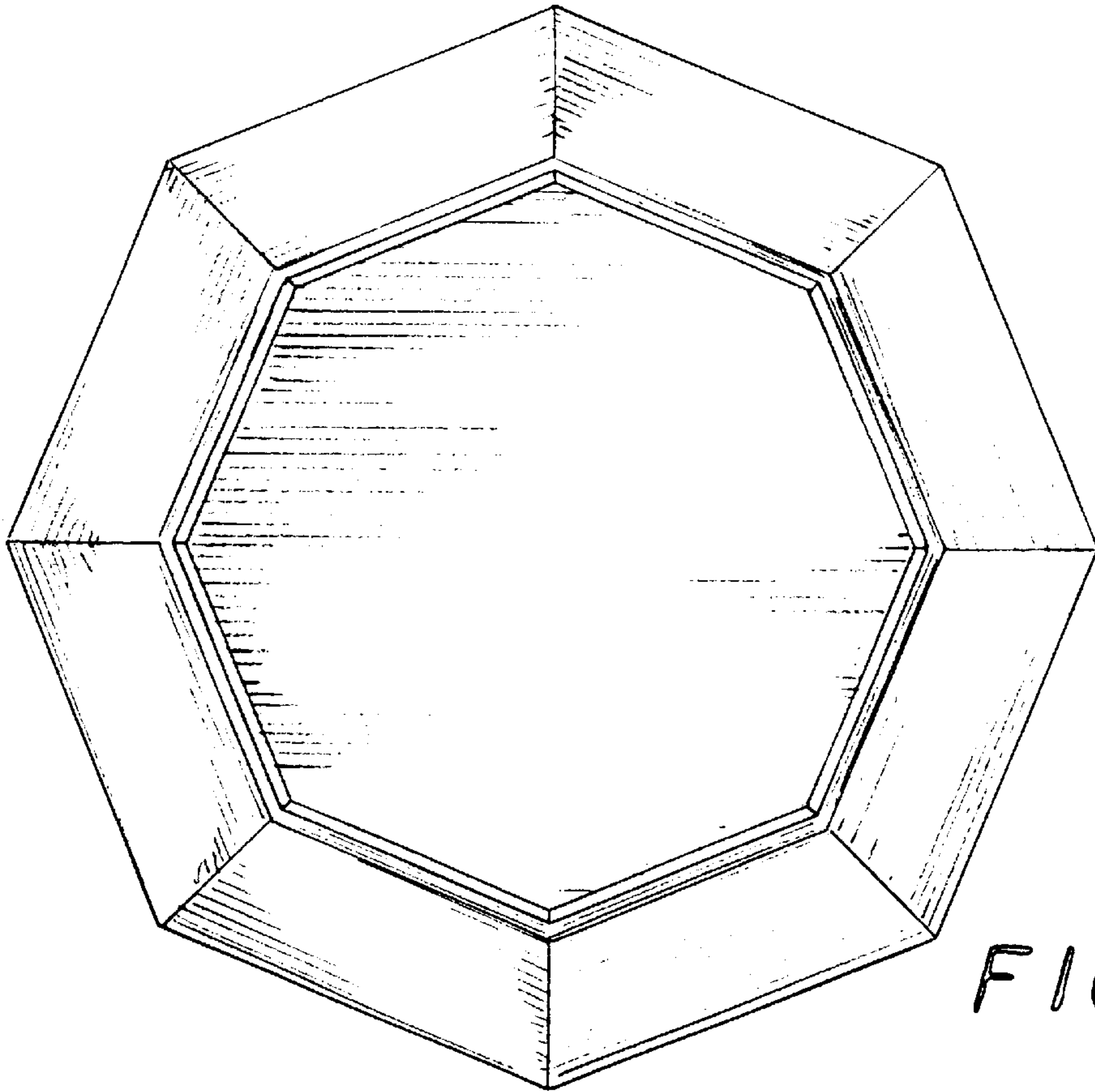

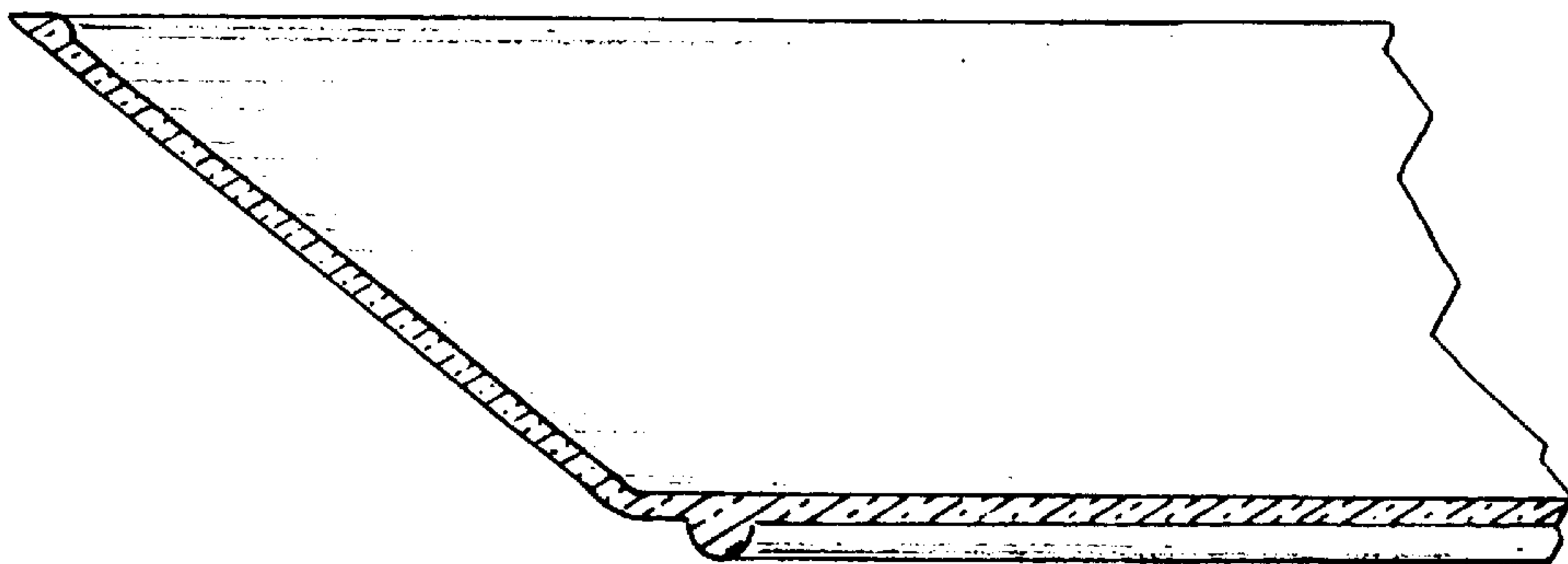
