FIG. 12 is a front elevation view of FIG. 8; and,

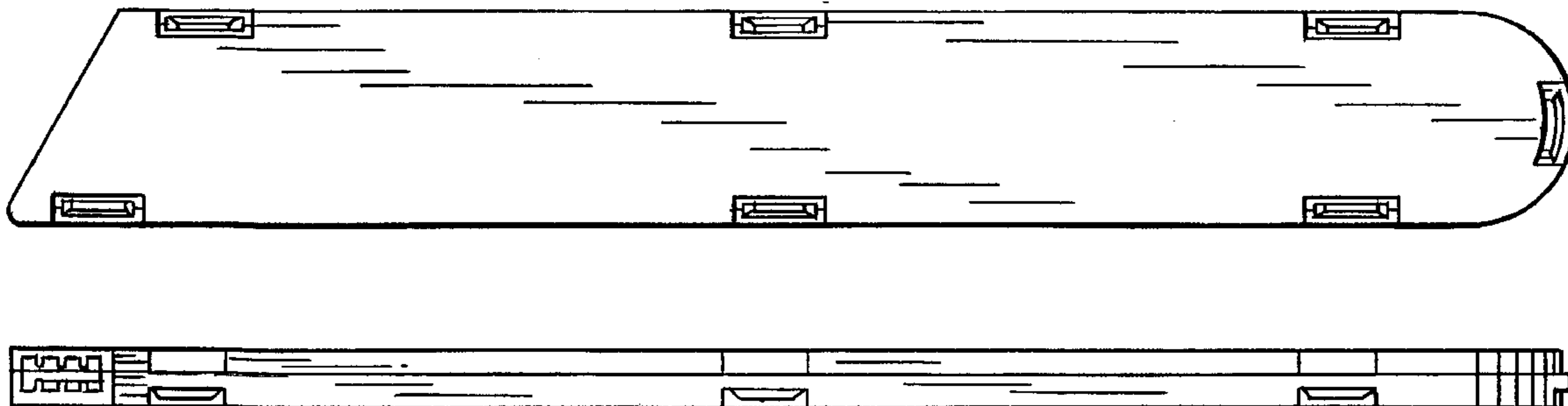
FIG. 13 is a rear elevation view of FIG. 8.

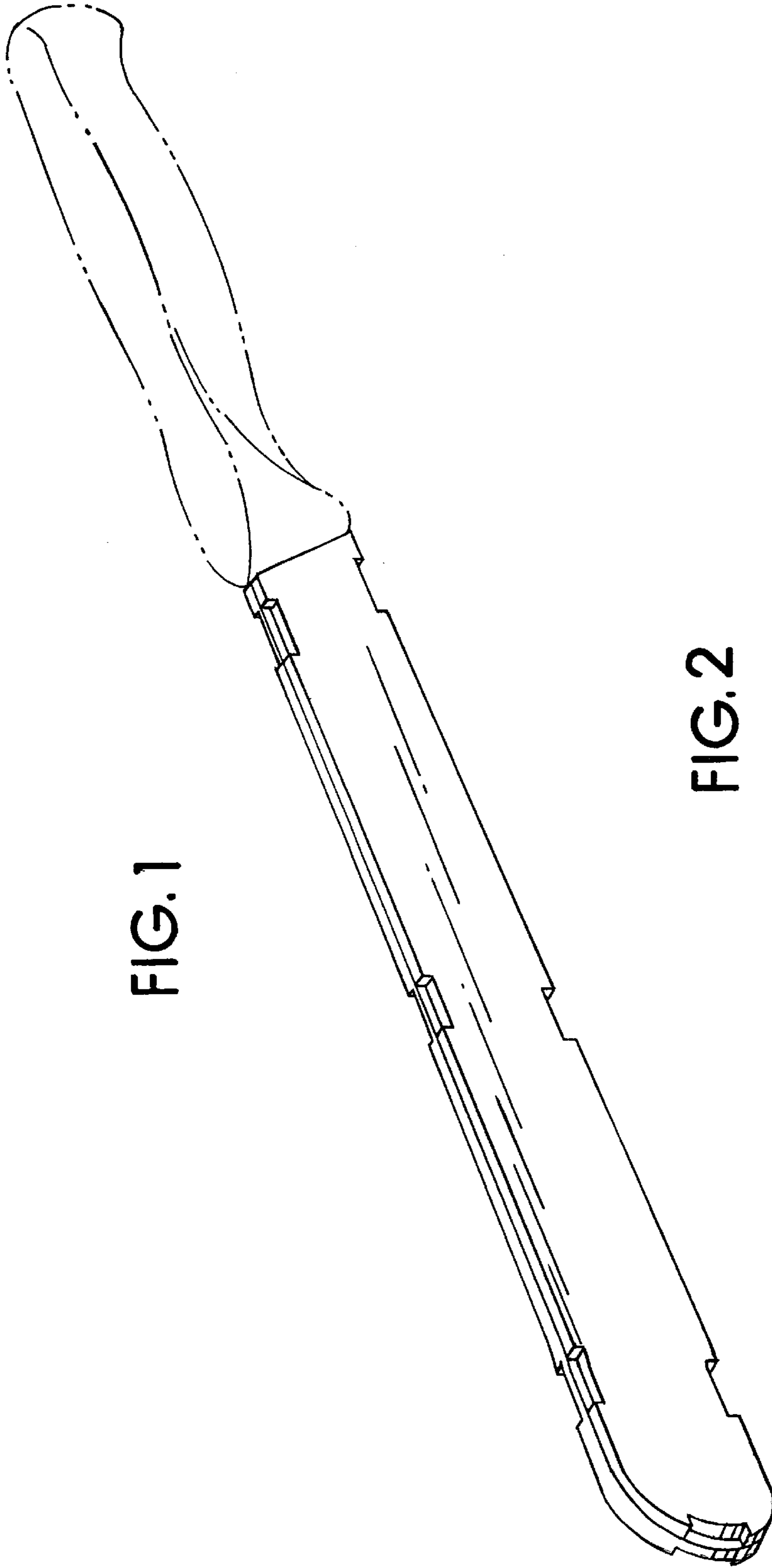

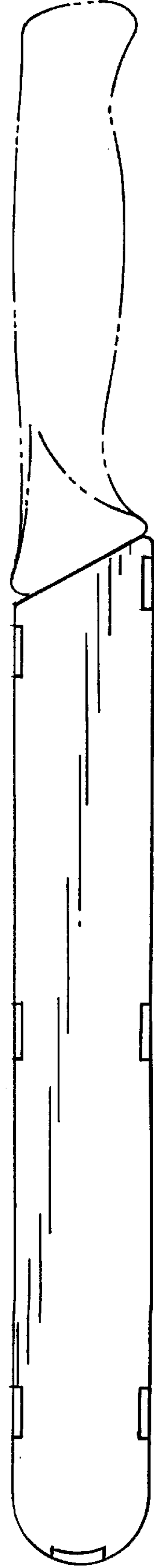

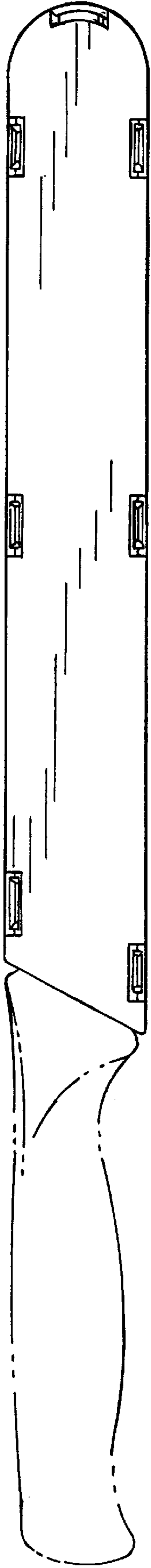

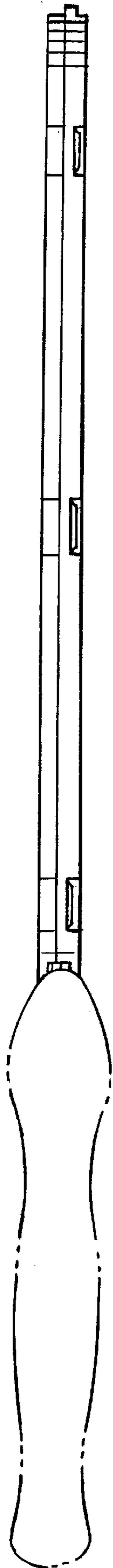

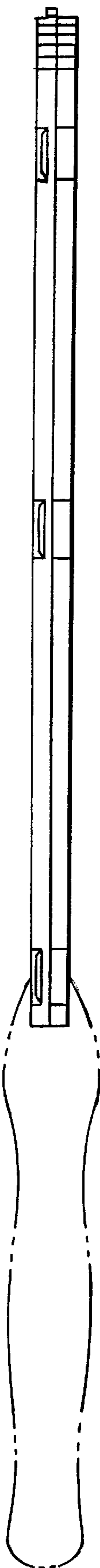

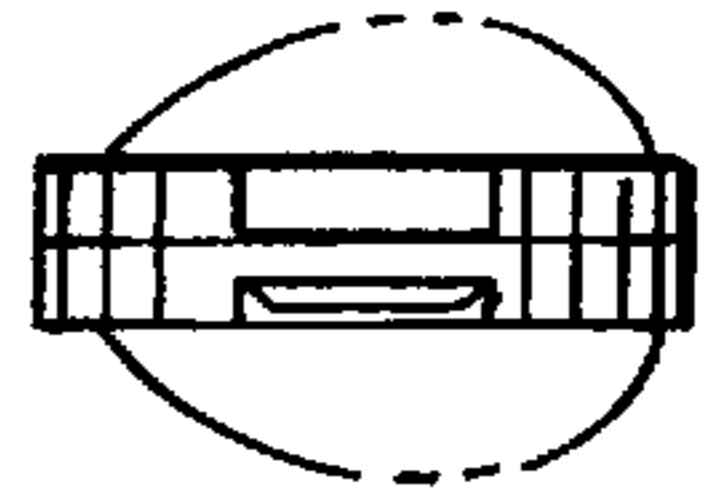

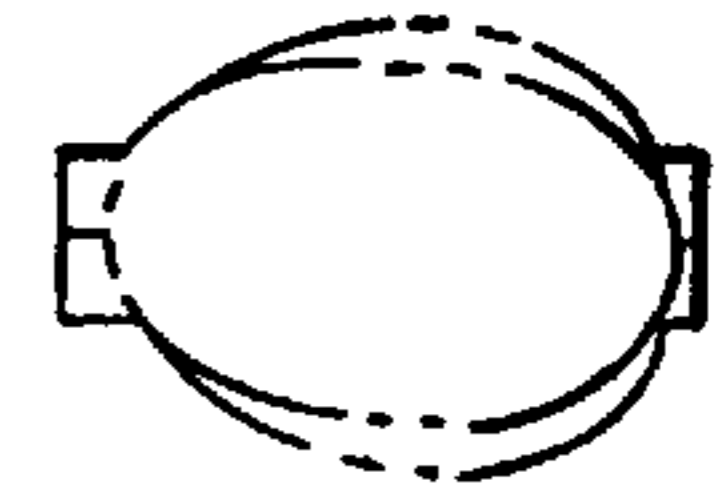

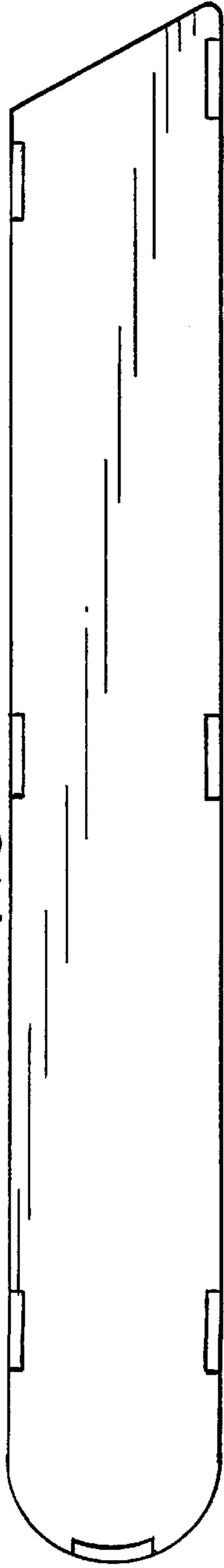

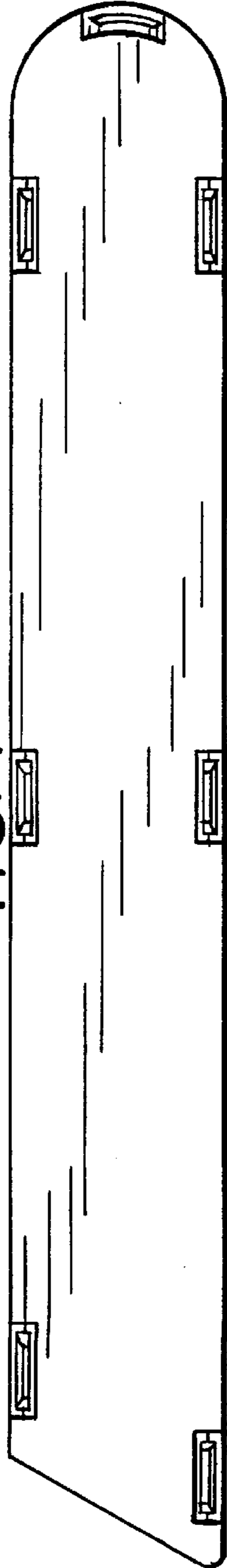

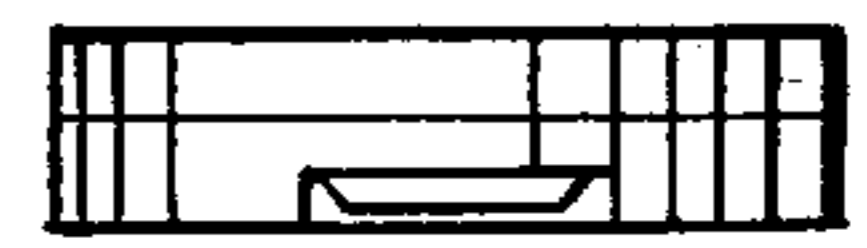

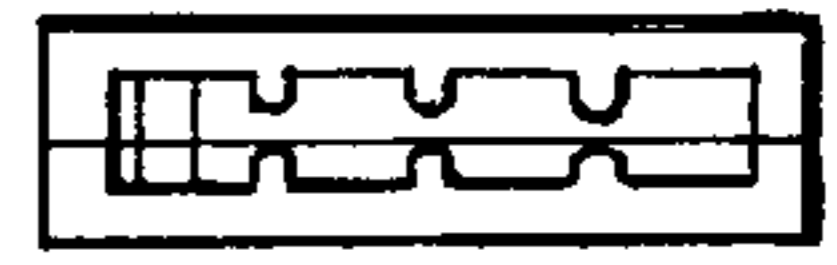
