DESCRIPTION

FIG. 1 is a front, top perspective view of an operative pair of chopsticks showing my new design in full lines with the broken lines showing environmental matter being for illustrative purposes only and forming no part of the claimed design;

FIG. 2 is a bottom plan view of the pair of chopsticks as viewed from the bottom of FIG. 6;

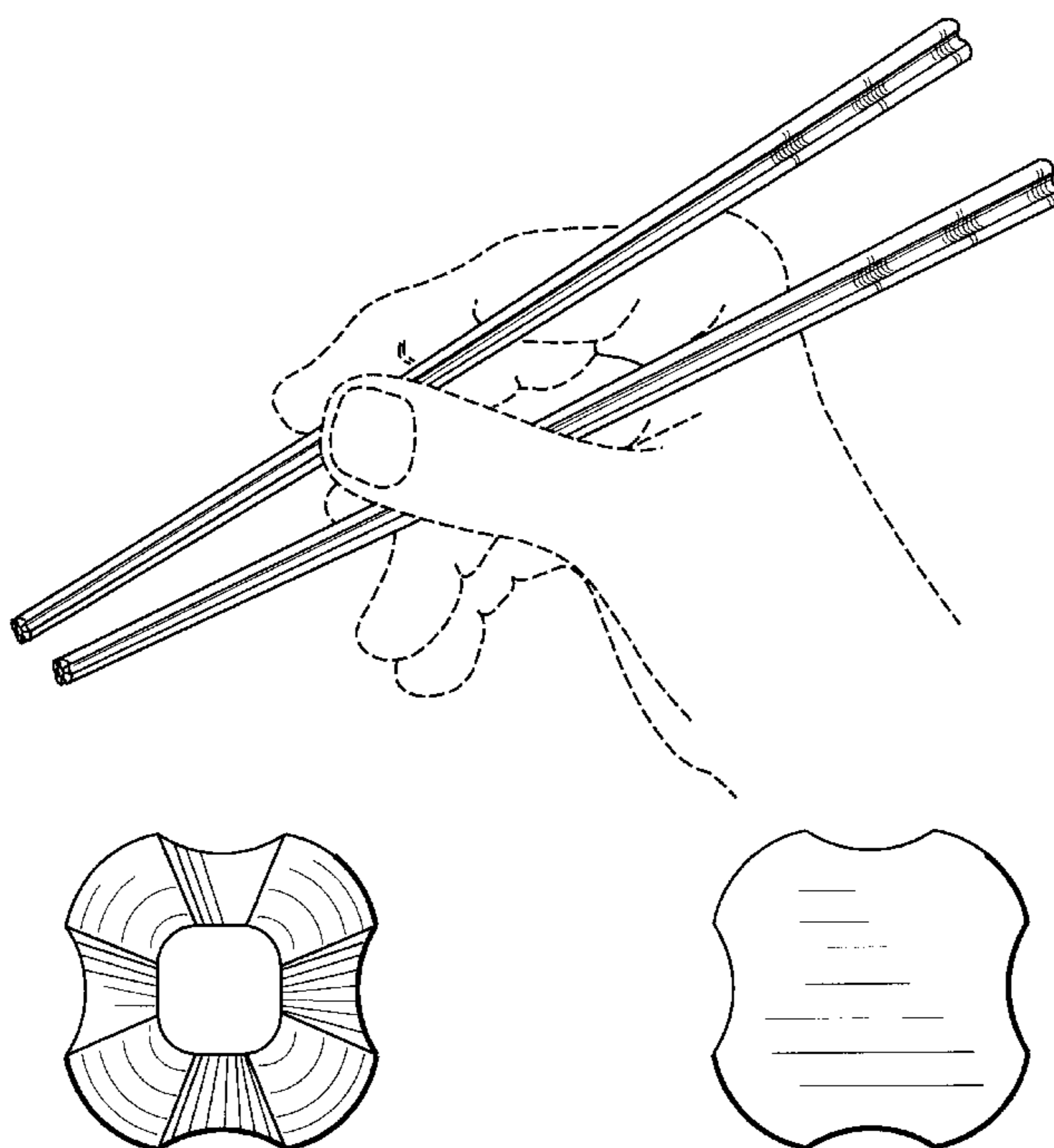
FIG. 3 is a top plan view of the pair of chopsticks as viewed from the top of FIG. 6;

FIG. 4 is an enlarged left end view of one of the chopsticks for ease of illustration as viewed from the left of FIG. 2;

FIG. 5 is an enlarged right end view of one of the chopsticks for ease of illustration as viewed from the right of FIG. 2; and,

FIG. 6 is an enlarged cross section view of the pair of chopsticks taken along the line 6—6 of FIG. 2.

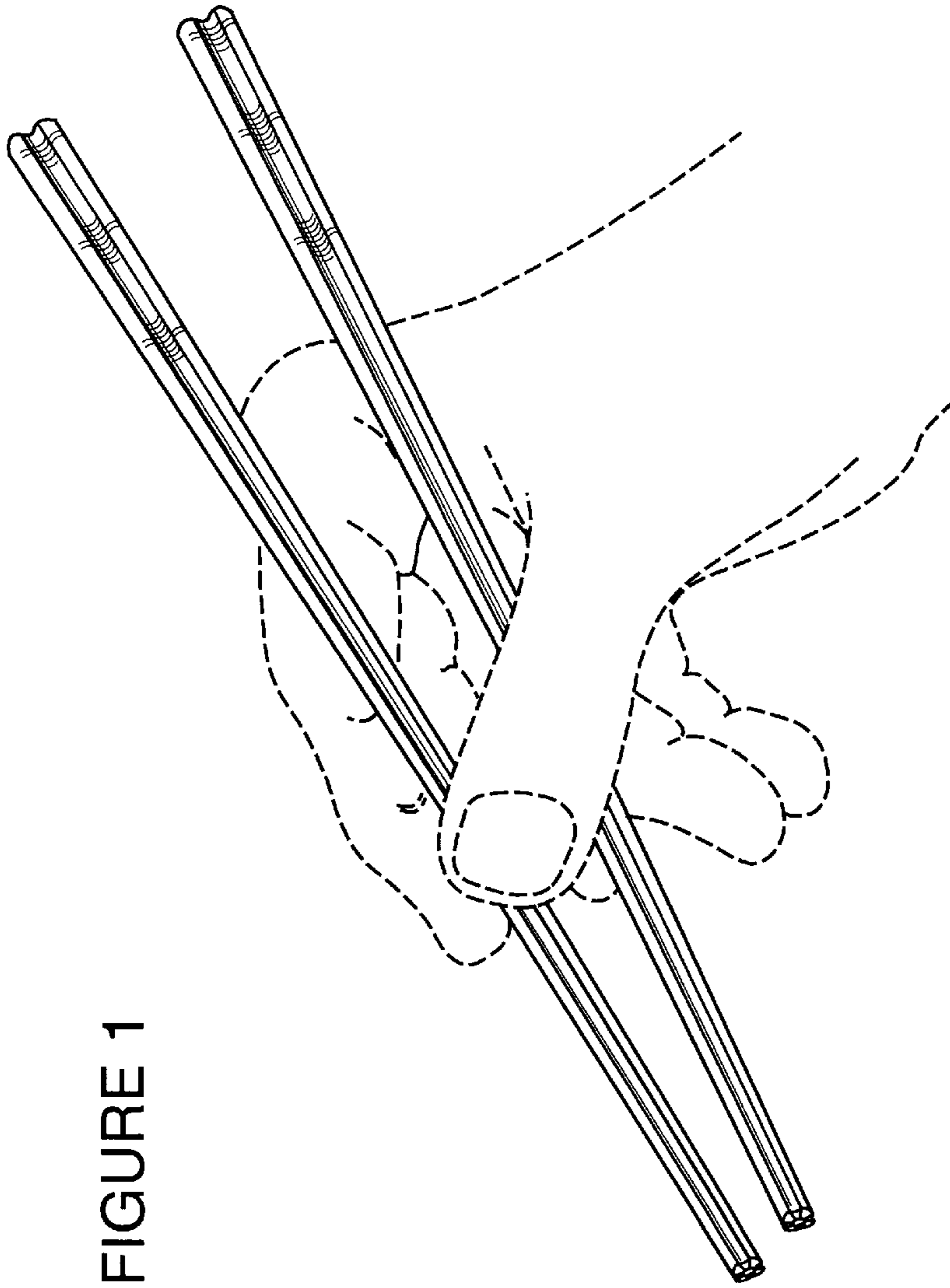

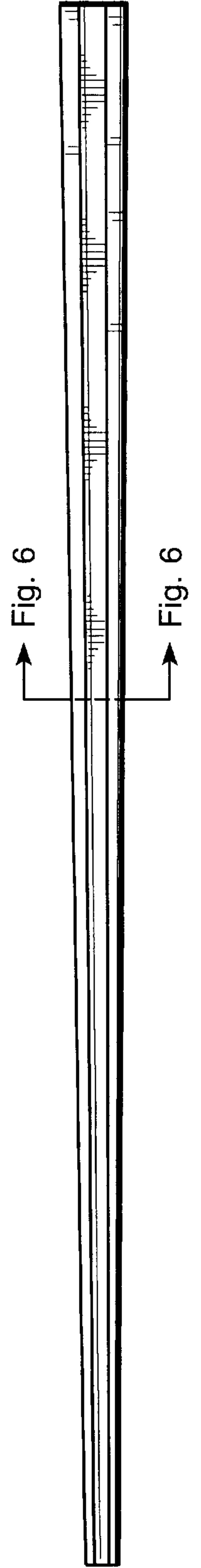

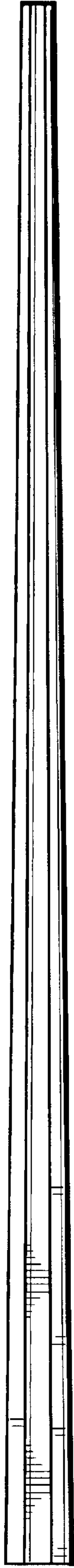

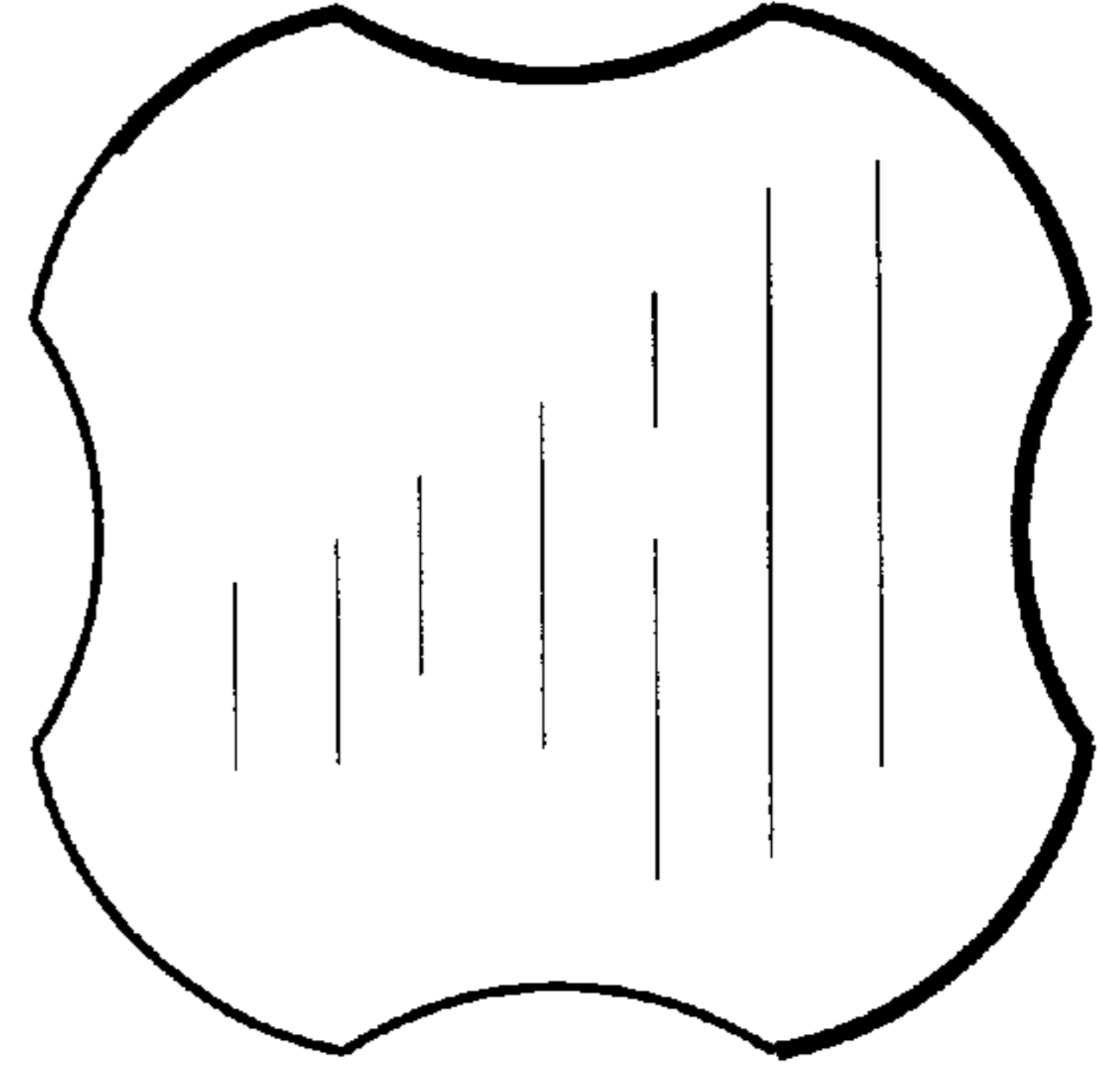
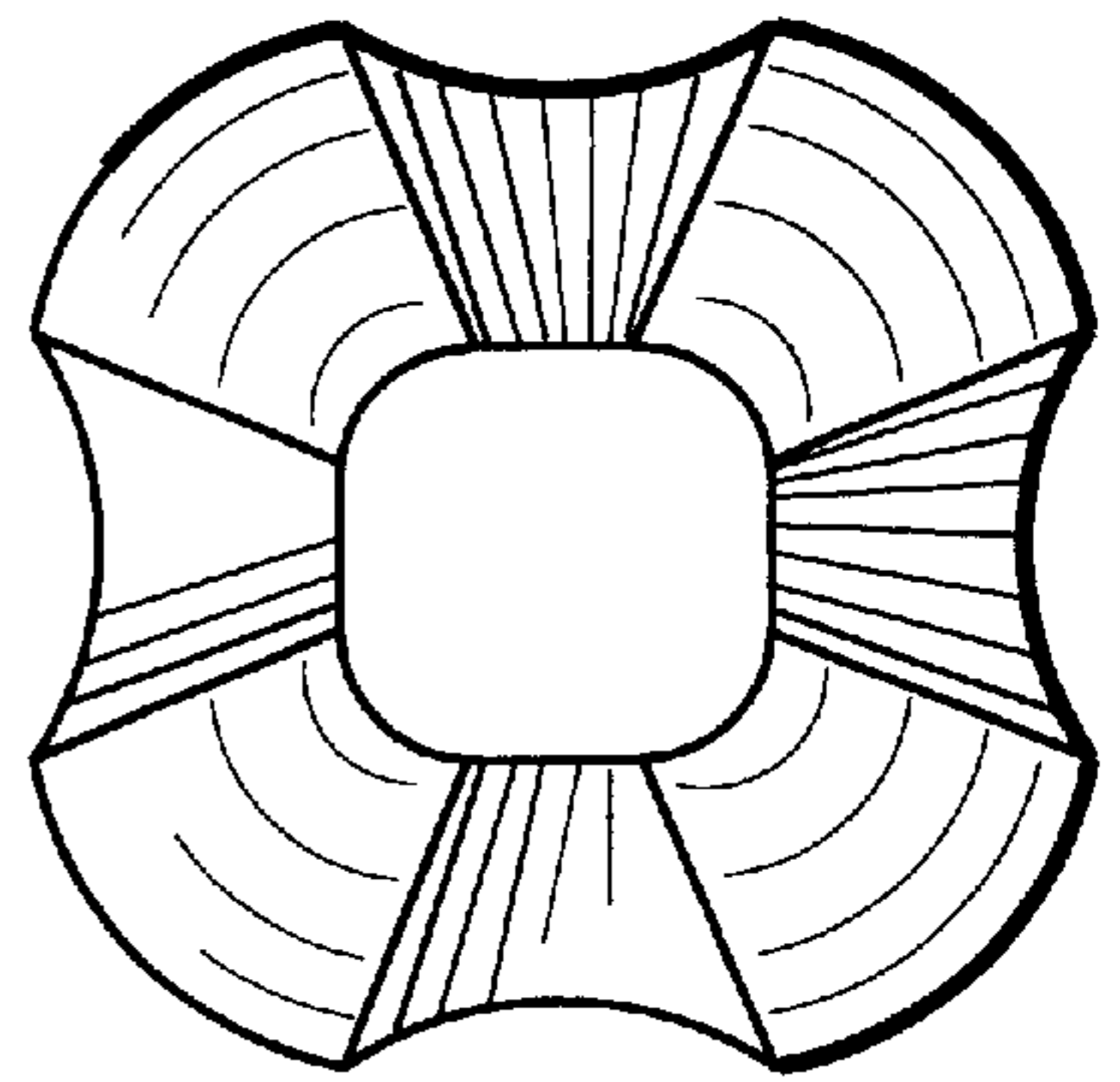

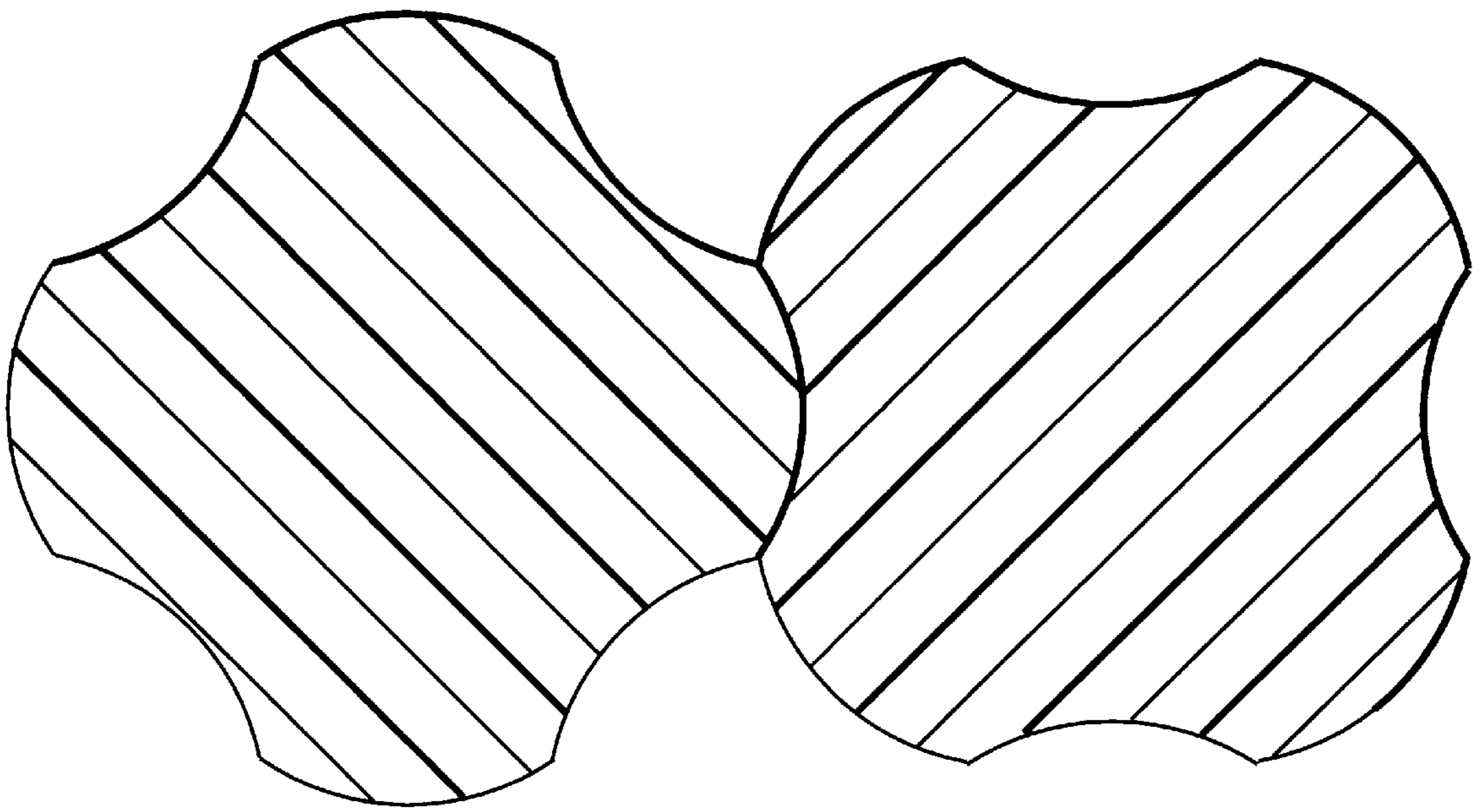
