[57] CLAIM

The ornamental design for a combined bottle and cap, as
shown and described.

DESCRIPTION

FIG. 1 is a front elevation of a combined bottle and cap
showing our new design, the rear elevation being the same
FIG. 2 is a right side elevation thereof, the left side elevation
being the same;

FIG. 3 is a top plan view;

FIG. 4 is a bottom plan view

FIG. 5 is a front elevation of a second embodiment of the
design;

FIG. 6 is a rear elevation thereof;

FIG. 7 is a right side elevation of the second embodiment,
the left side elevation is a mirror image thereto;FIG. 8 is a top plan view of the second embodiment of the
design;FIG. 9 is a front elevation of a third embodiment of the
design; the rear elevation is a mirror image thereto;

FIG. 10 is a right side elevation of the third embodiment;

FIG. 11 is a left side elevation of the third embodiment;

FIG. 12 is the top plan view of the third embodiment of the
design;FIG. 13 is the front elevation of a fourth embodiment of the
design;


FIG. 14 is the rear elevation thereof;

FIG. 15 is a right side elevation of the fourth embodiment,
the left side elevation is a mirror image thereto; and,

FIG. 16 is the top plan view of the fourth embodiment.
























