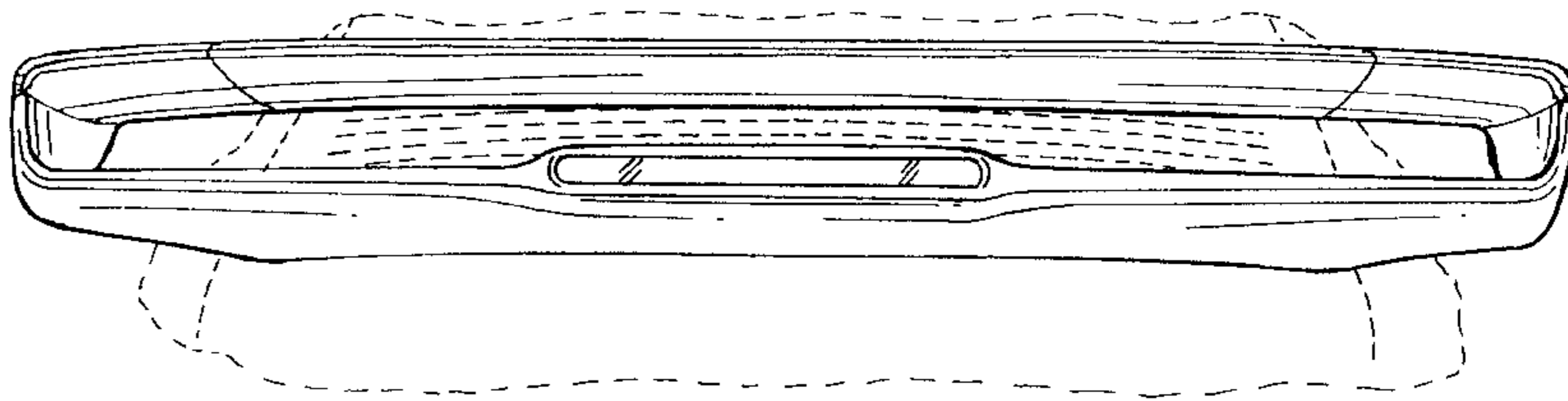
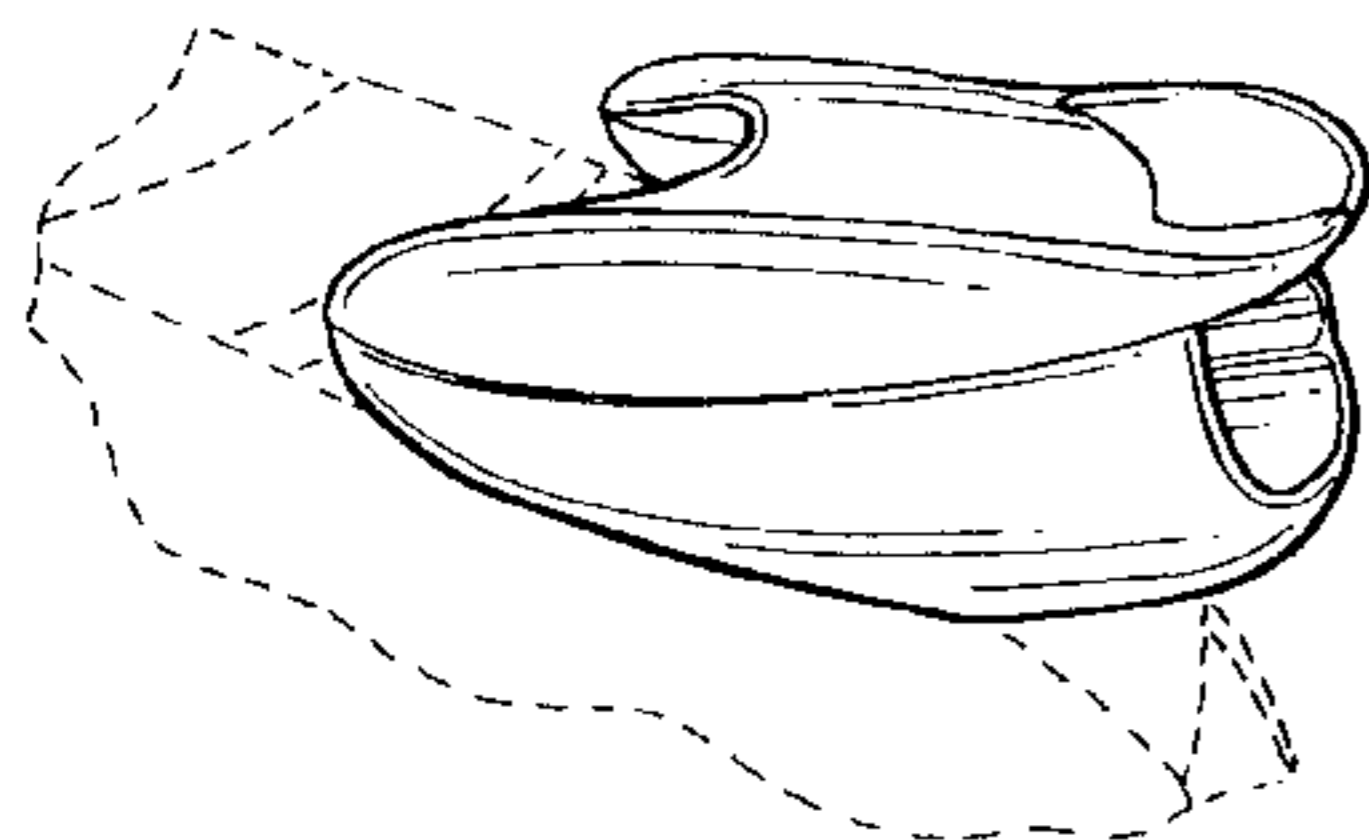
[57] **CLAIM**

The ornamental design for a rear spoiler for a vehicle, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view from the right of a rear spoiler for a vehicle according to my novel design, the perspective view from the left being mirror symmetrical;  
 FIG. 2 is a front view of the rear spoiler for a vehicle according to my novel design;  
 FIG. 3 is a side view from the right of the rear spoiler for a vehicle according to my novel design, the side view from the left being mirror symmetrical; and,  
 FIG. 4 is a top view of the rear spoiler for a vehicle according to my novel design.  
 The dash lines included depict environment and are not part of the claimed design.

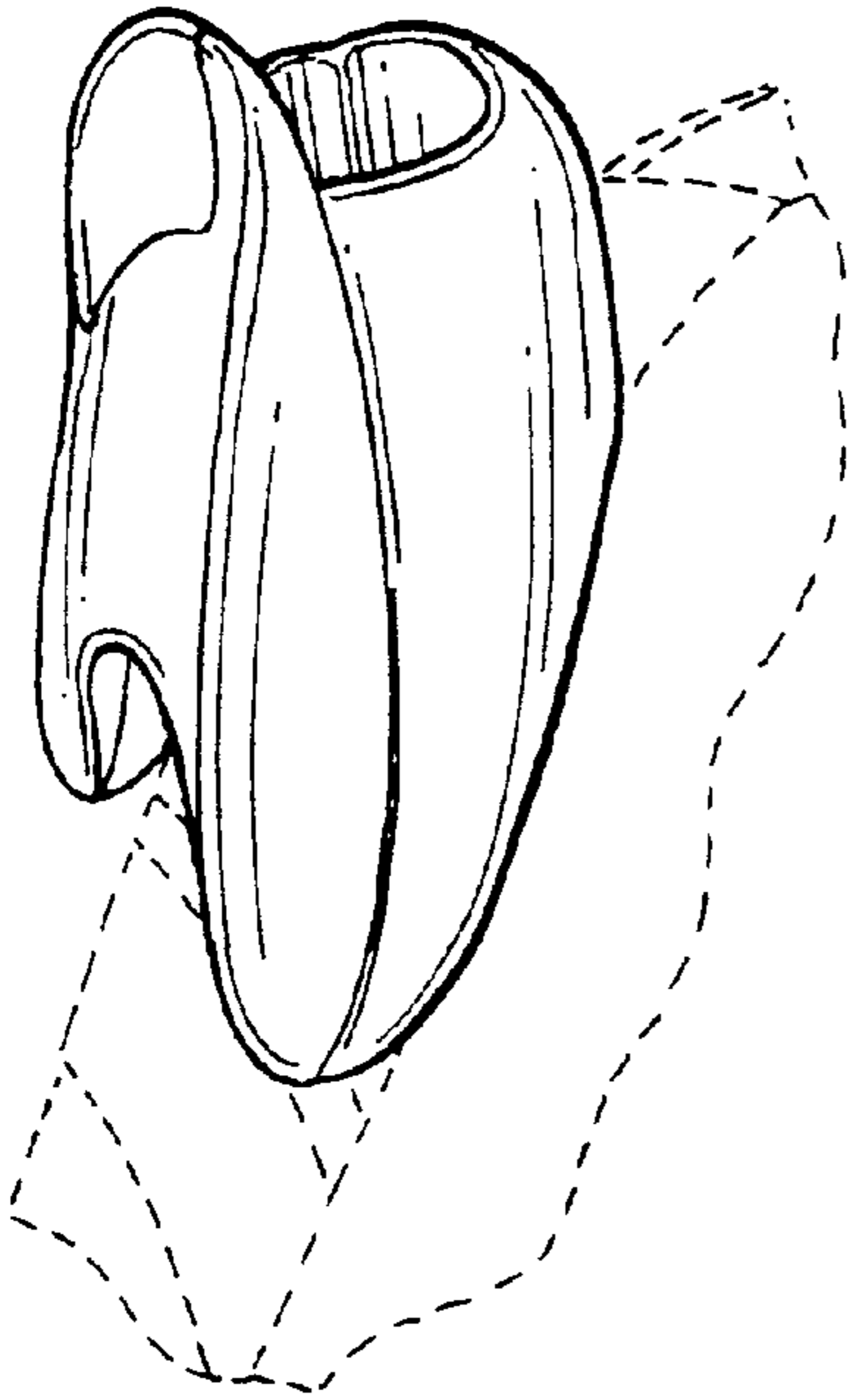

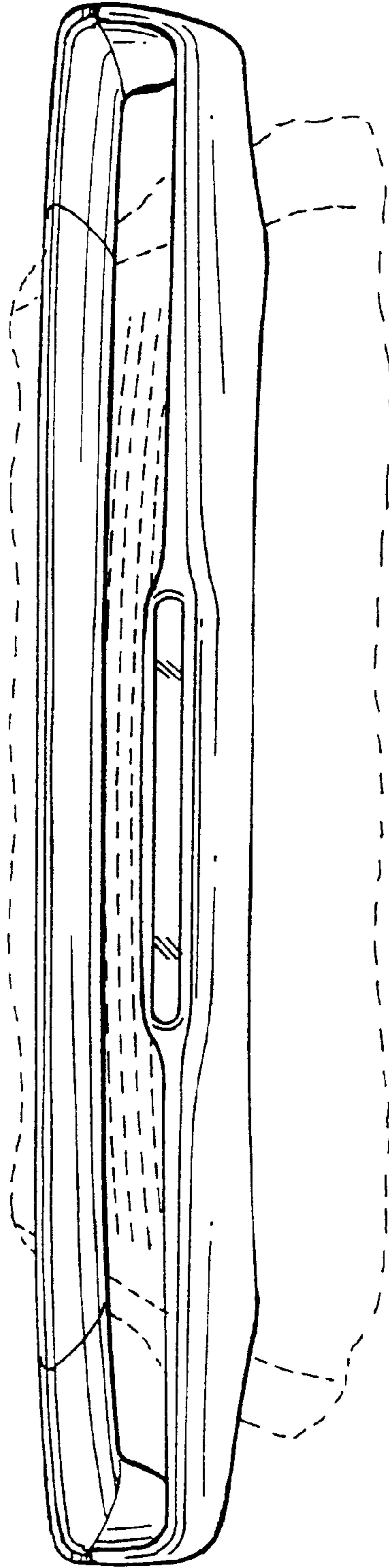

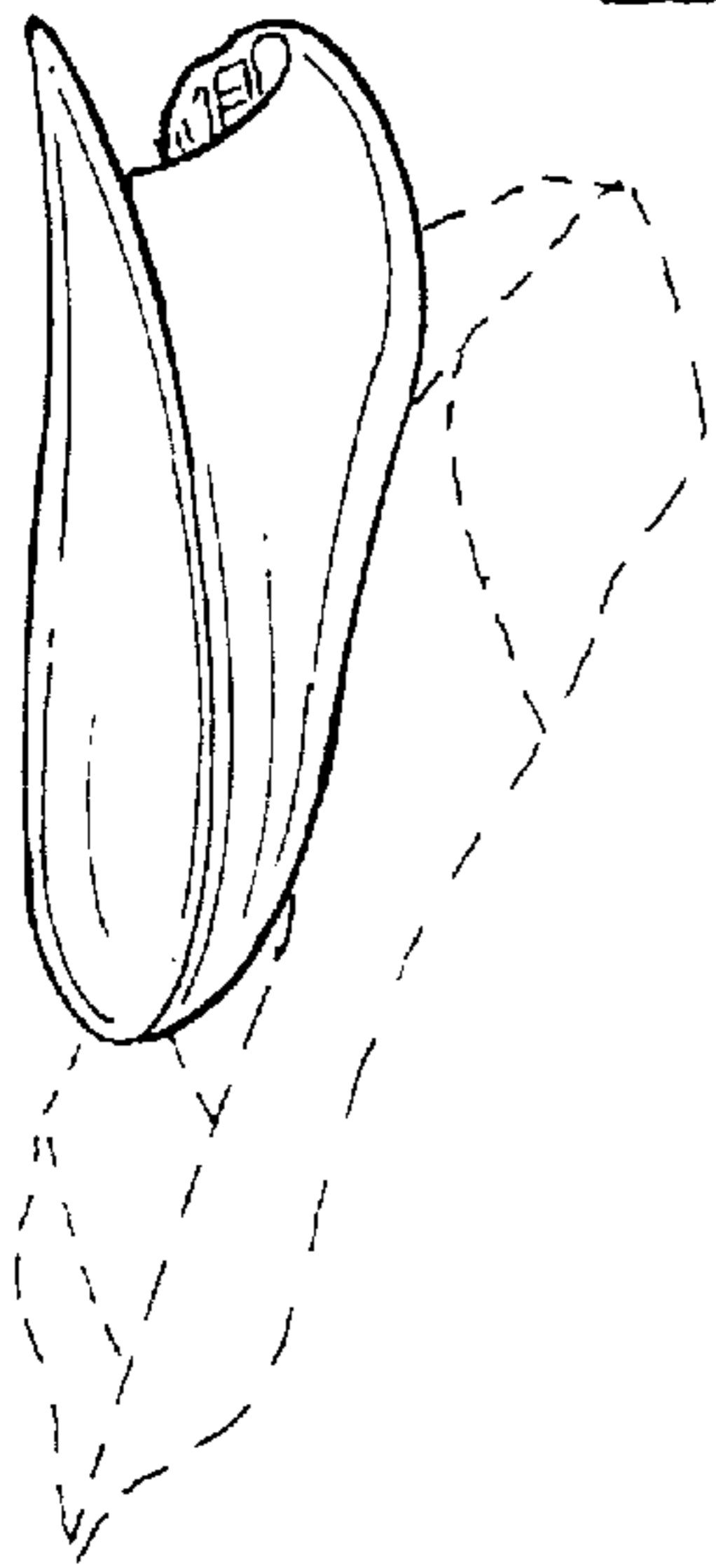
