The ornamental design for a remote control unit, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a remote control unit showing our new design;
FIG. 2 is a left side view thereof, the right side being a mirror image;
FIG. 3 is a back view thereof;
FIG. 4 is a top elevation view thereof; and,
FIG. 5 is a bottom elevation view thereof.
The broken line showing of the buttons in FIG. 1 is for illustrative purposes only, and forms no part of the claimed design.

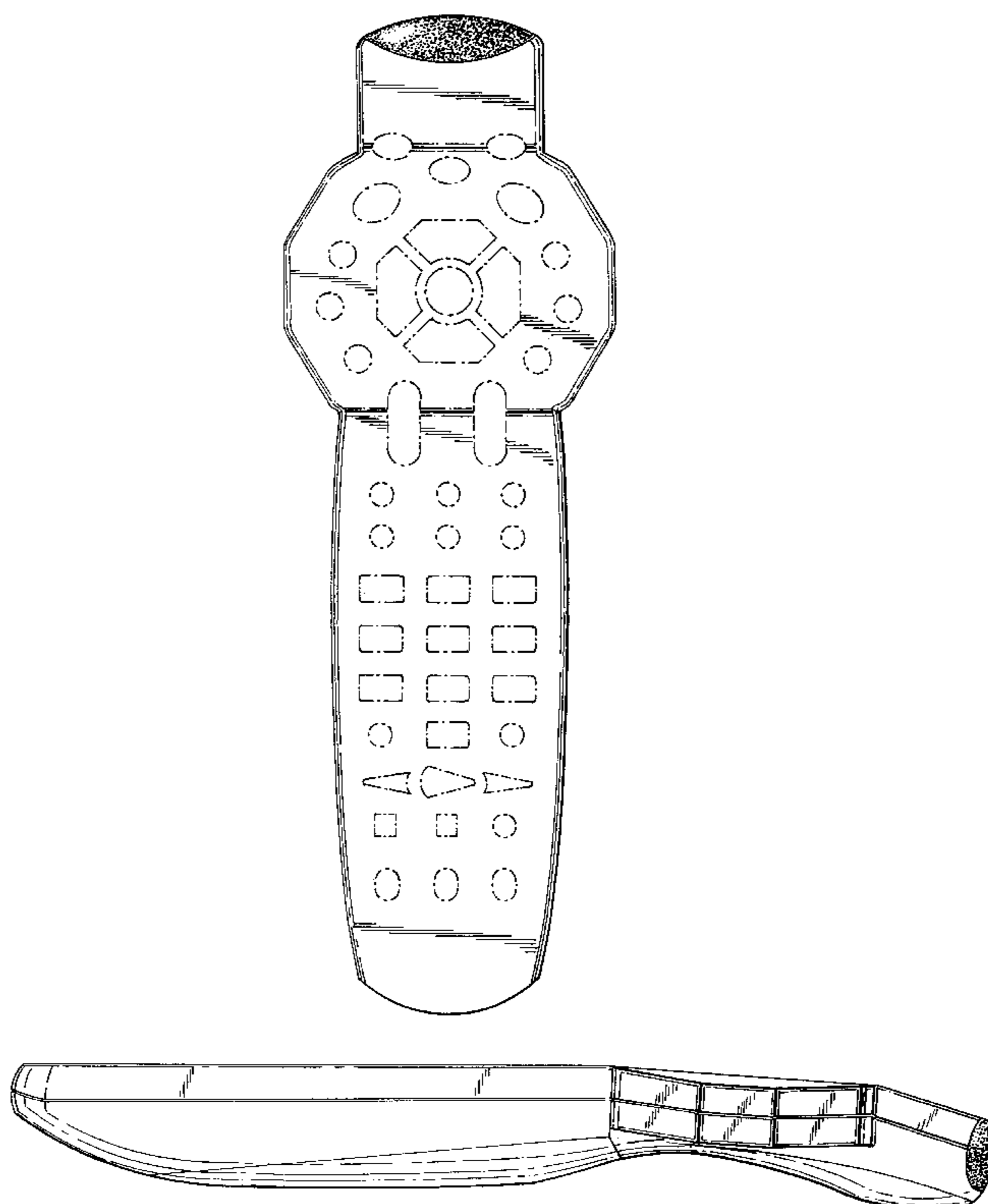
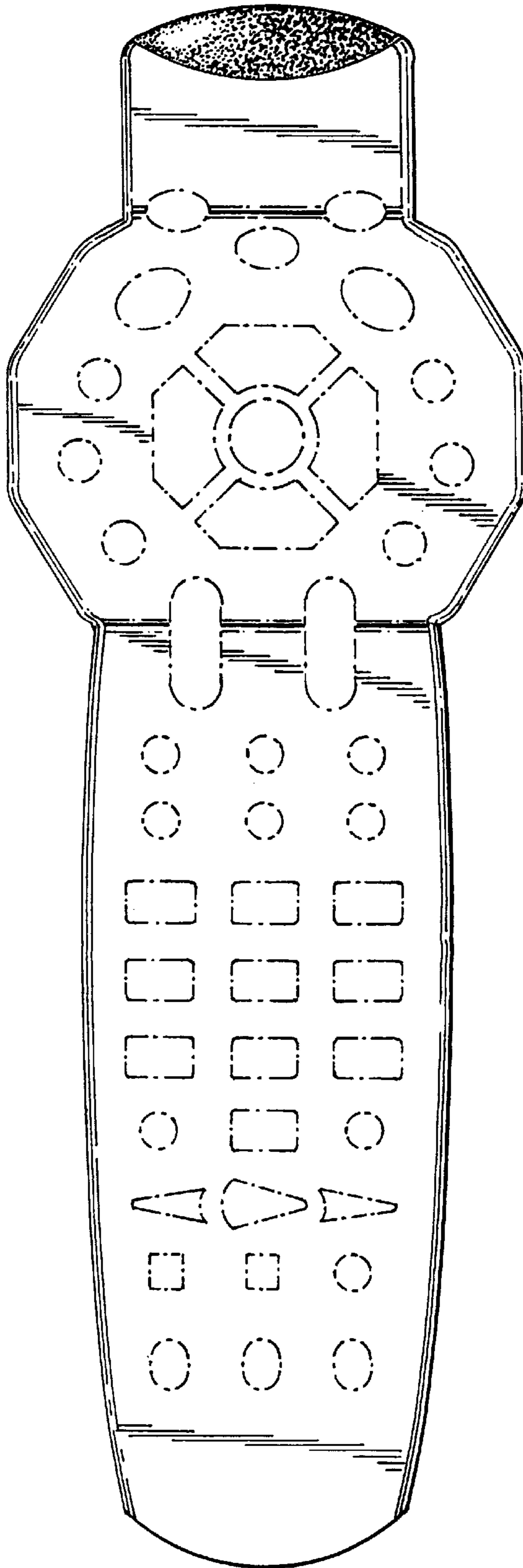

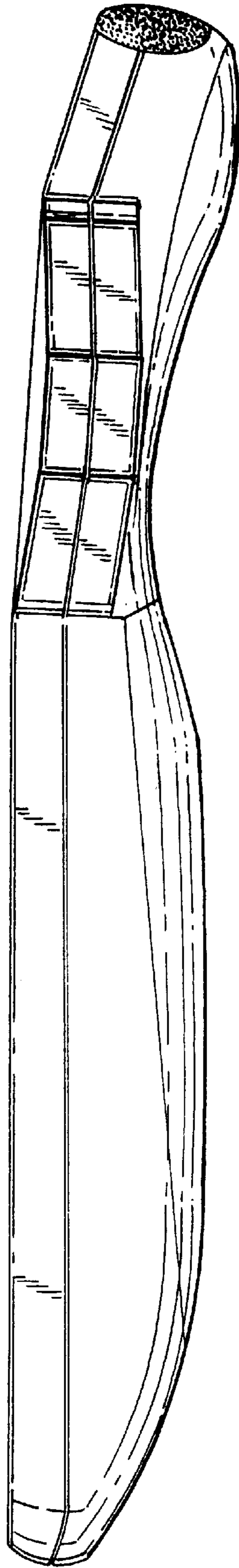
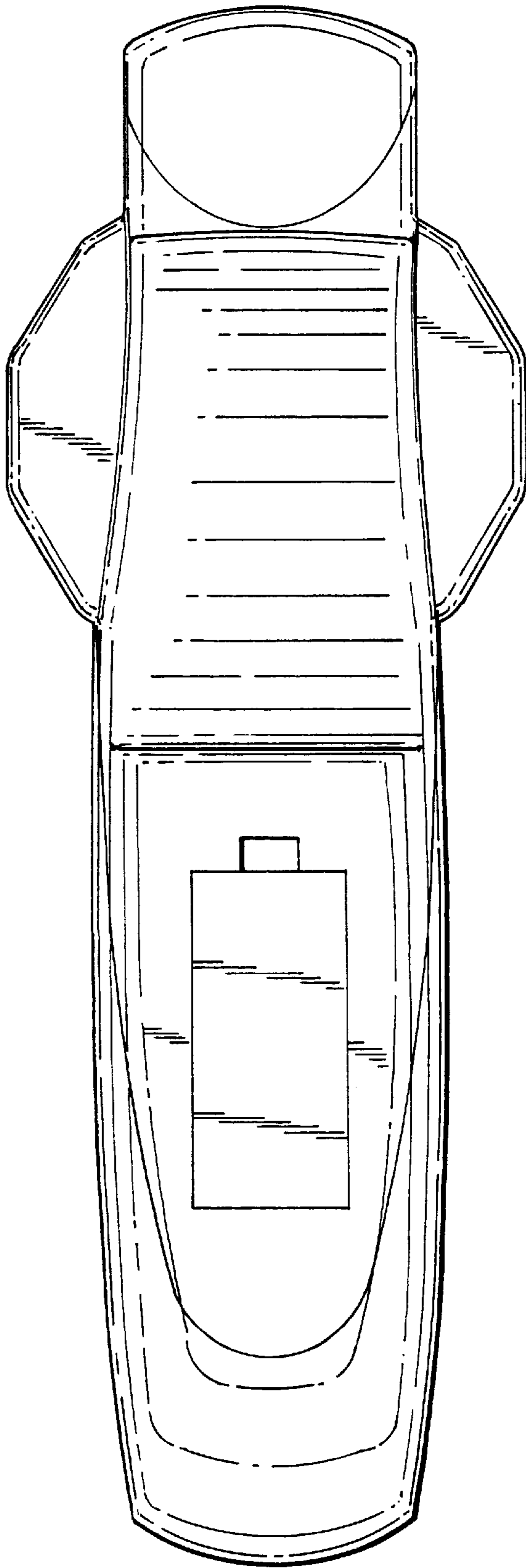

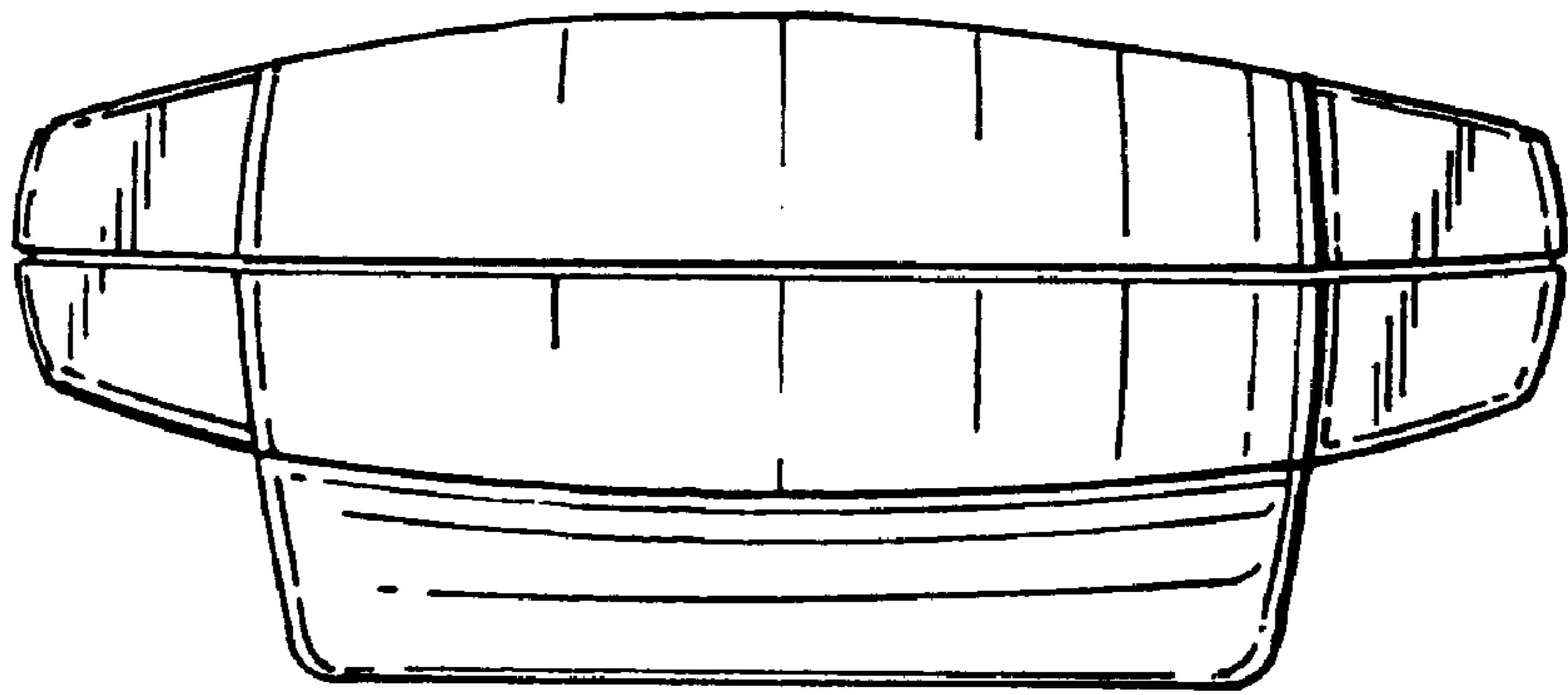

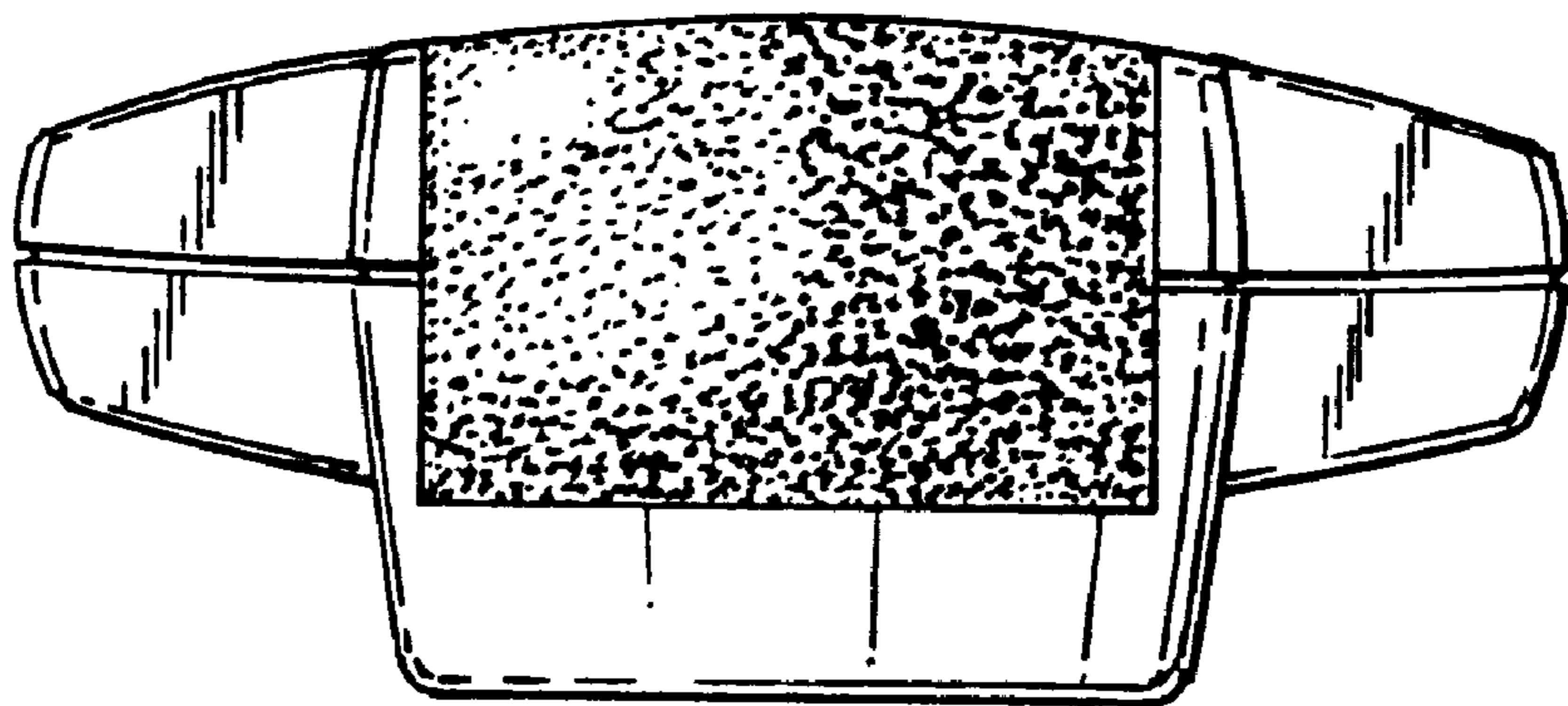
