The ornamental design for a shower control lever, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of our new design for a shower control lever;  
FIG. 2 is a front view thereof;  
FIG. 3 is a left side view thereof, the right side being the same as the left side;  
FIG. 4 is a rear view thereof;  
FIG. 5 is a top view thereof; and  
FIG. 6 is a bottom view thereof.

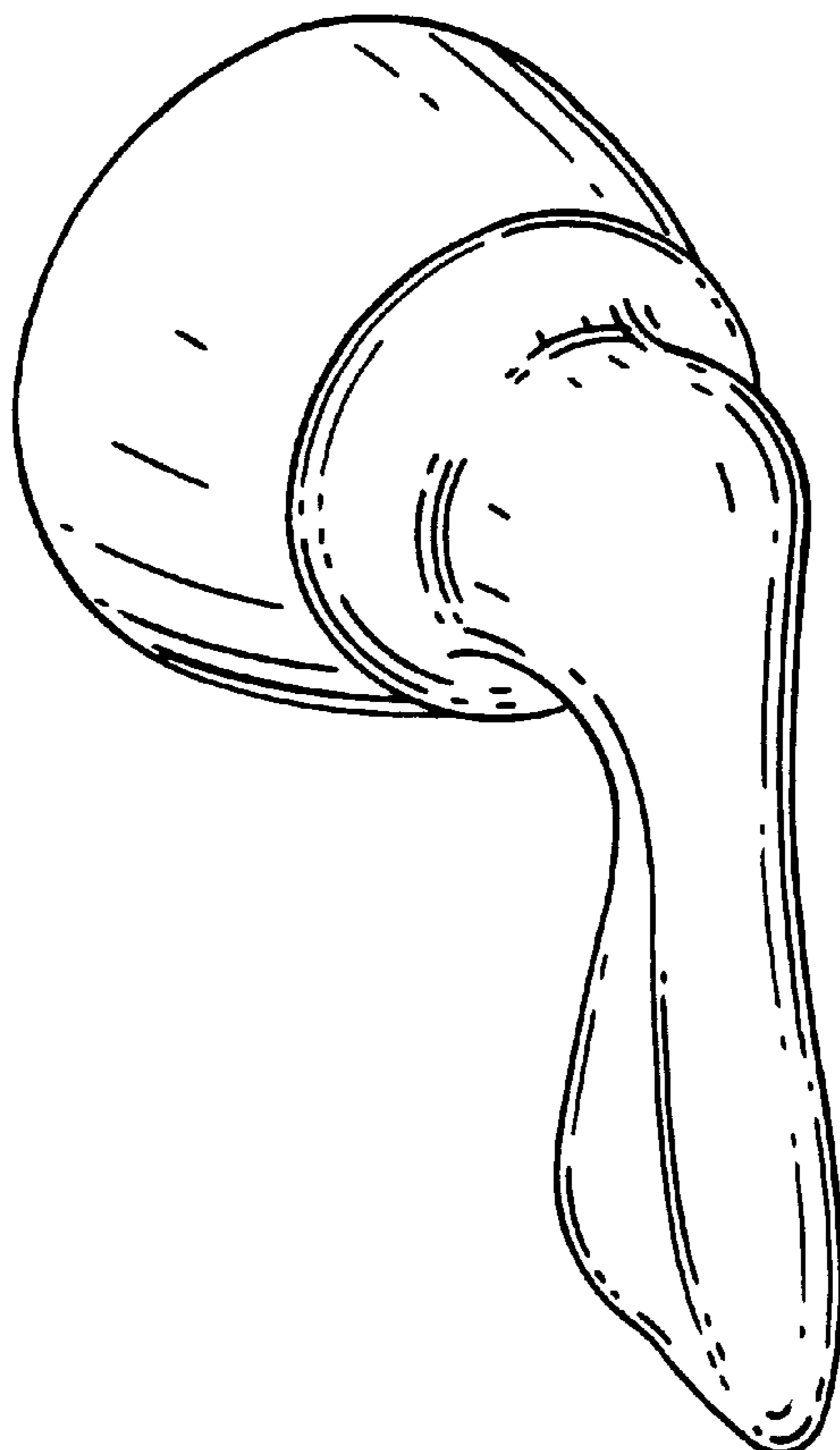

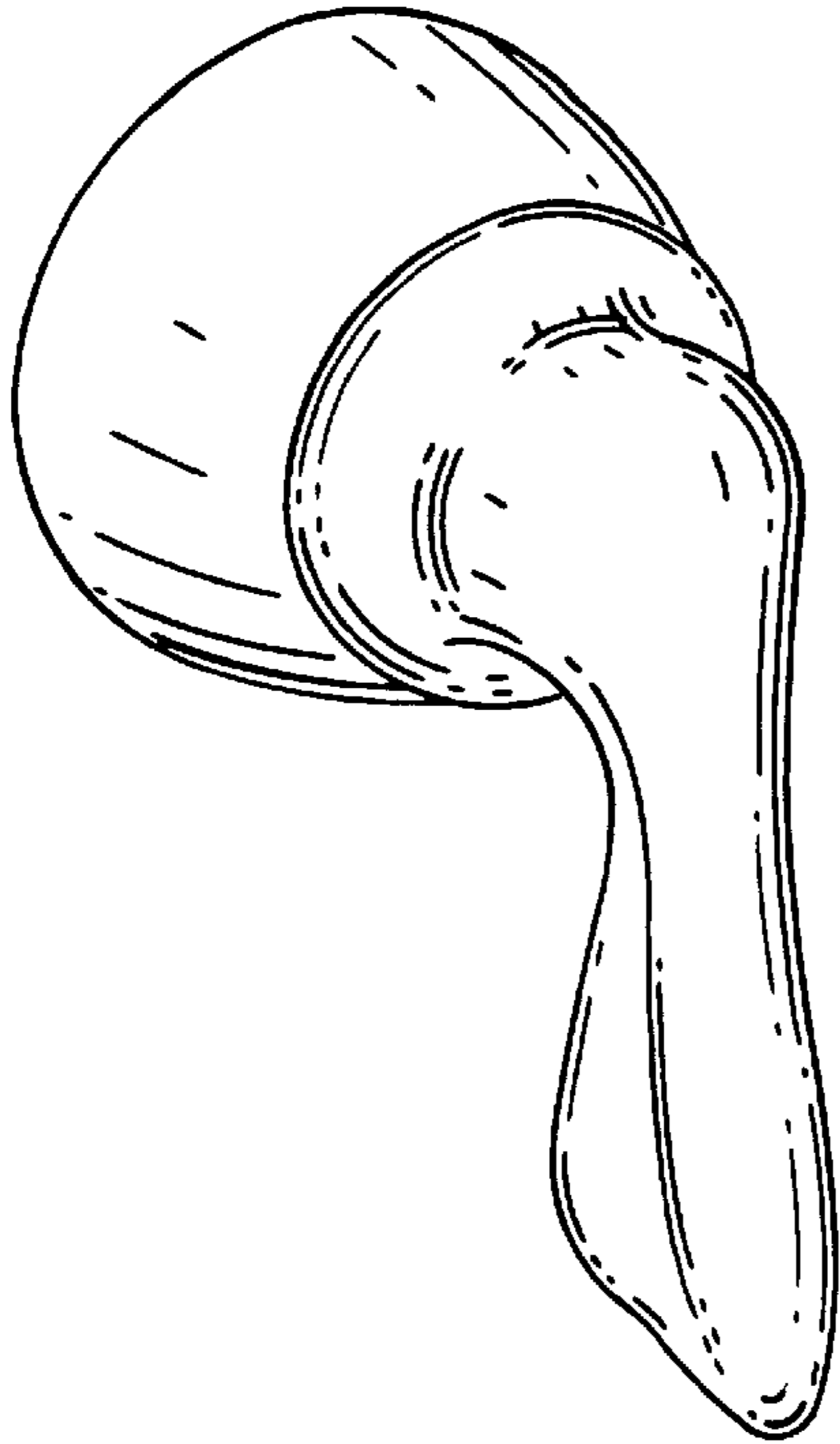

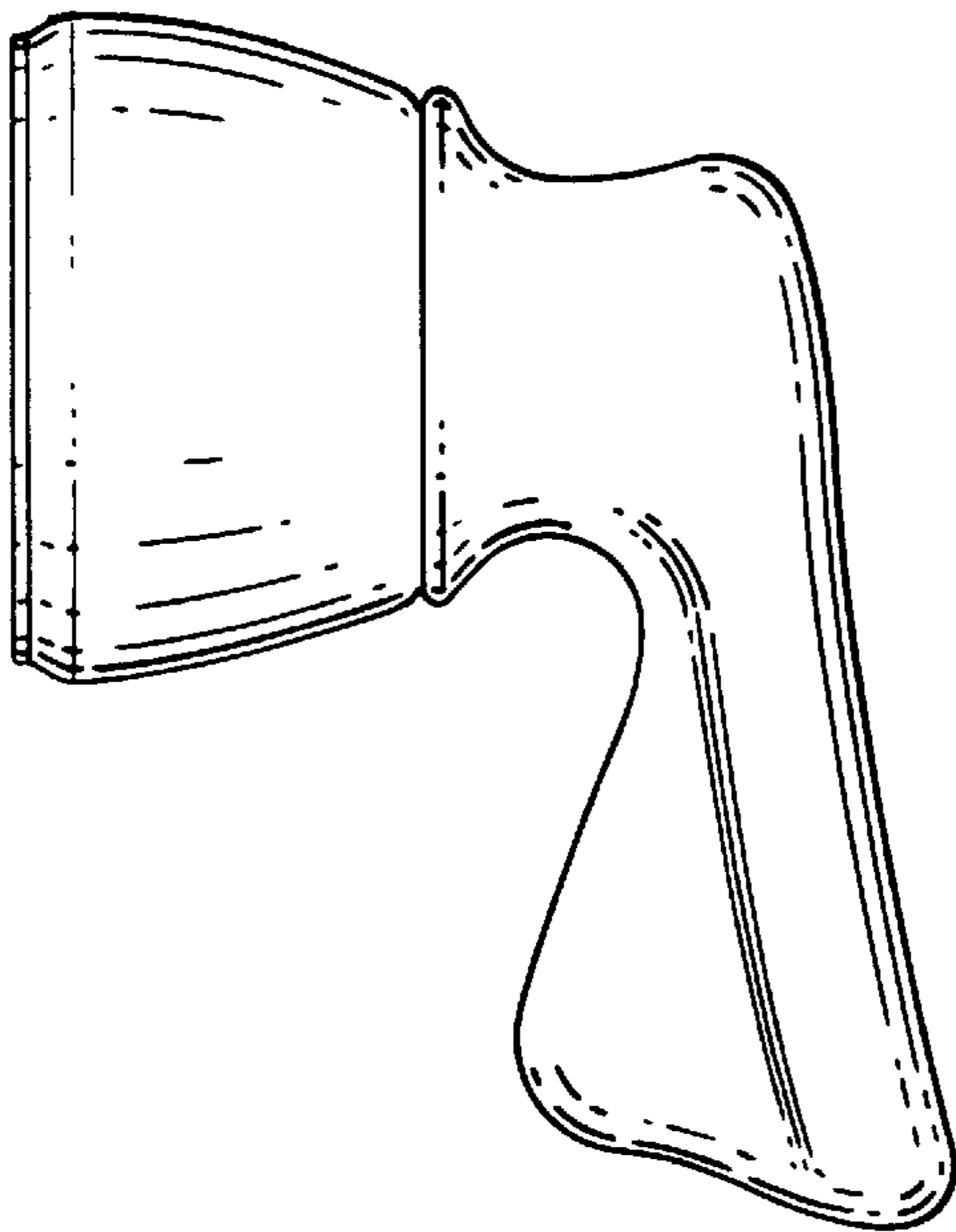
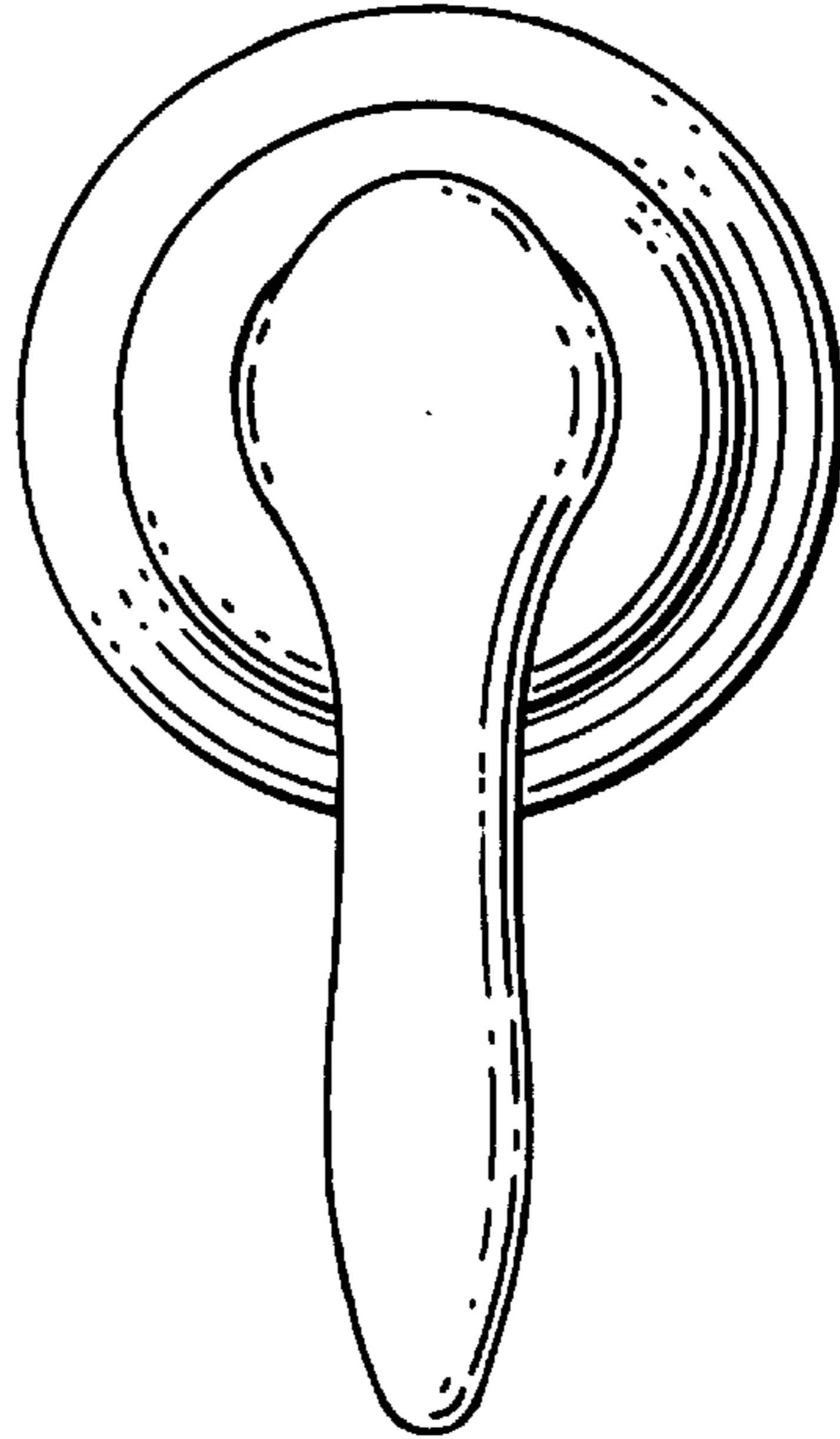

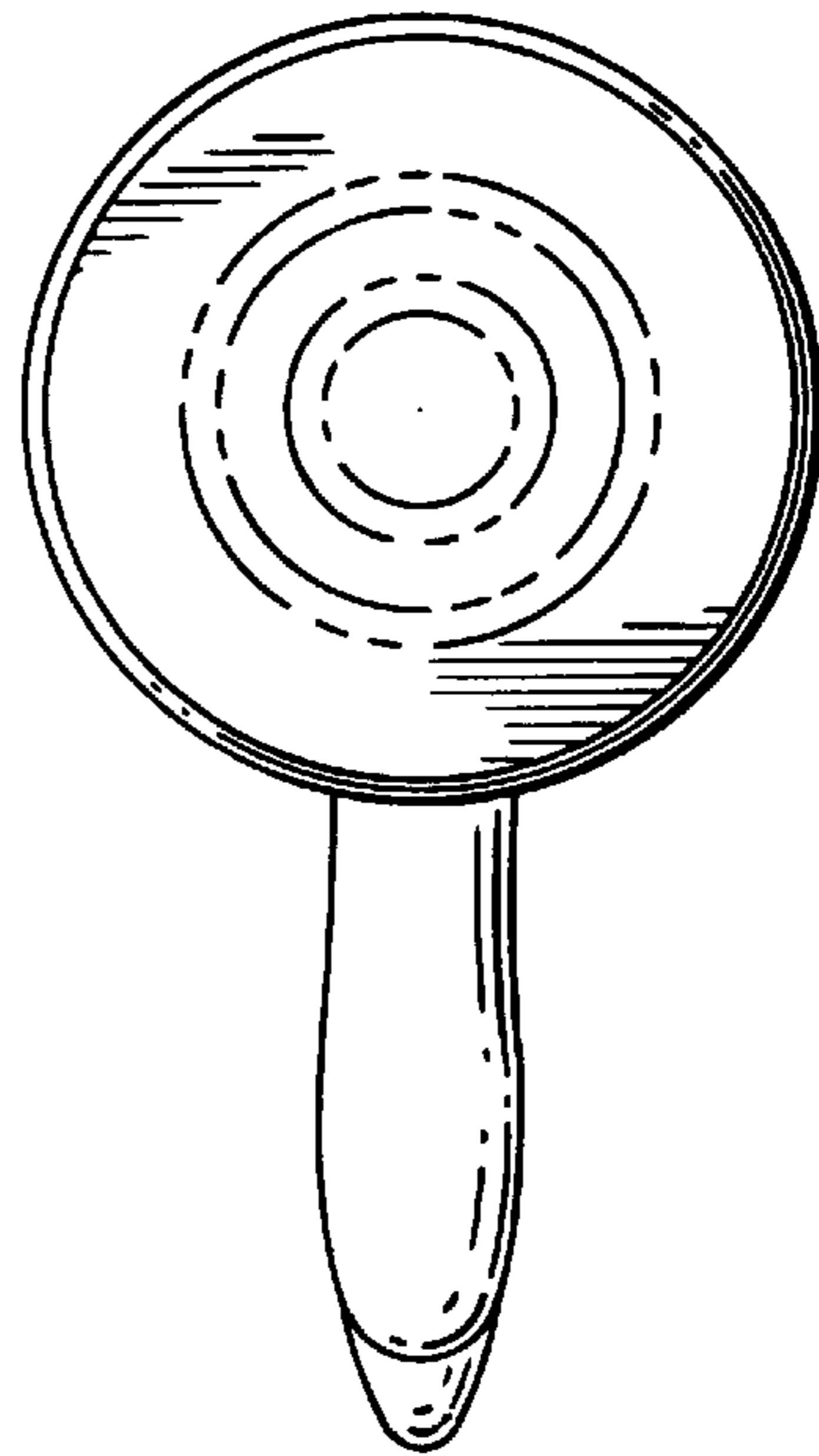

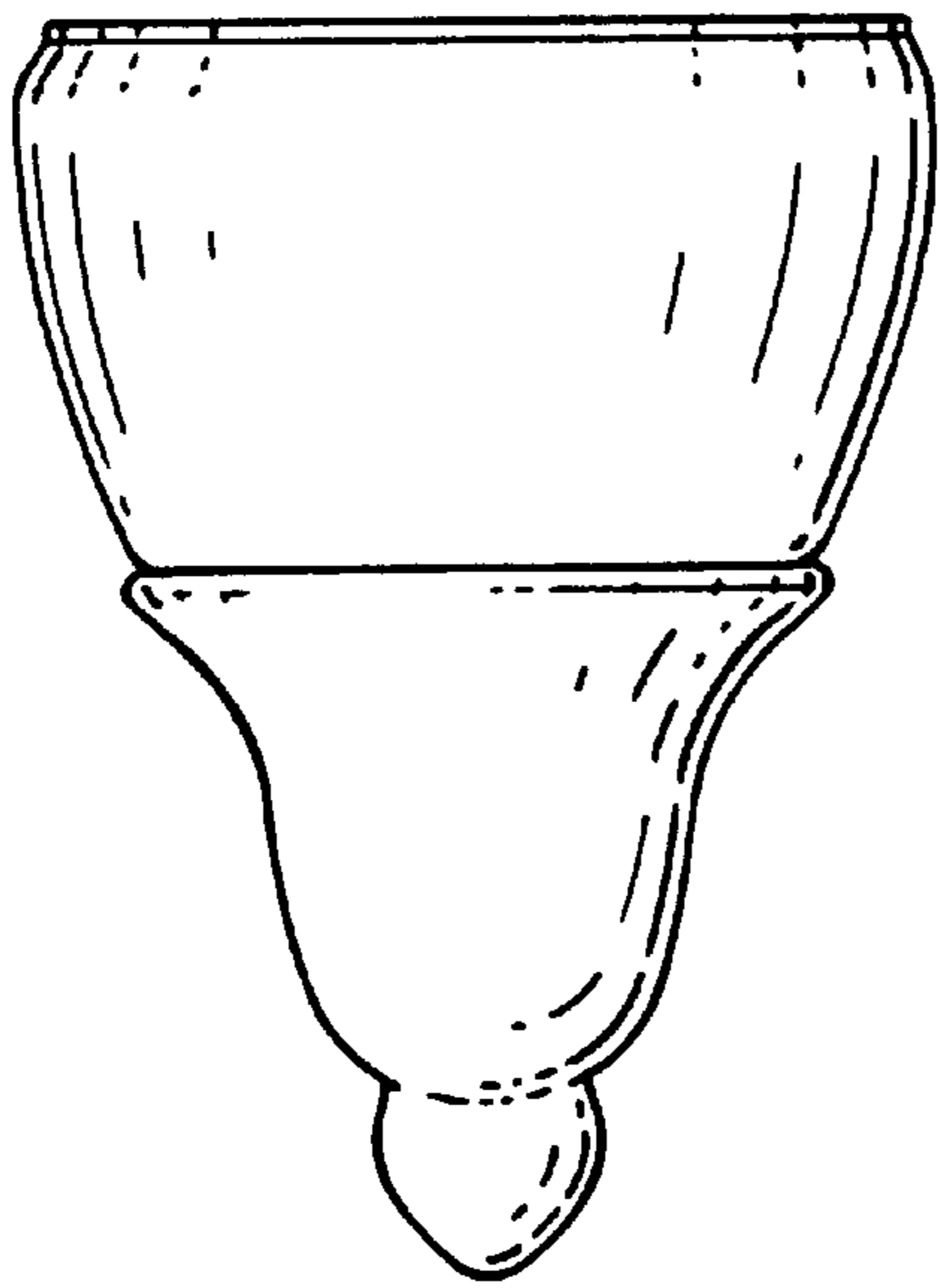

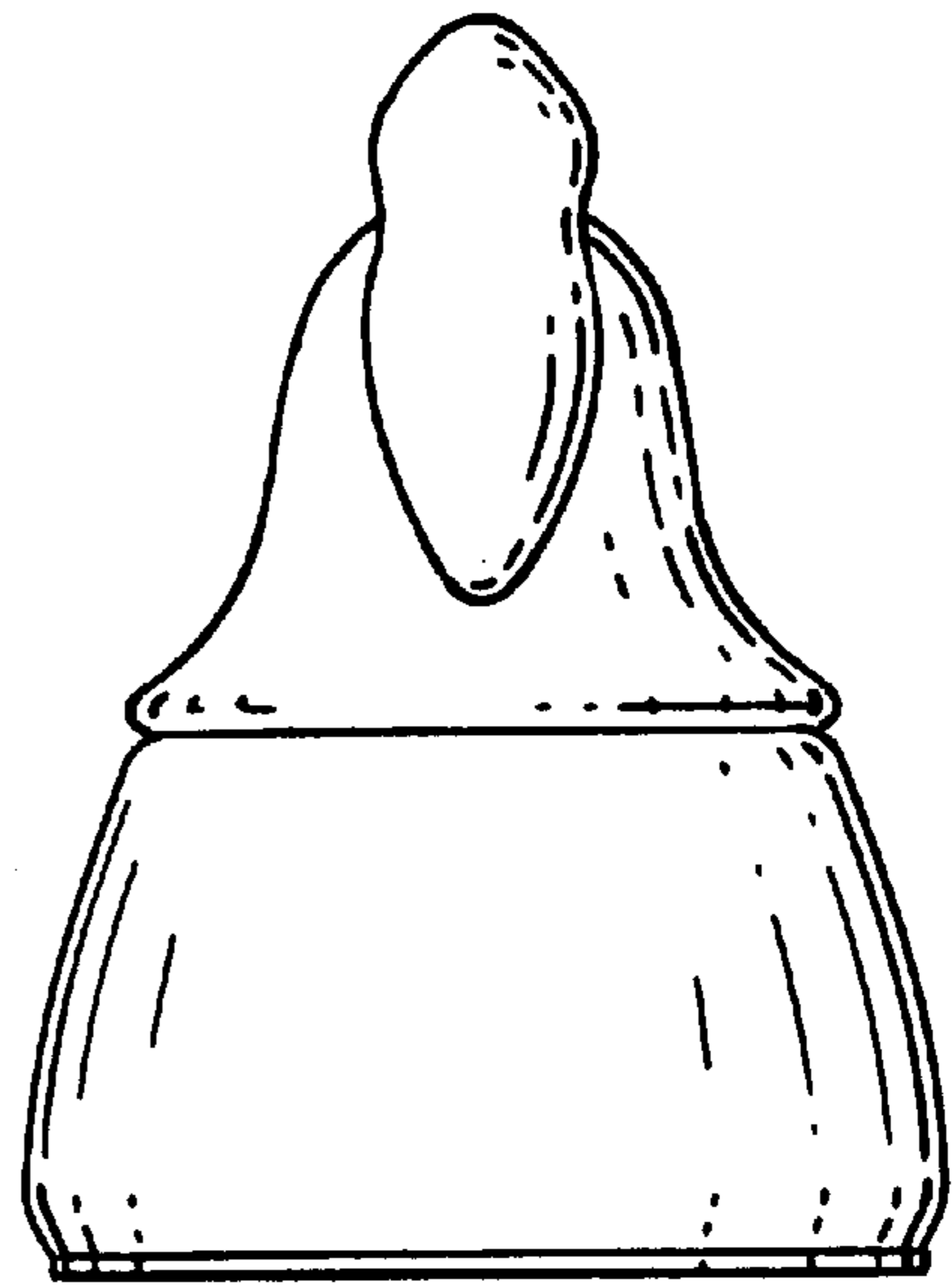
