[57] CLAIM

The ornamental design for an electric face cleaner, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view showing the top, front and right side of our new design for an electric face cleaner;

FIG. 9 is a rear elevational view thereof;

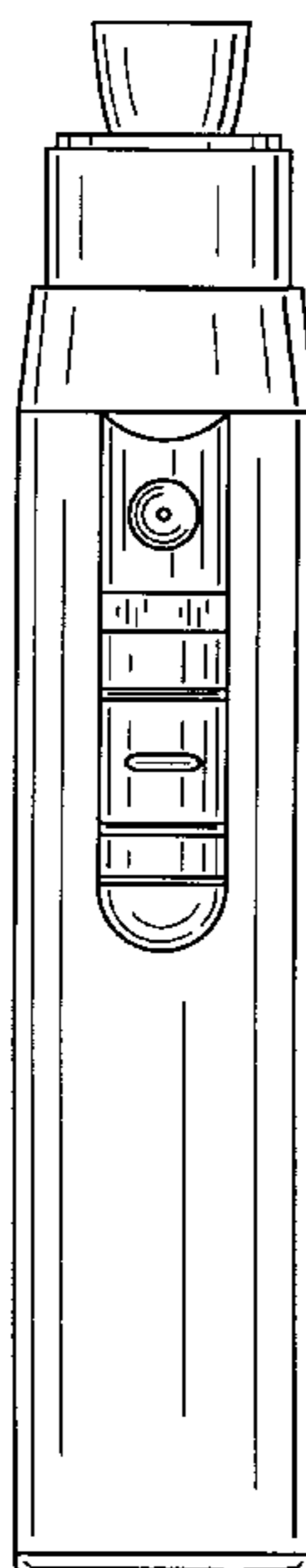
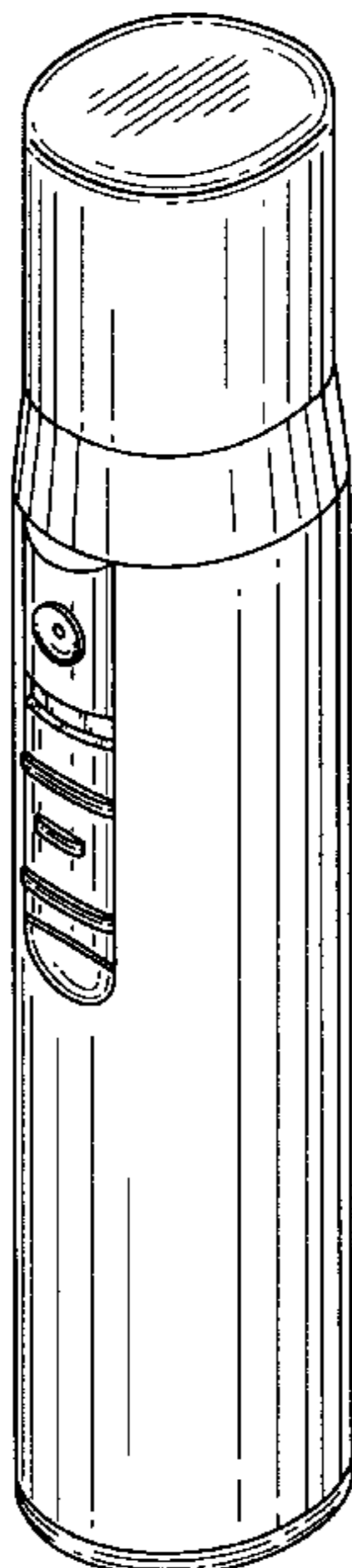
FIG. 10 is a right side elevational view thereof;

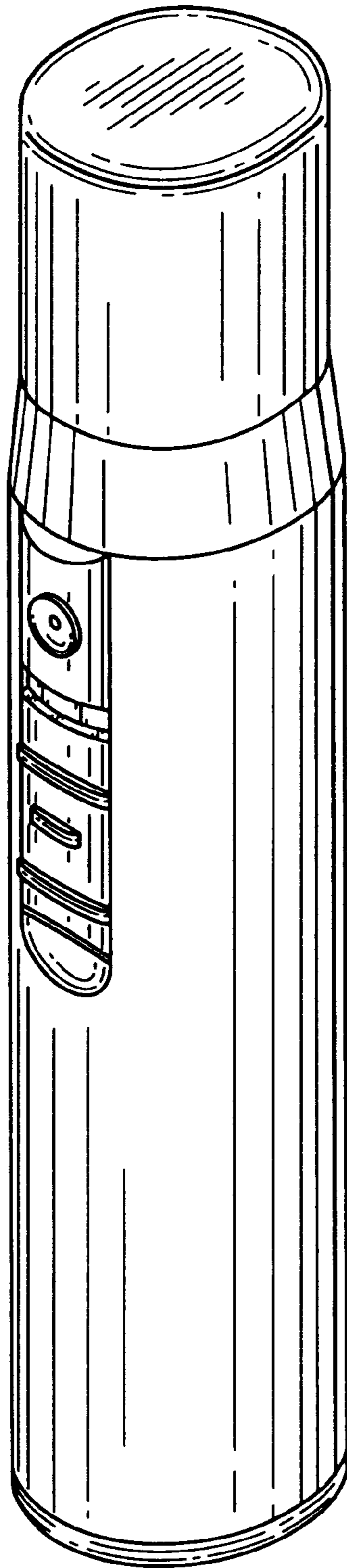

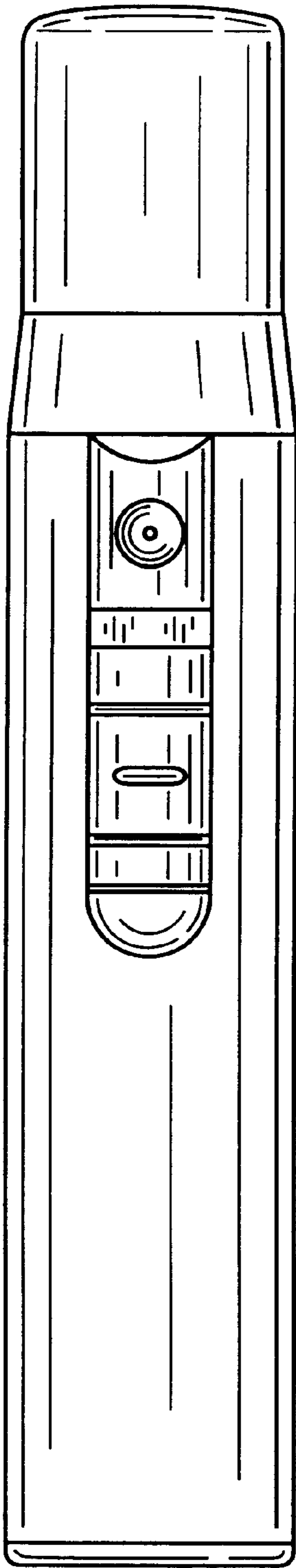

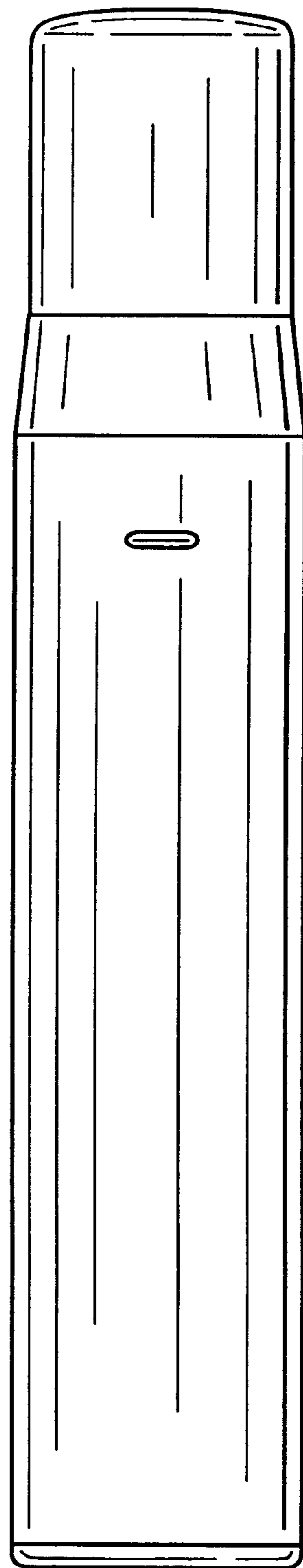

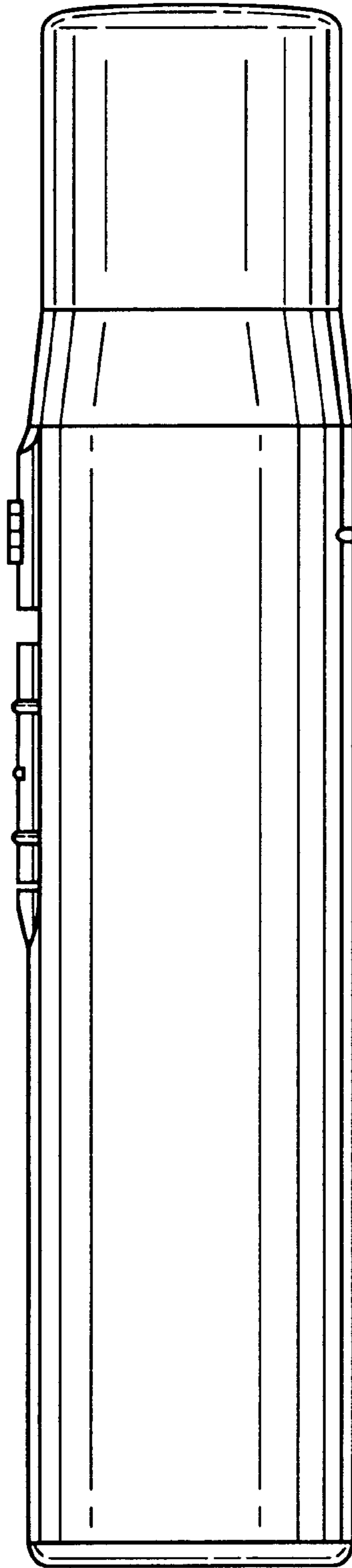

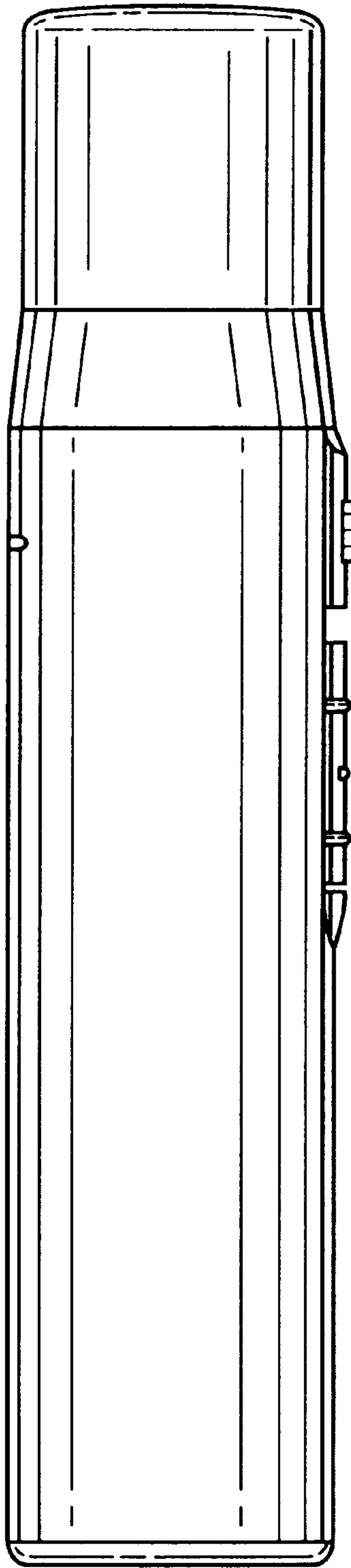

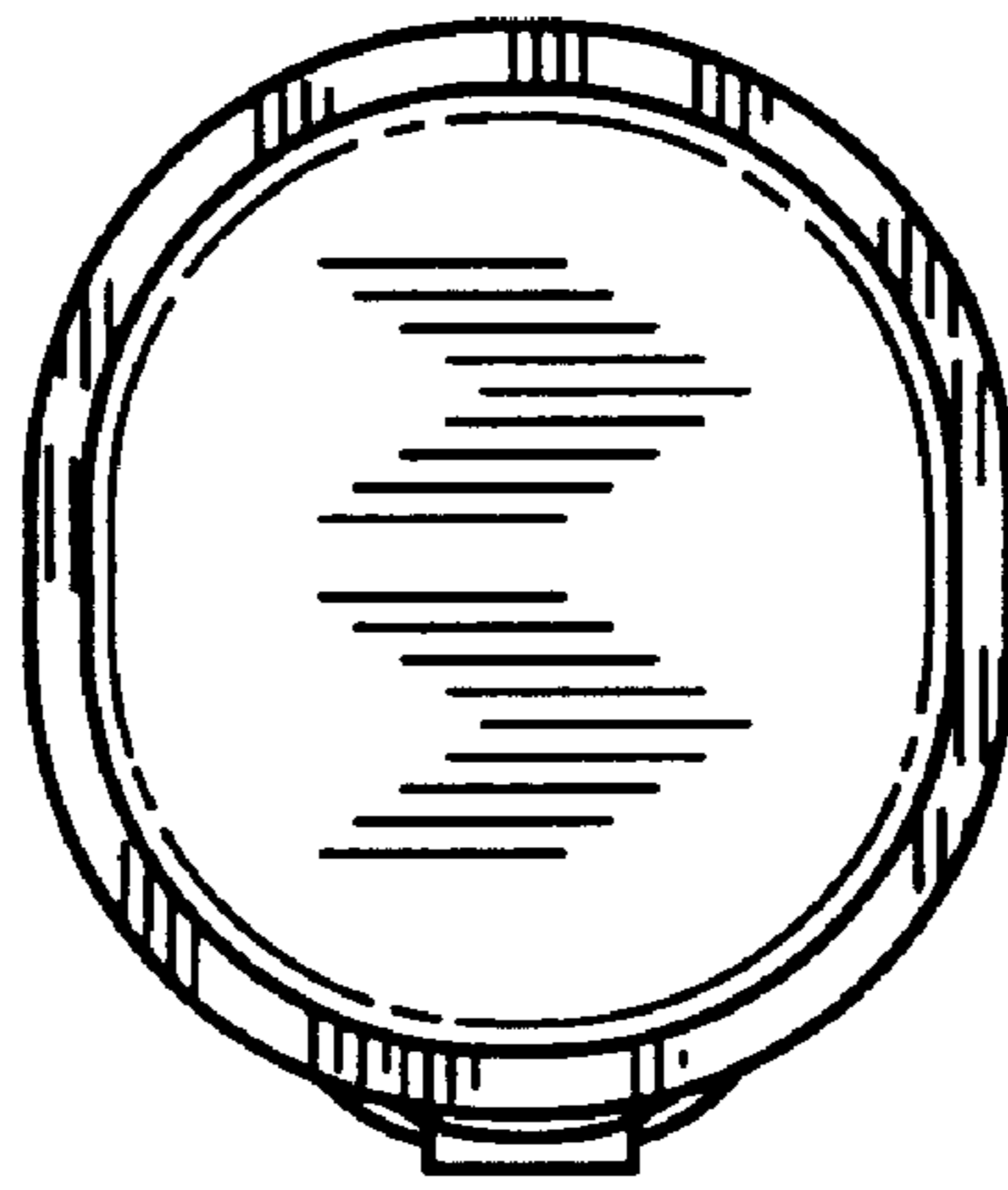

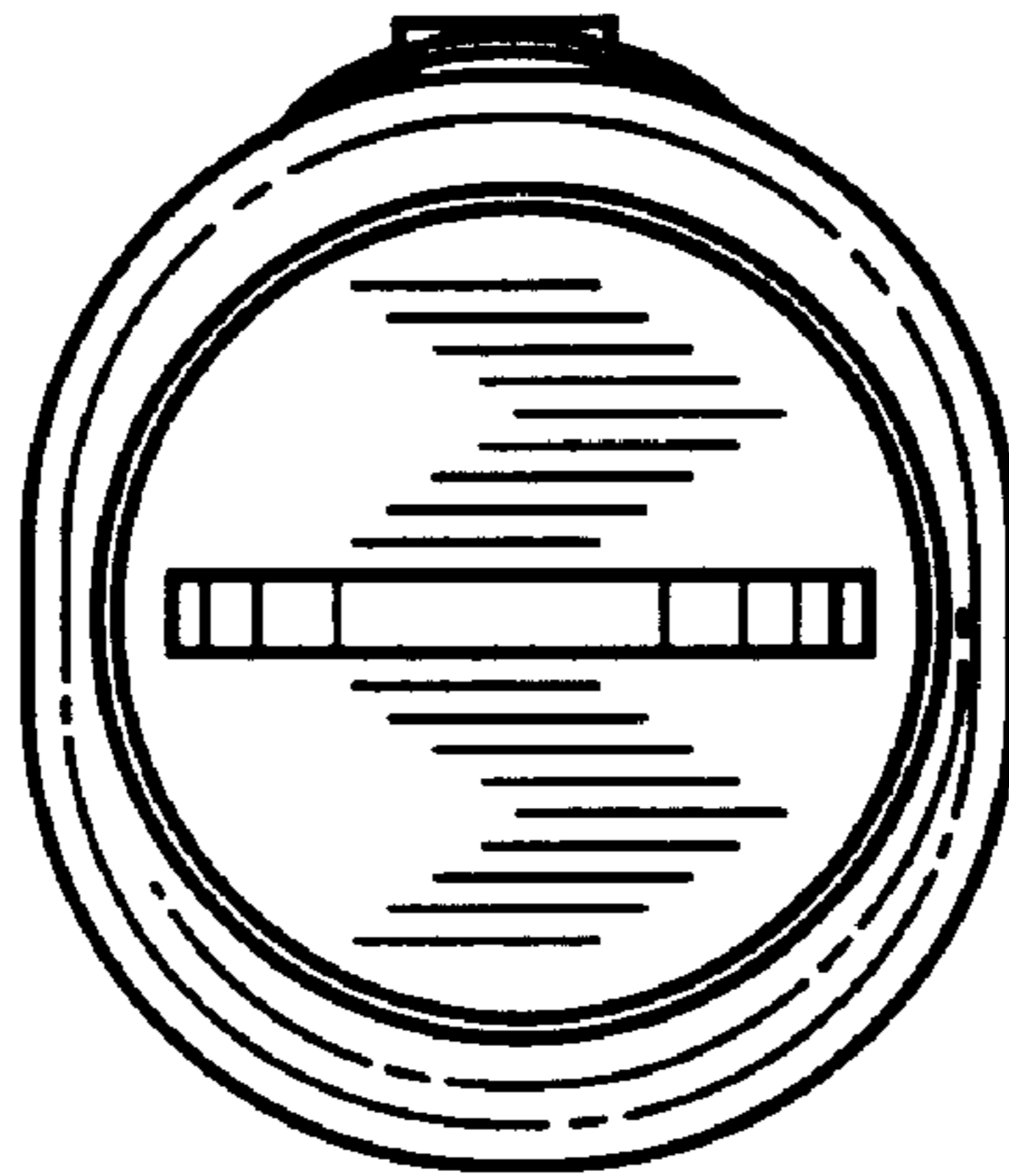

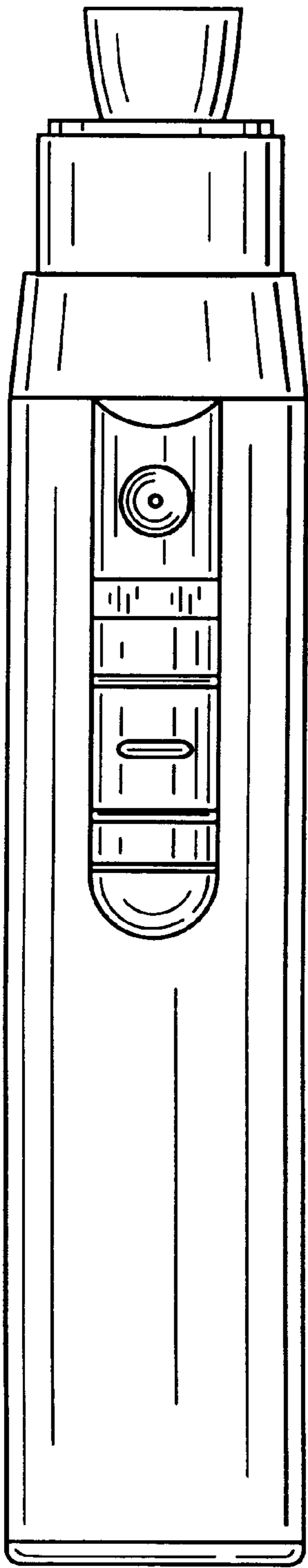

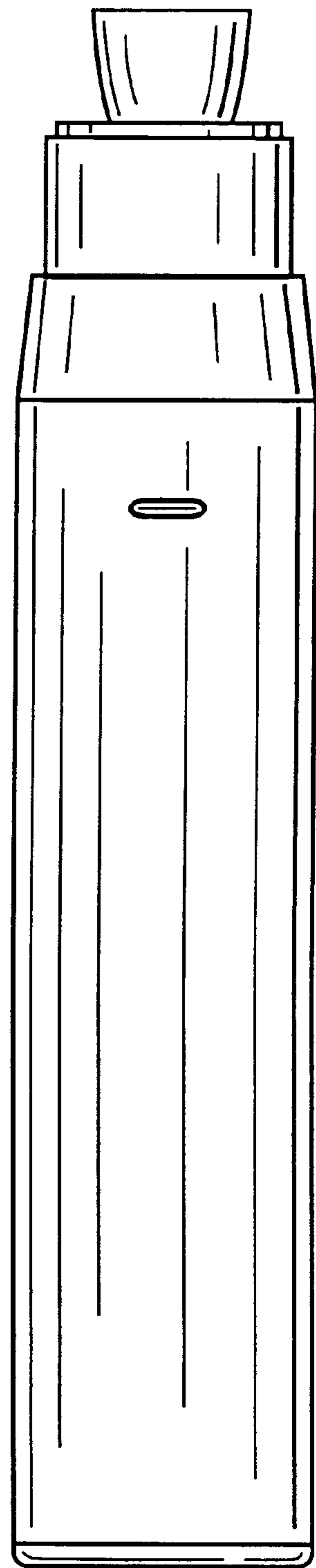

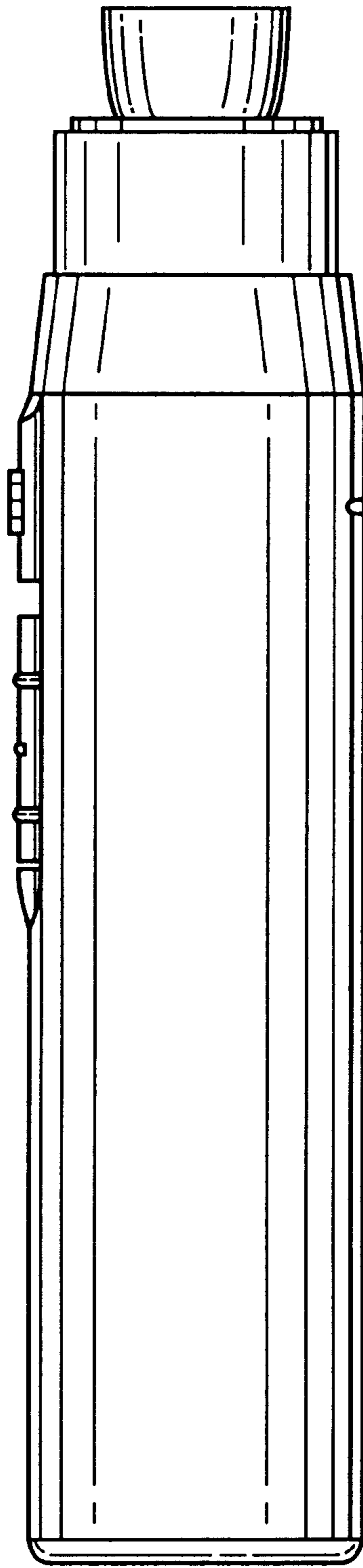

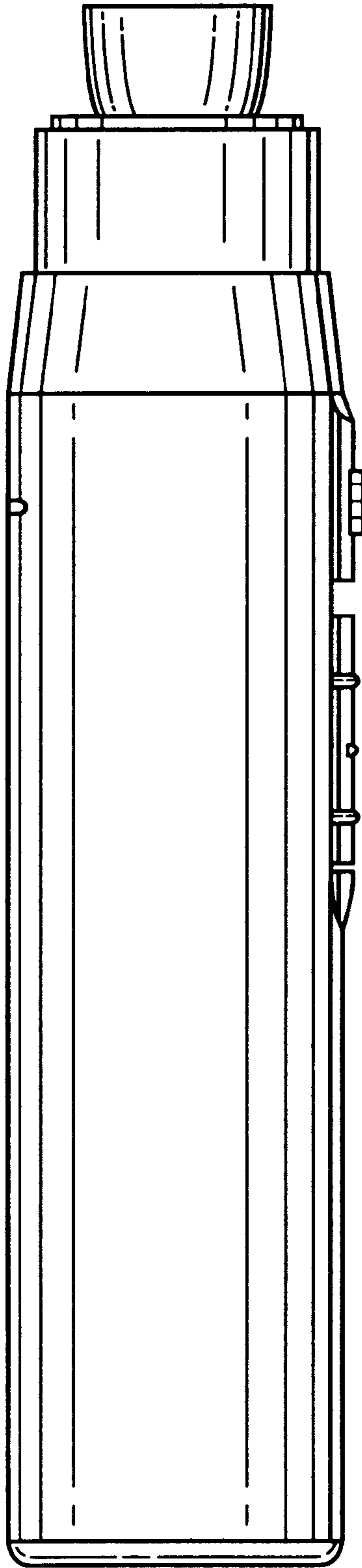

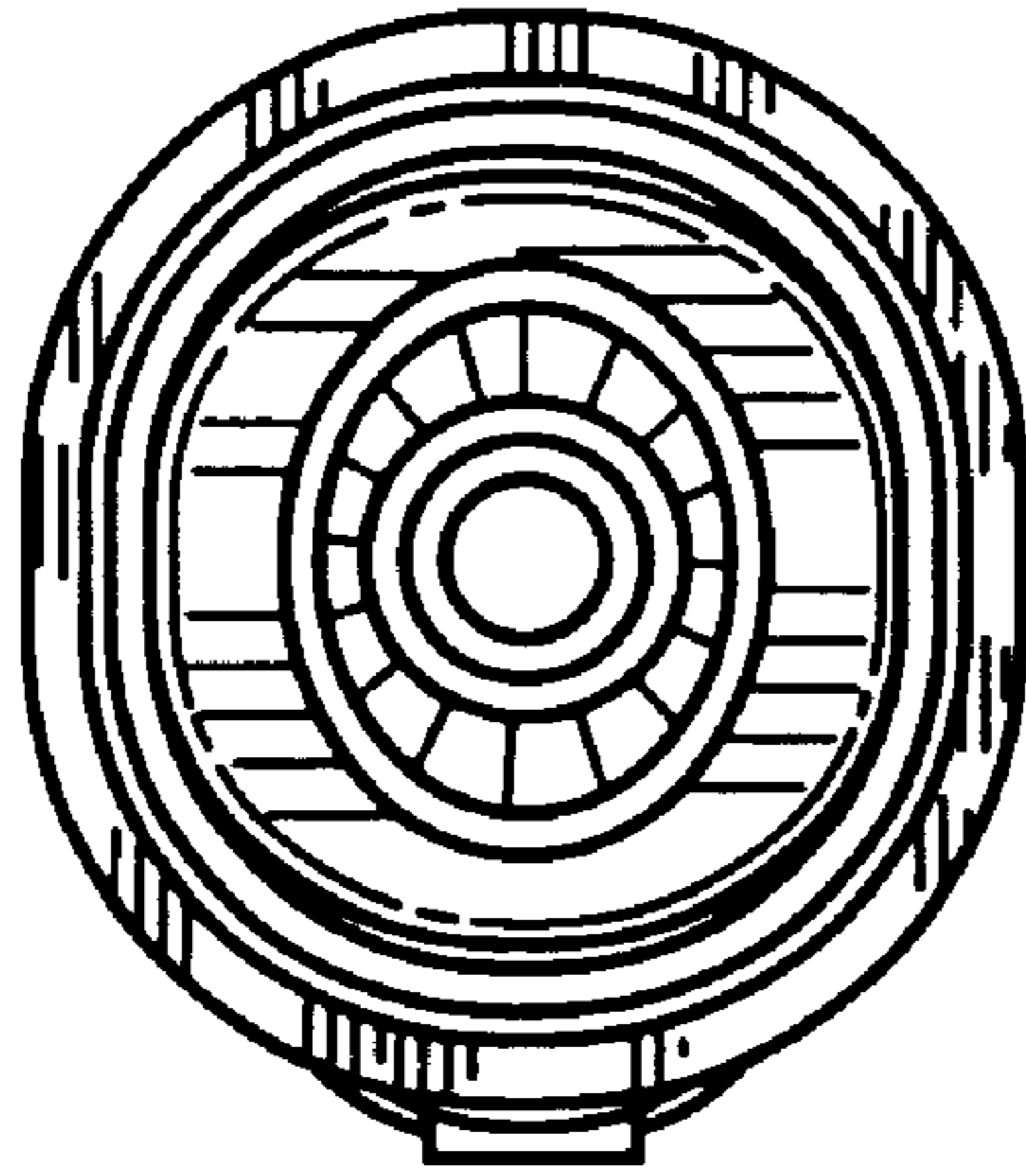

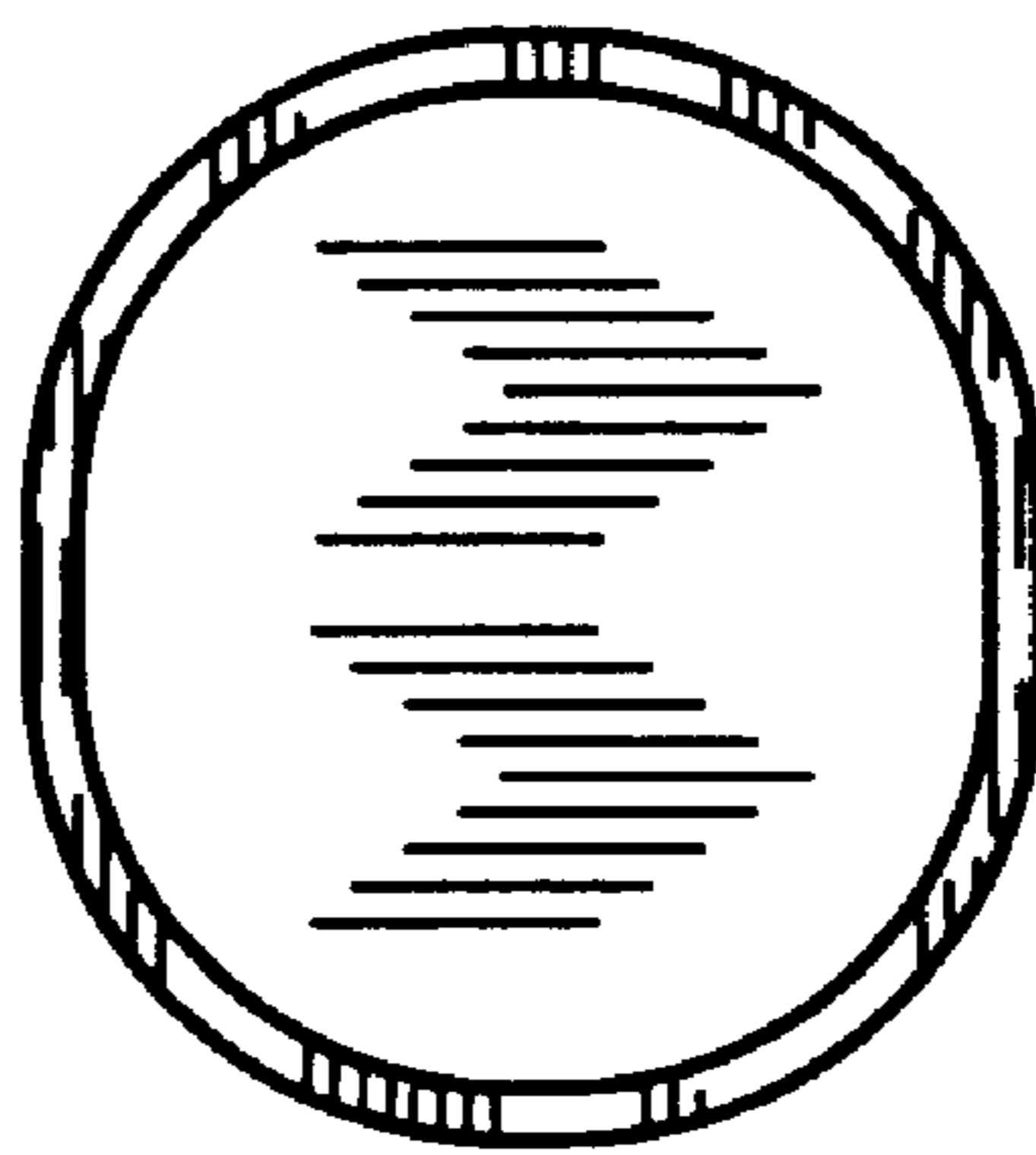
