[57] **CLAIM**

The ornamental design for a cosmetic tray, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a cosmetic tray showing my new design; the broken line showing of two cosmetic containers, spool and wire are for illustrative purposes only and form no part of the claimed design;

FIG. 2 is a top view thereof; the broken line showing an electrical cord is for illustrative purposes only and forms no part of the claimed design;

FIG. 3 is a front view thereof;

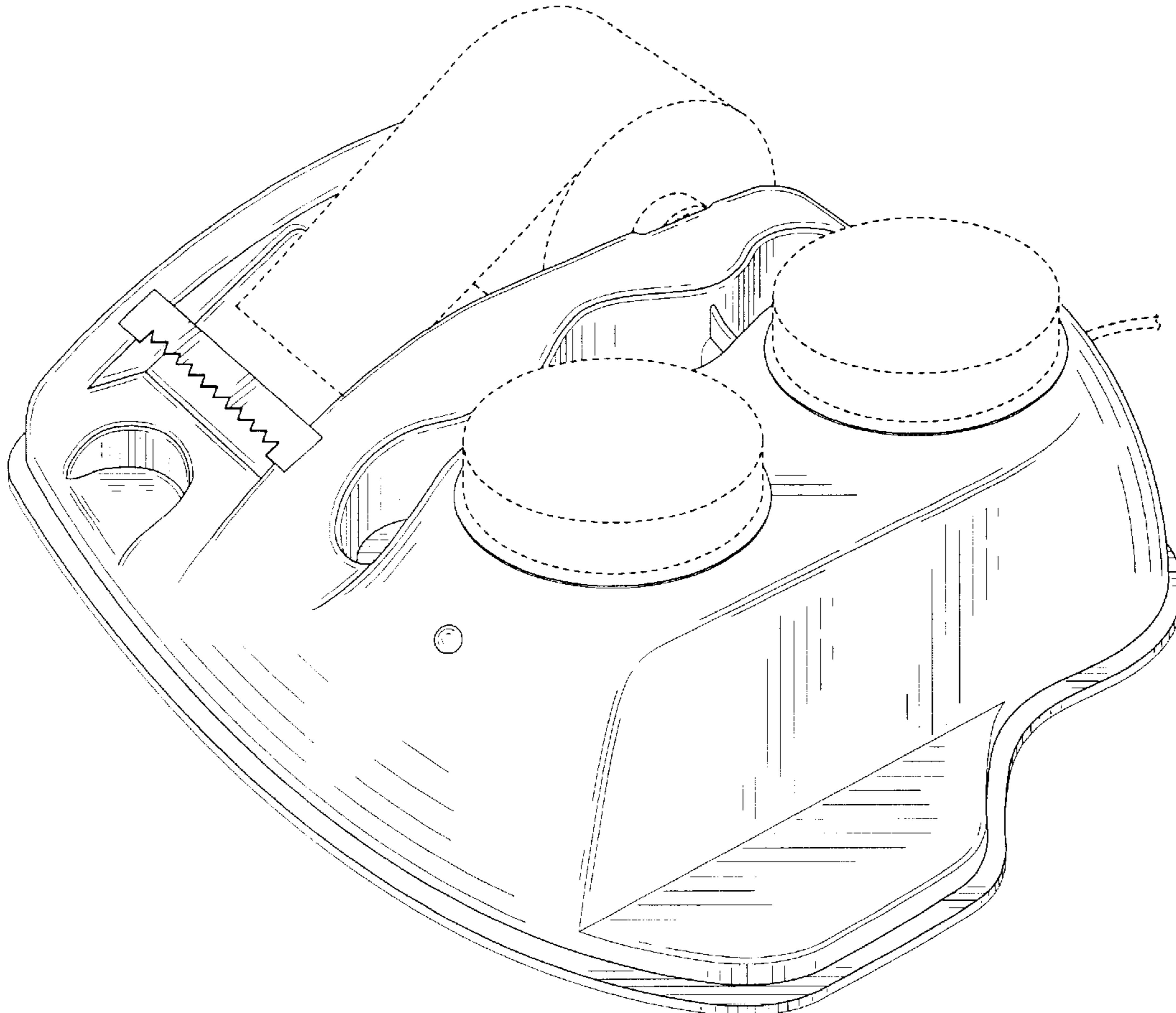
FIG. 4 is a right side elevational view thereof;

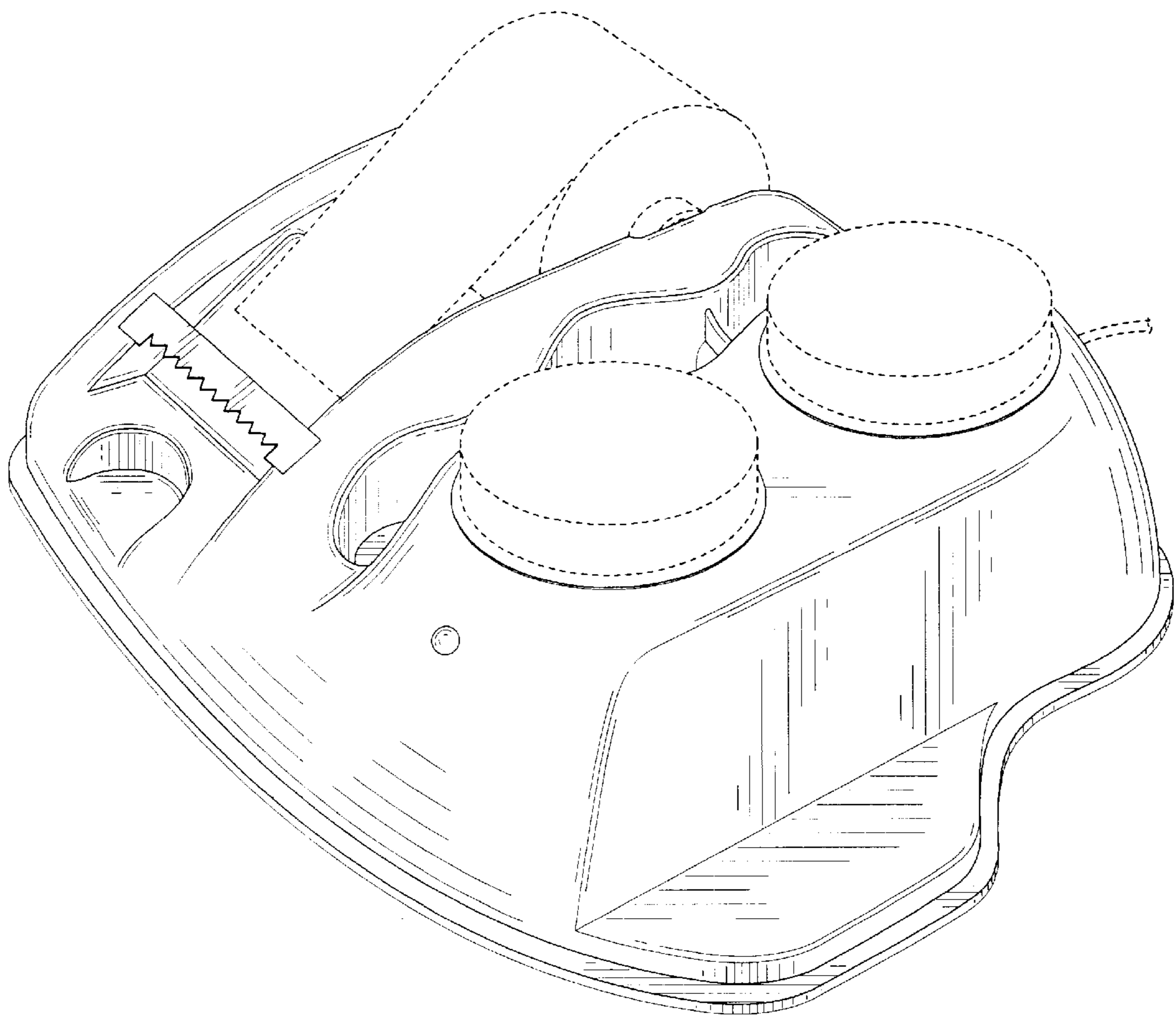

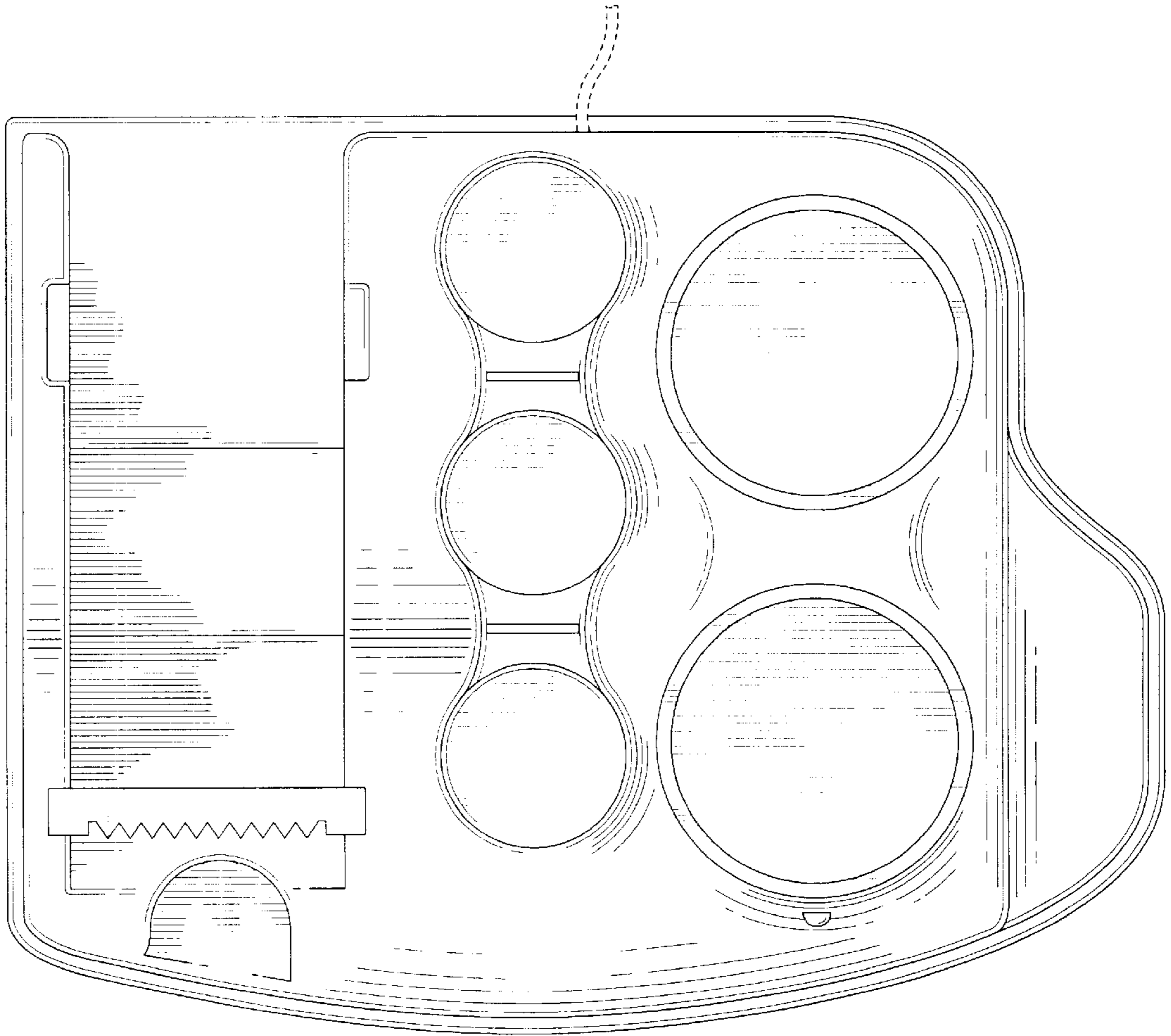

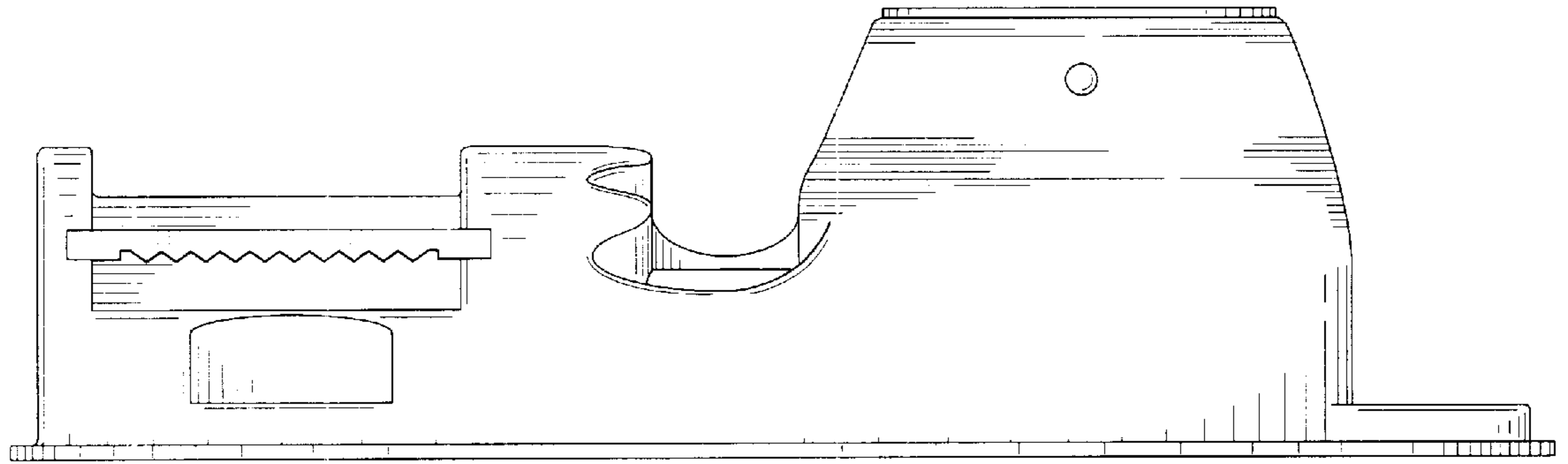

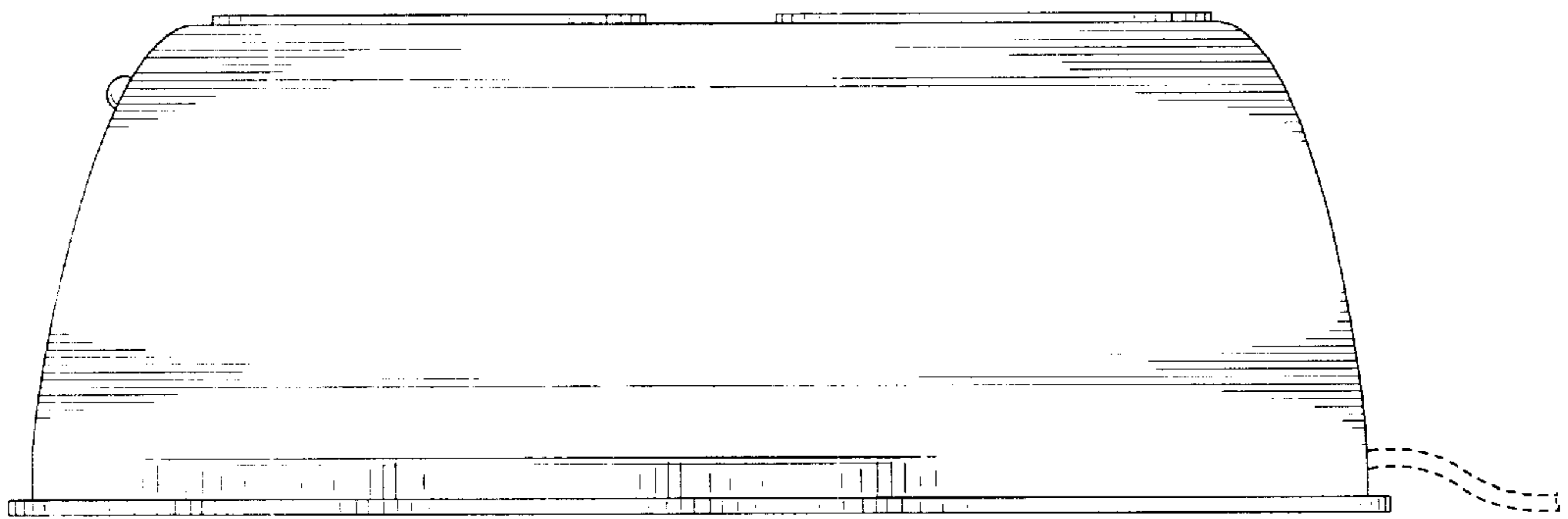

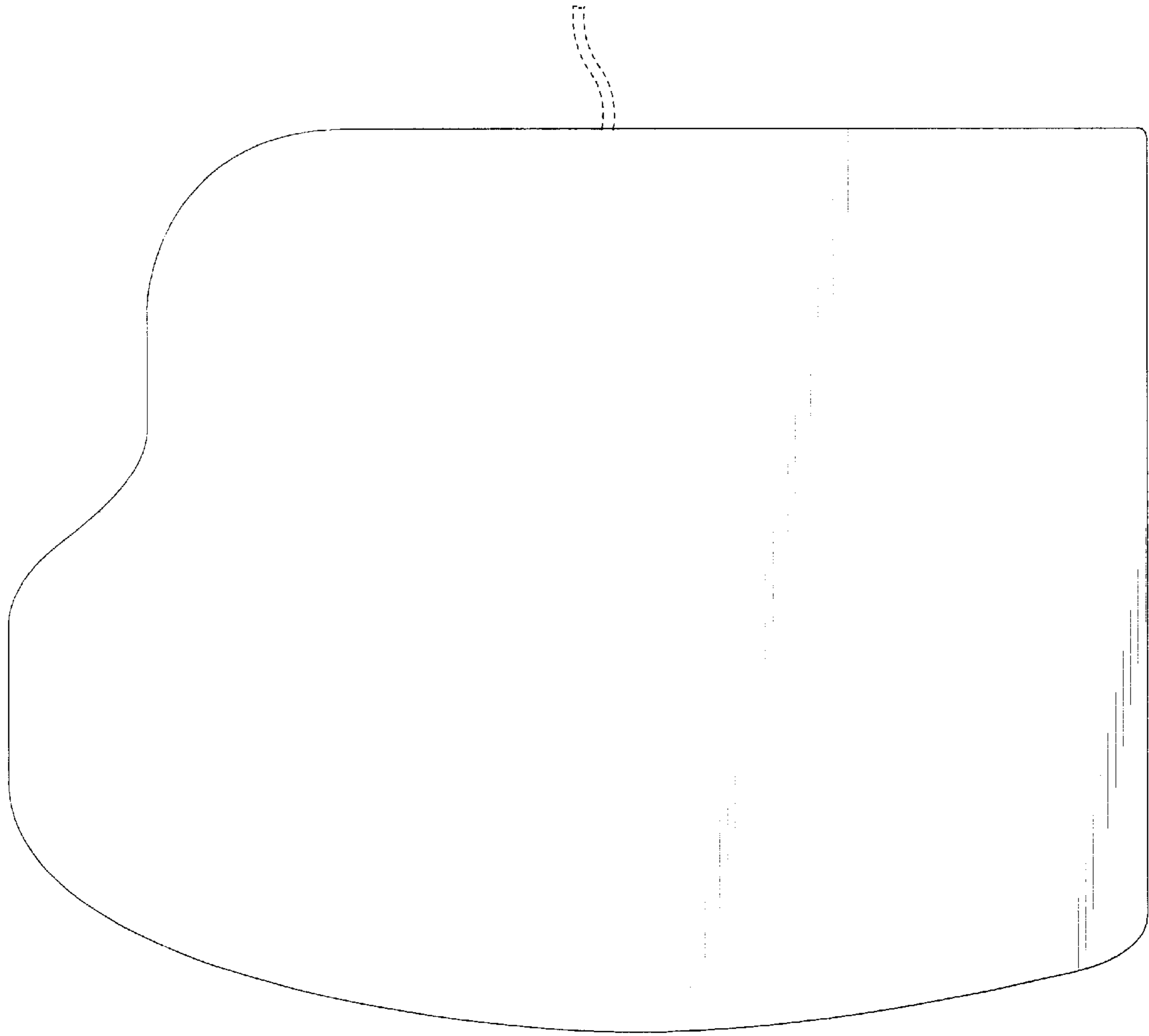

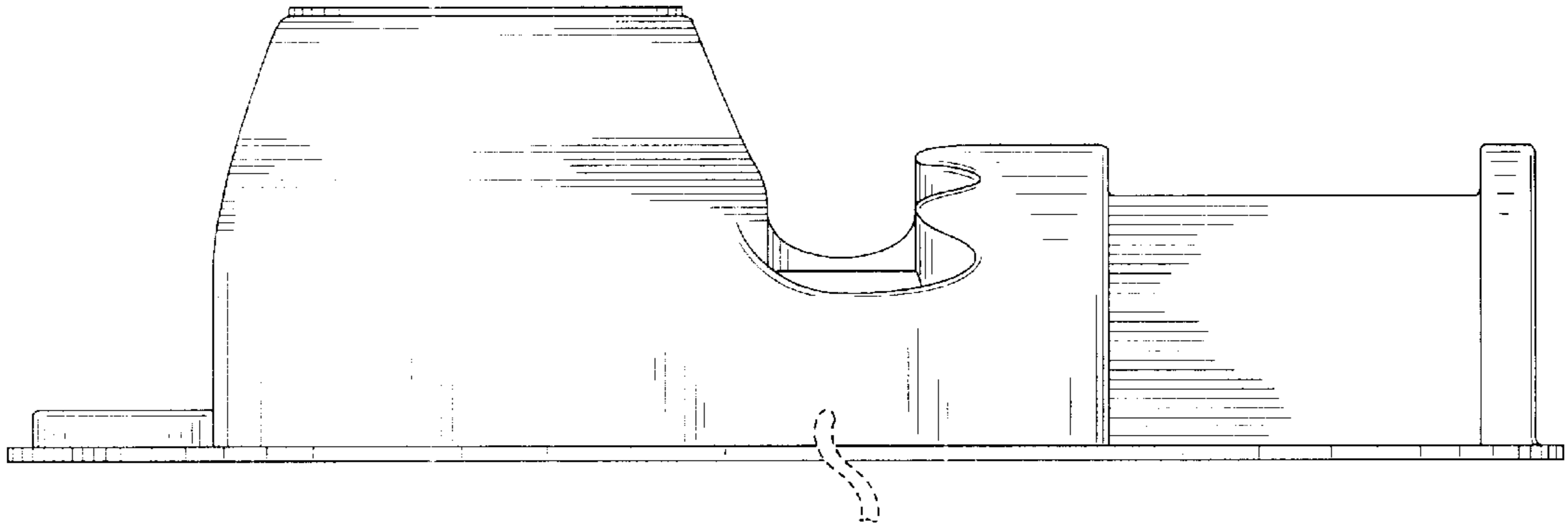

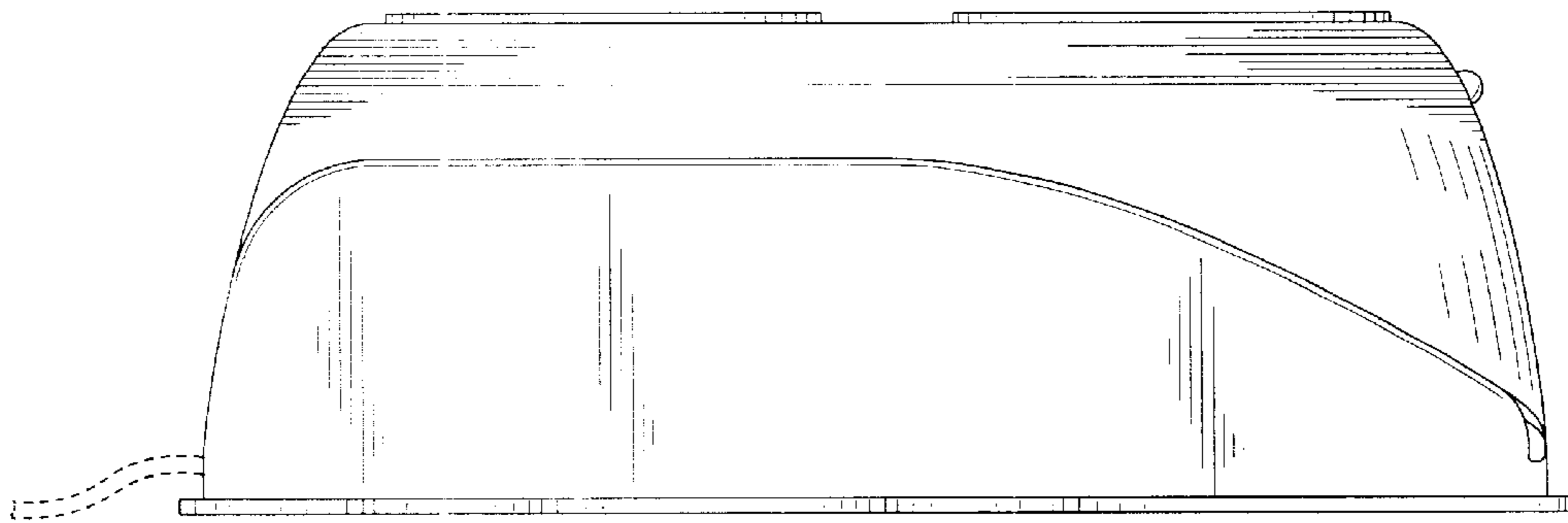
