FIG. 14 is a front and bottom perspective view thereof shown in condition of use on a human arm.

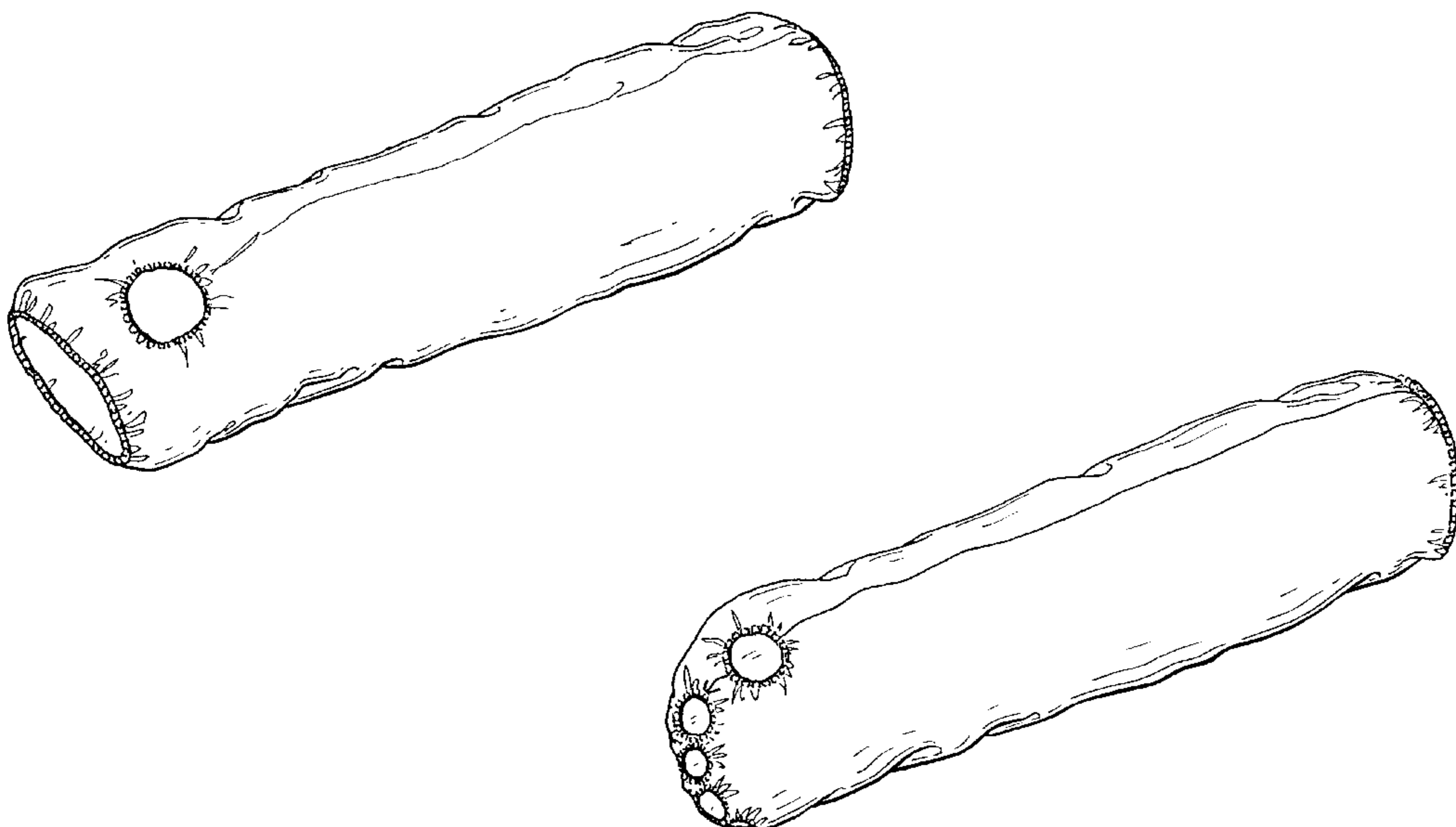

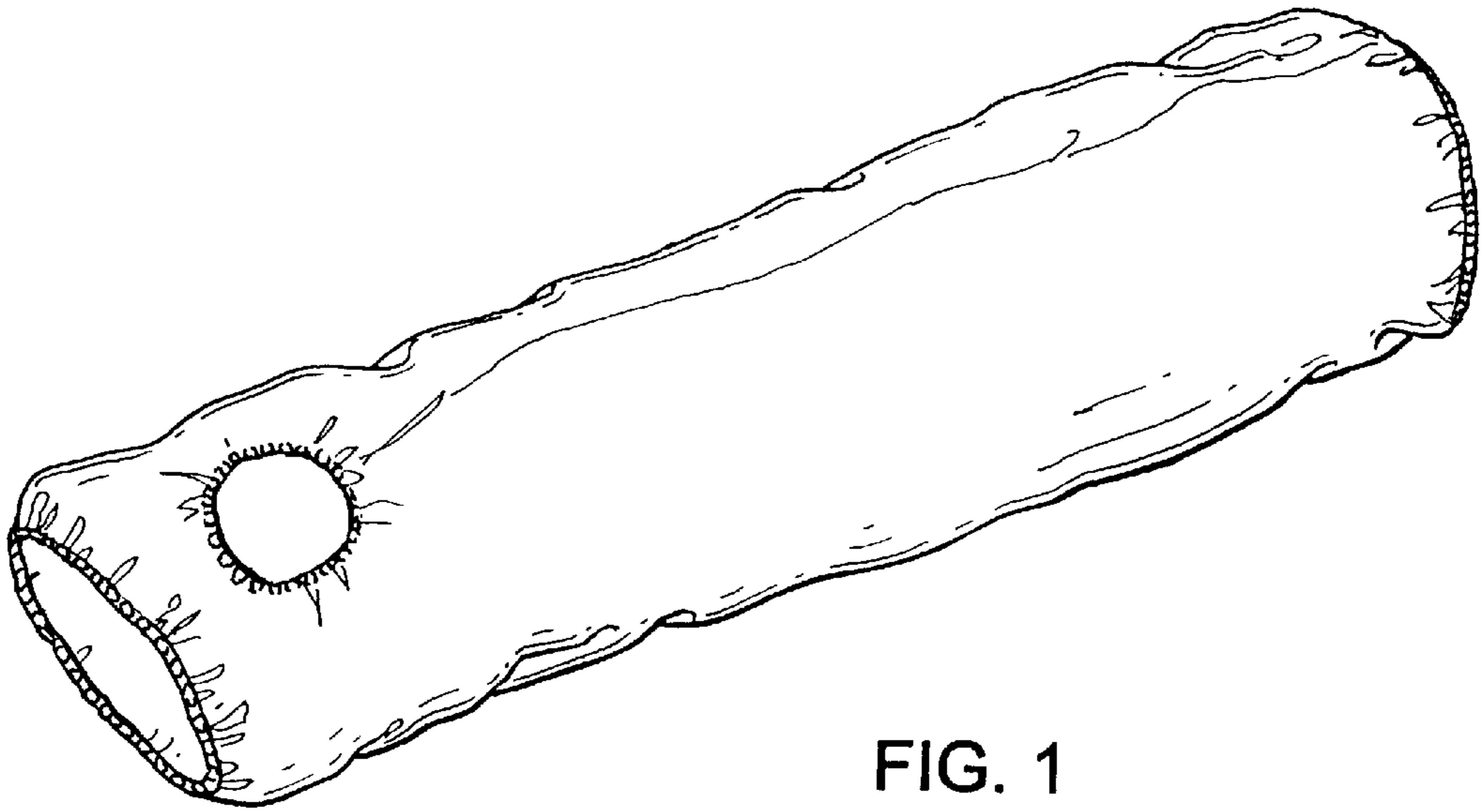

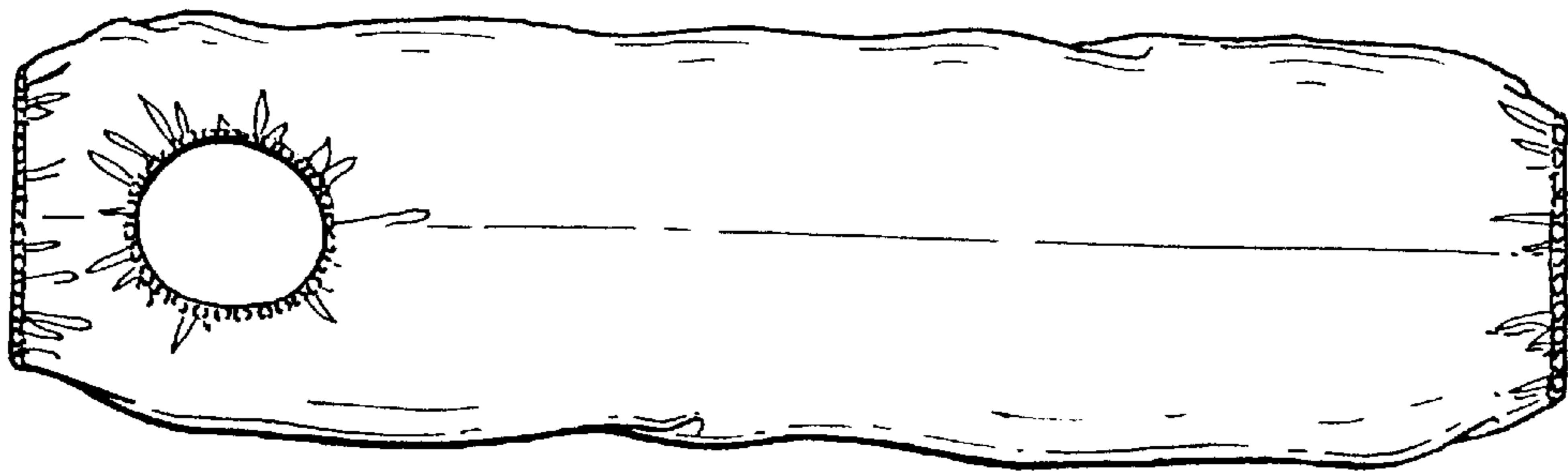

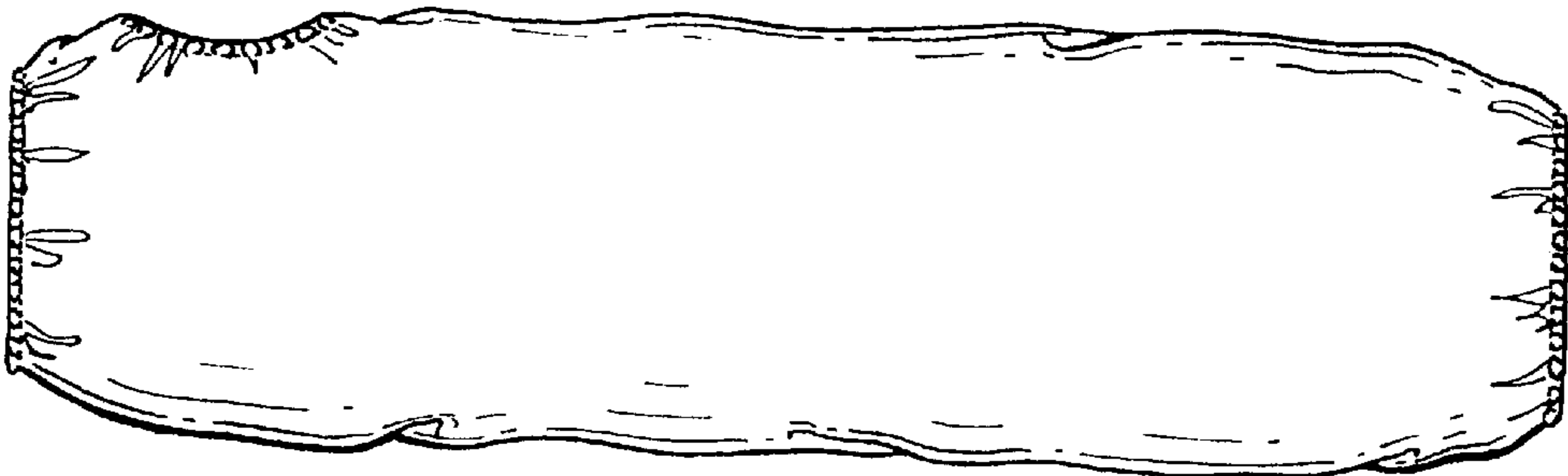

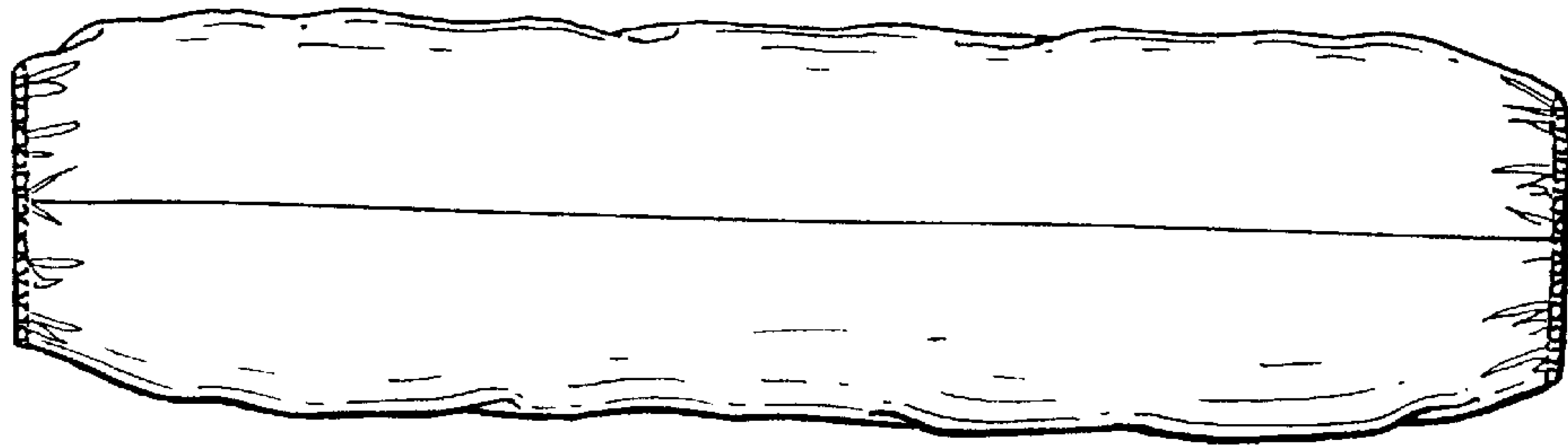

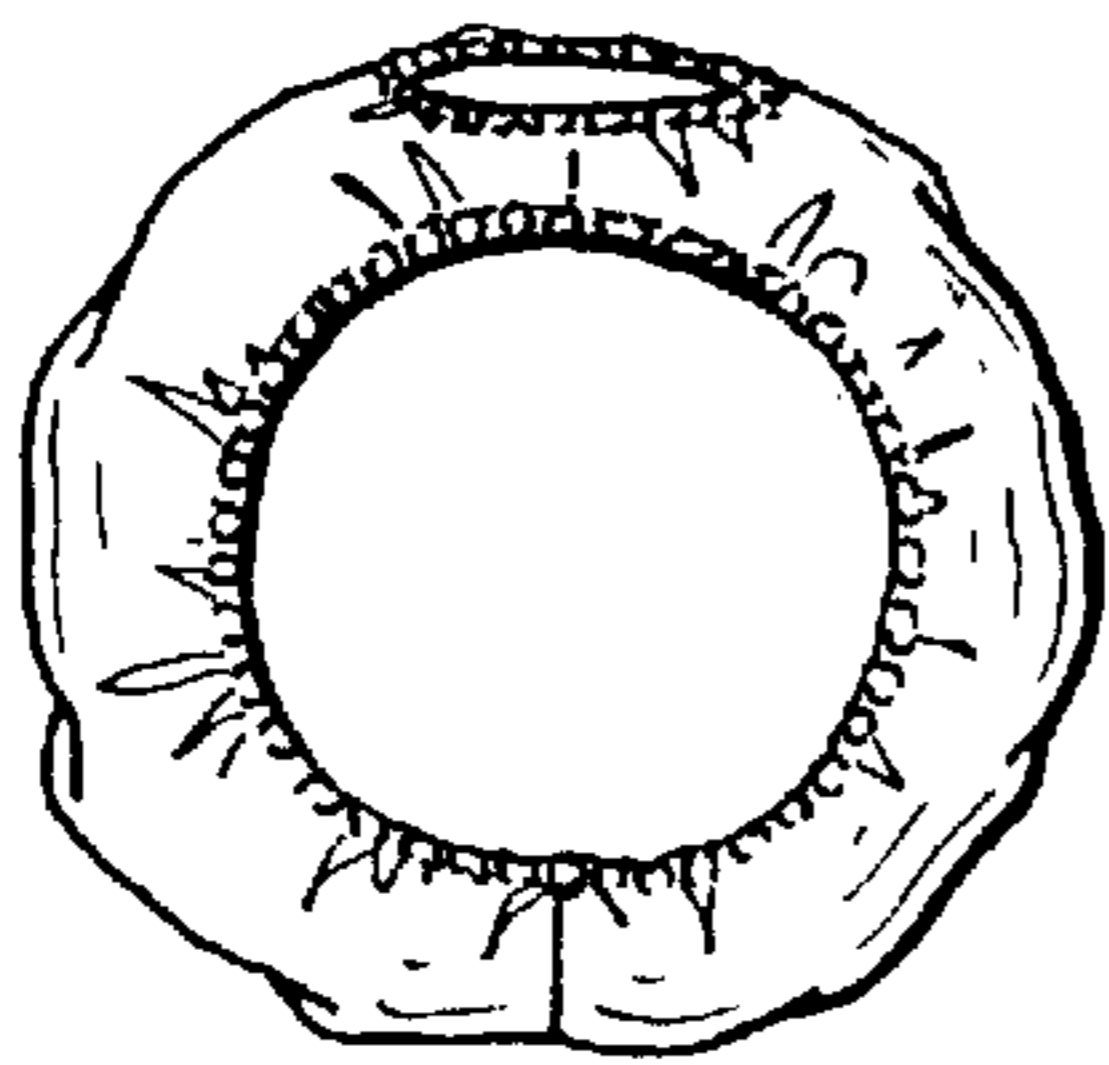

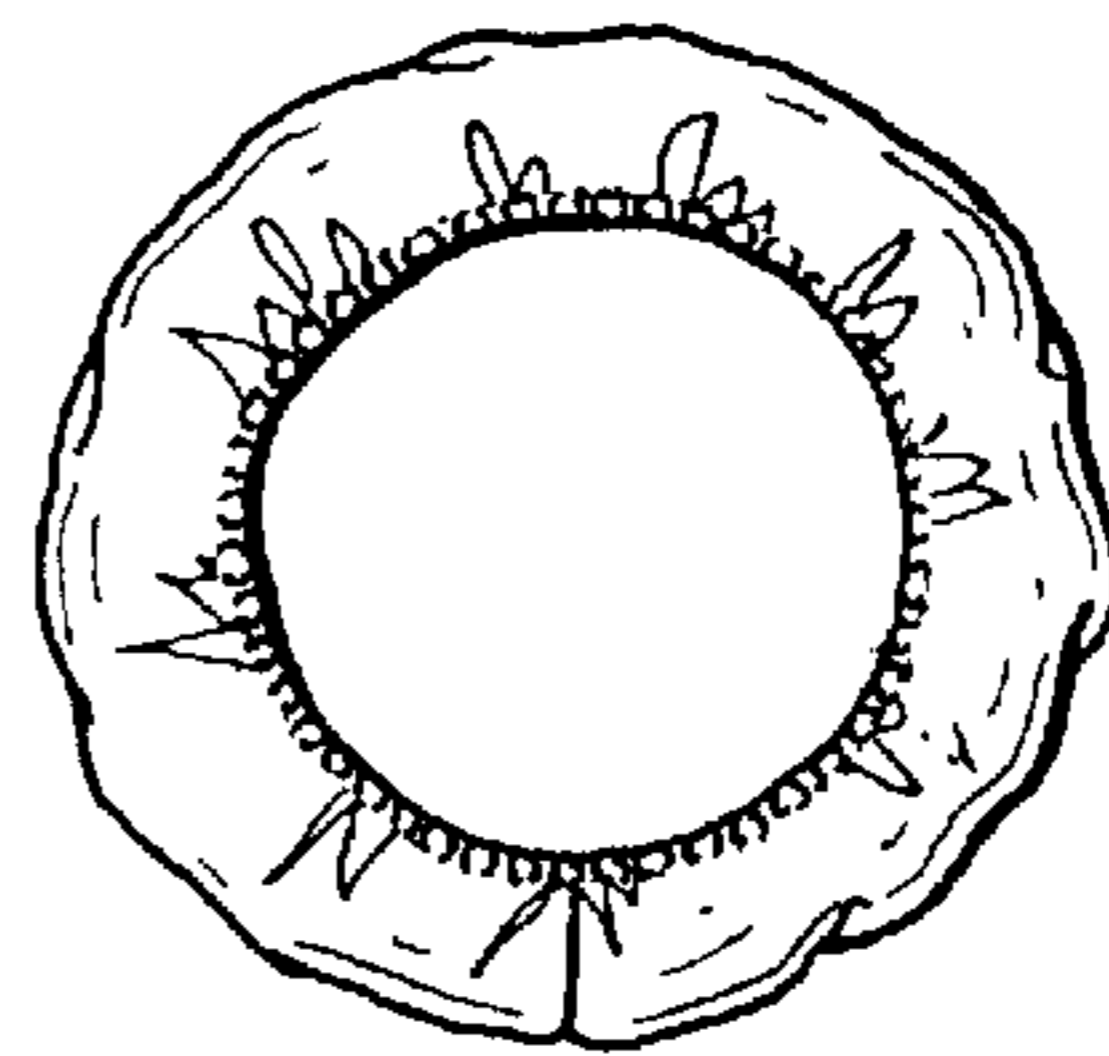

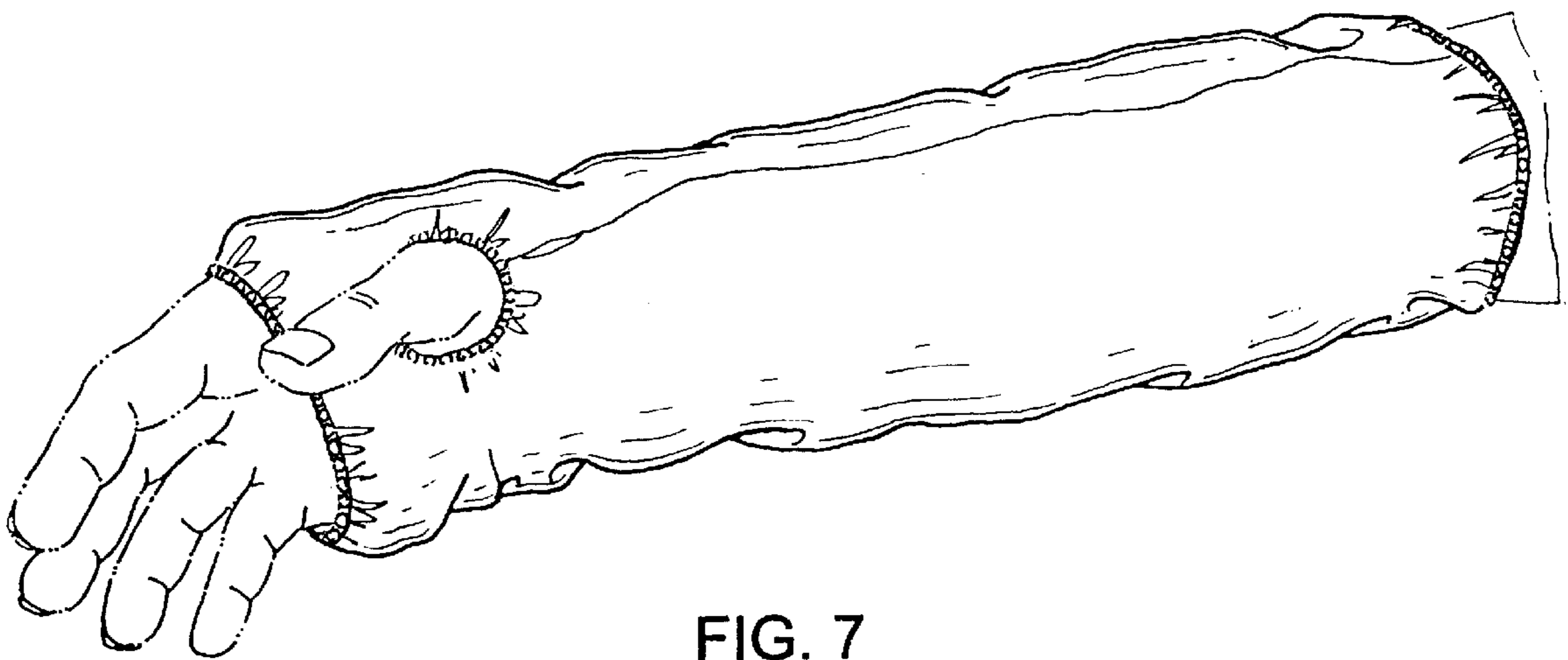

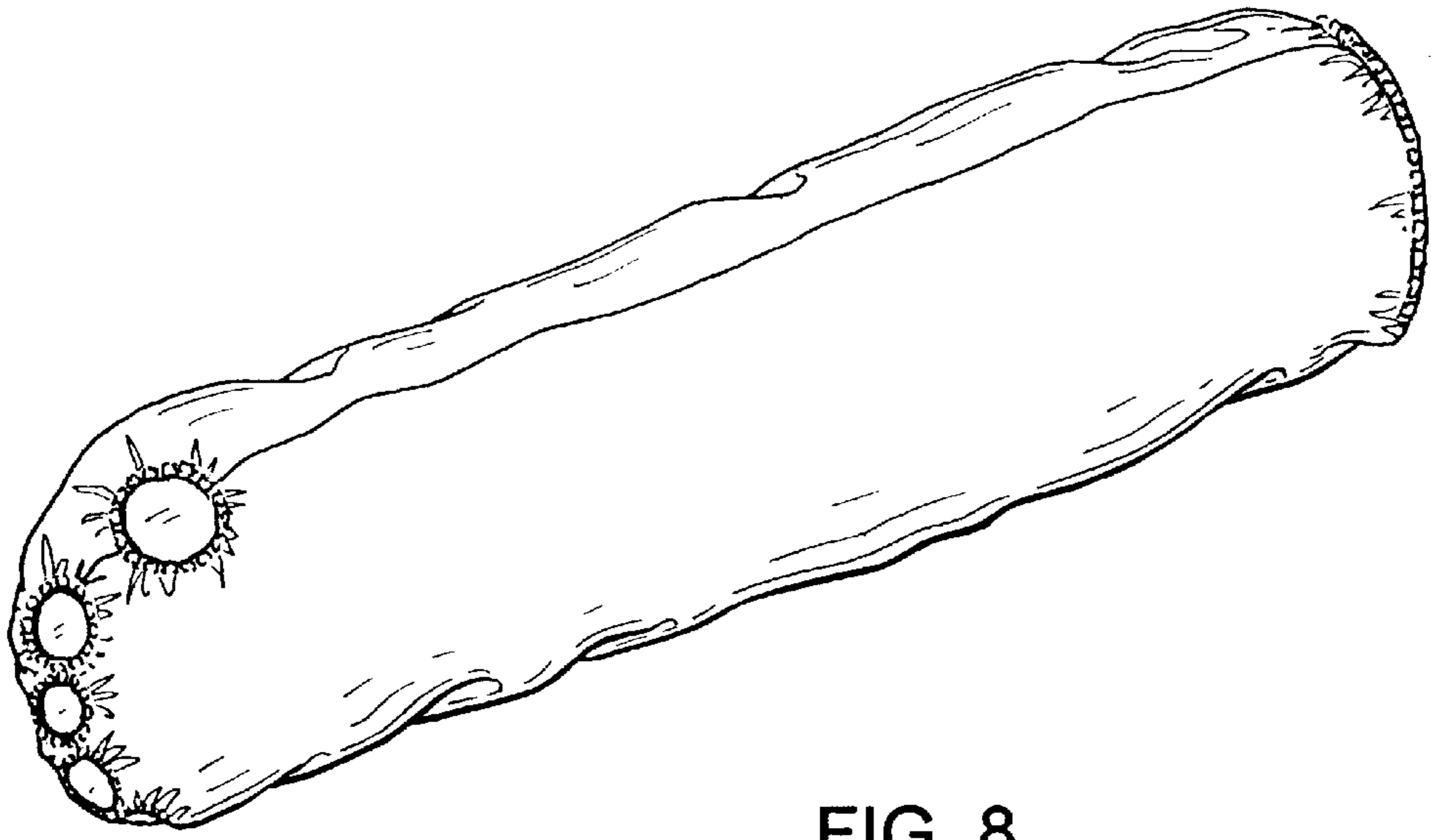

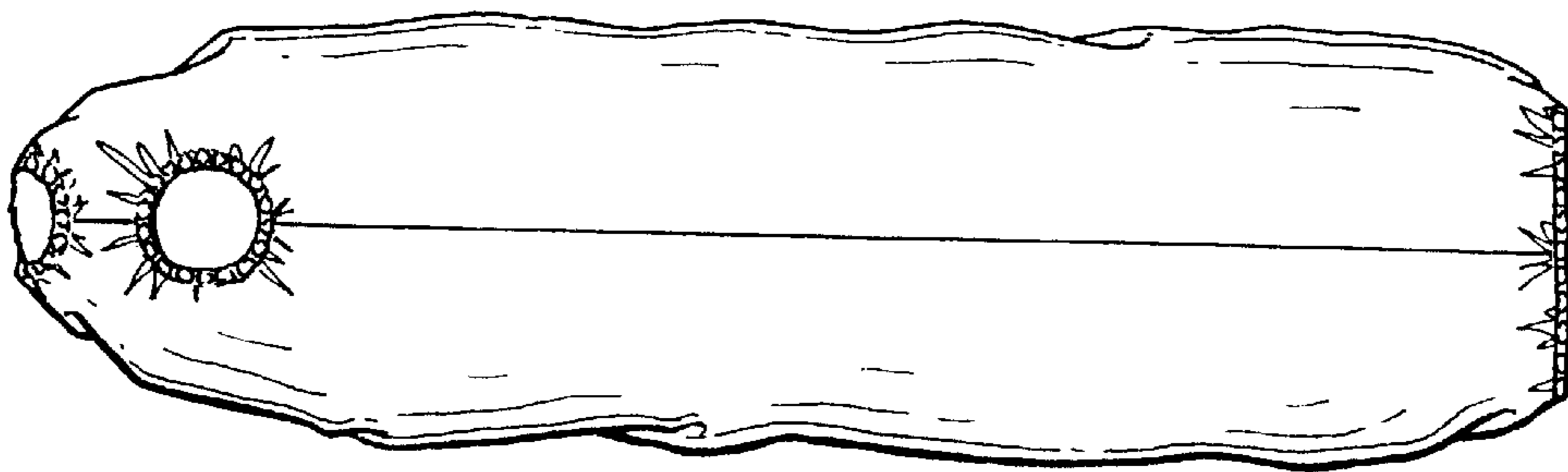

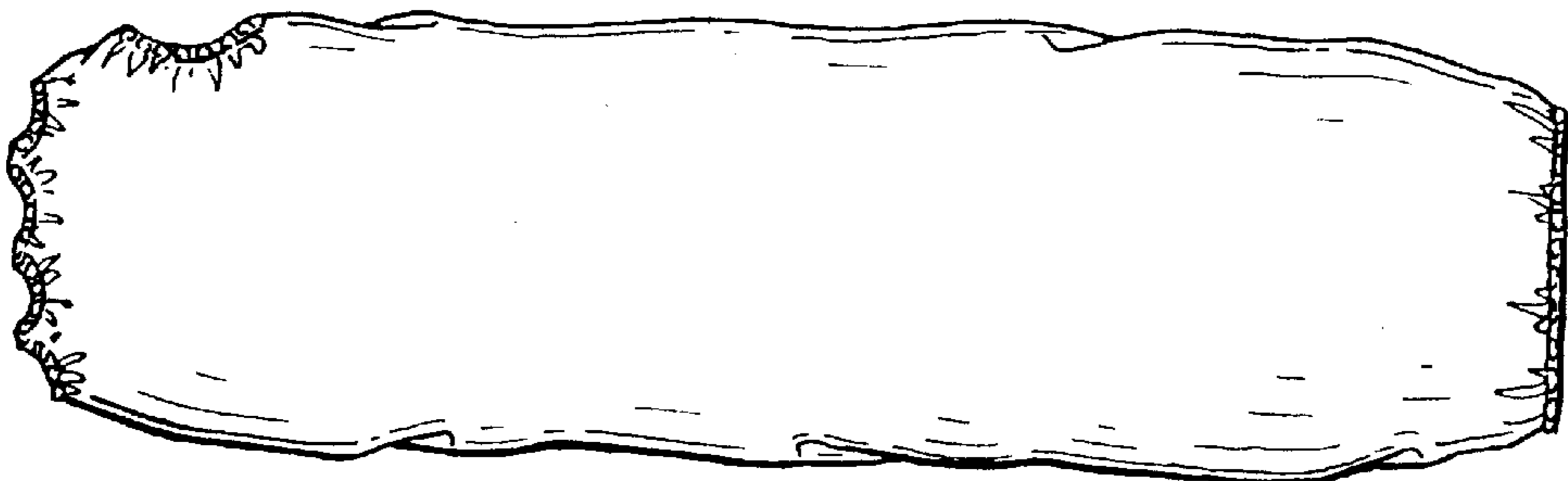

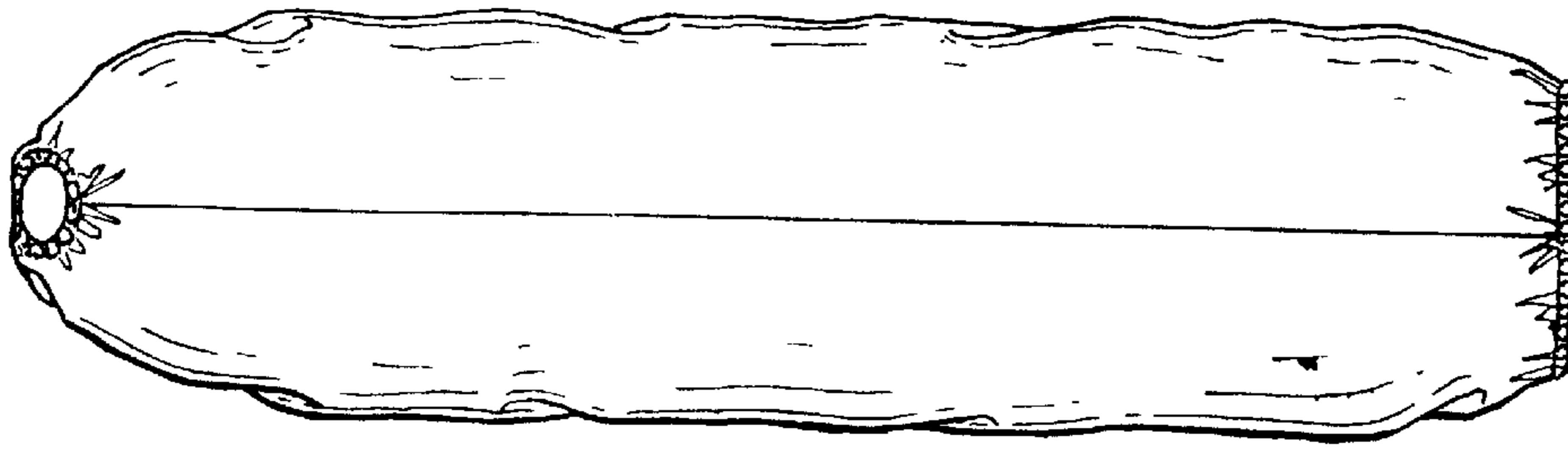

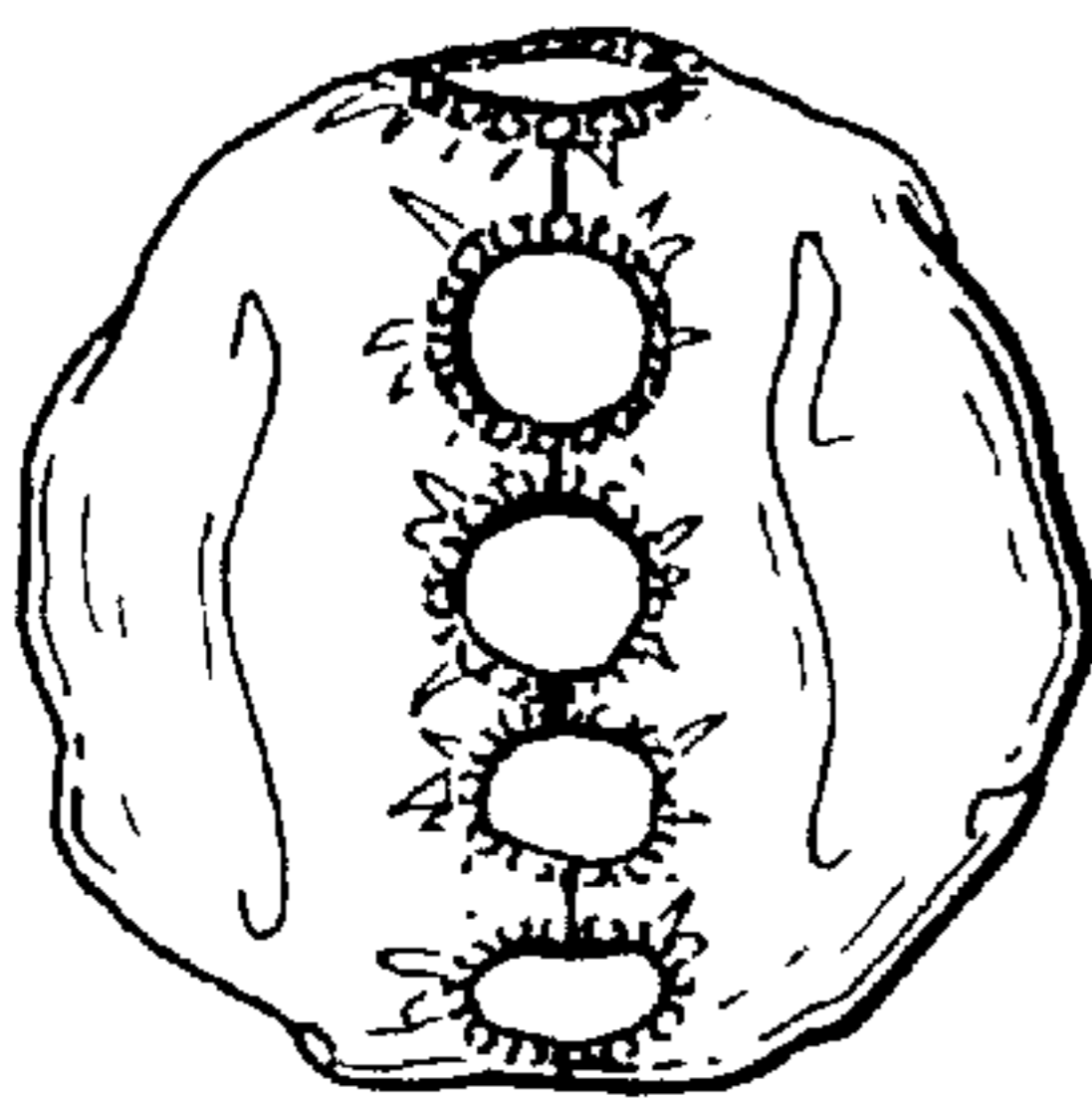

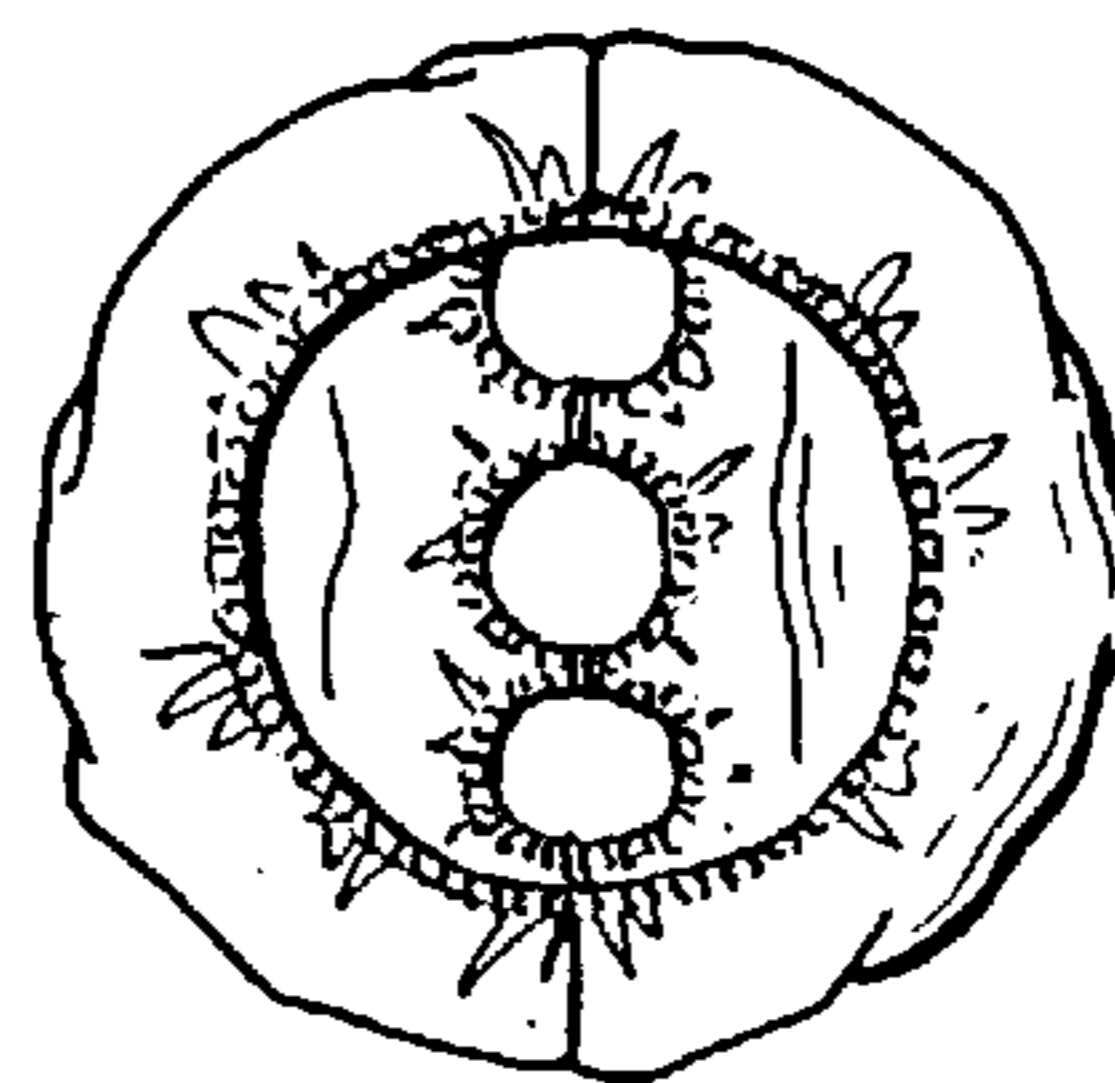

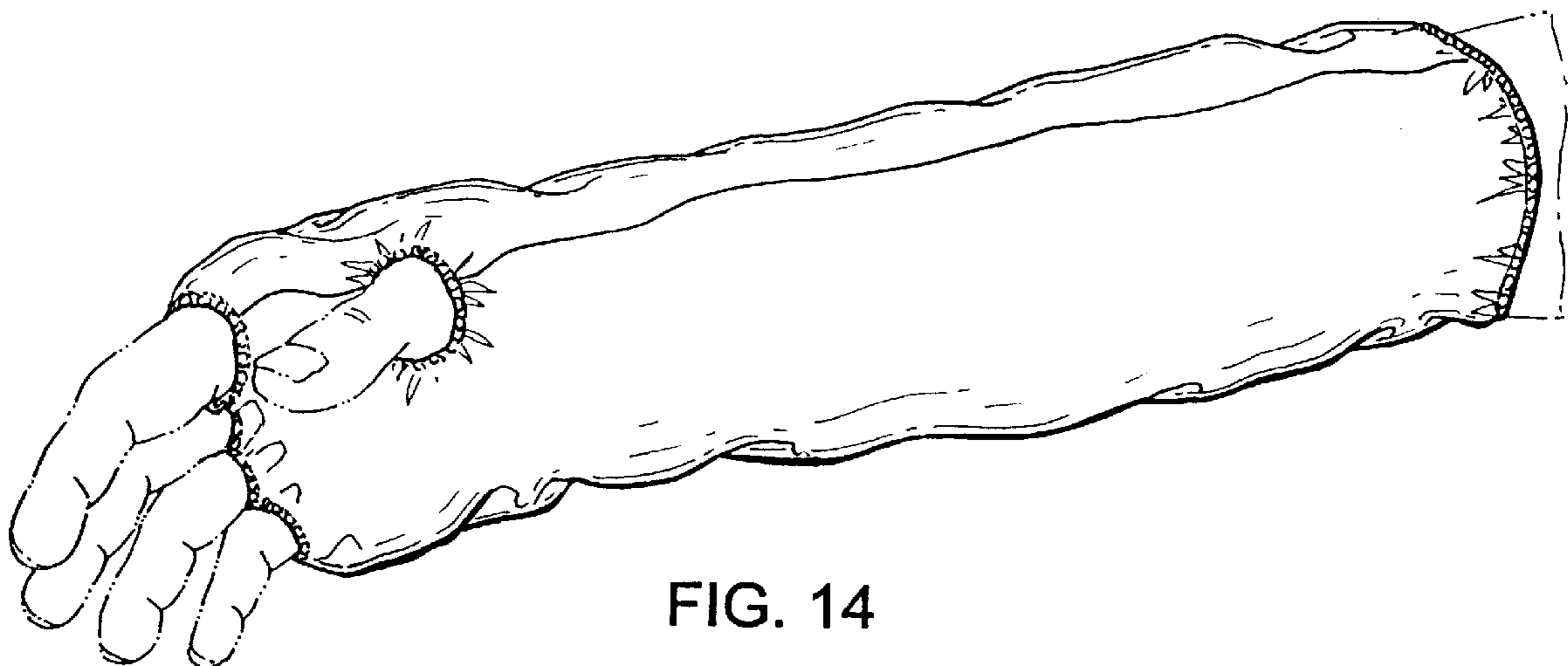
