#### [57] CLAIM

The ornamental design for an aromatherapy pillow in the form of a bear, as shown and described.

#### DESCRIPTION

FIG. 1 is a perspective view of an aromatherapy pillow in the form of a bear, taken from the front and right side, showing our new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a right side elevational view thereof taken from FIG. 1, the left side view being the same;

FIG. 4 is a back elevation view thereof;

FIG. 5 is a top plan view thereof;

FIG. 6 is a bottom plan view thereof; and



FIG. 7 is a perspective view of a first alternate embodiment of our new design, taken from the front and right side;

FIG. 8 is a front elevational view, showing alternate embodiment of our new design;

















