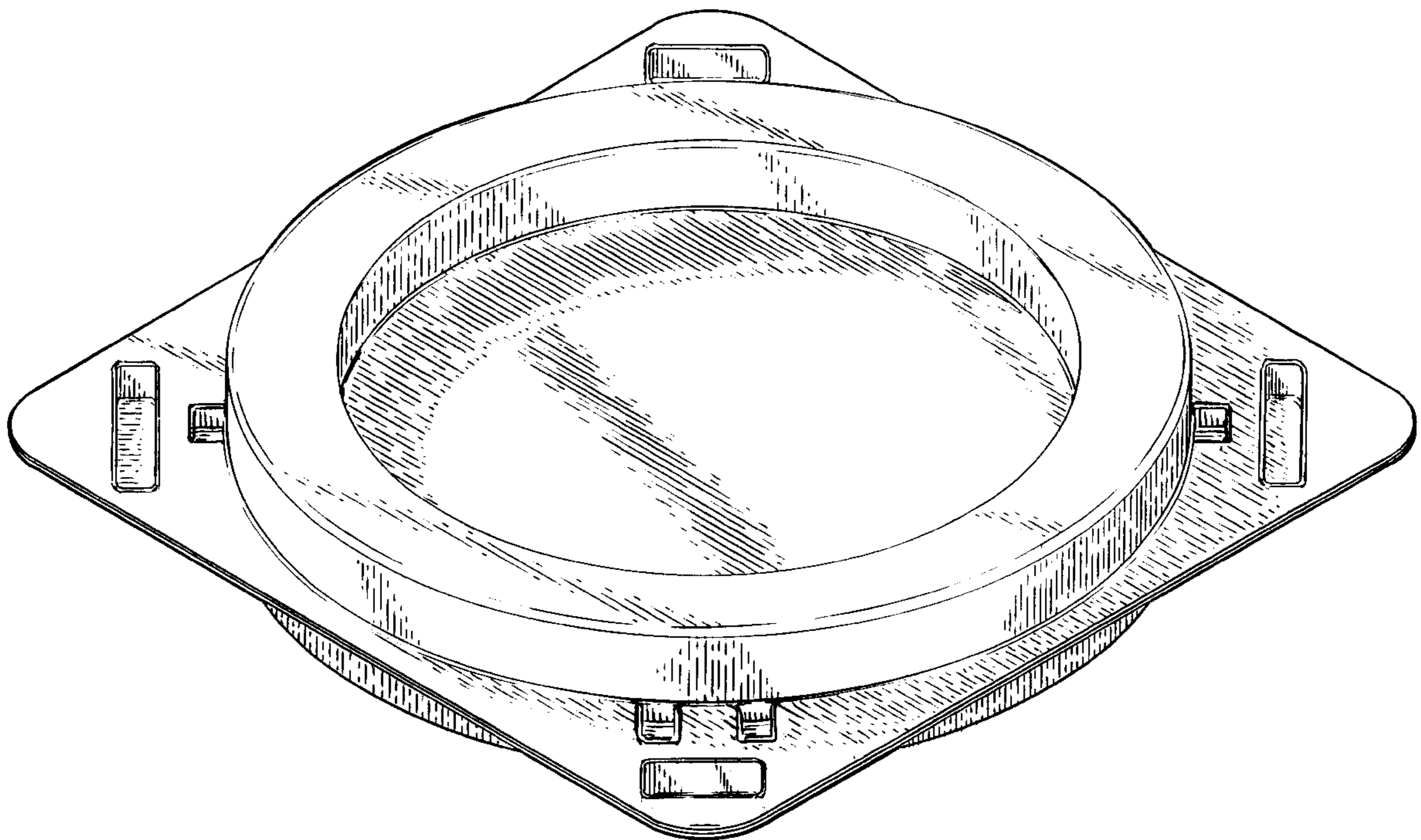
[57] **CLAIM**

The ornamental design for a non-contact protective package, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the non-contact protective package of the present invention; FIG. 2 is a top plan view thereof; FIG. 3 is a bottom plan view thereof; FIG. 4 is a front elevational view thereof; FIG. 5 is a back elevational view thereof; FIG. 6 is a left side elevational view; and, FIG. 7 is a right side elevational view.

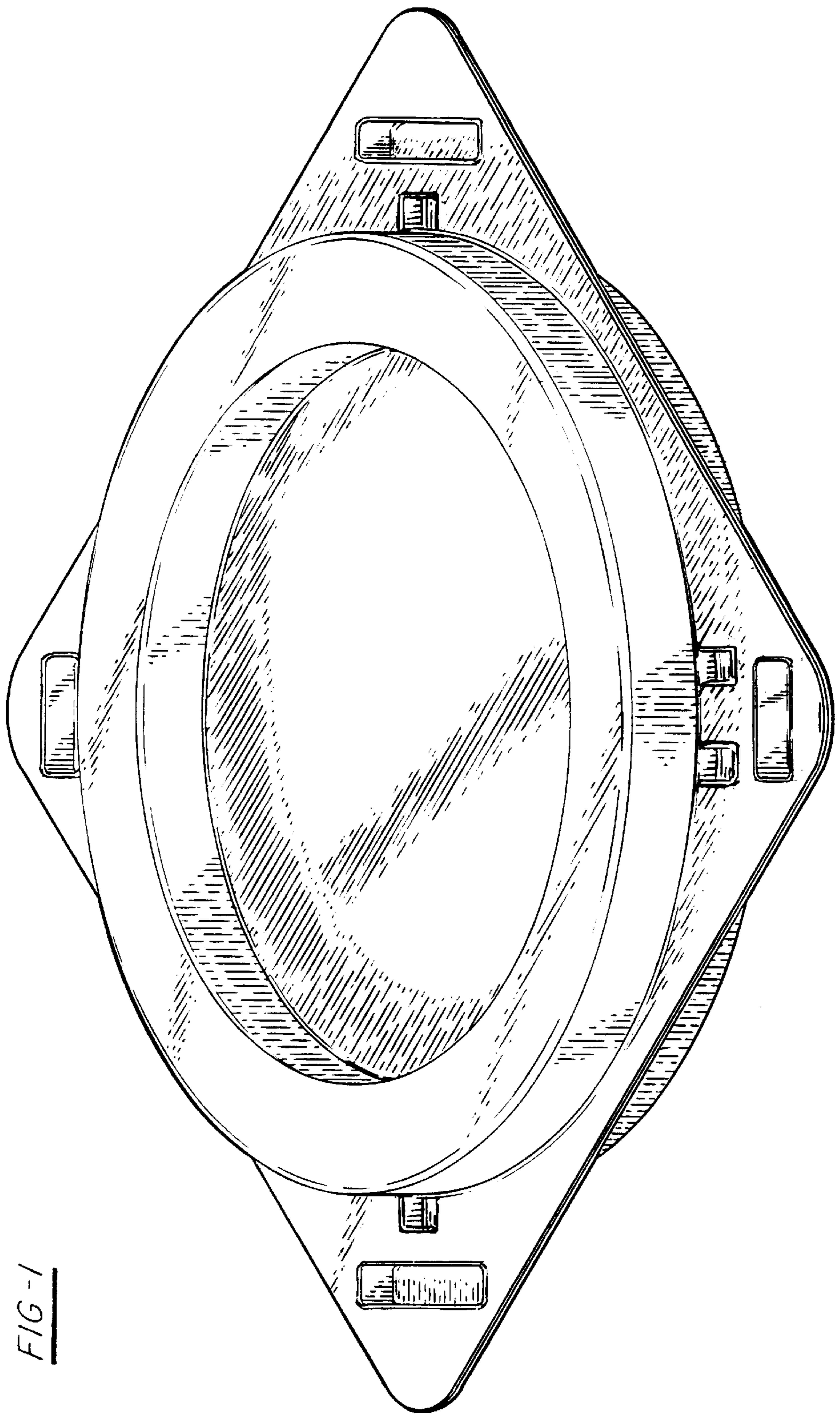

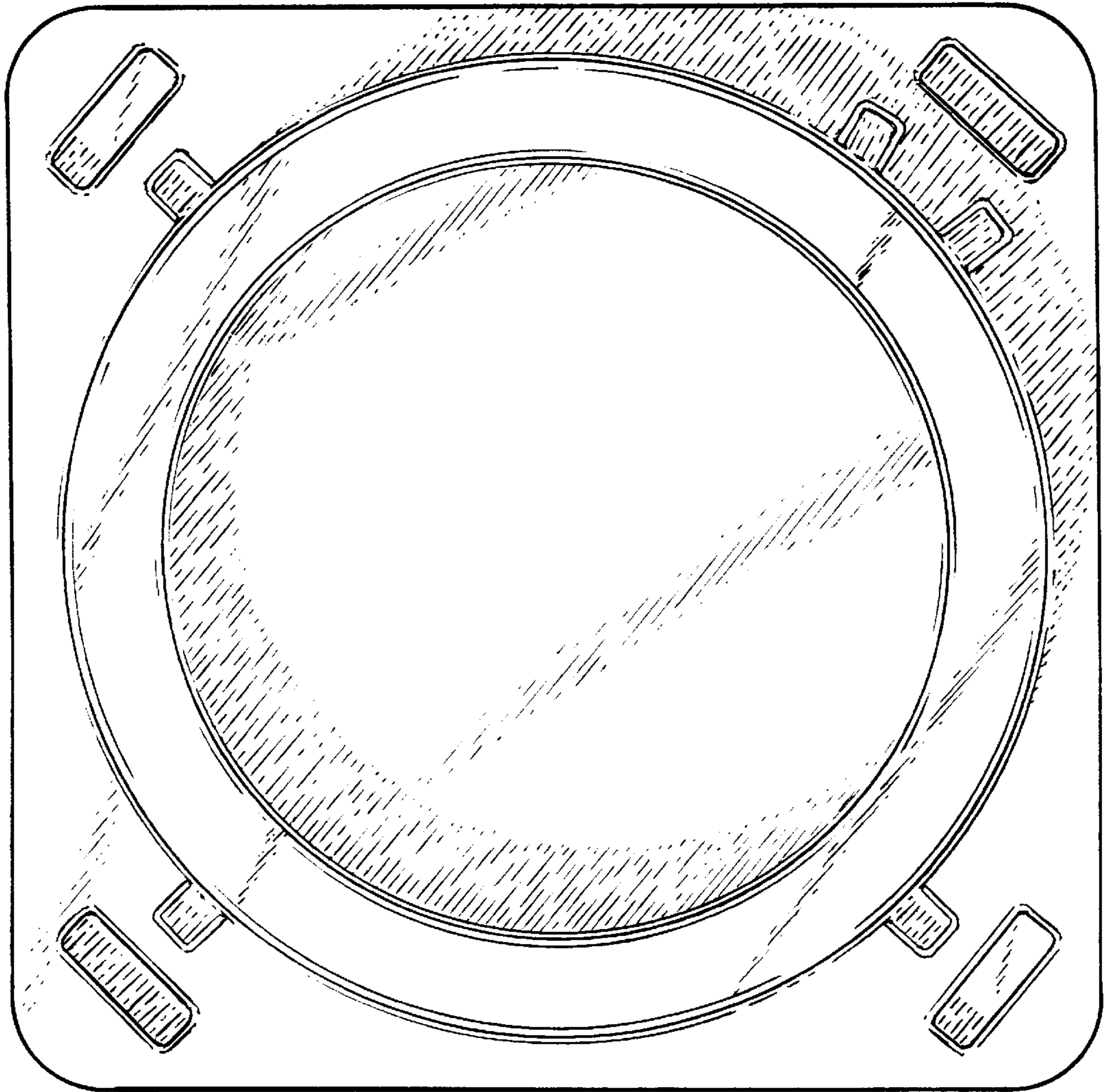

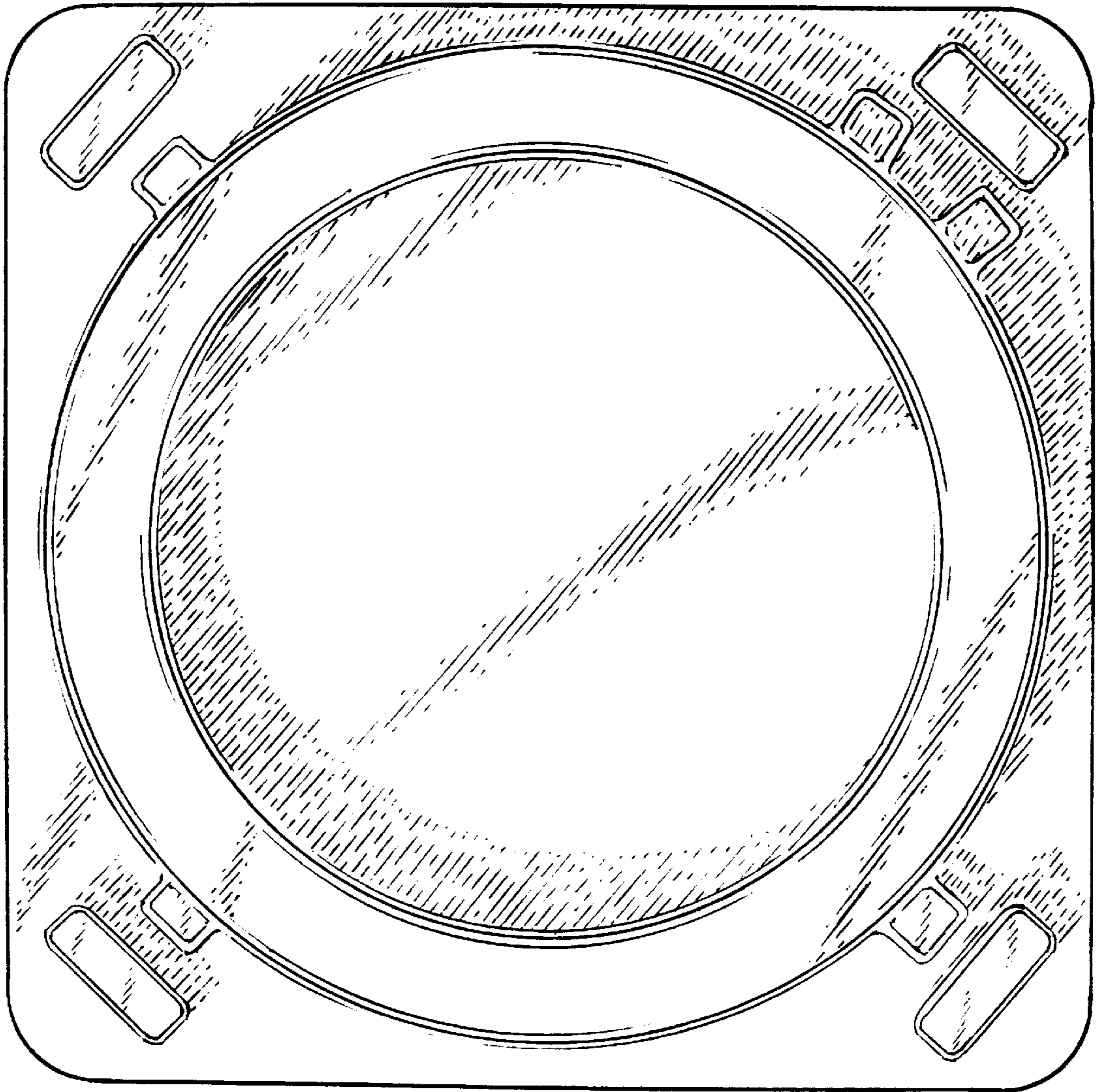

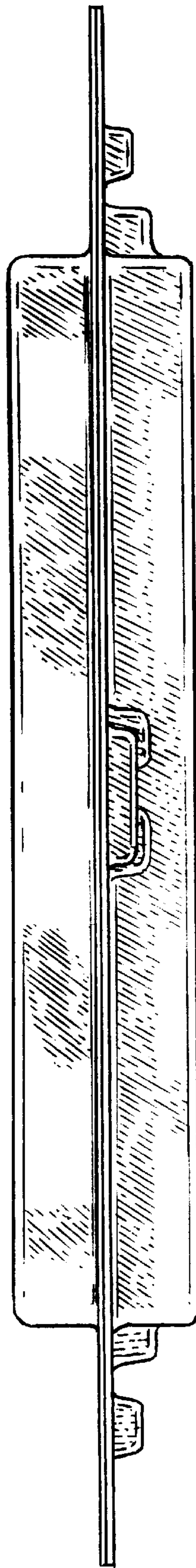

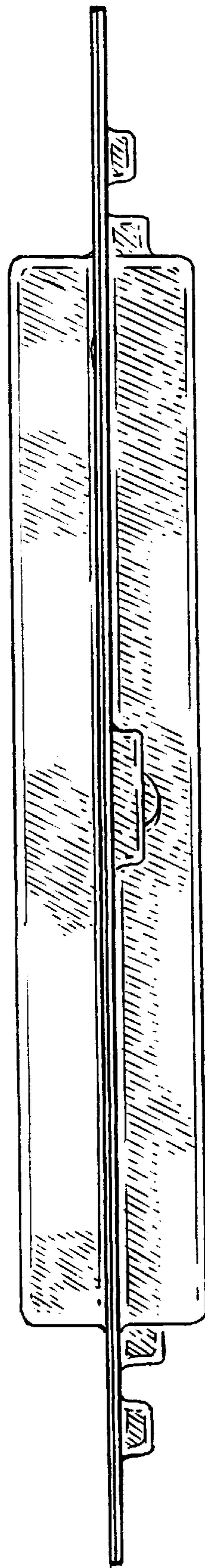

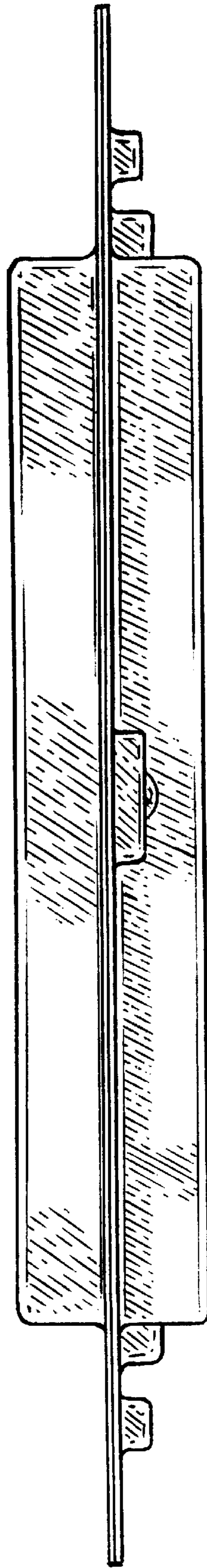

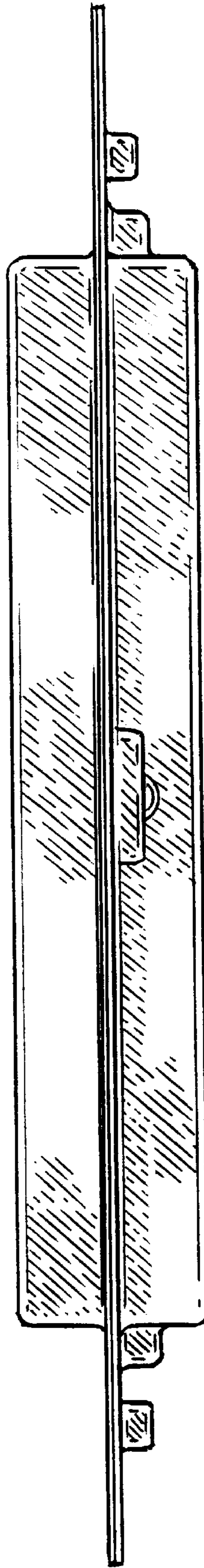
