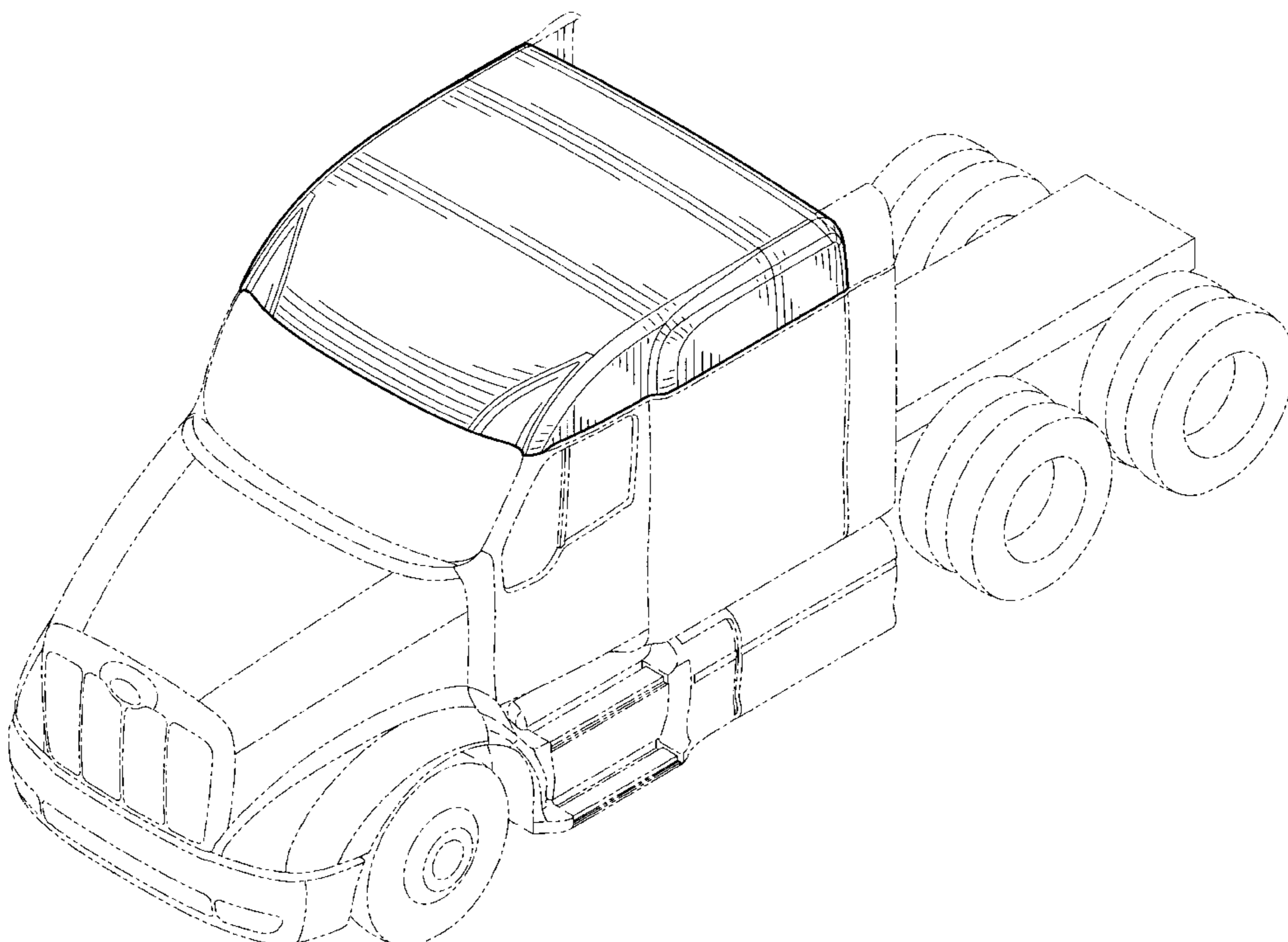
The ornamental design for a roof for a truck, as shown and described.

DESCRIPTION

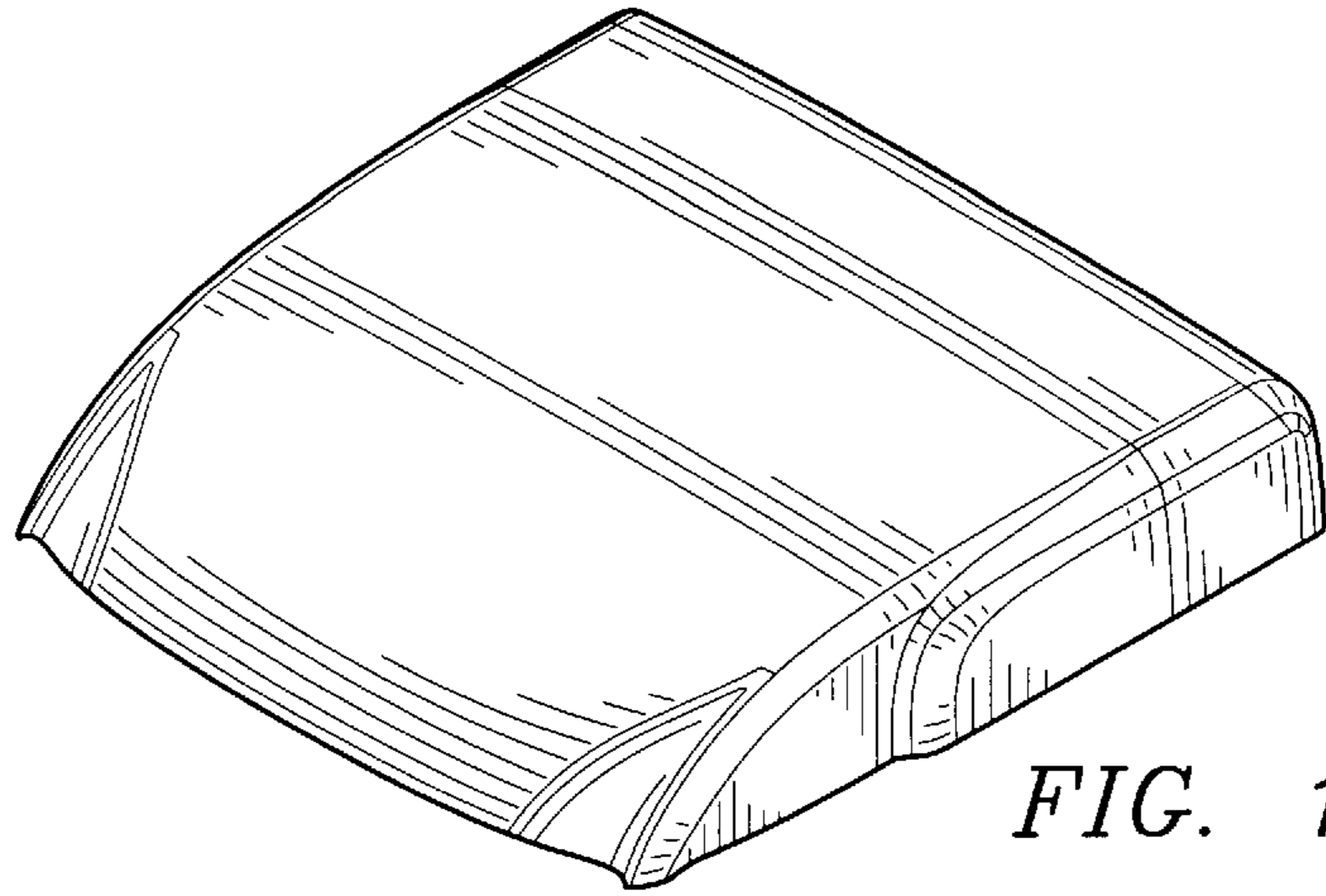

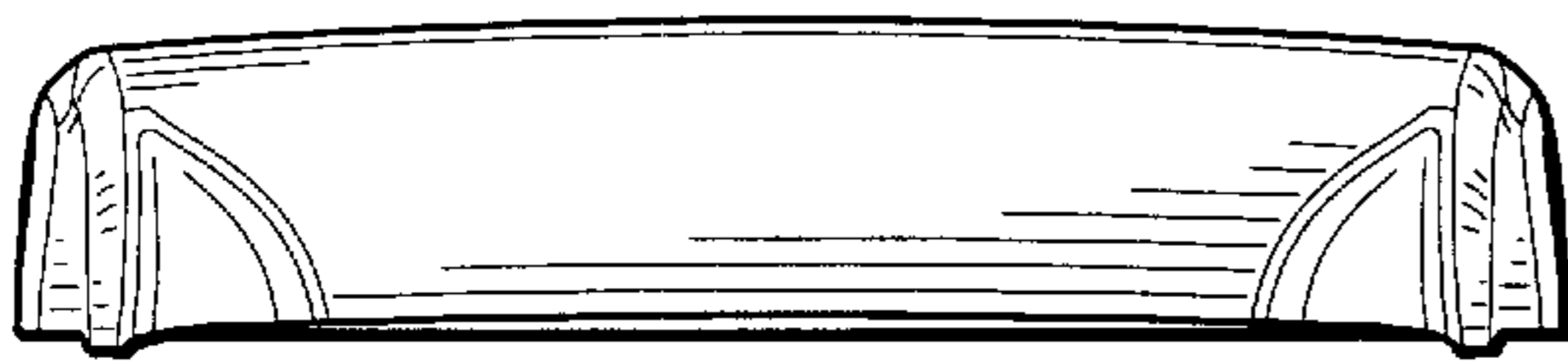

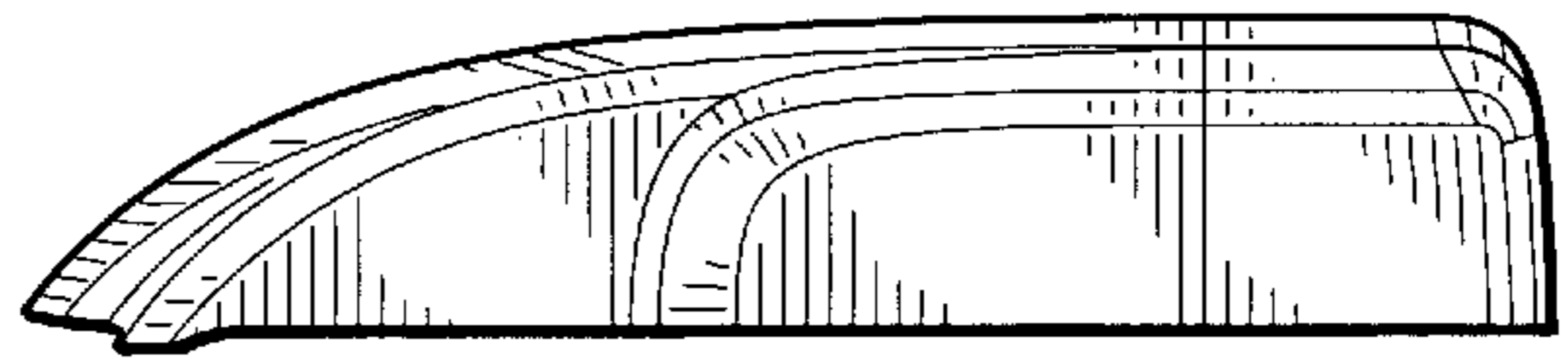

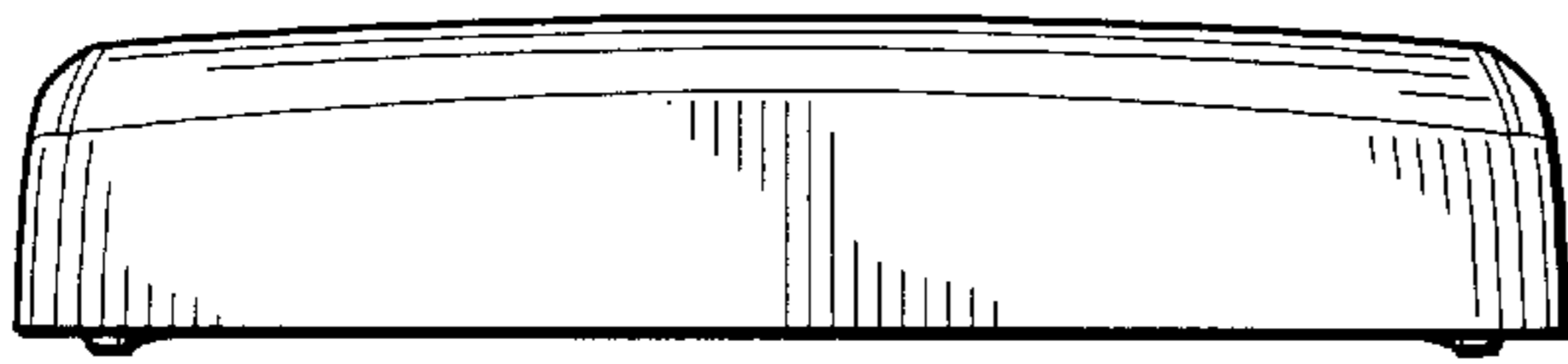

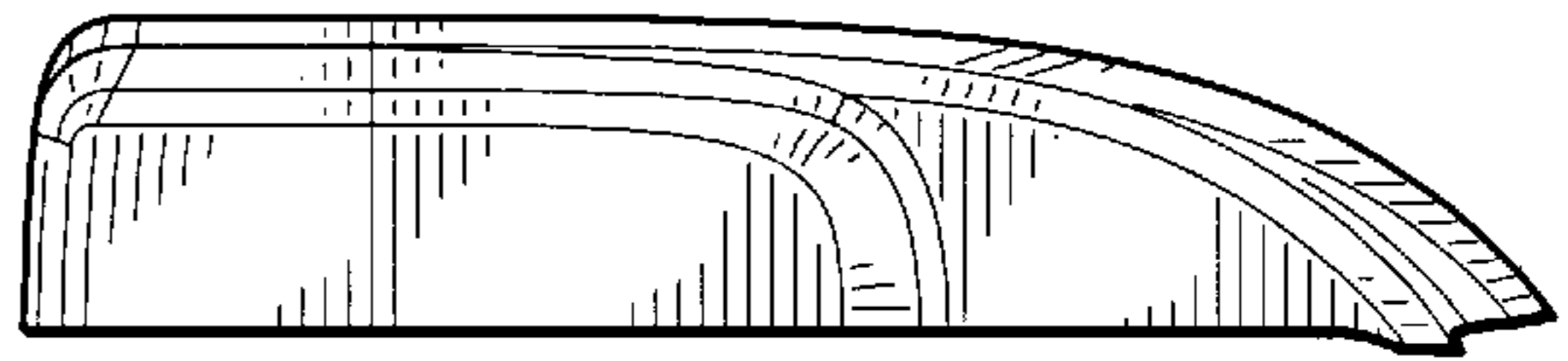

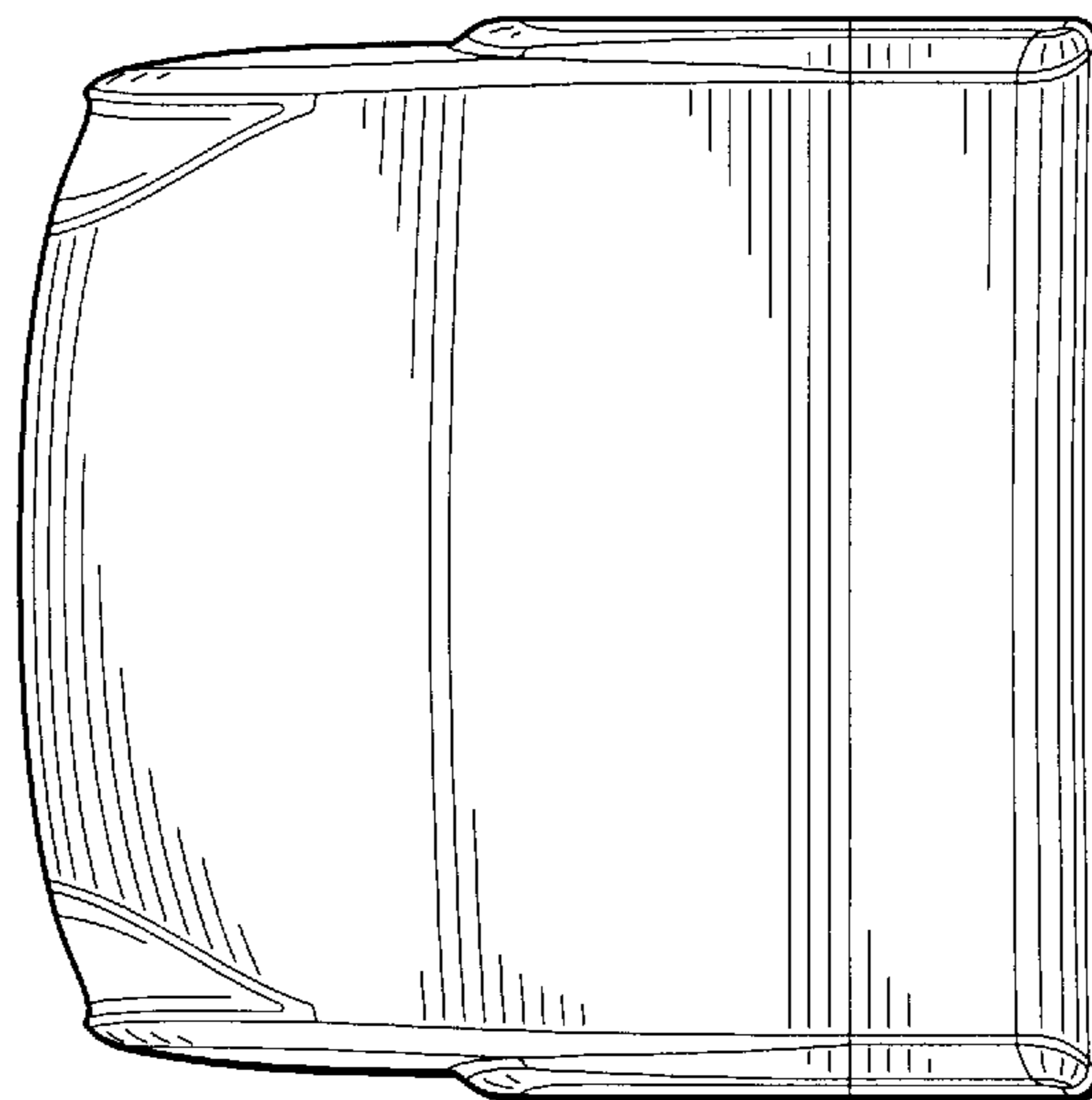

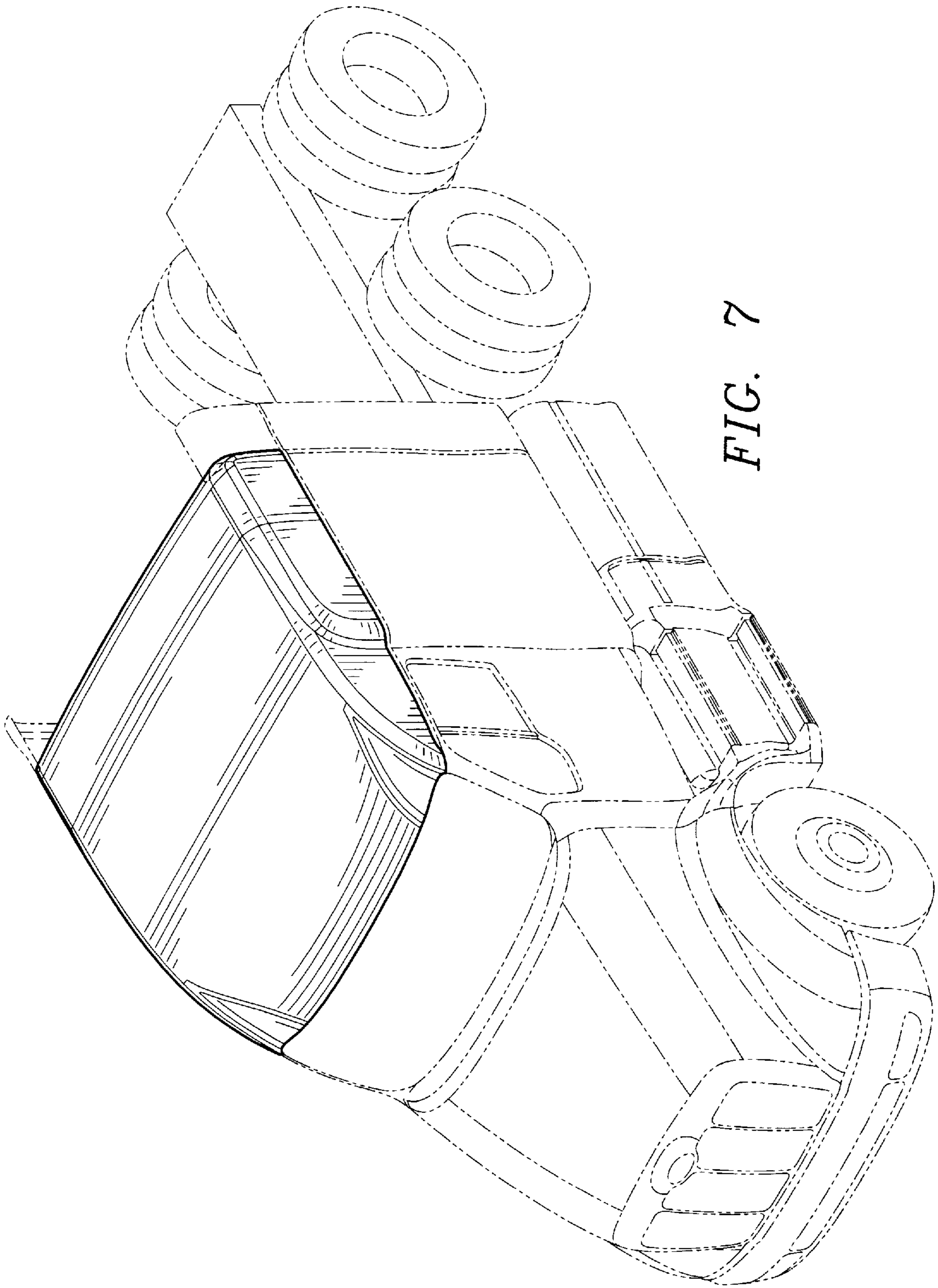

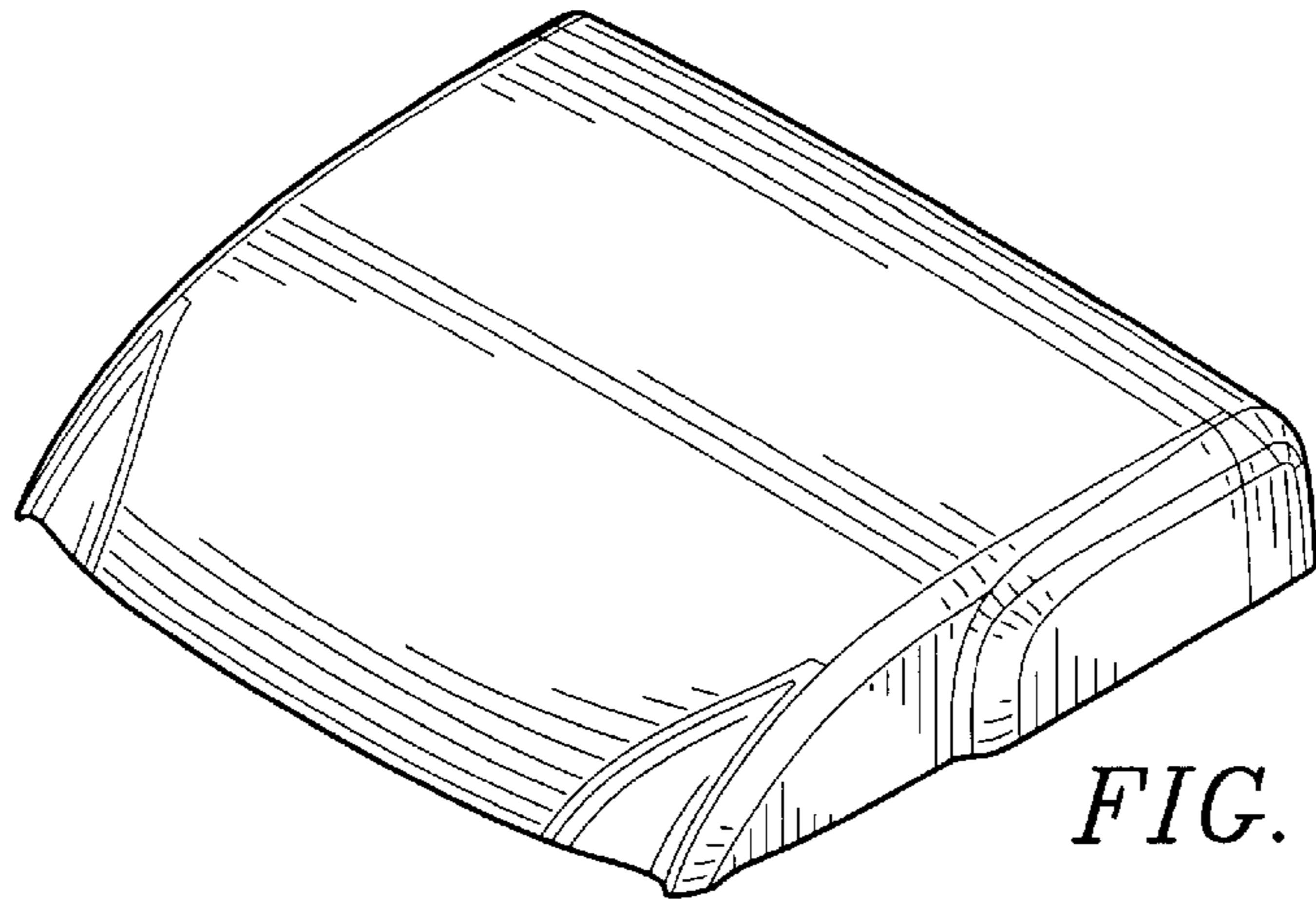

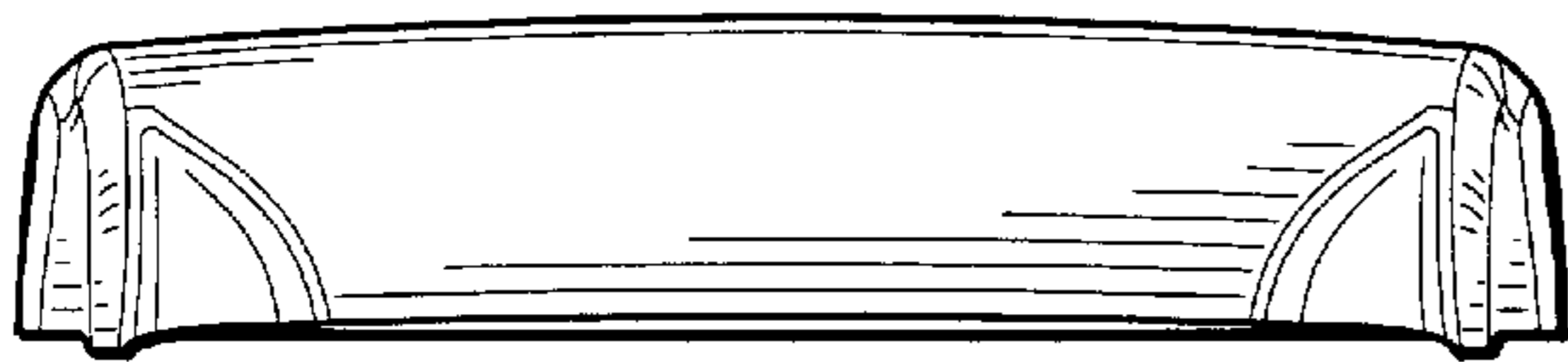

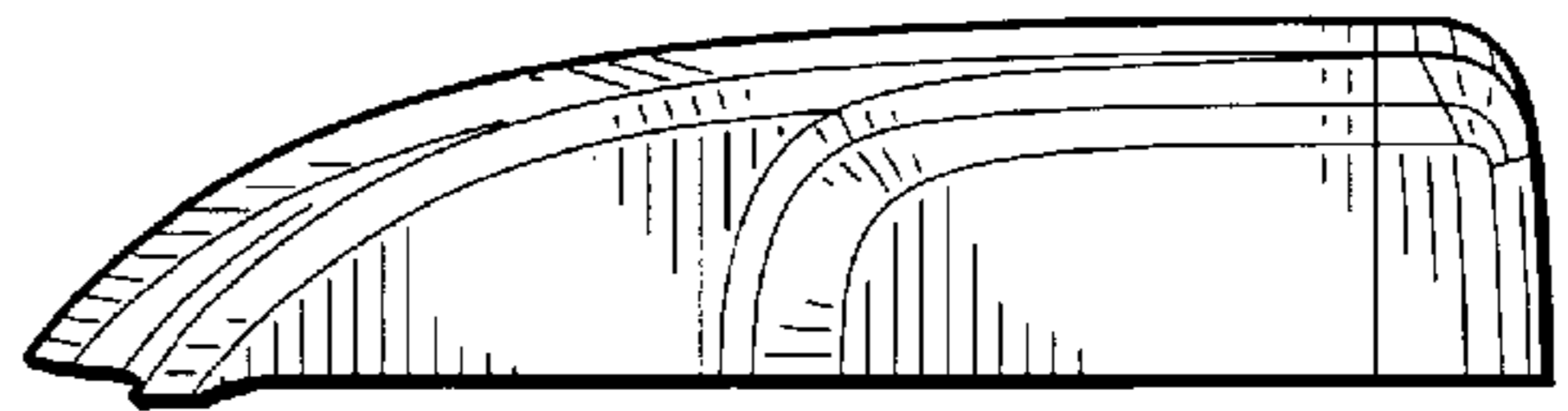

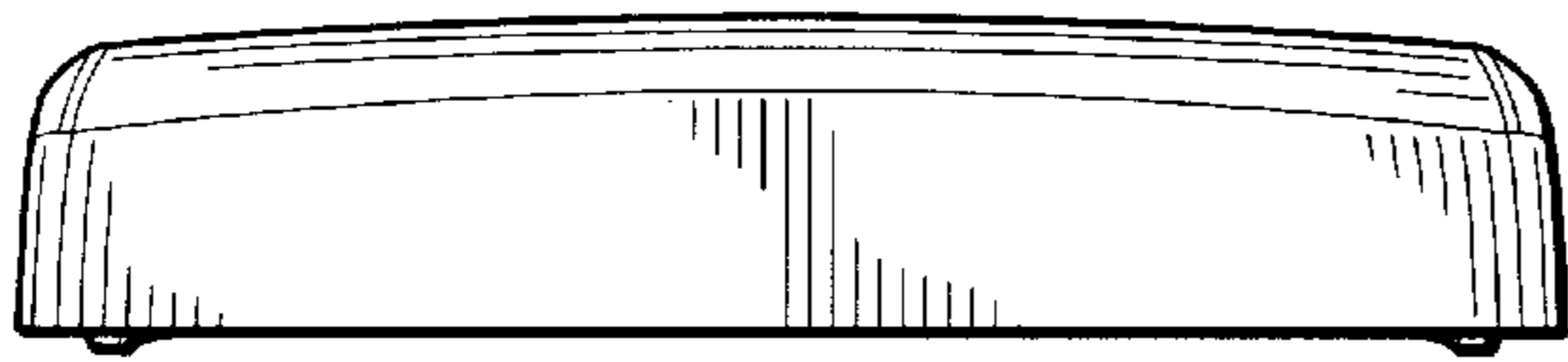

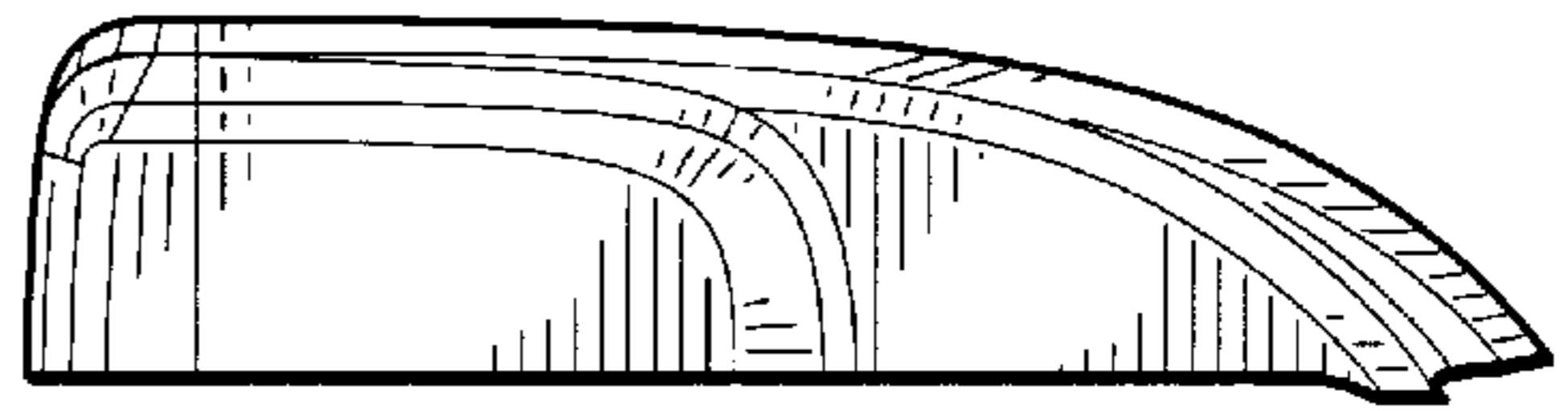

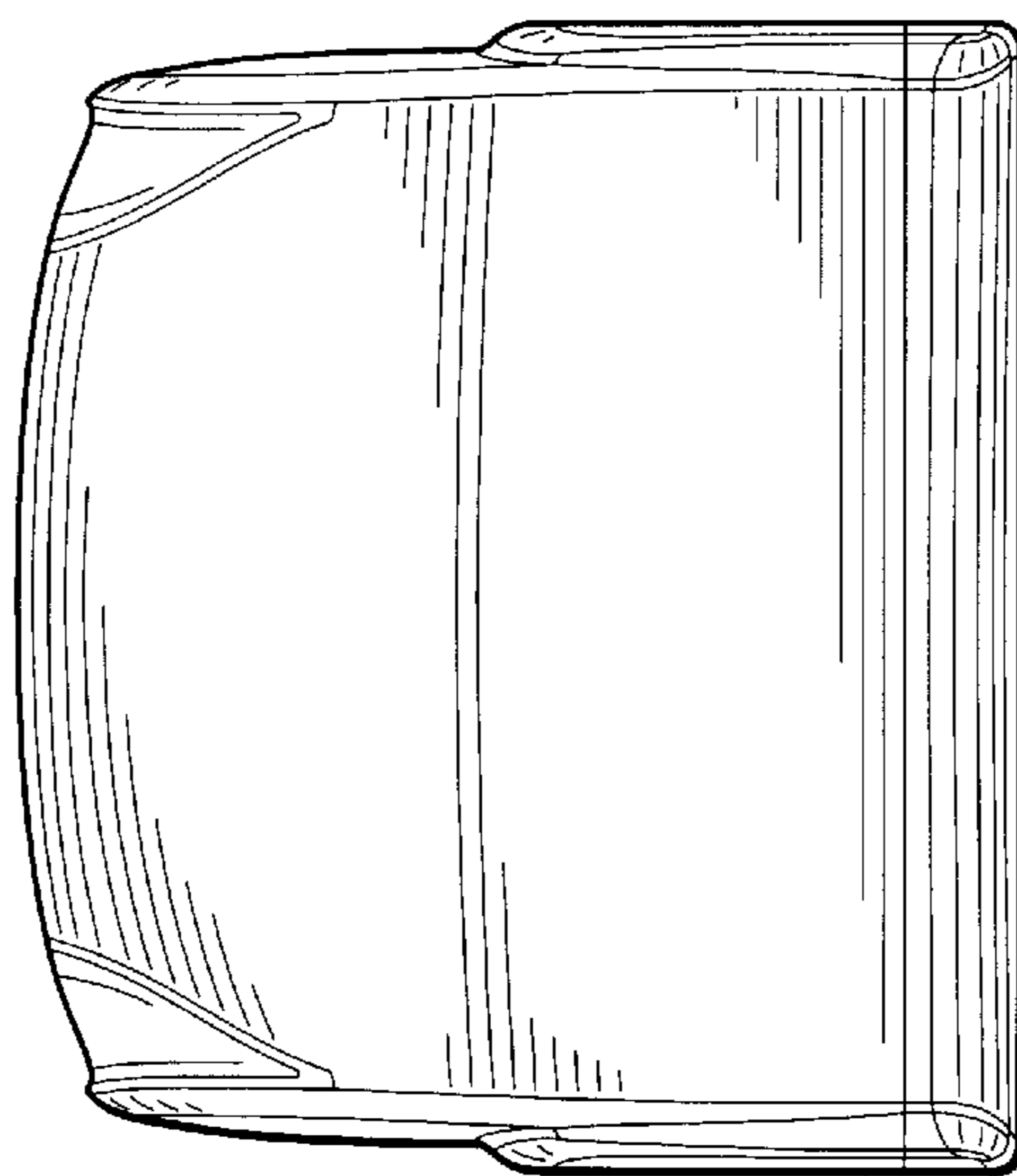

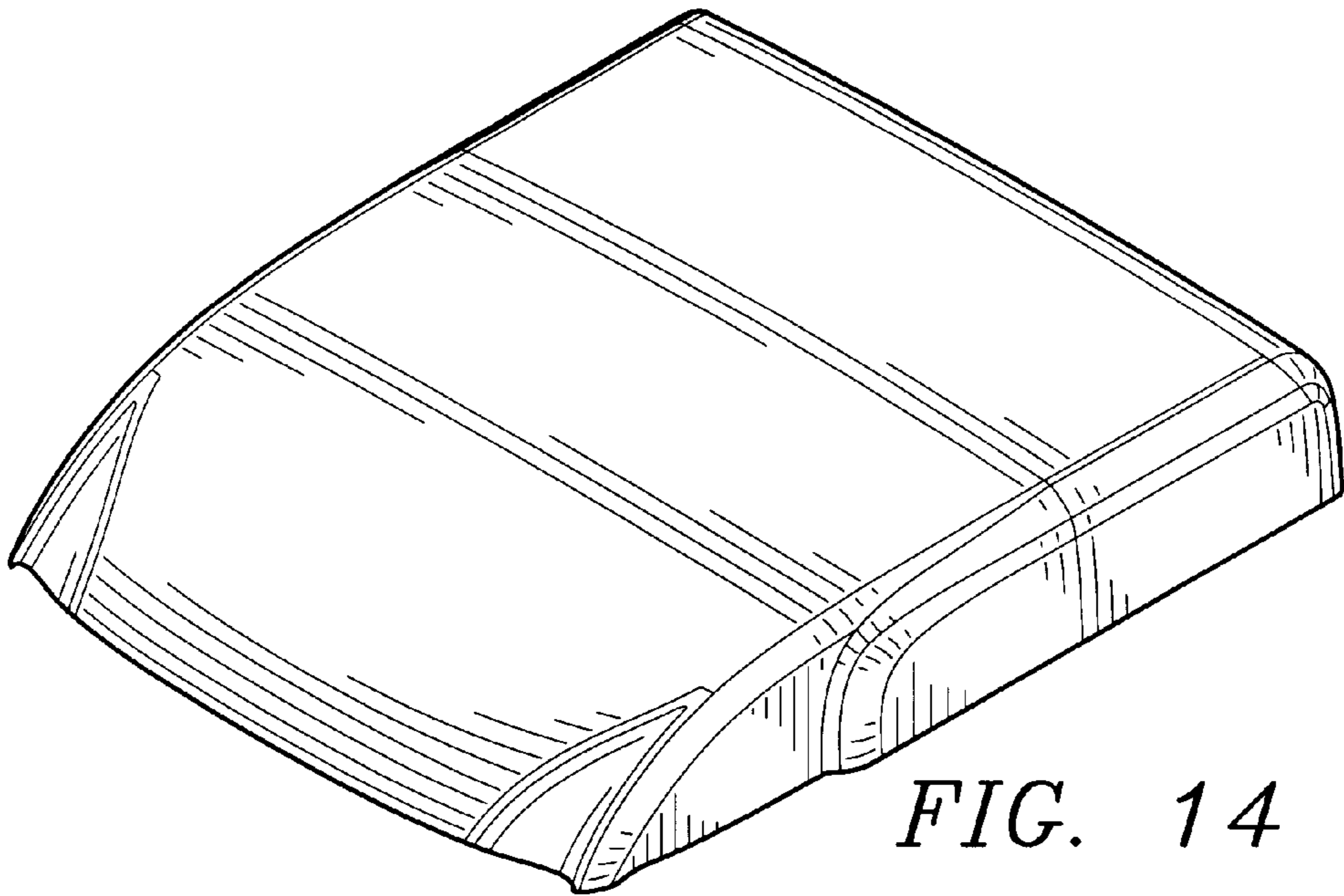

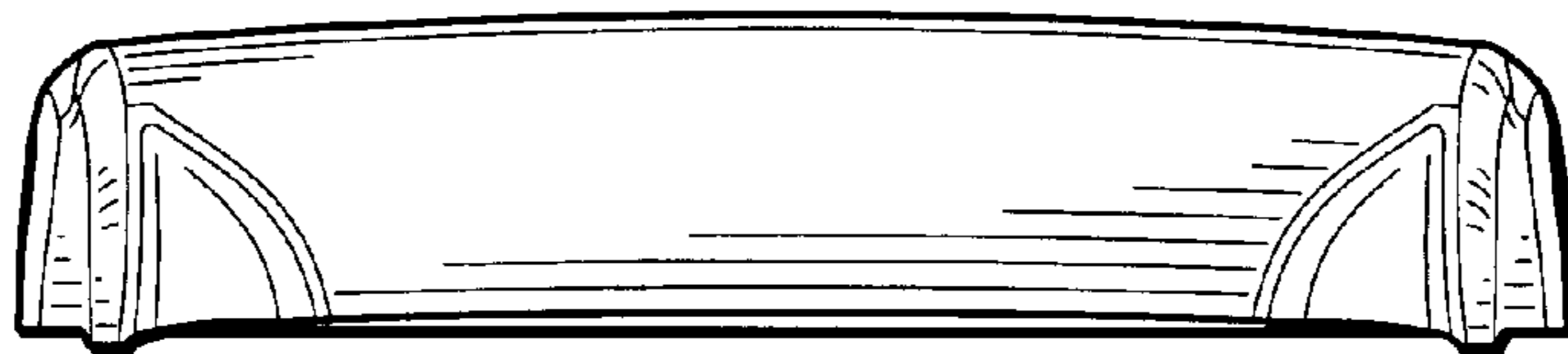

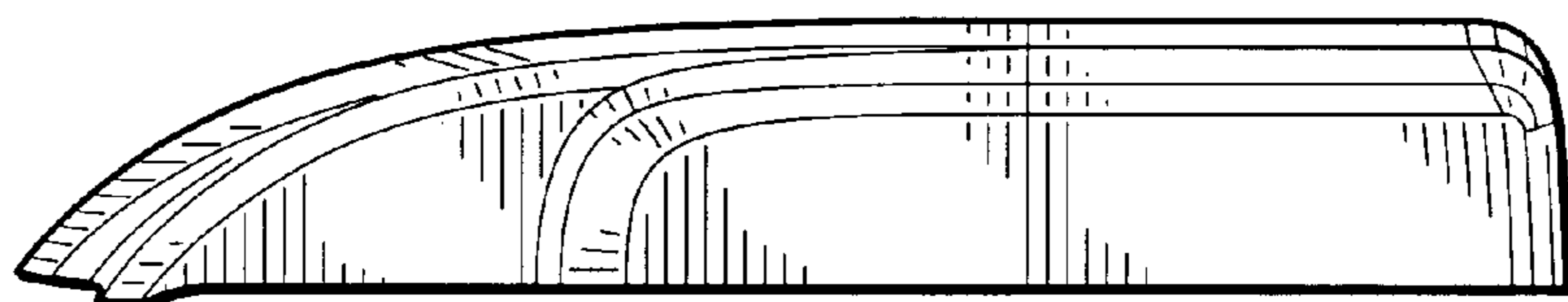

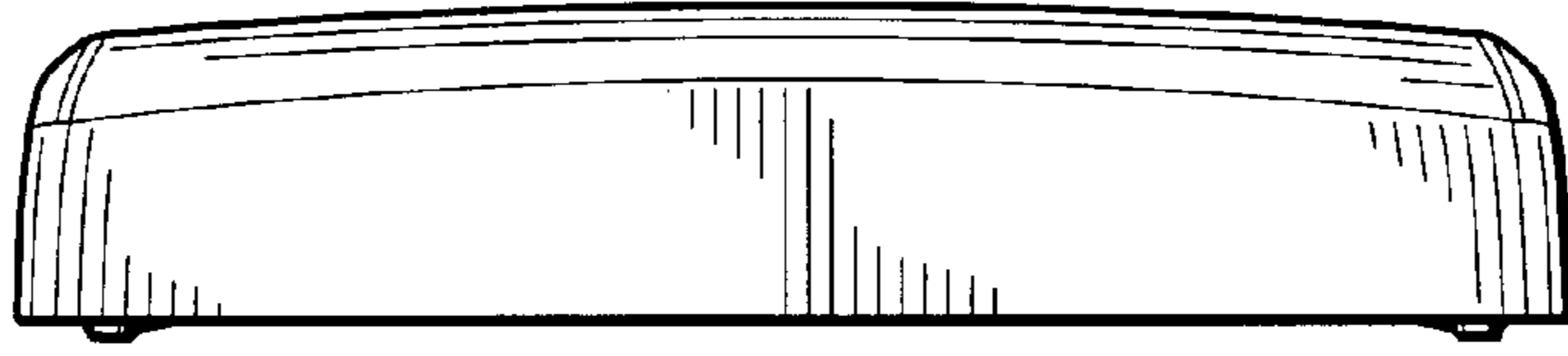

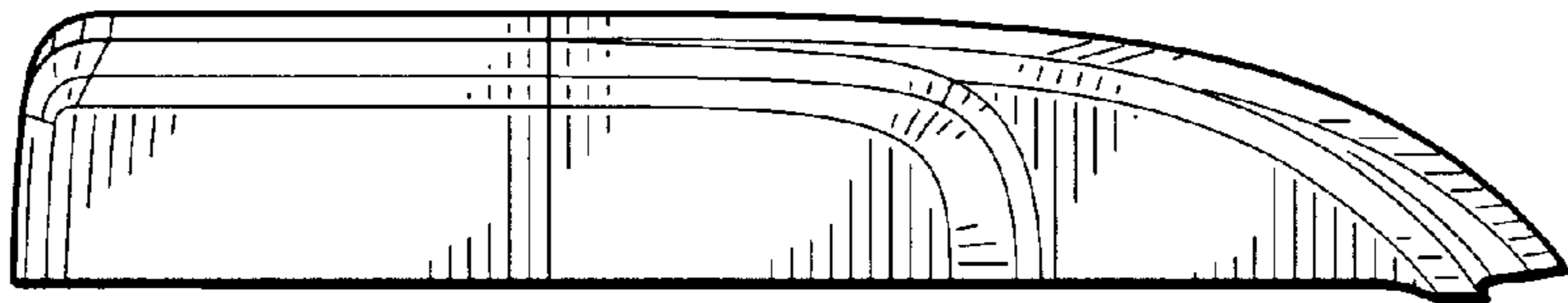

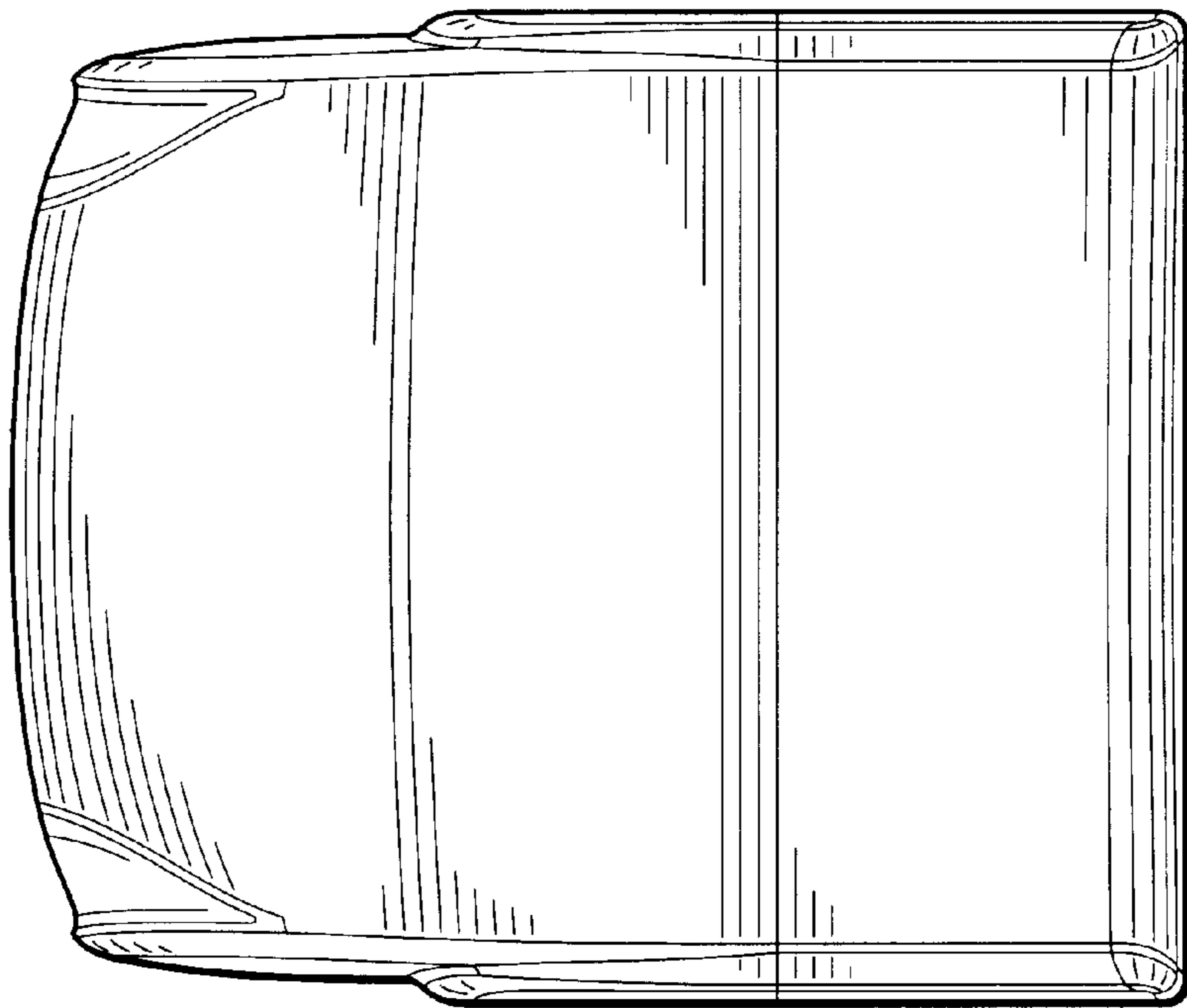
