[57] CLAIM

The ornamental design for a bicycle handlebar bar ends, as shown and described.

DESCRIPTION

FIG. 1 is a top view of a left bicycle handlebar bar end showing my new design;

FIG. 2 is a side view of the left bar end.

FIG. 3 is a bottom view of the left bar end.

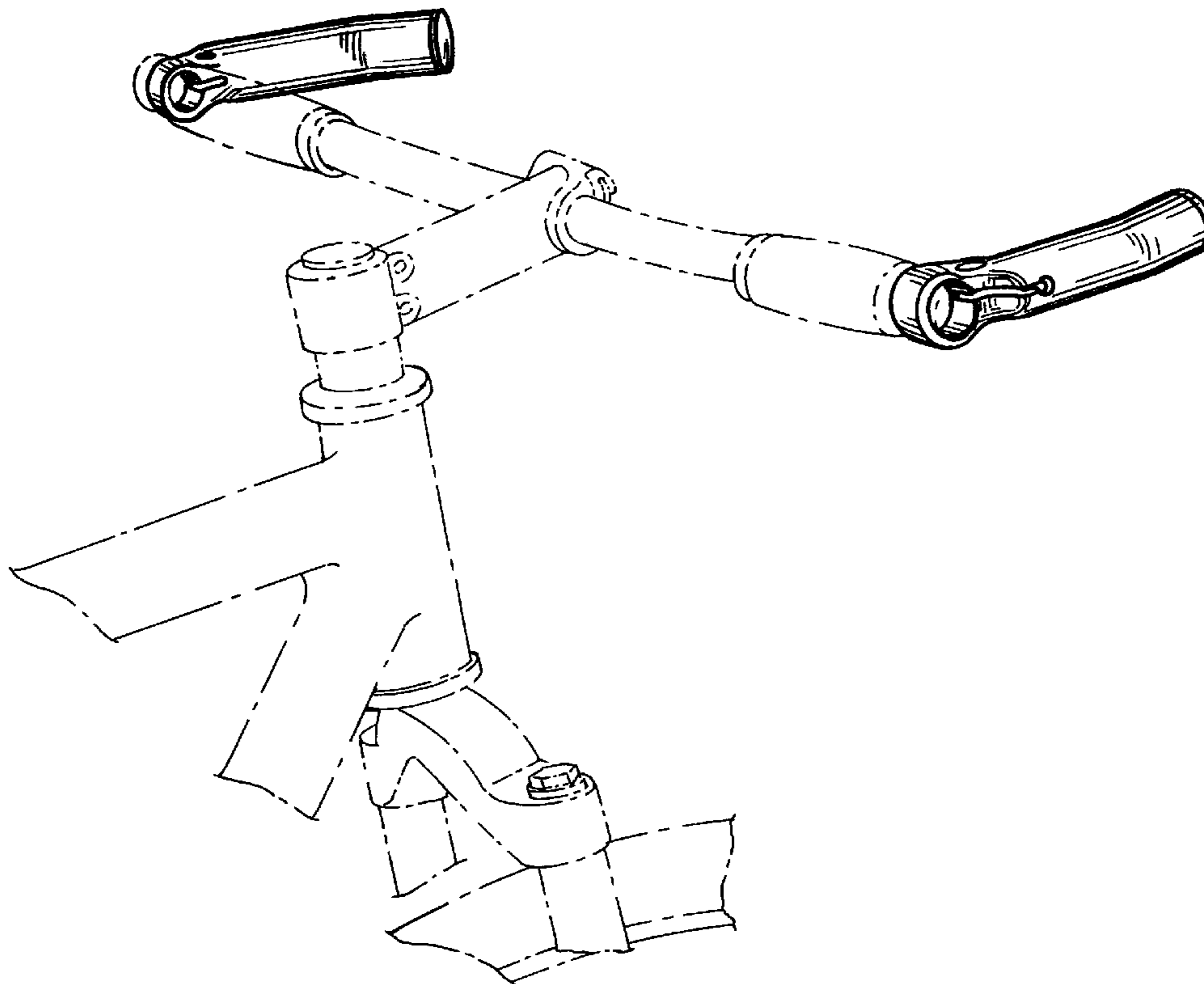
FIG. 4 is a side view (opposite FIG. 2) of the left bar end.

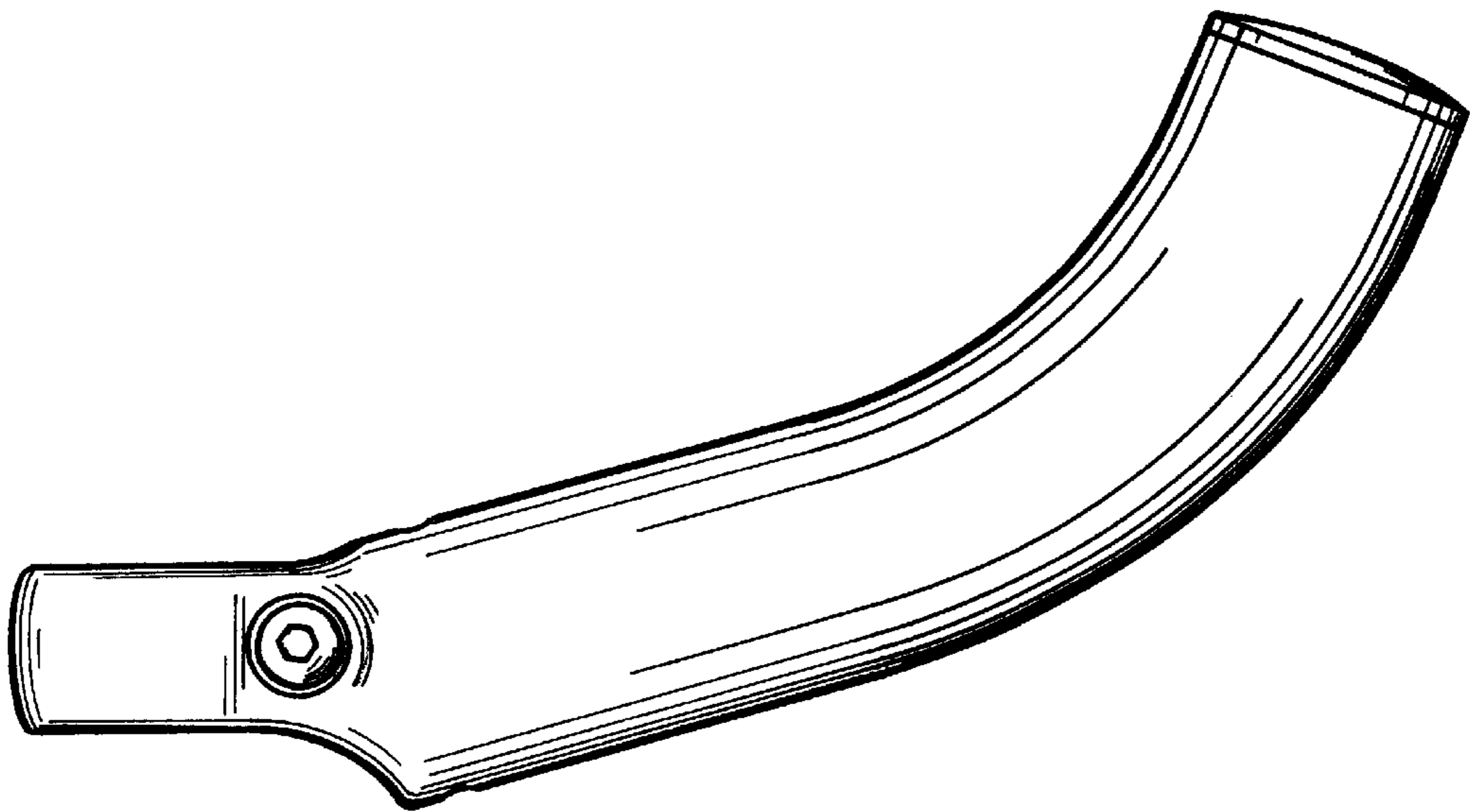

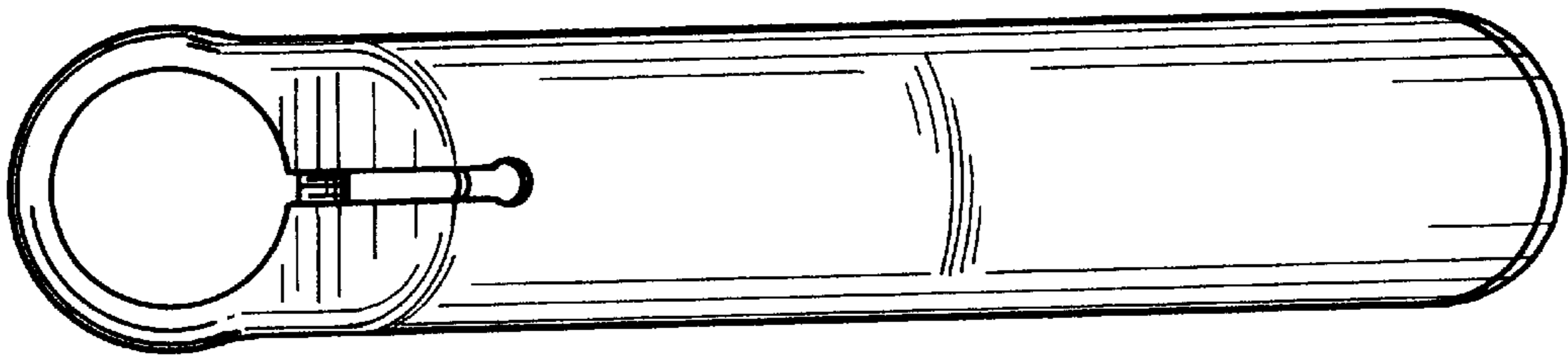

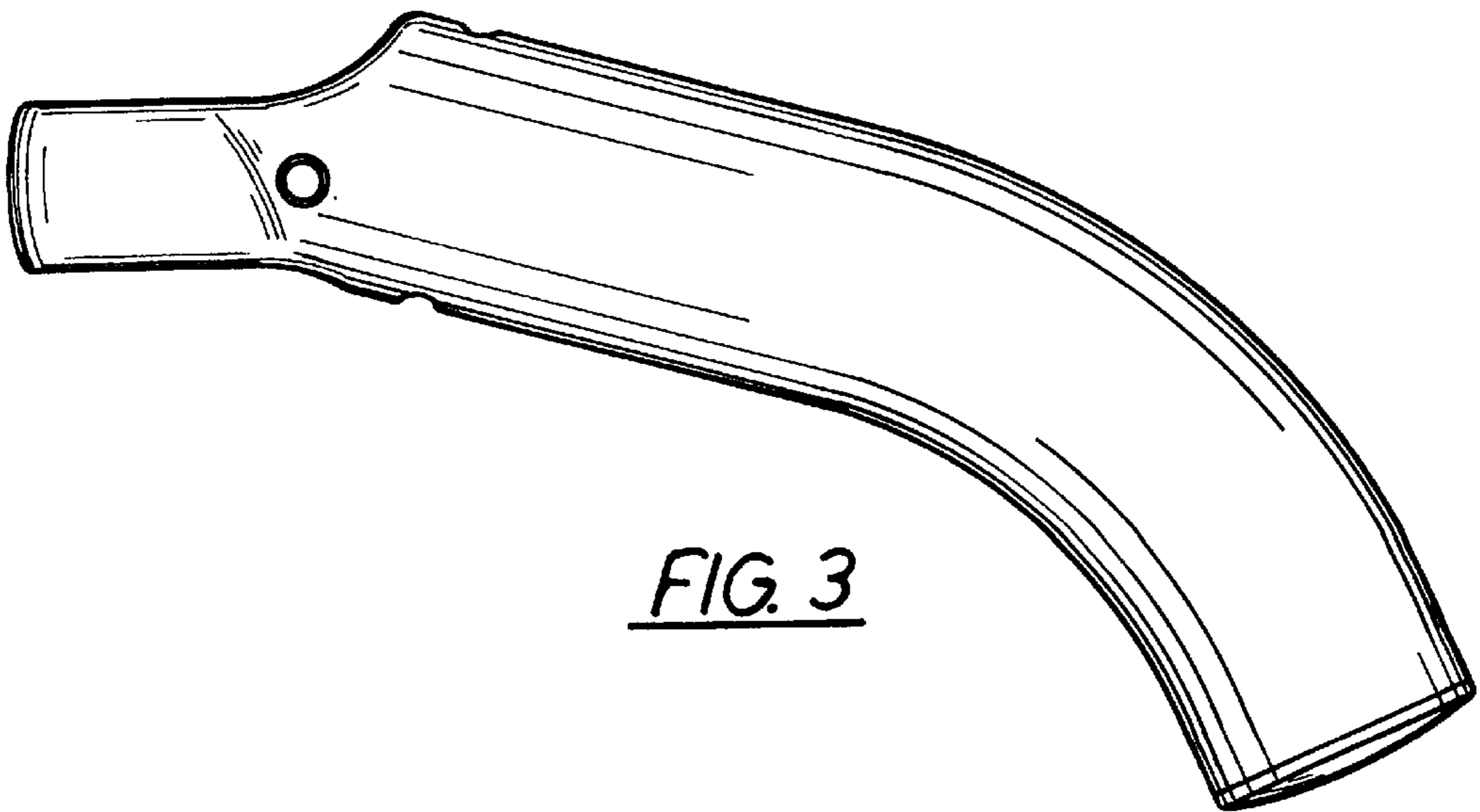

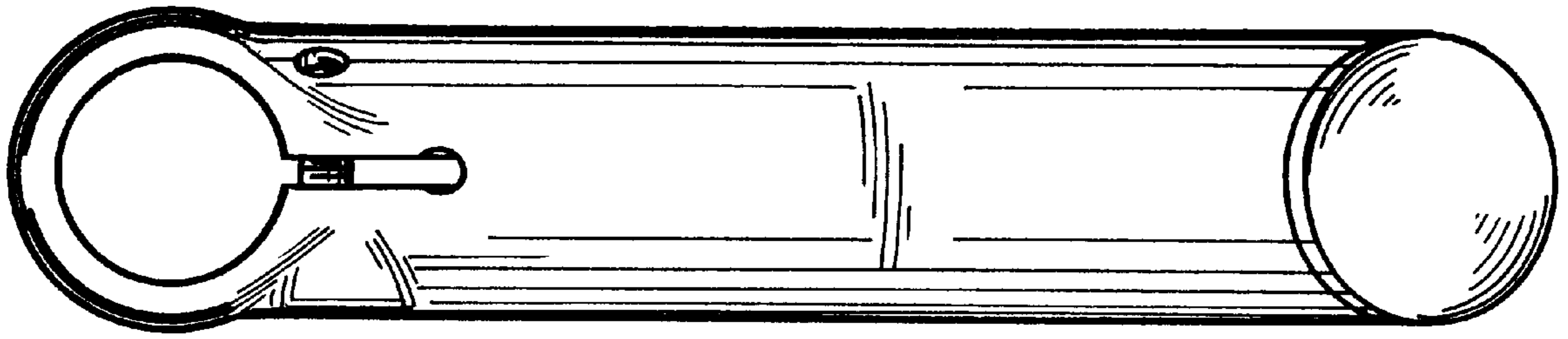

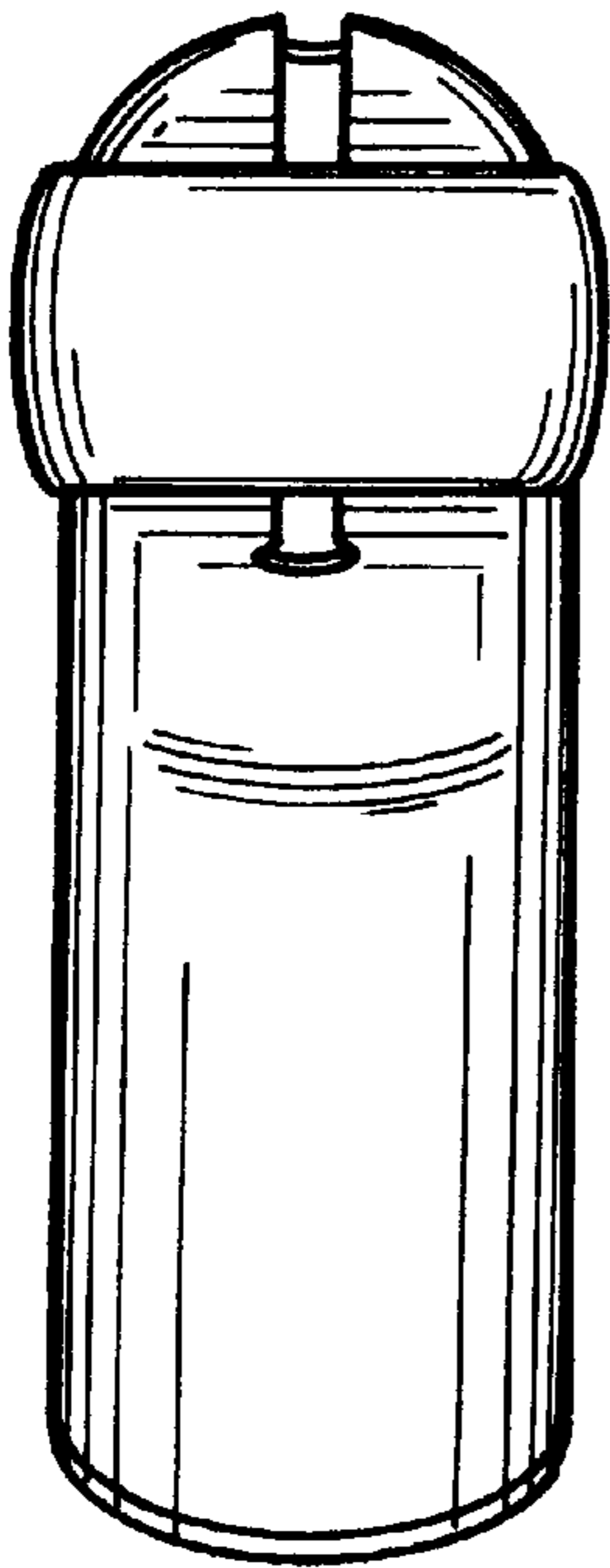

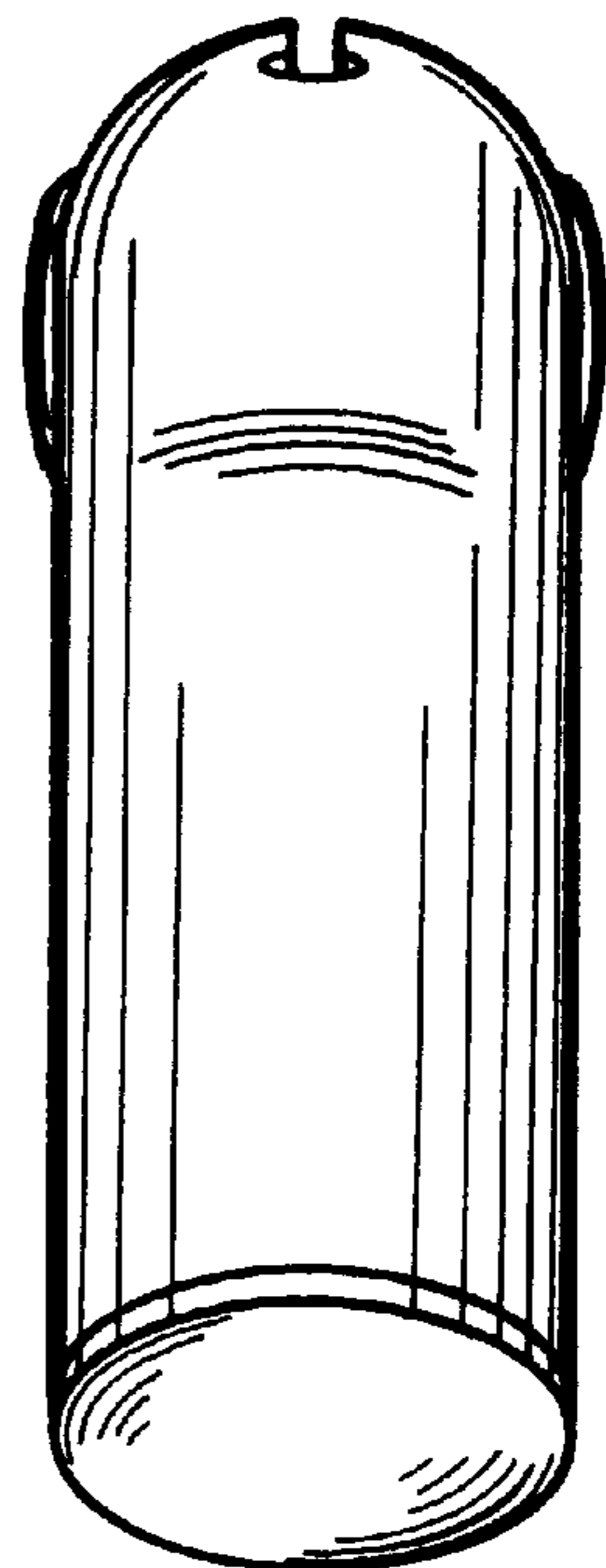

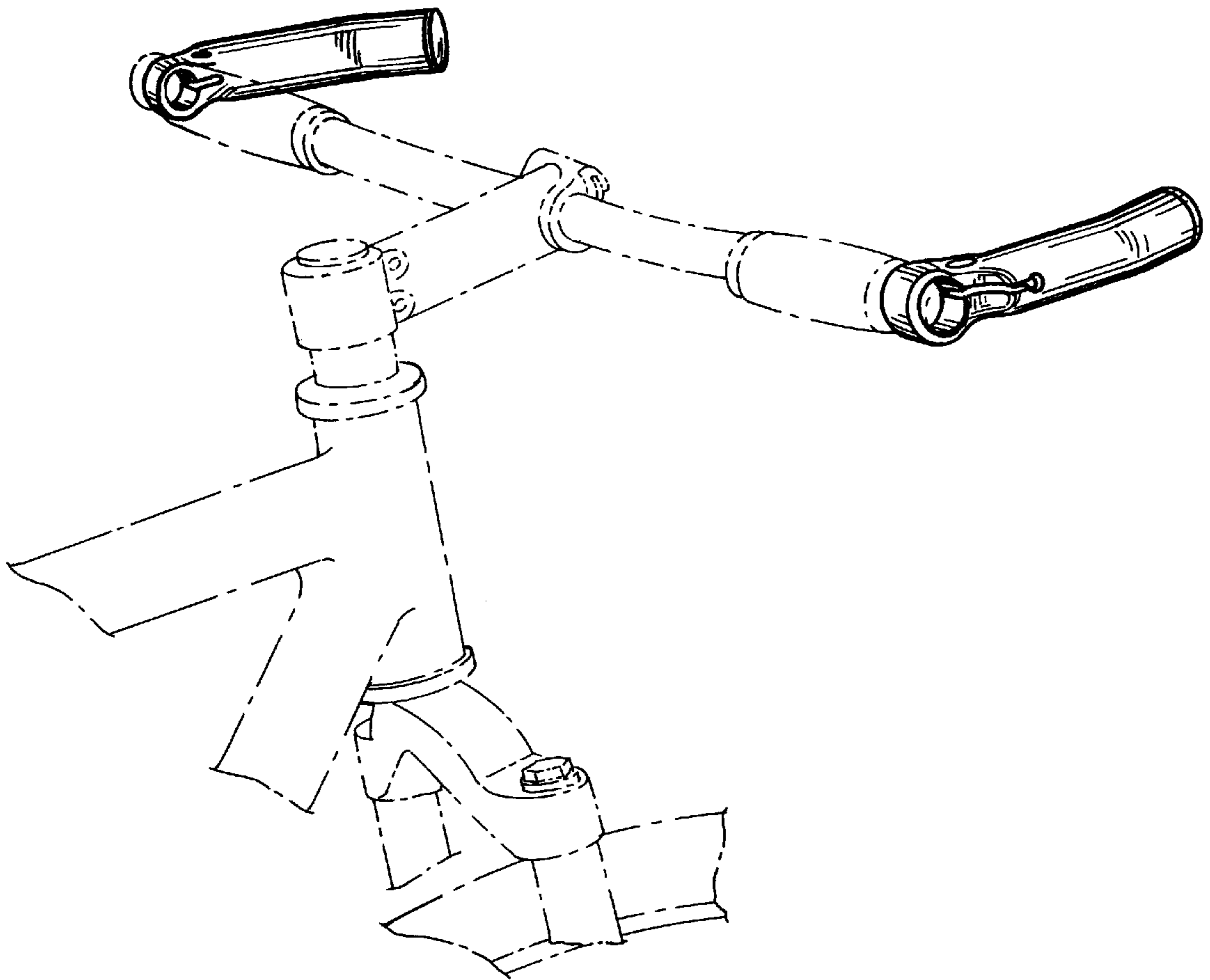
