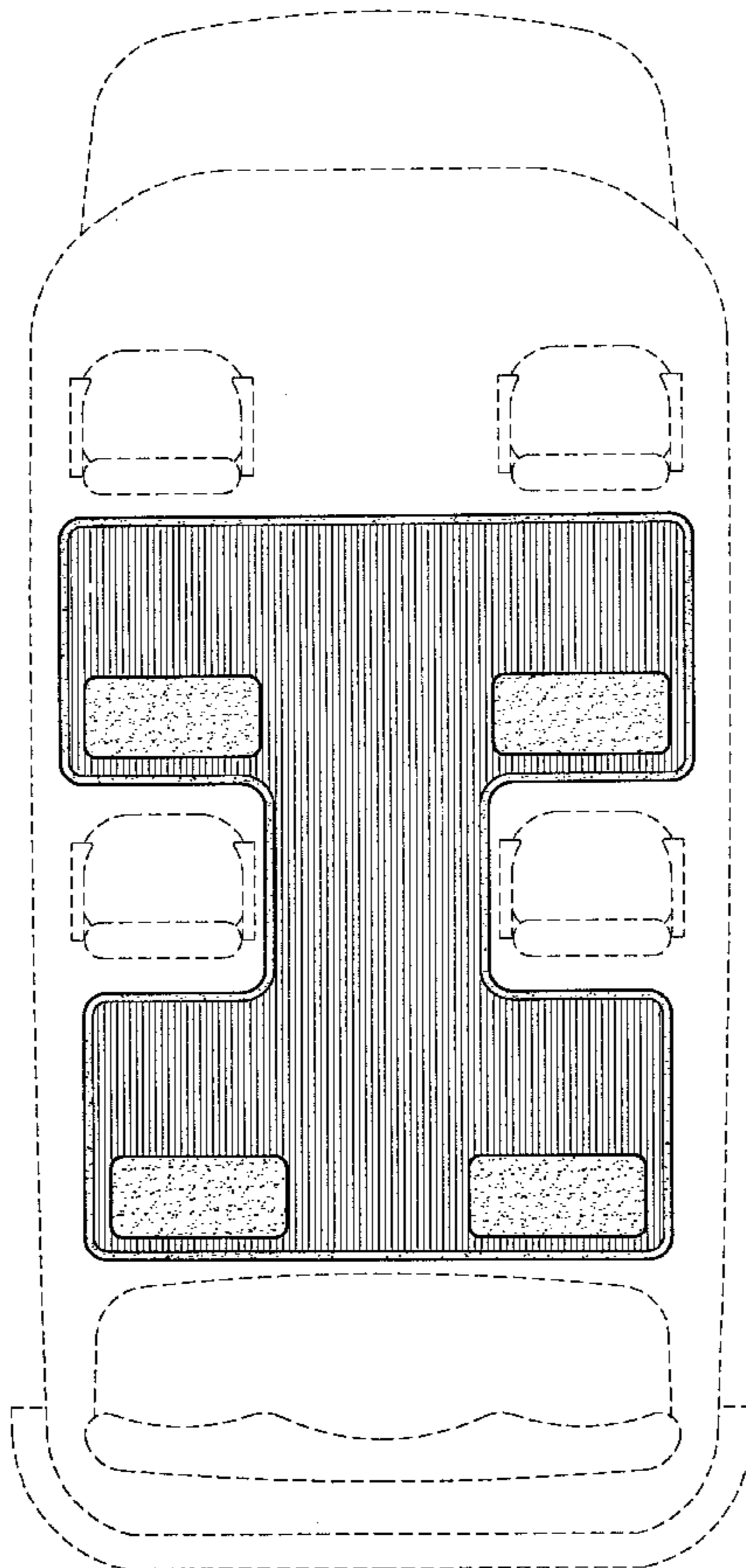
[57] CLAIM

The ornamental design for a van mat, as shown and described.

DESCRIPTION

FIG. 1 is an environmental top view of a van mat showing my new design;
FIG. 2 is an environmental bottom view thereof;
FIG. 3 is a right side elevational view with the left side being a mirror image thereof;
FIG. 4 is a rear elevational view thereof; and,
FIG. 5 is a front elevational view thereof.
The broken line showing of environment is for illustrative purposes only and forms no part of the claimed design.

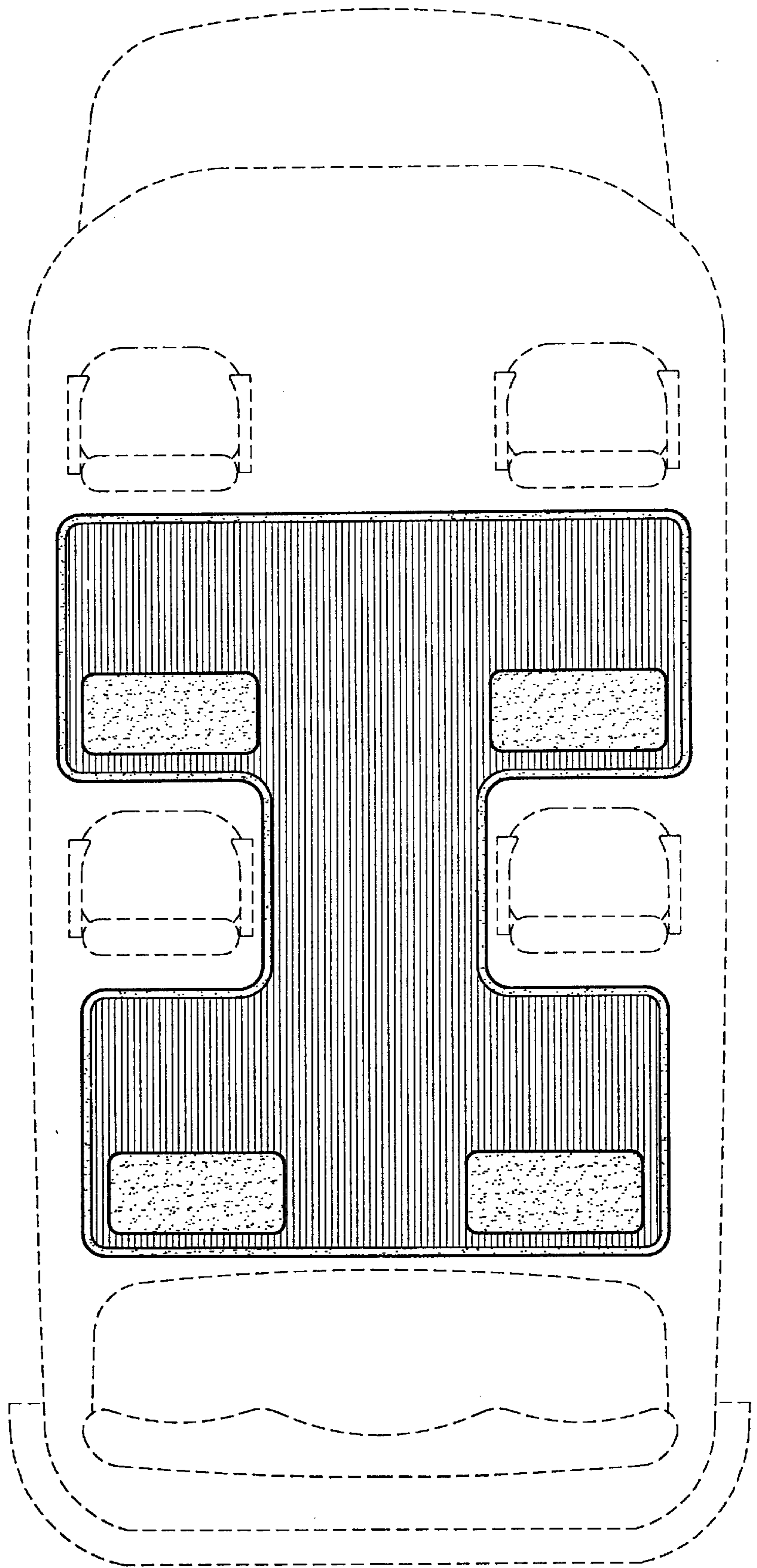

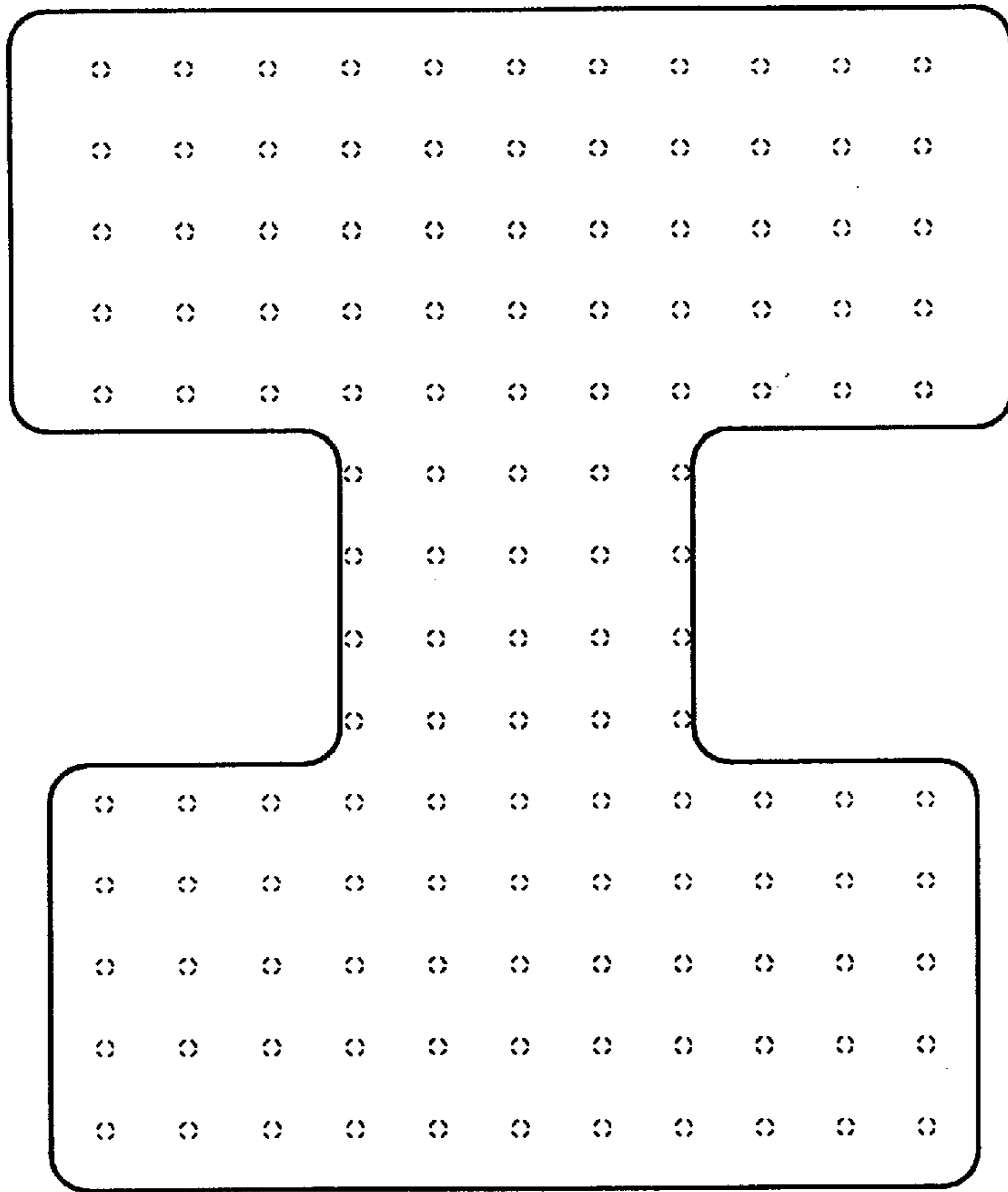

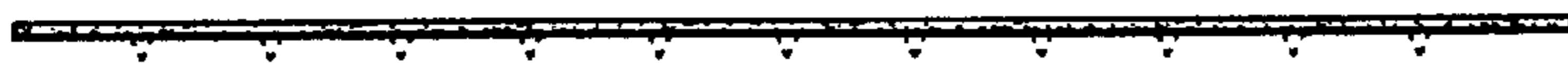

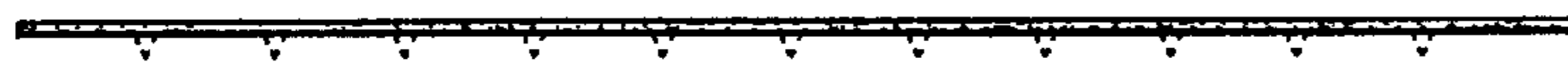
