The ornamental design for a console for vehicle, as shown and described.

DESCRIPTION

FIG. 1 is a top right front perspective view of a console for vehicle showing my new design shown in its position of use; FIG. 2 is a front elevational view thereof; FIG. 3 is a right side elevational view thereof, which is a mirror image of the left side elevational view thereof; FIG. 4 is a top plan view thereof; and, FIG. 5 is a bottom plan view thereof.

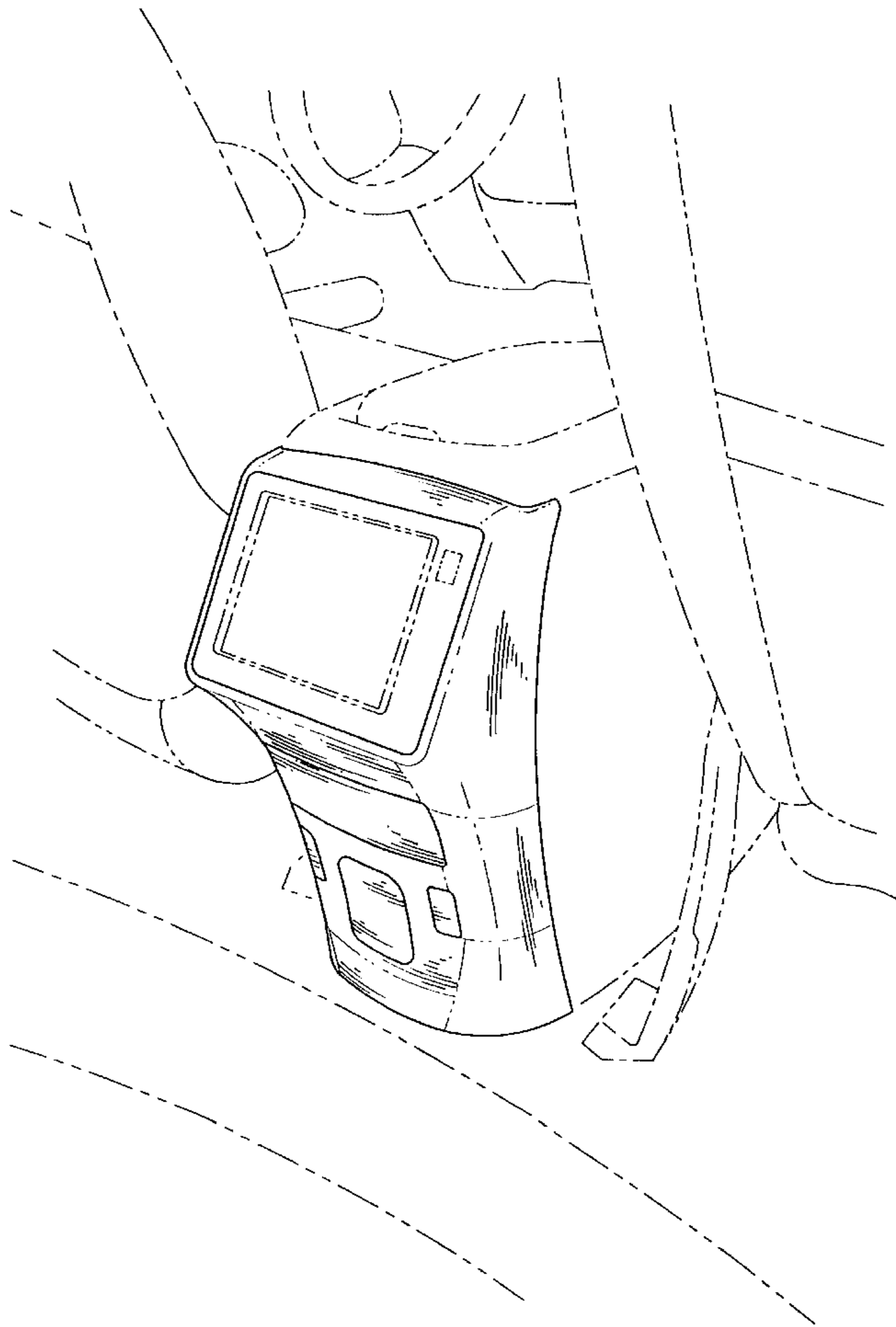

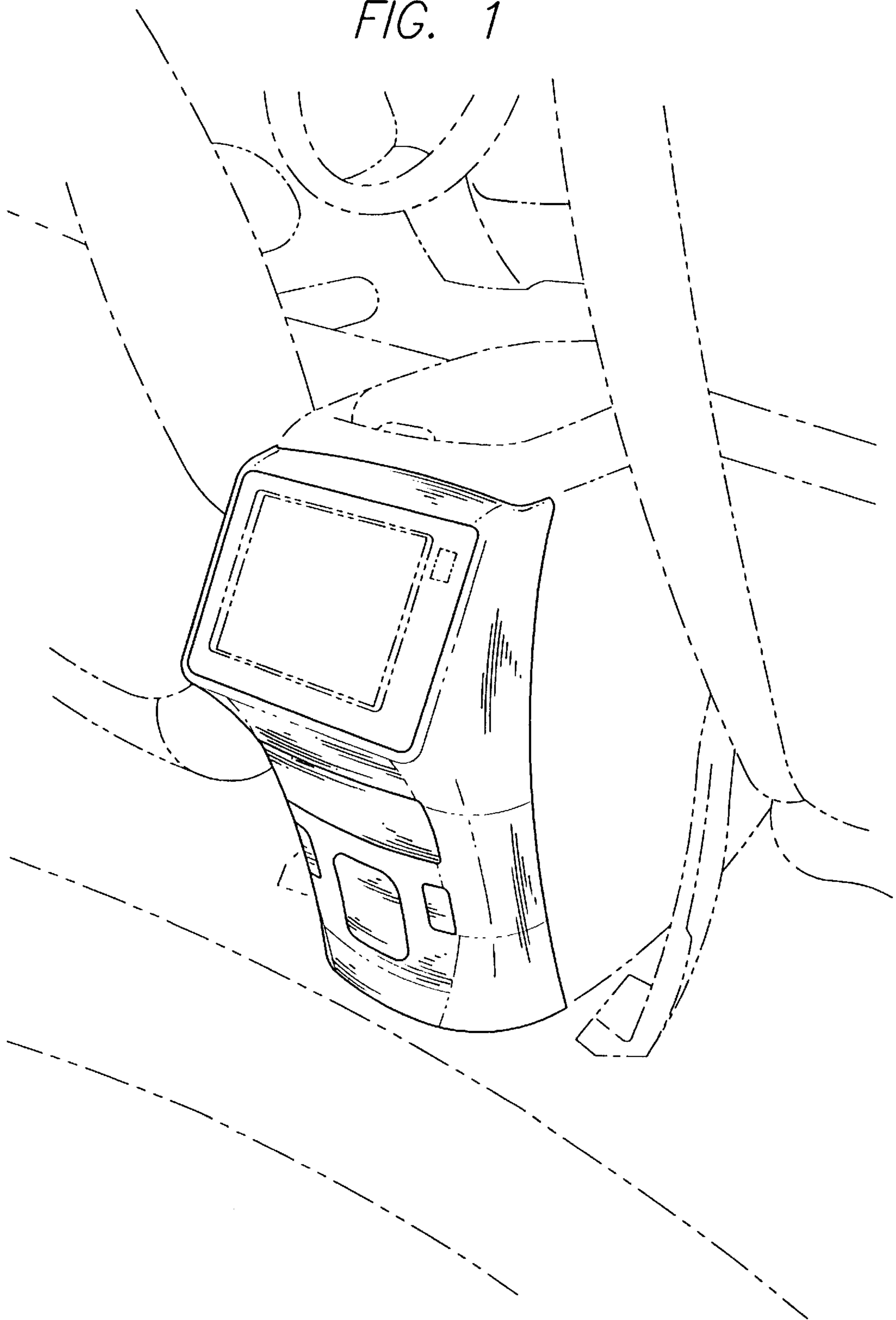

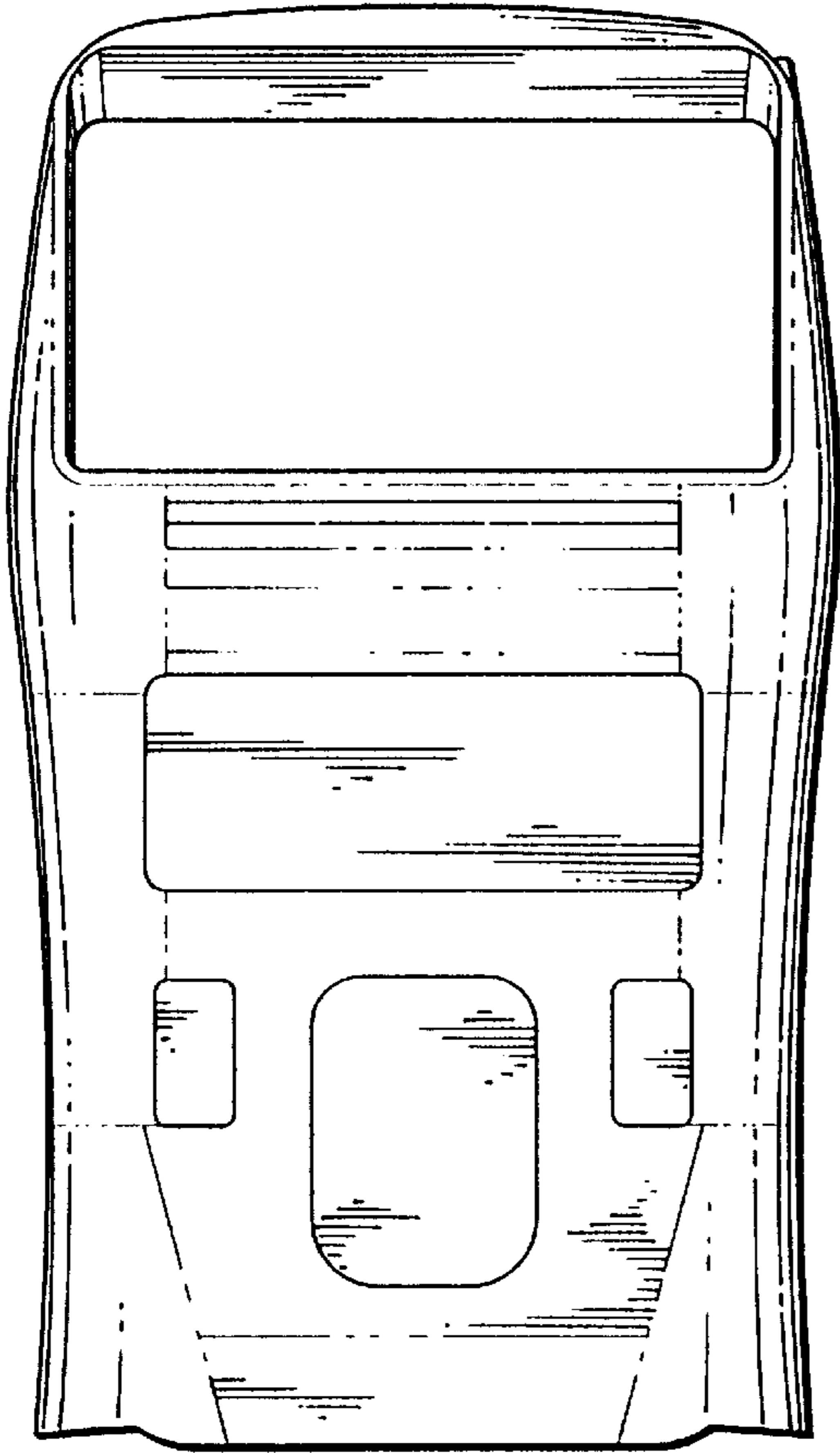

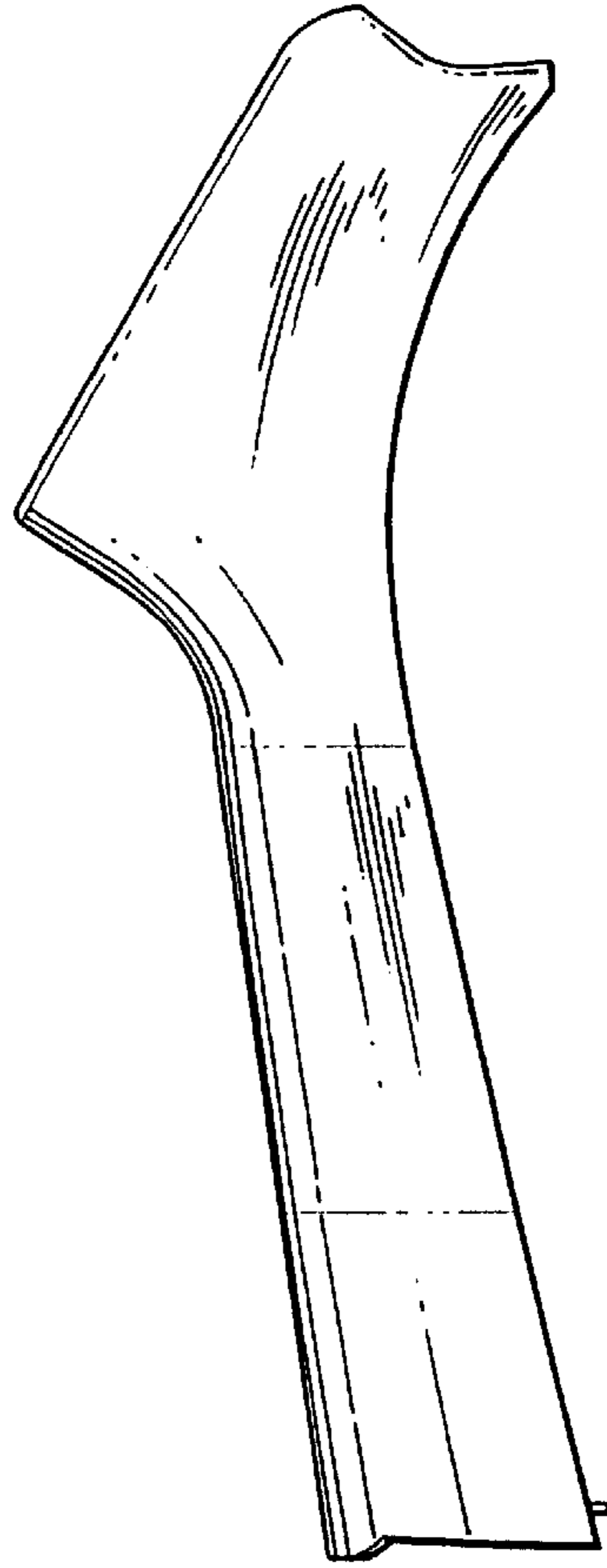

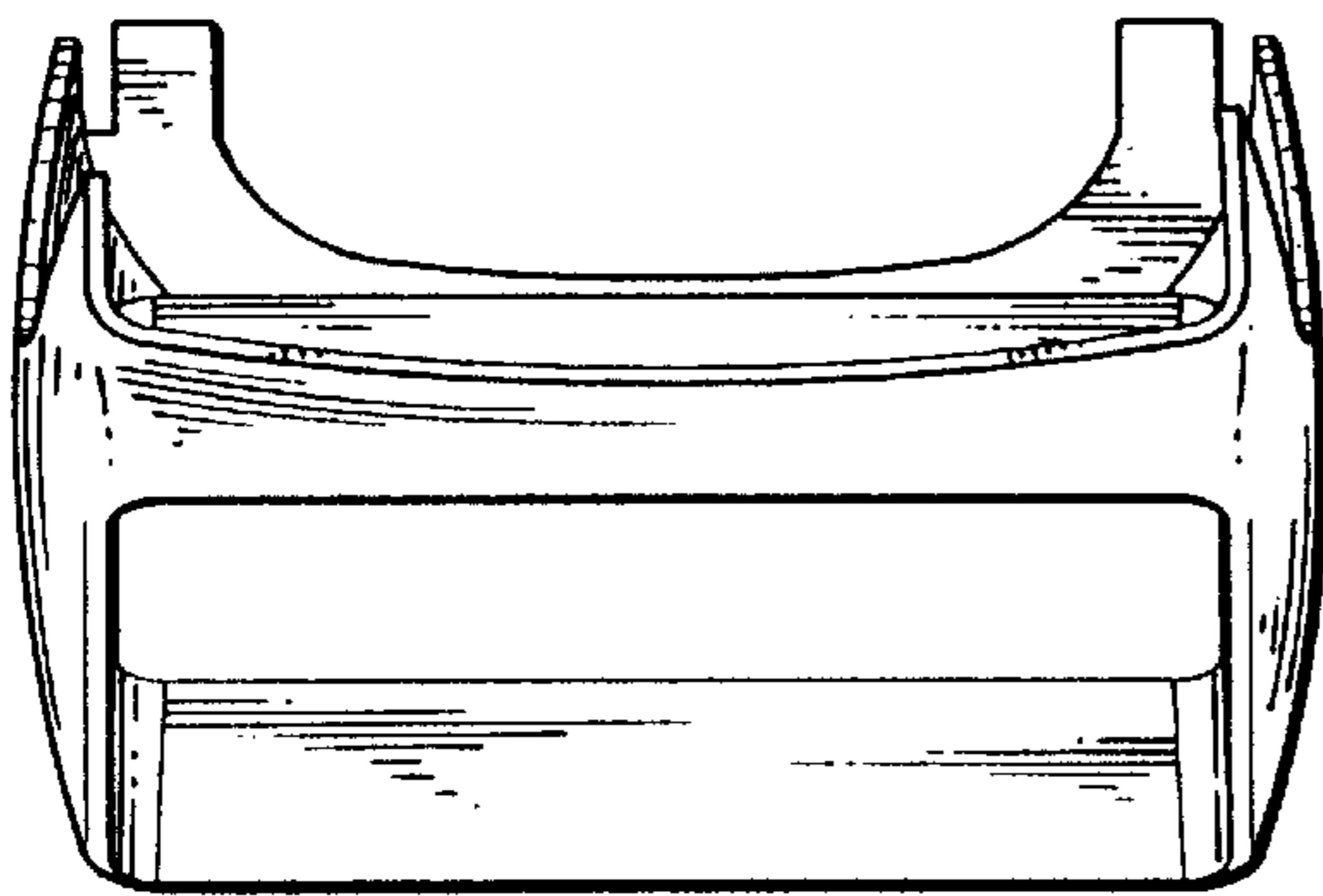
