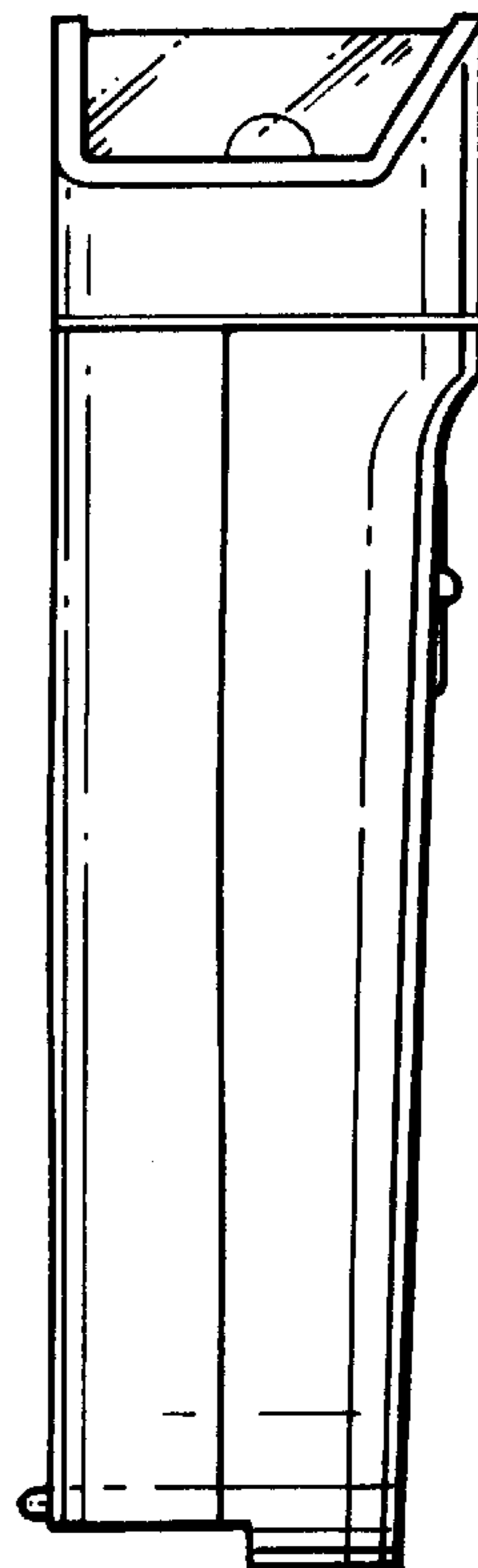
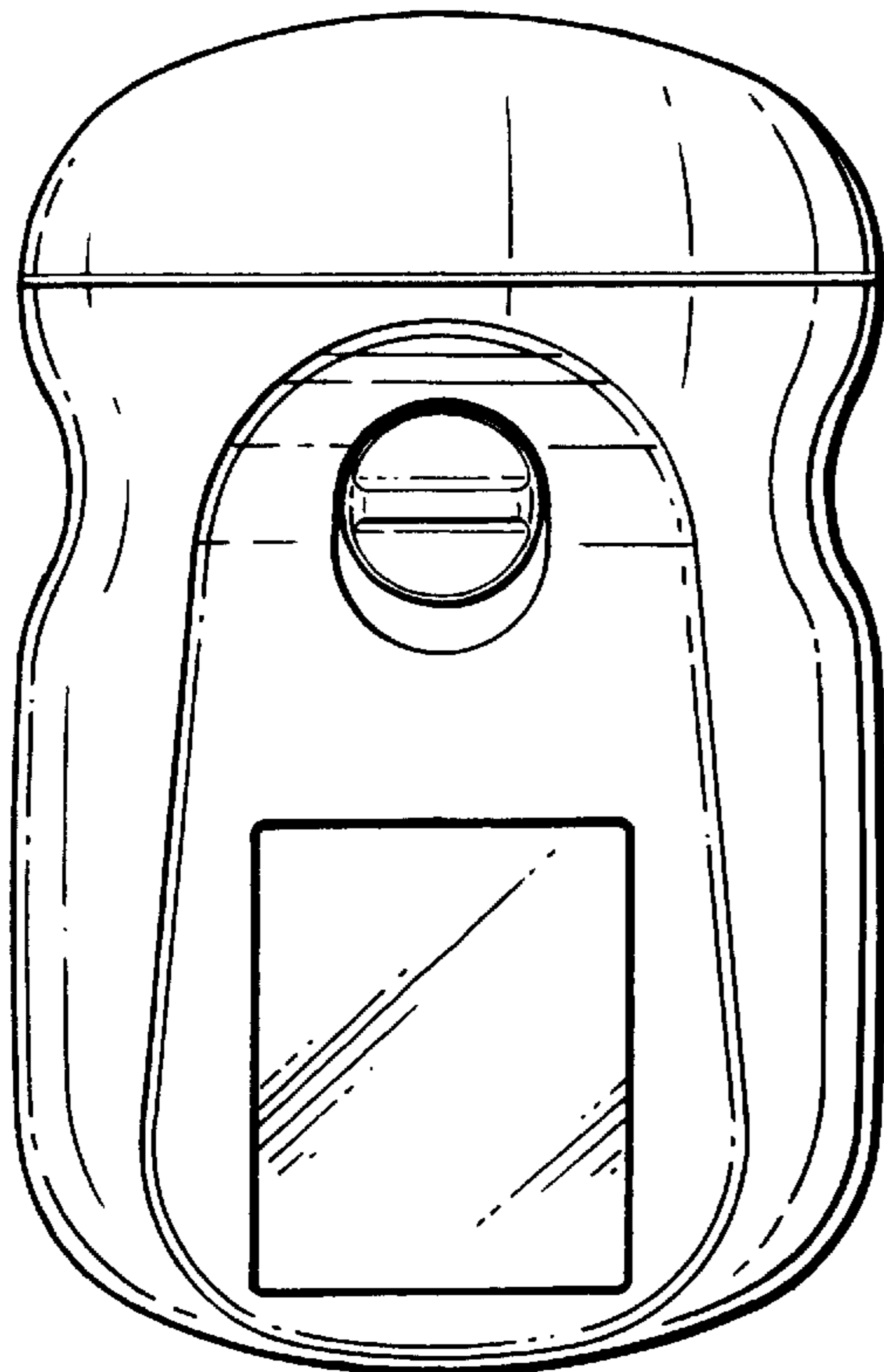
[57] CLAIM

The ornamental design for a rechargeable emergency light, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a rechargeable emergency light showing my new design;
 FIG. 2 is a left side elevational view thereof;
 FIG. 3 is a rear elevational view thereof;
 FIG. 4 is a right side elevational view thereof;
 FIG. 5 is a top plan view thereof;
 FIG. 6 is an underneath plan view thereof;
 FIG. 7 is a rear elevational view with plug extended thereof;
 FIG. 8 is a right side elevational view with plug extended thereof; and,
 FIG. 9 is an underneath plan view with plug extended.

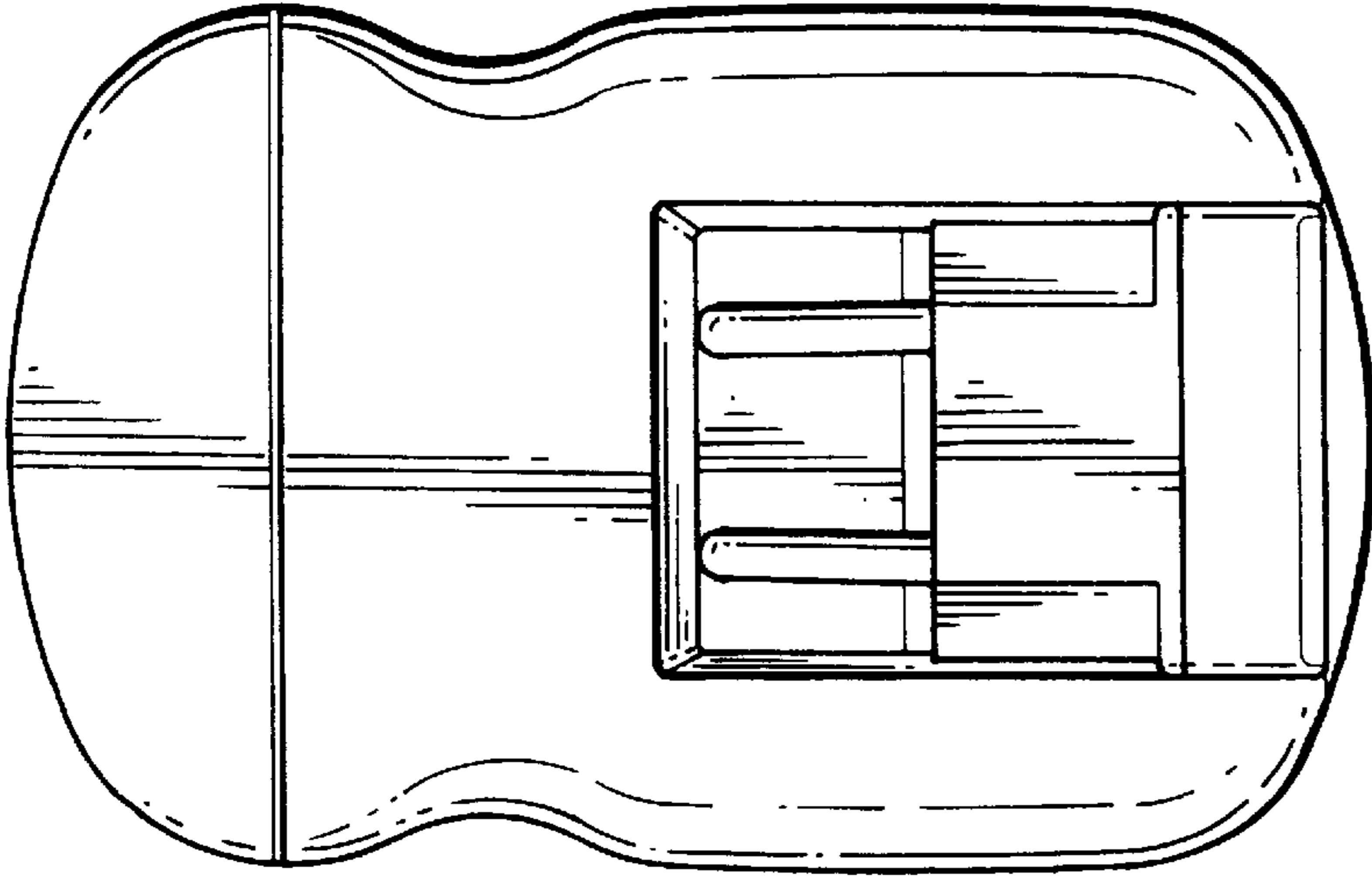

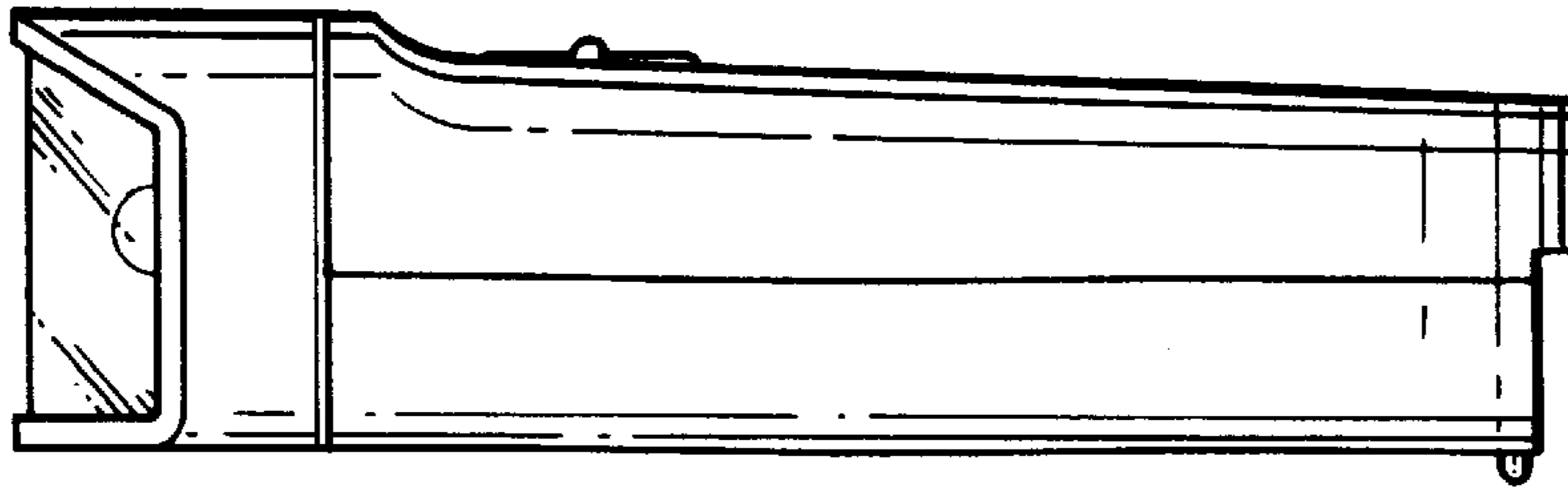

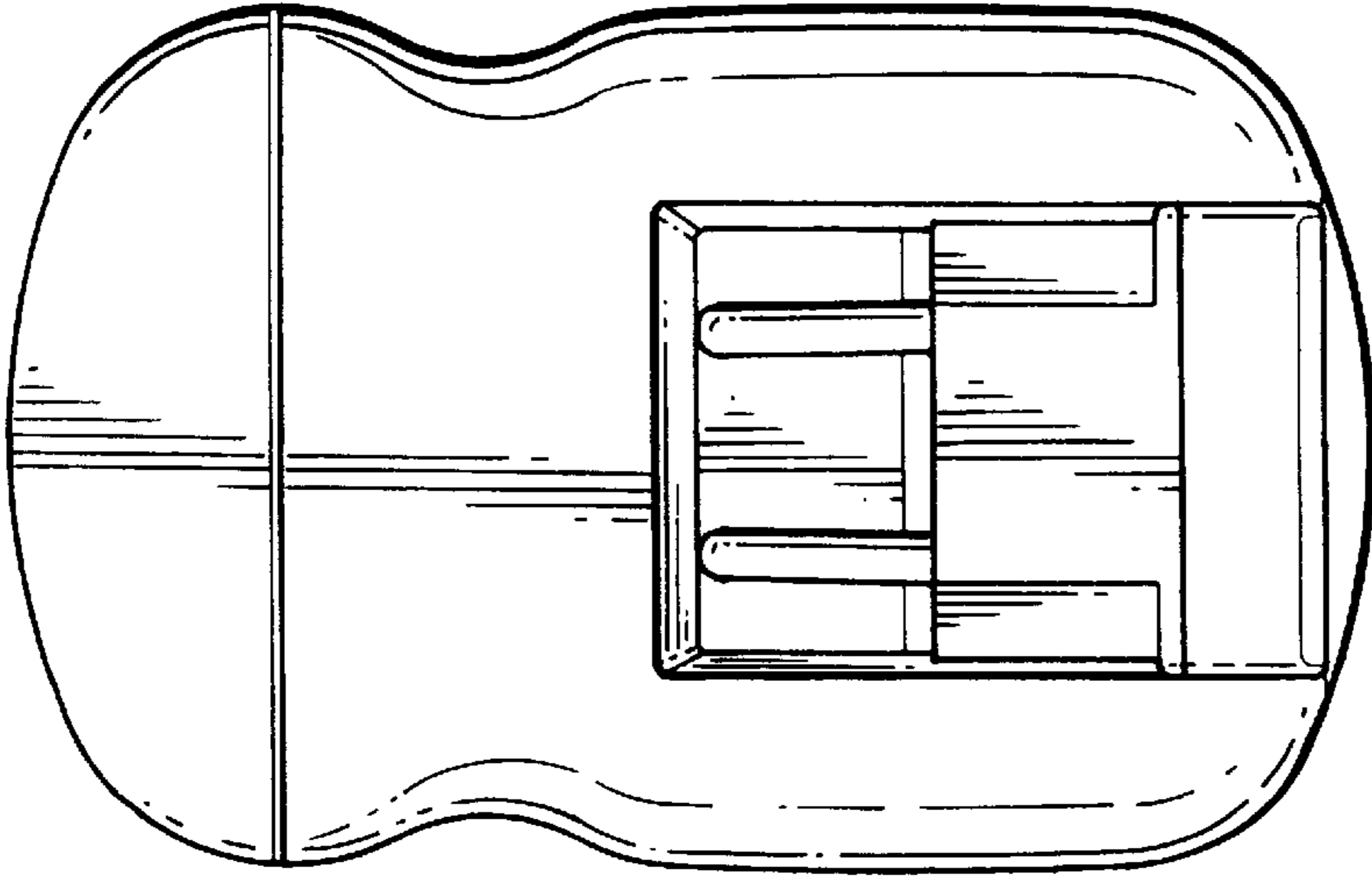

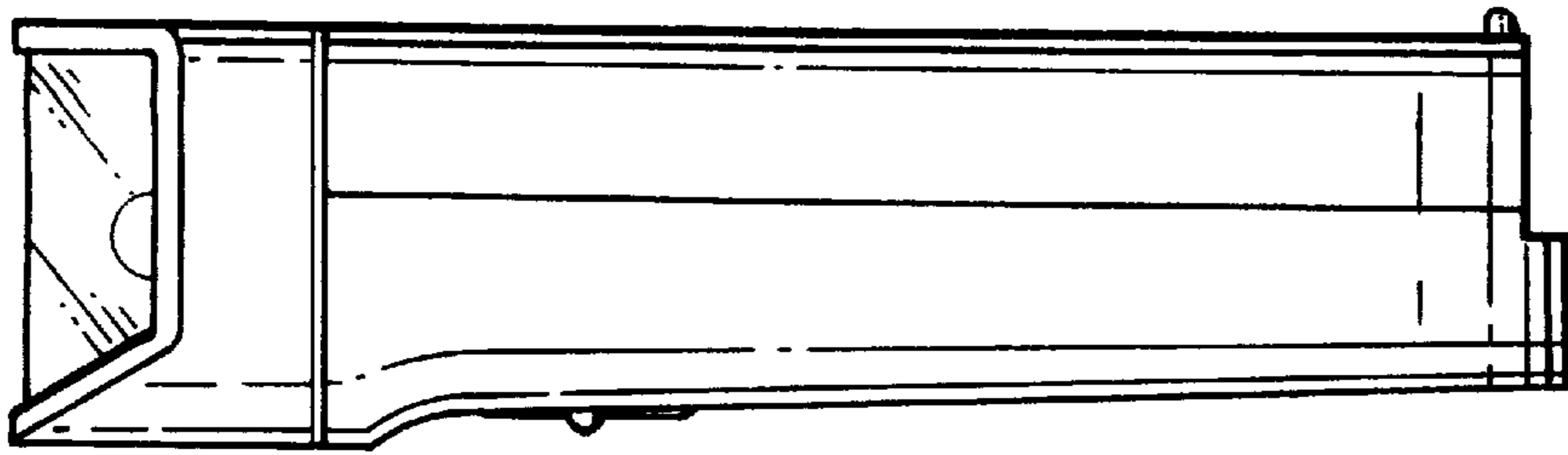

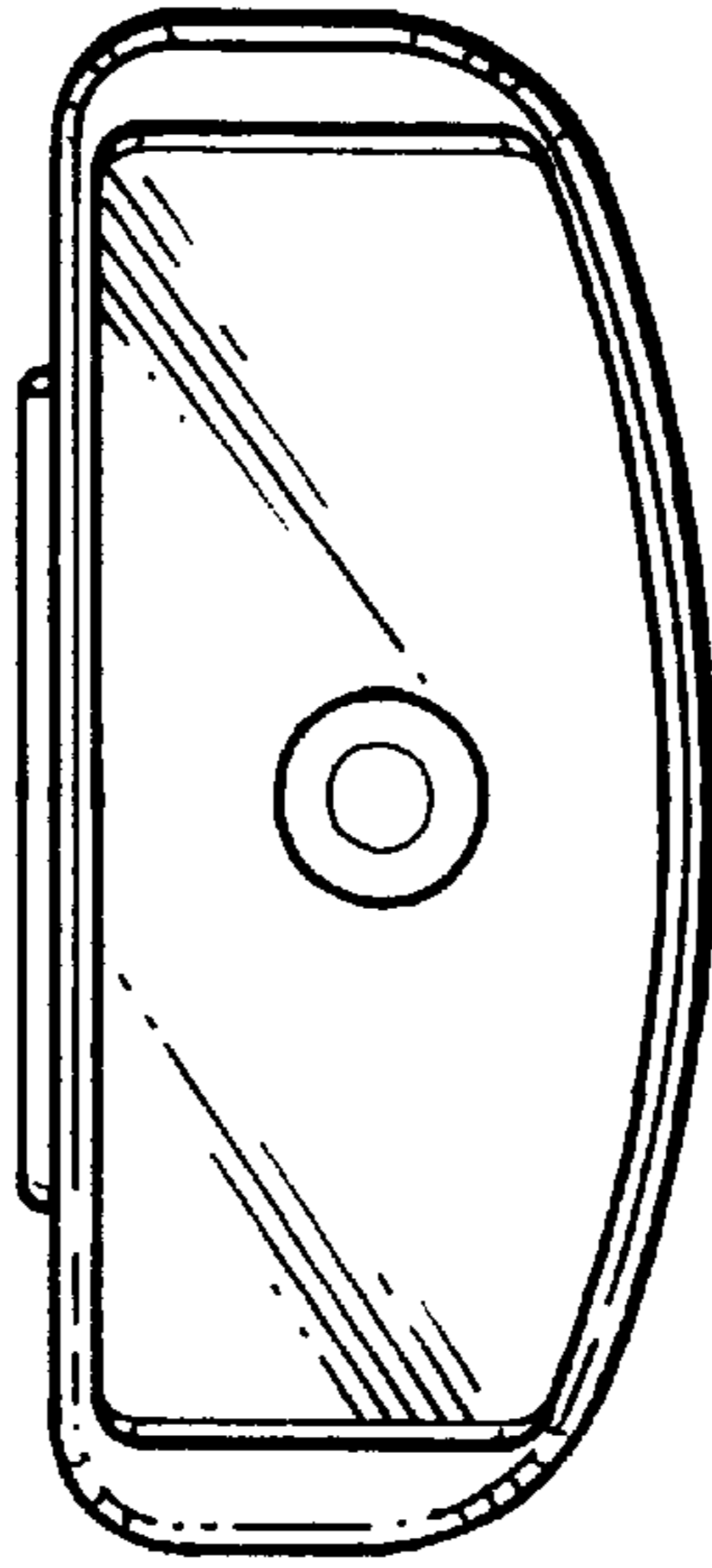

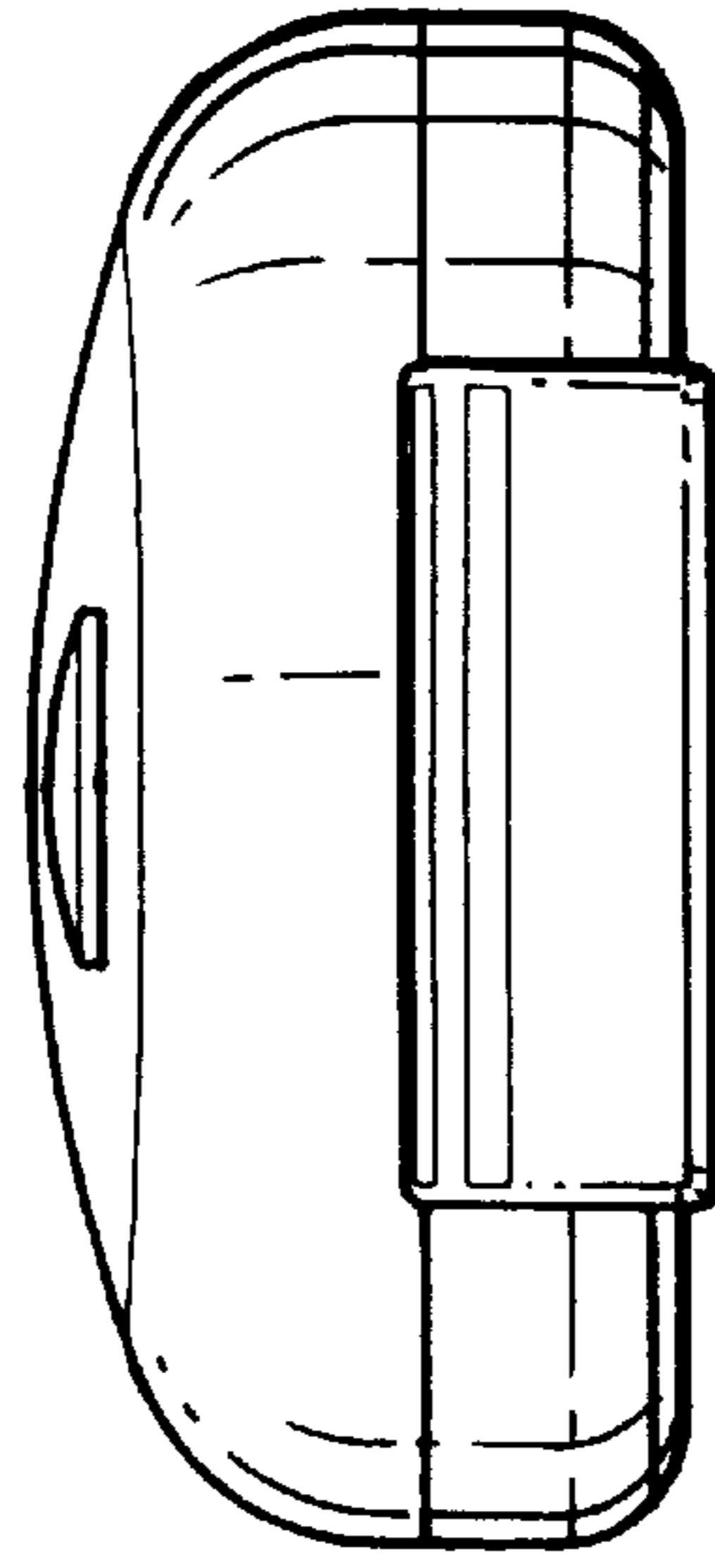

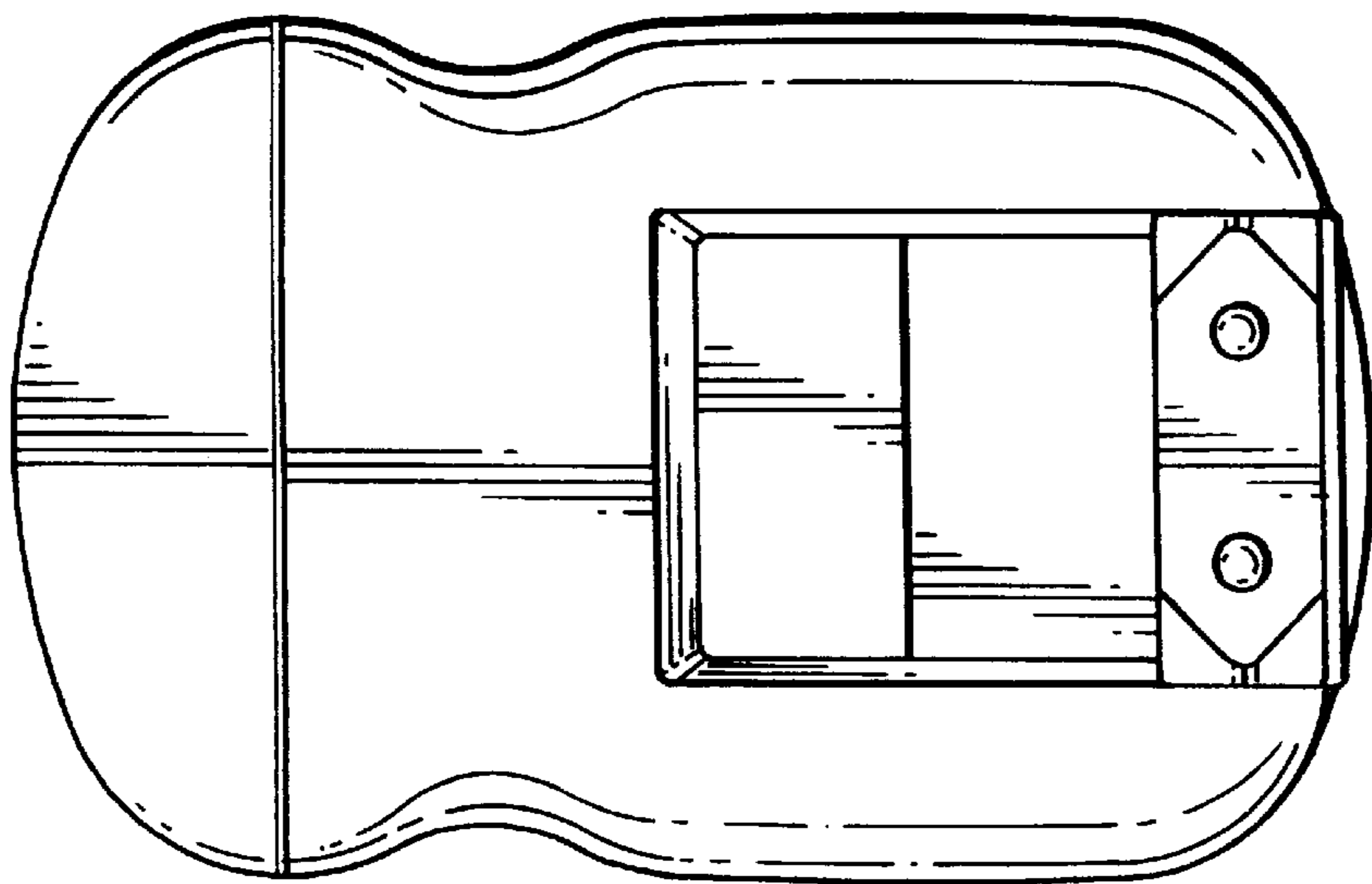

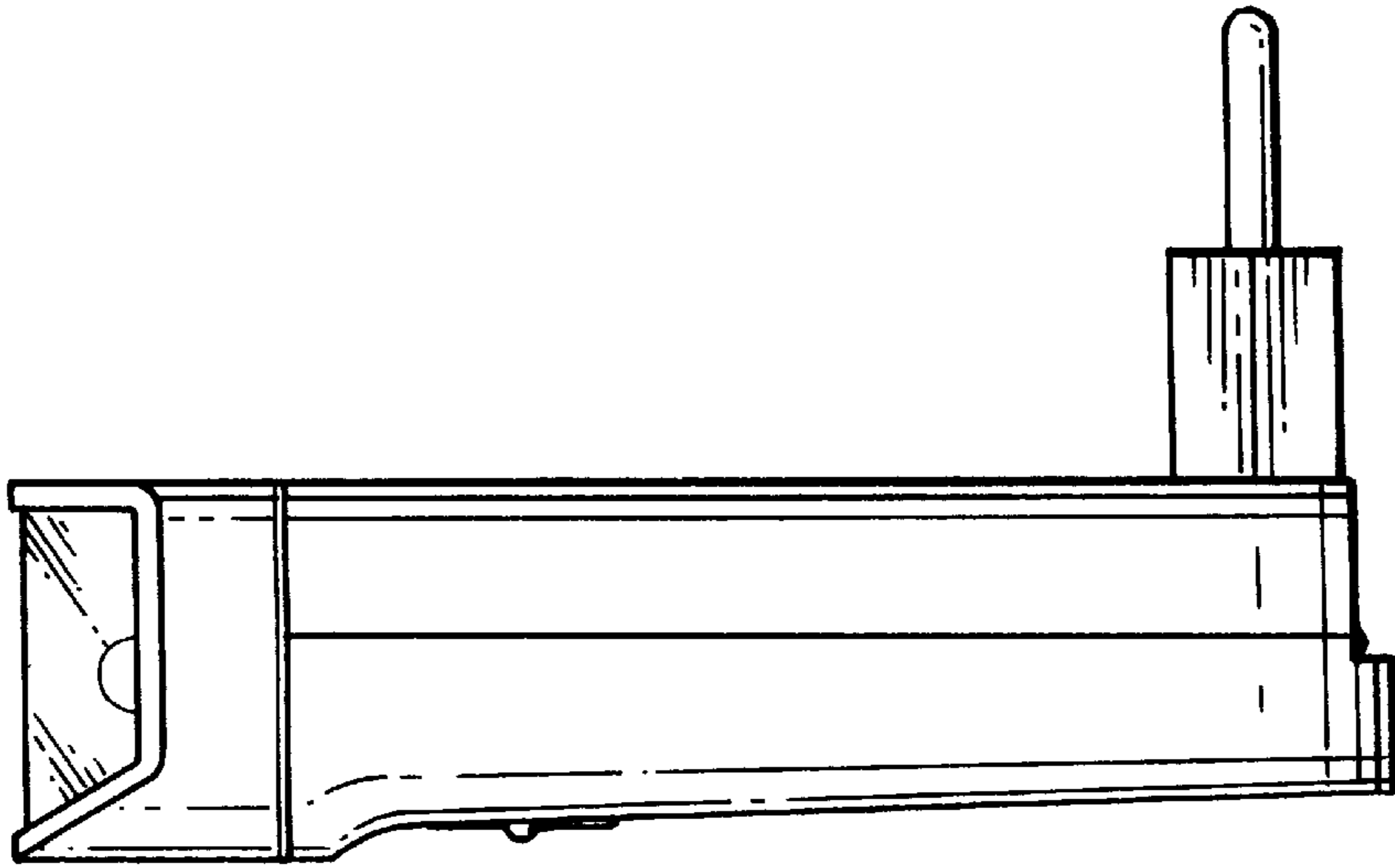

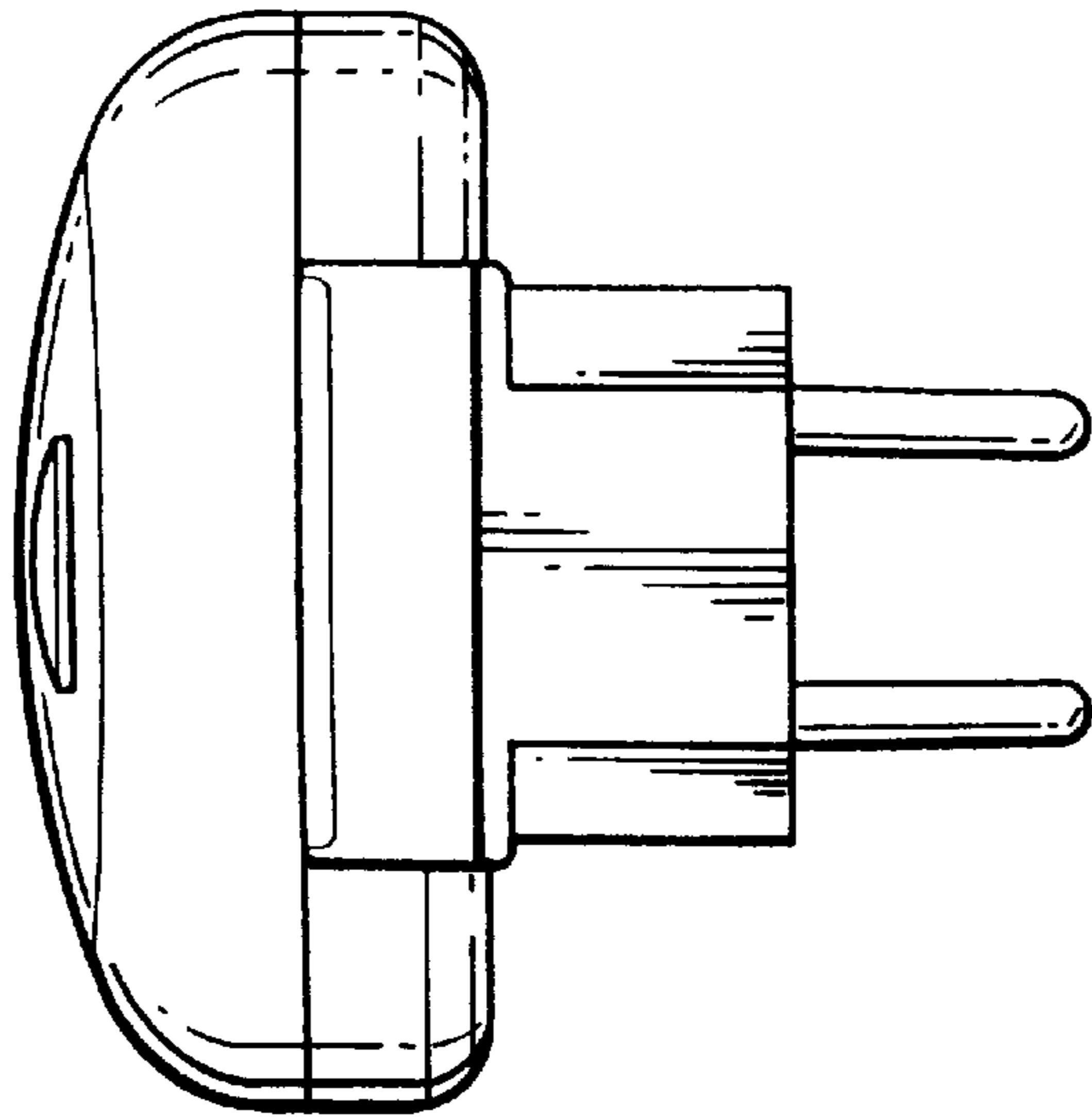
