opposite side being a mirror image thereof;

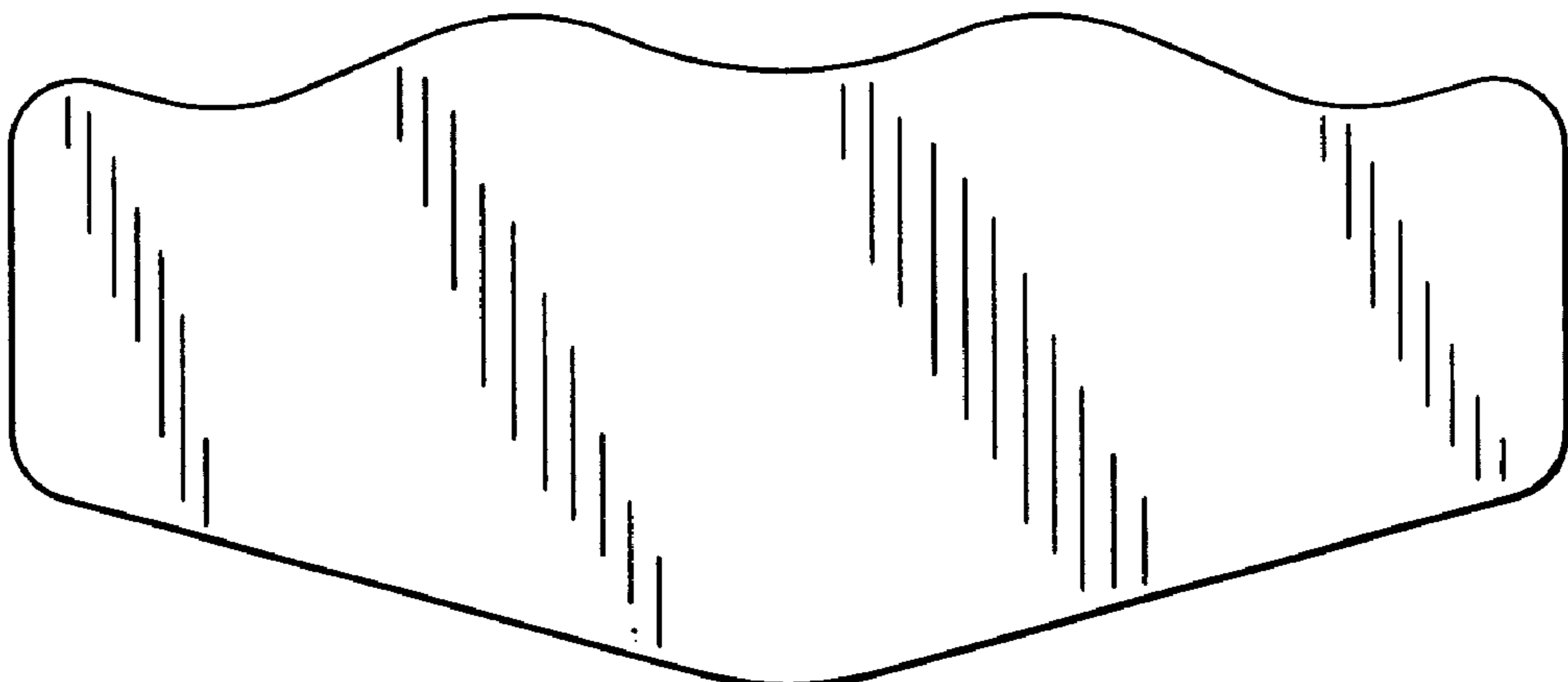
FIG. 5 is a perspective view of the beauty face sheet of FIG.

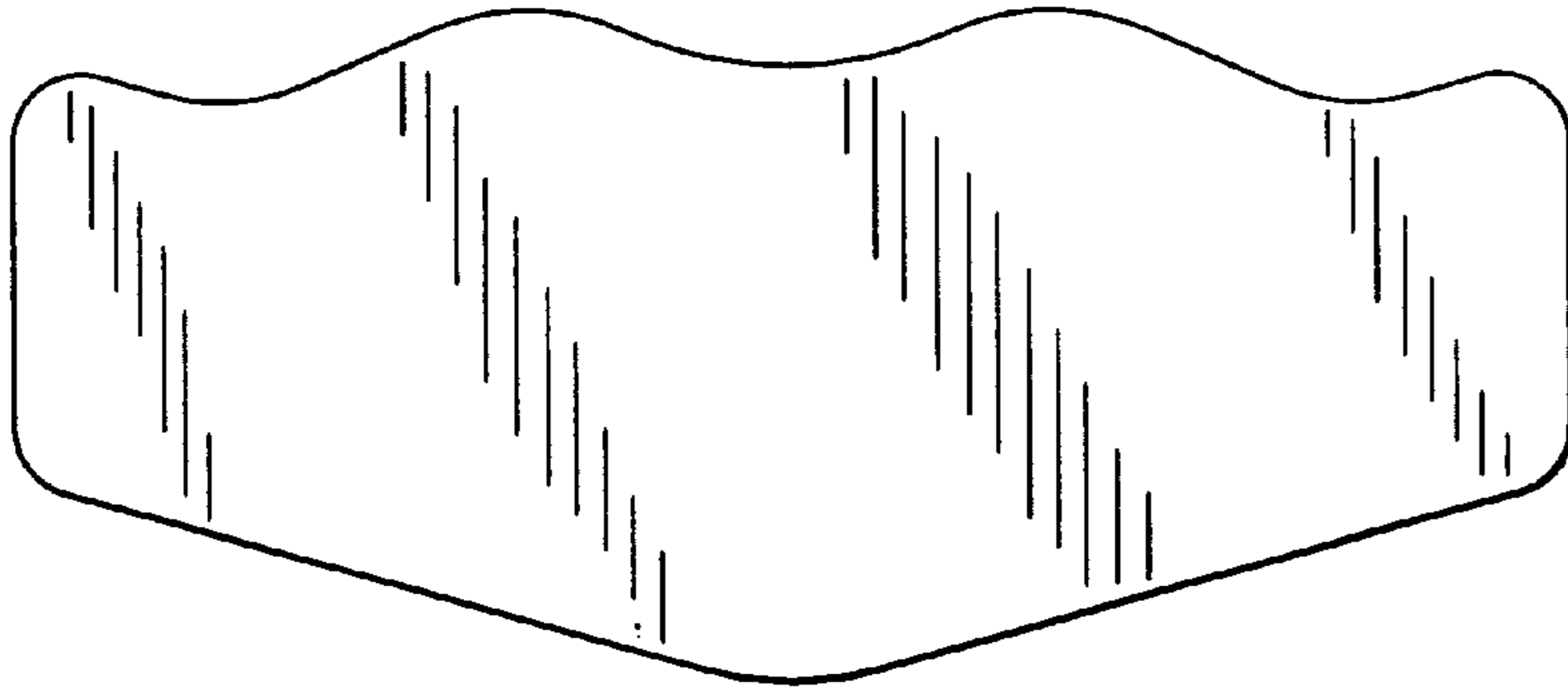

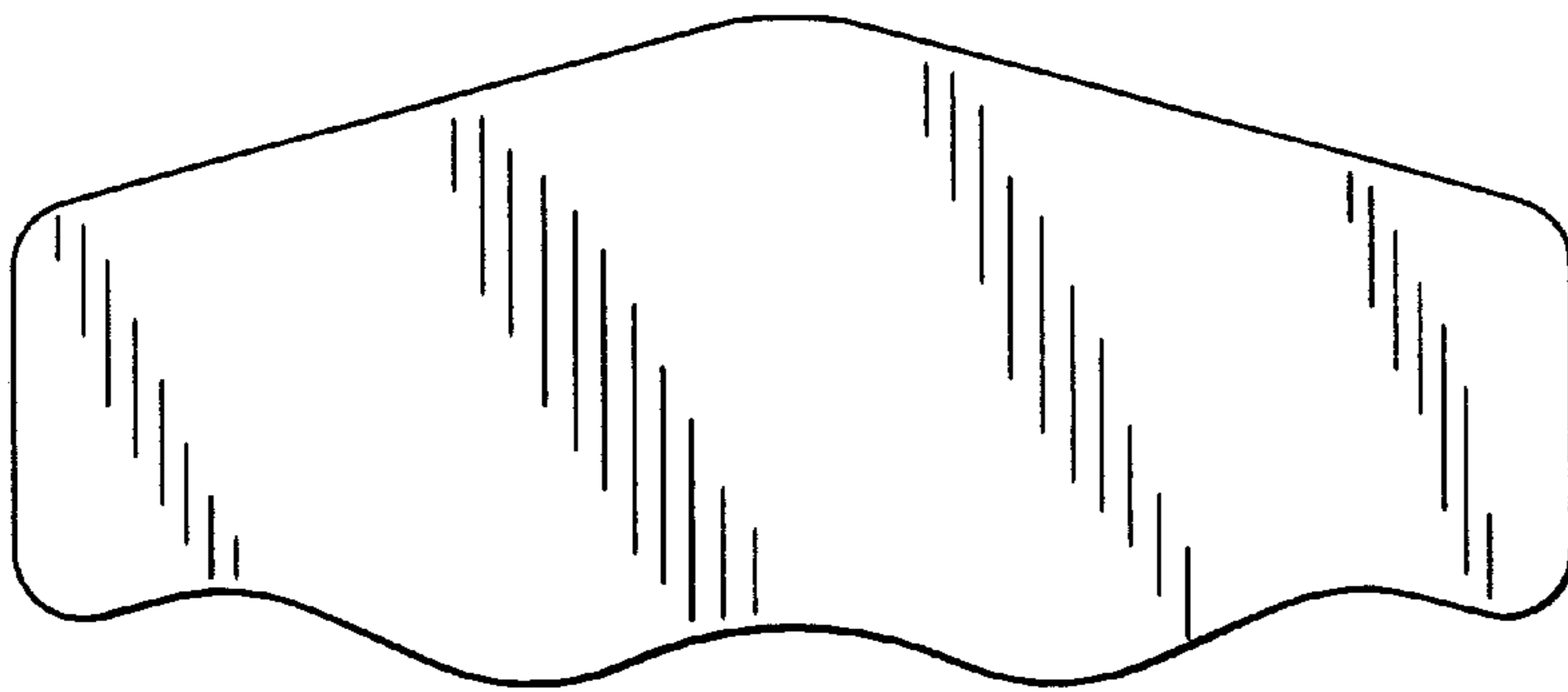

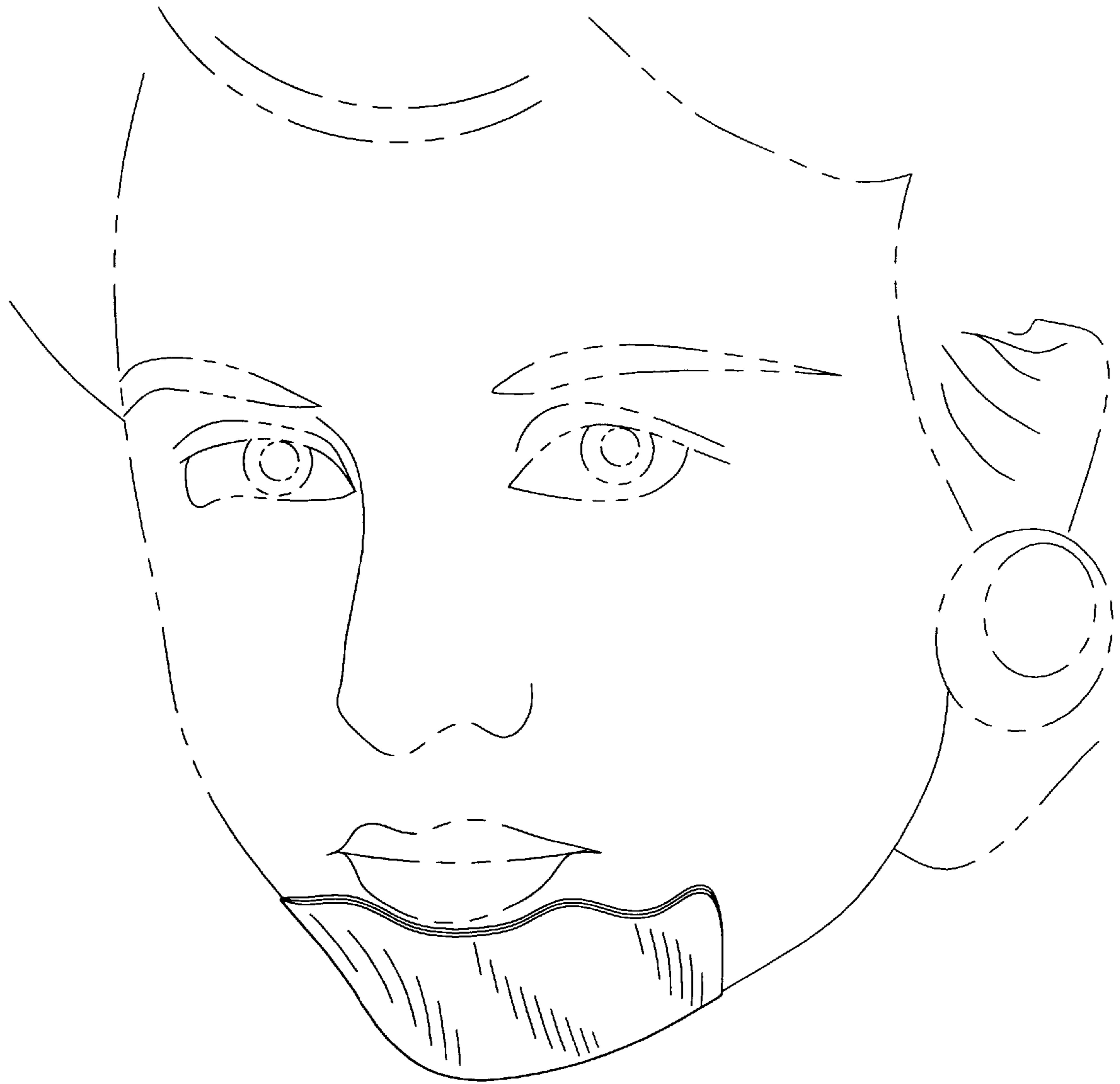
