[57] **CLAIM**

The ornamental design for a sports sock with crochet and beads, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a sport sock with crochet and beads showing my new design, all embodiments are identical except for the beads;

FIG. 2 is an enlarged fragmentary view of the portion outlined in dotted lines in FIG. 1;

FIG. 3 is an enlarged sectional view of the sock taken along the line 3 in FIG. 2;

FIG. 4 is an enlarged sectional view of the manner in which the beads are attached, taken along the line 4 in FIG. 2; and, FIG. 5 is a second embodiment of sport sock with crochet and beads showing my new design, the bead is drawn separately for ease of illustration;

FIG. 6 is a third embodiment of a sport sock with crochet and beads, the bead is drawn separately for ease of illustration;

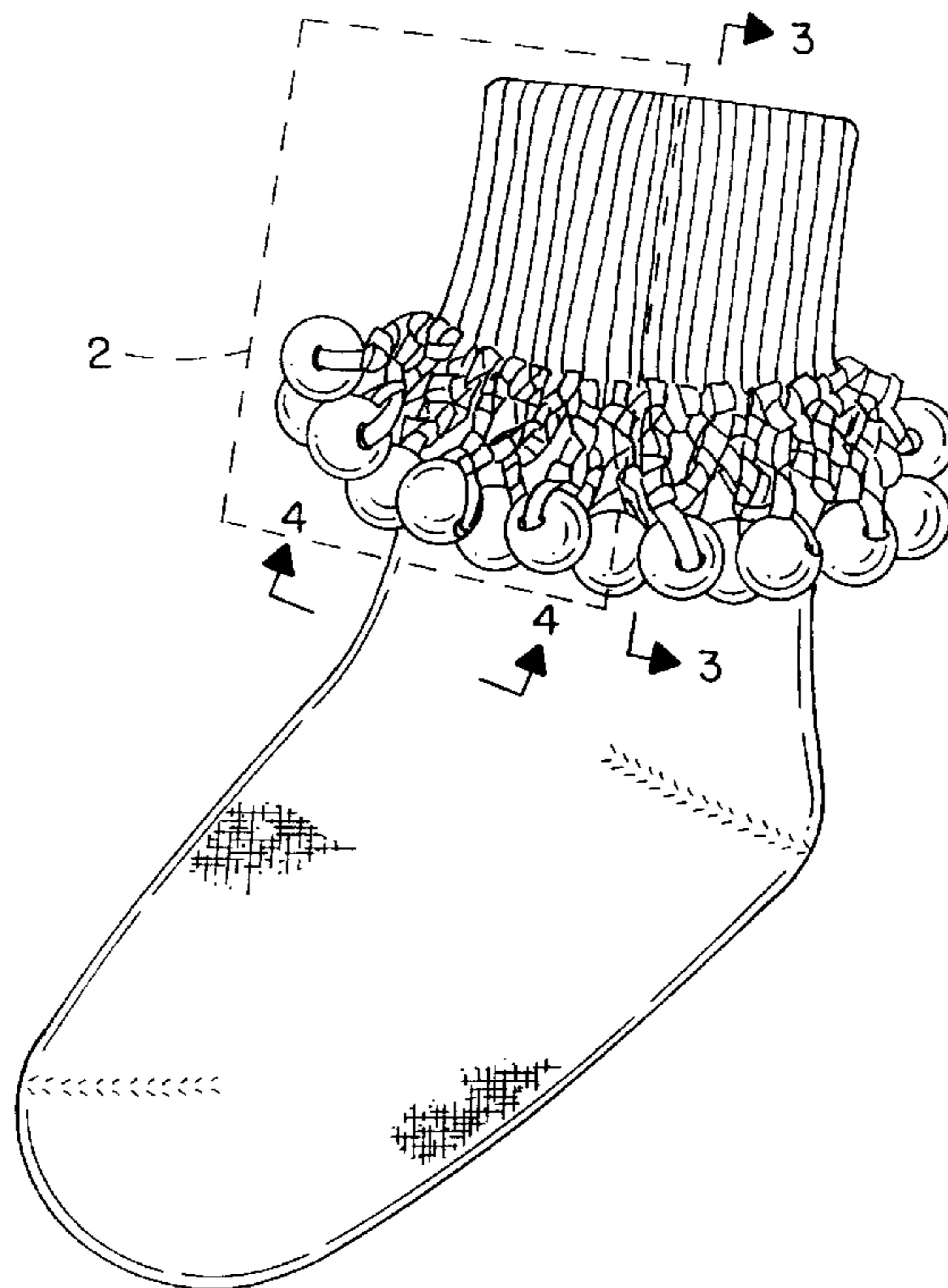
FIG. 7 is a fourth embodiment of a sport sock with crochet and beads, the bead is drawn separately for ease of illustration;

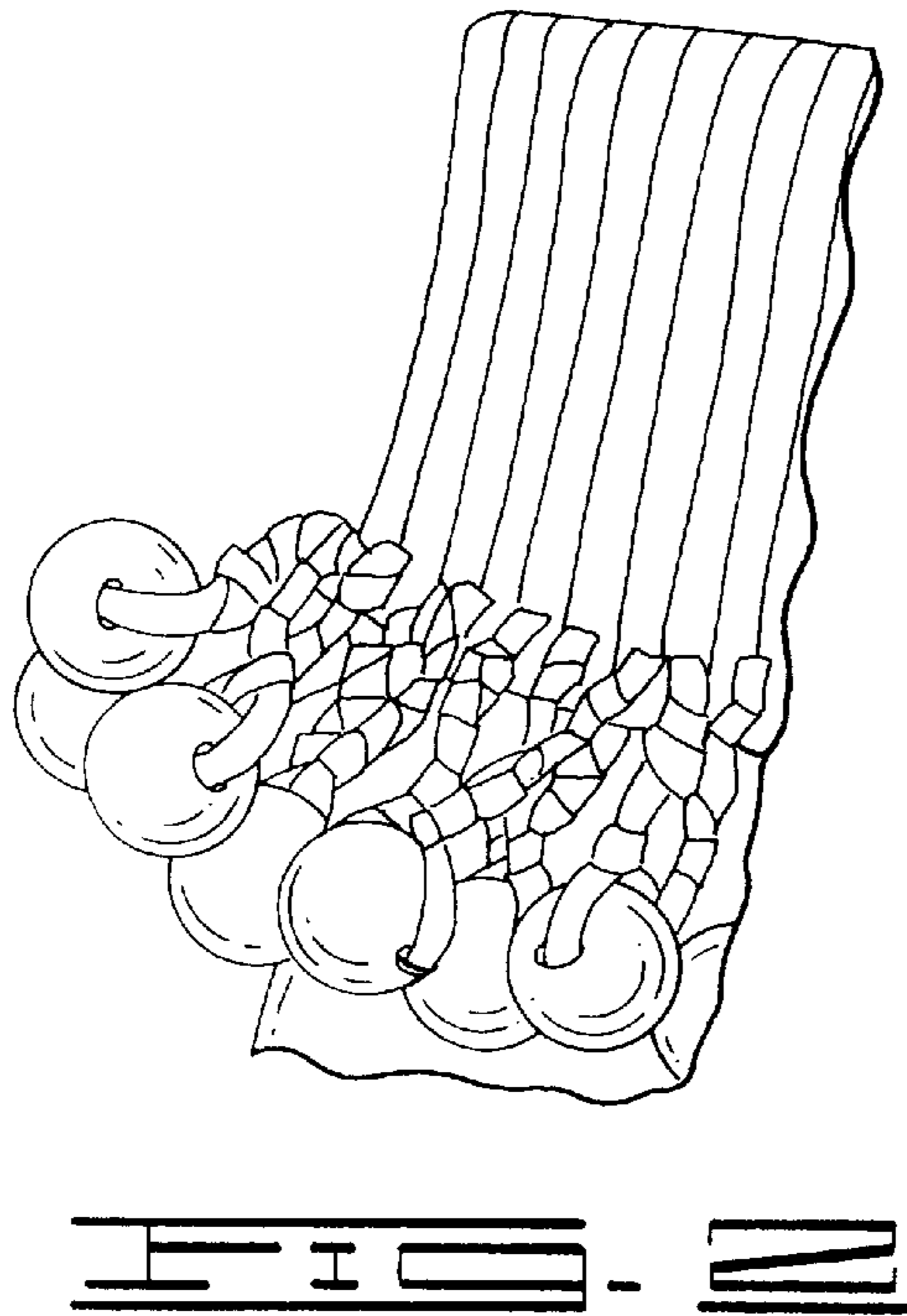
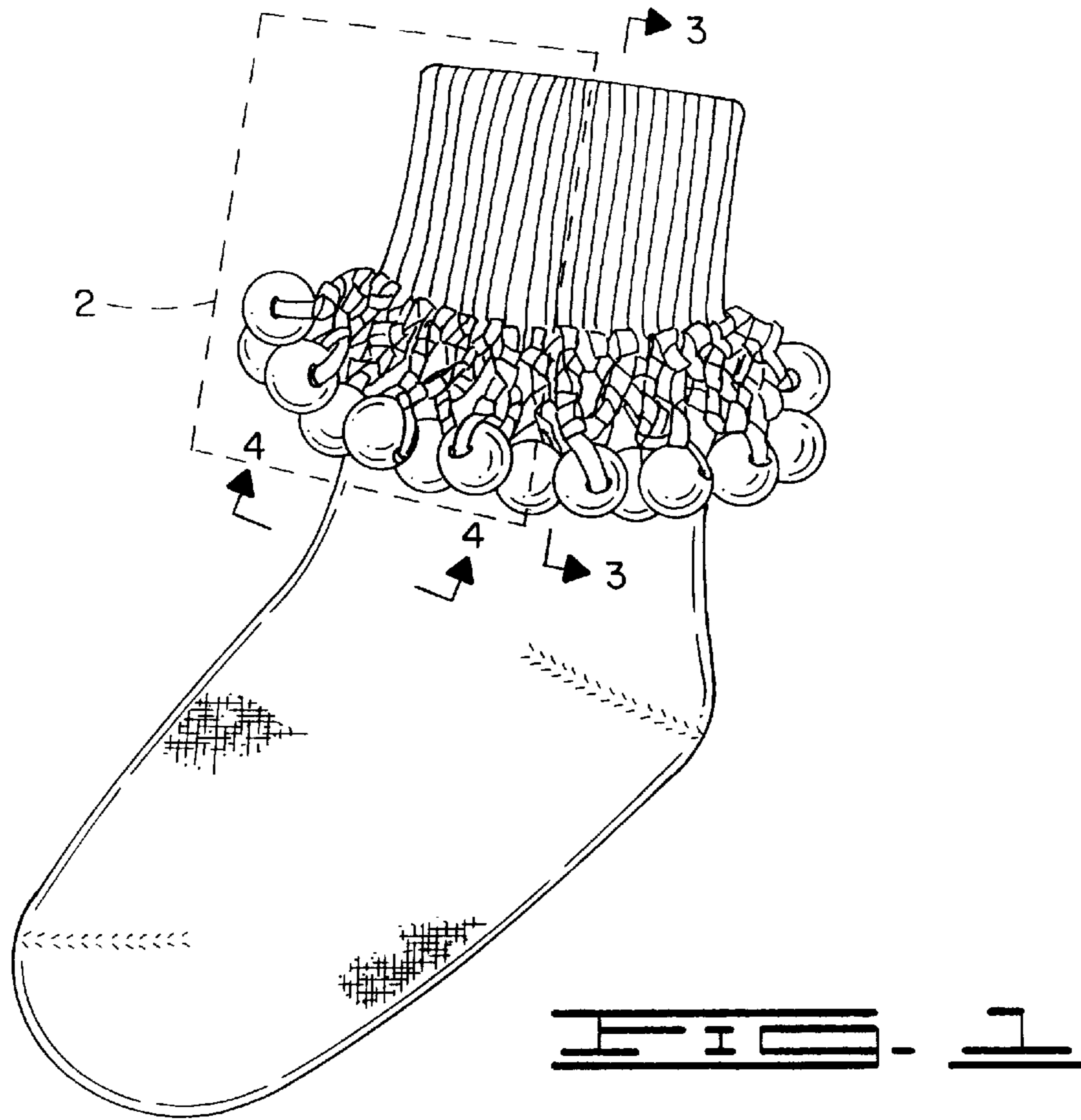
FIG. 8 is a fifth embodiment of a sports sock with crochet and beads, the bead is drawn separately for ease of illustration;

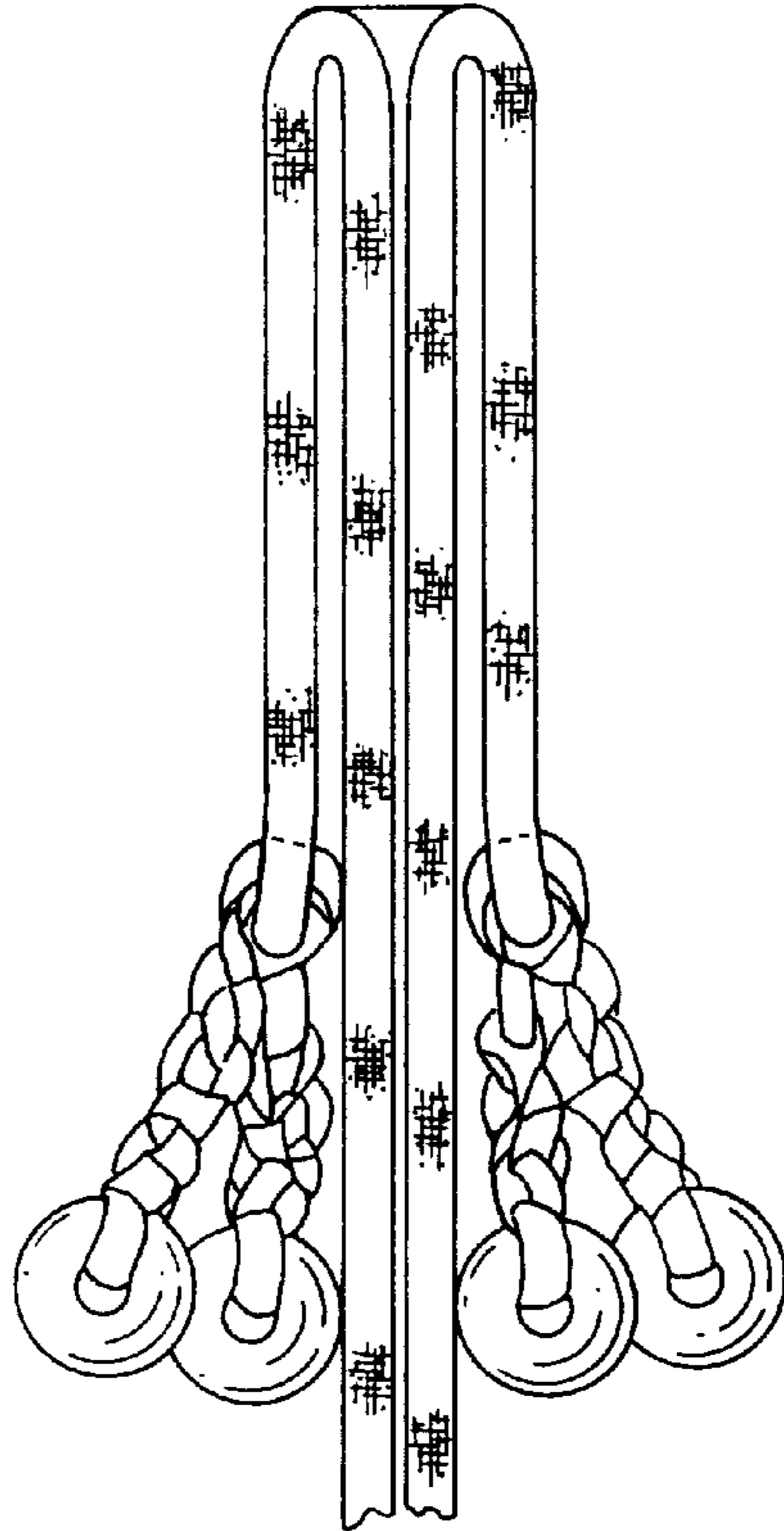

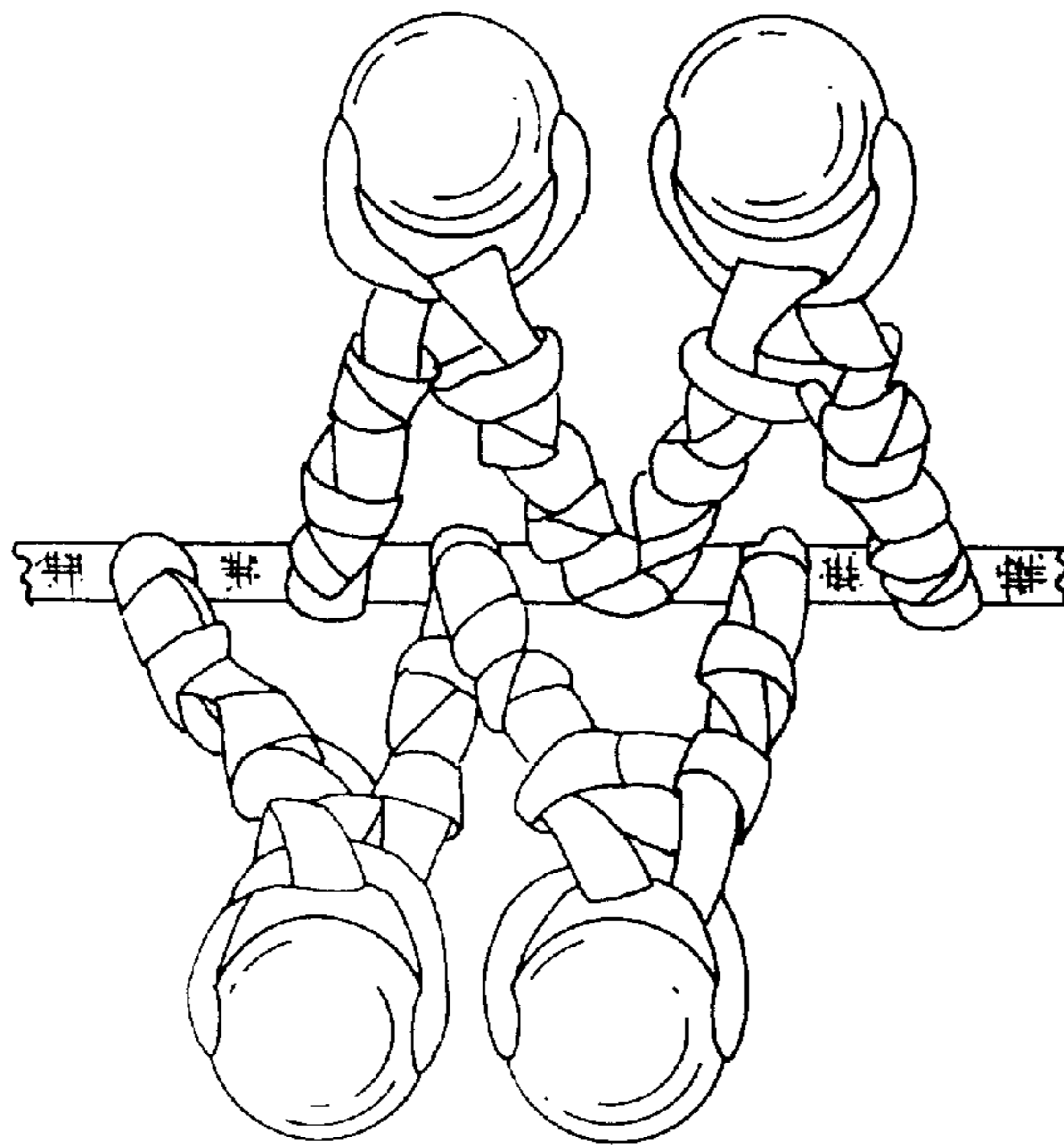
