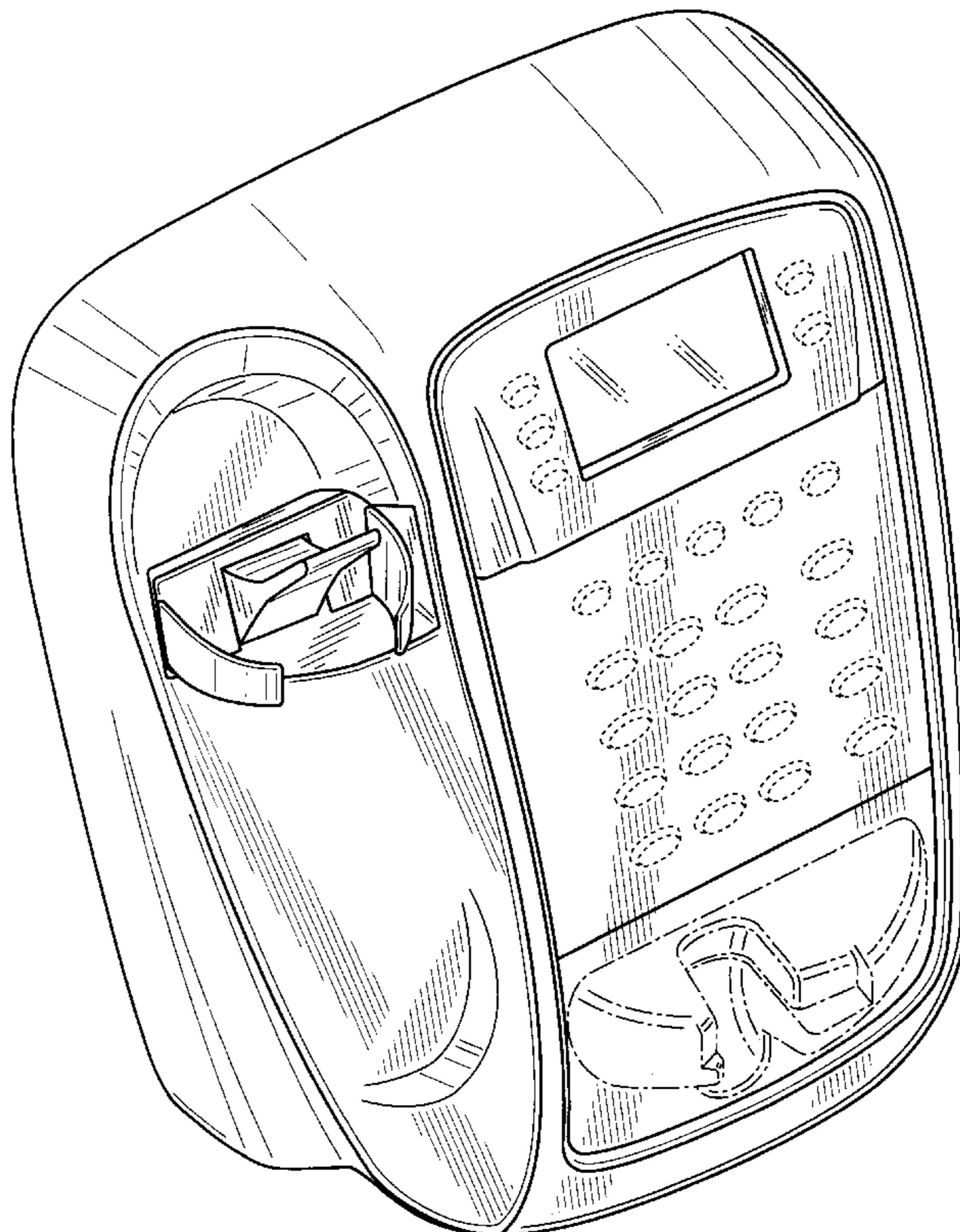
The ornamental design for a pay telephone, as shown and described.

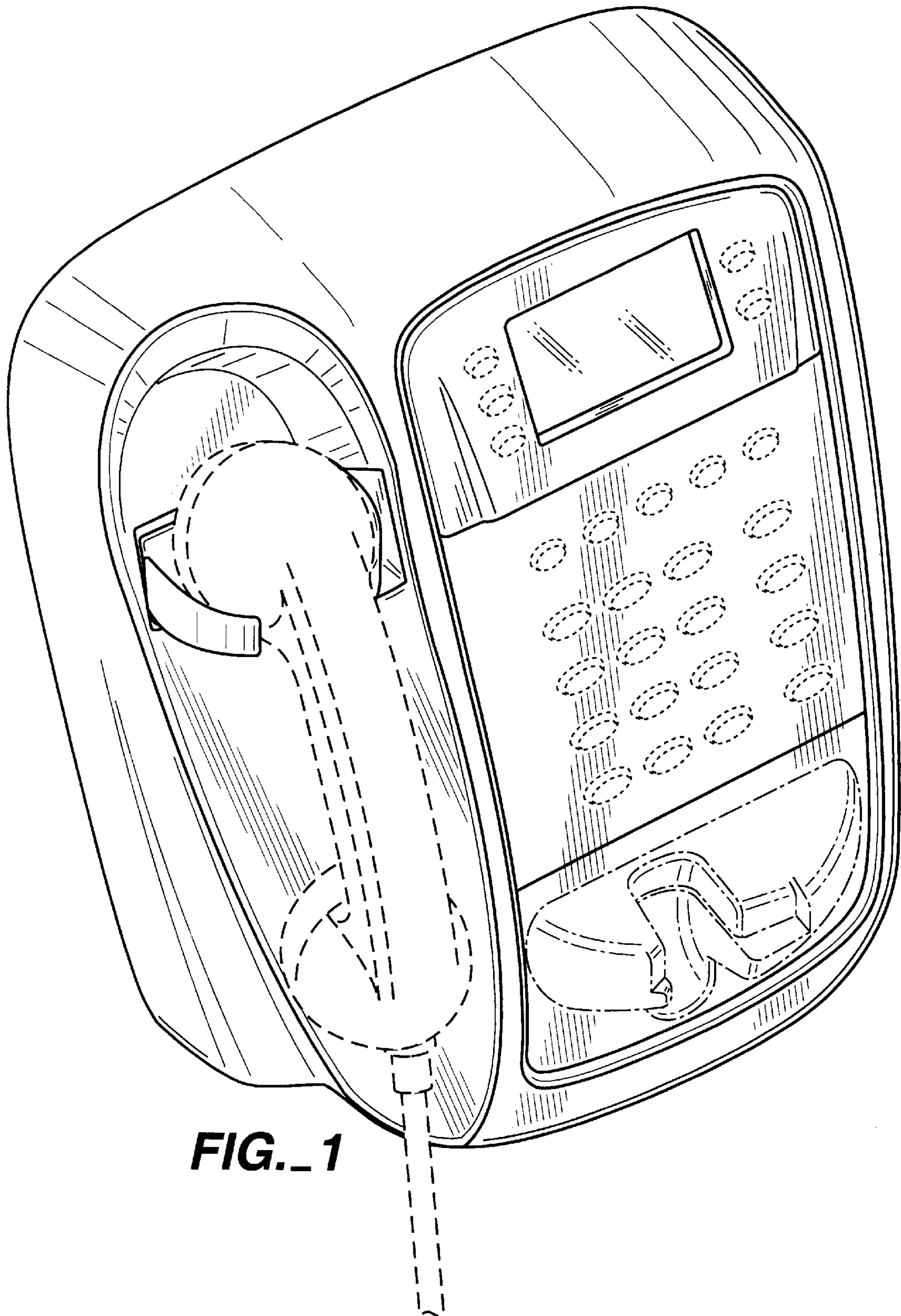
### DESCRIPTION

FIG. 7 is a left side elevational view thereof.

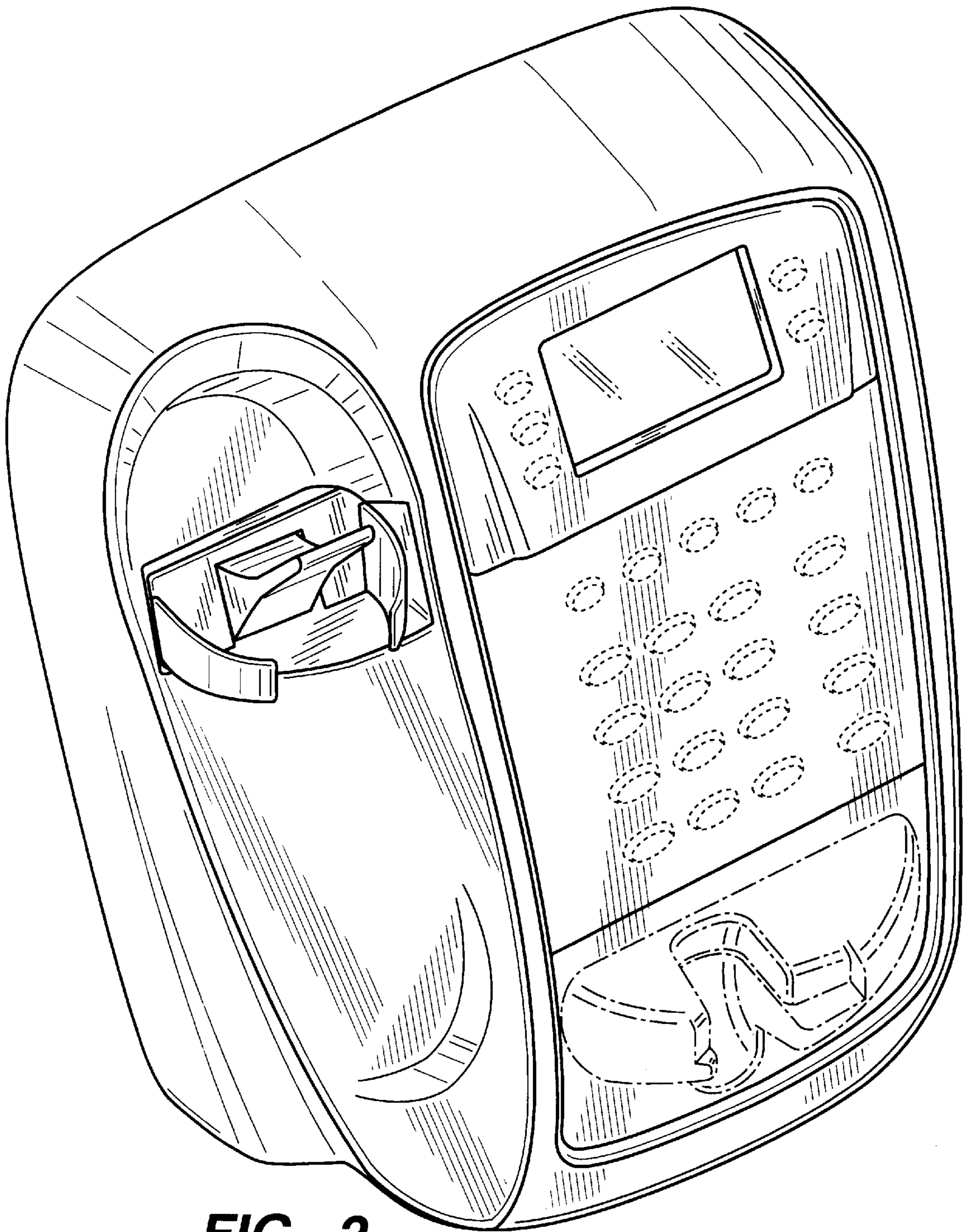

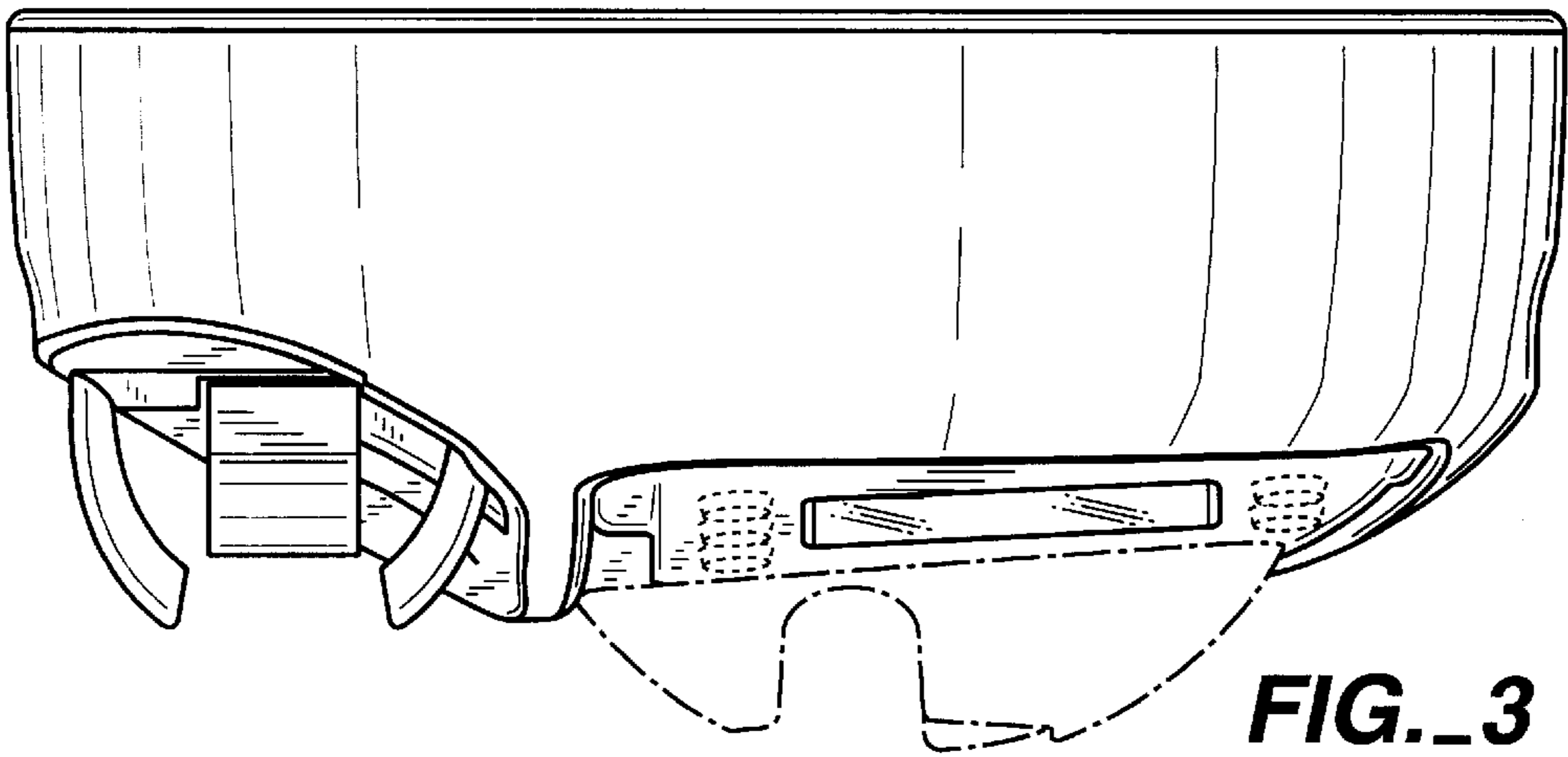




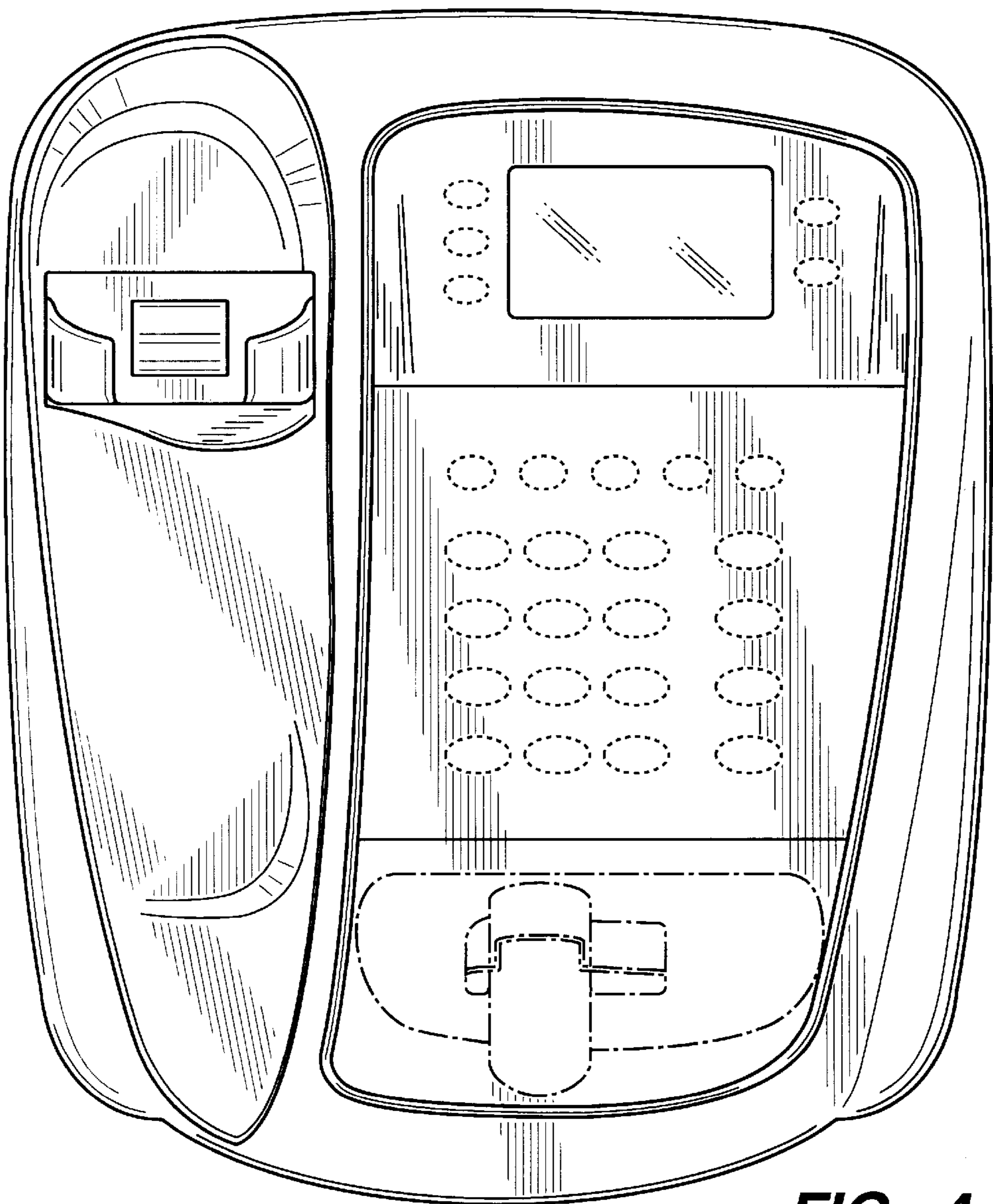

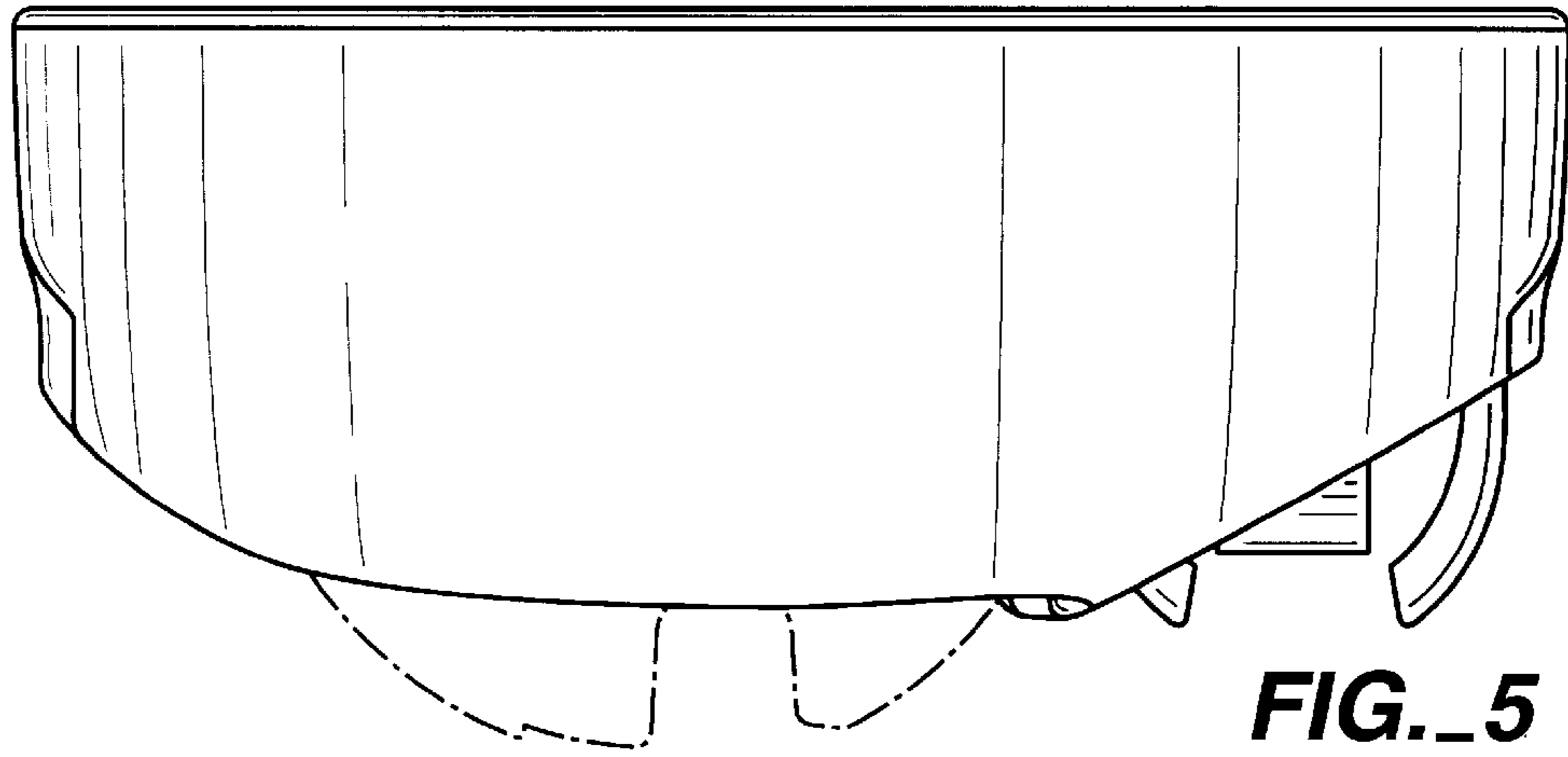

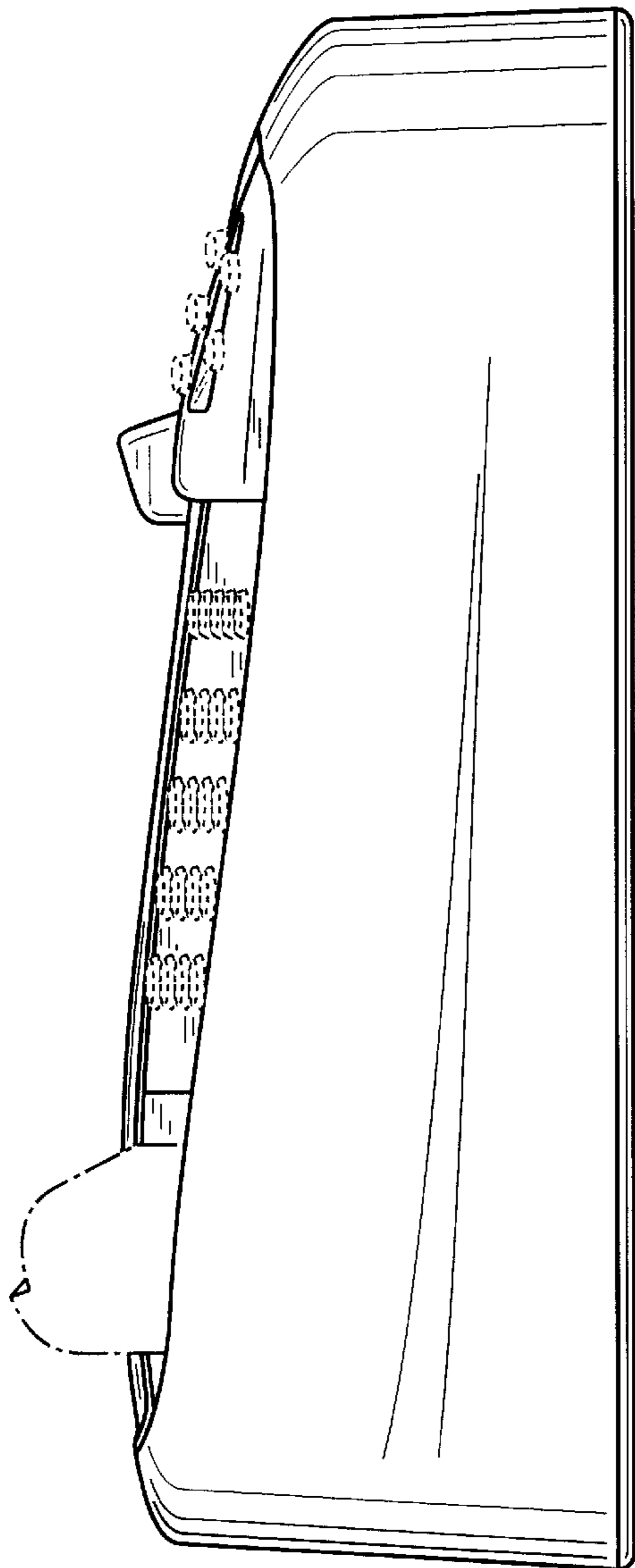

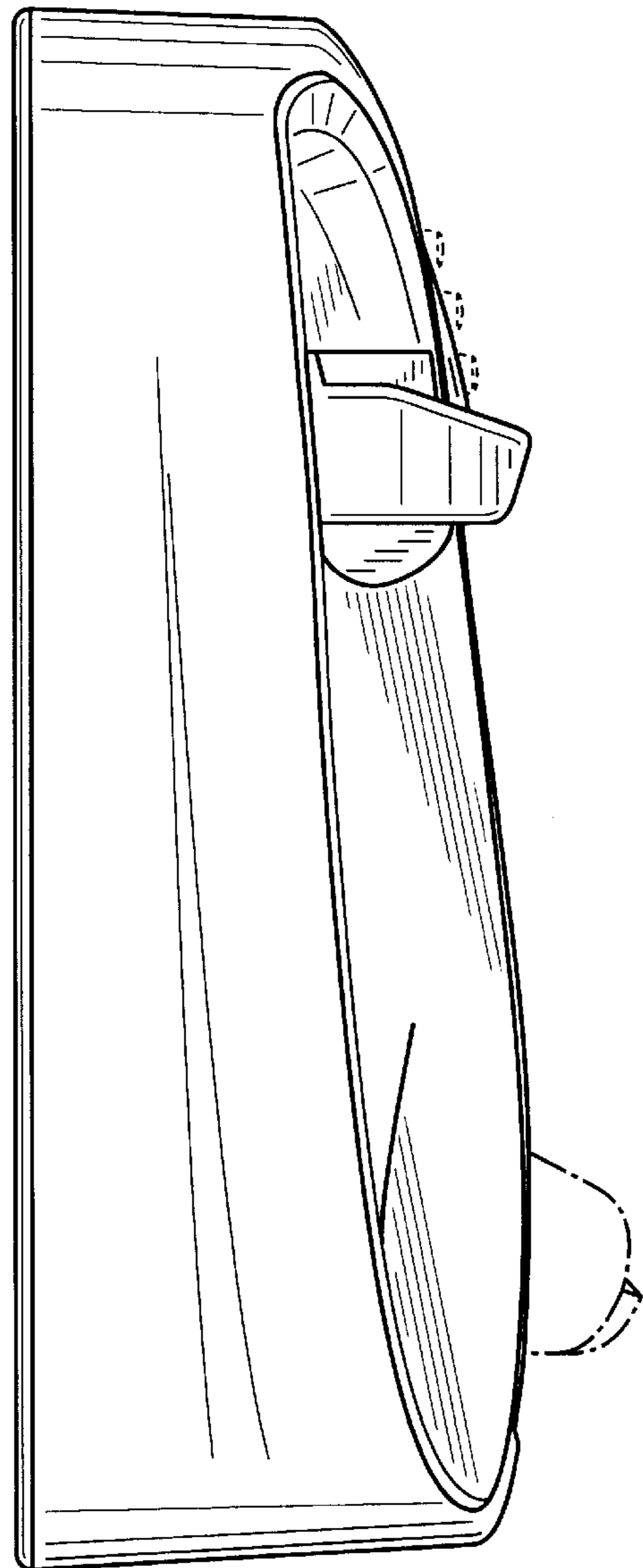
