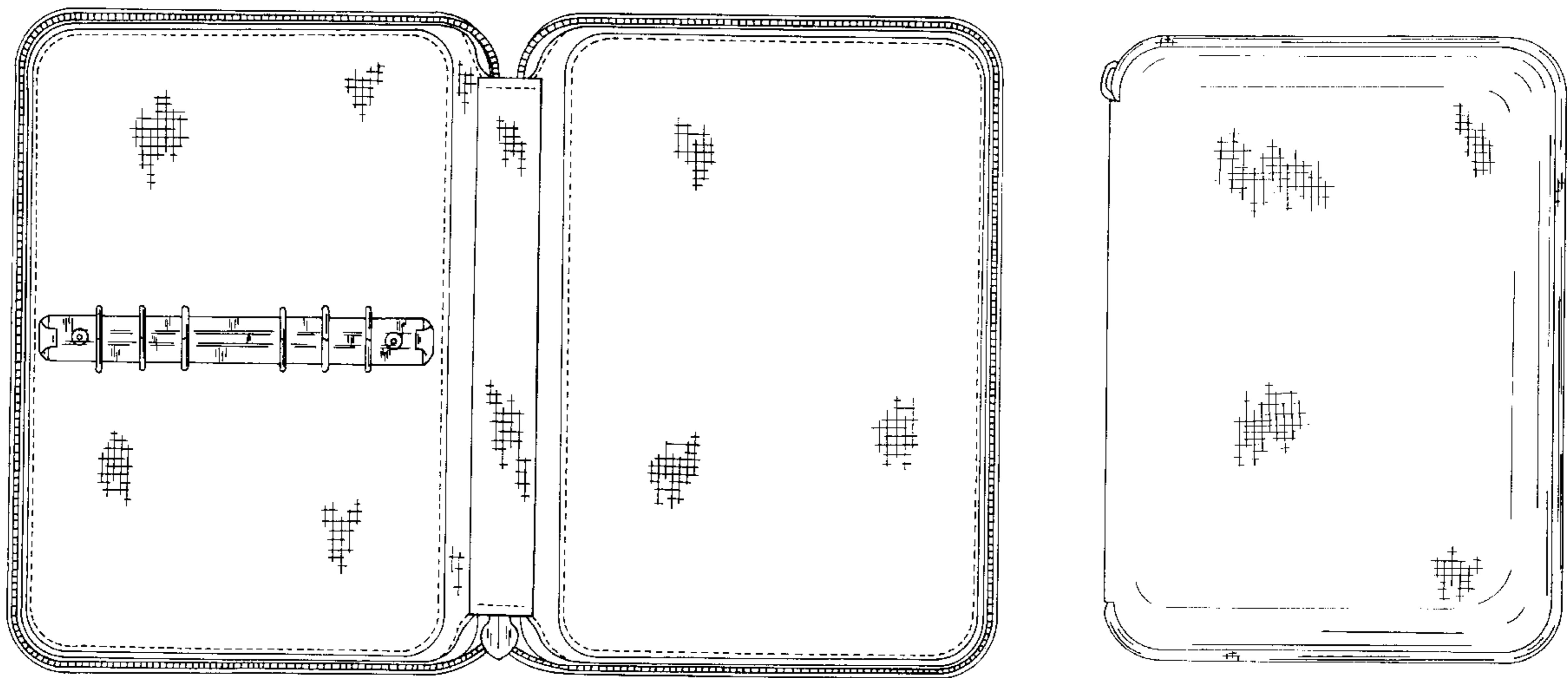
FIG. 1 is a top plan view of a portfolio in an opened condition showing my new design;

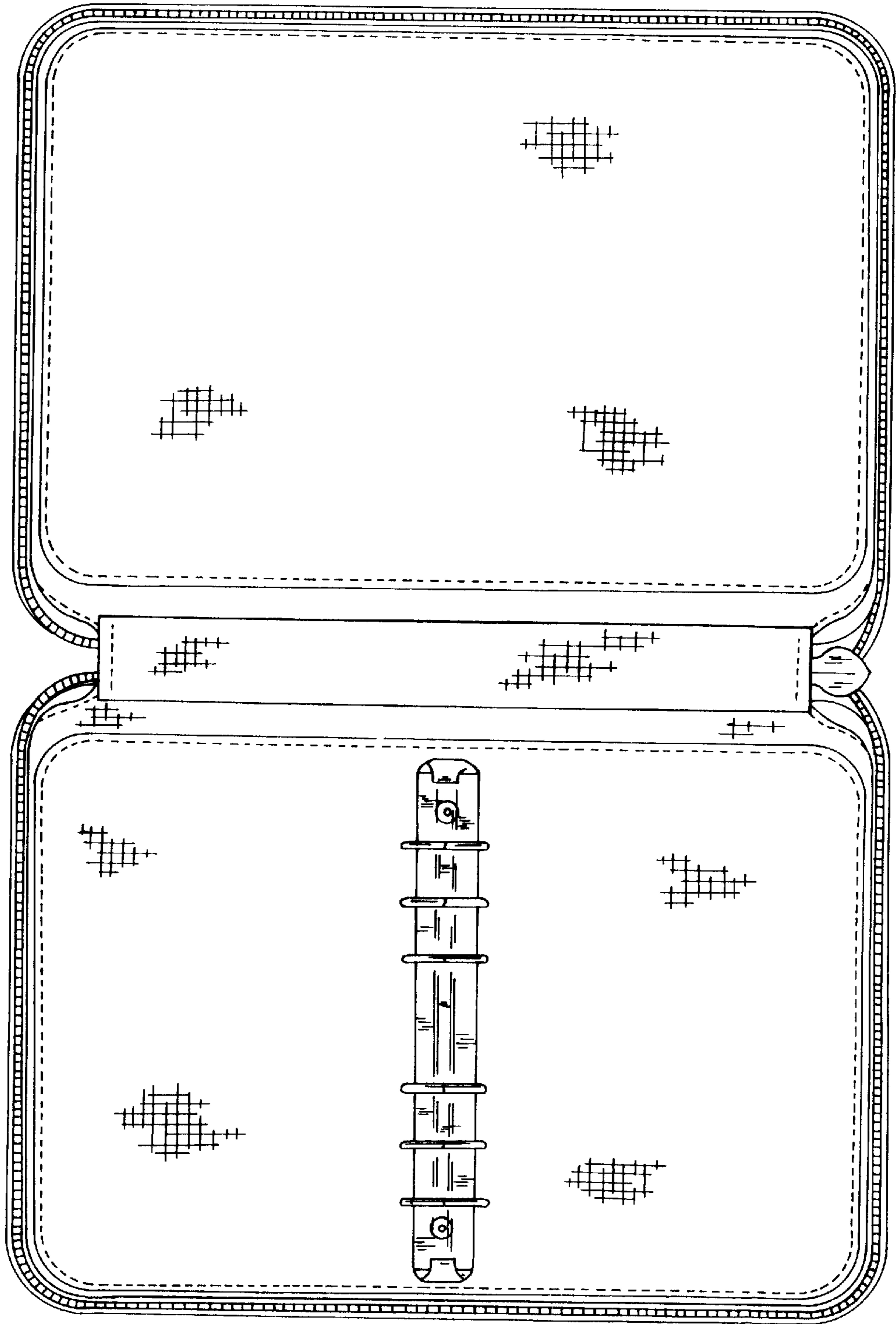

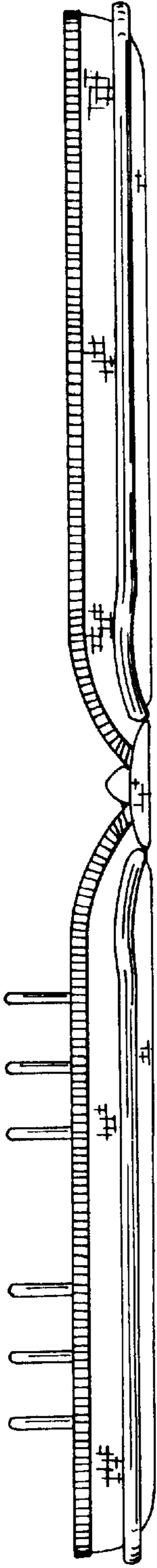

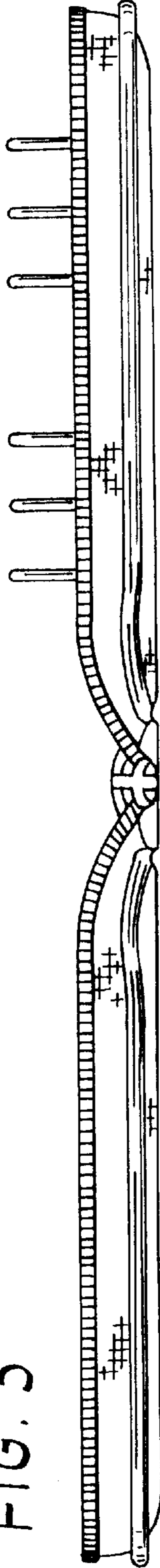

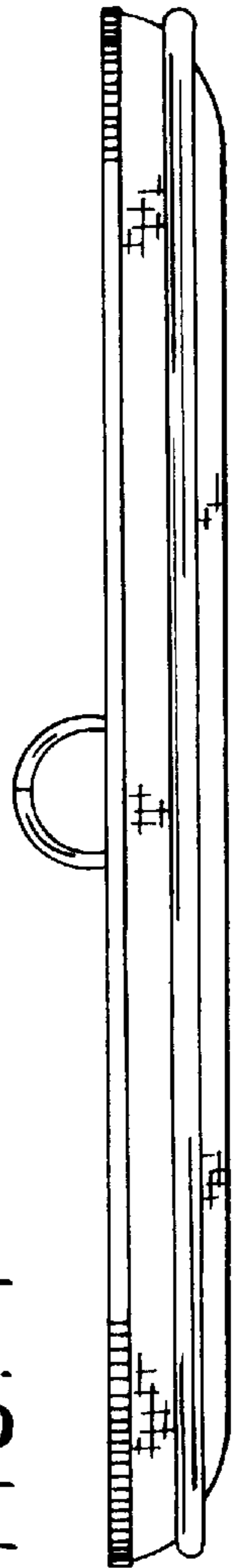

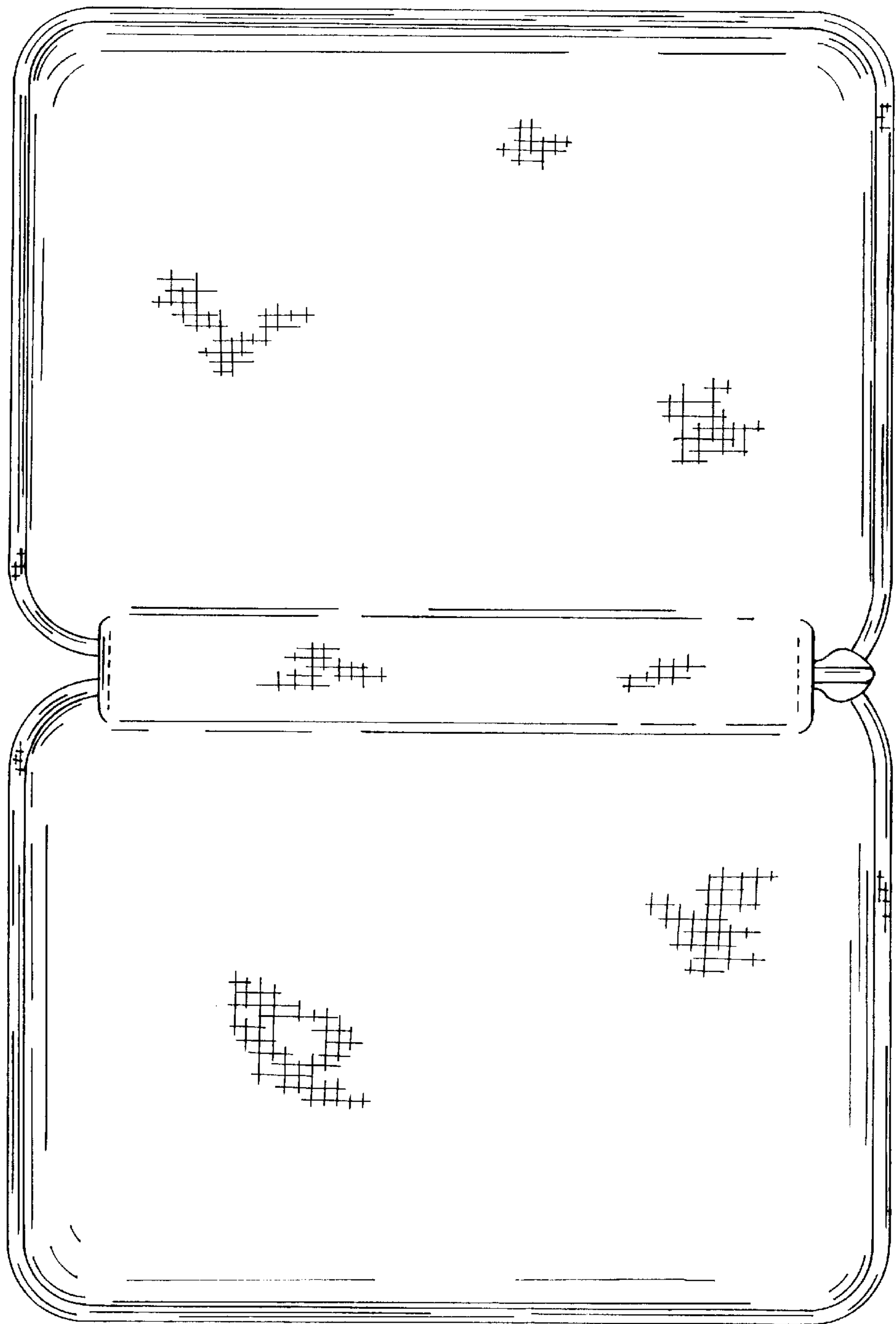

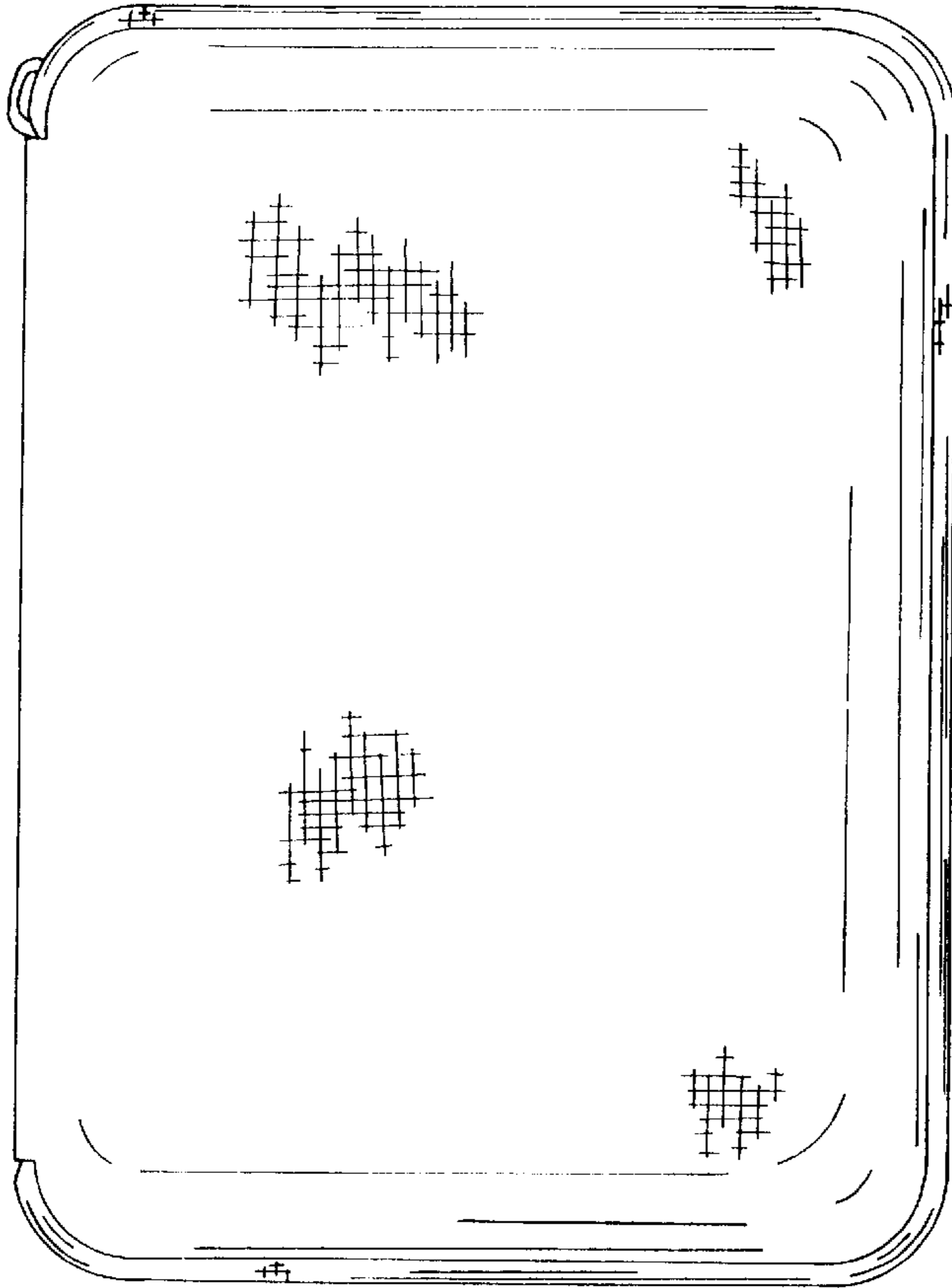

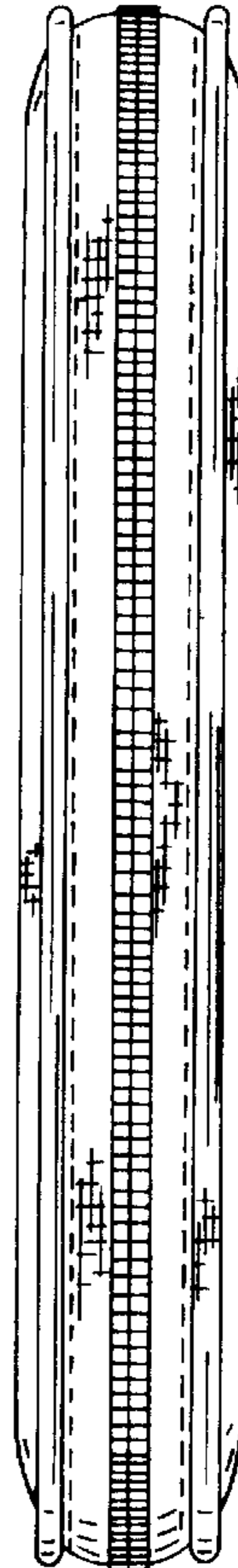

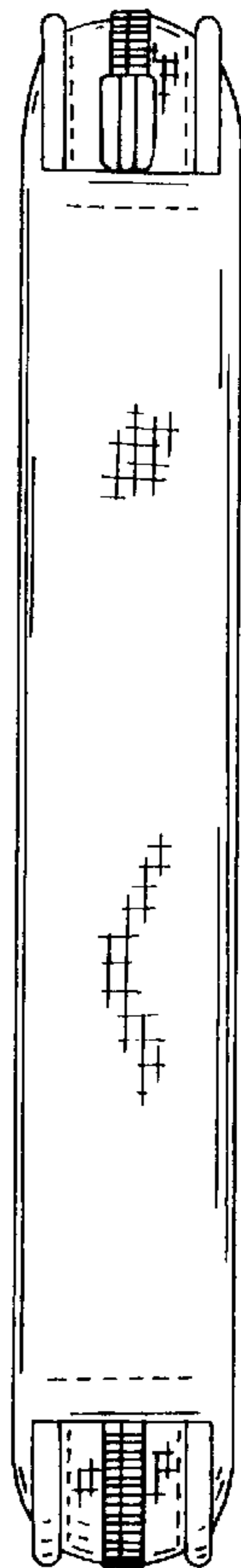

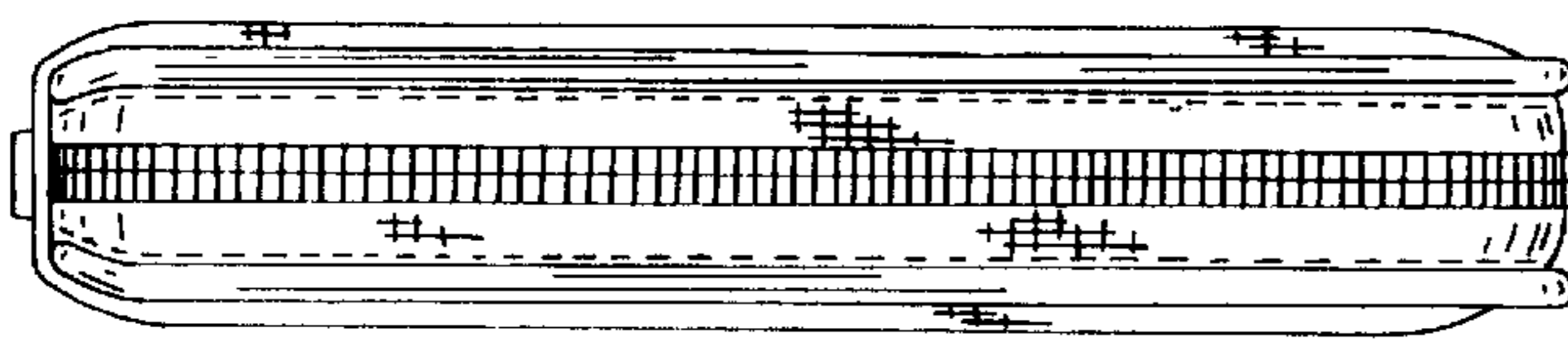
