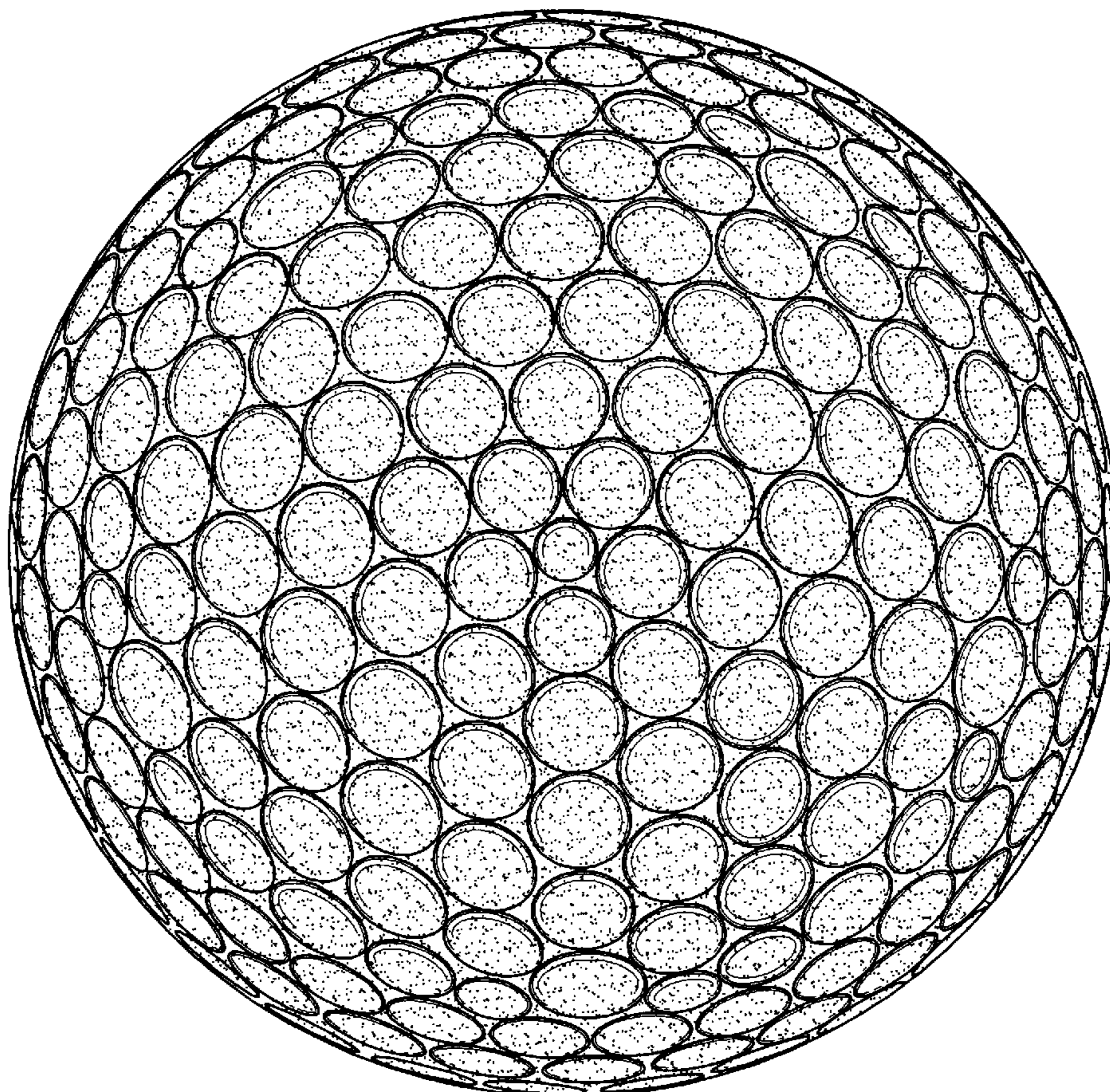
[57] **CLAIM**

The ornamental design for a golf ball, as shown and described.

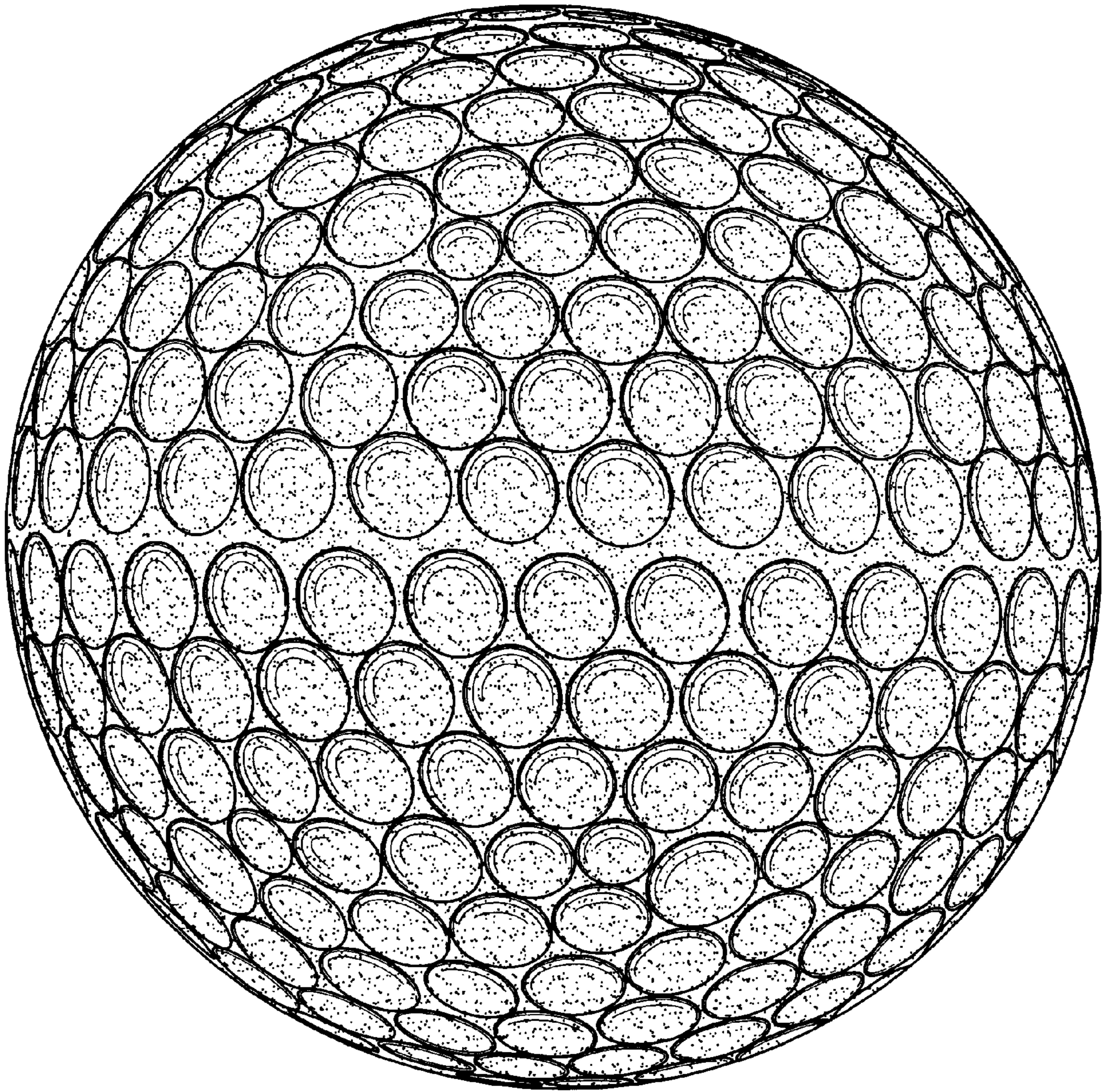
**DESCRIPTION**

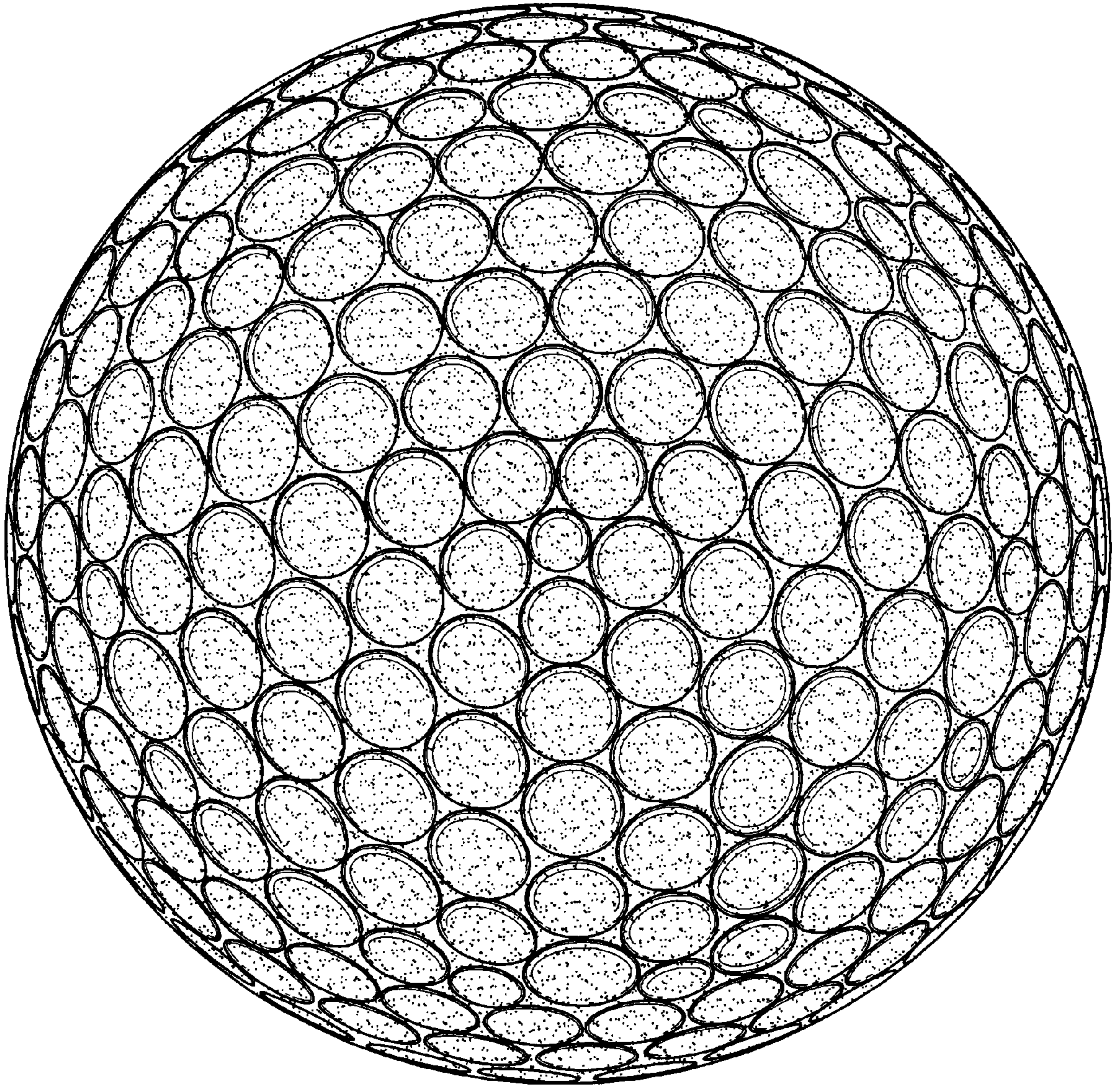
