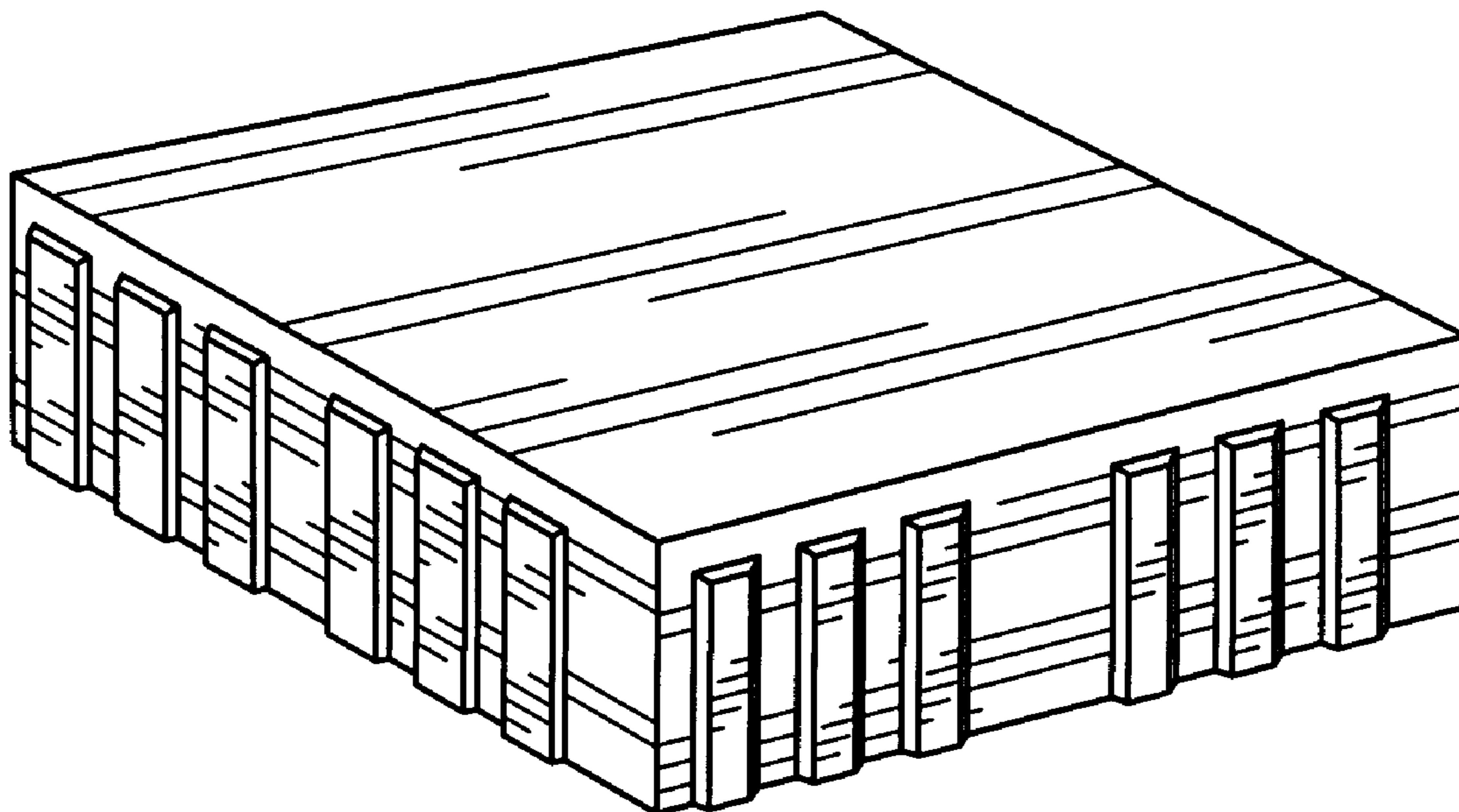
The ornamental design for a paving stone, as shown and described.

DESCRIPTION

FIG. 1 is a top and side perspective view of a paving stone showing one embodiment of my new design;
FIG. 2 is a top and side perspective view of a paving stone showing another embodiment thereof; and,

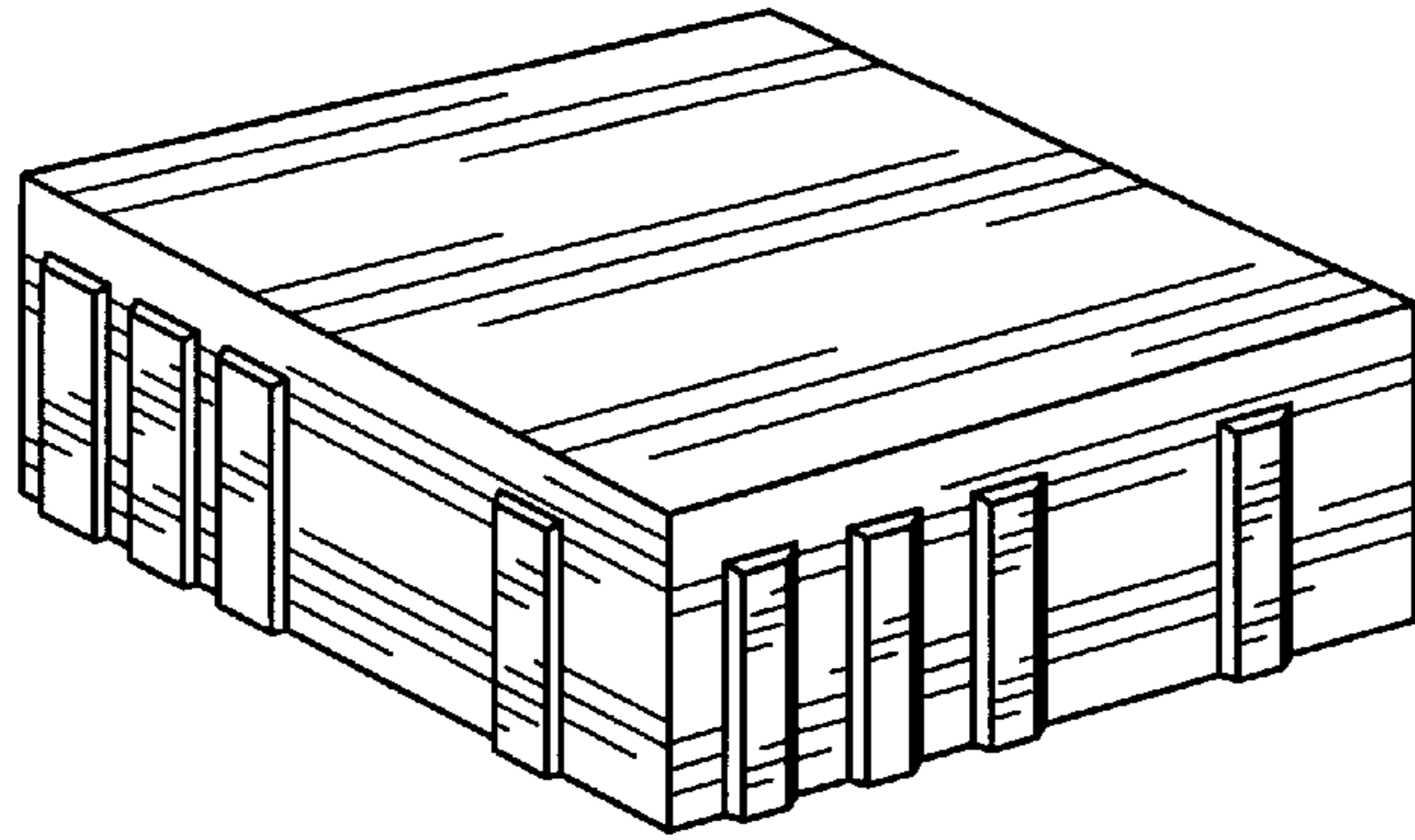

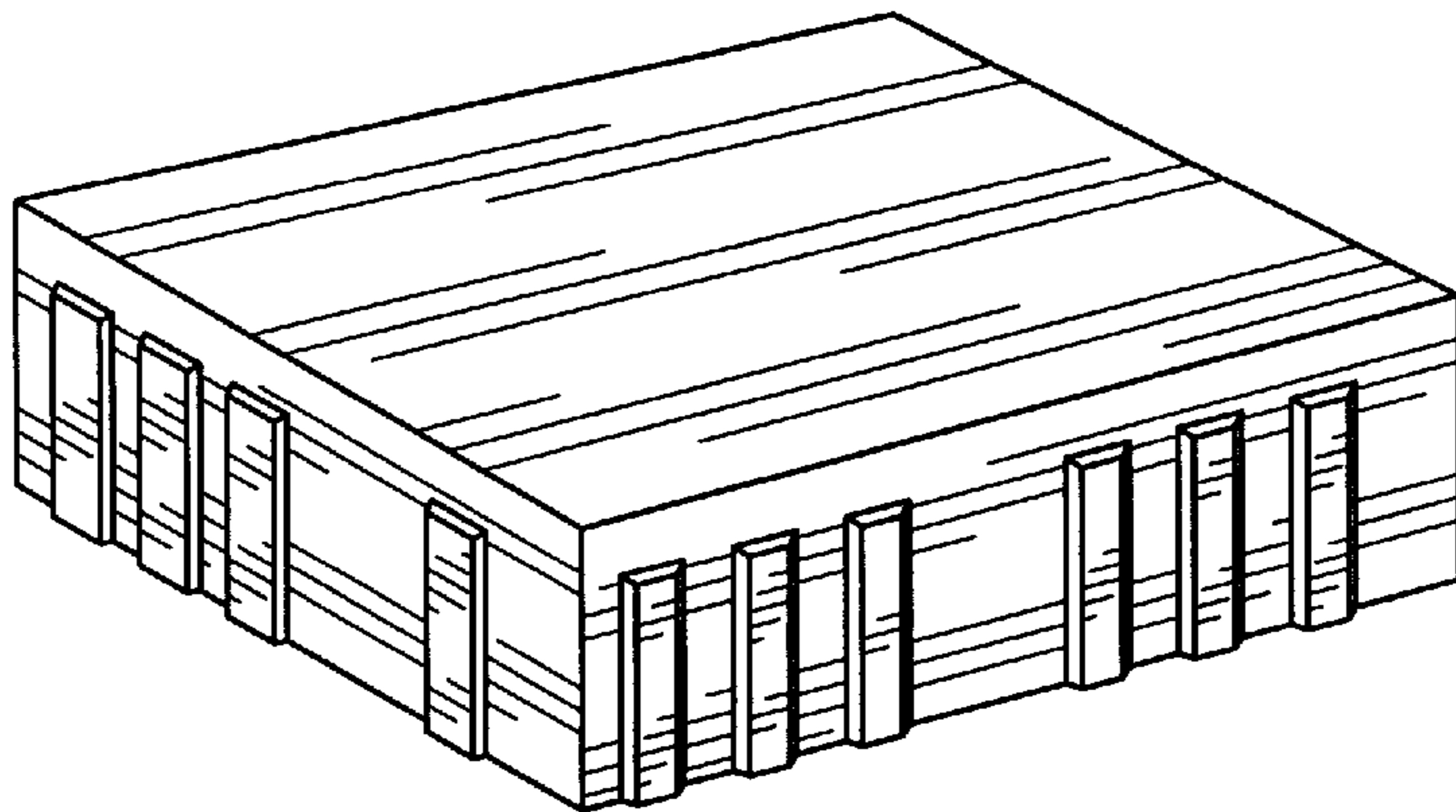

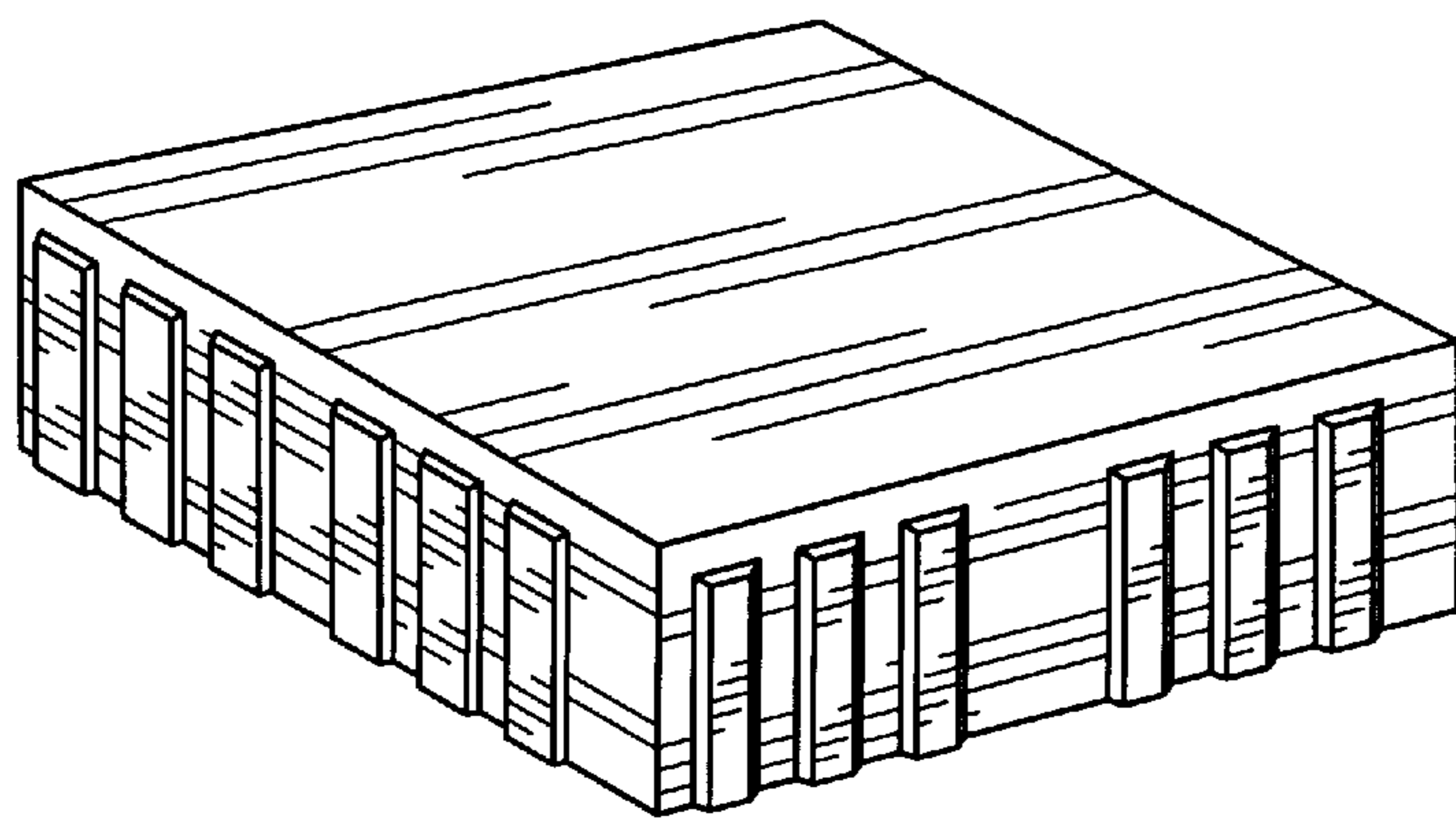


FIG. 3
